PREDICT QUICK PASSAGE FOR VETS MEASURE

Senate Receives Bill After It is Given Approval By Members of the House

Washington, Feb. 17.—(AP)—Notice was given in the Senate today by Senator Ashurst, Democrat, Arizona, that he would ask the Senate to begin consideration of the veterans' loan relief bill without further action by the Senate finance committee.

He first sought to bring the bill, which was passed yesterday by an overwhelming majority in the House, before the Senate for action today, but he was blocked by the rules. He then entered the formal motion for discharge of the finance committee, upon which he will ask a vote tomorrow.

A race is on by proponents of the measure to get it to President Hoover ahead of the ten day period before the close of the session in which he may kill the bill without returning it to Congress with a veto.

A powerful majority for the measure is certain in the Senate.

Washington, Feb. 17.—(AP)—After conferring with President Hoover, Senator Mosts said today they had discussed the House bill for increasing veterans' loans and predicted legislation would be passed by the Senate without delay.

The New Hampshire Republican was an early caller at the White House. He did not say what stand the President took in regard to the veterans' legislation, if any. It was opposed by the administration while before the House.

Senate proponents are insistent for immediate action on the bill to increase the veterans' privilege for borrowing on their adjusted compensation certificates from 22 1/2 percent to 50 percent of the face value.

Washington, Feb. 17.—(AP)—Into a Senate already perturbed by a new crop of controversial issues and threats was thrown today the veterans' loan bill, fresh from the House which rolled up a tremendous majority to put it over despite warnings of a possible veto.

Republican leader Watson wanted hearings on the measure in the finance committee. Bluntly Senator Couzens, Republican Michigan, answered:

"We will have no hearings. They aren't necessary."

He predicted the bill would be through with preliminaries and up for Senate action by Thursday at the latest, supported by a powerful majority.

The House passed the measure late yesterday afternoon, 363 to 39. The 39 were all Republicans, staunch old-liners who stuck to the administration, led by majority leader Tilson and Chairman Hawley of the ways and means committee. In all 216 Republicans followed Speaker Longworth to support the bill, joined by every Democrat present and the one Farmer-Labor member. The measure was passed under a suspension of the rules which closed every avenue of delay or amendment. It was on the way to the Senate within an hour after Speaker Longworth had it brought up. General opinion was that the Senate's action would be proportionately as fast, allowing for the normal greater extension of debate in that branch.

Supporters of the measure, sponsored by Representative Bachrach, Republican of New Jersey, were jubilant over recording a vote far in excess of the two-thirds required to override a veto. They were confident that if after passage by the Senate President Hoover added his formal disapproval to that already recorded by Secretary Mellon, they would pass it again. The adjusted compensation act of 1924—the present bill amends it to enlarge veterans' borrowing power to 50 percent of the certificate's face value—was passed over President Coolidge's veto 313 to 78.

The Bachrach measure reduces the rate of interest on such loans to 4 1/2 per cent compounded annually and allows a veteran with a \$1,000 certificate to borrow \$500. Its financing provisions call for making the loans out of the \$772,000,000 sinking fund for retirement of the certificates at their 1945 maturity, and also out of the \$500,000,000 government life insurance fund. It adds authorization for any necessary appropriations.

The bill increases the total loan value of the 3,400,000 outstanding certificates to \$1,712,500,000. Of this about \$325,000,000 already is on loan while estimates of the probable new borrowings to result range from \$375,000,000 to \$700,000,000, with Secretary Mellon pointing to even larger potential outlays.

House Receives Two Score Bills As Senate Debates Umstead-Whedbee Bill

Personnel Bill Passes Second Reading But Is Held Up By Amendments; New Measures Affect Entire State

Raleigh, Feb. 17.—(AP)—With the House receiving more than two score new bills, and the Senate considering the Umstead-Whedbee personnel commission bill, both houses of the General Assembly made slow progress with their calendars today. The personnel bill passed second reading 44 to 8 on a roll call but amendments offered delayed final action.

New public measures to affect the entire state were sent forward in both houses, including a bill by Mrs. McKee of Jackson, to levy a five per cent tax on consumers of gas, electricity, water and other utilities. The measure is the first revenue bill of the session to name "consumers" as the source to be taxed.

The House passed the committee substitute for the Ervin-Johnson bill.

U. S. EXPORTS FORGE AHEAD OF IMPORTS

Nation Showed Favorable Trade Balance of \$67,000,000 During January

Washington, Feb. 17.—(AP)—American exports for January amounted to \$250,000,000 as compared with imports of \$183,000,000, leaving a balance of trade favorable to the United States for the month of \$67,000,000.

Both imports and exports as reported today for January by the Commerce Department were the smallest recorded in many years.

The last low point in exports which compared with those of January was registered in February 1922, for which month they were slightly less than \$250,000,000 while imports in every month since September 1921 have been greater than those of January.

In a study of the export figures it was determined that a considerable portion of the January decline was due to the decreased foreign shipment of cotton as well as to low prices prevailing for that important American import commodity.

In spite of the contraction in foreign trade, the January record disclosed that the United States had begun the new year by making a heavy gain in gold on international balances. The month's imports of the monetary metal amounted to \$34,426,000 and the exports were \$54,000. In the same months last year gold imports amounted to \$12,906,000 and exports to \$8,948,000.

January exports of silver were \$3,574,000 and imports \$2,896,000. Both figures were under those of January last year. When silver exports amounted to \$5,892,000 and imports \$4,756,000.

Grocer Held For Slaying Partner

Kannapolis, Feb. 17.—(AP)—Henry Norris, 38, grocer, was under \$3,000 bond today for trial in April on a charge of slaying Bill Ethridge his 50-year-old partner.

Ethridge was to have appeared at the same time of court to answer a charge of murder in connection with the fatal shooting last fall of John Hinsley.

Norris testified yesterday before a coroner's jury that he shot Ethridge Sunday after his partner had attacked him with a knife. The coroner's jury ordered him held under bond for trial.

Asheville Banker Commits Suicide

Asheville, Feb. 17.—(AP)—Arthur E. Rankin, vice-president in charge of the Haywood Street branch of the Central Bank and Trust Company which closed last November, shot himself through the head at his home here this afternoon and died instantly.

Coroner John L. Carroll said an inquest was unnecessary. Rankin, who was 57, formerly was president of the American National Bank which also closed last November. He resigned in January of last year to become connected with the Central Bank and Trust company.

Neither members of the Rankin family nor his business associates were able to advance a motive for the action.

Rankin shot himself through the right temple with a revolver. His body was found slumped upon a stairway leading to the cellar of his home, a handkerchief had been wrapped around the weapon, presumably to deaden the sound.

His widow, a daughter, 27, and a son, 23 survive.

CROWDS HEAR MISS TAYLOR

Noted Bible Lecturer Thrills Hearers With Gospel of St. John at St. Paul's Church

Beginning her lecture on the Bible yesterday afternoon at 3:30 at St. Paul's Episcopal church, Miss Taylor told of the statement, "Gloria in excelsis deo," which she heard of the life, trial and death of Jesus: "O Jesus, had I been there with my Franks I would have avenged thy wrongs." This she said was the feeling of many people.

That had we known Jesus personally in the days when He lived on the earth we would not have been among those who dissipate Him in their lives.

Yet she said it is possible for us to know Jesus personally today. She quoted Chinese Gordon who made the statement that when Christ became unreal to him it was his custom to read the Bible a good deal; then Christ would become real again.

Then she stated that through the study of the Bible we too may make Christ real in our lives. She then proceeded to ask her hearers to study with her this week the Gospel of St. John.

The purpose of this Gospel she said was stated in the book of John itself in chapter 20, verses 30 and 31: "Many other signs truly did Jesus in the presence of His disciples which are not written in this book."

"But these are written, that ye might believe that Jesus is the Christ, the Son of God; and that believing ye might have life through His name. This she said was the great purpose of the Gospel of John.

Miss Taylor then gave an outline of the Gospel that was lucid, intellectual and spiritual.

Her hearers sat in profound interest as she then pointed out the seven signs that are in the Gospel of St. John. These signs she stated were: the turning of the water into wine; the healing of the paralytic; the healing of the man born blind; and the raising of Lazarus.

The tremendous meaning of these signs Miss Taylor stated is that just as Jesus had power over the forces of nature so also He has power to change our lives. He who turned the water into wine, she said, can turn our weakness into strength.

LONE BANDIT ROBS TRAIN PASSENGERS

Two-gun Man Obtains \$300 in Holdup of Observation Car of Crescent Limited

Montgomery, Ala., Feb. 17.—(AP)—Seven passengers lounging in the observation car of the south-bound New York-New Orleans Crescent Limited as it sped through Georgia last night were held up and robbed of approximately \$300 by a lone two-gun bandit who escaped in an exchange of shots with the flagman.

The story of the robbery, which occurred between Newnan and Moreland, Ga., at 7:20 p. m., was related here several hours later by passengers who credited M. Pierce, a Pullman porter, with keeping the robber out of the dining car where the steward who had more than \$1,000 in his cash account, Pierce, noting the robbery while it was in progress, crawled on his hands and knees to lock the forward door of the observation car.

Passengers described the bandit as middle-aged and somewhat nervous. He kept a good distance between himself and the passengers, forced C. H. Thornton, a negro bus boy, to collect the money, and then dropped off the platform as he brought the train to a halt by pulling the emergency stop cord.

The Crescent Limited is a Southern Railway train operated over the tracks of the Atlanta and West Point railroad between Atlanta and Montgomery.

Members of the train crew said they believed the bandit had boarded the train at Newnan.

Among the losses were J. J. White, South Orange, N. J., \$15; Mr. and Mrs. E. H. Barker, New York, \$80; Hampbell A. Gayden, Chester, S. C., no loss; Mrs. Henry Celaya, San Antonio, Tex., no loss; J. R. Cheatham, flagman of the train, followed the bandit to the platform and exchanged shots with him as he fled to a car that apparently had been waiting on a side road.

Mrs. Barker wanted when the bandit entered the car. Mrs. Celaya said she saved a \$3,000 diamond brooch and a number of valuable rings by tossing them on the floor.

Writers in the dining car observed that a number of passengers hid their money under plates and food, while negro employes stuffed currency into milk bottles to save it, when it was believed the bandit could advance into the diner. Both writers and passengers were busy from Moreland to Montgomery cleaning and drying their money.

BARDWELL TO BE BURIED AT OLD HOME IN MAINE

Asheville, Feb. 17.—(AP)—The body of Dr. Frederick A. Bardwell, chief of physio-therapy at Oteen Veterans Hospital today was sent to his old home at Canton, Maine, for burial following a brief funeral service here.

Dr. Bardwell died suddenly in his apartment here.

Fighting Polygamists

Mexico City.—In the wilds of Southern Mexico are Polygamists who often fight to death over their wives. They are members of a tribe of Maya Indians who speak pure Mayan and have no contact with other tribes. Raymundo Enriquez, former governor of Chiapas, now exploring, has wired President Ortiz Rubio urging efforts to civilize the tribe.

ASK ANDERSON CASE DROPPED

House Committee Recommends Withdrawal of Charges Against Judge

Washington, Feb. 17.—(AP)—The House Judiciary committee decided today to recommend that charges of official misconduct against Federal Judge Harry B. Anderson of the Western Tennessee district be dropped.

The full committee voted on a majority report from a sub-committee which conducted the investigation and which recommended the judge be exonerated. The full committee vote was not unanimous, but it decided to draft a report which all members might approve.

The action was taken on the basis of the sub-committee's report which was submitted by a four to one vote. The investigation was ordered by the House last year after being initiated by Representative LaGuardia Republican, of New York.

PLAN TO BLOCK APPROPRIATION BILL DEFEATED

Democratic and Republican Leaders Join in Vote to Take Up Report

Washington, Feb. 17.—(AP)—An attempt to block consideration of one of the appropriation bills which must be passed before the March 4 adjournment to avoid an extra session was defeated by an overwhelming majority today in the Senate.

Democratic and Republican leaders joined in voting 54 to 18 to take up the conference report adjusting differences between the Senate and House on the \$1,050,000,000 independent office supply measure.

Senator Black, Democrat, Alabama, who yesterday threatened a filibuster to force an extra session unless action is taken on Muscle Shoals legislation in the remaining two weeks, sought to block consideration.

"We all realize," Black said, "that those who are anxious to defeat the soldiers bonus legislation want to get the appropriation bills through. We realize there is a movement to delay the veterans' legislation so that it can be vetoed after Congress has adjourned."

"One of the methods of defeating the soldiers bonus is to allow the well-oiled plan to be manipulated so that the appropriation bills can be passed. Then there will be no way to hold them up in order to force consideration of the bonus."

Senator Smith, Democrat, S. C., said there were as many senators in proportion, favoring passage of the bonus legislation as members of the House. "The majority of the Senate," he said, "will not permit any plan to jeopardize the bonus bill."

The 18 voting against consideration of the bill were: Republicans—Blaine, Borah, Couzens, Cutting, Frazier, Howell, LaFollette, Norris, and Nye. Democrats—Black, Brock, Cawley, Dill, McGill, McKellar, Shepard with Trammell and Williamson.

Baby Dirigible Damaged During Forced Landing

Murfreesboro, N. C., Feb. 17.—(AP)—Capt. Anton Heinen, a jacked hole torn in the side of his "baby" dirigible in an ill-fated landing here on the way to Ueno, Fla., prepared today to start out again on the cruise as soon as the craft can be repaired.

Captain Heinen flew the 102-foot dirigible from Langley Field, yesterday, and decided to descend here for lunch. A gust of wind hurled the small craft into a tree, ripping a 30-foot gash in one of its struts and causing it to drop 40 feet to the ground.

The landing gear of the air yacht and one of its cabins crumpled under the impact, but Captain Heinen and the three members of his crew escaped uninjured.

He said the dirigible would be shipped back to Langley field for repairs and that just as soon as they were completed he would take off again for Pensacola. He expected the trip to be delayed two or three days.

APPROVE BILL TO BAR ALIENS IN THE CENSUS

Sparks Measure Given Favorable Consideration by House Committee

Washington, Feb. 17.—(AP)—The House Judiciary committee today approved the Sparks bill to exclude aliens from the population represented in Congress.

The measure proposes a constitutional amendment, reading: "Aliens shall be excluded from the count of the whole number of persons in each state, in apportioning representatives among the several states according to their respective numbers."

About 7,000,000 aliens will be deducted from represented population should this amendment be ratified by three-fourths of the state legislatures. The measure calls for ratification within seven years.

The House Republican leadership is opposed to granting consideration of reapportionment legislation, but representatives from agricultural states have mustered enough strenuous strength to force an issue. However, with the short time remaining of this session, many believe it doubtful any final action will be possible.

West representatives from metropolitan areas are seeking to block any change, particularly because prohibitionist members from rural regions are seeking to bar aliens dwelling in cities from the count.

Under the program today the House judiciary committee gave final consideration to the Hoch resolution for amending the Constitution to eliminate the 7,000,000 aliens from the count.

A concerted drive has been underway in the census committee to force a vote on the Thurston bill to increase House membership from 435 to 475.

URGES BANK SUPERVISION

Birmingham Banker First Witness Before Senate Committee During Morning

Washington, Feb. 17.—(AP)—Strengthening of supervision over state banks and greater efforts by the comptroller of the currency to prevent "bad failures" of national institutions were urged before the Senate Banking Investigating committee today by Oscar Wells, chairman of the First National Bank of Birmingham.

The first witness from the South to appear before the committee, the Alabama financier said "most of our difficulties have come from inadequate supervision."

State bank superintendents and examiners, he said, are paid "too meagre" salaries and are inexperienced in many cases.

Under questioning by Chairman Glass, Wells said the Farm Board cotton stabilization operations had "taken away some of the lending in our part of the country" and generalized it elsewhere.

Told by H. Parker Willis, committee expert, there had been 1,300 bank failures last year, the southern financier agreed there had been a "disproportionate" number of closings in the south compared with other sections.

This was primarily due, he said, to many banks in the agricultural sections relying upon "seasonal liquidation, and when that fell down, they were unable to go on."

"The drought and falling cotton prices were important contributing factors," he said, adding southern banks were too "remote" from stock market operations to be affected by events in Wall Street in the past two years.

Most of the closed banks in the south, he said, entered the last season "over extended." They were carrying obligations of customers but were borrowers also.

He agreed with previous witnesses that rural banks should be required to have a minimum capitalization of at least \$50,000.

Parties Draw

Sydney, N. S. W.—Midnight parties aboard the America, sailing ship Heler B. Sterling have been given much attention in the newspapers and police say they are powerless to act because the vessel is in American territory. The vessel owes port dues and needs repairs. DAVIS WINS DAMAGES IN COURT HERE

Grimesland Man Is Awarded Judgment for \$1283 Against Norfolk-Southern

Sam P. Davis, of the Grimesland community, was awarded a judgment for \$1283 against the Norfolk and Southern railroad in the opening session of the one week civil term of Pitt County Superior court here yesterday. He was suing for the loss of a leg which he sustained when run over by a Norfolk and Southern train sometime ago.

Although a virtual agreement had been reached at the expiration of the hearing, the case was allowed to go to the jury to decide the issue.

Under terms of the agreement Davis will receive \$750 for personal injuries and \$533 for hospital bill. Immediately after completion of the case the court began hearing in the caveat proceedings of Mrs. Church Perkins and Mrs. J. R. James against their mother, Mrs. D. R. Perkins. They are attempting to set aside the will of their late father who bequeathed his entire estate to his wife in fee simple.

The veaveators contend that the will was drafted in this manner as result of undue influence which Mrs. Perkins brought to bear upon her husband during his last days of life, and also that he was not mentally responsible for his conduct.

Mrs. Perkins, on the other hand, maintains that her husband was fully aware of the details of the transaction and meant that she should receive the property in fee simple instead of for a lifetime.

The case is being vigorously contested on both sides and was not expected to be completed until late this afternoon.

President Hoover Signs Postal Bill

Washington, Feb. 17.—(AP)—President Hoover today signed the bill fixing working hours for postal employes at 44 hours per week.

Announcing his approval, he said he intended to send to Congress a recommendation that a commission or the regular committees of Congress investigate means of increasing postoffice revenues.

"At the present time," President Hoover said, "it appears that the Postoffice Department will have a deficit of approximately \$100,000,000."

"This is largely due to increases in pay and the reduction of working hours of postal employes."

"It is only just to the country, he said, that there should be some means of increasing postal revenues to meet the increased expenditures."

Inform King Alfonso That He Cannot Secure Collaboration of the Republicans and Socialists and Would Have to Renounce His Task; He Advises King to Call Upon Melquiades Alvarez

Madrid, Feb. 17.—(AP)—Melquiades Alvarez, chief of the Reformist party and one of the leaders in the demand for a new constitution in Spain today declined King Alfonso's offer of the premiership.

A military movement, apparently intended to attempt the establishment of a military dictatorship, began late this afternoon.

Two artillery units near Madrid mounted long range guns and trained them on the capital. Civil guards were being mobilized throughout the city this afternoon.

Machine guns were placed at all strategic points and troops were held in their barracks in readiness for action if it should become necessary.

A group of high army officers, reported to be disgusted because the king seemed to be yielding to the left, were reported preparing to seize the power and repeat the coup by which Primo De Rivera seized the dictatorship.

Madrid, Feb. 17.—(AP)—A new political crisis, in which loomed the threat of a military dictatorship, was thrust upon Spain today at noon with failure of Jose Antonio Sanchez Guerra to form a government on a basis of liberal constitutional revision.

Sanchez Guerra, designated by King Alfonso yesterday to get together a cabinet, went to the palace at noon today and informed the king that he had been unable to secure the collaboration of the Republicans and Socialists, radical left groups, and would have to renounce his task.

He advised the king to call upon Melquiades Alvarez, another advocate of constitutional revision to limit the powers of the throne and leader of the "Reformist" group of the Spanish Conservative party. Alvarez, if anything, would be regarded as more radical than Sanchez Guerra, whose designation by the king yesterday was regarded by monarchists as a surrender to the extremists.

The development, which came with astonishing suddenness, threw the political situation into the utmost confusion and made developments extremely uncertain.

A large military clique is extremely dissatisfied with yesterday's events, which they consider constitutes an unnecessary surrender by the king of royal prerogative, and it was within the bounds of possibility today that some section of the group would attempt a coup d'etat to reestablish a dictatorship similar to that of the late General Primo De Rivera.

Sanchez Guerra failed to get together a cabinet on what probably was the most liberal program a Premier designate has advanced since the days of the Spanish republic in the early seventies.

Before accepting the king's invitation to head a new government to replace that of General Damsasco Berenguer which resigned yesterday, he exacted a promise from the king to call a constitutional convention which would rewrite the constitution of 1876 and decide what form the future Spanish government was to take.

Hoboes Offer a Solution For Their Own Case

Rocky Mount, Feb. 17.—(AP)—Louis Eucampopolous and Veto Magaseou got 30 days for vagrancy. They were sentenced to the roads, not to jail. But convict camp guards refused to have anything to do with them. In the first place, the guards said, there wasn't any room for them at the camp, and in the second place, how was anybody going to put their names on the records.

So Louis and Veto are back in the city jail and police are scratching their heads. The New York hoboes offered a solution by expressing eagerness to continue their travels.

DIES FROM INJURIES RECEIVED IN BATTLE

Morganton, Feb. 17.—(AP)—Deputy Sheriff Emore Wilson, wounded a month ago in a gun battle with alleged moonshiners, died last night.

Bill Dail, charged with the shooting, faces a murder charge.

## Wales' Trip Causes U. S. No Worry; Latin Trade Good

Washington—(AP)—The South American trip of the Prince of Wales and his "kid brother," Prince George, may cause some feminine hearts to palpitate, but Uncle Sam's position as the big business brother of Latin America seems secure. Foreign trade experts of the Department of Commerce do not believe American markets in South America will be jeopardized by the British business-baiting tour of the two princes. It may sell a few more high priced automobiles and English sports toys, they say, but business in the main probably will continue to go to whatever country can give the best service.

Foreign efforts to capture trade now going to the United States depend on the ability of foreign producers to compete successfully with specialized American products, says George J. Eder, chief of the Latin American section of the Department of Commerce. Chief among these are automobiles, agricultural and industrial machines, and motion pictures. The United States now buys from and sells to Latin America considerably more than Great Britain, Germany and France combined. Prior to the 1929 world depression, this country's trade with Latin America amounted to more than \$2,000,000,000.

Some Latin Americans have stressed the desirability of "buying only from those who buy from us"—meaning Europeans. "But," says Dr. Julius Klein, assistant secretary of Commerce, "the fact is that Latin American countries sell to us considerably more than they purchase from us." United States trade with South America has increased tremendously since the World War, passing Germany and the United Kingdom, which held second and first places, respectively. In 1919, American exports to South America were valued at \$177,627,000; the exports of the United Kingdom were \$307,917,000 and of Germany, \$290,730,000. In 1927, our exports were \$530,958,000; the United Kingdom \$334,741,000 and Germany \$102,447,000.

Argentina, where Great Britain is concentrating her trade expansion efforts, is the leading South American market of both the United Kingdom and the United States. Government statisticians point out that while America has "encroached" to some extent on British lines of trade with Argentina, the progress can be attributed almost entirely to new products typical of American industry, such as the automobile.

"The people of Buenos Aires are almost as familiar with our motor cars as we are ourselves," said Dr. Klein. "Almost equally popular are our motion picture films, our farm equipment, our office appliances and other products of our mills and workshops." Major British exports to Argentina are coal, steel rails, tin, woolens and cotton cloth. On the other hand, the United Kingdom buys more from Argentina than does the United States.

Durham, N. H.—(AP)—With competing strictly fresh western eggs selling for 18 cents a dozen, New England poultrymen see themselves approaching the necessity for an egg co-operative marketing association.

W. T. Whittle of Milford, N. H., criticizes lines of trucks making daily trips down through New Hampshire, picking up each day's output of eggs and converging at a convenient co-operative packing plant where the eggs will be graded, cartoned and labeled. Another string of trucks will carry them to the grocer's shelves each day—but only a day's requirement at a time. "We must realize," he says, "that eggs are judged by their freshness rather than their nearness to market."

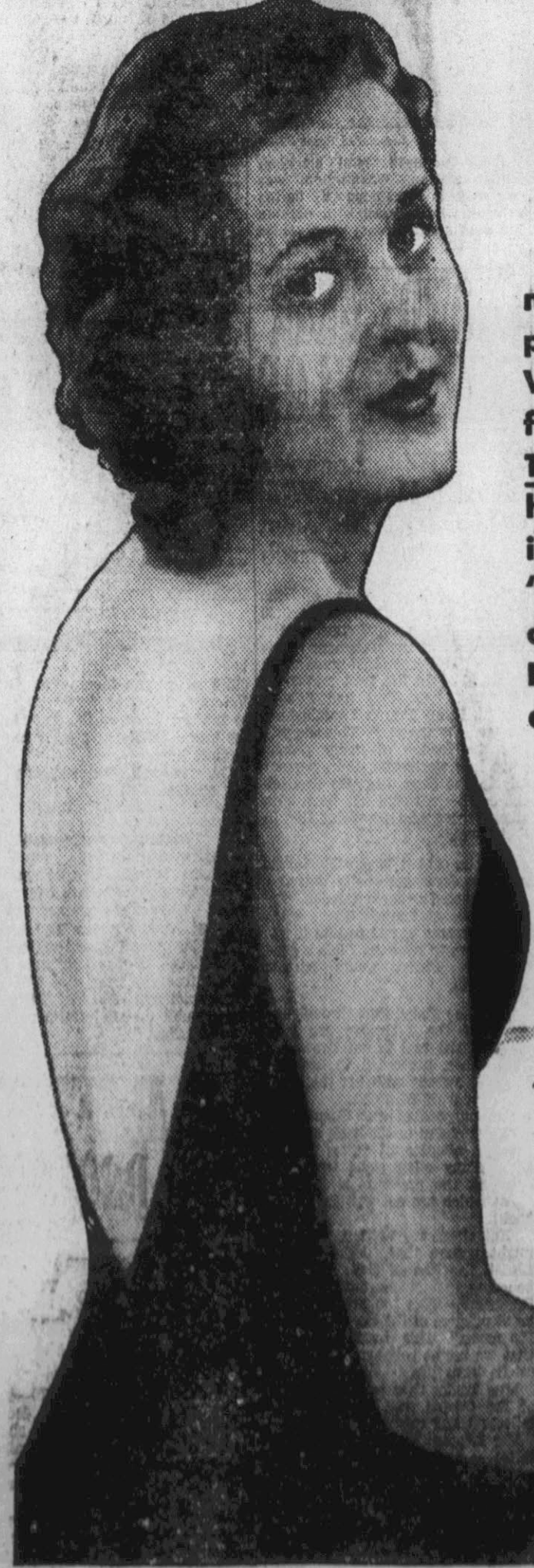

## Celebrities Take Part In Argument Over the Cornpone

Atlanta, Feb. 17.—(AP)—The Hon. Huey P. Long, LL. D., governor and senator-elect of Louisiana, and the Atlanta Constitution were engaged today in a battle of bristling language over whether cornpone should be dunked or crumbled in poltikker.

Long stands for dunking while the Constitution maintains that southern tradition requires crumb ling. There have been two exchanges between these stalwart warriors with Long's final Sally scheduled for publication tomorrow and meanwhile such eminent authorities as Governor Franklin D. Roosevelt, of New York, adopted son of Georgia, and Senator-elect James Hamilton Lewis, of Illinois, a former Georgian, have been called upon by the Constitution to join against Louisiana's fiery statesman.

For the benefit of the untitled, let it be explained that poltikker is not what the name might imply, but the essence of certain greens, such as turnip-tops, cabbage and spinach, and beet-tops, and green beans boiled and seasoned.

Certain admirers have called the substance ambrosial on which description Long and the Constitution do not differ, but how the cornpone should be contacted with the poltikker is something else again.

The argument started a few days ago when the Constitution in an Editor's note questioned Long's statement that he had dunked cornpone in poltikker for the benefit of visiting bond-buyers.

Yesterday Long telegraphed the Constitution that he did not object to questioning "my political sagacity or legal capacity," but he would tolerate no aspersions on his political recipe.

The Constitution replied that his position was "unbeatable" and a hresy "to stigmatize this fair section."

While Long's next sally is awaited, Georgia's governor-elect Richard B. Russell, Jr., is endeavoring to play the role of peacemaker. He said he personally crumbled his cornpone instead of dunking it, but "I think it is powerfully good either way."

## Three Burned To Death In New York

New York, Feb. 17.—(AP)—Two women and a man were burned to death early today in a fire which swept through a six story brick tenement on the congested lower East Side. Panic-stricken tenants escaped in their night clothes.

## FARM NOTES

It is estimated by farm authorities that the monetary loss through wasted manure each year is greater than the total sum expended annually by farms for commercial fertilizer. In 1929, farmers of the nation bought 7,914,638 tons of commercial fertilizer and wasted as much or more manure. Plant food in manure can be preserved by a properly built manure pit. Each ton of manure saved is worth from \$2 to \$7 when used as fertilizer.

Grooves in the floor of a milk cooling tank, made by pressing strips of wood into the concrete before it has hardened, will expedite cooling. The grooves allow the water to circulate under the cans and cooling takes place from the bottom as well as the sides.

Two and a half to three square feet of floor space and eight to ten inches of roost per bird are needed, under ordinary farm conditions, in poultry houses. Overcrowded and unclean poultry houses often harbor diseases. Concrete floors are preferable because their smooth impervious surfaces are very easily cleaned and disinfected.

A can of fresh milk placed out of doors when the temperature is 8 degrees below zero, takes three and a half hours to cool to 60 degrees, according to experiments conducted by Dr. James D. Brew of Cornell University. In an ice milk cooling tank, Dr. Brew found the milk cools to the required temperature in half an hour. Immediate cooling is necessary to prevent milk spoilage. The cooling tank is a proven essential to a dairy farm.

Seven out of every 24 people who die in fires in the United States each year are farm folks. Fireproof construction is one of the greatest needs of the American farmer. Isolated as he is from fire protection, the farmer can eliminate the fire hazard by building with fire-safe material.

In building foundations for small structures without basements earth walls of the foundation trench may be used as forms if the dirt does not cave. Planks laid on the ground along the side of the trench will prevent caving and provide a convenient runway for wheelbarrows.

## Chinese Bachelors Form Art Colony

San Francisco, Feb. 17.—(AP)—An art colony of young bachelors was formed in San Francisco's Chinatown today, coincident with the dawn of a new Chinese year. A group of painters and one sculptor agreed to live in the same house on a cooperative club basis and devote their lives to art.

The Chinese were rounded up by Otis Oldfield, a teacher at the California School of Fine Arts. Some are his students. Others have recently come from China or Hawaii. Their work has attracted much attention at the art school, but is almost unknown to the public.

The boys work in laundries, as house boys or wherever they can make a few dollars. With every cent they do not need for food, clothing and shelter, they buy cases, frames, canvas or paints.

In living together in the same house, their only agreement is that enough work shall be done to pay expenses. The remainder of the time is to be devoted to development of their talent.

February 28 the boys will have their first exhibit, a preview of selected paintings for newspapermen. If it "clicks," a public exhibition will be held later.

The real leader, Yen Gee, who has several paintings on exhibition in Paris, is now in Philadelphia. He plans to return in a few weeks to join the group in "La Vie Boheme a La Chinoise," as one artist phrased it.

# Market Report

### COTTON MARKET

New York, Feb. 17.—(AP)—Cotton opened steady today at an advance of 10 to 14 points in response to relatively firm Liverpool cables, a more hopeful view as to prospects for the settlement of disputes in India, and continued buying for both foreign and domestic trade accounts.

Brokers with Japanese connections were reported buyers again during the early trading and while the advance met considerable realising, offerings were quite readily absorbed. May contracts sold up to 11.25, or even with the previous high point of the movement, while October advanced to 11.75, making a new high for the present upturn. The market was within 3 or 4 points of these figures at the end of the first half hour.

Liverpool cables reported continental and Bombay buying in that market and said there was a fair cloth demand from the British home trade and South America with more inquiry for cotton yarns.

### STOCK MARKET

New York, Feb. 17.—(AP)—Despite a smoke screen of bullish activity in the fast moving issues, the stock market encountered substantial liquidation today, and after midday the trend turned unmistakably downward.

The market fluctuated widely during the morning, and several issues were pushed up 4 to 7 points but by midday showed losses of a point or two. In the meantime the bond market crept lower under moderate selling pressure as bankers interpreted the progress of the soldier bonus compromise measure as foreshadowing a large volume of government financing.

Issues selling a point or two under the preceding day's closing levels included American Can, American Telephone, International Telephone, General Electric, General Motors, Westinghouse, Electric Power & Light, North American, Lowry and DuPont. Early advances of 3 to 7 points in Allied Chemical, Ebers Case, Johns Manville, Worthington and Vanadium were lost, wholly or in part. Auburn converted an advance of 6 points into a loss of greater extent. U. S. Steel advanced nearly 2 points and Bethlehem nearly 3, then reacted. The former was pushed up to its best level of the movement several times but each time it was turned back.

The churning about of the list resulted in a heavy turn over, but it took higher prices to bring out any large volume of selling. Offerings lightened when prices dipped under yesterday's final prices. The selling appeared to be a combination of profit taking, bear selling, and liquidation which had been deferred for better prices.

In conservative quarters there was a feeling the bull campaign was getting out of hand.

While business reports do not provide any conclusive proof that March and April will bring the ex-

pected business upturn, sentiment among business executives has improved markedly with the growing conviction that the depression has at least touched rock bottom.

Credit conditions maintained the firmer tendency which appeared at the start of the week. Call money was unavailable under the official rate of 1 1/2 per cent.

### HOUSE RECEIVES TWO SCORE BILLS AS SENATE DEBATES UMSTEAD - WITTEBEE BILL

(Continued from page one) bill to submit a constitutional amendment to the voters changing the terms of office of county coroners and sheriffs to four years.

Among the 44 bills given the House were: A bill to repeal the workmen's compensation act; a bill to provide that bonded indebtedness of municipalities for water plants be cared for by increased water rates; and a bill to provide supervision of swimming pools and bathing beaches.

Attacking the personnel measure in the Senate, Senator Baggett of Harnett, termed the measure "undemocratic and contrary to the principles of North Carolina government." Mr. Baggett lamented the apparent growing tendency towards the establishment of bureaus and commissions to do the work once entrusted to people elected to public office.

Senator Umstead of Orange, one of the authors of the bill, defended its provisions and declared there was a crying need for it. He expressed the opinion it would save the state \$1,000,000 in salaries.

After the approval of the bill on second reading 44 to 2, Senator Hinsdale of Wake, sent up an amendment to make one member of the personnel commission an employe of some state department and Mrs. McKee of Jackson, sent forward one to make one member a woman.

The House passed the divorce bill of Johnson of Pender on second reading after amending it so it will not affect property rights but carried over for final approval. Last week the House killed two divorce bills.

The House also took up the moss measure to define cotton gins and provide for the tagging of cotton bales. In the middle of the debate the House adjourned until noon tomorrow in recognition of the service to North Carolina of James A. Young, former insurance commissioner, who celebrated his 78th birthday today.

The Senate carried over the personnel measure until tomorrow without acting on the amendments. The bill was set as special order at the close of regular business. The Senate adjourned to meet at noon.

In the House, after adopting two resolutions, one requiring departmental and institution heads to submit lists of employes and their salaries and the other to appoint a committee to confer with a South Carolina legislative committee on automobile reciprocity, the Thomas of Anson bill relating to county courts was passed with 68 counties exempted.

The bill would allow county commissioners to set up county courts with criminal jurisdiction. The House then started debate on its third and last divorce bill, by Johnson of Pender, to allow divorce proceedings to be instituted by either party to a separation of five years. Under the present law only "the injured party" can file proceedings. Last week the House killed two divorce bills seeking to change the period of separation necessary.

The Senate passed the following bills: HB 216—Morphew of Graham, to repeal the dog law as it applies to Graham county. (Tabled last night but reconsidered today.) SB 94—Price of Union, relating to recorder's court in Monroe. HB 183—Halstead of Camden, relating to the salary of the sheriff of Camden. SB 196—Gwyn of Rockingham, to extend city limits of Reidsville. HB 404—Doshier of New Hanover, relating to pay of New Hanover county commissioners. SB 24—Committee substitute, relating to vital statistics in relation to the pension bills. SB 25—Committee substitute, to require monthly check of pension rolls by bureau of vital statistics. EB 61—Clarkson of Mecklenburg, to protect constables in the exercises of their duties in Mecklenburg county.

Gastonia, Feb. 17.—(AP)—Urged to wage a determined fight for cash payment of veterans' compensation certificates and for better care of disabled veterans, post and unit officers of the North Carolina Department of the American Legion and Auxiliary returned home today from their conference in this city.

The meeting, which closed last night with the post officers' ball was attended by Ralph O'Neil, national Legion commander; Mrs. Robert Lincoln Hoyall, national president of the auxiliary, and other representatives of the national organization. Con. C. Johnson, of Mooresville, state commander, presided.

Henry L. Stevens, of Warsaw, a past state commander in an address before the conference, urged the Legionnaires to fight for cash payment of the compensation certificates and better provisions of disabled veterans.

The Legion will never rest, he asserted, until the disabled men are properly provided for, with a bed waiting for every veteran instead of thousands of veterans waiting for beds.
