Veterans Relief And The Muscle Shoals Bill Hold Limelight At Washington

Congress More Concerned With Two Big Issues Than Minor Matters; Do Not Believe President Will Call Extra Session If Vets Bill Is Passed Over His Veto.

Washington, Feb. 21.—(AP)—Congress was more concerned today about veterans relief and Muscle Shoals legislation than it was routine measures before it.

The veterans measure was at the White House with a veto assured but party leaders discounted rumors that the president might threaten an extra session to raise money to meet its obligations if it were passed over his veto.

Senator Reed, Republican, Penn., who conferred yesterday with the President on the bill, said he had not heard the suggestion that Mr. Hoover was contemplating an extra session under the circumstances.

The House today considered miscellaneous bills as the Senate worked on the last of the regular supply measures, that for the navy Senator Blaine, Republican, Wisconsin, interrupted the course of the bill to urge District of Columbia legislation.

The House Ways and Means committee closed its hearings on proposals for an embargo on oil importation and fixed Monday for a report. A compromise plan was in the making.

There are twelve members of the company, and all of them are volunteers. They do not have to be urged to go to a fire, but there every time needed and do not fail to put in their share of the work required in handling a blaze.

Fred Barnhill, chief of the department, is an old and experienced hand at the firefighting game, and is always lending his encouragement to the creation of a more efficient machine for safeguarding the life and property of the community.

It is impossible to estimate the value of firemen to a community. Their services at times are not capable of being estimated in terms of dollars and cents, and it is up to the citizenship to honor them whenever given the opportunity.

MRS. WRIGHT HOSTESS TO END-OF-THE-CENTURY CLUB. One of the most delightful club meetings of the year was held with Mrs. Robert H. Wright Tuesday afternoon. The club was called to order by the president, Mrs. L. C. Arthur, and several items of business disposed of. The books were discussed and exchanged. Miss Sallie Joyner Davis gave the program for the afternoon using "The Present Condition of India," as her subject. Miss Davis said that no understanding of the present conditions of India could be had without some knowledge of the racial antagonisms, the religious prejudices, the caste distinctions, the historic enmities and barriers of language which divide the three hundred million human beings who inhabit the country that is twenty times the size of England and Scotland. Then she traced briefly the struggle for self government which has been going on for years under the leadership of Mahatma Gandhi became acute last spring when he urged civil disobedience by non-violence. This began with the violation of the salt tax, which led to the destruction of many lives and much property and the imprisonment of Gandhi himself and thousands of his followers.

Miss Davis said that while Gandhiseems to be the embodiment of the spiritual qualities of the masses of India, he is unfitted for leadership in the national movement now going on, because he is unable to take a realistic view of the situation. He is in revolt against the great economic and industrial tides that are slowly flooding India and transforming it. Miss Davis also gave a brief analysis of the report of the Simon Commission that was created sometime ago to investigate conditions and make recommendations to the British government. This was followed by a discussion of the Round Table conference held in London during the last three months. Miss Davis said that while the conference failed in many respects, many think it paved the way for the dominion status of India in the not too distant future.

This talk was decidedly one of the most interesting that has been given this year and was thoroughly enjoyed by everyone. PROBE PLAN TO KILL KING ZOG

Adjutant to Albanian King Slain by Assassins Firing Upon the Monarch

Vienna, Feb. 21.—(AP)—Precautions for the safety of King Zog I, 36, self-made monarch of Albania, were redoubled today as police investigated an unsuccessful attempt against his life as he left the opera last night.

The king's adjutant received one of the twelve bullets intended for the monarch and was killed instantly. Another bullet wounded an Albanian court official, M. Lipozova, in the hip.

The two assassins, who gave their names as Asis Cami and Nak Tielezzi, were captured by chauffeurs of other cars standing behind the royal vehicle. They were badly manhandled. Questioning brought no other explanation than they had acted through political motives.

A blood feud exists among the Albanian mountaineers against the king and there have been frequent attempts to kill him. He rarely emerges from his palace at Tirna without clouthing his movements.

He came to Vienna last month to seek treatment for an indisposition which was diagnosed as a disorder brought on by his smoking 150 cigarettes a day.

King Zog before the World War was head of the Zogolli a ruling family of the Masi district. He fought in the Austrian army during the World War and afterward entered the political life of his own country. He became premier and then was elected president, holding that office for three years before proclaiming himself king late in 1929.

He has never been crowned, rumor having it that he is afraid the coronation would be attended with a new attempt against his life.

### COTTON MARKET

New York, Feb. 21.—(AP)—Cotton opened steady today at a decline of 5 to 8 points under continued near month liquidation and realizing in later deliveries, which was promoted by relatively easy cables and the proximity of a two day adjournment over Monday's holiday.

Tuesday will be the first March notice day and liquidation of that position was more active this morning than was absorbed by trade interests against sales of later deliveries. Trade interests were buyers on the opening decline which also brought in some covering by recent sellers and the market was fairly steady at the end of the first half hour, with May selling around 11.19 or about 3 points up from the lowest and within 3 or 4 points of yesterday's closing quotations.

Liverpool cables reported hedging with local and foreign liquidation in that market and said there was a moderate business in cotton cloths for shipment to Egypt and South America. The amount of cotton in shipboard awaiting clearance at the end of the week was estimated at \$7,000 bales against 121,000 last year.

### STOCK MARKET

New York, Feb. 21.—(AP)—Bull leaders launched a fresh advance in today's short session of the stock market, after stoutly holding the line against a wave of pre-holiday liquidation.

### PROVE ATHLETIC TEST FOR BOYS HERE

The American Committee on Athletic Standards for boys, will award to each boy passing any of the three tests an engraved certificate.

### BATTLE TO DELAY ACTION OF HIGHWAY BILLS BEGINS IN THE STATE LEGISLATURE

(Continued from page one) Representative Spence of Moore, chairman of the finance committee, rose to say his remarks yesterday about raising \$19,500,000 in revenue were not a reflection on Mr. Day, who has a revenue bill in committee. Mr. Spence said the state tax commission had estimated Mr. Day's bill would raise \$680,000 annually, while its author claims it will get millions.

Mr. Spence declared that the raising of the necessary money to fulfill the mandate of the MacLean law is "a year's problem." Representative Lumpkin of Franklin, admitting he was a signer of the "Round Robin" declared that the Legislature should not hold up important legislation and said

the road bill should be passed without delay. The Senate passed six local bills before again resolving itself into a committee of the whole to continue consideration of the local government finance act, section by section.

Both houses met in regular meeting today for the first time on a Saturday since the session started. Any bills ready for consideration could be taken up whereas previously the short Saturday meetings have only considered local measures.

The House got a bill by Johnson of Caswell to repeal the marriage bans law passed by the 1929 Assembly, which requires five days notice before marriage license can be procured.

In the Senate a bill was sent up to provide that counties may levy an ad valorem tax on legal and equitable titles in real estate. The measure, by Baggett of Harnett, is intended to allow counties to tax the equity of redemption in real estate, which cannot now be done.

After taking up 14 more sections of local government finance bill, the Senate adjourned until noon Monday. At the end of the morning hour Monday the body will again resolve itself into committee of the whole to continue study of the 77-section act.

The House passed the Doshier bill to establish a state board of heaters and plumbers examiners. Monday night's session of the House will have two road bills before it as special orders, the House this morning having set the Crudup bill as a special order along with the Connor, administration supported highway bill. The Crudup bill, a minority report of the House roads committee, is contradictory to the Connor bill.

# BLUE FLEET IS RETURNING FROM PANAMA

## Completes Successful Defense of Panama Canal and Nicaraguan Canal

U. S. S. Arkansas, Feb. 21.—(AP)—The navy's annual major war game isgame is concluded and the "Blue Fleet" is returning to Panama after a determined and successful defense of the Panama Canal and the supposedly completed Nicaraguan Canal. Its aircraft have demonstrated splendid capabilities both for search and for attack.

Wide flung aerial and surface searches located for a sea he advancing "Black" fleet in two main detachments, one depending upon the Nicaraguan Coast, near that canal, and the second aiming for the coast of the Republic of Panama westward of the Panama Canal.

The Blue forces concentrated after discovery of the enemy and attacked both detachments in force by aircraft and surface vessels on Thursday and so crippled the "Black" fleet that a successful attack upon the canals was no longer possible.

At 10 P. M., Monday, word was received that the "Black" fleet, nearing the coast was to arrive within a few days. Within the hour all "Blue" ships had left Panama, at top speed to search for the enemy. The dirigible Los Angeles swept a wide arc from Panama to the sea and back to the mother ship Patoka.

The southern area, down the South American coast and up to Costa Rica, was covered by patrol planes searching far out to sea. First contact with advancing enemy was made by planes from the Cruiser Trenton sighting the big

one in the late afternoon from which the over-matched cruiser retired at full speed eluding pursuit of the big battleship. Meanwhile the supposed enemy main fleet was discovered by the advance of the northern scouting line in the afternoon far to sea off the Nicaraguan coast and the northern force began concentrating for an attack.
