ATTEMPT LIFE OF CANDIDATE AT CHICAGO

Several Acts of Violence Reported On Eve of Chicago Mayoralty Election

Chicago, Feb. 23.—(AP)—An army of approximately 70,000 today made plans to maintain order in tomorrow's mayoralty and aldermanic primaries, with reports already before them of pre-election violence.

The reports came from the eighth and thirteenth wards and told of an attempt on the life of Theodore Clifford, a candidate for Alderman, of two sluggings and two kidnappings. Clifford reported to police that two shots had been fired at him from another automobile as he rode along in his own car last night.

Bernard Sheehan, 21, and John C. Grady, 30, complained they had been seized and beaten by hoodlums when they handed out campaign literature asking the selection of John O'Shay over John S. Clark. Simultaneously O'Shay headquarters reported that two unnamed men had been kidnapped in an automobile and attacked by their abductors before they were freed on the outskirts of the city.

Credentials were issued to 45,000 watchers of the city by Judge Edmund K. Jarecki, supervisor of the election, and a force of 15,000 judges and clerks of election will be augmented by 5,000 policemen and special city and county detail of several thousand men.

As primary day approached there was speculation about Alphonse Capone, the gang leader. Rumor had it that he was in Chicago. His attorneys said that he "probably" was, but just where could not be learned.

Meanwhile Mayor William Hale Thompson, Judge John H. Lyle, who issued a vagrancy warrant for Capone's arrest, Arthur P. Albert and George K. Schmidt, planned the windup of their fight for the Republican mayoralty nomination. None of them called for police guards.

Tennessee Robber Wounded In Fight With Ohio Police

Barnesville, O., Feb. 23.—(AP)—Wounded after a desperate running gun fight in which armed citizens of this village aided police, Lonnie Taylor, 24, and two of his companions were held here today for authorities of Knoxville, Tenn.

Taylor was decoyed here by a faked letter bearing the name of his young bride of a year, along with Bertha Ann, 24, and H. S. Smith, 26, all wanted at Knoxville on robbery charges.

Smith and the woman were arrested at a hotel without trouble, but Taylor barricaded himself in the bathroom of his wife's home when Chief of Police C. C. Bulger and three patrolmen entered.

Battering down the door, the officers met a fusillade of bullets, one of them ripping the chief's cap from his head, and in the confusion Taylor leaped from a second story window.

He seized an automobile and went speeding down the street in a hail of bullets from citizens who had hastily armed themselves and waited at street corners. More than 100 shots were fired, but Taylor was unscratched. A mile from town, however, his car failed to make a curve and he surrendered when surrounded in a field and wounded in the shoulder.

A dozen or more shots were fired. The lights were turned out. Men and girls fought desperately to get out. Tables and chairs were smashed to pieces. Windows were broken out. Clothes were torn and faces scratched. The dance floor became a mass of dancing pumps, hats, compact and other accessories.

Police found the stairways and fire escapes overrun as hundreds struggled to reach the street. One lad was found dead with his head in his fiancée's lap. Another made a move as though to draw his revolver and detectives shot him where he stood. Combatants had to be dragged apart. A cordon of police was thrown around the block and patrol wagons lugged all who had not fled to the police station.

With 60 men and 20 girls—many of them in their teens—on the grill, police reconstructed the events leading up to the panic. The "Happy Go Lucky Three," a social group, were holding their annual ball and had selected three judges to award the prizes for the best dancers. An argument arose over the fitness of one and the shooting started.

The slain man was Charles Barnes, 24, vice-president of the "Happy Go Lucky Three." The fatally wounded man was Michael Pizelle, 26. Most of the injured dancers had bruises, scratches, and

President To Determine Conditions of Veterans Before He Vetoes the Bill

Chief Executive Having Exhaustive Inquiry Made Throughout the Country to Ascertain Number of Vets in Distress

Washington, Feb. 23.—(AP)—President Hoover, preparatory to vetoing the veterans' loan bill, is having an inquiry made throughout the country to ascertain the degree and number of veterans in distress.

At the White House today, it was said various federal agencies are making queries to ascertain also how effective the legislation would be as a relief measure.

Under the bill the ex-soldier would be able to borrow up to 50 per cent of the face value of his adjusted compensation certificate.

The measure is to be vetoed between now and Thursday. Efforts are to be made in Congress to override the veto at once.

Taking \$1,000 as the average value of the certificates, the President was said already to have ascertained there are 210,000 veterans who would be able to borrow \$16,000,000 or \$80 a piece, if they had received no advance already on their certificates.

In the group having certificates ranging from \$250 to \$1,000, there are 500,000 veterans who—if they had not previously borrowed—would be able to get \$77,500,000 or \$137 each.

Mr. Hoover has received reports from two widely separated cities. In one there are 20,000 veterans and the veterans' administration was reported informed there are 159 of these veterans in distress and being cared for by relief agencies.

In the second city, which was larger there were 140,000 veterans and of this group 1,700 were reported in distress, and being cared for.

Before acting on the bill, President Hoover expects to receive complete reports from dozens of cities in widely separated sections.

He was also said to be endeavoring to ascertain how long it will be before the provisions of the present bill can be put into effect.

Provisional Government Calls For Volunteers To Crush Revolution In Peru

Defends Actions

Official Bulletins Admit the Capture of Arequipa by Insurgent Forces; Several Reported Killed in Fighting

Lima, Peru, Feb. 23.—(AP)—The provisional government of Lieutenant Colonel Luis M. Sanchez Cerro enlisted volunteers in Lima and Callao and moved troops from Oyon and Puna today to put down a revolution which began last Friday night at Arequipa, second city of the republic.

Official bulletins admitted that Arequipa had fallen to the insurgents and that "several" had been killed in fighting incident to capture of the city. These official communiques offered the only definite information available here, everything else being subject to a strict censorship.

Dispatches from Arica, Chilean border town, to Mercurio, Daily of Santiago, Chile, said all southern Peru had gone over to the new revolution but that the border censorship made it impossible to obtain definite information. Tacna and other border points were quiet.

The government called for 1,600 volunteers of 21 to 30 years of age for 60 days service. The decree stated that the call was made "for reasons of public order."

Although official pronouncement said the Arequipa revolutionary group was composed of adherents to the deposed President Augusto B. Leguia, now in prison in Lima, there was other information that it was composed of elements dissatisfied with President Sanchez Cerro's attempts to restore the normal life of the country.

Morrison Opposes Jonas Confirmation

Washington, Feb. 23.—(AP)—Senator Morrison, Democrat, of North Carolina, today went before the Senate Judiciary committee and announced his opposition to the confirmation of Representative Jonas, Republican, North Carolina, as district attorney for the western district.

The Senator said he objected chiefly to Jonas' opposition to the direct primary system in North Carolina. He also insisted that the retiring congressman should not retain his post as Republican national committeeman after becoming district attorney, as he understood was planned.

Chairman Norris of the committee, appointed a sub-committee to consider the nomination. With adjournment only a little more than a week away slight prospect for confirmation of Jonas was seen in view of Morrison's opposition.

Unless confirmed before the adjournment the Jonas nomination will die. President Hoover might give a recess appointment but this course is rarely taken on judicial appointments.

SENATE WILL GET LAST OF DRY REPORT

Data On Sixteen States Not Included In First Copy to Be Submitted

Washington, Feb. 22.—(AP)—Transfer to the Senate by the Wickersham commission of prohibition data on some of the 16 already sent to the capital was stated omitted from the material assured today by members of the commission.

While it was said at commission headquarters that data was lacking on conditions in six states or so, the remaining reports available are to be forwarded to the Senators. Thirty-two states were covered in the information sent last week.

Omission of some of the available data from the original commission was said at the commission to have occurred through an inadvertence.

One commissioner, who wished his name withheld, said there was some dissatisfaction among the members that any testimony had been submitted to the Senate without the approval of the full commission he asserted the selection of what was sent and what retained had been made entirely by Chairman Wickersham.

This same commissioner said there had been vigorous objections by the few members in the capital to the submission of the available "non-secret" data, on the ground that it would convey "only a half truth."

The omission of data on some of the states was explained as arising from the fact that only a few reports on them were available and these happened to be in the hands of members not now in Washington.

The 32 state reports now before the Senate were completed under the direction of Dr. James M. Moran, while he was prohibition commissioner under the Treasury Department.

Between 15 and 20 copies of each report were thus made available to the commission.

After the transfer of the prohibition bureau from the treasury to the Justice Department, however, only single copies of each state report were sent to the commission.

It was said the missing states fell within this category, and that the single reports upon them were in the hands of individual commissioners and would later be submitted.

WOMAN AGAIN ON THE STAND

Nancy Bowen Faces Cross - examination In Trial of Lila Jimmerson

Buffalo, N. Y., Feb. 23.—(AP)—Nancy Bowen, aged Indian woman, faced another day of cross examination today, her fourth day in the witness stand in the second trial of Lila Jimmerson, once known as the "Red Lilac" of the Cayuga Indians, now charged with the murder of Clotilde Marchand, wife of Henry Marchand, the artist.

Thomas F. Rogers, defense attorney, spent Friday in cross-examining old Nancy, the state's principal witness. The witness frequently informed her interpreter that she wouldn't answer Rogers' questions because it was "none of his business."

Occasionally, Nancy lapsed into English, which she supposedly does not understand, and on those occasions her replies took on a quality of invective and bitterness which was lost when she answered through an interpreter.

The climax of the trial is expected to come on Wednesday or Thursday, when Lila is expected to take the witness stand in her own defense. She has stated that she will tell her version of her relations with Henry Marchand, the artist—relations which Marchand swore at the previous trial were a matter of mere "professional necessity." Lila did not testify at her previous trial.

MRS. WOOTEN DIED EARLY THIS MORNING

Funeral to Be Conducted From Late Home Tomorrow Afternoon

Mrs. Lillie Hooker Wooten, 62, wife of J. L. Wooten, prominent business man and landowner, died here this morning at five o'clock. Although she had been ill since last Wednesday, her death came as a profound shock to the entire community and caused inexpressible sorrow among hundreds of friends in this and other parts of the state.

Funeral services will be conducted from her late home, corner Greene and Fifth streets, tomorrow afternoon at three o'clock. Rev. W. A. Lillycrop, rector of St. Paul's Episcopal church, assisted by Rev. J. C. Wooten, presiding elder of the Durham district of the Methodist Episcopal Conference, will officiate. Burial will be made in Greenwood cemetery.

Mrs. Wooten is survived by, beside her husband, a daughter, Mrs. W. I. Wooten, two brothers, W. E. and T. E. Hooker; and a sister, Mrs. F. C. Flanagan, and two grandchildren, all of Greenville.

Mrs. Wooten for years was closely identified with the religious and social life of the community. She was a charter member and former president of the End of the Century Club and a member of the Woman's Club. She was also a member of St. Paul's Episcopal church and for years was closely identified with the activities of the various departments of church work.

She was born at Hookerton, August 27, 1868, the daughter of the late Mr. and Mrs. T. E. Hooker. She spent her young womanhood in Hookerton and moved to Greenville following her marriage to Mr. Wooten 37 years ago. Since that time she and her husband had made Greenville their home.

DAME MELBA PASSES AWAY

Strange Illness Claims Life of Noted Singer At Melbourne, Australia

Melbourne, Australia, Feb. 23.—(AP)—The curtain was rung down today on the life of Dame Melba, one of the purest sopranos Grand Opera has ever known, after weeks abed with a strange illness which baffled her physicians.

Seventy-one years old, the famous prima donna for several days had fought a losing battle with a skin malady picked up in Egypt and aggravated by a long journey home from Europe before Christmas and the extreme heat of the Australian summer.

Friends believed she hastened her own end with insistence upon spending Christmas in her native Australia, disregarding the advice of her physicians in Europe under whose treatment she was growing better.

Known to all the world as the successor to Patti and Jenny Lind, Melba sang last in America at the New York Metropolitan in Faust in 1917-18 and after that was seldom heard in public. She was seldom heard in public. She was seldom heard in public. She was seldom heard in public.

Her most famous roles were as Gilda in Rigoletto, Violetta in La Traviata and Lucia. Other roles were the soprano parts of La Boheme, Tosca, Otello and an occasional brunhilde. Although the critics were lavish in their praise they sometimes complained of her coldness as an actress.

ILLICIT LOVERS PAY FOR DEATH OF PATROLMAN

Mrs. Irene Schroeder and Walter Dague Executed at Pennsylvania Pen

Rockview Penitentiary, Bellefonte Pa., Feb. 23.—(AP)—Irene Schroeder and Walter Glenn Dague went calmly to their deaths in the electric chair at Rockview penitentiary today just after break of dawn.

The state claimed of them the supreme price for the killing of a guardian of its highways, State Highway Corporal Brady Paul.

The woman went to the chair first, at 7 a. m. One contact was made and she was pronounced dead at 7:05.

Dague was placed in the chair at 7:08 and five minutes later was dead.

Mrs. Schroeder's face was pale, almost ghastly, except for a slight bit of rouge on either cheek, as she was brought into the death chamber. Her eyes were open until she was seated in the big chair, then she closed them and kept them closed until the hood was placed over her head.

Dague came in with steady stride and as he sat down in the chair, gazed left and right at the witnesses. The hood was adjusted and the electric contact was made while the prison chaplain still was offering up a prayer for the condemned.

The condemned pair were provided with breakfast at 5:30. They had grapefruit, toast, cornflakes and coffee.

MUSCLE SHOALS Report Adopted By the Senate

Washington, Feb. 23.—(AP)—The Senate today approved the Muscle Shoals conference report but then reconsidered its action—in order that the report could be debated.

Washington, Feb. 23.—(AP)—The Senate today adopted the Muscle Shoals conference report.

The conference report providing for operation of the government's \$150,000,000 power and nitrate plants on the Tennessee river in Alabama was approved by the Senate without a record vote.

It was the second time during the long years of controversy a bill has been sent to the White House providing for operation of the war-time plants.

The last time President Coolidge vetoed the measure. Some advocates of the present bill fear it will meet a similar fate.

The bill provides for government operation of the power plant and construction of transmission lines over which the power would be distributed with preferential sale to municipalities.

The nitrate plant would be leased for quantity production by private interests of fertilizer, if a lease could be found within a year. If no lease could be negotiated within this time the government would operate the plants for experimental manufacture of fertilizer. The bill also provides for construction of the Cove Creek dam on the Clinch river in Tennessee at an estimated cost of \$25,000,000.

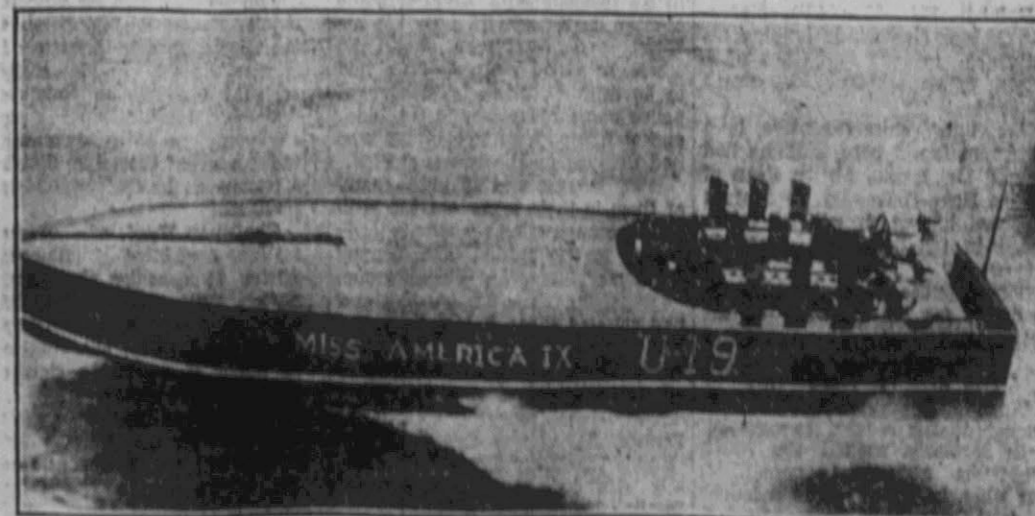

It was the wish of the young bride that the general appear in the gold embroidered uniform assigned to him by the board of general officers. Washington, however, wore his favorite blue and buff uniform and the old Continental cocked hat with the plain black fibbed cockade, a type of the days of '76.

The wedding supper was described as "the extreme of perfection and elegance in silver, china, linen and crystal." Cakes, bon bons and other dainties were supplied in abundance and many toasts were drunk to the health of the young couple.

Washington, Feb. 23.—(AP)—The Italian embassy today requested the Italian consulate in New York to send it for study a full report of the remarks made there Saturday night by Assistant Attorney General John Lord O'Brian.

The official has been quoted as having indirectly criticized Premier Mussolini in his talk. Ambassador Demartino declined to make any statement on O'Brian's speech before the Union League Club of Brooklyn, as reported in press dispatches. It was said on high authority, however, that the attitude of the embassy now is that since O'Brian made a public explanation that he was not casting aspersions on Italy or Premier Mussolini but merely drawing a contrast, no action would be taken.

The embassy has not communicated with the State Department.

URGES CUT IN LEAF ACREAGE

Floyd Says Depression Will End if the Farmers Plant Half As Much This Year

By GEORGE B. LAY "If the tobacco farmers of North Carolina will produce just half the crop they raised this past year and will specialize during 1931 on the production of the higher grades so desired by manufacturers, the present economic depression in the tobacco growing sections will end this fall," E. Y. Floyd, tobacco extension specialist at State College, said today Mr. Floyd insists that the farmers should, first of all, however, "live-at-home."

"The manufacturers are loaded up with poor tobacco of several grades," Mr. Floyd says. "The factories have no large surpluses of high grade tobacco and it is my opinion that the better grades in 1931 will sell for a fair price, a price at which the farmers can make a profit. Without doubt, low grade tobacco will not show any profit and possibly a loss during the coming season."

Mr. Floyd urges quality rather than quantity. He is stressing the necessity of an increased per acre yield of lower grades or as compared to a low per acre yield of quality tobacco. He is absolutely "sold" on the program of quality rather than quantity, and he is equally determined to carry the "Farm to Make a Living in 1931" slogan to every farmer he comes in contact with. "If the farmer will raise his supplies of food and feed, first, then he will be more independent in his methods of selling his cash money crops."

Mr. Floyd urges tobacco farmers to plant for production only what acreage the individual farm family can handle without hiring outside help. He insists on planting of tobacco on well-drained soils of uniform fertility. He urges against crowding of tobacco when put up in barns for curing, so that the burning will not result. And he feels that there should be much more care taken in pruning in the field, so as to get a uniform grade of ripeness and maturity and so that the farmers will do most of the actual grading of the tobacco before it is placed in the curing barn.

In speaking of the preparation of the plant bed, Mr. Floyd points out that one of the worst practices in the tobacco belt is the use of poor grade fertilizer. "These poor grade fertilizers do not pay," he says, "as they carry an excess of chlorine, which causes the growing plant to roll up and become thick and brittle and not grow normally." A good grade of fertilizer for the plant bed is necessary. Another mistake of the tobacco farmer is in allowing the flea beetle to injure young plants. The lack of proper and careful selection of the best suitable soils and locations for beds is another fault he finds with farmers in general. The failure to provide enough seed bed space to plant for the acreage planned is another difficulty, he says. He recommends the planting of a seed bed of 100 square yards for production of plants for from two and one-half to three acres, as such a plant bed space will allow the grower to grade his young plants.

In setting out the young plants in the field, Mr. Floyd says that one of the biggest mistakes is in failing to select uniform plants. "If the farmer would plant uniform plants together, then when he gathers the leaves, from time to time according to grades, he would be grading the tobacco leaves before he begins his curing operations in the barn. He would save much time and effort, and when the cured crop goes on the market grade by grade, he would obtain a higher price. When the farmer plants small plants next to more advanced plants, all in the same row, he makes it much more difficult to grade in picking and even to grade after curing for market. And all farmers know that a pile of tobacco will bring what the lowest grade therein is worth, nothing more. If the tobacco farmer would plant uniform plants and take care in picking and grading after the curing has been done the pie-broker would have a mighty hard time."

"Of course, the grower must have an ample supply of plants," Mr. Floyd points out. "Failure to have sufficient plants at the proper time is a grave mistake, which was quite general in the Eastern part of the State last summer." In preparing the land for planting of the young plants, Mr. Floyd recommends the putting in of fertilizer ten days prior to transplanting. He urges the use of an 8-4-4 (50 per cent mineral and 50 per cent organic) fertilizer. After the fertilizer is distributed he advocates running a plow along the row, so as to mix the fertilizer in the soil, and he urges especially a policy of planting the young plants in a bed rather than a list. Such additional work will pay, he has found, as rain will not leach out the fertilizer so quickly and in dry weather the plants will have a larger space for their roots.

ROAD BILL FIGHT HOLDS ATTENTION OF MEMBERS OF THE STATE ASSEMBLY

(Continued from page one) are enacted to place in effect the MacLean measure of state supported six-months schools by means other than an ad valorem tax, focused the attention of the state on the road question.

Governor Gardner is backing the road bill with all of his power and predicts it will pass both houses, but proponents of the MacLean measure claim 60 pledges to delay passage of the measure until the bills to secure revenue for the school have been passed.

Rumors current today were that the road bill would be taken up without delay by signers of the Day "round-robin" refused to concede that they had lost their fight.

Before resuming its study of the local government finance bill, the Senate passed a couple of local bills today and got one from Senator Wheelbee of Perquimans relating to economies of operation of public schools.

On motion of Senator Ward of Beaufort the constitutional convention bill, already by the House but amended in Senate committee, was set as special order when the finance bill is disposed of.

The Wheelbee bill provides machinery for operation of a six months school term but includes an ad valorem tax of not more than 20 cents to be used for school support. This provision is in direct contradiction of the MacLean law, passed by the Assembly earlier this session.

The House passed a resolution requesting Governor Gardner to report to it on work done by his unemployment and relief council and approved the Jeffress bill to provide for the completion of a survey of North Carolina not under way by the Federal government. The survey would cost \$82,500. The government would pay three-fourths and the state the remainder.

Approval was given the Crudup bill to amend the law relating to adoption of minors but the Jeffress bill to require inspection of summer camps by the State Board of Health was carried over, as was the Cherry bill to rewrite the banking laws.

The Senate completed its study of the finance bill as a committee this afternoon and reported the bill favorably, as amended during its three day course in committee. The bill was set as special order

for tomorrow. Without a special order before it, the Senate will meet at 8 o'clock tonight to take up routine work and will assemble at 10:45 tomorrow.

Former Governor Harry Flood Byrd of Virginia will address the Assembly in joint session at 11 o'clock tomorrow.

The House disposed of several more bills of state-wide importance and recessed to take up the road Acts tonight.

The Halstead drainage bill, making unpaid drainage assessments a lien against land, was passed by the House but the bill to make every officer of the law a deputy warden to enforce conservation laws was tabled.

Debatz was started on the Baggett bill to require children to attend school until they are 16 years old but the discussion was interrupted by the motion to recess.

HB 389—Lgrande of Davie, to abolish the office of treasurer in Davie.

ILLICIT LOVERS PAY FOR DEATH OF PATROLMAN (Continued from page one) teacher, and father of two children.

The woman, stolid and unromantic in appearance, and Dague, pale eyed and dapper, were bound together in an illicit love and a short career of bonanza.

Petty robberies and bold holdups perpetrated by the pair were climaxed by the killing of Corporal Brady Paul of the Pennsylvania Highway Patrol near New Castle, Pa., December 27, 1929. Patrolman Ernest Moore was wounded at the same time. Later as they fled west, the killers fought a policeman at St. Louis, and kidnapped and wounded one deputy sheriff and fatally wounded another in Arizona.

On the morning of December 27, 1929, Mrs. Schroeder, Dague and Tom Crawford, the woman's brother, had robbed a grocery store at Butler Pa. A report of the robbery was sent to New Castle. Corporal Paul and Moore sped out along the New Castle-Butler road and stopped all approaching automobiles.

When the officers stopped the bandit machine, they were probably off their guard because there was a woman and a small boy, Mrs. Schroeder's son, in the car.

Dague and the woman stepped from the automobile with drawn weapons. There was gun fire. Moore testified at the woman's trial that she fired at Paul. The woman admitted she actively engaged in the shooting. Paul and Moore fel-

the latter rendered unconscious by a bullet. The bandits sped on. Paul died about an hour later. Moore recovered to tell his story at the trials of Mrs. Schroeder and Dague.

Days after the gun battle, the authorities found Mrs. Schroeder's little son with relatives near Wheeling and the boy, investigators said, unknowingly furnished information that linked his mother with the crime.

In January came news of the kidnapping of Deputy Sheriff Joe Chapman at Florence, Ariz., by a woman and two men. Arizona officers engaged in a gun fight with the fugitives. Chapman and Deputy Lee Wright were wounded the latter fatally.

Arizona authorities gave over the woman and Dague to Pennsylvania for trial for the killing of Paul. The other man was Vernon Ackerman, alias Joe Wells, now serving a life sentence in Arizona. The authorities never learned what became of Crawford, although Dague's wife has said Dague told her Crawford was fatally wounded in the New Castle gun battle and that the fleeing couple buried him.

Mrs. Schroeder and Dague lost battle after battle in the state courts and before the pardon board and two governors to escape the death penalty. Their last hope vanished last week when Governor Pinchot refused to intervene.

DRY FORCES SET TO FIGHT

Dry Democrats Plan to Squelch Any Attempt to Line up Party for the Wets

Washington, Feb. 23.—(AP)—Whatever intentions Chairman Raskob may or may not have in regard to lining up the Democratic National committee on the wet side of the prohibition fence, dry members of the group are set for an aggressive try at squelching any such plan.

The committee will meet here March 5, at the chairman's call. Future policies he announced, will form a topic for discussion. Rumors have been current a resolution is being framed to push this steering group of the party off the prohibition fence. The rumors have not been denied.

Some of the dry Democrats on capitol hill have been roused to a fever heat of activity. Yesterday Senator Morrison of North Carolina, baby member of the Senate but no newcomer to national politics, asserted his group had sufficient votes to defeat any wet resolution. He is North Carolina's national committeeman.

Other Democratic leaders in Congress are trying to head off the issue by having the rumored resolution shelved now.

Senator George, of Georgia, has joined this group, asserting the committee has no right to form party policies, a function he holds belongs to the national convention.

This view has been communicated to the chairman. Incidentally the active dry count upon the support of Senator Robinson of Arkansas, in a pinch. He was running mate of Alfred E. Smith on the 1928 ticket and is party leader in the Senate.

The impending meeting, already drawing interest away from the closing days of Congress, has brought out a crop of presidential candidates. Most of those being boomed are far from dry.

Governor Roosevelt of New York remains the most discussed possibility here, but the names of Gov-

ernor Ritchie of Maryland, and Senator-Elect James Hamilton Lewis of Illinois, are among those being advanced by friends.

HOGS GET SURPLUS CORN SO FARMERS WON'T LOSE

Clemson College, S. C.—(AP)—South Carolina farmers are utilizing a surplus corn production in hog raising.

Authorities at the State College of Agriculture here point out that the state has a corn and feed surplus of 18 per cent above normal which is selling at a relatively low price.

They are urging farmers to use the surplus as hog feed, declaring hog prices will continue high, since the cornbelt crop last year was reduced by dry weather.

# SPORTS SLANTS

The five-man defense in basketball, standard style of play for cvn the smallest high school teams these days, was originated by the Eddie Stewart in 1909, while coaching at Allegheny college, Pa., according to Ray Peebles, sports editor of the Erie (Pa.) Dispatch-Herald.

Peebles writes to this column as follows: "You might be interested to know that credit for the introduction of the five-man system of defense in basketball belongs to Eddie Stewart, who introduced it at Allegheny college back in 1909. He stationed the three strongest men on his team across the center of the court with the other two behind them, and met the opponent's attack at that stage. The system was so effective that it was immediately copied, and Stewart was asked to visit other schools and teach it to the basketball squads."

Stewart, incidentally, had quite a record at Allegheny. In 1910 the Methodist lost their first home game the following year, and were then undefeated on their own court until 1915.

Stewart left Allegheny at the close of the football season in 1911 to coach both basketball and football, taking a position with the Oregon Aggies. He remained there for several years and then went to Texas where he was fatally injured in an automobile accident a little over a year ago."

A friend close to the California situation writes us that: Krut-Rockne, the shaggy headed dean of Notre Dame, had a good deal to do with bringing about the selection of "Navy Bill" Ingram as the Golden Bears' football coach.

Our informant says the field for the position finally was narrowed down to Ingram, Clark Shaughnessy coach at Loyola of New Orleans, Ossie Solem, of Drake, Brian Bierman of Tulane, and Chas Bachman of Florida.

"Krut-Rockne was a powerful factor in the selection and the above order was his rating," the letter said.

The Ramblers from Notre Dame have played Solem's Drake Bulldogs and Ingram's Navy Midshipmen for years and he knows the work of them at first hand. Bachman was slayer at South Ben under him. Shaughnessy and Bierman have been turning out great teams across the fence from each other on St. Charles avenue in New Orleans for years. Before Shaughnessy moved over to Loyola he had some fine teams at Tulane setting up a reputation for smart play that Bierman has upheld.

G. O. Mac Conachie, business manager in the United States for Capt. Malcolm Campbell, the British racing king, was chatting recently about the war-time steel league, where many big league stars spent 1917 and '18.

"That fellow Joe Jackson, 'Shoeless Joe' of the Old White Sox, was a marvel," MacConachie said. "I don't know of anyone who could hit a ball harder than he could and he could feel with the best of them, too."

"I remember one day Joe caught one ring on the nose and riddled it at Donie Busch, who was playing short. Donie was pretty good at going away with a hard driven ball, but he couldn't soften that one. He caught it right up against his chest and it knocked him flatter than a nEnglish heavy weight."

Joe didn't care what the pitcher was throwing or who he was. We used to ask Joe, after he'd slammed one out what kind of a ball he'd hit.

"Oh, I don't know," Joe would say. "It was spitter I guess, or maybe a fast one. No I believe it was a curve."

He never paid any attention to what they were throwing. His eye would tell him to hit it and he'd hit it, and how.

Joe was smart enough about a lot of things, but he really couldn't read. It was business manager for the Wilmington team, where Joe was playing and handled his money for him.

"A lot of those bums we had playing for us thought it was smart to take advantage of Joe's ignorance of the A B C's. Joe had a perfectly good excuse to escape the draft—his sister and mother were dependent on him, which is a lot more than some of the rest could say—but he was always afraid the government was going to call him."

He'd come into my office and say: "Mr. MacConachie, I'm in a lot of trouble. The government is sending a man down from Washington to get me and take me to the army."

"Who told you that, Joe? I'd ask him."

"Oh, I read it in the paper."

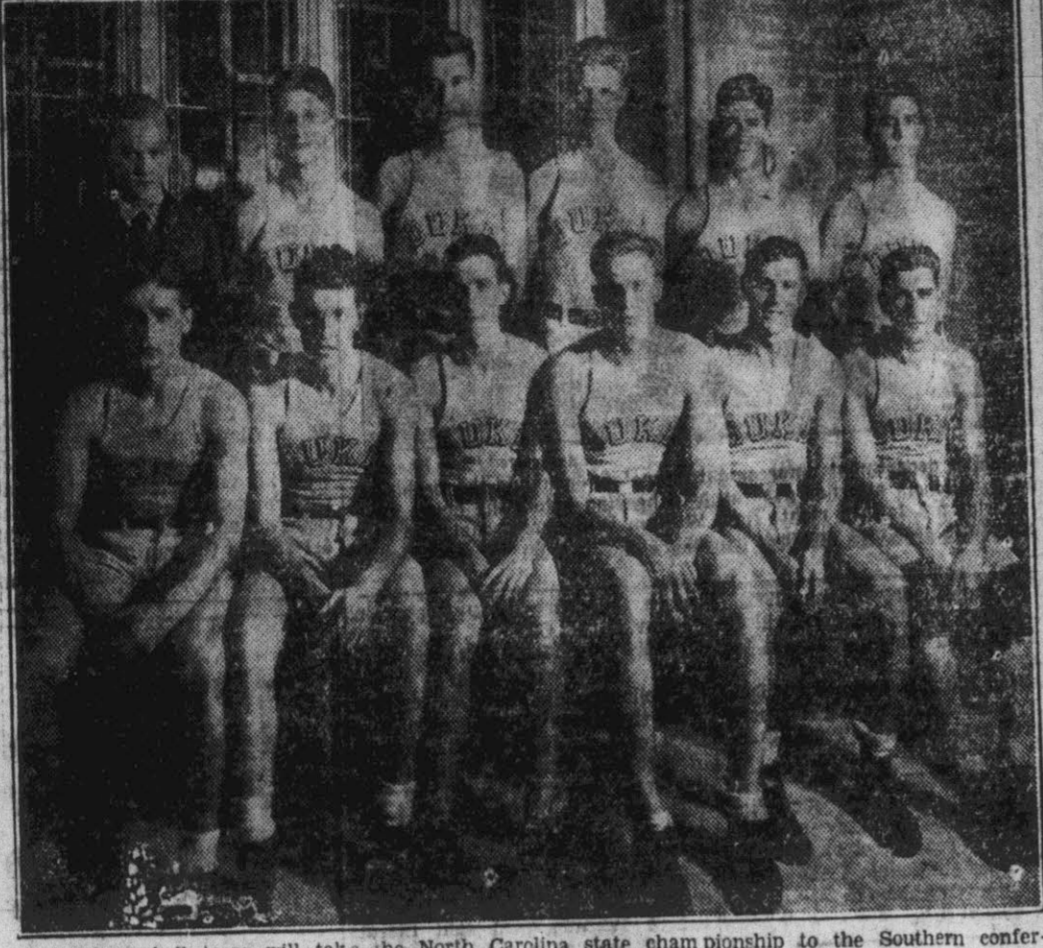
"Which paper, Joe? I knew he couldn't read."

## STRIBLING IS BELIEVER IN GREAT SPEED

New York, Feb. 22.—(AP)—Bill Stribling has lifted his dukes in professional combats; 290 times. He has flown 100,000 miles in 800 hours in the air. He has cracked up twice in 1200 landings. And the most serious accident he ever had was a fall from a bicycle. He was knocked unconscious and badly battered.

Stribling loves speed. Every time he gets his hands on the wheel of an auto-bus, sensible friends get out and walk. He drives as though he were trying to qualify for the championships at Indianapolis. He wants to try speedway racing some day. On the beach at Daytona, Fla., he showed a stock car up to 115 miles an hour.

As a youngster in Macon, Ga., "W. L." rode a wheel furiously before he ever saw a pair of boxing gloves. When he got enough money together he graduated to his motorcycle. The wind rushing into his face, tearing at his clothes gives him a tremendous thrill. He holds a transport license now, owns several planes, and the first of these is a big closed job. He doesn't like that one, he'd rather have a motorcycle again and that wing ripping at his face. Many night critics believe he lacks courage.

Everything he does is in a hurry. He wars everones out around him, runs up and down steps, bounces in and out of chairs, rarely has the patience to read for any length of time. He is impatient just before a fight. Cautious in critical moments has cost him at least two championship shots. His father and manager, "Pa" Stribling, is white with anxiety during Bill's matches.

"Be careful, son, don't get hurt," he tells him between rounds.

Stribling loves any kind of a competitor and hates to lose a game or an argument. He plays cards, checkers, dominoes, and with nothing at all at stake, perspires as though he were carrying a brick. He argues over every point.

Light clothes and bright colors irritate him and he hates blue serge suits because his mother clothed him in so many of them when he was young. He is almost violent in his likes and dislikes and speaks his mind freely and forcefully. He plays roughly with his friends and family but his mother dislikes are left strictly alone and are expected to fight shy of him. He'll cock a fist if a slighting reference is made about a friend. He is abrupt often undiplomatic, but mild mannered and hard to arouse to anger. He has the memory of an elephant when slighted.

One of Stribling's keenest disappointments was his parents' refusal to let him play football when he was a boy because the game was too rough. All that brawling over a football is his idea of a perfect way to spend an afternoon. He plays baseball almost as well as a professional, but there are too many rules. His big weakness is ice cream. He fills up at least once a day and often tucks away a large portion of the confection before he goes into the ring. He likes war stories but doesn't care for movies unless they are thrillers.

He shoots a gun, sters his plane and mans a cue stick all with his left hand. He writes and knacks fighters out with his right. He loves to visit with friends, hunt with them, take them flyine. Most of them prefer to stay on the ground.

Finally, he refused to play unless he got a raise.

"I was ready to let him be drafted if he felt that way about it," happened to speak to Hornsby about it.

## BOBBY JONES HAS WEAKNESS FOR OPERA

Atlanta, Ga., Feb. 23.—(AP)—If you gave Bobby Jones his choice of all masculine attainments, he'd like to be able to sing baritone.

Not that he aspires greatly to fill the vital spot in resonant nineteenth-century quarters, but because one of his passions is grand opera. He even likes German opera.

And he sometimes laments that he had to be born merely to play golf while the really lucky people can sing.

Bobby thinks that if he has any genius at all it is for play. He hates work in any form. He likes to hunt and fish. The first time he ever handled a .5 caliber service revolver he planted seven of his ten shots within the bulls eye.

But of all strange physical complications, Bobby is right handed and left eyed. He holds a pistol in his right hand but he aims with his left eye. It has worked out marvelously in golf, where you fix the portside optic on the ball and don't dare let your glance stray. It isn't hurt the pistol shooting. But it is a sore trial indeed when it comes to handling a rifle or shotgun. Bob has to keep the whole left eye closed when he's after birds with a scatter gun. He's a goat trapezist, though, and swings an eager stick in pool and billiards.

Bobby isn't particularly vain, but the ballooning waistline that sometimes afflicts the young man will be one of those things that will not be present when he displays his shots before the movie cameras of Hollywood. He won't diet, doesn't believe in it, but he works out daily with a physical director. In less than a month his weight of 185 pounds has shrunk to 175 and two inches have disappeared from his waistline. He is training harder for his motion picture debut than he ever did for a championship golf tournament.

For six years the galleries have been remarking how much heavier the young man has been getting but they were wrong. His five foot seven and a half inches of height will always give him a chunky look, but it hasn't varied much over a stretch of years. He will be 29 two days after the next Ides of March.

Bob has been careful of what he eats during a golf championship after some rather bitter experiences at the start of his tournament career. Last season he took little or no breakfast. He was always terrifically nervous before a day's play or else worried because he wasn't nervous. The more nervous he was the better he hit the ball. Luncheon between rounds in his more youthful days consisted of a slab of pie but they cost him too many strokes in the afternoon. New toast and tea is the maximum.

He ate all he wanted of anything after a day's tournament play but the last one—the final trick of golfers' grand slam—was at Mexico found his unable to sleep nights. It was the big shot and the strain affected him more than in any previous tourney.

Bobby spends most of his evenings with his wife and two youngsters. He reads aloud to Mrs. Jones, which is bad for his radio work because it encourages rapidity and casual inflection.

"Pa" Stribling will be quite happy if his show tomorrow night draws a \$50,000, at prices ranging from \$2 to \$5.

Walker, no longer concerned with the device of his middleweight title, has groomed himself for a slugfest with Risko, although "Good-time Mickey" will be under the handicap of conceding Johnny at least 25 and possibly 30 pounds.

## ALABAMA IS SET TO WIN TOURNAMENT

Atlanta, Ga., Feb. 23.—(AP)—Alabama today, for the second time in two years, found itself picked by the basketball committee of the Southern Conference to win the annual tournament starting here Friday.

Georgia, for weeks selected by sports writers as the favorite to take the tournament, was second to the Crimson Tide—in the opinion of the committee.

The committee has gone even further than that giving Kentucky third position and Maryland fourth. Considering the percentage, Georgia has won 15 and lost 1 game during the season—4 to Georgia Tech, for a percentage of 93; Alabama won 11 and lost 2 games, percentage .84; Maryland with 8 wins and 1 loss had a percentage of .88; next to Georgia with Kentucky fourth with 5 victories and 2 defeats, percentage .70.

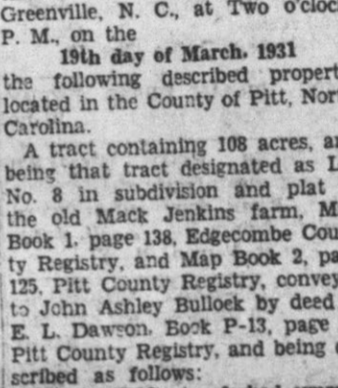

## NATION PAYS TRIBUTE TO WASHINGTON

### Birthday Anniversary of First President Observed at Nation's Capital

Washington, Feb. 23.—(AP)—With holidays for all but President Hoover and Congress, the capital devoted itself today to celebrating in earnest the 199th birthday of George Washington.

President Hoover remembered the father of his country yesterday by attending divine services in Alexandria. He occupied the pew in Christ church in which George Washington often sat. With him were Mrs. Hoover and their oldest grandchild, Peggy Ann. The broad avenues of the capital were lined with stars and stripes waving in a brisk breeze. Here and there the flags of foreign nations fluttered their tribute from the embassies and legations.

The churches held patriotic services yesterday for all lay organizations postponed until today the usual exercises. This morning a military mass at the Church of the Immaculate Conception was the principal service, attended by a large body of American Legion members and a guard of honor of marines from the Quantico, Va., base. Part of the picturesque ceremony was a presentation of massed colors. In the afternoon Memorial Continental Hall was the chosen scene of a program sponsored by the Daughters, Sons and Children of the American Revolution.

While devoting most of the day to work, Congress set its meeting hour early to permit the annual exercises in the House. Departing from the pattern of accepted custom, reading of Washington's farewell address was dispensed with, and an address by Representative Beck of Pennsylvania, substituted.

Philadelphia, Feb. 23.—(AP)—George Washington's outlook upon the world and the part in human affairs which he "requested of his country as of himself" were inspired by his Christian faith, the most Rev. James De Wolf Perry, Bishop of Rhode Island, declared today in addressing the 106th annual Washington's birthday exercises at the University of Pennsylvania. Bishop Perry delivered the oration at the exercises, and with Secretary of State Henry L. Stimson received the honorary degree of Doctor of Laws. Nearly a century and a half ago Washington received a similar honor from Pennsylvania.

### Plans to Rebuild Temple of Solomon

New York, Feb. 23.—(AP)—A Maine farmer who claims direct descent from King David and aspires to his throne, came home today from Jerusalem, where he went to arrange for rebuilding the temple of Solomon.

The farmer—John Willis Settle, of Bowdoinham—arrived on the liner Britannia with a plan for taxing everybody one shekel to finance reconstruction of the temple. It's only fair that the tax be international, he said, since the kingship itself is sort of universal.

The shekel is now worth only 30 cents, but Mr. Settle intends to stabilize it at 64. He carries a Bible in a chamois kn bag, with inscriptions on the fly-leaves in Hebrew, Arabic, Syrian, French and English, acclaiming him as King David. Business conditions are a bit depressed in Palestine now he said, so he was uncertain when work on the temple of Solomon would begin.

The return journey was real pleasant, Mr. Settle reported. He got one passenger to renounce smoking and another to give up drinking.

Hawley declined to make public the vote in the committee. The resolution adopted reads: "Whereas in the opinion of the committee there would not be sufficient time during the remainder of the present session for the consideration of tariff or embargo bills, therefore it is resolved that the consideration of all such bills referred to and pending before the committee be postponed." 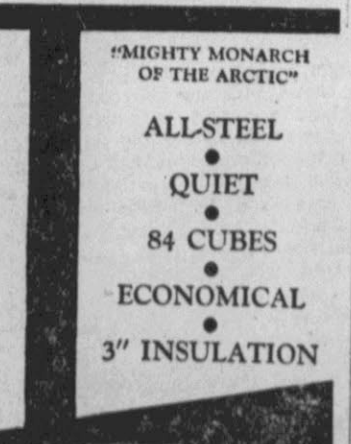
