SEE CHANGE IN STABILIZATION WORK IN U. S.

Farm Leader Predicts Optional Use of Export Debuture Plan in the Future

Washington, March 23.—(AP)—A prediction that optional use of the export debuture and the equalization fee would be substituted for stabilization operations came today from Chester H. Gray, of the American farm bureau federation.

Gray, Washington representative of the organization, pointed to abandonment by the farm board of stabilization operations in wheat as a result of a congressional move to strip the board of this power and substitute the two points of contention in the long campaign for farm relief.

"This will be done by friends of the act, not its enemies," he said. Sam H. Thompson, newest member of the farm board, was president of the American farm bureau federation until his appointment by President Hoover last week to fill the vacancy caused by the resignation of Alexander Legge.

Thompson Long was an advocate of the equalization fee. No word had been received today as to when he would assume his new duties. Gray predicted 50 cent wheat as a result of the board's announcement yesterday.

"The action of the board," Gray said, "means that the burden of taking care of crop surpluses has been thrown back on the farmer where it always has been. Farmers don't need a farm board to tell them that."

He observed that farmers would reduce acreage only when economic conditions absolutely forced them, and expressed belief that next fall if wheat prices dropped to 50 cents, as he thought they would, production would be curtailed.

Gray said that from the board's policy for 1931 in respect to wheat, the inference could be drawn that it would not make stabilization purchases in cotton for the next crop year.

The Farm Board has not bought any cotton since 1929, and Chairman Stone said recently no purchases would be made until July 1 at least. The board now holds 1,300,000 bales which were bought in 1929.

Representative Burtness, Republican, North Dakota, said if the Farm Board is not prepared to meet emergencies "we might as well abolish the board."

"I deem the farm board's announcement that it will not stabilize the 1931 wheat crop a big mistake and entirely premature," Burtness said.

"The stabilization powers granted by the marketing act are intended to be used in emergencies. No one can today say whether an emergency will or will not exist when the 1931 crop is ready for market."

"The Russian deluge is driving us away from the European markets. I agree with the board's program to reduce production, but it should stand ready to carry out the policy of the law and deal with any emergency when it arises."

Representative Kvale, Farmer-Labor, Minnesota, said that politically, "it may be a smart move to meet the crisis toward which the farm board seemed heading over with long before the next campaign."

"But," he added, "it doesn't seem to speak well for any concrete benefits from the board if that agency is going to discontinue stabilization."

Washington, March 23.—(AP)—Learning that he cannot expect the government to attempt stabilization of the 1931 wheat crop, the farmer today had two alternatives—'to limit production to domestic demand or accept world prices.

The Farm Board made it clear yesterday that its grain stabilization corporation will not try artificial price maintenance indefinitely since the work is of an emergency nature and expensive.

The board reiterated in a statement, however, it planned no change in policy in respect to 1930 wheat, now being stabilized through purchases of surplus stocks.

About 300,000,000 bushels of wheat have been brought by the stabilization corporation out of a \$500,000,000 revolving fund authorized by Congress.

MILD WEATHER PREDICTED IN THE CAROLINAS

Final Act of Winter in N. C. Giving Away to Mounting Temperatures

Asheville, March 23.—(AP)—Winter, after putting on a final act of bravado over the week-end today was knocking under to spring.

Snow in the mountains of Western North Carolina yesterday fell in depths varying from one to 12 inches. In some places it did considerable damage to highways and telephone lines.

Warm temperatures and a slight rainfall today had melted all the snows in the low sections leaving only white capped mountain peaks as a reminder that winter had paid a visit.

The mercury today was rising rapidly. From 35 degrees at 8 o'clock, it went to 45 at 11 o'clock. The weather bureau promised still warmer temperatures during the afternoon but added that there was a chance of a light frost last night. Tuesday was scheduled to be much warmer.

At Marion and at Saluda, the snow reached depths of around 12 inches. In the Smoky Mountains, the snow was eight inches deep at noon Saturday, when the snow fall began in Asheville, and the depth was estimated at around 18 inches.

Precipitation in Asheville was recorded at 56 in Asheville, most of it falling as snow. Had it not melted to a large extent as it fell there would have been five and one-half inches on the ground.

The snow was regarded as a great boon to the farmers, soaking the land freely for spring planting.

J. H. BROWNING BURIED TODAY

Died of Injuries Sustained in Fall Following Stroke of Apoplexy

John H. Browning, 57, of the Reedy Branch community, died in the local hospital here early yesterday morning. Mr. Browning suffered a stroke of apoplexy while in the business district of the city Saturday afternoon, fell to the pavement and sustained a fractured skull. He died without regaining consciousness.

Funeral services were conducted this afternoon by Rev. E. H. Canady, pastor of the Winterville Baptist Church, assisted by Rev. M. A. Woodward, pastor of the Free Will Baptist Church. Burial was made in the Reedy Branch churchyard. He was buried with honors of the Masonic lodge.

Mr. Browning was a veteran of the Spanish-American war, having seen two years service with Company E, North Carolina Infantry. He was also prominently identified with activities of the Masonic lodge at Winterville.

He is survived by a half-sister, Mrs. J. B. Johnson, of Washington; two half-brothers, J. L. Tripp, Jacksonville, Fla., and Heber Tripp, El Paso, Texas.

LOCAL YOUNG MAN DIES BY HIS OWN HAND

Ray Briley Fired Shotgun Charge Through Lung Here Last Night

Firing a shotgun charge through his left lung, Ray Briley, son of Mr. and Mrs. J. Harvey Briley, of this city, committed suicide in the front yard of the Yum Yum Barbecue Palace, on the opposite side of Tar river, last night. The shooting occurred about 12 o'clock and the young man died in the local hospital at 3 o'clock this morning. No cause was ascribed for the act.

Funeral services will be conducted from the home of his parents on Fourth street, tomorrow afternoon at three o'clock. Rev. W. A. Ryan, pastor of the Eighth Street Church of Christ, will officiate. Burial will be made in Greenwood cemetery.

Young Briley, who has been spending two weeks in Washington City with relatives, returned to Greenville Saturday to spend the week-end with his parents. Sunday afternoon he went over to Williams-ton to see a young woman.

Returning home last night, he stopped at the Yum Yum Barbecue Palace for supper. After eating, he walked out to his car, was seen to scribble something on a piece of paper, and a few seconds later he shot himself.

He was rushed to the hospital for medical attention, but the wound was of such serious nature that no hope was entertained for his recovery.

The note found near the body contained only a farewell message. It said: "Good-bye, friends, old Ray has gone." The young man was said to have written two letters before going to Williams-ton, one to his mother and the other to the young woman he visited. Neither of the messages threw any light on his action.

Young Briley was a member of the Christian Church here, having joined at the age of 14. He was also a member of the North Carolina National Guard, and was held in the highest esteem by scores of persons.

PRES. HOOVER WELCOMED BY PORTO RICANS

Citizens of Ponce Take Holiday to Celebrate Coming of Distinguished Visitor

Ponce, Porto Rico, March 30.—(AP)—President Hoover reached Porto Rico today, the battleship Arizona, which brought him here from Norfolk, anchoring outside Ponce harbor as small boats took him and his party to shore. The President was the last of the party to leave for the quay.

The city was decked with flags, bunting and banners which screamed the word "welcome"—in Spanish "bien venido"—and a large triumphal arch had been erected across the entrance to Abolition park to mark the occasion. The city was enjoying a double holiday, the emancipation fete which fell yesterday having been carried over until the week day.

From Ponce, where Governor Roosevelt and island officials and political leaders were assembled to meet the President, the party was to go in a caravan of 23 automobiles across the island to San Juan where Mr. Hoover planned to make an address in answer to his welcome.

President Hoover was enthusiastically cheered as he landed but there was some hissing as the mayor officially welcomed him to Ponce. School children serenaded the cavalcade with songs as it passed through the streets, which were decorated with pennants praising President Hoover's appointments of American officials of the Porto Rican government.

The President thanked the mayor briefly for his welcome. The crowd cheered the mayor's reference to Governor Roosevelt. The President praised the self-reliance of the Porto Rican people and said he hoped that his visit would result in closer cooperation between Porto Rico and the United States.

The President was not on deck when Governor Roosevelt arrived aboard the battleship to greet him. The governor rode out to the ship on a handsome yacht, and was met by Secretaries Wilbur and Hurley. There were no ceremonies as he boarded the battleship, for the navy gives no salutes before 8 o'clock.

There were rain squalls an hour before, but the sun was coming up clear before the Arizona anchored. Governor Roosevelt said that the Presidents speech before the Porto Rican legislature will not be made before nine o'clock Tuesday morning.

MRS. PICKETT PASSES AWAY

Wife of Noted Confederate General Died At Capital in 83rd Year

Washington, March 23.—(AP)—"Mother" Pickett of the snow-white hair and charming accent, no more will tell of the last Confederate charge at Gettysburg or draw word pictures of interesting characters and incidents.

In a private hospital here yesterday Mrs. LaSalle Corbell Pickett, called "Mother" even by Presidents, died of hardening of the arteries in her 83rd year. With her passed the tingling tale she told of how Confederates stormed up Cemetery Ridge at Gettysburg July 3, 1863. Only to be repulsed when they found the Union forces had not exhausted their ammunition.

She had reason to know that story well. She was 15 when she married the officer who led the southern forces—General George Edward Pickett. Before his death in 1875 she became known as "the child bride of the Confederacy," praised for her vivacity and beauty. She was a native of Virginia.

A favorite in society, she knew every President beginning with Lincoln, and met authors, actors and diplomats. One of her most colorful manuscripts entitled "My Memory Chain," was left unfinished by her death.

She was an honorary president of the United Daughters of the Confederacy. As survivors she leaves two grandsons, Captain Christiany Pickett and Lieut. George E. Pickett, 3rd, both in the army; two sisters, Mrs. W. F. Cotten, and Mrs. W. C. Eley, and a brother, Dr. E. F. Corbell. Funeral services will be held here tomorrow, but relatives have not decided whether interment will be beside the body of General Pickett in Virginia or in Arlington National Cemetery.

ADOPT PLANS FOR FORCING NEW CONGRESS

Peace Societies and Socialists Want Economic Distress Attended to

Washington, March 23.—(AP)—A program demanded for force an extra session of Congress to deal with economic distress was adopted today at a conference of representatives of various reform organizations, peace societies and the National Socialist party.

Delegates to the conference, headed by Norman Thomas, former Socialist candidate for President, immediately began a series of conferences with political leaders demanding the extra session.

They called first on Senate Republican Leader Watson. He told them he did not believe the situation had reached a point where an extra session was necessary.

Watson promised, however, to talk the situation over with President Hoover on his return from his Caribbean cruise.

The program adopted by the conference provided also for appeals to Speaker Longworth of the House and the chairman of the national committees of the major political parties.

The conference also agreed to ask the leaders of the recent Progressive conference to appeal to the country for an extra session and to go out and make speeches for it if possible.

The program also proposes to get members of Congress to report to President Hoover on economic conditions in their districts and to organize a large delegation to appeal personally to Mr. Hoover for him to call Congress together.

Discussion largely centered around the basis for the extra session demand.

It was generally agreed that the need for unemployment relief should play a major part but some insisted international affairs should also be considered.

International questions discussed included world credit, international debts, the recognition of Russia, and the international aspects of the Hawley-Smoot tariff law.

Thomas, as chief spokesman, told Senator Watson "the sheer mass of human misery demands something beyond local relief. He said the country had sustained a wage loss in 1930 of \$9,000,000,000.

Watson asked Thomas if he advocated the dole and the Socialist leader agreed that that was included in the necessary relief program.

Watson said he was "violently opposed" to the dole system but said he would be willing to take money out of the treasury to prevent starvation if necessary. He added, however, that this country had not yet reached that condition.

RESCUE SHIPS PUSH WAY OUT OF ICE FIELDS

Bobb Fogg, Plane Pilot, Wrecks Plane in Crash On Horse Island

St. John's N. F., March 23.—(AP)—The rescue steamer Sagona, with 118 survivors of the seal-ship Viking explosion disaster on board, today forced its way through almost impenetrable ice floes off Horse Island on the return voyage to this port. Other vessels, with nine survivors on board, were likewise engaged.

While the ships with the survivors started out of the ice fields, the ocean-going tug Foundation Franklin arrived here with the body of Patrick Bartlett, one of the disaster victims.

Bob Fogg, Concord, N. H., pilot, who flew north with a camera man in quest of picture of the disaster, crashed on Horse Island, probably ending his flight. Reports of the damage to his plane were meagre but it was reported that neither Fogg or his companion was seriously injured. He had taken off earlier in the day from Hampden, N. F., with a camera man.

Another picture airplane expedition, that of C. F. Kent, who was forced down at Pictou, N. S., while en route from Moncton, was continued today when he took off at 8:55 A. M.

Meanwhile Bert Balchen, internationally known flyer, with his companions Rander Enslow and Merion Cooper, prepared for the next leg of their flight at Corner Brook. The Balchen party will search for Varriek Frissell and A. G. Penrod, of New York and 24 others who have not been found. Frissell and Penrod were motion picture men engaged in obtaining pictures of the sealing fleet's activities.

FIRE DAMAGES FORBES HOME

Another Blaze and Two False Alarms Handled by Fire Department Since Sat.

The home of C. S. Forbes, on Evans street was damaged by fire of undetermined origin this morning shortly after 8 o'clock. Firemen estimated the loss at approximately \$700.

The fire originated in the ceiling of the bathroom and spread to the roof where it had gained considerable headway when the fire department arrived. The blaze was extinguished with the aid of a small-diameter hose and water damage was slight. The furnishings on the upper floor were considerably damaged from smoke.

The fire department was called out about 8 o'clock last night to extinguish a burning automobile at the home of W. C. Brasswell on Dickinson avenue. The upholstery of the car was damaged to the extent of about \$500. The cause of the fire was not ascertained.

The department was called out twice between 10 and 11 o'clock Saturday night, but each of the alarms was of the false variety. The blazes were sent in from boxes 71 and 87 in widely-separated areas of the city, and while members of the police department attempted to place responsibility for the alarms, the culprits continued at liberty today.

Approximately a dozen false alarm calls have been sent in during the past month and caused the board of aldermen to offer a reward of \$50 for the arrest and conviction of responsible parties. To day, however, no arrests have been made and the alarmists continue to hurl defiance at the city fathers and members of the police force endeavoring to break up the practice.

Pastor Seizes Church After House Burns

Antioch, Ill., March 23.—(AP)—The address of Clarence Spiering and family still is: "Methodist Episcopal church, Hickory Corners, Illinois."

After his home across the street from the church burned, Spiering moved his family in, bag and baggage, declaring the church trustees lost their right to the property because a review was suspended during the winter.

He was appealed by a Justice court but was overruled on a charge of "breaking, entering and usurping" retaining possession while the case is pending.

MELLON SIGNS ANTI-DUMPING MATCH ORDER

Edict Prohibits the Importation of Matches from Several Other Countries

Washington, March 23.—(AP)—Secretary Mellon today signed an anti-dumping order against the importation of matches from Finland, Norway, Estonia, Sweden, Latvia, Austria, Holland and Poland. The edict is effective immediately.

Under the regulation, the duty will be the difference between what is considered a fair price for matches by the Treasury Department and the price at which the product is dumped in the United States.

The treasury has set a fair valuation of 80 cents per gross, and it was said approximately \$750,000 would accrue to the government from this order.

The controversy over matches started in 1928, the treasury said, when Russia began dumping operations.

The price was driven at that time down to 29 cents a gross. Other foreign manufacturers met the Russian price. The market was later raised after anti-dumping orders were promulgated against Russia, but American manufacturers still claim it is too low.

TWO MEN HELD FOR SLAYINGS

Charged With Killing Couple in Haywood County During Last August

Asheville, March 23.—(AP)—Deep in the rugged Big Creek section of Haywood county one day last summer, Scott Brown and Mims White started up the narrow trail which leads over the mountains into Tennessee.

They were never seen alive again. Today, after months of investigation and miles of search through the mountain wilds, two other men were in jail, one in Asheville and one in Waynesville, charged with their murder.

The accused are Frank and Cass McGaha, 21 and 18 years old, respectively. Officials have shrouded the basis for the arrests in secrecy, and so far as is known the bodies of the missing men have never been discovered.

Reports of their disappearance were followed by whispers that they had met with foul play as the result of a moonshiners feud.

Months of effort by officers brought no results. Then the break came. Sheriff Lowe received word from a man in Gastonia that his son had information touching the case. The man and son were carried to Asheville. (Continued On Page Three)

Many Senators Visit House While They Mark Time for Action Tonight; Senate Expected to Consider Routine Calendar and Administration Bill Tomorrow at Noon

Raleigh, March 23.—(AP)—The House today deferred consideration of the \$28,000,000 revenue bill of its finance committee until tonight.

Many senators, their own division of the legislature not meeting until tonight, were visitors in the House for the opening of the revenue fight but beyond adopting the substitute bill of the committee the House took no action.

Tonight the body will resolve itself into a committee of the whole and first consider the uncontested sections of the bill. When this is completed the sections on which fights are expected will be taken up.

The Senate tonight is expected to consider its routine calendar and tomorrow at noon the administration bill to consolidate the boards of trustees of N. C. C. W., North Carolina State and the University of North Carolina will be a special order.

Wading into its public calendar with a will, the House passed its substitute for the Folger oleomargarine bill prohibiting the sale of margarine colored to look like butter and approved the Connor bill to require all trailers operating on highways to be equipped with red reflectors.

Other state-wide bills passed included: Miss Waynight and Brown to provide for a study by the tax commission of the question of taxing and assessing property for taxation; and, Connor, to revise the law on establishment of cartways to make to conform to the new state highway act.

The House passed the following bills: HB 954—Howell and Reed of Buncombe, to exempt Asheville hospitals from taxes.

HB 1064—Lumpkin of Franklin, to establish partial payment of taxes in Franklin.

HB 1044—Johnston of Ashe, to incorporate Warrensville.

HB 784—Rogers of Macon, to put Macon under the primary law.

HB 613—Pinnix of Yadkin, to put Yadkin under primary law.

SB 154—Folger of Surry, to define oleomargarine and regulate its sale.

HB 676—McRae, Garibaldi and Reading of Mecklenburg, relating to reformatories or homes for fallen women in Mecklenburg.

HB 974—White of Robeson, to amend law relating to appointment of trustees for the Cherokee Indian Normal School at Pembroke.

HB 1045—Mack, Waynick and Swank, to provide for a study of taxing and assessing property for taxation.

HB 1061—Conner of Wilson, to revise the law as to establishment of cartways.

SB 411—Folger of Martin, to exempt preachers and churches from paying assessments in Williamson. The House tabled the following bill: Brooks of Durham, (by request), to amend the charter of Durham school district.

He is survived by his widow, who was formerly Mrs. Louisa Howell, four sons, James T., Edward, Willie and David Dixon. Three daughters, Mrs. Laura Mirde, Mrs. Essie Boyd and Miss Myrtle Dixon of Grimesland. Three brothers, Olive Dixon, Greenville, Joe, John Dixon, Back Bay, Va., and Stanley Dixon of Beaufort county.

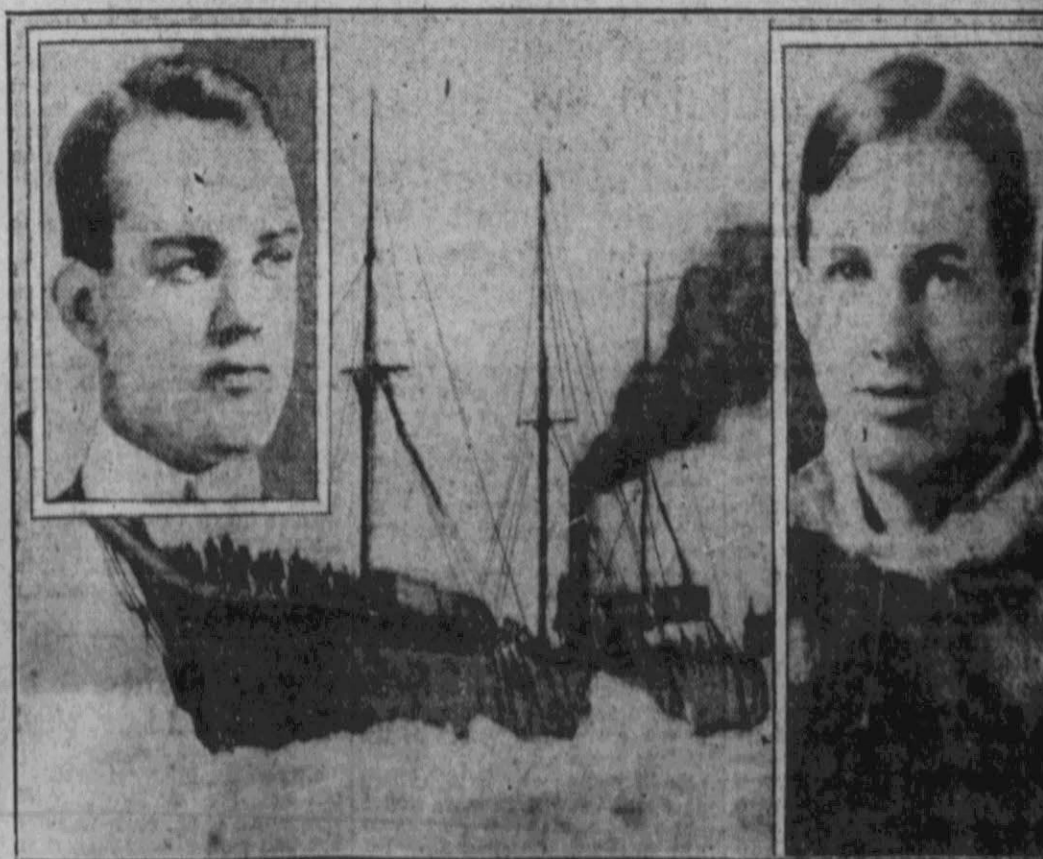

## PRESIDENT ROBERT WELCOMED BY PORTORICANS

(Continued From Page One) President Hoover last his administration had produced more legislation for solving the island's problems than any since the beginning of the American adventure in Porto Rico. This fact, he said, had served to renew the interest of Porto Ricans and to revive their hopes that Porto Rico might be incorporated on a basis of constitutional equality as a self-governing state in the union.

"Your arrival this morning," he said, "strengthened the ties of mutual understanding and reciprocal affection between this territory and the continental United States."

The reception by the municipality of Ponce was held at the city hall, several miles from the President's landing place.

President Hoover was given an elaborate embroidered banner, cloth on which had been worked designs of the favorite flowers of all of the American Presidents who have held office since Porto Rico became part of the United States.

The poppy, designated by President Hoover as his favorite flower, was included in the design.

Up to the last minute a small, active group of Nationalists continued their opposition to the entertainment program of the President. Urging all Porto Ricans, that their own dignity, not to participate, one hand bill, signed by Luis Vergne Ortiz, president of the Nationalist party of San Juan, was distributed in the cars of the reception committee. It criticized President Hoover as leader of the national Republican party, which is described as "capitalistic, plutocratic, anti-socialist, and opposed to the interests of workers."

At the point of capture, Stone was forced to open the vault. The robbers took as much cash as they could find and fled in an automobile.

## Gotham Awaiting Roosevelt Action In Walker Charge

New York, March 22.—(AP)—Gotham was rife with speculation today awaiting the action of Governor Roosevelt on charges against Mayor Walker.

The Times said the governor was expected to send to Mayor Walker for answer the charges filed by the city affairs committee.

The Herald-Tribune quoted a close friend of the chief executive as saying the charges probably would be dropped as too vague and indefinite.

Referee Samuel Seabury, who has been conducting an inquiry into magistrates' courts and who was appointed commissioner to inquire into the conduct of District Attorney Thomas C. T. Crain, conferred with the governor at the latter's home in Hyde Park for four hours yesterday. Nothing of the conference was made public.

Prediction that the charges against Mayor Walker would be dismissed, the Herald-Tribune said, was based on the fact that a search of records by the mayor's friends yielded no precedent for removal of an elective official where the charges do not involve malfeasance in office or personal corruption.

The Herald-Tribune printed a dispatch from a staff correspondent at Palm Springs, Calif., where the mayor is vacationing, saying he had definitely disposed of reports that he has any intention of quitting under fire. The same paper said local Democratic leaders had been told by the governor that Tamman would "not remain silent if the governor to win support for his presidential boom removed the mayor or district attorney."

## Public Enemy Draws 10 Years At Chicago, Ill.

Chicago, March 22.—(AP)—The law appears to be tightening its grip on Chicago's "public enemies."

One by one the men so classified by the authorities have been stacking their wits against the agencies of the law—and have lost.

The latest to feel the attack is William Niemoth, whose conviction for participation in a \$47,000 payroll robbery in Baltimore in 1926 has been upheld by the Court of Appeals at Annapolis. Niemoth was sentenced to ten years. Attorneys said his chances for a re-hearing were slim.

Niemoth's apparent failure to escape punishment followed closely the conviction of No. 1 on the list of 26 enemies—Alphonse Capone, who was sentenced to six months for contempt of federal court in Chicago. The charge grew out of his failure to respond to a summons from the grand jury which was investigating incomes. He is trying to avoid the penalty by an appeal.

Meanwhile Chicago police said they would not be surprised to see a new flare-up of gangland guns as a result of the slaying Saturday night of Johnny Genaro, known as a Capone henchman, and a brother of Joseph "Pepe" Genaro, a "public enemy." They said they believed a quarrel between the Genaro brothers and Jimmy Belcastro and Rocco Fanelli, also "public enemies," was responsible.

Two on the original list have been killed—Joe Aiello, north side gang leader, who walked into a machine gun ambush last fall, and Jack Zito, slain last August at Delafield, Wis., a month after he had been questioned in connection with the slaying of Alfred Lingle, the newspaper reporter.

All of the public enemies have been the subject of an attack by local authorities as vagrants, while federal officials have used the income tax law and deportation and contempt proceedings as their weapons. Capone's vagrancy case is still pending.

## Building Contracts Reach High Mark

Washington, March 22.—(AP)—During the first week of spring, building contracts totaled \$1,000,000, the highest total yet recorded by the president's employment committee.

At the same time, the bureau of economic warfare reported construction contracts for \$1,000,000 had been authorized in 300 cities during February. This year, a decrease of 2.5 per cent from January permits of \$1,025,000, but the decrease was less than the 4.3 per cent for the same period last year.

The public works contracts, including postoffice and other Federal buildings, state and municipal buildings, colleges, hospitals, highways, churches and streets, were construction and other work of a type, were let in 28 states and the District of Columbia.

## BOY FATALLY INJURED IN FALL FROM BUS

Waynesville, March 22.—(AP)—Woodrow Bradford, 13, fell from a school bus four miles from here today and was fatally injured.

The boy was sitting on the front seat when the door flew open while the bus was in motion. He tumbled under the bus and a wheel passed over his body. He died shortly after being brought to a hospital.

John A. Heves, 40, was the driver of the bus. Ray Humberburg, superintendent of schools, said Reeves was a very careful driver.

Dr. R. A. Allison, coroner, planned an inquest this afternoon.

## YEGGS CRACK CHURCH SAFE

### Approximately \$500 Taken in Haul At Asheville Baptist Church Last Night

Asheville, March 22.—(AP)—Yeggs entered the First Baptist church office here late last night and executed a neat job of safe cracking and escaped with approximately \$500 in cash and checks.

Investigation by the police, headed by Chief W. R. Messer, began this morning and photographs of finger prints on the safe and office equipment in the church office were taken.

Melvin Nix, negro janitor discovered the robbery when he went to work early this morning. He reported it to Earl Grice, church secretary, who notified the police.

The loot consisted of checks and cash contributed in the collection plate at services on Sunday. Forty dollars of the amount was raised by the Women's Missionary Society in home mission prayer services last week. Another portion was Sunday School collections.

The yeggs entered the church from the rear by forcing a window in the classroom of Women's Bible class. The church office where the safe is located was locked, so the robbers placed a chair near the partition separating the office and corridor and climbed over, leaving foot prints and finger prints in several places.

The yeggs opened the safe with an axe from the church coal bin. Three new chisels were also left at the scene. They broke the combination of the safe and tripped the lock. Papers, cancelled notes, Sunday School and church reports and other things of minor value were scattered over the floor. A desk beside the safe was rifled but it is believed nothing of much value was stolen from it.

## New Cancer Serum Discovered in London

By HOWARD W. BLAKESLEE (Associated Press Science Editor) New York, March 22.—(AP)—Cancer tissue growing artificially in glass dishes is killed in a few minutes by a new serum developed in the cancer research laboratory of London Hospital, England.

Unlike other tumor remedies this serum is harmless to living tissues except cancer.

These discoveries and their possibilities for experimenting with cancer in man are told in the April issue of the American Journal of Cancer by Thomas Lumsden, M. D., director of the London laboratory. The Journal is edited by Dr. Francis Carter Wood of Columbia University.

The serum comes from animals which have been inoculated with cancer. It is tested upon cells of cancer of heart, kidney and other body tissues growing artificially outside of living beings. A start has been made in testing it upon living animals, a few rats having been cured of cancer, and others made immune.

"Animals," Dr. Lumsden says, "are capable of forming anti-bodies having a specifically lethal effect upon malignant tumor cells of any variety, but which are non-toxic to normal cells."

Whatever these protective anti-bodies are, human cancers also possess them, Dr. Lumsden reports. One of these, he says, "should be an excellent reagent with which to attempt the treatment of cancer in man," but the serum must be injected into the tumor as it is not effective when thrown into the general circulation."

## Member of Wilkins Polar Expedition Lost in N. Y. Harbor

New York, March 22.—(AP)—Willard I. Grimmer, quartermaster of Sir Hubert Wilkins' Polar submarine Nautilus, was lost overboard yesterday in the outer harbor as the craft was on the way to the Brooklyn Navy Yard for christening today. He was married three weeks ago.

Report of the tragedy by Commander Sloan Danenhower, skipper of the craft, was that Grimmer had been lost, that a thorough search had been made. Members of the crew said the cable, or deck rail, broke under his weight and that he fell into the sea from the after deck. The cable was intact when the submarine was berthed last night.

Grimmer, 27, was formerly a radio operator in the navy. Until his engagement as quartermaster for the projected polar expedition he sold insurance. His widowed bride is the former Miss Mary Fountain of Philadelphia.

Navy Times police launches and navy airplanes joined in search for Grimmer after radio calls were sent from the submarine. The craft was being towed by a tug when the quartermaster was lost. Sir Hubert was not aboard.

The submarine, formerly the O-12 of the navy, was recently reconditioned for the polar under-ice trip at Camden, N. J.

The polar trip will be made in July.

The false alarms assumed the epidemic stage and the city officials were forced to take some action to bring a stop to the practice. They offered \$50 reward for the arrest and apprehension of any person sending in a alarm of this nature, but to date no arrests have been made and the false alarms

continue as flagrantly as ever before. The citizens should be able to render a distinct service to the city by keeping a keen lookout for the false alarms. When an alarm is sent in, people living near the alarm boxes should rush and see why the alarm was sounded. It is nothing but plain civic pride to desire to know why an alarm was sent in, and people who make it a point to check their boxes will be rendering the city a great service.

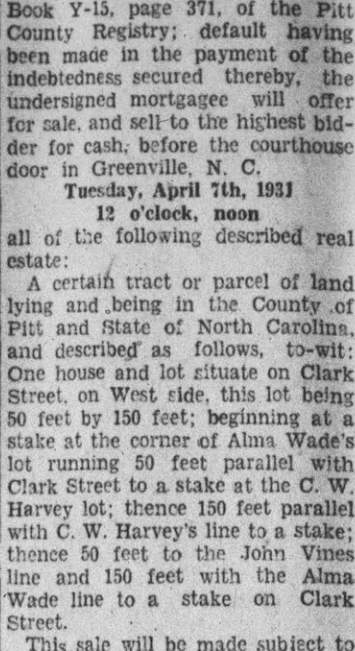

# ATHLETICS NOT SO FAST THIS SEASON

Fort Myers, Fla., March 23.—(AP)—The development of the Philadelphia Athletics in their spring training camp has left something to be desired, to judge from performances, even though nothing has occurred serious enough to dislodge the world's champions as favorites in the forthcoming pennant race.

Although there is no pay-off on the results of exhibition games, the defeat of the A's in three out of four games with their world's series rivals, the St. Louis Cardinals, did not prove enjoyable to Connie Mack and his associates.

With the start of the season only about three weeks off, Mack's principal concerns are these:

(1) The ability of the club's veteran infield to withstand the wear and tear of another full campaign effectively.

(2) The ability of Grove and Tarnshaw to gain to shoulder the pitching burden to the extent of winning 50 games between them, besides saving a flock of others.

(3) The annual task of signing Al Simmons, the club's premier punch, complicated by reports that the famous outfielder intends to demand a \$100,000, three year contract.

Only the run of the season will furnish the answer to the first items, Mack has several promising youngsters or infield replacements if Dykes, Boley and Bishop fail to meet expectations or suffer mishaps. These reserves, however, are still short of big league requirements in experience. The A's gained a third sacker but lost their best utility man when Dykes was assigned to regular work.

In seeking support for the twin hurling aces, the A's have uncovered two unusually promising recruits in Hank McDonald, a 19-year-old California boy, and Lew Krause, an 18-year-old product of Philadelphia suburban districts.

If Mack can get winning results from one of these youths this year, he will be well fixed, for he counts on consistent work from Rube Walberg, Leroy Mathey, Eddie Rommel and Bill Shove in support of Grove and Earnshaw.

Mack, when the subject was brought up, told the Associated Press he did not classify Simmons as a holdout, having agreed with the outfielder to postpone final discussion of salary terms until they meet in Philadelphia before the season opens.

Tonight at Philadelphia, Tony Canzoneri, of New York, holder of the lightweight championship, puts his best with Tommy Grogan of Omaha, Neb., but the title will not be at stake.

# Market Report Cotton--Stocks--Grain

## COTTON MARKET

New York, March 23.—(AP)—Cotton opened steady today, 1 to 3 points lower in response to disappointing Liverpool cables which were followed by local and New Orleans selling.

The announcement of the policy of the Federal Farm Board with reference to the coming wheat crop seemed to have rather an unsettling effect on sentiment and may have led to a little selling at the opening. There was some favorable comment on this statement, however, and the comparatively light offerings were sufficiently well taken on the decline to 10.91 for May and 11.48 for October to steady the market, which after showing net losses of 6 to 10 points rallied 3 or 4 points from the lowest by the end of the first half hour.

Liverpool cables said that Manchester and continental liquidation in that market had been absorbed by covering and reported buyers of cotton cloths and yarns cautious with a moderate turnover.

## STOCK MARKET

By CLAUD A. JAGGER  
(Associated Press Financial Editor)  
New York, March 23.—(AP)—The stock market today again demonstrated its newly acquired ability to take bad news calmly.

The downward tendency which developed late last week was carried over into the early trading, and no sooner did its influence wear off than a drop in Chicago wheat to the lowest levels in 36 years prompted further selling. The list stiffened again by early afternoon, however, and prices were inclined to recover.

Trading was quiet from the start. Early losses of 2 or 3 points in such issues as Allied Chemical, American Can, and Case were largely cancelled. Auburn Auto behaved erratically, dropping 5 then rebounding 10 from the bottom to reach new high ground above 220. U. S. Industrial Alcohol was a soft spot, dropping 5 to a new low, reflecting a disappointing earnings statement and deferment of dividend action. Radio Corp. was well supported, and Preprint Texas was pushed up 2 to a new 1931 top, but losses of a point or two were fairly general during the morning, embracing such shares as U. S. Steel, American Telephone, United Corp, North American General Electric, Anaconda, International Harvester, New York Central, Borden, Union Carbide, Nash, and Studebaker.

The break in wheat on announcement that the Farm Board would not support the market for the new wheat crop was naturally a depressing influence on financial markets, but if lacked sufficient element of surprise to prompt any hasty selling of securities.

Wall Street could scarcely be expected to turn decidedly bearish over the Farm Board's decision to abandon its open market operation in wheat, in view of the caustic comment that has come from this quarter ever since the Farm Board started buying. Despite the improvement in textiles, cotton was nevertheless, at least momentarily

"No, not even the 18th amendment does that," Connor retorted, adding "the purpose of the bill is to keep drunken, irresponsible drivers from going on the highways and killing other people. I don't know whether it will do it or not," as he also replied to a question from Moyer as to the purpose of the bill.

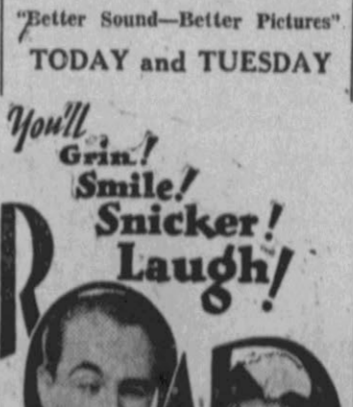
