PROPOSES NEW KIND OF PLAN FOR BUSINESS

Dean Wallace Donham of Harvard Sees Destruction of Old System

New York, March 28.—(AP)—An important American business leader, a capitalist, in fact—has proposed a national plan for American business—even as Soviet Russia has its five, ten and fifteen year plans.

Dean Wallace Donham of the Harvard graduate school of business administration, in his book, "Business Adrift," published today, predicts destruction of the American capitalist system, unless steps similar to his recommendations are taken quickly.

The employee who has been shaking in his boots for fear of his job the past few months, may rightfully blame business leadership for his condition, Dean Donham says. American business can and must prove to the efficient working man that he need not fear for his job because of recurring business depression.

Business must work toward progressive stability within itself, and with the help, but not domination of government, must organize a system of federal unemployment exchanges, from whose statistics depression could be foreseen, and building of national public works immediately ordered.

And work is the real cure-all—business and government must provide work, not doles.

Dean Donham holds that certain reasonable assumptions must be made for the basis of planning, among which these three are most striking:

First, the most "superficial" analysis shows that the Soviet system is likely to succeed over the next 20 years, at least. So the American business man should consider as he considers every other major risk.

Second, tariff walls will continue to stand not only around this nation but increasingly around the other nations, for a similar 20-year period, for the legitimate protection of important national groups.

Third, efforts to expand greatly our foreign trade will result in world disaster, even war. Our home market must be developed. Surpluses must not be dumped. In an economic war, America—if victorious—would probably ruin England and Germany, whose economy is based on foreign trade and that would be the beginning of the fall of western civilization.

High Court to Rule In Chain Store Tax Case On April 13

Washington, March 28.—(AP)—Chain stores and the legislatures of many states will keep a weathered eye on the supreme court when it meets April 13 in expectation of a decision in the Indiana chain store tax case.

If the statute is upheld some of the harmony in the jangle of chain store cash registers may vanish.

The Indiana law frankly is an attempt to regulate and check the growth of the chains. Familiar arguments for and against them were heard in briefs and speeches attorneys presented to the court.

A Federal three-judge district court in Indianapolis declared the tax unreasonable and the law void, but Indiana appealed.

The law was passed in 1929. Under it taxes range from \$3 for one store to \$25 for each over 20.

Lafayette Jackson of Indianapolis operating 225 stores as the Standard Grocery Company, assailed the law as discriminatory and unconstitutional.

He said an example of its unfairness was his tax of \$5,443 as compared with that of many department stores which "did a bigger business but paid only \$3."

E. S. BARNARD IS VICTIM OF HEART ATTACK

President of American League Succumbs to Illness at Mayo Clinic

Chicago, March 28.—(AP)—Grief prevails throughout the baseball world today over the sudden death of Ernest S. Barnard, president of the American league. He died late yesterday afternoon, the victim of a heart attack at the Mayo Brothers' clinic at Rochester, Minn.

The baseball leader had been in apparently good health until the time of the annual meeting of the American league in New York last December when he suffered an attack of influenza. He continued his work, however, against the advice of his physicians until the meeting was over. Then he went to Florida for a brief rest before starting his annual inspection tour of the American league training camps.

Mr. Barnard's health, however, had not returned to normal, and he decided to consult the Mayo, believing he was suffering from stomach trouble. He reached Rochester Wednesday. His case was diagnosed by specialists as heart disease. He was ordered to bed, but was not informed of the seriousness of his condition. He was resting easily and in apparently no distress when he was seized with a violent attack and passed away while his wife was at his bedside talking with him.

Barnard, who was 56 years old, succeeded Byron Bancroft Johnson as second president of the American league in November, 1927, after Johnson's quarrel with Kenesaw Mountain Landis, commissioner of baseball, caused the baseball owners to virtually oust him from the office he had held since the organization of the league.

William Harridge, secretary of the league, left last night for Rochester to take care of the funeral arrangements. Mr. Barnard is survived only by his widow and his mother.

Pending the election of another president, the office probably will be administered by Frank J. Navin, owner of the Detroit club, and vice-president.

Elinor Smith's Plane Plunges 2,000 Feet and She Escapes Unhurt

New York, March 28.—(AP)—Elinor Smith, girl aviator, had a thrill a crackup, a good cry and maybe a record regained in her history today when she dived from a dizzy height over New York yesterday after a try for the altitude record has been sent to Washington for calibration.

William Ward, representative of the national aeronautics association, who examined the barograph, said there was a possibility Miss Smith went higher than the 20,734 feet mark set for women by Miss Ruth Nichols.

Starting from Roosevelt Field yesterday, Miss Smith fainted at the top of her climb for lack of oxygen, plunged to 2,000 feet before regaining consciousness, and glided to a small clearing in a clump of woods near Roosevelt Field and nosed over to avoid hitting a tree.

HOLD AUTOPSY IN KILLING OF HENRY ABRAMS

Body of Aged Man Exhumed As Officers Try to Determine Cause of Death

Mysterious circumstances surrounding the death of Henry Abrams, aged construction company employee, whose body was found on the side of the road in the Monkey Den section of Belvoir township Saturday two weeks ago, were the object of more complete investigation by county officers today.

The body, which was buried in the Belvoir community shortly after the death occurred, was exhumed under the direction of Sheriff Sam Whitehurst this morning and an autopsy was to be performed by Dr. Joe Smith, Dr. R. S. McGee and Dr. Williamson of Coneto.

Raymond Stancill, Francis Bullock, and Thomas Hathway, three men who were arrested by county officers in connection with the crime were ordered remanded to jail without bond in a habeas corpus hearing yesterday. Three colored men, Sam Lawrence, Buster Dowell and Dave Foreman, were also being held as material witnesses. Lawrence and Dowell will face trial in County court next Tuesday morning on a charge of manufacturing liquor.

Abrams, who was employed in the construction of the new school building at Belvoir, was said to have been paid off Saturday afternoon two weeks ago and started to the home of a relative. Three hours later his body was discovered on the highway by those now held in connection with the crime.

Officers said the man evidently had come to his death through a blow on the side of the head. His pay envelope which he had received earlier in the afternoon was missing, and this led to the conclusion that he had been a victim of highwaymen.

Without a single clue to guide them in their investigation officers several days later arrested the six men, but only Stancill, Bullock and Hathway were charged directly with the crime. The investigators claimed they had obtained information that Abrams came to his death while in the company with the three men.

Stancill during the first of the week made an admission that partly cleared up the crime, although he denied he killed Abrams. Officers said he admitted that.

COX AND TURNSEA Tie for Honors In Pinehurst Golfing

Pinehurst, March 28.—(AP)—Joe Turnsea, Elmford, N. Y., and Wiffy Cox, Brooklyn, today tied for first place in the North and South open golf tournament with 288s for 72 holes. The arranged a nine-hole play-off this afternoon for first honors.

BAN JOHNSON PASSES AWAY AT ST. LOUIS

Former President of American League, Dies From Complication of Diseases

St. Louis, March 28.—(AP)—Ban Johnson, 67, former president of the American league, who built baseball to its commanding position as the national pastime, died at St. John's Hospital here at 8:10 o'clock this morning from diabetes and complications.

The death of the stalwart, and at times stormy, old figure of baseball ended a six-year quest of health in which Johnson went from hospital to hospital and sanitarium to sanitarium in search of relief from his dread enemy, diabetes.

His final illness had kept him in a hospital bed here since last September, except for a few weeks in January when he apparently was able to go to Hot Springs, Ark. There he suffered a relapse and physicians advised amputation of a leg because of infection. He returned to St. Louis. Amputation was avoided but a blood transfusion was resorted to February 19.

For a day or two after the transfusion, Johnson's condition seemed improved, but both he and his physicians soon gave up hope for recovery. He was unconscious and delirious much of the time before the end.

His death followed 18 hours that of Ernest S. Barnard, who succeeded him as president of the American league. Barnard died suddenly at Rochester, Minn.

Johnson's body will be taken to Spencer, Ind., for burial in a mausoleum he built there several years ago at a cost of \$25,000. The body will lie in state at the Marshall undertaking establishment here probably until Sunday.

His widow, Mrs. Jennie Johnson of Spencer, Ind., is expected to arrive here today. He is survived also by a brother William Johnson of Coronado Beach, Cal. Mr. and Mrs. Johnson had no children.

During the last few weeks his physician Dr. Robert Hyland, advised amputation of Johnson's right leg which was badly infected from diabetes, but the patient refused to submit and the infection spread to the other leg.

COLD WEATHER VISITS SOUTH

Belated Cold Wave Reported Spreading Over Southeastern Section of Nation

Little Rock, Ark., March 28.—(AP)—A blizzard-like SHR CMFWYP PU—As a belated cold wave moving south and east spread over the southland today, farmers attempting to recuperate from last year's drought, became apprehensive of danger to early fruit crops.

Rain was general over the south yesterday with the prediction of colder weather and snow to follow in many places. In northeast Florida a killing frost was predicted unless winds prevent.

Agriculturists pointed out that the rain preceding the cold wave would greatly injure fruit as the buds would be water soaked.

In Arkansas, the greatest danger to fruit was in the northwest section. The predicted low of 26 degrees would, orchardists say, kill practically the entire peach crop in the Arkansas river valley. Apples, plums, grapes and cherries also would be hard hit.

Starting from the Rockies, the cold wave has moved eastward at the rate of 1,000 miles a day.

The funeral for G. T. Allen, well-known citizen of the Bell Arthur community, was conducted from his late home this afternoon at 3:30 o'clock by Rev. M. A. Woodward, pastor of the Free Will Baptist church at Bell Arthur. Burial was made in the family burying ground.

Mr. Allen died yesterday morning after illness extending over a period of one year.

GRIMESLAND YOUNG MAN KILLS SELF

Clifton Godley Fired 22 Bullet Through Heart Early This Morning

Clifton M. Godley, 23, popular young business man of Grimesland, committed suicide early today by firing a bullet through his heart. The young man was apparently in best of health and relatives were unable to attribute any cause for the act.

Funeral services will be conducted from the Grimesland Christian church Sunday afternoon at two o'clock. The body will be brought to Greenville and interment will be made in Greenwood cemetery. Final rites will be conducted by Rev. Warren Davis, pastor of the Grimesland Christian church.

The suicide occurred in the office of the store of the Hudson Supply Company where Godley was employed as bookkeeper. The body was discovered lying on the floor this morning when the store was opened for business. A bullet had been fired through the heart with a 22 calibre rifle. The young man was believed to have been dead about three hours.

Although Godley left two letters, one to his father, W. S. Godley, and the other to his employer, he did not describe any motive for his action. He was said to have been in the best of health and apparently in a splendid state of mind, and both relatives and scores of friends in this and other parts of the state were profoundly shocked over the tragedy.

The young man attended school in Grimesland and Greenville, and later received his business education at the Charlotte Business school. Returning to Grimesland he entered the business field and had been associated with the Hudson Supply Company of that place for some time.

He was a native of Grimesland, and spent the most of his life there, with exception of the time he was attending school. He was very popular among a wide circle of friends both in Greenville and Grimesland, and his death was received with indescribable sorrow.

He is survived by his parents, Mr. and Mrs. W. S. Godley; three sisters, Mrs. Bruce Holliday, Greenville; Mrs. C. E. Tucker, Charlotte; (Continued on page three)

MacLean Apologizes for Calling N. C. Governor An 'Ass'

Raleigh, March 28.—(AP)—Representative Angus D. MacLean of Beaufort today personally apologized to Governor O. Max Gardner for referring to him as "a damned ass" on the floor of the House Wednesday afternoon.

"If he hasn't made a damned ass of himself, he assumes you are one," MacLean told the House as he flayed the attitude of the governor to a sales tax. He had just referred to the governor's advocacy of a six cents gasoline tax as one "of the highest sales taxes."

Visiting the governor's office, MacLean assured him that he regretted very deeply his expression reflecting on the governor.

He stated he had no intention of reflecting on the governor and had always supported and admired him. Governor Gardner acquiesced MacLean of any intention to reflect on him, accepted the apology and regarded it as an utterance made in the heat of debate.

BETHEL MAN IS KILLED BY AUTOMOBILE

Luman Whitehurst Victim of Hit-and-Run Driver Near Bethel Last Night

Luman Whitehurst, 31, of the Bethel community, died in a Tarboro hospital early this morning from injuries which he received when run down by an automobile on the Bethel-Rocky Mount road last night about 10 o'clock. Officers today were searching for the driver of the car, who continued on his way after the accident.

Whitehurst was picked up by other motorists, and rushed to the Tarboro hospital. Both legs were broken and he also sustained internal injuries.

Whitehurst, in company with several other young men, was said to have left Bethel yesterday afternoon on his way to Rocky Mount. Nothing more was heard of the party until the discovery of the young man's body on the highway.

County officers began an investigation this morning, but at the noon hour it was said they had not received a single clue that would aid them in clearing up the case.

Whitehurst was the son of Mr. and Mrs. Ben Whitehurst and had spent practically his entire life in Bethel.

The body was taken to Bethel this afternoon. Funeral arrangements had not been completed.

WOMAN TAKES HER LIFE BY INHALING GAS

Funeral of Mrs. W. T. Roberson of Durham Held at Stokes This Afternoon

Mrs. W. T. Roberson, 33, formerly of Stokes, who committed suicide early yesterday morning at her home in Durham, was buried in the old Keel graveyard near Stokes this afternoon. Funeral services were conducted from the home of her brother, R. V. Keel, at 3 o'clock by Rev. L. A. Mayo, pastor of the Christian church of Durham. The body arrived from Durham by hearse early this morning.

Mrs. Roberson came to her death by closing the doors and windows of her room and turning on the gas. The act was said to have been the outgrowth of despondency. She was said to have suffered financial reverses of the last few years, and recently had the misfortune to lose her farm in the Stokes community.

Mr. and Mrs. Roberson moved from Stokes to Durham about three months ago. The husband, a carpenter, was said to have been unable to obtain employment and Mrs. Roberson operated a boarding house to keep the family bark afloat.

Both were natives of the Stokes community. Mrs. Roberson being the daughter of the late W. T. Keel, who for years was one of the most prosperous planters of the community.

She is survived by five children: Curtis, 16; Sally, 14; Billy, 10; Louisa, 8; and Ronald, 6.

She is also survived by two brothers, Rufus and W. C. Keel, and three half-sisters, Mrs. H. P. Congleton, of Stokes; Mrs. Abe Baker and Mrs. Ed Roberson, both of Stokes.

General Assembly Stops Work Until Next Monday

Early Morning Session Will Hold Service

With House Revenue Bill Advanced to Third Reading at Midnight Session, Legislators Hope to Bring An End to the Activities by Midnight Next Saturday

Raleigh, March 28.—(AP)—With the House revenue bill advanced to third reading at a session held at five minutes after midnight this morning, many legislators held hope today that the 1931 Assembly would complete its session by midnight next Saturday but observers predicted two more weeks at least before the weary lawmakers can go home.

The revenue bill is expected to raise \$28,202,000 as it stands approved on the second reading 82 to 6. Possibly that the Ewing power tax amendment might be dropped today, and if it is the bill automatically will go back to first reading, nullifying the effect of the midnight session for second reading.

After its early morning session the House recessed until Monday night and the Senate met only half-an-hour today to consider local bills.

In session for more than 11 hours yesterday, the House completed its consideration of the revenue bill as committee of the whole, passed the reorganization bills to establish a personnel director and a bureau of purchase, approved the reorganization of the state park commission, killed the 55-hour week bill; refused to table the Bennett act to increase the highway patrol personnel; and gave final legislative approval to congressional redistricting.

During the week the House killed the drivers' license bill; adopted the general sales tax as a part of its revenue bill by a 56 to 54 vote after refusing a luxury tax 60 to 48; enacted the law merging N. C. State college and N. C. C. W., with the University of North Carolina and received a bill to cut all state salaries 10 percent to 30 percent.

The Senate did little work during the week as it watched the House fight on the sales tax, to which there is much Senate opposition.

The Congressional districting bill was passed and sent to the House; the Seawall banking bill to create a new bank department was given a favorable committee report and three times deferred when it came up as a special order; the agricultural department reorganization bill got an unfavorable committee report; the Hamilton bill to allow erection of piers and terminals at Morehead City as passed, as was the Senate substitute for the White bill regulating trucks.

Senat Baggett of Harnett introduced a bill to levy a surtax on foreign and domestic corporations and another to make income tax data available to the public.

Tuesday Governor Gardner addressed a joint session of the assembly to express his opposition to the forms of sales tax as proposed in the House—the luxury tax and the tax on gross receipts of retail merchants. The gross receipt tax was later adopted.

Three Men Killed In Crossing Crash

Kings Mountain, N. C., March 28.—(AP)—Three men were dead here today as the aftermath of a railway crossing accident on the edge of the city square.

They were: Ambros Crote, 50-year-old widower; Boyce Martin, about 30, a bride groom of a few weeks; J. T. Heaton, 26, unmarried.

All were employees of the Margraves mills, local textile plant. Witnesses of the crash, which occurred last night said a small closed car, occupied by the three men and driven by Martin, darted around another machine and ran directly in front of a Southern passenger train No. 40, northbound.

The locomotive buried the automobile 150 feet down the track and demolished it. The men were thrown clear of the wreckage and were instantly killed.

The train halted, while the bodies were removed to a local mortuary to await funeral arrangements.

TRADE BOARDS ASKING FOR REDUCED ACREAGE

Requests of this nature are received frequently in court circles, and while the answer is supplied in most cases, it is impossible for officials to bridge the intervening years and tell what happened without the valuable records doomed with the destruction of the old courthouse.

If the House has its way about it, football and baseball games are going to contribute their part toward the financial support of the state government in the future.

Eliminating high school athletics, the lower house yesterday incorporated into its revenue bill provisions for the taxing of all forms of athletics, as well as public amusements at seashores and other places.

It required a mighty long time for the boys to find their way around to this source of taxation, but it was worth the time. It is estimated that football games alone will bring to the treasury something like \$25,000 annually. A larger amount should be obtained from baseball games, and it is impossible to estimate the sums to be realized from resort attractions and public dances.

It was a lucky stroke that caused the legislators to turn their attention to these things, and it is hardly probable the extra tax will diminish the enthusiasm of those who pack the baseball and football parks each season to witness their favorite sports.

The plea for reduction of both tobacco and cotton acreage is reverberating from one section of the country to the other at this time, as leaders of the agricultural field attempt to impress upon their fellow planters the necessity for careful consideration of this important matter.

The growers are being told that the world market is glutted with large surpluses of both cotton and tobacco, and if they do not reduce acreage the situation will become even more accentuated through the lowering of prices.

Instead of planting normal acreage of the money crops, the growers are advised to confine more attention to the production of better grades of both commodities, and to produce more of the things which they use at home.

Superior brands of cotton and tobacco should have a tendency to boost the price situation, and at the end of the season the growers should have in their pockets more

money than they would receive from a bumper crop.

Comparison of figures the last several years shows that prices have been gradually undergoing a decline from year to year because of increased production and the inability of the manufacturers to create a demand in proportion to what the farmers produce.

From these figures it is natural to assume that the situation will be even more serious this year with the market congested with larger surpluses than ever before.

Farmers should not make the mistake of not giving due attention to the handwriting on the wall. It can mean only one thing, and that is an unprecedented economic situation in the sections where these crops are produced.

The first of a series of cantatas in connection with the Easter season will be held at the Christian church tomorrow night.

Other churches will hold similar events the following Sunday, and it is the hope of the denominational leaders that the public will attend the services and see what the choir members have done to provide something truly celebrating the Easter season.

The exercises should be largely attended in view of the fact that they are in keeping with the "Resurrection," an event of transcendent importance wherever Christianity exists.

It is true scores of people will spend the Easter season out of the city, but those who remain at home may be assured of services equally as inspirational and representative of immortality as any other in the country.

DISCUSSES TAX QUESTION
Governor Gardner says our average increase property tax levied since 1923 has been \$4,505,000 thru the year 1928.

He says "The weight of this burden on our industries and our citizens has in truth become well nigh intolerable."

He further states "We must use a sane, constructive program of action without imposing a luxury tax which in its injustice and its effect is more intolerable and more throttling of the welfare of the common people than is the burden we are determined to take in large measure off their shoulders."

You notice he used the word citizens while his arguments applies solely to real estate owners.

In other words he says a luxury tax on real estate owners is more intolerable than the \$27,000,000 tax paid almost wholly by them.

The plea for a sane and constructive program reverts back to the beginning of our tax evils, the year 1923. That year the constitution of North Carolina was violated, foreign stocks were exempted from taxation. From that time property taxes, you might as well say real estate burdens increased \$4,500,000 a year.

Governor Gardner, did our immortal Thomas Jefferson whom you like to quote, advocate the exemption of foreign stocks from taxation?

It is self-evident that legislation exempting from fair and just taxation classes able to pay together with inflated values of real property is largely responsible for the plight of real estate owners.

Our governor waxed eloquent in behalf of the common people who were not able to bear the burden of a sales tax, yet he refrained from mentioning our vast sources of practically untaxed wealth that can relieve the common people.

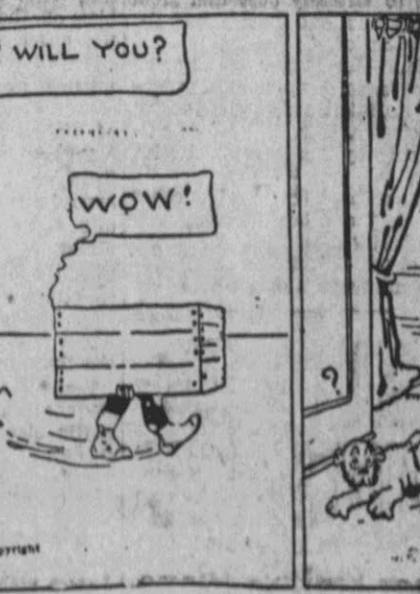

NOT TO PUSH TAX INCREASE

Next Congress Will Not Give Government Deficit Much Consideration

Washington, March 28.—(AP)—Whether the government will go deeper into the pockets of its citizens to meet increasing expenditures and a prospective \$700,000,000 deficit was the subject today of discussions in the capital.

Legislators and organizations alike took part in the talks, but it was considered unlikely either major party would push a proposed tax increase at the next session of congress because of the nearness of the Presidential election.

While these discussions were under way, the treasury prepared to issue on Monday \$100,000,000 in 90 day bills to help counter-balance the deficit and pay veterans loans.

Aligned in favor of a tax increase were at least three progressive republicans—Senator Norris of Nebraska and Borah of Idaho, and Representative Fear of Wisconsin. Senators Reed, Republican, Pennsylvania, and Walsh, Democrat, Montana asserted they were against the proposal.

Norris said he believes money should be raised by increasing inheritance taxes and hiking the levy on bigger incomes. He expressed the opinion progressives generally would support a proposition in that direction.

Fear said the government "should not be operated on borrowed money."

But Reed said that instead of increasing taxes Congress should reduce "handouts to the soldiers and farmers." He advocated abolition of the farm board.

"The present tax rates will yield enough for all ordinary expenses," he asserted. "If Congress will develop the courage to say no it will not need to increase taxes."

Abrams came to his home during the afternoon his dead body was found on the highway. Abrams, he was said to have told officers, sat down in a chair in his home and latter dropped dead.

Not wishing to become implicated in the death, Stancill said he and other members of the party hauled the body down the road and dumped it out on the highway. Officers were later notified of the finding of the body, but no attempt was made to throw light on the death until the sheriff obtained information that Abrams had been seen in the company of Stancill shortly before the crime was committed.

The defendants during the habeas corpus hearing yesterday requested that the body of Abrams be disinterred and an autopsy conducted with a view to determine the actual cause of death. The post mortem examination was expected to continue during the late afternoon.

NEXT SENATE CAUSES WORRY

Republican Independents to Extend Rest of Their Power to Committees

Washington, March 28.—(AP)—Republican Independents may extend their balance of power from the Senate floor to the all important committees which frame legislation.

Democrats are demanding a larger proportion of committee assignments because of the close party division in the new Senate. Republican leaders fearful of turning control over to the Democratic Independent Republican coalition, are resisting the demands.

The prospective line-up in the new Senate is so close that administration leaders have no hope of guiding Senate floor activities when there is a combination between Democrats and Independent Republicans.

Their only hope for keeping control of controversial legislation is in the committees, in most of which

they now hold the majority of votes.

Democratic Leader Robinson has written Chairman McNary of the Republican committee on committees, however, asking that the margin between Democrats and Republicans on the more important committees be cut from three to one.

This would give the coalition control of any committee on which one of the Republicans was an Independent or virtually all of them. McNary is holding out for the present committee divisions, with an eye to a compromise on a margin of two instead of one. This would leave administration forces in control of most of the groups.

The only important committee not materially affected by the dispute is the finance committee, which is already dominated by the

COTTON MARKET

New York, March 28.—(AP)—Cotton opened steady today, 5 to 7 points higher on some overnight buying orders from the trade and week-end covering promoted by a steadier tone in Liverpool and Alexandria.

There was also some comment on unfavorable weather conditions in the south causing delay in crop preparations, but the early demand was supplied by realizing or liquidation and after selling at 10.89, May eased off to 10.84, while October declined from 11.42 to 11.37, with the market quiet and steady at the end of the first half hour.

Liverpool cables reported that the market had been absorbed by covering and trade all.

Egyptian cotton futures in Alexandria were 11 to 27 points higher and the Indian spot quotation in Liverpool showed an advance of 3 points. The amount of cotton on shipboard awaiting clearance at the end of the week was estimated at 99,000 bales, against 104,000 last year.

STOCK MARKET

New York, March 28.—(AP)—Less encouraging reports from the steel industry accelerated the decline in the stock market today.

The downward momentum gained in the bear drives late yesterday was maintained in large scale selling, the turnover for the two-hour trading period approximating 2,000,000 shares.

Losses of a point or more embraced most of the list, while several important issues dropped 2 to 5 points, including American Can, American Telephone, General Motors, Bethlehem Steel, Electric Power & Light, North American, Johns-Manville, Allied Chemical and American Water Works.

The utilities were heavily sold. Consolidated Gas dropped 4 points, the decline in General Motors carried DuPont off 4, and Worthington Pump, Foster Wheeler and Vanadium lost as much.

Auburn Auto fell back 14. Such issues as U. S. Steel, Radio, Radio Keith and General Electric lost a point or more. Rails were neglected.

The week-end estimate of next week's steel mill operations in the Youngstown area, indicating a reduction from 51 to 48 per cent of capacity, helped the bear cause. An unexpected slump in orders for automobile sheets was said to have caused a curtailment of operations by some of the smaller makers.

Furthermore, Alfred P. Sloan, Jr., president of General Motors, was quoted as expressing a very conservative attitude toward business prospects. He looked for good business in 1932 and 1933, but felt that it would be a hard pull this year.

The weekly trade reports were mildly cheerful, pointing out that the approach of Easter had brought the best week in retail trade so far this year.

The noiseless system of mechanical communication, installed in several NBC studios last fall as an experiment, has proved so practical that soon it will be extended to all studios. The system is built around special noiseless teleauto-graph machines.

This brings to an end a colorful part of broadcasting. No longer will it be necessary for production men to run into a studio, whisper to the orchestra leader, push a soprano closer to the microphone or wave their hands this way and that in efforts to convey messages.

Under the new system a man in the control room writes orders on the teleauto-graph machine at his elbow. These are recorded on another machine in the studio.

SPORTS SLANTS

No golfer's pilgrimages are complete, it seems, until he has seen and played Eastlake, the links of the Atlanta Athletic club and the home course of Bobby Jones.

Bobby, unfortunately, was not about the premises when this correspondent first viewed the hazards of this famous layout, its summer greens carpeted with a felt-like substance, but its terrifying vistas of water and rolling terrain otherwise exposed to full view.

In fact, the handicap card (if any) of Jones was not to be found in the rack outside the locker room thereby depriving the visitor of a much anticipated curiosity. I have often wondered what a handicap card for Bob would look like. There has been one of course, but nobody has thought well enough of the last one to frame it for posterity to gaze upon in some awe and wonder.

The incident, although it has nothing to do with this story, reminded me of a visit to Champaign, Ill., with the Army eleven—a few years ago, where I supposed the celebrated "77" jersey of Red Grange would be in a glass case, at least, prominently displayed for the benefit of all tourists.

Not only was this dramatic article of apparel not to be found but no one seems to care where it might be, the best guess being that it was in a pile of old junk.

They are not lacking, however, at the Atlanta Athletic club in appreciation of the achievements of this great golfing members.

The caddies, without the slightest diplomacy, gladly will furnish a newcomer with details of a shot Mr. Jones pulled off to carry a number of hazards after the afore said newcomer has taken a number of shots for each of these same hazards.

At the sixth or "island hole," it was gratifying to learn, after placing my tee shot well on this green by a great stroke of fortune, that Jones was twice in the water the last time he played the course. There are such flaws occasionally even in the superlative.

At the town house of the A. A. C. are on display the four British and American championship trophies—littered in the last and all-conquering Jones campaign together with the huge Walker Cup, and a special plaque holding a ball used by Bob in each of his four victories tournaments.

It is an impressive exhibit, one that this generation of golfers at least is extremely unlikely to see again to signify the works of any single performer. It marks the end of a glowing epoch for the camp golfers, including this correspondent, who saw Jones win his first national title at Inwood in 1923 and his last at Merion in 1930.

The Atlanta A. C. points with pride not only to the individual achievements of Jones in capturing a grand total of 20 assorted state, sectional and national golf titles, but to the contributions in tennis of Bryan Grant, Jr. national clay court champion and the winner, all told, of 12 important tournaments.

Organize to Cut Tobacco Acreage

Henderson, March 27.—An organization embracing all tobacco-growing counties in the Old Bright Belt of North Carolina was formed yesterday in Oxford for the purpose of waging an intensive campaign for a curtailment of from one fourth to one-third in the 1931 tobacco crop. The organization is similar to one already formed and which is now functioning in the Eastern North Carolina bright belt, and is in line with Governor Gardner's appeal by radio to all tobacco growers in the State to cut their acreage this year. The governor predicted greater disaster than that of 1930 if another big crop is grown in 1931.

Several leaders of the Eastern Carolina movement attended the meeting in Oxford and assisted in organizing the Old Bright Belt Association. Andrew Jamison, of Oxford, was elected president, and G. W. Knott, of Henderson, was chosen as the secretary-treasurer. It was estimated that about 75 tobacco men were present for the meeting.

A meeting was called for next Monday morning at 11 o'clock at the Washington Duke Hotel in Durham to lay plans for the campaign that is to be put on at once. Warehousemen, bankers and tobacco men, in general are invited to attend that meeting.
