Thompson Defeated As Chicago Cites Cermak An Overwhelming Vote

Former Immigrant Boy, Running on the Democratic Ticket, Emerges From the Mayoralty Race With Majority of 191,916; Victory Greeted With Tremendous Ovation by Constituents

Chicago, April 8.—(AP)—The political career of William Hale Thompson, as mayor, today lay buried beneath a record-breaking vote of 191,916, which elevated to the mayorship, Anton J. Cermak, one-time immigrant boy from Bohemia.

"Big Bill, the builder," and a past master of the art of American politics, was swept out of office by his Democratic opponent by the overwhelming majority of 191,916, thus becoming the worst beaten mayoral candidate in the history of the city. The vote, Thompson, 475,613, Cermak, 567,529, was in sharp contrast to previous record majority of 17,477 by which Thompson won in 1915.

The result by which the "cow-boy" mayor's aspirations for a fourth term were abruptly ended, was hailed by his opponents as a "new deal for Chicago."

"Chicago," said Robert Isham Randolph, president of the Chicago Association of Commerce, "has redeemed itself. We've had enough of Nero fiddling while Rome burned. He has told the world that we are prepared to regain our business level and restore our good name."

The mayor-elect, who expects to take office soon—possibly within the next week—took his elevation to the mayorship of America's second city quietly, declaring the "whole world" would not be disappointed in the new administration. He took a nap after the close of the poll, awakening to find himself "in a daze."

"Criminals," he said, "will find no hiding place here. Our streets will be safe. Industry and commerce will find the highest encouragement. We shall at once set ourselves to the task of preparing our house for those who shall visit us at the Century of Progress exhibition. This truly begins a new day for Chicago."

Bedlam broke loose in the streets of downtown Chicago as shouts of frenzied Cermak supporters hailed his victory over the master showman. Bombs and bullets added to the din, but they were fired harmlessly into the heavens. The outburst of enthusiasm exceeded that of Armistice day. There were no disorders last night or during the day's balloting.

But for "Big Bill" who entered the campaign after a bitter partisan campaign fight announcing he would never seek public office again, there was no cause for rejoicing. He smiled—a forced smile—congratulated his victorious opponent and then served notice that the vote that reduced him to a private citizen would not deter him in efforts to aid Chicago.

LONGWORTH ILL IN S. C.

Speaker of House Is Suffering From Severe Attack of Pneumonia at Aiken

Aiken, S. C., April 8.—(AP)—Nicholas Longworth, for six years Speaker of the House, lay seriously ill here today from pneumonia. Mrs. Longworth was at his bedside.

The former Alice Roosevelt, the daughter of President Roosevelt, arrived here to be with her husband this morning at 10:30 a. m. She was summoned last night after physicians attending Longworth revealed a heavy cold he had had for ten days developed into pneumonia Monday night.

While saying their patient was seriously ill, Longworth's physicians would not make public details of his illness.

Dr. R. H. Wilds, of Aiken, said there had been no change in Longworth's condition since last yesterday, but added that Longworth had a "good night."

Longworth, a Republican, began his service in Congress in 1903. He has since continuously represented the first Ohio district.

The physician and his associates in treatment of the case, Dr. Thos. G. Brooks, of Aiken, and Dr. V. P. Sidenstricker, of Augusta, conferred with Mrs. Long soon after her arrival here.

Although they had said there would be an official bulletin on Longworth's condition after the conference, none was issued immediately.

THINKS FARM BOARD FAILED

Chicago Man Says Stabilization Plan Has Failed to Bring Needed Relief

Chicago, April 8.—(AP)—President James C. Murray, of the Chicago Board of Trade, declared today that the stabilization program of the Farm Board "has failed completely in the attempt to maintain the markets on any satisfactory level."

In an address before the Chicago Association of Commerce, he said the Farm Board's operations "have only resulted in accumulations which are a menace to the coming crops."

"Passage of the agricultural marketing act intended to be of benefit to the farmer has admitted failure of its purpose," he said.

Mr. Murray said the Board of Trade strongly recommended that the government should, at the earliest possible date, divert itself entirely out of the business of merchant dealing grain to the end that the marketing of the surplus already stored up shall be handled by the regular dealers in the domestic and export trade with the least possible disturbance to the marketing of the coming crops.

Two important points were stressed by the speaker. First, the welfare and status and progress of God's cause are not to be gauged by the conduct of the multitudes. Today the brazen multitude scoffs at the old landmarks of the Bible, the church, the home, parental responsibility, the marriage vows.

Gurney P. Hood Accepts Newly Created Post Of State Bank Commissioner

Governor Gardner Expresses Gratification Over Action of Goldsboro Man Following Conference This Morning

Raleigh, April 8.—(AP)—Gurney P. Hood, of Goldsboro today accepted the newly created position of state commissioner of banks.

Mr. Hood, a member of the House from Wayne county, was tendered the position last week by Governor Gardner. He accepted after a conference with the executive this morning.

"I am highly gratified that Mr. Hood accepted the position," Governor Gardner said in announcing the result of the conference.

The Senate must approve the appointment, which it is expected to do.

The Seawell law, ratified last week, created the position of commissioner of banks and set up a new banking commission divorced from the Corporation Commission.

Word H. Wood, Charlotte banker; Agnew H. Bahson, Winston-Salem business man; and Col. John F. Bruton, Wilson banker, were named by the governor to serve on the advisory banking commission together with Captain Nathan C. Berry, state treasurer, and Attorney General Dennis G. Brummitt.

Mr. Hood is head of the Hood System of Industrial Banks. He will assume his duties when the legislature adjourns.

SAYS CURTIS NOT TO RUN

Congressman Tilson Thinks Vice - President Will Not Be a Candidate Again

Asheville, April 8.—(AP)—Congressman John Q. Tilson of New Haven, Conn., majority leader in Congress and outstanding national leader, expressed the opinion today that Vice-President Charles Curtis would not be a candidate for re-election and that the Republican party would select another running mate for President Hoover in 1932.

He dismissed Colonel Theodore Roosevelt, Jr., governor-general of Porto Rico, as the possible choice for this place, insisting that the young New Yorker did not possess sufficient strength in his native state to warrant a place on the national Republican ticket.

Congressman Tilson declined to comment on the reports of nationally political writers and observers by radio speakers that he would probably be the vice-presidential nominee in 1932. He explained that he preferred to let such a forecast take its natural course.

Congressman Tilson accompanied by Mrs. Tilson and their two children, John Q. Jr., and Miss Katharine Tilson, arrived in Asheville yesterday afternoon and spent the night here as the guests of Mrs. H. H. Briggs at "Chowhirst" in Chunn Cove.

FEDERAL DRY AGENT SHOT

Government Men Are Fired On When Mistaken for Moonshiners by County Cops

Wilson, April 8.—(AP)—G. W. Mallard, 25, a federal prohibition agent, was in a serious condition here today from wounds he received early yesterday when seven Johnston county officers mistook eight federal agents for moonshiners and fired on them.

The shooting occurred near Clayton at a still the county officers raided the night before and were fired upon by alleged blockaders. L. A. Pollard, Clayton police officer, who accompanied them, was slightly wounded in the gun - fire, and the county officers withdrew to wait for another opportunity to swoop down on the liquor plant.

Unaware that the county officers were near the still, the eight federal officers, from the Wilson district headquarters, raided it also.

While they were engaged in destroying a 500-gallon still, 38 gallons of whiskey, a quantity of beer and empty fruit jars, the county officers fired on them with shot-guns, they said.

Mallard, wounded in the abdomen, was brought to a Wilson hospital. Physicians said he had a chance to recover.

Although Deputy Administrator Perry M. Caudie was out of the city and could not be reached for a statement, other officers at the prohibition headquarters expressed the opinion that federal authorities probably would investigate the shooting.

The agents who accompanied Mallard on the raid were H. V. Andrews, L. T. Brinson, L. G. Carson, J. W. Darnell, B. K. Boykin, Guy Massey and G. L. Pool. The names of the Johnston county officers were given as Deputy Sheriff Marler Stewart, N. D. Barbour, Sam Ellis and J. J. Ellis, Game Warden Weyland Jones and Pollard.

They arrested an unidentified man at the still but he escaped when the moonshiners fired on them.

Body Spends Three Hours and a Half in Debate During the Morning and Recesses for Lunch; House Passes Long Bill to Submit a Constitutional Amendment to the Voters at the Next General Election to Allow Solicitorial Districts Without Regard to Judicial Districts

Raleigh, April 8.—(AP)—Completing three and a half hours of the allotted time of five hours for debate, the Senate was expected to vote on the Hinsdale "luxury" tax amendment to the revenue bill late this afternoon.

The Senate went into regular session a few minutes before recessing for lunch and adopted the House amendment to the administration central purchasing agency bill which leaves the matter of salary of the director of purchase to the governor and budget commission. The Senate sought a \$6,000 limit but the House refused that figure, or \$8,500.

When the body recessed until 3 p. m., more than an hour of debate time had not been used.

Starting debate yesterday on the "luxury" proposal, providing for tax on tobacco, cosmetics, new automobiles, theaters, ammunitions and other selected commodities, the Senate as a committee of the whole agreed to limit discussion to five hours.

No time is being counted when senators are answering questions.

The Hinsdale plan was offered as a substitute by Senator Hinsdale of Wake after the Senate yesterday afternoon eliminated the Day gross receipts tax from the bill sent to it by the House. The Day plan would have levied a one per cent tax on retail merchants.

Efforts to revive it if the Hinsdale plan is defeated were underway today by backers of the MacLean school law.

Hinsdale, Ward of Beaufort, and Peale of Martin, spoke in favor of the Hinsdale plan, while it was assailed by Horton of Chatham, Jones of Richmond, Lawrence of Hertford and Burrus of Guilford. Hendren of Forsyth, opposing the "luxury" tax, told the Senate he hoped it would adopt the Day plan.

Washington, April 8.—(AP)—Lieutenant Commander Charles E. Rosendahl, who knows more about airships in fair sailing and disaster than any other American, today was named first skipper of the Navy's new queen of the skies, the dirigible ZRS-4, better known as the Akron.

Rosendahl is a survivor of the Shenandoah disaster and was for three years captain of the Los Angeles.

The Akron, named for her birthplace, will be by far the largest flying craft in the world, with a cubical content two and one half times that of the Los Angeles, nearly double that of the Graf Zeppelin and 35 percent larger than that of Great Britain's ill-starred R-101, which crashed in France last year.

Northern States Visited By Snow

New York, April 8.—(AP)—Sections of upper New York State, Pennsylvania and New England were covered with snow today as a result of a storm which crippled power and light service in several communities and hampered highway traffic throughout the affected areas.

Salem, N. Y., was thrown into darkness when a 12-inch fall of snow disabled the lighting system. Many telephone lines were down. Traffic in the vicinity of Olean, N. Y., was hampered by the storm during which 10 inches of snow fell in 24 hours.

DENNIS GIVEN ROAD TERM

Moonshiner Appeals From Six Months Sentence in County Court Here

Skilton Dennis, moonshiner, captured by county officers in a raid in the Winterville community, was sentenced to twelve months on the county roads by Judge W. L. Whodbee in the regular weekly session of County court here yesterday.

Dennis was charged with manufacturing whiskey and firing on a county officer. He filed notice of appeal to Superior court under bond of \$1,000.

France Announces His Candidacy for President of U. S.

Baltimore, April 8.—(AP)—Offering a platform opposing government interference with private business, repeal of the 18th amendment and a concert of nations, former Senator Joseph I. France, of Maryland, has announced himself a candidate for the Republican nomination for President of the United States.

Dr. France was in the United States Senate from 1917 to 1923. He was one of the "irreconcilables" who opposed the entry of the country into the League of Nations, proposing as a substitute a concert of nations.

In 1920, he was an ardent advocate of opening trade relations with Russia, but not recognition and in his platform he opposed such recognition "in advance of mutually satisfactory settlement of all moral and financial questions."

"The 18th amendment," he said in his platform, "is an important issue, but involves two paramount issues: Shall we elect to the Presidency any man who can condone such a terrific blow struck at the very roots of constitutional government? Shall the people elect to the Presidency, at this critical time, any man who has lacked the candor and the courage to state soundly and clearly where he stands upon this and every important issue of vital concern to the American people?"

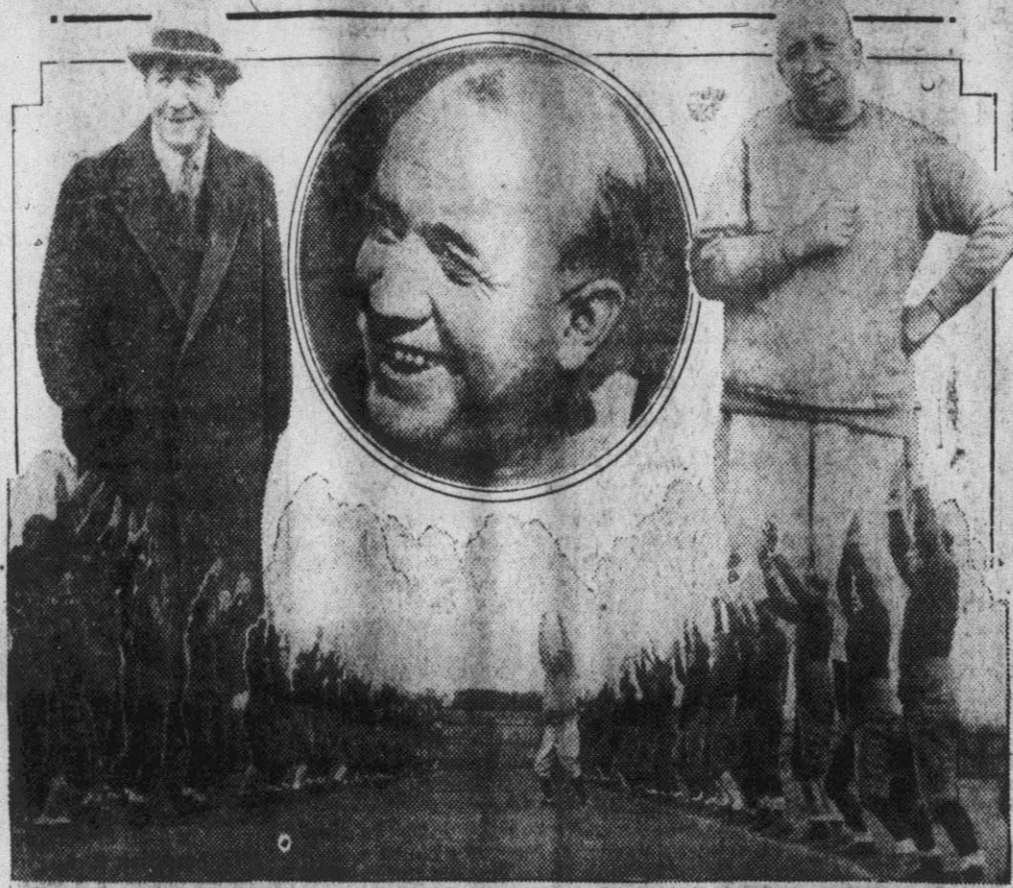

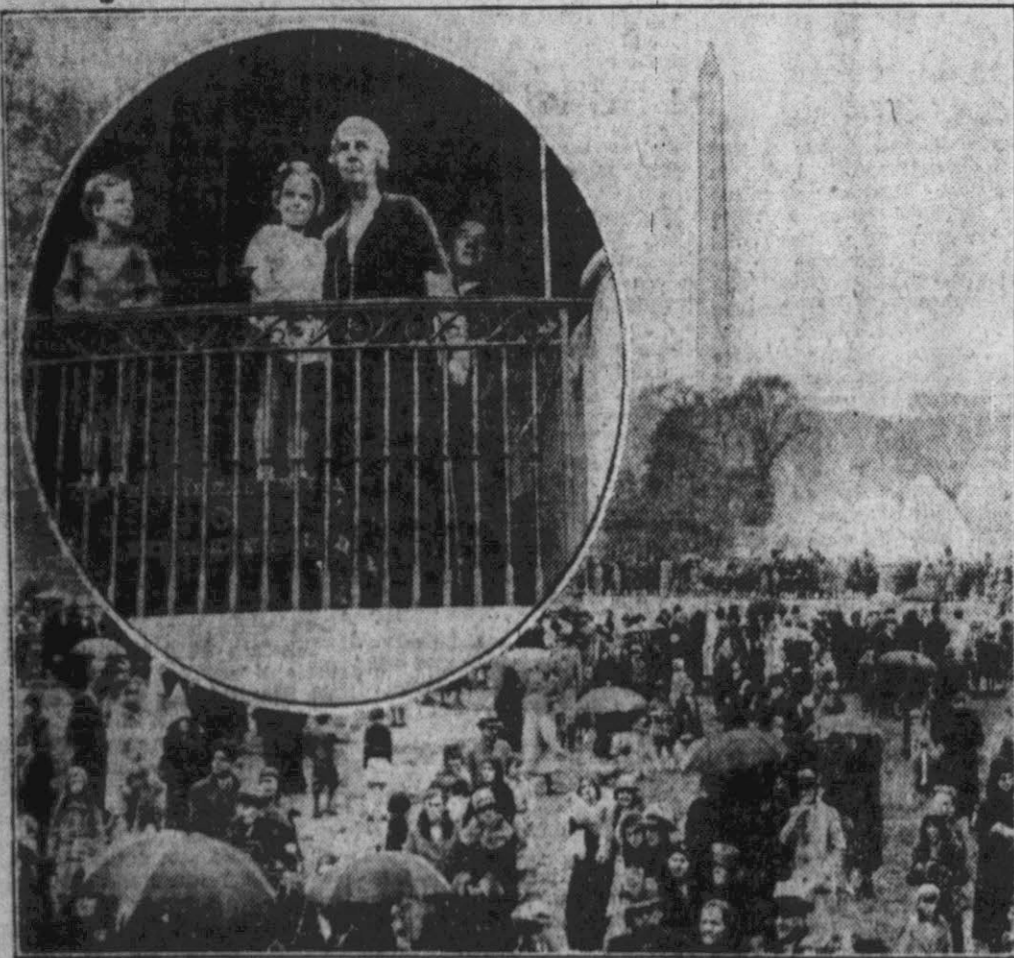

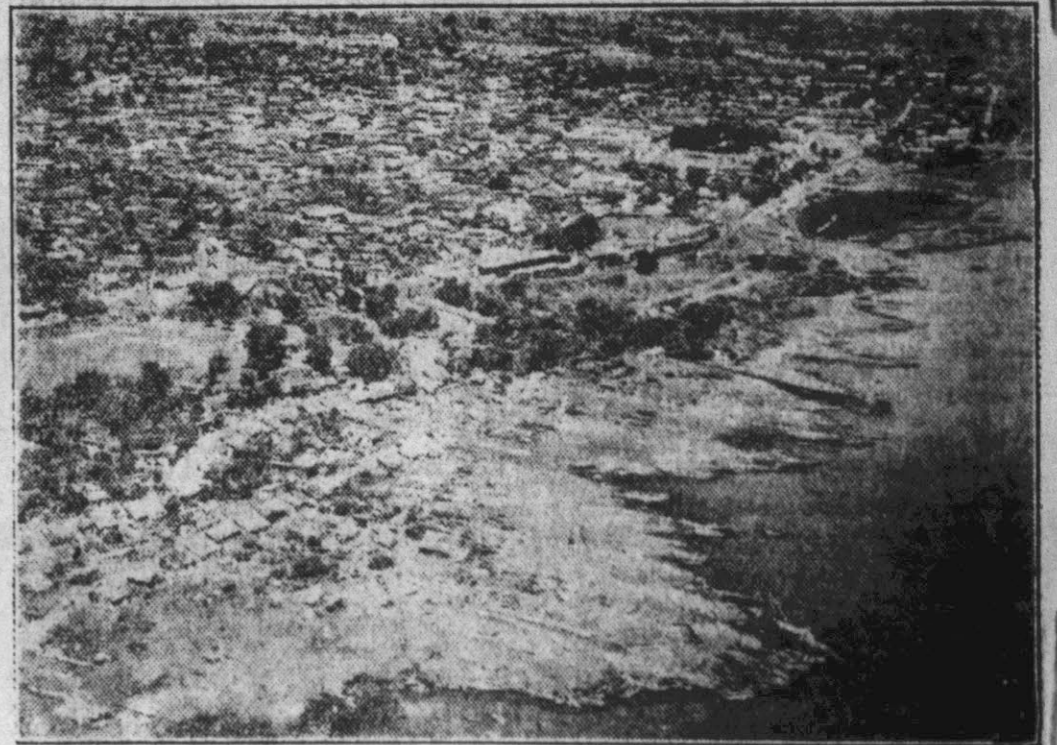

Co-Op Receivership Has Cost \$200,000

Raleigh, April 8.—(AP)—The receivership of the Tri-State Tobacco Cooperative Association, which began five years ago, has cost to date more than \$200,000 in attorneys' and receivers' fees.

This total was reached yesterday when Judge I. M. Meekins, in U. S. District court, signed an order distributing \$20,000 in fees to four receivership attorneys.

ASK FOR TRUE LAND VALUES

County Tax Relief Association Passes Resolutions at Meeting Here

The Pitt County Tax Relief Association held a meeting on Monday, April 6, that was well attended. By unanimous vote the following resolutions were adopted:

"WHEREAS: Pitt County Tax Relief Association and the under-entirety and business be on equal footing. It opposes unfair and unequal tax burdens, under which Pitt County real estate owners are now living; and

"WHEREAS: Pitt County real estate is now on the tax books of the county at fictitious values, almost without exception greatly in excess of true values. That such violates Article 5, Section 3 of the Constitution of this State, and thereby violates property rights. That Pitt County is about to begin taxing property for taxation for the year 1931, without re-valuing its real estate for the purpose of having on the tax books at its true value.

"Therefore: Pitt County Tax Relief Association do hereby signed petitioners do respectfully resolve and petition Pitt County Board of Commissioners to cause the real estate of Pitt County to be placed upon the tax books at its true value in money as required by our Constitution and fairness.

"And we represent that if our property is so valued for taxation we will put forth our best efforts to pay our taxes promptly. We further represent that if our property is not so valued, within the bounds of reason based upon sale of such property in the way that such property is ordinarily sold, we shall order resist the payment of taxes on values which violate our Constitutional rights."

On motion of W. C. Dresbach, seconded by Mr. Mark H. Smith, it is resolved: That this association give its hearty support to the Mac Lean law, and petitions our Representatives to firmly support it. That it is further resolved that this association does not advocate any sales tax but that if choice must be made between a general sales tax and luxuries sales tax, that the luxuries sales tax be accepted as less objectionable than the general sales tax.

The sense of the meeting was strongly against the present values on farm property as it appears upon the tax books. About seventy farm owners and home owners signed the resolutions relative to tax values and presented it to the Board of County Commissioners. In each township the resolutions in the form of a petition, is being circulated among property owners. For encouragement of land owners it is stated that it is reasonably certain that as many as a thousand Pitt County land owners will sign this petition pledging to support the Constitution of this State and to oppose its violation as is being attempted through fictitious and excessive values on farm land as now appears upon the tax books.

Air Corps Will Concentrate On Dayton In May

Washington, April 8.—(AP)—Defense of America's industrial centers and a majority of its population will be the problem next month confronting the Army Air Corps in its history.

Flying from all parts of the country, regular air corps forces, combining with National Guard forces for the first time, will concentrate at Dayton, Ohio, and related points to defend the Atlantic seaboard from Maine to Virginia against an imaginary enemy, said P. Trubee Davidson, assistant secretary of war for air.

"Never in its history has the Air Corps," Davidson said, "held field maneuvers on the scale involved in the present mobilization. It is necessary that they take place because it is the only way of finding out whether theories are practical and efficient."

"A mass attack against the great eastern centers to cut off supplies, demoralize the east and diminish armed resistance would be the first effort of offensive force attempting to land in the United States. The forthcoming maneuvers are to test the mobilize of the Air Corps to the greatest possible extent."

"In the mobilization of 672 airplanes," he continued, "the air corps is massing every available piece of equipment outside of training planes. This does not mean that we would have 672 planes for war combat should an emergency arise tomorrow. The fact is that we would have only about 425 combat planes, the remaining number being cargo and school planes."

"In their concentration air corps planes will fly over every state in the union, affording an opportunity to some 75,000,000 citizens to witness the demonstration."

Banking & Trust Co. And Branches Show Increased Deposits

Deposits in the Greenville Banking and Trust Company and its branches in Grimesland and Bethel have shown a gain of \$345,369.94 during the last year, it was revealed in the statement of the condition of the institution on March 25.

On March 27, 1930 deposits in the three banks were given as \$1,421,002.72. The recent statement listed deposits at \$1,826,372.66.

Bank officials view the increase with pride owing to the fact that it was realized during one of the most pronounced periods of depression the nation has experienced in years. The growth was due largely to progressive banking methods, and increase of service to the depositors in the three towns served by the institution.

Says State Must Improve Farming or Face Ruination

Goldboro, April 8.—(AP)—Hugh McRae, of Wilmington, president of the North Carolina Conference for Social Welfare, holds the state must choose between development of a better agricultural system and ruin. Addressing the conference here last night, McRae urged that vigorous efforts be made to evolve an agricultural order able to compete with the economic set-up of the world. He suggested a definite and extended program to teach the farmers the necessity of adopting a live-at-home system.

More than 250 delegates are attending the conference, which is devoting special attention to unemployment as related to agriculture. The sessions began yesterday and will close today.

Two Men Killed In Tunnel Blast

New York, April 8.—(AP)—The "touch off" man of a blasting crew working in a tunnel 605 feet below the street pulled a switch last night just at the moment a messenger ran up to tell him the order had been changed.

The explosion rained tons of rocks and earth on fifty men and two of them, Weyman Moffatt, 30, night superintendent, and Tedeimo Fernandez, 27, foreman of the muckers' gang, were killed. Three others were injured.

The tunnel is a part of a \$44,000,000 Catskill water system that will supply the boroughs of Brooklyn and Queens. Thirteen men have previously been killed in the construction and the project has become known as "the black luck tunnel."

The career of the manufacturer was as brilliant as the annals of the Carolinas afford. Born at Fort Mill S. C., he started as a wholesale grocery salesman in Charlotte and rose to a position of first place in the industrial and commercial life of the Carolinas and the south.

At his death, he owned seven cotton mills in Lancaster, Chester, Kershaw, and Fort Mill S. C.; was director of numerous banks and president of a short-line railway and was interested in water power and fertilizer companies and several mercantile concerns.

UP TO THE SENATE.

In our opinion the Senate took the proper step when it eliminated the general sales tax plan from the revenue bill to make way for the luxury tax plan. It is to be hoped that the action on the latter late today will be favorable. Now if the Senate will put the recapture clause, eliminated by the House, back into the revenue bill and repeal that section of our laws that exempts stocks in foreign corporations from taxation, that body will be getting on the road to raising enough revenue to run the state and schools, from the sources from which it should come.

As we see it, the luxury tax is far more desirable than the general sales tax in that it does not place the burden upon those people able to purchase only the bare necessities of life, but upon those who are able to purchase non-essentials and enjoy luxuries beyond the means of the poorer classes. The elimination of the recapture clause by the House cut approximately \$600,000 from the revenues that would have been paid by the power companies and other public service corporations and industries from excess profits and this feature should be replaced in the revenue bill.

Then as to the repeal of the foreign stock exemption there can be no argument. The enactment of this piece of legislation in 1923 was one of the greatest outrages in the history of our law-making bodies and there can be no justice in taxation in this state until this piece of favoritism is removed. The adoption of these features into the revenue bill by the Senate and the concurrence of the House in the same bill will justify the existence of the General Assembly of 1931. Otherwise it cannot be said that the session did its duty to the people of the state.

In Eastern North Carolina there has been a steady increase in the production of bright tobacco. In 1926 it produced 231,210,178 pounds and the price averaged \$26.31 per hundred pounds; in 1927 the production was 291,400,019 pounds with an average price of \$22.17 per hundred; in 1928 it produced 324,286,296 pounds, with an average price of \$19.24 per hundred; in 1929 it produced 305,732,054, with an average price of \$18.64 per hundred, and in 1930 it produced 356,286,599 pounds, with an average price of \$13.25 per hundred.

Liner Runs Aground At Southampton But Is Towed In

Southampton, Eng., April 8.—(AP)—The giant Cunard liner Berengaria was anchored in a dense fog off Nab Tower, at the entrance of the Spithead today, after spending several hours aground nearby during the night. Blinded by a heavy fog the liner went aground early in the evening as it proceeded from Cherbourg. There was a jar and a heavy crunching sound, and then the vessel shivered as its engines were thrown in reverse in vain efforts to refloat it. Four tugs went out from Southampton but their efforts were futile until reinforced by two others and a rising tide at 3 a. m. All but 75 of the liner's passengers were removed by tender shortly after the accident and taken to Southampton. Others remained aboard, electing to spend the night on the ship rather than risk the trip by small boat into port. When the Berengaria reached her berth at the docks no trace of damage was found in an examination of the hull from the inside and no marks were visible on the outside.

No Damage Results From High Rivers

Raleigh, April 8.—(AP)—High waters in Eastern Carolina rivers were nearing the coastal section today without having done any material damage and with prospects none would be done. Lee A. Denison, in charge of the United States Weather Bureau here said. The Roanoke, Neuse and Cape Fear rivers had reached flood stage today at some stations but the overflow in no instance was more than five feet, Mr. Denison said, which meant that only a small acreage of lowland would be flooded. The temporary bridge over the Cape Fear at Lillington remained closed today due to high water. John D. Waldrop, state highway engineer, said it would probably be opened tomorrow. No other highways are affected. The Roanoke river was 32.8 feet deep at Weldon today, about three feet above flood stage. The Neuse was about one foot out of its banks at Smithfield. The Cape Fear was at 32 feet at Fayetteville, really three feet below flood stage but high enough to necessitate a warning, Mr. Denison said, and was slightly less than three feet out of its banks at Elizabethtown with a

Vote Against Impounding of Ballot Boxes

Raleigh, April 8.—(AP)—The House committee on elections this afternoon voted to recommend that the Butler-McBee resolution requesting the governor to impound ballot boxes in the Bailey-Prichard senatorial election not be passed. The committee also recommended that "in so far as practicable at this late stage, steps be taken to safeguard the ballots and ballot boxes used in the election until such time as by due process of law they may be taken over by the Senate of the United States." The resolution was introduced in the House by the two Republican members as an outgrowth of the contest of the election of Senator J. W. Bailey, filed by George M. Prichard, Republican. The committee reported it had found the laws of North Carolina "do not require preservation of the ballots in an election in the absence of request or notice of contest." It was noted that Prichard never served notice of the contest with the State Board of Elections or any official of the state. The contest was filed in the United States Senate.

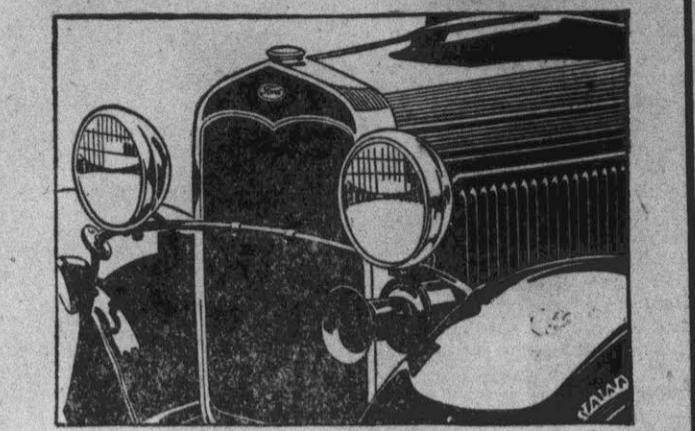

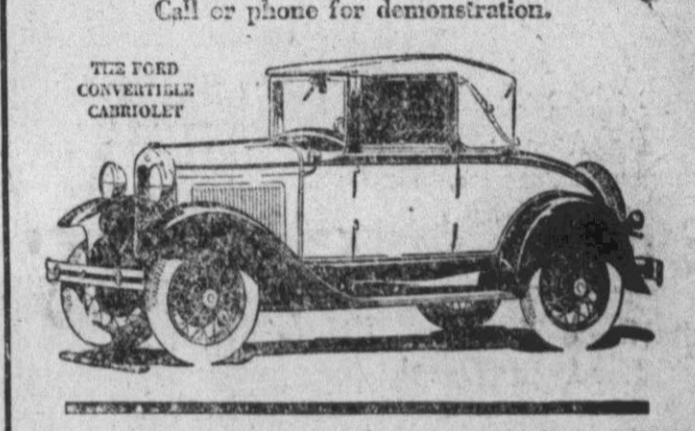

TWO FISTIC BATTLES FOR THE SUMMER

Max Schmeling is slated to defend his title against Young Willie Stripling in Cleveland, probably in July, and now it develops that lumbering Primo Carnera of Italy and Jack Sharkey have been matched for a bout at Ebbets Field, Brooklyn, on June 10 and the winner probably will be recognized by the New York State Athletic commission as champion.

Reports current for some time that Jimmy Johnson, who shifted his role from manager to promoter, had opened his battle against the Madison Square Garden Corporation by signing up a rival heavyweight attraction were crystallized yesterday with the definite news of the date for the 15 round scrap. Several kinks in the program still must be straightened out, but unofficial word from the boxing solons indicated that the commission would lend a hand at this business.

Officially the commission announced that Carnera, suspended after his famous "fungo hitting" tour, will be reinstated "sooner or later." Unofficial it was made known that the reinstatement would be in time for a meeting with Sharkey and that the contract the Ambling Alp has with the Garden for a meeting with the winner of the Schmeling-Stripling bout would be overlooked by the commission. Half the profit of the Ebbets Field show, it is understood, will be given to New York charities.

Fire, believed caused by defective wiring, destroyed his stable containing the 18 horses.

Lexington, Ky., April 8.—(AP)—Hollywood Daisy today was the only one left of ten fine broodmares owned by John L. Dodge, New York, trotting horseman. The other nine, valued at almost \$100,000, were burned to death when fire destroyed a barn on his Hollywood farm near here last night.

With the broodmares, five foals and four mules lost their lives. The total damage to barn and contents was estimated by the farm overseer at \$125,000.

Plan to Erect New Field House to Knute Rockne

South Bend, Ind., April 8.—(AP)—A new field house may rise on Notre Dame's campus as a tribute to Knute Rockne.

Members of the Rockne memorial committee at their meeting last night, were unanimously in favor of building a much needed field house in his memory instead of retaining the new football stadium "Rockne Stadium."

Committees will be organized in all principal cities of the United States to receive donations for the fund. If it is large enough, a new field house is reasonably certain.

"Rockne will ever be remembered as a builder of men rather than a great football coach," a prominent committee member explained. "And it is felt that a new field house would be better as a memorial than the re-naming of the football stadium. A suggestion that he himself blocked before it hardly became known."

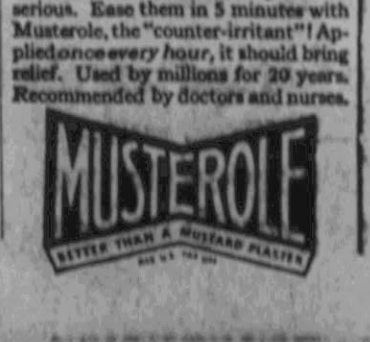
"Battling Ban," as Byron Bancroft Johnson was known most of his life, will remain best remembered for the many engagements he fought, whether it was win, lose or draw.

The New York baseball fraternity in 1922 when Johnson discarded the official record so a game here that season, accepting instead the unofficial record so that Ty Cobb would be credited with an extra base-hit and thereby gain, for the third time, a percentage of 400 or better.

Johnson's action fixed Cobb's figure for 1922 at 401. The Georgian had batted .420 in 1911 and 410 in 1912.

Johnson contended the official scorer was inaccurate in this and other features of his report on the particular game involved but there was a terrific hullabaloo at the time. The baseball writers, in solemn session, denounced Johnson and adopted resolutions demanding Cobb's mark not be recognized. It wasn't that they begrudged Ty any of the glory, but they resented Johnson's arbitrary decision in the player's favor. Cobb is down in the record books at 401, nevertheless.

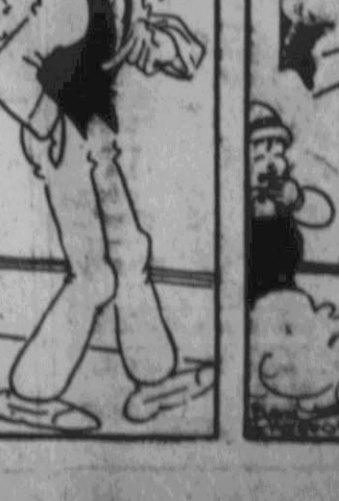
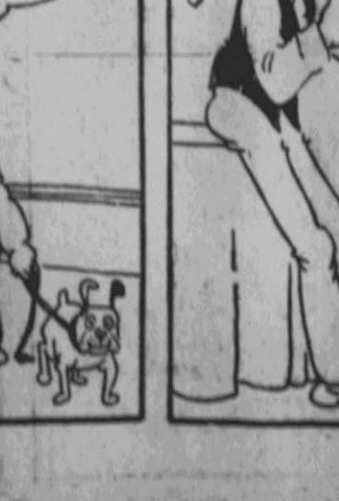
