Special Police Mobilized For Action May Day

N. Y., London and Other Large Cities of the World Take Steps to Prevent Disorders During Celebrations of the First of May

New York, April 30.—(AP)—Police Commissioner Mulroy mobilized special police details today in preparation for the May day celebration tomorrow.

He ordered a police guard for every church and public building and for homes of prominent citizens an asked every precinct commander, especially those near Union Square, the center of Communist speech making, to keep reserve squads ready, yet he said he expected no trouble.

The spotlight will fall mainly on the Communists, Socialists and Veterans of Foreign Wars, all of whom have arranged to meet in Union Square at hours prescribed by the police department, so as to avoid possible conflict.

London, April 30.—(AP)—Police of much of the world today made preparations to suppress disorders and maintain order during widespread observance tomorrow, May Day, of International Labor Day.

In England May Day celebrations have gone somewhat out of fashion and little beyond some soap box oratory and a few small processions was expected in London, but elsewhere in Europe and in Spanish American observance prevented a more serious problem.

The government has forbidden open air meetings and parades in Paris in an answer to efforts of Communists there to stage a great demonstration tomorrow. Vigorous preparations were made to combat any breach in order.

Police of Berlin, where the celebration two years ago initiated serious rioting which lasted two days, will be mobilized for the day and a rigid curb placed upon demonstrations.

Mexico City, April 30.—(AP)—A force of 3,000 police will guard against disorders in Mexico City tomorrow, when workers' organizations plan to celebrate labor day with street meetings and parades. Mounted police detachments will patrol the streets and a strong guard will be stationed in the Zocalo or main plaza, where the national palace is situated.

Four Hundred Killed in 'Quake

Erivan, Armenia, April 30.—(AP)—Nearly 4,000 persons were killed and 2,000 injured in the earthquake which rocked Armenia on Monday, according to preliminary estimates, and property damage probably will reach \$1,000,000.

The shocks were felt generally throughout Armenia but were most severe in the southwest near Nakhichevan, where the longest shock lasted about a minute and was followed by terrifying subterranean rumbling.

The flimsy native huts collapsed in a dozen villages, and at the little town of Sisian every house was destroyed. The villages of Gerovin and Megrin also suffered heavily.

Twenty thousand peasants are said to be homeless in the Kafanze district, living in the open. A heavy rainfall is adding to their misery and food is scarce.

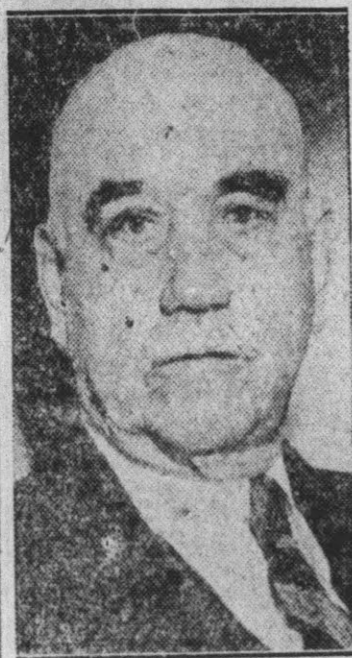
In the Gerusian district nine villages were wiped out with more than 100 killed, and at Sisian the death toll was even higher. All wire communications and electrical lighting systems were badly damaged.

Hilwaize, Ga., April 30.—(AP)—Doyle Gregory is "free, white, and 21, and married," but so far as his father, Sheriff J. R. "He decided to 'pitch' one because I was out of town," Sheriff Gregory told in a public announcement. "So when I returned I said to him, 'son, I have been getting after other folks for doing this thing and here you are making a fool of yourself. I'll just teach you a lesson you won't forget.'"

YOUNG HERO IS HONORED

The President Gives Bryan Untied Opportunity to See the Nation's Capital

Washington, April 30.—(AP)—Bryan Untied went sightseeing today in deluxe fashion.

The 13-year-old Colorado school boy, guest of President Hoover because of heroism in a school bus tragedy during the March blizzard, left the White House early in a big presidential automobile. He was accompanied by Mrs. Stark McMullin, a friend of Mr. and Mrs. Hoover. Together they rode around the speedway jutting into the Potomac. Cherry blossoms still are in full bloom there. A trip also was made to Arlington National cemetery and the tomb of the unknown soldier.

The boy was particularly interested in the monument to those killed when the Maine was sunk and asked to see the grave of Floyd Bennett, who flew the plane in which Admiral Byrd crossed the North Pole.

At the Fort Myer, Virginia, stable Bryan saw the fine horses ridden by the presidential body guard. He was up early enough to have breakfast with the president and to see the latter play medicine ball on the south lawn.

The boy arrived in Washington early yesterday, and began a round of activity which might well have tested the staying power of most adults. Everybody connected with the White House started out to see that he had a good time, and when he went to bed in the blue room he had pretty well exhausted all the nearby sights, as well as himself.

First of all he saw and talked with President and Mrs. Hoover and long before he could get over that he watched the brilliant ceremonial attending the formal reception yesterday morning of the king and queen.

A sightseeing trip to Washington Monument followed and then an informal, pleasant family luncheon with the president recalling the table with amusing stories.

After lunch there was a session with photographers followed shortly by a visit to the navy yard with Captain Noel Boone, White House physician.

The visit to the White House came near ending when the boy was shown the gun room of the navy yard. Dr. Boone said he almost had to drag Bryan away from the firearms display. From there they went to the Ford Theatre where Lincoln was shot and cross the street to the house where Lincoln died.

DR. ALDERMAN IS A VICTIM OF APOPLEXY

Va. University President Dies in Pennsylvania While Enroute to Illinois

Charlottesville, Va., April 30.—(AP)—Dr. Edwin A. Alderman, president of the University of Virginia for 27 years, died last night as he was speeding westward to give his blessing to the start of an old friend in a new task.

Apparently in good health despite his 69 years, Dr. Alderman left here by train for Urbana, Ill., where he was to take part in the induction of Dr. Harry W. Chase into the presidency of the University of Illinois.

A few hours after the train left Washington, he was stricken by apoplexy and at Conneville, Pa., he was removed to the state hospital. He died there a short time later.

His body will be brought here Friday for funeral services at 11 a. m. (EST) Saturday. He will be buried in the university cemetery. Long prominent in southern educational circles, Dr. Alderman was known nationally as a member of the General Education Board and as an intimate and defender of Woodrow Wilson.

Before and after his election to the education board, he fought for universal education. As assistant state superintendent of schools in North Carolina in the early 1890s, he preached the doctrine of "education for all" up and down the state.

In later years, his ideas were incorporated in the program of the board and he was hailed as one of the early educational liberals in the south.

His close association with President Wilson as personal friend and professionally led Congress in 1924 to invite him to deliver the address at a session honoring the war President. There he defended Wilson's idealism. "He sought," said Dr. Alderman, "to give the twentieth century a faith to inspire it and to justify the sacrifice of millions of lives, and if there was a failure, it was humanity's failure."

Dr. Alderman was graduated and later president of the University of North Carolina, the state of his birth. He was born May 15, 1861 at Wilmington and gained his first degree in 1882.

He was connected with public schools in North Carolina until 1892 and after one year as professor at the State Normal College was appointed professor of education at the university. He was chosen as president in 1899 and of the University of Virginia in 1904.

Dr. Alderman is survived by his widow, formerly Bessie Green Heath of New Orleans, and a son, Edwin A. Alderman, Jr., of New York.

Urbana, Ill., April 30.—(AP)—Dr. Harry Woodburn Chase, former president of the University of North Carolina who will be installed tomorrow as president of the University of Illinois, expressed his sorrow today in a statement of tribute to Dr. Edwin Anderson Alderman who died last night while enroute here.

"I have been deeply shocked and saddened," said Dr. Chase, "to learn of the sudden death of my friend (Continued on page four)

False Alarmist Sent To Roads

Negro Given Six Months for Sending in False Alarm; Another Man Given Six Months for Aiding Prisoners to Escape From County Jail

Jarvis Parker, negro, charged with turning in a false fire alarm in Greenville, was sentenced to six months on the roads by Judge W. L. Whedbee, presiding at the regular session of County court in this city yesterday.

Parker was nabbed by police following an alarm sent in from the western section of the city about a week ago. Two negroes testified they saw Parker standing around the fire alarm box at the time the alarm was sounded.

It was the first arrest made in connection with an epidemic of false alarms which have occurred from various sections of the city the last several months. The practice had become so widespread that members of the Board of Aldermen offered a reward of \$50 for the apprehension and conviction of anybody responsible for sending in a false alarm.

Parker was said to have been drunk when taken into custody by police. Whether he had been engaged in sending in any other alarms could not be said, but belief was expressed that he was.

Robert Lovitt, charged with aiding prisoners in an effort to escape from the county jail about two weeks ago, was sentenced to the roads for six months.

Lovitt was charged with delivering a package of hacksaw blades to the prisoners on a visit to the jail, and was arrested and held for county court action shortly after the attempted escape had been frustrated by county officers.

Kid Williams, colored, charged with assault with a deadly weapon, was sentenced to the roads for six months.

Janie Lewis, colored, paid cost in an assault charge.

Owing to the congested docket, it was necessary for county court to remain in session two days this week. The congestion was caused by no court being held during the criminal term of Superior court the last two weeks.

Portuguese Begin Attack On Rebels

Lisbon, April 30.—(AP)—Federal forces aboard Portuguese warships off Madeira began a general attack on the island this afternoon, directing an intensive bombardment against rebel forces which installed a junta government at Funchal nearly a month ago.

Three detachments of infantry were landed at Machico, fifteen miles northeast of Funchal under cover of the naval guns. Seaplanes supported the attack.

GROUPS TALK U. S. BUSINESS

Many Phases of Activity Discussed at Annual Meeting of Chamber Commerce

Atlantic City, April 30.—(AP)—Employment stabilization, the relation of installment buying to business depression, retail sales taxes and trade associations were among the subjects discussed before various groups at the annual meeting of the Chamber of Commerce of the United States today.

M. B. Folsom, assistant treasurer of the Eastman Kodak Company, told of measures adopted by industries in Rochester, N. Y., to reduce seasonal fluctuations in employment.

He said a survey of 69 concerns employing 41,000, revealed that production and employment had been materially stabilized by sales forecasts, production scheduling, manufacturing for stock, standardization of products, diversification of products and intensification of sales efforts.

Edwin C. Vogel, chairman of the executive committee of the Commercial Investment Trust Corporation, defended installment buying against critics who blame it as a factor in the business depression.

The record of installment credits during depression, he said, compares favorably with results from other forms of credit. He said that predictions installment credits would collapse in a period of depression and unemployment had proved unfounded in the experience of the past 18 months.

Charles F. Abbott, executive director of the American Institute of Steel Construction, Inc., said that trade associations are the voice of the industry they represent. He urged that trade organizations take the lead in bringing about industrial recovery.

B. Earl Puckett, president of Frederick Looser and Co., of New York, denounced the retail sales tax as an unjust form of taxation, the greatest burden of which would fall upon the small consumer. A general sales tax, he said, is administratively impossible because of the wide ramifications and tremendous detail involved in the collection of a tax on retail transactions.

Taking up the subject of banking controller of the currency Policy expressed the belief that branch banking under national sponsorship would do much to decrease the difficulties of the depositaries. He said he believes there was strong public support for a program which would encourage the banking system to operate under the standards of big-city banks.

Measure, Including Selected Commodities Tax, Passes Second Reading By a Vote of 67 to 41; Senate Approves Co-operation of State Officials in Investigation of Bailey-Pritchard Senatorial Campaign; Upper House Also Puts Stamp of Approval Requiring High Schools to Use Same Text Books

Fraleigh, April 30.—(AP)—The House passed the conference report on the biennial revenue bill, including selected commodities sales tax, 67 to 41 on second reading today.

The Senate, taking up its public calendar, added its approval to the substitute House resolution providing for co-operation by officials of the state in a re-investigation of the Bailey-Pritchard senatorial election.

Seeking the use of uniform text books for schools throughout the state, the upper division of the assembly also added its approval to the state in a re-investigation of the Bailey-Pritchard senatorial election.

Both Houses passed a resolution introduced by Senator Ward of Tennessee expressing regret at the death of Dr. Edwin A. Alderman, president of the University of Virginia and a native North Carolinian.

The Senate tabled the Baggett bill to make the commissioner of revenue appointive.

The resolution provides that all ballot boxes and ballots not destroyed be gathered at the offices of the clerks of Superior Court and turned over to the Federal investigators when they ask for them. The state is to be put to no expense it is stipulated.

As the contest of the election of Senator J. W. Bailey was not filed until four months after his defeat of George M. Pritchard, the resolution sets forth that the co-operation be done "insofar as possible at this late stage."

The Senate adopted the conference report on the luxury tax early this morning by a vote of 27 to 22. On three previous occasions the Senate has defeated the luxury tax, each time by a vote of 26 to 24.

Absent and not voting: Grant (Republican), Total 1.

The voting was marked by two attempts on the part of pro-luxury tax senators, Hatchett of Caswell, and Gower of Johnson, to break their pairs. Upon objection by Senator Orier of Iredell, that both pairs were recorded in writing with the principal clerk, Senator Hatch consented to let his pair stand, but Senator Gower did not consent to let his pair stand until after it became apparent that he could do so without jeopardizing the success of the luxury tax.

Senator Folger of Surry, leader of the anti-sales tax forces delivered the only speech on the conference report. He vigorously attacked it. On the grounds that it shifted taxes from the wealthy landowners to the "poor men who could not afford to buy more than one pack of cigarettes at a time."

He predicted that the next legislative would be Republican as a result of the tax.

According to the estimate of Commissioner of Revenue A. J. Maxwell, the bill will raise approximately \$25,000,000 annually. Senator Hinesdale, sponsor of the luxury tax, however, estimates that it will raise about \$28,000,000. The difference is in the luxury tax. (Continued on page four)

Last Kinston Bank Fails to Open for Business Today

Kinston, April 30.—(AP)—Kinston was left without banking facilities today when the Farmers and Merchants Bank failed to open its doors.

Notice posted at the entrance stated the bank had been closed by the directors "for the protection of depositors."

A short time ago the city's other two banks closed their doors. Officials of the bank said its affairs were in the hands of the state banking department and officials from Raleigh were expected to arrive during the day to take charge.

Word of the closing created consternation throughout the city and a large crowd assembled in the vicinity of the bank.

It had been believed that the institution was in sound financial position after it waded through the financial storm created by closing of the National Bank of Kinston at the First National Bank on April 21.

Sylvester L. Shough is president of the bank; William Allen, vice-president, and Frank O. Fitzgerald, cashier. Pending arrival of representatives of the state banking department they would make no statement relative to the bank's condition.

The bank had deposits of \$367,000, according to its statement of March 25 to the state bank examiner. The institution was capitalized at \$47,900, had \$50,000 surplus and \$5,000 undivided profits March 25 with total resources of \$772,000.

In the hope of securing banking facilities for the city a committee of business men was organized shortly before noon. Leading business men composed the committee, which immediately went into session to consider the situation.

BOARH SCORES WASTE SYSTEM

Replies to President's Statement Regarding Expenditures by Congress

Washington, April 30.—(AP)—The people have been told by Senator Borah that the federal government is approaching "the most wasteful, the most demoralizing and most inefficient form" yet conceived.

This statement the Idaho Republican made yesterday to answer President Hoover's recent assertion that no tax increase would be necessary if congress kept expenditures within budget recommendations.

Borah replied that "congress is constantly being besieged by the executive departments for much larger appropriations than congress is willing to grant."

In the last 10 years, congress has lopped \$44,000,000 from budget estimates, while federal appropriations have grown from \$1,098,632,000 in 1914 to \$4,821,374,000 for 1931.

There is no remedy for the situation Borah said, "unless the people, the voters themselves, place this subject on their agenda and call for an accounting in no uncertain terms."

Within the last two years, the Idahoan asserted, 26 government commissions have been established, of which congress has been responsible for only one or two.

"The most wasteful and extravagant part of the government is this bureaucracy, nation-wide, which we are building up, and appropriations are its life blood," he continued.

"Unless there is some limit to be placed upon the building up of these bureaucracies there cannot possibly be any decrease in appropriations."

"In Washington treason may be said to consist of a conspiracy to prevent increase of salaries or to abolish an office or to refuse to create an office—especially commissions."

"It is perfectly certain that this bureaucratic tendency can lead to nothing but permanent increase of government expenditures and permanent increase of taxes."

"It is no easy thing to change this. It cannot be done in my judgment, except by a most thoroughly aroused and sustained and angry public opinion."

which Maxwell estimates will raise not more than \$6,000,000 and Hinsdale says will raise 9,000,000.

The measure as adopted would raise the \$18,500,000 to carry out the MacLean law to provide support for the six months school term from sources other than ad valorem taxes.

The House passed a bill by Representative Moss of Nash to set the minimum license plate fee for automobiles at \$12.50. Under the Moss-Cherry bill, changing the basis of licensing automobiles from horsepower to 55 cents per hundred pounds, the minimum would have been \$12.50 and the state would have lost \$100,000 in revenue annually.

After debating the measure more than an hour the Senate passed the Davis measure to authorize and direct the State Highway Commission to construct an improved highway from Swan Quarter to Englehard in Hyde county.

# WES FERRELL HURLS NO-HIT, NO-RUN GAME

By GAYLE TALBOT, JR. (Associated Press Sports Writer). Possibly the Cleveland slugger had taken his chiding members of their hurling staff. Something like:

"Yeah, if it wasn't for us hitters, where would we be. We wouldn't be riding out in front of the American League if we had waited for you guys to get going."

Anyway, young Wes Ferrell took it upon himself yesterday to uphold the honor and dignity of the tribe's curving corps. Any future insinuation that the nub's batting order is carrying all the load will fall pretty flat.

Wes went the limit to prove his point. He pitched the first no-hit, no-run game seen in the major leagues in nearly two years to lick St. Louis Browns, 9 to 0.

The star righthander, starting his third campaign in the big show, allowed only six men to reach first—three on walks and three on errors by Bill Hummel—and not one of them got as far as second base.

He struck out eight and, incidentally, won his fourth victory of the young season.

Ferrell further repudiated the swatmiths by driving in four runs with a homerun and double. Earl Averill also cracked one into the outer stands to help hand the Browns their sixth straight reverse and send them into a tie with the Red Sox at the bottom.

The last previous no-run, no-hitter was pitched by the Giants southpaw, Carl Hubbell, who victimized the Pittsburgh Pirates on May 8, 1928.

The victory kept the Indians a game and a half in front of the Washington Senators, who took

undisputed possession of second place by thumping the crippled Yankees again, 8 to 5. The New Yorkers have dropped four of their last five with only a 14-inning tie to break the monotony. They failed to easily four-run lead off Lloyd Brown yesterday, but four pitchers could not hold it.

Chicago's White Sox tied their previous high run for the year by making it two straight over Detroit, 3 to 0. They grouped their five hits off Whitehill, while Thomas kept seven Tiger blows well spaced. Inclement weather stopped the Athletics and Red Sox for the fourth straight day at Boston.

St. Louis and Chicago continued their red-hot argument over the leadership of the National League, and it still is a dead heat. Both won their eighth victory in eleven starts, the Cardinals taking Pittsburgh 7 to 1, and the Cubs drowning Cincinnati, 3 to 1. There were only two games, rain preventing play at New York and Philadelphia.

Making his second start of the year for the Cards, Jess Haines limited the Pirates to four scattered hits, while his mates got to Kramer and Osborn for 12. Adams and Orsatti each had a double and single.

The Cubs nipped Red Lucas for only seven hits, but bunched four of them in the fifth inning to score all their runs. The Reds couldn't realize on their eleven blows off the rookie, Ed Baecht.

### Forty Persons Killed As Train Burns in Egypt

Cairo, Egypt, April 30.—(AP)—Forty persons were counted dead today, with scores injured because a hot box set a train afire. As the Cairo-Alexandria express rolled along yesterday afternoon, laden with a holiday crowd of pleasure seekers, a hot box developed on one of the third class coaches and set the coach afire.

The train's motion pulled the flames down the length of the coach, and then one by one into the trailing coaches. Passengers were panic stricken. Some burned to death. Others, preferring to jump from the speeding train, lost their lives as they hurled themselves from coach windows to the right of way.

Frantic efforts were made to signal the engineer, who speeded up his train, unaware of the tragedy being enacted behind him. Not until he passed Benha, where a signalman saw the flames and flagged him down, did he know what had happened.

He stopped the train and the flames devoured the remainder of

the three cheap coaches, charring the bodies of those inside beyond recognition, and leaving only the undercarriages unconsumed. Railway officials said it would be impossible to estimate the casualties until a thorough search had been made along the right of way for other bodies of persons so badly injured in their jumps from the coaches that they had been unable to seek assistance. The engineer was arrested pending an official inquiry at Benha. It was the worst train accident of Egyptian history.

### STOCK MARKET

New York, April 30.—(AP)—The stock market ended its gloomiest month so far this year with a mild recrudescence of cheer today.

The tonic effects of strong support for the Standard Oil share were apparent.

Wall street brokerage circles were convinced that strong supporting orders for these issues had emanated from close to the Rockefeller interests. Bears were sent into a steady retreat all along the line, and advances of 2 to more than 5 points were numerous, while Auburn surged up more than 15, getting once more above 200.

U. S. Steel regained about a third of yesterday's 9-point drop, and miscellaneous issues rising 2 to more than 4 points included General Motors, Radio, General Electric Consolidated Gas, Electric Power & Light, American Water Works, Sears, Woolworth, North American & Foreign Power, Eastman, Westinghouse, Union Carbide, DuPont, Aitchison, New York Central and Ohio and Case.

Allied Chemical shot up 6, Standard of N. J. advanced 2 points, a substantial move for this issue, and Standard of California gained 35 much. There was a little further selling soon after the opening, but it quickly dried up. Curtiss Publishing dropped several points on reduction of its dividend.

Increasing strength of Standard of N. J. recalled the bid for 1,000,000 shares which checked the decline in this stock in the 1929 crash. While the petroleum industry remains unsettled, Wall street gossip has it that both Standards of New Jersey and New York will probably declare their regular dividends, although New Jersey may discontinue the regular extra.

There was considerable interest in the possibility that the Federal Reserve Bank might reduce its discount rate to 11-2 per cent.

Although Wall street has grown rather skeptical over the theory that excessively cheap money is a stimulating factor, many quarters would welcome any move that might strengthen the still discouraging bond market.
