Ask Senate To Instruct Conferees To Advocate Grier-Folger Revenue Act

Resolution Introduced in Upper House During Afternoon Session; The House Passes Dunlap-Gravely Bill to Allow Governor to Issue Notes to Meet School Expenses Should a Deficit Threaten; Senate Passes Long Alamo Bill; New Threats of Attempted Adjournment Heard

Raleigh, May 5.—(AP)—With the biennial revenue bill conference report in the background, a resolution was introduced in the Senate this afternoon to instruct conferees of that body to advocate passage by the Assembly of the Grier-Folger revenue act.

The Grier-Folger act, passed by the Senate itself and refused by the House, does not contain a sales tax and contemplates a county ad valorem tax levy for school support.

Senate rejection early today of the conference revenue bill, with its luxury tax and provision for state support of the six months schools without an ad valorem tax, sent the measure back to conference but this afternoon no move had been made for a meeting of the conference group.

The House passed the Dunlap-Gravely bill to allow the governor to issue notes to meet school expenses should a deficit threaten because of insufficient revenue but refused to give him the power to curtail school appropriations 10 per cent as he can do with other appropriations. The measure had passed the Senate.

The Senate passed the Long of Alamo bill, already by the House, to submit a constitutional amendment to the voters for the purpose of creating senatorial districts.

New threats of attempts to adjourn the Assembly since die at once were heard but none had reached the floor early this afternoon.

The House, by a vote of 58 to 28 took the Ewing bill to levy a two mill tax each kilowatt of hydroelectric current generated in the state from the finance committee and placed it on the calendar.

Representative Ewing of Cumberland, his author, said he wished to amend the measure and have it considered. It is understood he will seek to have the bill passed carrying a tax of one-half of one mill.

Governor O. Max Gardner this afternoon requested the General Assembly to be allowed to address it in joint session tonight and a joint resolution inviting him to do so was passed by both Houses.

The resolution set the hour for 8:30 P. M., the House and Senate adjourned to meet at 8:15.

This afternoon the governor refused to discuss on what he would address the Assembly but it was generally believed it would relate to the revenue impasse between the two Houses.

Senator Ward of Beaufort, rising to a point of personal privilege in the Senate, charged that several telegrams which he had received asking him to vote against a luxury tax were "not signed by the men they were purported to be sent by."

The Beaufort solons, noting that many senators received similar messages, stated that he had asked several of his constituents who were supposed to have sent the telegrams if they had done so and stated that they informed him they had not.

The senate in executive session, confirmed the appointments made by Governor Gardner to the newly created late Highway Commission and also approved his reappointment of seven members of the plan board.

MAY OPPOSE IMPOUNDING

Bailey Undecided Whether He Will Protest Seizure of Ballot Boxes

Raleigh, N. C., May 5.—(AP)—Senator Joshiah W. Bailey, Democrat, was undecided today, he said whether he would oppose the turning over of the ballot boxes to the U. S. Senate subcommittee investigating the contest of his election by George M. Pritchard, defeated Republican contestant.

On a petition of the subcommittee and James S. Duncan, Republican State chairman, the Federal District Judge in North Carolina yesterday signed orders for the impounding of the boxes used in last November's election. U. S. Marshal Porth with took steps to serve the orders on election officials.

One of the jurists, Judge I. M. Meekins, of the Eastern District, stipulated, however, the boxes in his district were not to be turned over to the subcommittee until 10 days had been allowed for a further hearing.

Although not saying definitely what course he would follow, Senator Bailey expressed a wish that the other two judges would amend their orders to conform with that of Judge Meekins.

Pointing out that all U. S. Marshals in the state "are republicans," Bailey said:

"I would not be inclined to complain if the courts had provided satisfactory measures for the safeguarding of the ballot under supervision of all parties concerned."

He said Judge Meekins' order allowed "opportunity for more effective protection of the ballots in the counties of Eastern North Carolina."

The election count gave Bailey a majority of more than 113,000 votes over Pritchard. The petitions for the impounding of the ballot boxes, however, claimed that election irregularities would show Pritchard to have won by "not less than 10,000 votes."

Special Venire Called for Trial of Negro Killer

Clinton, N. C., May 5.—(AP)—A special venire of Sampson County citizens was summoned here today for the second trial of Ernest Herring, negro, charged with the murder of F. F. Newton, postmaster of Kerr, N. C. The trial starts tomorrow.

Newton was killed last June. At the first trial Ernest Herring and his brother, Chevis, were found guilty and sentenced to be electrocuted.

Both appealed to the Supreme court and Ernest was granted new trial. The execution of Chevis was postponed in order that he might testify at his brother's second trial.

ADVERTISING REAL ESTATE DELAYED HERE

Commissioners Postpone Sale of Land for Delinquent Taxes Until October 1

Members of the Board of County Commissioners in regular monthly session at the court house here yesterday decided not to advertise real estate for sale until October 1. The advertising of the property had originally been set for today.

This will give property owners more time in which to make settlement of their delinquent taxes, and is in accordance with recent action of the State General Assembly, giving commissioners the power to delay sales.

The commissioners will meet in adjourned session Monday to consider the question of revaluation of property. Just what action will be taken in this connection is a matter of considerable speculation at this time. It was said, however, that action will be largely influenced by what the State Legislature does in the matter during the week.

These two questions were the most important taken up by the commissioners yesterday, and attention to routine matters occupied the major part of the meeting.

CITY TO HONOR CONFEDERATES

Dr. Wright to Deliver Principal Memorial Day Address Here Friday, May 8

The men who marched with Lee and Jackson in the stirring days of the Civil war will be honored by Greenville and Pitt County people in appropriate exercises at the East Carolina Teachers college, Friday, May 8. The principal address of the occasion will be delivered by Dr. R. H. Wright, president of the East Carolina Teachers College.

Memorial Day falls on Sunday this year, and members of the committee decided that the celebration here should be staged on Friday instead of Saturday or Monday as in some of the other cities.

Exercises for the Confederate dead will be held at the cemetery, and a bevy of young women will scatter hundreds of flowers on the graves of the sturdy warriors who have answered the final bugle call. Always of an inspirational nature, the exercises this year are expected to be even of greater interest than former years.

The regular program will begin at the college auditorium promptly at 11:15.

The meeting of the J. Bryan Grimes Camp of the Confederacy will be held at the court house during the early morning hours and officers for the ensuing year will be elected. Hardly a dozen of the bent, gray-headed veterans are expected to respond to the roll call this year. Their ranks have been constantly dwindling from year to year, only a handful are on hand to take part in the exercises honoring their beloved dead.

Greenville and Pitt county people are urged to attend the exercises and in that way help pay tribute to the men whose deeds of heroism will ring through the centuries, capturing the imagination of the children of all time.

TELLS COURT BANK REPORT WAS FALSE

Bank Accountant Testifies in Case of Bank Directors At Asheville Today

Asheville, May 5.—(AP)—W. S. Coursey, a bank accountant, today testified in the trial of Wallace B. Davis, president, C. N. Brown and Dr. J. A. Sinclair, directors, of the defunct Central Bank and Trust company here, that the bank's report of its condition, made to the Corporation Commission September 24, contained numerous false statements.

The three defendants are charged with making false reports of the condition of the bank which failed last fall with more than \$18,000,000 on deposit, including nearly \$8,000,000 of public funds.

Coursey said the bank's report of September 24 overstated by \$2,175,000 the amount it had on deposit in other banks. He said figures were juggled to show a false credit of \$2,000,000 with a New York Bank on that date when actually the money had been withdrawn September 15.

An overdraft of \$5,337.90 by the First Bank and Trust company of Hendersonville were not shown on the report, he said.

The accountant said the overdrafts on September 24 actually totaled \$181,830.69 while the bank reported its overdrafts as \$71,704.92.

Turning to alleged false statements in the report of the public funds on deposit September 24, Coursey said the true total was \$7,294,352.98 while the report gave the amount as \$5,432,039.60.

The difference, he said, was included in a special account of the City of Asheville and county certificates of deposit not listed in the report.

An effort by the state to establish that the report listed \$2,000,000 in loans and discounts and stocks and bonds which the state contends were worthless drew an objection from the defense.

The jury was excused and argument over admission of the evidence begun.

Attorneys for the prosecution argued that the officers of the bank between July 3, 1930, when the bank examiner made his inspection, and the time the bank closed allowed increases in loans which had already reached the limit the bank was allowed to loan.

They contended also that new corporations were formed, without the addition of new property to handle illegal excess loans and that loans were made to firms which the bank examiner had warned were doubtful.

As a result of the loans, the state attorneys argued, the bank in 1930 had practically no liquid assets.

The defense attempted to impeach Coursey's character by questions about his personal debts and charging he had given bad

EARTHQUAKE IN ALABAMA

Shocks of Considerable Intensity Recorded in Birmingham District

Birmingham, Ala., May 5.—(AP)—A slight earthquake was felt here about 17 this morning. Reports from as far south as Montgomery and as far east as Leeds say the tremor was felt in those places. The disturbance lasted approximately ten seconds starting off with a slow slight rumbling tremor with the most severe shock at the last. Windows and dishes rattled and people were awakened in Birmingham but no reports of damage have been received.

The tremor grew in intensity, appearing to be centered in the vicinity of Cullman, north of here, where a telegraph operator reported the shock lasted 30 seconds. At Lay Dam and Clanton south of here, residents reported the shock was felt, continuing for several seconds.

The dispatcher's offices of the Louisville and Nashville railway, the Southern and the Alabama's Great Southern railroads said stations along their lines reported the tremors.

Newspaper offices here were swamped with telephone calls following the shock which at first was believed to be a mine explosion. Today's tremor was the second felt in the Birmingham district in the past decade. Records here show a similar disturbance occurred 12 years ago.

AGED MAN IS SUICIDE HERE

Will Banks Fires Bullet Through His Head At Home Near Cotton Mill

Will Banks, 56, resident of the cotton mill district of this city, committed suicide by firing a bullet from a .32 calibre revolver through his head late yesterday afternoon at his home. The cause of the act was ascribed to his mental condition.

Funeral services will be conducted from his late home this afternoon at 2 o'clock by Evangelist Turner, after which the body will be taken to Kinston for burial.

Mrs. Banks, employee of the cotton mill, left home yesterday afternoon about 4 o'clock to return to her work. She left one of her children in care of Mr. Banks returned, she found the body of her husband lying on the floor with a bullet wound through his head.

Banks who was confined in the State Hospital for three of four years, returned to his home here about four months ago. Opinion was expressed that he killed himself while in a fit of despondency over his condition.

He is survived by his wife and three children.

Four Killed As Miners Battle With Officers

Harlan, Ky., May 5.—(AP) Reports received at the sheriff's office here this morning said four men were killed in an undetermined number wounded in a gun battle at Everts, near here, between peace officers and miners.

No details of the fight were available. Sheriff J. H. Blair sent a special force of deputies to the scene.

Everts is in the heart of the Harlan coal fields which have been the scene of frequent disorders in the last few weeks. Today's fight was another episode in the labor disputes resulting from strikes throughout this region, authorities said.

Last week Federal Judge A. M. Cochran issued a temporary order, restraining approximately 100 miners from trespassing on mine property.

Several weeks ago Deputy Sheriff Jess Pace was slain as he attempted to make arrests at Everts as a result of the mine disorders. A short time afterwards, mine guards and a band of men hidden in the hills engaged in a gun battle which several thousand shots were fired but no one was injured.

Several days ago sixteen vacant homes in a mining camp near here were destroyed by fire believed to have been of incendiary origin.

Mayor Lanier Defeated By Flanagan In Battle Of Ballots Here Monday

TARIFF ISSUE AND WAR DEBT GIVEN AIRING

Other Questions Also Receive Attention of Members of International Chamber

Washington, May 5.—(AP)—The controversial tariff and war debt questions came to the fore at the third plenary session today of the International Chamber of Commerce, along with a demand for abolition of floor trading on American exchanges and restriction of marginal dealings to curb stock gambling by persons of small means.

Julius H. Barnes, chairman of the Board of the Chamber of Commerce of the United States, who last week called for tariff revisions with a view to improving American foreign trade, told the congress that business locked to the tariff commission for helpful readjustments in piecemeal fashion and that it would be "most unfortunate to reopen the tariff in the next session of Congress."

The 1,000 delegates from two score nations heard inter-allied debts mentioned for the first time, though very cautiously, in speeches by Sir Alan C. Anderson, a director of the Bank of England, and Alberto Pirelli, Italian industrialist.

Sir Alan alluded to a warning against placing all international settlements on a gold basis and inquired whether it would not be better to cancel the war debts. While this of itself would not cure the world-wide depression, he said, the settlements of these obligations "seriously aggravates the world's troubles in these hard times."

The present crisis, the secretary continued, was the more severe than most because it followed a world war but he said that in his country there had been an effort on the part of the government and private business not only to prevent reduction in wages but to keep the maximum number of men employed.

"Progress can be achieved only by a great movement, made up of a vast number of individuals or individual efforts and not by any single action that government's or groups can take."

Breaking a two year silence during which he has not discussed publicly the world wide depression, the veteran treasury secretary emphasized that purchasing power was an all-important factor and that power insofar as America is concerned, is dependent to a great extent upon the standard of living which obtains in this country.

Mr. Mellon addressed a luncheon given foreign bankers attending the International Chamber of Commerce by the American Bankers Association. He told them that each nation must be allowed to work out in its own way its solution to the economic problem.

"The troubles which all of us face at this time cannot be cured by any quick and easy method, or at some one else's expense, and it is well to face the fact," he said.

Three of Five Members of the Board of Aldermen Also Swept From Office In One of the Heaviest Votes Ever Cast Here; Flanagan's Votes Was 1,200, and Lanier's 758; Most Spectacular Aldermanic Fights Centered in Second and Third Wards

Mayor J. C. Lanier and three members of the Board of Aldermen were swept from office in yesterday's municipal election by one of the heaviest votes in the history of the city. Only one of the four aldermen actually having contested, survived, that being J. H. Boyd, in the fourth ward, who won out over D. A. Windham by a comfortable majority. A. E. Hobgood, alderman from the fifth ward was without contest.

The total vote cast was 1,958, almost over two hundred above any other vote ever before recorded in an election of the kind.

Flanagan's vote was 1,200, Lanier's 758, giving the former a majority of 442.

The most pronounced battles of the contest were fought in the second and third wards. In the second ward, W. L. Patrick defeated Herbert Waldrop, incumbent, by a majority of eight votes. Patrick's vote was 260, Waldrop's 252.

In the third ward, H. H. Duncan ousted T. T. Hollingsworth by a majority of seventeen votes. Duncan's vote was 206 against Hollingsworth's 191.

J. N. Williams defeated John Ivey Smith, incumbent of the first ward, by over a two to one count. Williams piled up 132 votes against Smith's 69.

J. H. Boyd, Jr., incumbent of the fourth ward, found sailing decidedly easier than the remainder of the candidates, and walked away from his opponent, D. A. Windham, by a vote of 197 to 72.

A. E. Hobgood, in the fifth ward, who was the only one without contest, received a vote of 401.

The election was one of the liveliest staged in the city in years. It was featured by one of the heaviest feminine votes since women were accorded the privilege of going to the polls.

All day long an almost unbroken stream of voters filed along the corridors of the courthouse and expressed their preference for the candidates. Crowds were gathered around the Third street entrance and while there was a considerable amount of jocularly, no disorder was reported.

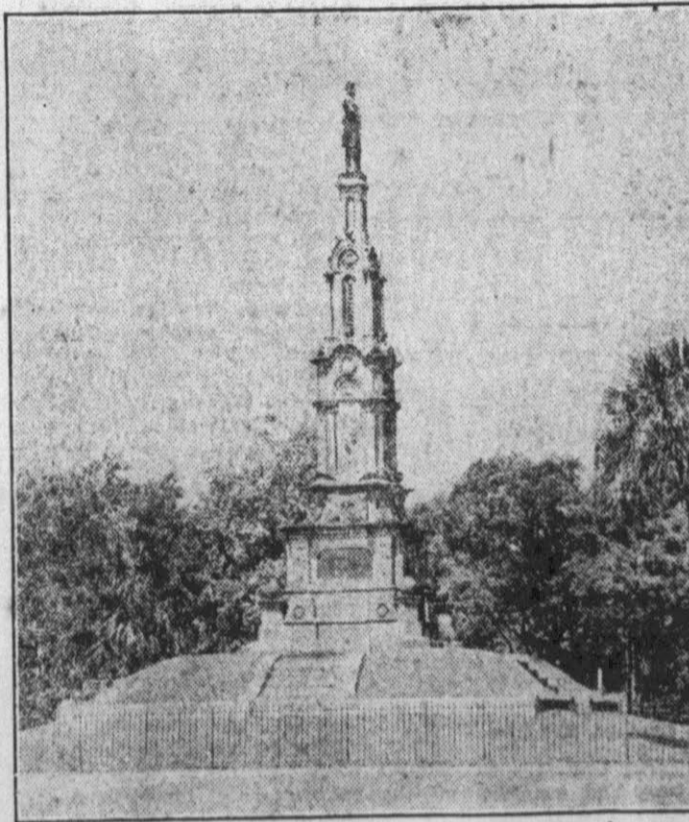

Foreign correspondence award—H. R. Knickerbocker, of New York Evening Post and Philadelphia Public Ledger for articles on Soviet Russia's five-year plan.

Best Editorial—"Charles S. Ruman of the Fremont, Neb. Tribune, for his editorial, 'The Gentleman from Nebraska,' dealing with Senator George W. Norris policies.

Best Cartoon—Edmund Duffy of the Baltimore Sun for his drawing entitled, "An Old Struggle still Going On," depicting the Russian problem with the church.

Music study award—Elliot Griff of New York.

European travel scholarships (awarded to graduates of the Columbia University School of Journalism)—Frederick D. Sink, Zanesville, Ohio; David A. Davidson, New York, and Winston D. Philph, New York.

Say Leaf Acreage Must Be Reduced Sharply This Year

Atlanta, Ga., April 5.—(AP)—Tobacco acreage must be cut in the south this year sharply, agricultural leaders say, if the growers are to receive a fair return on their crop.

Dr. G. W. Foster, economist of North Carolina State College, recommends the most drastic cut for North Carolina.

After a survey he reported a decrease of 64 percent necessary if farmers of North Carolina are to receive 15 cents per pound for their product. Dr. Foster said it costs 15 cents to grow tobacco in North Carolina for the past six years has grown 64 percent of the nation's flue-cured tobacco.

Virginia Department of Agriculture officials said a 28 to 30 percent reduction would return growers a fair price for the crop there.

However, Dr. Foster said a survey indicated North Carolina farmers did not intend cutting their acreage as much as 74 percent and in some places the acreage will be increased. Virginia officials reported indications of a 13 percent reduction in acreage.

Officials of Georgia and South Carolina have also advised a reduction in acreage.

Around The WORLD

Tobacco plants are being put out at the rate of thousands daily at this time, and farmers are being told in increasing volume to refrain from planting normal acreage, that it will mean nothing but ruin for them at the end of the year.

Many will heed the warning and others will not, but those who act wisely will reduce their crops and cultivate the curtailed acreage as intensively as possible. This should bring about improved quality of leaf and that in turn will mean better prices when the auctioneer begins his song.

Planters should not try to make themselves believe that conditions will be better than they were last year with the market glutted more than it has been in years. They have been told that normal acreage will mean disaster. The message came from men high in the life of the industry and who should know what they are talking about.

The only salvation lies in reduced acreage and planting of the surplus acres in food and feed crops.

Then Lewis bragged the ropes to escape a hold by Declane, who was attempting a headlock. The next moment, Lewis had his opponent pinned to the mat. Referee Tremblay awarded the fall.

Declane arose holding his right arm. The referee examined the wrist and after a conference with two members of the Athletic commission announced that Lewis had bitten Declane's wrist. Lewis was disqualified and the bout awarded to Declane.

Lewis filed a protest, denying that he had bitten Declane. "In eighteen years of wrestling," he said, "I never bit a man and did not start tonight."

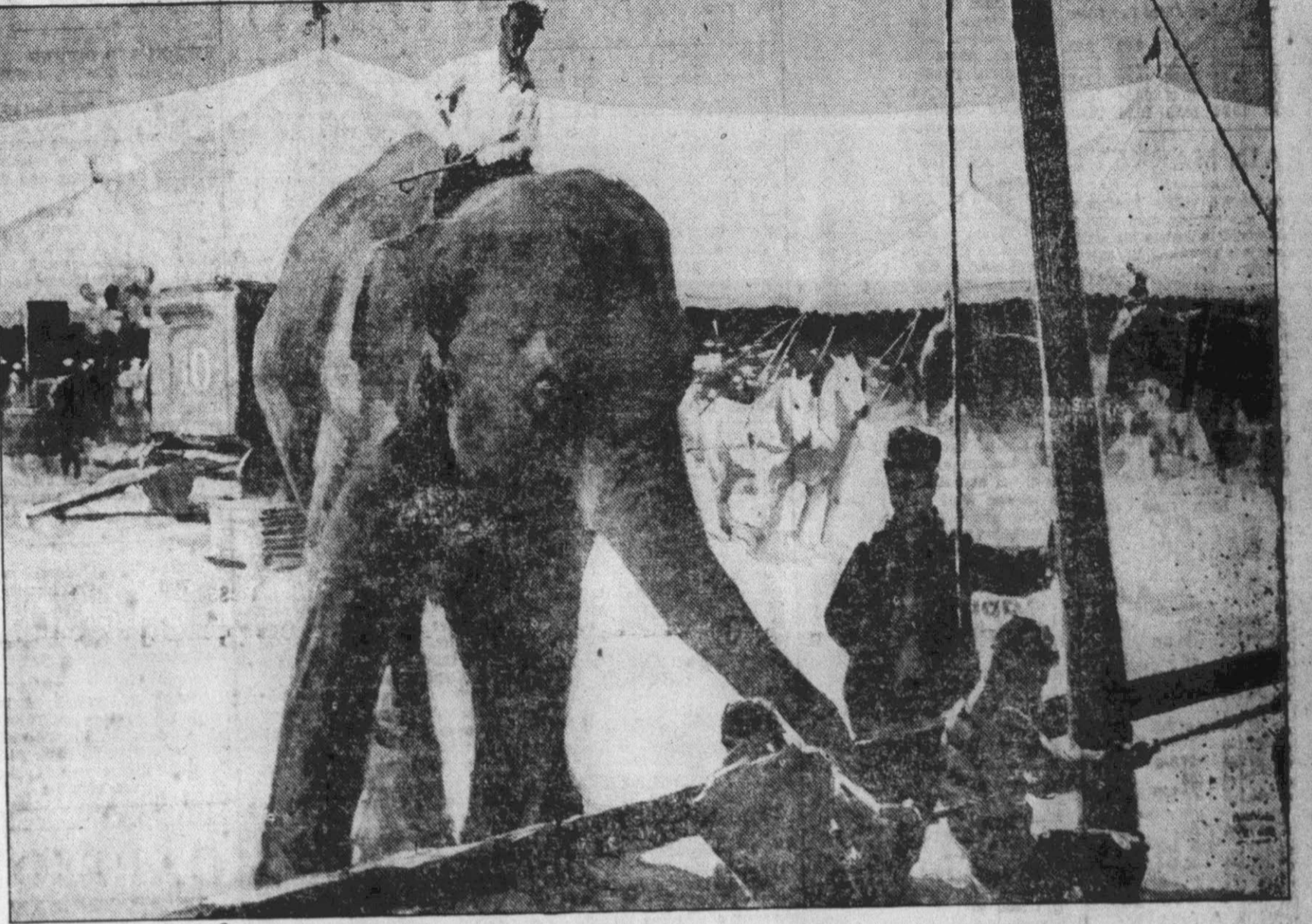

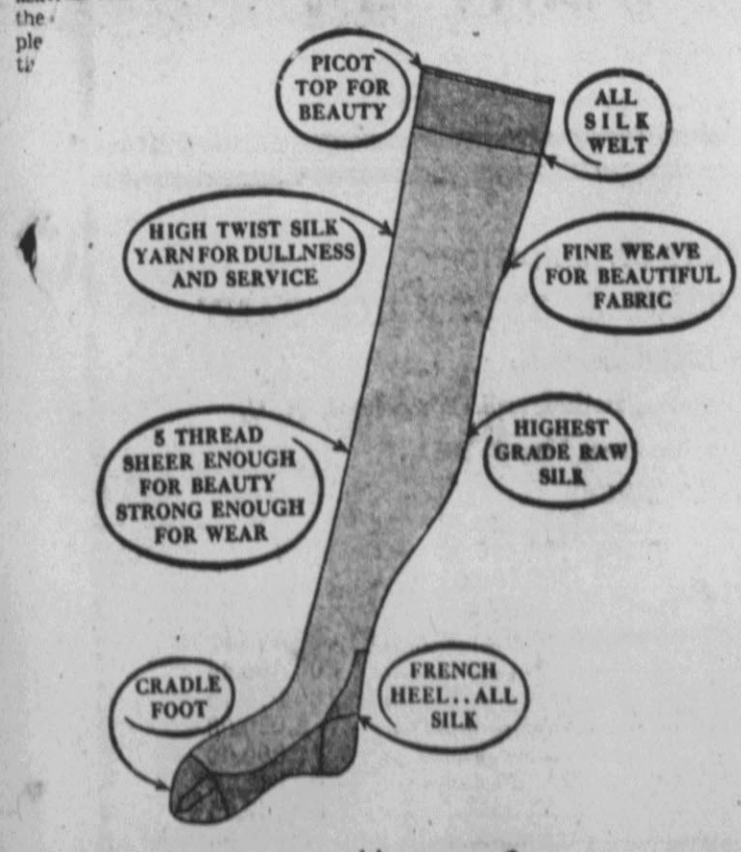

Charges Internal Conditions With Recent Strikes

Chapel Hill, May 5.—(AP)—Internal conditions rather than outside agitators were responsible for the strikes and walkouts in recent years in Gastonia, Marjane and Danville mills, declared James Myers, secretary of the Federal Council of Churches, in an address here today.

Speaking at the Institute of Human Relations of the University of North Carolina, Myers classed the strikes as "spontaneous revolts of employees against conditions in the mills themselves."

He based his conclusions, he said, on two years of investigation in the strike areas during which he interviewed employers, employees and state officials.

When the workers decided to rebel, the speaker declared, they merely accepted the first leadership which offered itself.

The textile employers who recently brought about the reforms eliminating night work for women and minors and limiting weekly hours, will need the help of the state laws to bring the minority into line with these more progressive policies, the speaker asserted.

"The history of labor legislation shows that in the fierce pressure of competition a minority of employers always will endanger higher standards unless social legislation steps in to protect those wishing to operate under better conditions."

Myers' address was the only one on today's program.

Fell Story of the Rescue of Italian Flier

Sao Paulo, Brazil, May 5.—(AP)—The story of a 13-day journey through the wilderness on foot, ending in the rescue of Count Edmondo Di Robilant, Italian flier, and the suicide of his mechanic Maurania Quaranta, stirred public interest today.

The Italian consul said Di Robilant told him that Quaranta hanged himself to the limb of a tree with his own belt rather than endure longer the suffering of starvation and fever. The fliers left Sao Paulo April 12 and were forced down the next day near Pirajury.

Earlier reports said the mechanic died in a hospital at San Jose as a result of his experiences.

As told to the consul, the flier encountered a storm four hours out of Sao Paulo and was forced down in the jungles due to a leakage of fuel. Leaving the plane undamaged, they started back towards civilization with marmalade and hard-tack as their only provisions.

Mosquitoes harassed them every foot of the way. Ants devoured their food. Constant wading of streams sapped their energy. Loss of their matches in the water left them without means to build a fire. They subsisted for days on what fish they could catch with their hands the fruit they could find.
