DOZEN GIRLS SENT TO PEN IN ARSON CASE

Former Samaritan Inmates Draw From 18 Months to 5 Years In State Prison.

Carthage, May 20.—(AP)—Twelve girls of high school age who pleaded guilty to attempt to commit arson in connection with the burning of two dormitories at Samaritan state institution for delinquent girls, today were sentenced to serve from 18 months to five years in the state penitentiary at Raleigh.

Two others were freed under conditional sentences. In the case of Rosa Mull, 13, of Rutherfordton, the youngest of the group, Judge Michael Schenck continued prayer for judgment for five years on condition of good behavior. If the good behavior clause is violated, he told the girl, he would sentence her to two years in the penitentiary.

Margaret Pridden, 15, of Wilmington, was given a suspended sentence of 12 months to three years. A five-year good behavior clause was also added to her sentence.

As the jurist pronounced sentence on the 14 young women they burst into tears. There was no other demonstration in the courtroom, however, and when the girls were marched away all except a few had stopped sobbing.

In sentencing the girls, Judge Schenck said their stay in the penitentiary would "depend entirely on your own behavior."

"If you want to stay in the penitentiary," the jurist said, "go down there and set something on fire. If you want to get out within 18 months, change your ways, behave yourselves and try to make something out of your lives. It all depends on your individual attitude."

He also explained to them the state's parole system and advised them good behavior would be properly rewarded.

The girls sentenced to serve not less than 18 months nor more than five years are: Marion Mercer, 15, Ayden; Josephine French, 16, Haw River; Virginia Hayes, 16, Walker; Thelma Council, 17, Tarboro; Margaret Abernethy, 17, Kinston; Estelle Watson, 16, Lexington; Cloah Stillwell, 16, Kinston; Edna Clark, 17, Halifax; Ollie Harding, 17, Chowchilly City; Bertha Hall, 21, Norfolk, Va. and Teral Stulles, 21, Canton.

Cases against two girls, Mary Bronson, 16, Rocky Mount, and Wilma Owens, 16, Waynesville, were not pressed.

The girls were originally indicted for first degree arson, a capital offense in this state, but pleaded guilty when Solicitor Don Phillips agreed to modify the indictments to attempt to commit arson.

Immediately after sentence was imposed the 12 girls given prison terms were placed in a school bus and sent to State's prison at Raleigh.

Minister's Duel Refusal In Upheld In Hungary

Budapest.—(AP)—The dueling code of Hungary was given another blow recently when the lord lieutenant of the county of Pest upped Rev. Dr. Alexander Veorus, rector of the Protestant community, in a refusal to fight.

The minister, who is also director of a high school, had been boycotted by the "Gentry Club" of the town of Kunszentmiklos. He appeared to the official.

The hearing developed that the challenge had come from one of Dr. Veorus' colleagues whose wife was offended by remarks made by the rector's sister.

The lord lieutenant said it was ridiculous to try to force a duel upon one who was forbidden by his religion to use arms against his neighbor, especially when he was also a teacher of youth.

Earthquake Shakes Portugal and Mexico

The populations of two widely separated cities—Lisbon, Portugal, and Aaxaca, Mexico—were frightened by earthquakes today and last night.

In Portugal's capital two sharp tremors were felt early beginning at 3:20 A. M., although they created a panic among the inhabitants, who deserted their beds to flee to safety. There were no casualties.

Most of the populace of Aaxaca spent last night out of doors, remembering last January's destructive quake, after strong shocks were felt in the early evening.

Seismographs at Stuttgart, Germany, Rome, and Zurich, all recorded earth disturbances at about the time Lisbon experienced the quake.

LEGION HOLDS ITS OWN HERE

Retains Large Enrollment and Looks For Increase; Fing Program Last Night.

The Pitt County Post of the American Legion is holding its own from the standpoint of membership despite the period of depression which has existed through this area the last several months, was revealed by Commander J. C. Elliott, at the regular meeting of the organization at the Rotary club last night.

He stated that the membership at this time was 205 and urged the members to get busy and try to increase it to 225 in order to give them an extra vote at the State convention during the latter part of the summer.

The Legionnaires had several distinguished men as their guests during the evening and from each received short talks of appreciation of the splendid service which the organization is rendering the men who came back from the war maimed in mind and body.

The guests were Dr. Ben R. Lacy, president of the Union Theological Seminary of Richmond, who is conducting a series of evangelistic services at the Presbyterian church; J. B. Overmyer, of Gastonia, evangelist; Judge W. A. Devin of Oxford, who is conducting a two-week term of civil court here; W. Hill Horne, who was recently elevated to the post of Grand Commander of Knights Templar of North Carolina, and Ralph Deal, member of the faculty of East Carolina Teachers College.

Solo numbers were rendered by Mrs. Layton McGowan and Mrs. J. H. Waldrop, each being accompanied by Mrs. Ray Tyson. Each of the singers was liberally applauded.

The Legionnaires decided to hold the annual election of officers during the meeting in June. It was decided that nominations and election should take place at the same time. Delegates to the state convention will also be named at this time.

Commander Elliott called attention of the post to the condition of a disabled ex-service man here. He asked the Legion to donate a sufficient sum to enable the man to go to Wisconsin where he said he would be able to establish his identification and receive government aid. Members of the post and other organizations had been paying the man's expenses here for sometime. The commander also called attention of the ex-service men to the annual sale of poppies to be conducted here next Saturday by the Auxiliary. He urged the Legion buy liberally of the poppies and in that way help the Auxiliary do its part toward carrying cheer to the disabled veterans and their families.

After the meeting the members of the post went to the home of Mrs. Smith, T. D. Phillips and Lee Moore members of the post, who are in hospital receiving treatment.

Body Reverses Itself After Voting In Favor Of Bill Yesterday; Senator Clark-son Read Number of Telegrams Opposing Passage Of Bill.

Raleigh, May 20.—(AP)—The Senate today reversed the action it took yesterday and tabled a bill which would have allowed horse racing and pari-mutuel betting in Polk county.

Yesterday the Senate passed the measure, introduced by Senator McLean of Polk, but today it reconsidered its action and quickly sent the measure to the table—where a similar measure applying to Buncombe county was laid earlier in the session.

Senator Grier of Iredell made the motion to reconsider the vote by which the bill was passed 15 to 14 yesterday. The Senate supported him 24 to 9.

Immediately Senator Clarkson of Mecklenburg read the Senate a number of telegrams and letters which he said were sent him by citizens and organizations in Polk county and elsewhere throughout the state in which he was urged to oppose the bill.

Senator McLean, defending the bill, called off from memory the names of a number of citizens of Tryon and Polk county who he said had sent him the racing bill and asked him to introduce it. He said "all the merchants and leading business men" want the bill and that it was endorsed by the mayor of Tryon and at least two county commissioners.

Senator Clarkson moved the bill be tabled and the motion carried 28 to 8.

Under the Polk bill a racing commission to supervise horse racing and pari-mutuel betting at a proposed track near Tryon would have been created. It was understood the track was backed by officials of the Jockey Club of America.

GRIFTON FIRM WINS VERDICT

H. A. Hart & Brother Awarded Judgment Of \$837 Against J. B. Hardee and Wife.

H. A. Hart and Bro., Grifton was awarded judgment for \$837.00 against J. B. Hardee and wife by a jury in the civil term of Pitt County court here yesterday.

The case centered about a note which the defendants gave the plaintiff for supplies, furnished them during the preparation of their crop.

The case occupied the major part of yesterday morning's session and after its completion hearing was begun in the issue of Mrs. L. E. Brewer against Roy Moyer and the Ayden Veneer and Manufacturing Company.

The plaintiff is asking for damages of \$2,500 for injuries which she alleges she received when a car in which she was riding collided with a truck of logs which the company was said to have left on the highway near Ayden.

Mrs. Brewer contends that she received painful injuries when a long log protruding from the truck crashed through the windshield of the automobile in which she was riding.

The case was expected to consume the most of the morning session today, and a decision was expected during the afternoon.

N. Y. Illustrator Commits Suicide

New York, May 20.—(AP)—Ralph Barton, widely known illustrator, committed suicide today in his home.

When a maid reported for work she found her employer dead with a bullet wound in the right temple and revolver in his right hand. Police pronounced the death suicide.

Barton, who was 39 years old, suffered a heart attack several months ago, but apparently had recovered.

He was well known for his caricatures satirizing Americans and American life which appeared in the New Yorker, Vanity Fair, Liberty and Harper's Bazaar. He also illustrated books.

ACQUIT WOMAN OF SLAYING TWO DIE IN AUTO WRECK

Mrs. Nirdlinger Freed Of Killing Husband By French Court.

Nice, France, May 20.—(AP)—Charlotte Nash Nixon-Nirdlinger was acquitted today of a charge of manslaughter in the shooting of her husband, Fred G. Nixon-Nirdlinger, Philadelphia theatrical manager, in their villa here last March.

When the jury filed in an announced its verdict, the spectators, most of them friends of the defendant, cheered.

The defendant's elderly mother was overcome with emotion. The jury deliberated only two minutes after both sides had summited up.

"She is too beautiful to be bad," Mrs. Nirdlinger's lawyer told the jury.

Nice, France, May 20.—(AP)—Mrs. Charlotte Nixon-Nirdlinger burst into sobs when she was brought into court today to stand trial for the killing of her husband, Fred Nixon-Nirdlinger, former Philadelphia theatrical manager.

Dressed entirely in black, including a black mantle, which a gendarme removed as she entered the prisoner's box, she was too overcome to answer her name and could only nod to questions.

When Magistrate Vauchier started to call the jury, the presented a pitiful appearance as she tearfully eyed the men who will decide her fate.

Mr. Nixon-Nirdlinger was shot to death on the evening of March 11, in his villa near here and his wife subsequently admitted that she fired two shots into his body. She said he had threatened to kill her in a jealous rage and had accused her of having an Italian lover.

Mrs. Nixon-Nirdlinger appeared to be only a shadow of the vivacious young woman who once represented the city of St. Louis in an Atlantic City beauty pageant. The strain of imprisonment showed in her features.

She sank back in her seat, still sobbing and seemingly uninterested in the proceedings until the clerk of the court began reading the charge in a loud voice. She gasped audibly at this point as if realizing to the fullest degree that she was on trial for murder.

With stooped shoulders and nervous hands grasping the rail before her, she listened to the magistrate mumble a brief resume of the crime. He made out what appeared to be an easy case for her but charged her with indiscretions which she denied almost inaudibly. When he said she had danced and flirted arousing her husband's jealousy, she summoned her strength and disclaimed the accusations vigorously.

SENATE REFUSES TO ACCEPT CONFERENCE REPORT ON REVENUE

SENATE PROBE IS COMPLETED

Ward Announces that So Far as He Knows Bribery Inquiry Has Been Concluded.

Raleigh, May 20.—(AP)—The special Senate committee probing rumors and suggestions that senators had been bribed or subjected to corruption in an effort to influence their votes on the sales tax issue today had apparently completed its hearings.

The only evidence of any direct approach to a senator heard at the three hearings held was given last week by Senator Hinsdale of Wake, who testified David H. Pope, chairman of the Wake County Board of Commissioners, told him that W. N. Reynolds told Pope to tell him he could have "anything he wanted" if he would "let up" in his fight for a luxury tax.

Pope and Reynolds, an official of the R. J. Reynolds Tobacco Company, denied that any mention of remuneration was made to Hinsdale.

Yesterday Senator Gower of Johnston testified he was "only joking" when he told E. G. Hobbs, a Selma attorney, and C. P. Harper, Selma druggist, that he and "his colleague" had been offered \$2,500 each to vote against a luxury tax.

Last week Faison Thomson and J. J. Hatch, Goldsboro attorneys, testified that Hatch offered Thomson "a fee" if he would use his influence to defeat the luxury tax. Thomson testified Hatch mentioned no names but that he inferred he meant Senator Hugh Dortch of Wayne county.

Dortch yesterday testified that he knew nothing about the reported bribery efforts.

At the conclusion of yesterday's session Senator Ward of Beaufort, chairman of the probing committee, said that so far as he knew the investigation has been concluded.

RECOVER BODY GEN. DUNLAP

American Marine Leader Perishes in Land slide at Stone Age Cave Near Tours.

Paris, May 20.—(AP)—French Army engineers today recovered the body of Brigadier General Robert H. Dunlap, U. S. M. C., who was buried alive in a stone age cave by a landslide near Tours yesterday.

They also recovered the body of Denis Briant, a farmer, and they worked frantically to rescue Briant's wife whose screams could be heard from the back of the cave where she had taken refuge.

These reports came by telephone to the American embassy from Major Robert L. Wash, whom Ambassador Edge sent down to Tours yesterday.

The embassy notified Washington and sent an undertaker to Tours this morning to bring the general's body here. It probably will be sent home by steamer or on the cruiser Pittsburgh which is due soon at Marseilles on the way home from Manila to be scrapped.

Tours, France, May 20.—(AP)—The muffled of a woman's voice spurred rescue parties to new efforts today as they struggled to clear away the debris from the Trocloyde cave in which Brigadier General Robert H. Dunlap, U. S. M. C., and two others were buried by an avalanche yesterday.

They advanced feverishly with pick and axe and finally obtained clear evidence that the voice was that of Mme. Denis Briant, one of the victims. They finally were able to engage in conversation with her and she distinctly said:

"I am not injured."

By drilling a hole through the wreckage, into the cave and heard the woman say that she knew nothing as to the whereabouts of General Dunlap or her husband, both of whom dashed toward the cave at the first landslide in an attempt to rescue her.

LACY SPEAKS TO THE LEGION

Urges Members of the Local Post to Lift High the Banner of Lord.

Urging his hearers to lift up their banners to the cause of Christ, Dr. Ben Lacy, of Richmond, last night delivered one of the most inspirational sermons of the series of evangelistic services, which opened at the Presbyterian Church last Sunday morning.

It was a special message to members of the Pitt county post of the American Legion, who attended the services in a body and were seated directly in front of the pulpit. Dr. Lacy, who served as chaplain of the 113th Field Artillery during the world war, drew a graphic picture of the sacrifices which American men made on foreign battlefields, and urged the Legionnaires to fight as hard for the cause of Christ as they fought to stem the tide of German autocracy, which was sweeping over Europe when America entered the deadly conflict.

The services will be concluded this week. Dr. Lacy speaks twice daily, in the morning at 10, and in the evening at 8:00 o'clock. The morning service is confined to a study of the Scriptures, and has proven of great help to those seeking more light on the truths of the Bible.

Friday night will be devoted to the young people of the city. It has been designated as "Young Peoples' Night," and Dr. Lacy will deliver a special sermon to the youth of the city. Everybody was urged to help lift the building with young people at this service and in that way make it one of the most impressive of the series.

Rev. W. S. Harden, pastor of the church, last night again called attention of his hearers to the importance of taking immediate advantage of the services, that they would be completed before they realized it. He urged members of the congregation and the public generally to attend every service the balance of this week.

Taking his text from the fifth verse of the 20th Psalm, "In the name of our God we will set up our banner," Dr. Lacy told the Legionnaires that it was the same text he used in a prayer service in France celebrating the signing of the Armistice.

He painted a graphic picture of the meeting of the soldiers, their hearts burning with joy and ecstasy over the ending of the greatest conflict in the history of the world, gathering there to offer thanks for the cessation of hostilities.

He said he urged them to "lift up their banner in the cause of Christ," and to return home and see that the banner danced proudly in the breeze the remainder of their life.

Going through England at the outbreak of the war, Dr. Lacy said he was astonished at the rapid way men were being mobilized for service. As he looked around for the cause, he was confronted by thought.

Defeat Motion To Adopt Plan Based On 15 Cent County Ad Valorem Tax By Vote of 25 to 23; Way Paved For Reconsideration of Action Tomorrow; House Meets Then Recesses to Await Senate Action.

Raleigh, May 20.—(AP)—The Senate today refused to accept the conferees' report on the biennial revenue bill based on a 15 cent county ad valorem tax but the way was paved for a reconsideration of the vote tomorrow.

The official vote defeating a motion to adopt the report was 25 to 23.

The vote on the adoption of the committee report was 24 to 24 when tallied on the floor of the Senate and before the result could be announced Senator Burrus of Guilford changed his vote from "aye" to "no" in order to be able to move to reconsider tomorrow.

On a motion to adopt a report a tie vote means defeat, necessitating the change of the Guilford Senator.

While the Senate argued the revenue report the House met in a short session and then recessed until this afternoon to await action by the Senate.

Refusal in the Senate probably means the report will not be considered in the House until after the Senate has voted on the expected motion to reconsider. The roll call follows:

Following the vote the Senate debated the matter of barring pairs in future votes.

It was brought out that Senator Price of Union, paired against the report, called on long distance telephone a few minutes before the vote was taken and broke his pair with Nixon of Lincoln, who favored the report; and was present.

Sensor Clark of Edgecombe, who was paired against the report with Jones of Richmond, who favored it, then refused to record the pair.

The discussion ended with the decision the Senate had no authority to bar pairs after which the body adjourned until noon tomorrow.

Senator Clement of Rowan traced the history of the state aid for schools through an equalization fund from the beginning of the practice down to now. "When the state is in the most serious financial condition it has ever been in and the counties ask it to take over complete support."

The Rowan legislator said he did not believe the state could take over the support as required under the MacLean law.

Adoption of the report is equivalent to first reading but it must pass two readings on separate days before it has been finally passed by the Senate. A previous conference report was adopted 27 to 22 and on second reading was rejected 25 to 24.

Opening the debate, Senator Pritchett of Bertie, a member of the conference committee, raised the question of the legality of the proposed ad valorem levy.

"This report," he said, "calls for a uniform tax of 15 cents and admittedly the valuations in the several counties are at wide variance and therefore the tax would not be uniform." He also pointed out that the tax would be based on 1930 valuations, which have been changed in many counties, making a "false" basis for the levy.

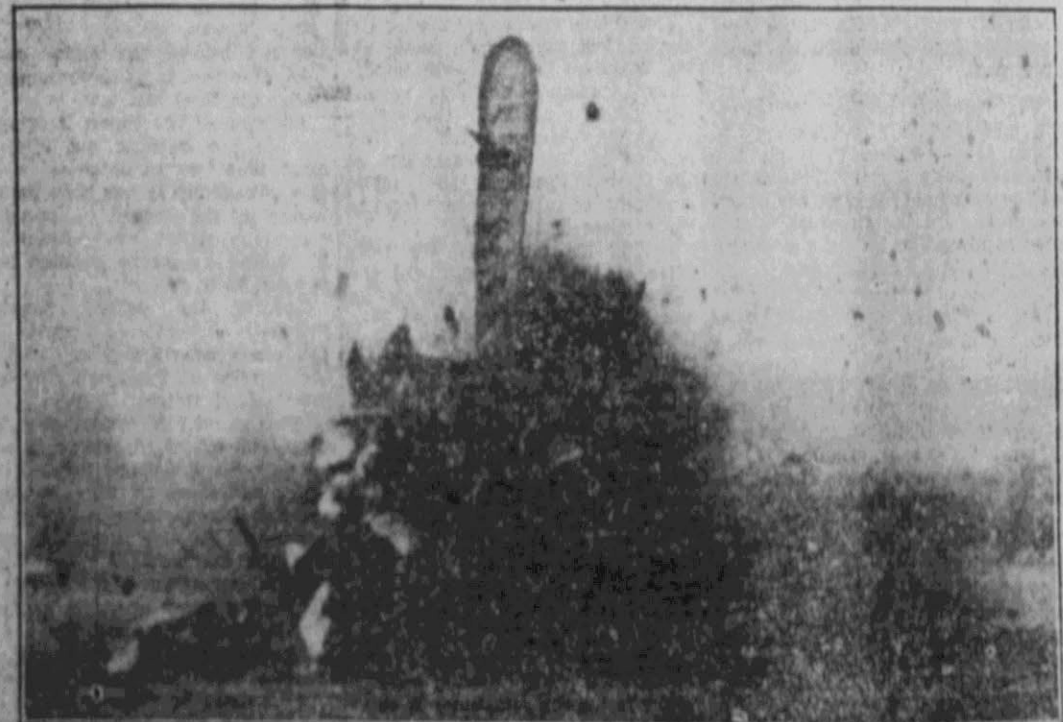

GAS PLANTS CHANGE HANDS

Local Plant Involved In Sale To The Tidewater Power Company.

Kinston, May 20.—(AP)—The Tidewater Power Company, with headquarters at Wilmington, today took over gas plants at Kinston, Greenville, Washington, New Bern, Goldsboro and Fayetteville.

The price involved was not divulged. All the plants were previously owned by the Carolina Gas and Electric Company which maintained headquarters here.

Officials announced that any revision in rates would be downward. Officials of the local gas office were notified of the change of ownership yesterday. It was stated today that the transfer would not affect the general office staff here nor any of the other employees. J. T. Bland will continue as manager, and Mrs. J. L. Carper as bookkeeper.

It has been known for some time that the Kinston interests were contemplating selling the six plants in this part of the state, but nothing definite was determined until yesterday when a representative came here to complete the transfer.

Says Many States Have Anti-Chain Store Legislation

New York, May 20.—(AP)—Thirty seven states and the Federal Government have anti-chain store legislation of some sort or other now pending, M. M. Zimmerman, chain store merchandising consultant, said today in commenting on the upholding by the Federal Supreme Court of the Indiana "chain store" tax law.

"There are some 85 laws pending in these 37 states," Mr. Zimmerman said, "many of which are undoubtedly discriminatory but the Indiana law may provide the outline which the chain foes have long been seeking, and it is likely that many of these laws will be changed to conform to it in outline."

"The Indiana law provides that one store shall pay \$3 a year; the next five stores, \$10 each; the next five, \$15; the next five, \$20 and stores thereafter \$25 each."

"There are in the United States about 8,000 chain systems. Sixteen hundred of these are called national chains, since they operate on a wide scale with many units. These 1,600 probably account for more than half the chain store volume, and it is at these that the Indiana and other state legislation apparently is directed."

"The state of Ohio had a law requiring taxes of from \$100 to \$750 on chain systems of more than five stores, depending on the volume of business. A store doing a \$100,000 gross was to be taxed \$750. The attorney general declared the proposed law discriminatory and unconstitutional and it was never passed."

"A North Carolina law calling for license fees of \$50 on chains exceeding two stores was passed and held constitutional by the state courts. It was appealed to the United States Supreme court and now seems likely to gain control."

"He came into the bedroom," she said, "and said such disgusting things to me that I cannot repeat them. I fired—I did not mean to kill him."

Her voice failed and, unable to proceed, she sank back into her chair. Most of the other women in the room were weeping with her.

Even as the king and the nation needed men in that trying period, so the King of Kings needs men to carry His banner today. He needs men to dedicate themselves to the cause of Christ, to rally behind the blood-stained banner of the Cross and carry it on to victory over sin and unrighteousness.

Referring to the tremendous amount of work in preparing for war, Dr. Lacy declared that this nation would realize new heights of prosperity if they should put the same amount of energy in civil life.

He told of the preparation at military camps, of the taking of the oath of allegiance to the flag, because the time would come on the battlefield when there would be no flag to look on and only the allegiance would enable them to carry on in the interest of the cause for which they fought.

Jesus calls the people to His banner in the same way, he said, in order that His word may be carried out into every field of human endeavor to enrich the life of mankind.

He asserted that peace time called for more courage and boldness than the trying times of war. Men fall by the wayside in civil life who bared their breasts to shrapnel during the war. The courage of Christ, he pointed out, is needed by men and women today to help them face life's battles bravely and with the realization that this strength will enable them to surmount all difficulties.

Greenville lost the annual relay race with Washington yesterday afternoon. It was the first time in five years that Washington had been able to win, and the victory was greeted with elation by high school students of that place.

By winning four consecutive years Greenville was awarded permanent possession of the cup last year, and the series this year was for the possession of a new cup offered by the Washington Rotary Club.

Greenville's loss yesterday was attributed to the fact that all of the runners were young and not sufficiently experienced to compete with their more hardened rivals. In fact Greenville was not apprised of the revival of the race until a short time ago and no preparation had been made prior to that time.

Washington must win four years to capture the cup, and during that time Greenville will be preparing to offer more strenuous opposition, although it must be said to the credit of the youngsters that they put up a splendid fight for honors yesterday.

Members of the Pitt County Post of the American Legion were talked to last night by one of their own buddies, a man who as chaplain of the 113th Field Artillery during the World War won the name of the "Fighting Parson."

Dr. Ben Lacy, president of the Union Theological Seminary of Richmond, told the Legionnaires that to win the battle of today they must recognize the supremacy of God and His ability to carry them through safely when all other things fail.

Dr. Lacy, who is conducting a series of revival services at the Presbyterian Church here, is one of the foremost exponents of the Bible in this part of the country, and has done much to advance the cause of Christ.

Mr. McGinnis has shown keen interest in the development of the local organization the last several years, and the recognition accorded him is an expression of the appreciation of club members for his high type of service.

J. H. Waldrop has been president of the club the last year and will retire during July when the new officers will be installed. Mr. Waldrop has filled the post very acceptably, and the club despite the depression has been able to accomplish much good work in behalf of the city and community.

Clubs of this kind are always trying to render a high type of service to humanity, and this is especially so of the Rotary club whose slogan, "Service Above Self" has been lived up to by every member of the organization.

To Attempt First Ship-to-Shore Radio Broadcast Tonight

New York, May 20.—(Special to the Daily Reflector)—The first ship-to-shore radio broadcast every attempted from mid-ocean will take place Wednesday evening, at 7:45 (EDT), from the home-bound S. S. Leviathan, of the United States Lines, when that ship is a thousand miles from Sandy Hook. A ship-to-shore wireless telephone will carry the voice of Robert L. ("Believe it or not") Ripley to New York, where it will be broadcast over a regular radio hook-up of five stations covering the Atlantic seaboard, from Maine to Georgia. This will inaugurate a new twice-a-week radio program sponsored by the Standard Oil Company of New Jersey.

Known all over the civilized world for his "Believe it or Not" cartoons, Mr. Ripley (who signs his drawings as "Rip") is returning from a two months' trip in search of new "Queeroddities" and facts that are stranger than fiction. After searching through remote corners of Algeria, Tunis, Morocco, Egypt, the Balkans and the Holy Land, as well as Europe, Ripley will sail from Southampton May 16th. He plans to reveal in his mid-ocean talk, it is reported some of the latest incredible things unearthed on his trip which he has not yet been able to work into drawings.

Since the program is scheduled to begin May 21, and the Leviathan is not scheduled to dock in New York until May 22, special methods had to be adopted to get Mr. Ripley's voice through to waiting listeners.

Nor is the ship-to-shore broadcast the final solution to the problem of putting "Believe it or Not" on the air. The second program of the Standard Oil Company of New Jersey featuring Mr. Ripley is scheduled to go on the air at 7:45 P. M., Eastern Daylight Time the same night as the ship docks—May 22nd, and it is probably going to be necessary to get Mr. Ripley to the National Broadcasting Studios on Fifth avenue via airplane from the Leviathan off Nantuxett Lightship to the Battery, Manhattan. Otherwise he would have no time to rehearse a very difficult program scheduled for that evening.

Believe it or not, after that, Mr. Ripley is expected to settle down more or less peacefully in New York, working on his drawings, his talks, and his new book, and, (much to the relief of radio engineers), he will take himself and his voice to the microphone every Wednesday and Friday, instead of having to have his voice telephoned to a "mike" a thousand miles away. The program is to be known as the "Believe it or Not" Esso Entertainment.

Rule Against Tobacco Rates

Washington, May 20.—(AP)—The Interstate Commerce Commission today held not justified proposed any quantity rates on leaf tobacco from points in North Carolina to Norfolk and Richmond and related points.

The schedules, which had been suspended, were ordered cancelled. The City of Newport News, the Chesapeake and Ohio railway and others protested the proposed reduction.

The commission held that if permitted to become effective, the rate would result in an undue and unwarranted rate disadvantage to Newport News with irreparable injury to that point as a port of call. FINISH JURY IN BANK CASE

Seven Former County Officials and Bankers Go On Trial In Buncombe Court.

Asheville, May 20.—(AP)—John Mitchell, chief state bank examiner, today was subpoenaed to appear in Buncombe Superior court and produce any and all reports in his possession, "confidential or otherwise," bearing on the solvency of the Central Bank and Trust Company in 1928, 1929, and 1930.

The subpoena was ordered by Judge M. V. Barnhill at the request of counsel for Newton Anderson, former county commissioner who with Wallace B. Davis, former president of the Central Bank and Trust Company, and five other bank and county officials, is on trial on charges growing out of the bank's failure last fall.

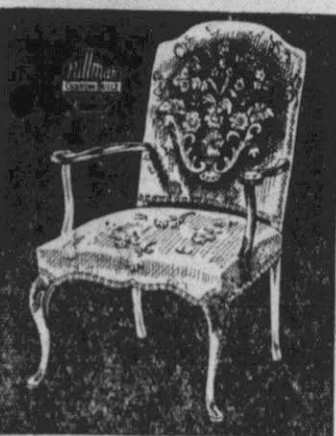

Asheville, May 20.—(AP)—A jury to try seven men, former bankers and former Buncombe county officials on charges of conspiring to use county funds to aid a failing bank was completed in superior court here today.

The twelfth juror was selected soon after court opened. Yesterday 11 jurors were picked from 71 veniremen examined.

The trial is the second for Wallace B. Davis, who was president of Central Bank and Trust Company, which failed here last November. He was convicted last week of making a false report of the bank's condition, but has not been sentenced.

The venire from which the jury was selected was drawn from near-by Madison county.

When the jury was completed, it was empaneled and sent from the courtroom while attorneys argued motions.

Havana Mayor Seeks Return Of Bull Fights

Havana, —(AP)—Bull fighting, which has been moribund in Cuba since the American occupation following the Spanish-American war, will be back in Havana next fall if Mayor Tirso Mesa has his way.

Attempts to re-establish the Spanish sport have previously failed principally because of the opposition of an American woman, Mrs. Jeannette Ryder. Several times she leaped into bull rings and by exhorting the spectators against cruelty to animals shamed them into leaving.

But Mrs. Ryder died a few weeks ago, and Mayor Mesa believes the time is ripe for a revival.

By virtue of his mayoralship he is also president of the National Tourist commission, and he advances the argument that legalization of bull rings would stimulate tourism as well as bring revenue to the government.

He believes that the "rejoneo" or "armless" form of bull fighting would be best for a start. In this game a bull is turned into the arena against a lone horseman,

who demonstrates his riding skill by both attack and escape until the bull gets tired of chasing so elusive a foe.

The mayor said that later, if the fans demand the real thing, with a matador dealing a death thrust

to the bull, it probably could be arranged.

Burlesque bullfighting, called the "charlotada", was tried here a dozen years ago, but failed to win popularity.

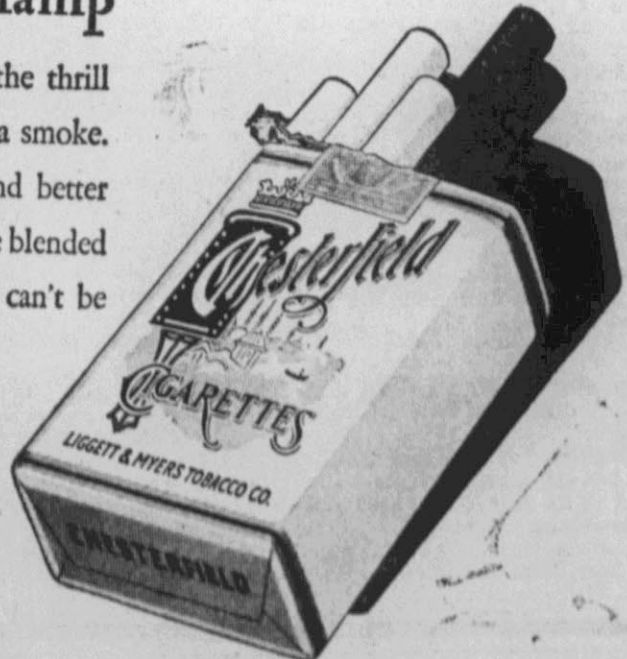

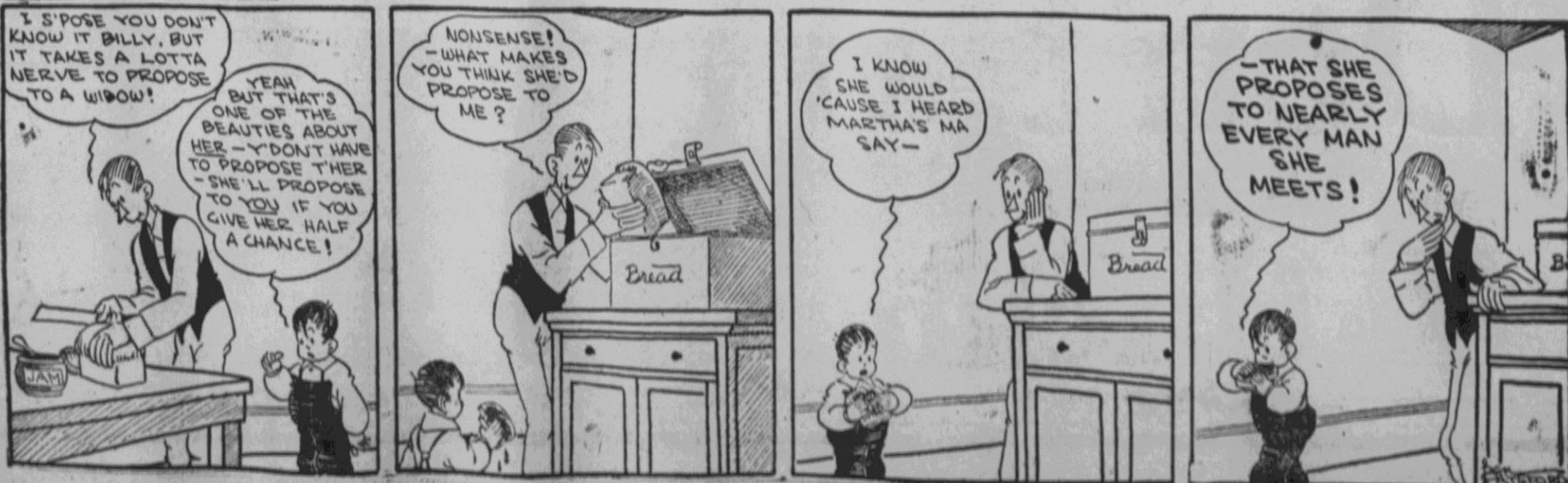

YANKEES FOR CARDS BATTLE FIRST PLACE

Major league baseball teams are busy these days proving that forecasts of a close race in the National League and the Athletics again in the American were correct.

The St. Louis and New York National league clubs are battling for the lead only a half game apart. The Philadelphia Athletics, while they have not been able to outdistance their leading rivals, are on top and have done their best to make it a runaway by winning eleven straight.

The A's downed the Detroit Tigers 5-0 yesterday behind the unbeatable pitching of Big George Earnshaw. The Philadelphia Athletics gave just two hits while his teammates, led by Al Simmons, made good use of nine blows off Waite Hoyt. Simmons, hitting in his 17th successive game, connected for a single, a double and a triple.

The victory resulted in no gain for the A's, however, for their leading rivals, the New York Yankees staked a comeback to hand Cleveland its eleventh straight defeat, 8 to 6. The Indians, whose weakness is one of the season's puzzles, made a great attempt to break their losing streak by driving Charley Ruffing from the mound in the second inning, but Henry Johnson pitched good relief ball and Clint Brown could not still the big bats of the Yankees in the early innings.

Washington lost some ground as rain stopped the game at Chicago. Wet grounds halted Boston and St. Louis.

Timely slugging enabled the National league leaders, the Cardinals, and their strongest rivals, the Giants, to continue their race. The Cards beat Brooklyn 6 to 2 as the Robins failed to give Babe Phelps good support. They got only two runs on eleven hits off Hallahan and Derringer and made five errors. The Giants took things fairly easy against Cincinnati, using Young Bill Morrell on the mound for the full game and hounding Critz out of the in-up, but they won out easily, 9 to 3.

The third place Boston Braves continued their pursuit of the leaders by pushing Chicago deeper into fourth. Aided by three Cub errors, the Braves scored eight runs in the first inning and won out 9 to 5. "Ace" Elliott of the Phillies was in the hole again but this time it was not of his own making. He relieved Jim Elliott in the ninth inning with none out and the bases full and retired the Pirates 1 time to save a 3 to 2 victory. The victory left Philadelphia only half a game behind the fifth place Pittsburghers.

New Ball Has Plenty Of Life

Chicago, May 20—(AP)—American league pitchers, except for a few slow curve ball tossers, today admitted that the "dead" baseball was a pretty healthy sphere.

A comparison of records from the current American league campaign with those up to May 20, 1930, reveals that in five cases out of six the present ball has a livelier bounce than the discarded ball of a year ago.

A year ago today, there were 15 games in which one team scored 10 runs or more a game. So far this season, there have been 21 or six more.

Last year at this time, there were 25 "big" innings in which a team scored five or more runs. To date in 1931, there have been four more.

Individual batting feats have been more plentiful this season than a year ago also. Up to May 20, 1931, 15 batters succeeded in getting four hits on one game while one hampered out five; so far this season, 16 batters whacked out four hits in one game while four more belted out five over nine innings each.

Again, up to May 20, 1931, pitchers turned in 21 games in which the opposition batters collected five or fewer hits in nine innings. To date, this season, there have been only 18.

The exception is in shutouts. Over the same period in 1930, only seven shutouts were turned in as compared with 10 this season.

Players collecting five hits in one game so far this season were Joe Vasmik of Cleveland, Al Simmons and George Mule Haas of the Philadelphia Athletics, and Bill Dickey of the New York Yankees.

STOCK MARKET

New York, May 20.—(AP)—A morning rally in the stock market, centering in the rails, petered out after midday today, as it did yesterday.

The severe pressure against the rails, which Wall Street had been inclined to attribute to foreign sources, has abated, but b'ars still have no difficulty in uncovering isolated weak spots in various sections of the list. Furthermore, the mid-week business statistics were on the whole as unfavorable as advanced estimates had indicated.

American telephone and American Water Works sank more than 4 points to new bottom levels, and the Can stocks were weak. Continental dropped more than 3 points in response to an adverse first-quarter earnings estimate, and American Can declined as much, after an early upturn.

Liquidation of the motor shares seemed to be partly in response to the weekly steel trade reviews, which pointed to tangible evidence that the spring peak in automobile output is being reached. "Iron Age" said there had been a slackening in steel requirements of motor producers, and their plans were uncertain. It said steel production had contracted from 47 to 45 per cent of capacity, while "Steel" estimated it at 44 per cent. This is the most pronounced slackening in steel output since April.

Call money again renewed at 11.2 per cent, but was abundantly available in the outside market at 1. Funds continued to flow into high grade bonds, which is said to be the chief objective of the cheap money policy.
