Aldermen Take Initial Steps Looking To The Purchase Of Gas Plant

Committee appointed At Last Night's Meeting Names Louis Gaylord as Special Counsel to go to Raleigh and Determine Exactly What Action Will be Necessary Leading to Acquisition of Property Here. Gaylord to Report Thursday Night.

L. W. Gaylord, special counsel for the City of Greenville, was in Raleigh today conferring with members of the local government commission regarding what action the city will have to take in the proposed purchase of the gas plant formerly owned by the Carolina Gas and Electric Company but which was recently sold to the Tidewater Power Company.

Mr. Gaylord was to report the result of his conference to members of the Board of Aldermen who will consider the matter at the regular meeting Thursday night.

Sending of the council to Raleigh was the outgrowth of a special session of the Board of Aldermen last night to consider whether or not the city desired to purchase the gas plant. The session was attended by officials of both the Carolina Gas and Electric Company and the Tidewater Power Company, as well as numbers of citizens interested in the matter.

Greenville sold the local franchise to the Carolina Gas Company several years ago with the understanding that in case they ever desire to sell the city should be given due notice with a chance to buy.

The aldermen were notified some time ago that the company was planning to sell, and asked that they submit figures regarding the price and condition of the plant. They were advised later \$100,000 and had completed negotiations for sale to the Tidewater Company, pending word from Greenville.

Mayor Lanier presided and explained the nature of the gathering last night. He called for expression of the public in the matter in order that the aldermen might be able to ascertain the desire of the people.

D. S. Spain, chairman of the Water and Light Commission said his department had no definite recommendations to make, but that if the city desired to buy the gas plant he thought it could be operated successfully by the commission. He reported that members of the municipally owned plants at Rocky Mount and Wilson and found that they had proven paying propositions. He submitted figures showing the rates of both towns to be considerably less than Greenville was paying at the present time.

He presented the following figures regarding the operation of the plants in the three towns: Rocky Mount: Operating cost per month, \$8,533.33; amount invested, \$462,094.99; operation cost per year, \$103,000.00; revenue per month, \$14,033; revenue per year, \$157,000; net revenue per year, \$34,957.14; number meters, 2,809; rate, first 4,000 cubic feet, \$1.60.

Wilson: Operation cost per month \$4,531.75; amount invested, \$208,971; operation cost per year, \$54,381; revenue per month, \$5,773.41; revenue per year, \$69,280.94; net revenue per year, \$14,898.91; number meters, approximately 1,200; rate, first 2,000 cubic feet, \$1.50, ten percent discount.

Greenville: Operation cost per month, \$2,437; operation cost per year, \$27,186; revenue per month, \$2,451; revenue per year, \$27,608; net revenue per year, \$422.99; number meter 436; rate, first 1,000 cubic feet, \$2.38.

Mr. Spain also pointed out that at the time the franchise was sold to the Carolina Gas and Electric Company the local plant consisted only of five miles of pipe line, no plant or real estate. Today it has fifteen miles of pipe line, a complete plant and about four acres of land adjacent to the plant.

J. B. Ficklen, member of the Water and Light Commission, reiterated the statement of Mr. Spain that the commission would do its best by the gas plant if the city desired to buy it. He said the

VETS SURE TO MEET AGAIN

Confederates at Montgomery Shout There Never Will be a Last Annual Reunion.

Montgomery, Ala., June 3.—(AP)—With leaders declaring that this is not the last reunion and "there never will be a last one," the remnants of Lee's army started business sessions of its 41st annual gathering here today.

General Harry Rene Lee of Nashville, adjutant general and chief of staff, who was first to declare this was not the last reunion, reiterated his statement yesterday, telling the veterans, "save your money and get ready for 1932. There never will be a last reunion. We're going to meet next year either at Washington, Richmond or Houston, Texas."

General Lee was speaking before the Confederate Southern Memorial Association, but scores of veterans attending the session sent up a rousing yell and shouted back, "You're right. You're right."

Behind the scenes the battle for the commandership to be vacated by General L. W. Stephens, of Southatta, La., was developing, with General Rice A. Pearce of Union City, Tenn., commander of the Tennessee division and General C. A. De Saussure, of Memphis, Tenn., mentioned as candidates for the honor.

General Pearce last night issued a statement committing himself as opposed to Washington D. C., as the 1932 convention city. "The Bonnie Blue flag does not fly in Washington. The people

Pocket Book Of South Reopened As Scores Of Banks Resume Business

By CARL CRANMER Atlanta, June 2.—(AP)—Gradually the pocketbook of the south is being reopened as scores of banks resume business after being forced to close their doors in 1930 and early weeks of 1931.

Reports from banking commissioners in five southern states which suffered most from bank failures show that since January 1 deposits amounting to more than \$39,000,000 have been restored to circulation or by depositors' agreements with the reopening of 159 banking houses.

Capitalization of the reopened institutions totals \$6,779,000. The figures are from Arkansas, Mississippi, North Carolina, Kentucky and Florida. In Tennessee, a legislative investigation is being made into politico-financial alliances in an effort to fix responsibility for involvement of almost \$7,000,000 of state funds in a series of bank crashes, and the process of liquidation has been slow. Only two banks with deposits amounting to \$130,000 have reopened in Tennessee where 20 banks with de-

posits of \$13,377,500 were forced to suspend operations. Four hundred and eight banks capitalized at \$23,063,000 closed in these five states during 1930 and early this year and tied up deposits totalling \$190,270,000. Banking commissioners report that 269 institutions are permanently closed. Arkansas, most severely hit, had 143 banks with \$39,000,000 in deposits, to suspend business. But that state has made the most rapid recovery. There 73 banks with \$12,250,000 in deposits have reopened, and one other institution is expected to open in the next two months with deposits of \$300,000. Sixty-nine banks are permanently closed, says the state banking department. Mississippi with 100 bank failures involving \$46,000,000 in deposits, has reopened 35 banks with deposits of \$12,600,000. Six of the failing banks had national charters and two of them have reopened. Thirty-five banks with deposits of \$8,325,000 have reopened in

CONVICT DIES IN ATTEMPT TO GAIN LIBERTY

J. N. Kelly Shot Down By Guard in Effort To Escape From Cary Prison Camp.

Raleigh, June 3.—(AP)—J. N. Kelly, 17, of 1319 South 29th street, Philadelphia, Pa., who was sent to state's prison from Guilford county March 7 to serve two to five years for larceny of an automobile, was shot and killed today while attempting to escape at Cary prison farm, near here.

Kelly and C. Jordan, alias W. C. Maguire, tried to escape while being marched to a cotton field to work. Kelly was instantly killed by a load of shot fired by Guard Marvin Neville. Jordan immediately surrendered.

The youth attempted to get their freedom by dodging behind a large highway signboard, evidently hoping it would shield them from the view of the guards. The rear guard of the detail could not see them and called to Neville, who shot.

Coroner L. M. Warren of Wake county viewed the body but held no inquest.

Prison records listed Kelly's father as Mickey Kelly of Philadelphia. Four youths escaped from the Cary farm yesterday by overpowering a guard. None of them had been captured today.

HEAVY DOCKET GIVEN HEARING

County Court Disposes of Number of Cases in Day-and-a-Half Hearing.

Lorice Ray, negress, was sentenced to serve thirty days in jail on a charge of assaulting her neighbors by Judge W. L. Wheeler, presiding over the regular session of County court, in this city today.

The woman was alleged to have advanced on her neighbors with a deadly weapon and was later arrested and bound over for hearing in County court.

This session of court was the first held in the last two weeks because of the two-week term of civil court which came to an end last week. Court began work yesterday morning and concluded hearing shortly before the noon hour today.

Heber Hardee, of Grimesland, was sentenced to 90 days on the roads following conviction on a charge of possession of liquor. Arthur Smith, colored, of Grifton, paid a fine of \$10 and cost on a charge of possession of liquor.

Wesley Edge and Millie Pitt, colored, were found guilty of adultery. Edge was sent to the workhouse for 90 days and the woman was given a sixty-day suspended sentence to jail.

Tom Roberson, colored, was sent to the roads for six months for carrying a concealed weapon. M. L. Nobles, charged with issuing a worthless check, was allowed to pay the amount of the check and cost of action.

W. H. Hausley, colored, larceny, paid a fine of \$20 and cost. Bennie May, charged with non-support of his family, was given a six months' suspended sentence during which time he will be required to provide for his people.

Charged with possession of whiskey, Robert Redding, colored, paid \$50 and cost. Tom Black, colored, was sent to the roads for four months after conviction of carrying a concealed weapon.

Sentence was suspended on payment of cost in the case of Tom Moore, charged with trespass. Convicted of assault with a deadly weapon, Dan Grimes, was sent to the roads for four months.

Tom Potter and Bettie Hardison, were adjudged guilty of a charge of immoral relations. Potter was sent to the roads for six months, and prayer for judgment was continued in the case of the young woman.

Found guilty of possession of liquor, Charlie Williams, was sent out to the roads to spend 90 days.

"How about the hair tonic I'm using? Is it O. K.?" asked George of the "floating trumpet" through which advice was being issued. He didn't like the answer, so he turned on the flashlight.

As a result, Mrs. Lillian Jeffs, the "spiritualist," was brought to court today on a warrant charging obtaining money under false pretense. George said the light revealed Mrs. Jeffs clad in black, waving the "floating trumpet" about and talking through it. He wants the \$14 he paid Mrs. Jeffs for advice returned to him.

CANNON SUES REP. TINKHAM FOR \$500,000

Bishop Seeks Damage As Result of Alleged Libel Charges In Politics.

Washington, June 3.—(AP)—Bishop James Cannon, Jr., filed suit in the District of Columbia Supreme Court today against Representative Tinkham, Republican, Massachusetts, for \$500,000 for alleged libel.

Cannon based his suit upon the charges Tinkham made in connection with his 1928 anti-Smith campaign activities.

The Southern Methodist Bishop alleged that Tinkham had written and caused to be published on June 19, 1930, an article charging him with violating the Federal corrupt practices act.

The article, the bishop's suit accused him of failing to account received from E. C. Jameson, a New York capitalist, for use in opposing the candidacy of former Governor Smith for the presidency.

Bishop Cannon's brief said he had always complied with all laws in all activities in which he was concerned, including the 1928 election, and had only refused to subject himself to "unjust and unscrupulous" attacks.

His brief said he had been greatly injured in his good name and fame as a citizen, churchman and moral leader by the statements alleged to have been made by Tinkham in the newspaper articles. He asked \$250,000 compensatory and the same amount as punitive damages.

The suit apparently was based upon a statement Tinkham gave newspapermen a year ago in which he repeated charges he had made on the House floor. Bishop Cannon had called him a "blustering, cowardly congressman" for making the charges under the cloak of immunity from libel proceedings which shields congressional speeches.

In his speech on the floor, Tinkham had demanded that Cannon make an accounting of the \$48,300 and said that until he did he "will stand convicted in the eyes of all honest men."

CATHOLICS ARE JAILED IN ROME

Leaders Arrested On Political Warrants Signed By The Prefect.

Rome, June 3.—(AP)—A number of leaders of Catholic young people organizations have been arrested on political warrants signed by the prefect. After being questioned they were held for further disposition, which may mean confinement to the Island of Lipari.

Among those arrested was Atorney Corsanigo, honorary general of the Italian Catholic young people organization. He received from the prefect a "political admonition," a measure which usually immediately precedes exile to the prison island.

Davidson To Spend Over Two Millions For Improvements

Davidson, June 3.—(AP)—Davidson College trustees today had adopted a building program which will involve the expenditure of more than two and a half million dollars within the next five years.

Details of the program were outlined by trustees here yesterday after a student-alumni petition that student dances on the campus be allowed had been denied.

Refusal of the dance petition was a retaliation of the board's stand in regard to dancing on the campus but it also included a recommendation to the faculty that "restrictions" and "safeguards" be thrown around students who "dance in other places."

Included in the financial program would be erection of an infirmary, library, two dormitories, field house, social and religious center, enlarged chemical laboratory and a new church at an estimated cost of \$500,000.

Endowments of \$300,000 for the library, \$100,000 each for buildings, and \$1,000,000 for the general endowment, would complete the program. A committee was appointed to work out the details of the program and to decide on its promotion.

Davis Sentenced To Serve Five To Seven Year Term in Prison

Camonian Is Declared English Derby Winner At Epsom Downs Today

Orpen, Co-Second Choice Finishes Second in Front of Lord Roseberry's Sandwich in Annual Renewal of English Classic; Cameronian Went to the Post a Seven to One Favorite While Orpen Was Held Nine to One.

Epsom Downs, Eng., June 3.—(AP)—J. A. Dewar's Camonian, the favorite, today won the 148th renewal of the English Derby.

Sir John Rutherford's Orpen, co-second choice, finished second in front of Lord Roseberry's Sandwich with Marcel Boussac's Goyescas fourth.

Camonian went to the post a 7 to 1 favorite while Orpen was held at 9 to 1 and Sandwich at 8 to 1.

A crowd of 750,000, including King George and the royal family, saw the son of Pharos Una-Cameron, gallop home in front of 25 other three-year-olds.

Camonian won by three-quarters of a length with a like distance separating Orpen and Sandwich.

Jacopo, the Aga Kahn's Pommé D'Api and Sir Edward Hamner's Gallani finished practically in line for fifth place. Sir Andrew was far back among the pack.

Camonian was the first favorite to win in recent years. The cold was installed the choice soon after his victory in the two thousand and guineas and up to post time was a good thing at 4 to 1. His odds were lengthened, however, as the huge crowd began to plunge on the outsiders.

While interest in the Derby as a horse race and spectacle was, if anything, keener than ever, it was pre-eminently a "money race." There have been some rather tall guesses on the amount involved but one London paper this morning went so far as to estimate that 20,000,000 pounds sterling were at stake.

Even if this were an exaggerated stab however, it seemed safe to say that with the gigantic Irish sweepstake swelling the total, there probably was more money hanging in the balance than ever before on any race in history.

Democrats May Accept Tariff Act As Definite Issue In 1932 Campaign

Washington, June 3.—(AP)—Acceptance by the Democratic party of the Smoot-Hawley tariff act as a definite issue in the 1932 campaign appeared likely today as administration officials continued silent on the new Canadian tariff increases.

Chairman J. H. Shouse of the Democratic National Executive committee predicted his party would accept tariff as an issue in charging the administration with responsibility for "prolonging the business depression through the Smoot-Hawley act."

In a formal statement, Shouse said American exports to Canada had been sharply curtailed since enactment of the measure and added:

"Canada's latest tariff increases on goods imported from the United States is the more blow to our industries already suffering from the ruination of our foreign markets by the Smoot-Hawley tariff."

"The administration could not have inflicted greater punishment on American business had it deliberately sought to alienate our best customer."

Counsel For Former President of Defunct Central Bank and Trust Company At Asheville, Files Notice of Appeal to Supreme Court and Bond is Set at \$10,000; Guilty of Causing False Report of Bank's Condition Prior to Closing to Be Published.

Asheville, June 3.—(AP)—Wallace B. Davis, former president of the defunct Central Bank and Trust Company here, today was sentenced to serve five to seven years in state's prison for violation of the state banking laws.

Counsel for Davis filed notice of appeal to the Supreme court from the sentence and bond was set at \$10,000.

Davis had been found guilty of causing a false report of the bank's condition prior to its closing to be published.

The bank's crash last fall wiped out \$20,000,000 in deposits, including \$9,000,000 in funds of Buncombe county and the City of Asheville. A number of smaller banks of the section also failed as a result.

Before pronouncing sentence Judge Barnhill, presiding, criticized severely the citizens of this section, who he said appeared to desire "persecution" rather than "prosecution" of Davis.

He said that he would fix a penalty which he considered sufficient punishment for the crime of which the former banker was convicted, regardless of the amount of criticism which might result among the former depositors of the bank and their friends in this section.

Prior to pronouncing judgment Judge Barnhill heard a plea for leniency by R. R. Williams, of counsel for the defense. Mr. Williams declared that "ten days will be as hard on this defendant as 30 years on the ordinary criminal."

After pronouncing sentence Judge Barnhill recessed court until later in the day, when it was expected bond arrangements for Davis and other details in connection with the case would be handled before adjournment of the special session.

Today's sentence brought to a close two trials of Davis on charges growing out of the bank's failure.

He was convicted about three weeks ago of causing a false report of the bank's condition to be published but was found not guilty of the second count of the indictment, making a false report to the State Corporation Commission. Two directors of the defunct bank were acquitted of the charges at the same time.

Davis' second trial was on a charge of perverting the credit of Buncombe county in an effort to save his tottering bank. This trial ended Monday with a verdict of not guilty. Other defendant, acquitted at the same time were Newton M. Anderson, former chairman of the Buncombe county board of commissioners, and L. L. Jenkins, former treasurer of the county. Non-suits were entered as to Russell Davis, C. N. Malone, James Grimes and J. O. McElroy.

Wilson, June 3.—(AP)—W. E. Finner, of Rocky Mount, today was elected president of the Eastern Carolina Warehouse Association. Rocky Mount was selected as the 1932 convention city.

Other officers elected are as follows: B. B. Sugg, Greenville, vice-president; H. J. Browder, Rocky Mount, secretary-treasurer. The following directors were named: J. W. Mangum, Rocky Mount; W. L. House, Tarboro; Nat Hill, Kinston; R. H. Knott, Farmville; J. E. Crute, Wilson; W. Z. Morton, Greenville; H. L. Skinner, Smithfield and W. T. Adkins, Robersonville.

The association adopted a resolution calling on tobacco planters to destroy the common ground leaves or first primings this year in an effort to further reduce the 1931 crop. This resolution will be circulated throughout the entire tobacco belt.

ABOUT TOWN

There is an ordinance in the City of Greenville requiring residents to keep their premises clear of rank growth of vegetation during the summer months. This ordinance was passed some years ago with a view to reduce the annual attack of mosquitoes and at the same time add to the beautification of the city.

In a recent statement Mayor J. C. Lanier called attention of the public to the law and asked everybody to co-operate in the movement to improve conditions.

Weeds form splendid breeding places for the mosquito and citizens who permit rank growth around their premises may expect to have a bumper crop throughout the summer season. In the anti-malarial campaign conducted here for several years the necessity of eliminating weeds was stressed by the workers in an effort to reduce mosquito breeding.

The people should make an effort to co-operate with the mayor in this instance and in that way protect themselves against mosquitoes and at the same time insure better health.

Pitt county growers have received approximately \$25,000 this year from the raising of hogs and chickens, according to a report yesterday by the farm department.

This will give the public something of an idea what may be accomplished when the growers long oppressed by low prices for the main money crops, turn their attention to extra sources of revenue.

The growing of hogs and chickens has been receiving attention of farmers for a number of years, but not until the last four or five years did they really begin to seriously consider the matter.

It is impossible to estimate the extent which the industry will assume in future years, but it is one of the planks in the platform of the live-at-home movement enunciated by prominent agricultural men two years ago, and one which is destined to play a vital part in the farm life of the state.

It is only through diligent experimentation along lines of this kind can the farmers hope to win salvation from the mire of depression to which they have been thrown the last few years.

It will be of interest to the public to note that the government is planning to save twenty millions of dollars through the Agricultural Department during the next fiscal year.

This announcement was made by President Hoover yesterday following a conference with prominent members of the farm department.

The reduction is in keeping with slashes made in other departments and should have a pronounced effect in the economic condition of the country the next several years if carried out according to program.

The reductions are in response to a widespread demand of people in all parts of the nation, who desire to enjoy the prosperity promised by the administration some years ago, are now clamoring for the cutting of expenses hoping to get some relief from the burden of taxes they have been carrying so many years.

Long pronounced King of the Southland, cotton is being elevated to a more exalted position by the people in all sections of the nation this week, proclaimed far and wide as "National Cotton Week."

Additional recognition is being given to the staple this week to encourage more extensive use of materials made from the product. Stores in the largest cities are featuring cotton-made goods and costumes, and the result of the displays no doubt will be quite satisfactory.

The merchants of Greenville and county are also emphasizing the cotton fabric, and the showing in many instances is the most extensive in history of the community.

Prices for the staple have been below the cost of production for several years now, and only increased consumption can the people hope to improve conditions.

The public should give serious consideration to this attempt to increase use of the leading product of the Southland because they are just as directly concerned as the grower in the final summing up of the situation. It is the same old story that when the farmers suffer, the rest of the people are likely to suffer also.

The public is given a cordial invitation to attend final exercises in connection with commencement season of the Greenville high school at the campus building of East Carolina Teachers College Friday evening.

At that time seventy-seven graduates will receive diplomas from the school which has achieved the distinction as the first in the state from the standpoint of scholastic rating. This is an honor which prides of the school should consider with pride. From a financial rating away below the larger schools of the state, Greenville high has been able to climb to the highest peak of scholastic endeavor through the pure excellence of its system and the faithful work of the faculty.

The school for years has enjoyed an A-1 rating, but not until this season was it able to forge to the forefront in the educational life of the state. The record followed in the wake of reduction of faculty, two slashes of salaries, and is an indication of the spirit of the men who, despite these obstacles, have been able to scale the heights and reach the prehelion of public school service.

ALDERMEN TAKE INITIAL STEPS LOOKING TO THE PURCHASE OF GAS PLANT

(Continued from page one) figures presented by the chairman of the commission had not been exaggerated and were based on actual conditions prevailing at this time.

Martin Swartz, superintendent of the water and light plant, explained that the number of stoves used for gas and electricity were about the same.

J. E. Wallace, representing the Carolina Gas and Electric Company, and the Tidewater Company, assured the aldermen that they wished to live up to the terms of the franchise. He said that surrounding plants operated by the Tidewater Company would always be ready to render any service to the city in case it desired to purchase the plant. He said if the Tidewater should come here, it was the desire of the officials to see the city grow and that they would do everything in their power to further this purpose.

Mr. Matthews, vice-president of Tidewater, referred to other towns where his company operated as respect to the policy which they had adopted, and said they would do everything possible to advance the cause of the local plant whether they bought or not.

Alderman Hollingsworth said it was up to the board to decide immediately what should be done in the matter and not defer it until July 21 when the option expires.

Asked by Alderman Boyd as to what action the city would have to take to acquire possession of the gas plant, Mayor Lanier explained that it would be necessary to call an election to determine whether the people desired a \$100,000 bond issue with which to finance the purchase of the enterprise. He said he had no doubt but that the local government commission would pass on the bonds considering the splendid financial condition of the city.

Alderman Boyd made a motion that an election be called for the purpose of voting on the issue. Alderman Hassell said he thought the city should employ special counsel to confer with the local government commission and definitely determine what action will be necessary. Alderman Boyd withdrew his motion and the board adopted the suggestion of Alderman Hassell.

A committee composed of Alderman Boyd, Hassell and Hobbard was appointed by Mayor Lanier to employ counsel to go to Raleigh and obtain all available information on the matter. The committee met immediately after adjournment of the aldermen's meeting and selected Mr. Gaylord, who was urged to obtain the information and have it ready for the Thursday night meeting.

POCKET BOOK OF SOUTH REOPENED AS SCORES OF BANKS RESUME BUSINESS

(Continued from page one) North Carolina where 96 institutions having deposits of \$50,523,000 were suspended. The deposits of the reopened banks are bound by depositors' agreements to be left in the vaults undisturbed for a maximum period of two years, unless collections by the banks warrant a quicker release.

In Kentucky eight institutions have reopened their doors, releasing \$2,467,000 in deposits. Thirty state banks closed in Kentucky, "freezing" \$24,906,000 in depositors' funds. In addition two national banks quit business.

Five banks in Kentucky probably will be reopened with deposits amounting to \$21,968,000 within the next two months, the Kentucky banking department says.

Eight state banks with deposits of \$3,568,000 have reopened in Florida where 39 institutions suspended business and tied up \$249,480,000 in deposits. The figures do not include national banks which were forced to suspend. Thirty-one banks are permanently closed.

Goldsboro, June 3.—(AP)—Miss Levisa Sancher of New Cannon, Conn., was seriously injured near here early today when her automobile overturned. A 15-year-old boy with her escaped with bruises.

Miss Sancher was returning to her home from Miami, Fla., and had been driving all night. She said she must have gone to sleep at the wheel. She is being treated at a local hospital.

state banking laws.

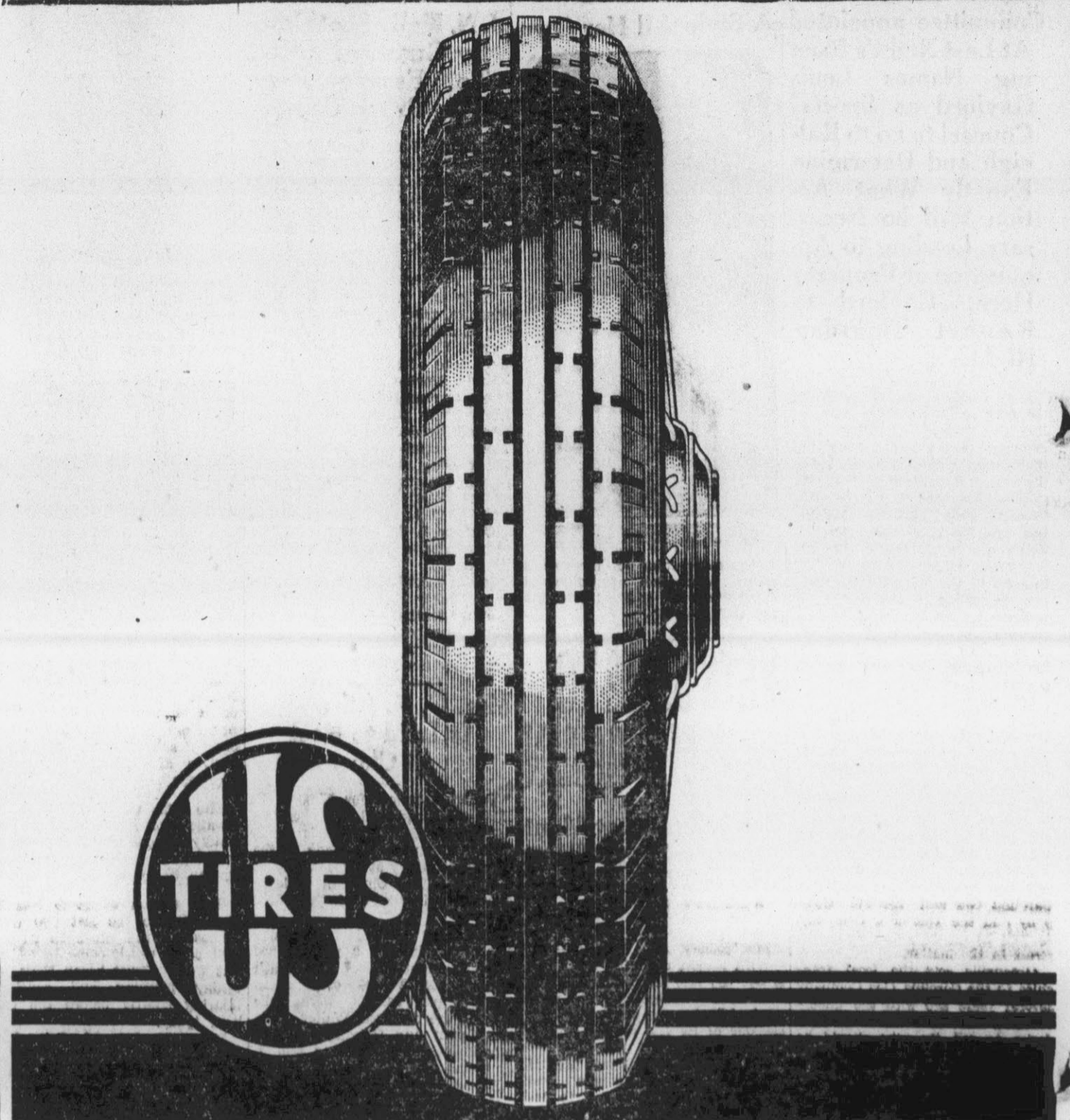
Judge Barnhill an hour before had sentenced Davis to from 5 to 7 years imprisonment.

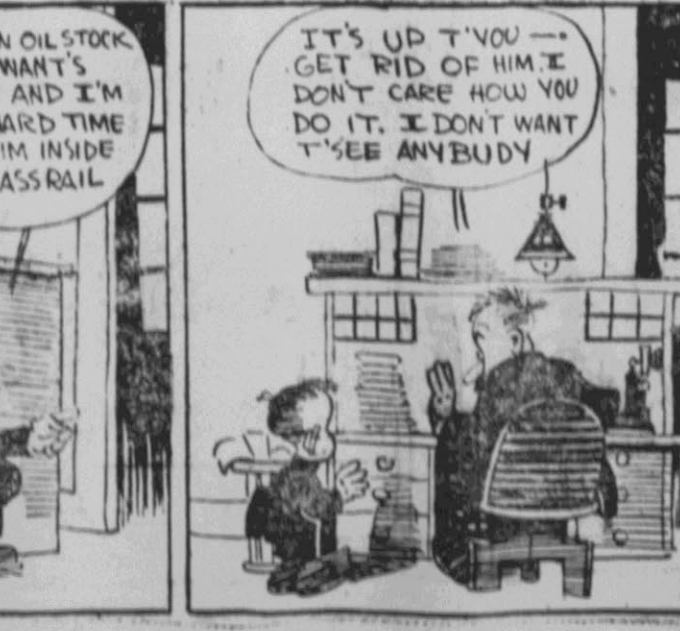

Cotton--Stocks--Grain

N. Y. COTTON

New York, June 3.—(AP)—Cotton opened steady today unchanged to 5 points higher on covering and trade buying which seemed to be based upon price rather than any particular factor in the early news.

Offerings were light following recent declines and were readily absorbed, with the active month selling about 8 to 10 points net higher right after the call on a continuation of the demand. This bulge met a little more cotton but it was absorbed on reactions of 3 or 4 points with the market holding steady at the end of the first half hour.

The earlier cables from Liverpool were steady on covering but prices there weakened later owing to the weakness in Alexandria where the Egyptian futures were 10 to 25 points lower. The New Orleans market was closed. A little southern selling was reported here early but it was in small volume.

GRAIN MARKET

Chicago, June 3.—(AP)—Spectacular downward swings of grain prices today accompanied announcements in the judgment of the Federal Farm Board the parting of the way had been reached between old crop wheat dealings and the new 1931 domestic crop. Definite word from official sources was received that government sponsored agencies were not buying wheat in any market, and some cases prices quickly fell more than 14 cents a bushel.

It had been promised that buying support for cash wheat prices by Farm Board allies would continue until new wheat started moving in the southwest, but authentic advices were received today that 40 to 50 bushels an acre of new wheat were harvested in Texas, and was moving rapidly to market. Withdrawal of government sponsored buying support for June wheat contracts and for cash wheat, followed and with the collapse of quotations the market here and at other leading centers became semi-demoralized.

STOCK MARKET

New York, June 3.—(AP)—The stock market's spirits improved measurably today. Although some further liquidation had to be absorbed after a strong early advance, prices quickly rallied again when this pressure was lifted.

Lading shares had shown much better resistance yesterday and their refusal to yield much more than the gains of the opening rally this forenoon indicated one of those oversold positions out of which shorts hasten to scramble. The day's news was mixed in character, so that the market seemed to be influenced chiefly by its own internal position.

Gains of a couple of points or more developed in leading shares generally, including U. S. Steel, American Telephone, Borden, New York Central, Atchafon, Union Pacific, Westinghouse, Allied Chemical, Corn Products and the American Tobacco. Rock Island rallied after the reduced dividend had been announced, while the 7 per cent preferred, on which the regular rate was declared, recovered briskly.

Sentiment gained courage from the announcement that at least two large local banks had cut their margin requirements on loans to brokers to 20 per cent from 25. Officials of one institution explained that the action was taken because the bank believed stock prices were on a level which made the lower margin conservative. The effect of course, would be to stimulate borrowing. Liberal reductions were made after the first crash in 1929, and others have followed.

Decision of the Department of Justice to withdraw its opposition to the oil consolidation was rather a surprise. The merger action had been regarded as a test of the government's attitude toward recombinations of old Standard Oil units, and the decision not to appeal was interpreted in Wall Street as an indication that federal authorities had recognized a changed competitive situation in the oil industry since the dissolution decree of 1911. The possible bearing on a union of New Jersey and California Standards, which was discussed some time ago, was naturally the subject of comment, but the general opinion seemed to be that there would be no immediate scramble in the direction of mergers.
