OTHER HORTON CHARGES COME UP NEXT WEEK

Tennessee House Adjourns for Week-End After Rejecting One of Eight Articles.

Nashville, Tenn., June 6.—(AP)—After rejecting the first of eight articles of impeachment preferred against Governor Henry H. Horton, the Tennessee House of Representatives was in week-end adjournment today.

Consideration of seven remaining charges was expected to start Tuesday.

If the articles are taken up in rotation, the next to be acted upon alleges that the executive was derelict in his duty in failing to see that estimates were made of the amount of surety bonds officials and employes handling public funds should have.

"Had Governor Horton performed his official duties," the article sets forth, "the state might have saved the loss of the millions of dollars of highway and bridge funds."

The House yesterday defeated 58 to 41, an article charging that Governor Horton conspired with Colonel Luke Lea, publisher, and Rogers Caldwell, financier, to receive their political backing and in return let them dominate certain state departments for their financial gain.

Any possibility of the consideration at this session of allegations contained in the article was eliminated by adoption of a motion, 52 to 47.

Congressman E. H. Crump, Memphis political leader, who has been here aiding in the impeachment fight, announced that rejection of the first article did not by any means stop the battle.

Veterans Conclude Alabama Reunion

Montgomery, Ala., June 6.—(AP)—The small band left to bear the colors of the Confederacy was demobilized today for another year after closing its forty-first annual reunion here.

With the strains of "Dixie" still lingering in their ears these gallant sons of the Old South were storing away their faded gray uniforms and returning to their homes to await the call to muster a year hence at Richmond, Va.

While the "rebel yell" rang as true as ever, their tottering gait belied the enthusiasm with which they shouted "On to Richmond" as they boarded trains and gave parting handshakes to their comrades.

Reuniting in the "cradle of the Confederacy" for the first time the veterans and their legions of friends were unstinted in their praise of Montgomery's welcome.

Special trains bore General C. A. DeSaussure, the new commander-in-chief, and his spirited little army back to their homes many of the veterans having departed before the ball of the Sons of Confederate Veterans, which closed the reunion officially last night.

PARROTT TO DECIDE ON HEALTH POSITION TODAY

Rocky Mount, June 6.—(AP)—Dr. J. M. Parrott of Kinston, recently elected secretary of the State Board of Health, will decide either today or Monday whether he will accept the position.

The physician made this statement here last night. Certain personal matters, Dr. Parrott said, must be given careful study before he decides.

Physicians to Pass on Fall's Condition

Washington, June 6.—(AP)—Albert B. Fall is to be examined soon by two physicians appointed by a District of Columbia Supreme court judge to determine whether he is able to come to Washington to begin a term of a year in prison.

Chief Justice Wheat is to make the appointments as early as possible.

Fall was convicted of accepting a \$100,000 bribe from Edward L. Doheny, wealthy oil man, in leasing government petroleum reserves. He was sentenced to a year in jail and to pay a \$100,000 fine. The Supreme court refused to review the conviction and a mandate, ordering execution of the sentence, has been handed down.

NO CHANGE IN HARWOOD CASE

Asst. Attorney General Leaves for Bryson City to Serve Warrant.

Raleigh, June 6.—(AP)—A. J. Maxwell, commissioner of revenue, said today there were no further developments in the case of Miss Lols G. Harwood, who is alleged to have misappropriated \$4,903 in state funds.

Mr. Maxwell declined to discuss the case, saying he had placed the matter in the hands of the courts of the state for handling, and "in no way wished to prejudice Miss Harwood's rights."

Walter G. Siler, assistant attorney general, left Raleigh last night presumably for Asheville of Bryson City, Miss Harwood's home, to serve a warrant sworn out here yesterday for the arrest of the young woman.

All state officials concerned in the case were silent as to when they expected Mr. Siler to serve the warrant.

Bryson City, June 6.—(AP)—Assistant Attorney General Walter Siler, reported to be enroute to Bryson City to serve a warrant on Miss Lols G. Harwood, daughter of Judge John H. Harwood, superior court jurist, of Bryson City, had not arrived at 9:30 o'clock today, according to an officer in Sheriff Patterson's offices.

Sheriff Patterson left Bryson City this morning for Asheville and could not be reached. He was expected to reach Asheville at noon. Members of the staff at Bryson City said they did not know when Siler would arrive.

Miss Harwood was at her home here where she has been for several weeks. Neither she nor her father would make a statement regarding the case.

Miss Harwood, former employe of the State Revenue department, is charged with embezzlement of state funds. It is alleged that her accounts were short \$4,903 for the period from March 29, 1929, to March 21, 1930.

State Auditor Baxter Durham in giving out the report of his auditors last week said there was no proof that Miss Harwood had taken the money, but it had been embezzled during her period of service and in passing through her custody, and she had made no explanation.

Hold Funeral For Col. Fries Today

Winston-Salem, June 6.—(AP)—Francis H. Fries, 76, president of the Wachovia Bank and Trust Company, will be buried here at 5 p. m. today.

Funeral services will be held in the Home Moravian church, of which he was an elder and trustee. His body will be buried in "God's Acre," the ancient Moravian cemetery, a quarter of a mile from the church.

Officers and directors of the Wachovia bank and its branches will be honorary pall bearers. All branches of the bank will close an hour earlier today as a mark of respect to Mr. Fries.

B. B. Sugg Also Named as Vice-President at Meeting of Directors of New Institution Last Night; The Bank is Expected to Open July 1; Cashier to be Selected During Next Few Days.

S. T. White, prominent Greenville business man, was elected president of the State Bank & Trust Company, new institution organized to take over the old National bank, at a meeting of the board of directors last night. B. B. Sugg, well-known tobacconist, was also elected to the vice-presidency.

It was stated that a cashier would be selected in the next few days, and it was hoped to throw open the bank for business on July 1. The board of directors was elected at a meeting of stockholders yesterday morning at which time the bank charter and by-laws to govern the operation of the institution were read and approved. It was stated that 908 of the 1,000 shares were represented at the meeting, either in person or by proxy.

The election of the two officials last night has been connected with general interest throughout the city. Both have been long affiliated with the business life of the community, and are well informed concerning local conditions.

Mr. White for several years served as chairman of the Board of Commissioners of Pitt county, and during the time rendered meritorious service to the county. He has been engaged in various business projects in past years, in addition to his large holdings in city and farm property. He is at the present time head of a chain of stores in this section of the state, with the main store located in this city.

Mr. Sugg is one of the leading spirits of the Greenville tobacco market. He has been connected with G. V. Smith in the operation of the Star warehouse for a number of years, and is prominent in the general business life of the community.

J. L. Little was president of the old National bank, which the new bank is taking over.

LINDY PICKS EAST ROUTE

Flight to Japan and China to Take Him Near the North Pole, Announced.

New York, June 6.—(AP)—Col. and Mrs. Charles A. Lindbergh are considering flying to China and Japan over an eastern route, which would bring them close to the North Pole on a 6,500 mile journey to the Orient.

Colonel Lindbergh is studying the possibilities of a Great Circle course across Greenland and Spitzbergen instead of taking the Bering Strait route (from the Pacific coast).

He is making inquiries as to fuel and supply bases and stores along that northern route. The whole plan is in a formative stage.

At North Beach airport, Queens, mechanics installing pontoons have been ordered to put a water rudder on Lindbergh's Lockheed plane. The equipment under consideration includes a tent, a rubber boat, two months food supply and radio apparatus.

The northern-Gret Circle route has been flown three times by the army round-the-world fliers, Von Gronau, who made it last year in a Dornier flying boat, and by Parker Gramer and Bert Hassell of Rockford, Ill., who lost their plane in a wreck in Greenland.

There have also been flights to that part of the world by Sir Hubert Wilkins and Captain Albin Ahrenberg, Swedish pilot who went searching for Amundsen after the wreck of the Italia.

"The trip will be made some time this summer and we plan to fly to China and Japan, and that is all we ourselves are sure of so far," said Lindbergh.

Tokyo, June 6.—(AP)—The impending flight of Col. and Mrs. Charles A. Lindbergh to the Orient was hailed with enthusiasm here today.

Most vernacular newspapers ventured editorially they would succeed, although several commented that it was not "by any means what might be called a pleasure trip."

GERMANY ASKS RELIEF FROM REPARATIONS

Government Declares It Has Reached Limit of Its Capacity for Payments.

Berlin, June 6.—(AP)—The time has come for Germany to tell the world that liberation from "unbearable reparations burdens" is imperative, the government declared today in an appeal to the people, published simultaneously with a series of new emergency tax decrees calculated to yield nearly \$400,000,000 in new revenues.

"We must call our last reserves and tell the world that we have reached the limit of our capacity to bear privations," the appeal declared.

Germany's purchasing power, the document said, is diminished by reparations payments and she is compelled to increase her exports against which other nations are raising increasingly higher barriers in the fierce war for world markets.

"We are often told that Germany has not economized enough," the appeal said. "At the present juncture that is not true. Including today's decrees we have saved 1,500,000,000 marks (about \$345,000,000) in expenses, and so far, as we can see now our 1931 budget is balanced."

The government is under no illusions regarding the severity of the sacrifices demanded from the nation and its citizens, the appeal said, but these are unavoidable.

"It is better to take from those who have than to risk discovering some day that we cannot meet our liabilities. We have done everything possible to meet them, and have taken up much foreign capital, but this is no longer possible."

British Refuse to Regard Armour as Truly an American

London, June 6.—(AP)—Admitting they couldn't get away from the fact that the open golf championship has gone to America for the eighth successive year, British golf enthusiasts and press commentators clung fondly today to the fact that Tommy Armour is of Scottish birth and refused to regard him as an American.

All agreed that the 1931 open was one of the most exciting and remarkable fights in the history of the championship and had nothing but admiration for Armour, while extending hearty sympathy to Jose Jurado, the little Argentine, who tossed away his chances on the last two holes.

Jurado was credited with a "glorious failure" but Armour was declared the greater golfer and a worthy winner.

No excuses were offered for the failure of any of the British home-bred to win, and virtually all interests was centered on the hot fight between Armour and Jurado.

The Morning Post said: "The moral of it is we have still to discover and apply the secret which subtly distinguishes the best American from the best British golfers—the secret which always brings the Americans in a cluster to the top."

CONTINUES HIKE PULLING GOAT CART TO CAPITAL

Rocky Mount, N. C., June 6.—(AP)—O. C. Liles of Goldsboro left here early today, continuing his hike to Washington, pulling a wagon with two of his children as passengers. A third child pushed his way along on a scooter.

Liles hopes to reach Halifax or Weldon by night. He is operating on no set schedule, though he must be back in Goldsboro within two weeks.

CAPONE FACES PRISON TERM

Gang Leader is Held for Alleged Evasion of Government Income Tax Law.

Chicago, June 6.—(AP)—The chief of gang chiefs—Alphonse Capone—today faced the possibility of a 32-year penitentiary sentence and a fine of \$80,000 for alleged evasion of the government income tax.

This is the maximum sentence possible if he is convicted on the charges on which he surrendered yesterday, following his indictment by a federal grand jury.

He posted a \$50,000 bond and was released. There were two indictments, one was returned yesterday. Another was voted March 16, but was suppressed. They contained six felony and two misdemeanor counts, and alleged government tax claim of \$215,080.45.

The indictments marked the culmination of two years of investigation under the direction of A. P. Madden, chief of the special intelligence department of the Internal Revenue Department, during which Madden said that more than 1,000 persons were interviewed. A total income of \$1,038,654.84 during the years of 1924 to 1929, inclusive was charged. Federal agents, however, said this did not represent Capone's income but only the sums which could be definitely traced.

There was no indication as to the exact date of the gang leader's trial, but United States Attorney George E. Q. Johnson, who has won a conviction against every gangster he has tried for income tax frauds, announced that he was ready for the supreme test against Capone.

The indictments constituted but one of a series of blows the government has struck at Capone, whose income from his liquor, vice and gambling interests are reported to have reached enormous sums. Within a few hours after the news of Capone's indictment became public, Sam Guzik, one of his lieutenants, was on his way to the federal penitentiary at Leavenworth, Kans., to serve a sentence of a year and a day for an income tax violation.

Almost simultaneously federal agents announced they had broken up what they referred to as a subsidiary of the Capone liquor syndicate, with the arrests of 20 men in Illinois and Iowa.

When Capone surrendered he was nattyly attired as usual, wearing a grey suit, black shoes, a white shirt, a black tie and a new straw hat, but for the first time in his infrequent courtroom appearance he appeared to have lost his smile. He said there was "nothing to it" when questioned about a rumor he would plead guilty.

Capone is already under a six months sentence on a charge of contempt of court for failure to return to Chicago in 1929 for trial. Appeal is pending.

Asheville, N. C., June 6.—(AP)—Miss Elizabeth Lee, of Black Mountain, today was selected by Buncombe County Commissioners as the official Buncombe county sponsor for the rhododendron festival here, June 24, 25 and 26. This is the first year the county has named a sponsor for the annual fête.

Miss Lee, daughter of Mrs. Cora L. Lee, was chosen by the commissioners as the most beautiful girl in the county.

She was born in Lakeland, Fla., but the family moved to Black Mountain when "Miss Buncombe County" was an infant. She was educated at Black Mountain High School and at Brenau College, at Gainesville, Ga.

NEGRO SCHOOL CLOSSES HERE

Prominent Educators Spoke at Commencement Exercises on Thursday Night.

Commencement exercises of the Greenville colored school were brought to a conclusion with appropriate exercises in the auditorium of the colored Methodist church last Thursday evening.

The principal speakers were Dr. N. C. Newbold, of the Negro Division of Education who was invited by Principal C. M. Epps to give the correct information as to what North Carolina is doing for her negro citizens and the evident results, and Charlotte Hawkins Brown, president of Palmer Memorial Institute, Sedalia, N. C. Born in North Carolina and transplanted while young to New England and there trained, this leader of education returned in after years to the Old North State to labor in a rural community for the Congregational church. Like the late Booker T. Washington, she has established with New England support, the finest institution for negroes in the state. She has preached the gospel of "good will" and expressed her appreciation of the support given her by the outstanding men and women of the white race.

Principal Epps said he was proud of the speakers and their happy manner of presenting such needed advice and information to the graduates and their parents.

The principal expressed his appreciation of the large attendance of white people. J. L. Little, chairman of the board of trustees of city schools, awarded standard diplomas to the twenty-two graduates and nineteen seventh-grade students were sent to the high school. The farewell address was made by J. H. Rose, superintendent of city schools.

HONOR STATE SENATOR

DR. POTEAT MAKES FINALS SPEECH HERE

Seventy-Nine Students Awarded Diplomas at High School Closing Exercises.

Discussing the lack of knowledge existing among the people today, Dr. William Louis Poteat, president emeritus of Wake Forest college, last night delivered the annual address before members of the graduating class of Greenville high school in the campus building of East Carolina Teachers college.

The speaker confined himself largely to the field of science where scholars are constantly searching for the great truths of life, and his sparkling sense of humor brought forth many a ripple of laughter. The address was a complete departure from the customary final oration, and instead of containing warnings concerning the pitfalls of life, urging the students to continue their search for the inexhaustible truths of life, constantly unfolded by science.

Even in this day of scientific development, he declared, there are people who believe in superstitions. He pointed to the countless numbers who shiver at the mention of "13," black cats, and last but not least, those who consult astrologers and palmists concerning future life.

"Why, I can tell more about a man by the creases in his breeches than the lines in his hands," the speaker asserted.

Referring to the prevailing provincialism in America, he scored the U. S. Senate for its stupidity in matters dealing with the world court, declaring it should be provided with a kindergarten. He said it was foolish to keep this nation aloof from the other powers of the world when its influence was needed to help solidify the bonds of brotherhood. He described as foolish the opinion that adherence to the world court would compromise the independence of the country.

He "impressed upon his hearers the fact that they should not only know what they can do, but also what they can't do, believing that would inspire them to search for the things which have not yet been revealed by scientific research.

Dr. Poteat said the great scientists say that science cannot discredit faith in the realm of reality to which methods and apparatus are inappropriate. He declared the beauty and glory of nature suggest the Infinite, that the Heavens declare the glory of God. He said his thought of science as walking in God's garden, informing itself of the beauty and glory of life, and attempting to gain a more complete realization of the greatness of life.

Dr. R. H. Wright, president of East Carolina Teachers College, introduced the speaker of the evening as a man who had written his ideals into the hearts of thousands of men and women throughout the state. He said he was one of the truly great educators eternally seeking for the truth and endeavoring to produce a higher type of civilization.

The address was the crowning feature of the closing exercises, commencement season and was heard by an audience that packed the auditorium to capacity and overflowed into the balconies. Seventy-nine students received diplomas from the hands of J. L. Little, chairman of the board of trustees of the school. The class, although as large as last year, is considered one of the record classes of the school.

J. H. Rose, superintendent of schools, summed up some of the achievements of the schools during the past year, and pointed with pride to the rating which placed the school as head of the state system from the standpoint of scholastic rating, although it is far below the line compared with larger towns from the financial viewpoint. He also told of the achievements in the field of music, writing and sports, and said the schools had received considerable recognition in these branches of endeavor.

He announced that the Keech distinguished service cup, offered by last year's graduating class in the best all-around pupil, had been won by Miss Mary Shaw Roberts. The young lady was called to the platform and presented the cup. The award was given by last year's class in recognition of the splendid services of J. H. Keech, retiring principal.

Jim Slay and William Tolson, two of six North Carolina youths who won out in the essay contest conducted by the American Chemical Society, were each presented \$50 in gold given by the society in recognition of their achievement.

Mr. Rose also announced that William Nesbit had been declared winner of \$10 in gold given by the Woman's club to the student making the highest scholastic record and presented the award.

PERSONNEL HEAD NAMED

Frank Dunlap to Have Supervision Over All State Employees, It is Announced.

Raleigh, June 6.—(AP)—Frank L. Dunlap, Wadesboro attorney and four times a member of the state senate, today was appointed state personnel director by Gov. O. Max Gardner.

For sometime it had been generally understood that Mr. Dunlap had been offered the position but the official announcement was not made until today, when Governor Gardner returned to his offices after spending a week at his home in Shelby.

The position of personnel director was created by the 1931 General Assembly. The director will have supervision over all state employes.

"I have appointed the Hon. Frank L. Dunlap as personnel officer," a statement issued by the governor said. "He is well qualified for this important position."

"He is thoroughly familiar with all departments of the state and its institutions by reason of his service in the General Assembly as chairman of the Senate finance committee.

"He has one of the most difficult and at the same time most important jobs of any man in the public service of the state. His sincerity, honesty and sense of fair dealing equip him splendidly for the responsibilities of this office."

Drowned Youth to be Buried Sunday

Asheville, June 6.—(AP)—Funeral services for Dewey Cordell, 11, son of Mr. and Mrs. John Cordell, of West Asheville, who was drowned in the French Broad river Tuesday afternoon, will be conducted at Swannanoa Baptist church at 2 o'clock tomorrow afternoon. Interment will be in Piney Grove cemetery in the Swannanoa community.

Dr. John L. Carroll, county coroner, said today that no inquest would be necessary. There is no evidence except that the child was drowned in an accidental manner while swimming.

"The body was brought to the surface near Carrier's bridge yesterday afternoon after a dynamite blast had been set off in the river.

German Envoys Are Pleased With London Welcome

London, June 6.—(AP)—German envoys of cooperation, Chancellor Heinrich Brüning and Foreign Minister Julius Curtius, were well pleased today with England's welcome to the conference with British officials on the problem of war reparations.

After a reception at the foreign office they said their first day in London was "eminently satisfactory" and had proved to them that England was Germany's friend.

Prime Minister Ramsay MacDonald presided, offering toasts to King George and President Von Hindenburg, and Foreign Secretary Arthur Henderson and other cabinet ministers entertained them.

The London newspapers take the position that Great Britain has forgotten far-time animosities and favors friendly relations with the German state but that she cannot act alone in the matter of reducing reparations payments.

ABOUT TOWN

Announcement that the State Bank & Trust Company, new institution to take over the old National bank, will open in the next thirty days is the best news the people of this city have heard in some time.

That the bank has a bright future is not to be questioned. This was the opinion expressed by E. G. Flanagan at the meeting of stockholders here yesterday.

Mr. Flanagan is in a position to know what he is talking about by reason of his actual contact with the financial life of the community for many years. Those engaging in organizing the new institution are to be congratulated for the splendid spirit exhibited throughout the signing of the documents.

It was largely through their diligence that the opening of the new bank will become possible. It is not to be doubted that the people will rally to the support of the organization, realizing as they do its preference to some outside interests.

J. C. B. Ehringhaus, of Elizabeth City, addressing a group of business men from various sections of the state here sometime ago, urged the business men to build from within and not from the outside in securing the financial life of the community.

It is the effort of the home town men that results in the progress and development of community life. Greenville people have accepted the advice of this leading lawyer and statesman of the Pasquotank district, and the advice finds a counterpart in a significant way in the organization of the new bank.

Now that the aldermen have called an election to vote on the question as to whether or not Greenville shall issue \$100,000 in bonds to finance the purchase of the local gas plant, the people should begin gaining all possible information concerning the proposition.

The Board of Aldermen and several other prominent citizens attending the session of the city fathers during discussion of the purchase, are heartily in favor of the project, and believe it will mean much to the future of Greenville.

Members of the Water & Light Commission have expressed opinion that they would be able to operate the plant successfully and earn an appreciable revenue for the city each year.

Comparative figures compiled by D. S. Spain, chairman of the Water & Light Commission, show that municipally-owned plants in Wilson and Rocky Mount have earned splendid profits each year and at rates considerably cheaper than those existing in Greenville the last few years.

The leaders in public thought seem unanimously agreed that it would be much more profitable to the city to operate the plant than to have it operated by a power company. They believe this will protect the water and light plant and give it a greater opportunity to turn back revenue for the continued progress and development of the community.

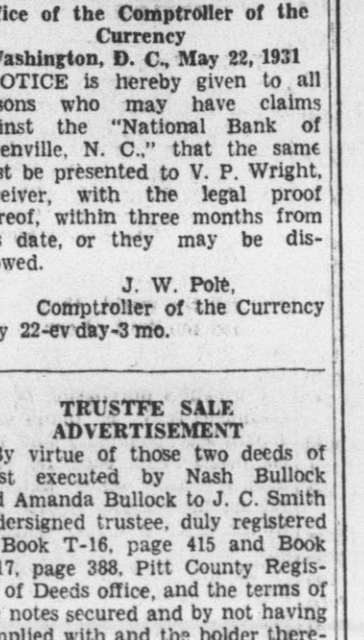

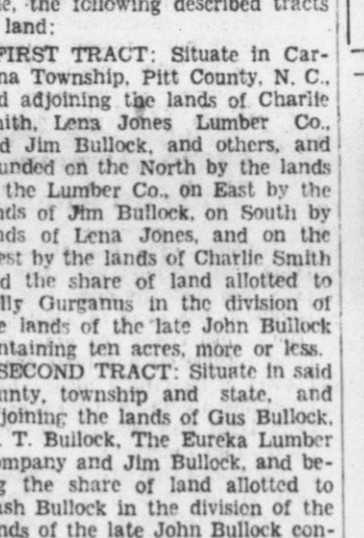

FIVE MEN KILLED IN PHILADELPHIA TODAY

Philadelphia, June 6.—(AP)—Five men, working in caisson holes 70 feet below the street level, were killed in a cave-in early today and a policeman was fatally injured when a patrol wagon, enroute to the scene, crashed into a truck.

The workmen, all negroes, were entombed at the bottom of a 30-foot caisson hole, when the 40-foot side wall of an excavation for a 32-story Central City Office building collapsed.

Five other workmen were injured and 40 endangered as tons of dirt, rock and debris fell into the pit. At the end of two hours rescue work was halted until walls of the excavation could be reinforced.

Authorities said the five men, if not crushed to death, had died of suffocation before the efforts to rescue them were halted.

The dead patrolman was Elmer Patterson, 45. He died of a fractured skull received when he was thrown to the street as the patrol wagon swerved into a telegraph pole after striking the truck. Three other patrolmen were slightly injured in the crash. Louis Marchel, 23, driver of the truck, escaped injury.

Oppose New Theory Concerning Lincoln

New York, June 6.—(AP)—A woman biographer, a German historian and a psychiatrist, all widely known, were on record today as opposed to Dr. A. A. Brill's theory that Abraham Lincoln was a "schizoid-maniac" personality.

Dr. Brill's contention that Lincoln was a Dr. Jekyll and Mr. Hyde, who succeeded in keeping his baser nature under rigid control was disputed by Ida M. Tarbell, Emil Ludwig, and Dr. L. Pierce Clark.

Miss Tarbell said she never was able to trace to Lincoln any story that could not be repeated to decent-minded persons. Dr. Brill claims Lincoln had a low taste in humor which descended to the obscene.

Market Report Cotton--Stocks--Grain

N. Y. COTTON

New York, June 6.—(AP)—Cotton opened barely steady today, 13 to 16 points lower under quite active selling by houses with foreign connections and local liquidation, and in response to a show of weakness in the Liverpool market as well as continued favorable weather over practically the entire cotton belt.

The December price declined to 8.99 and around this level, the market encountered a fair amount of trade buying and week-end covering which served to check the decline and brought about a moderate reaction, December working up to 9.04. The action of the stock market served to discourage new buying but the volume of selling after the opening was not large and the undertone was slightly steadier.

Liverpool cabled that the market there had declined under local, continental and general liquidation, and owing to a poor offtake while Manchester was unsettled and the cloth and yarn buyers cautious. Cotton on shipboard awaiting clearance was reported at about 65,000 bales compared with 66,000 a year ago.

Chicago, June 6.—(AP)—Notwithstanding that an authoritative summary said the Canadian crop situation was the worst at this season in 29 years, wheat prices today showed weakness. The chief reason was that the report asserted one good soaking rain within a week would materially alter the outlook. Another bearish factor was scantiness of fresh export demand for wheat from North America.

Wheat closed unsettled, 1-8-3-4 cents lower, corn 1-4-1-2 down, oats 1-8-3-8 off, and provisions unchanged to 12 cents setback.

STOCK MARKET

New York, June 6.—(AP)—Week-end profit-taking and renewed short-selling ate a hole into the stock market's advance today. Sales exceeded 700,000 shares.

Prices were off at the opening, but the dullness of trading on this reaction was followed by a steadier tone as the first half hour was passed. Offerings came in steadily, if slowly, however, and the market worked slowly during the balance of the two-hour session. Trading seemed governed by technical conditions rather than by any outside influence.

All groups participated in the decline, which was sharpest in the rail stocks. The range was about 1 to 3 points for pivotal issues.

The statement by Chancellor Bruening in London regarding Germany's financial position and the imposition of a "crisis tax" by the Reich government caused some uncertainty. Plans of the railroads to coordinate efforts to obtain higher freight rates, amounting to perhaps 15 percent in order to provide a ten percent rise in revenues, left the market lukewarm, and it was apparent that the news had been discounted marketwise.

Grains opened firm but reacted later on profit-taking.

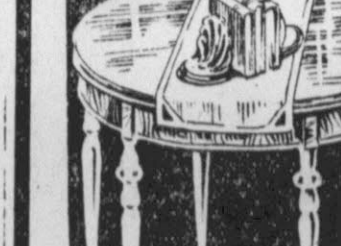

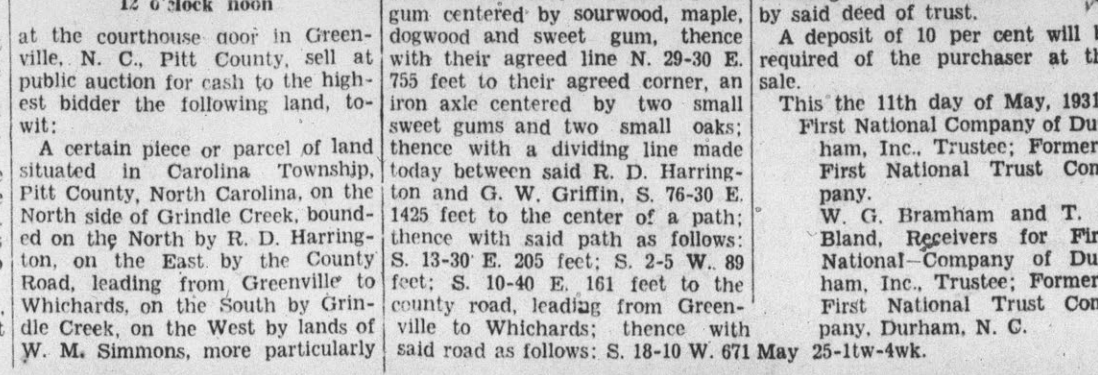
