## SEEKS TRUTH IN THE DEATH OF HER SON

### Mrs. J. C. Boykin Employs Legal Assistance to Aid Coroner's Investigation.

Raleigh, July 7.—(AP)—The Raleigh Times in a special story from Clayton says this afternoon that Clawson Williams, solicitor of the Fourth Judicial District, will personally examine witnesses when Coroner J. H. Kirkman holds an inquest to attempt to determine the manner of the death of Jesse Williams, who died of a gunshot wound in the breast, June 26.

The story says Mrs. J. C. Boykin, mother of Williams, sought legal assistance because she wanted to find out the truth about the death of her son.

James Daniel Parker of Smithfield, whom she consulted, requested Solicitor Williams to examine the witnesses and the solicitor consented to do so, the story says.

Williams was chairman of the Johnson County Democratic Executive committee. His wife, according to a physician who reached the home a few minutes after Williams died the night of June 26 or early morning of July 27, said her husband shot himself.

Members of the coroner's jury, after viewing the body, stated they saw no evidence of powder burns.

Mrs. Boykin, the story says, was interviewed at her home in the Archer Lodge community of Johnson county and stated:

"I'll never believe that Jesse killed himself. He was too jolly, always making jokes. I never will believe it."

The coroner's jury met twice one time to view the body and again a week after Williams' death but no verdict has been announced. No date has been announced for a further hearing.

## Continue Probe Of Woman's Death

Aiken, S. C., July 7.—(AP)—Aiken county officers redoubled their efforts today to learn whether Mrs. Bertha Collins, of Cloverville, was slain, brutally last Saturday night, or whether she was a victim of a hit-and-run automobile driver.

Four persons have been arrested during the investigation. Two of them were later released. All admitted having been with the 32 year old woman at one time or another the earlier part of Saturday night but denied having been with her within hours of the time her death occurred.

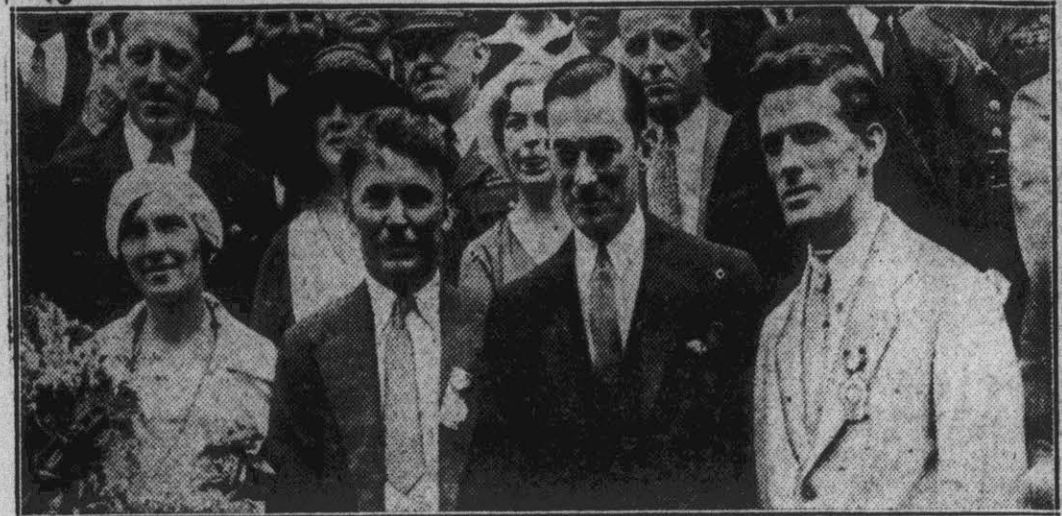
A passing motorist found Mrs. Collins' crushed body on the Augusta highway a few miles from here about 4 A. M. Sunday.

## Farm Boy Confesses Slaying Merchant and Then Firing Store

Monroe, La., July 7.—(AP)—Dawson W. Crowson, 18 year old farm boy confessed to police today that he shot and killed Ira Castles, 60, a merchant, and set fire to his store, last night after Castles refused to lend him five dollars to buy his sweetheart a box of candy. The youth fled after setting fire to the store but returned to the smoking ruins some while later and surrendered.

## MAN JAILED FOR SHOOTING

### Johnnie Stepp Believed Fatally Injured by Roscoe Wainwright During Argument.

Roscoe Wainwright, Farmville painter, was lodged in the county jail here yesterday charged with shooting and probably fatally wounding Johnnie Stepp during an altercation in Marlborough, about a mile from Farmville, last Saturday.

Stepp, who was brought to the hospital here immediately after the shooting, was described as dangerously wounded and little hope was held out for his recovery. An entire load of gunshot was fired into his thigh, almost completely shattering that section of the body.

Wainwright and Stepp were said to have disagreed over some work which they had previously done. When the argument reached its height, Wainwright was said to have gone home, obtained a shotgun and returned to the scene of the verbal engagement. When the argument was resumed, he was alleged to have fired upon Stepp.

Walter Stepp, brother of the injured man, was said to have attempted to intervene, but was hit across the head with the gun barrel by Wainwright. His injuries were said to be of a painful nature.

Wainwright was non-committal when placed in custody, but it was understood that he would plead self-defense when the case comes up for hearing. He will be denied bond pending the condition of Stepp.

## Mocksville Scout Saves Another Life

Coltlemee, July 7.—(AP)—Two lives that might have been sacrificed to searing flames and treacherous water have been saved by Everett Walker, 14-year-old Mocksville Boy Scout.

When Walker dived into Dutchman creek near here after three men had failed to bring the unconscious body of Boone Stone-street, Mocksville mail carrier, from its 14-foot bottom, it was the second time in his life he had faced possible death to save another.

Walker brought Stone-street to the surface and, with the aid of others, carried his body to the shore.

Stone-street's lungs were partially filled with water and Walker used his knowledge of resuscitation to revive him.

Walker was awarded the Boy Scout Life Saving Medal for his heroism in rescuing a younger brother from the flaming Mocksville hotel when that hostelry was burned last October.

The blaze was discovered at 3 A. M. Walker and his brother were sleeping in an upstairs room, the lower part of the building was filled with fire and smoke but he managed to drag his little brother to safety. Both were badly burned and Walker remained in a hospital two months before he had fully recovered.

## State Deficit Over \$2,000,000

Raleigh, July 7.—(AP)—North Carolina ended the 1929-31 biennium June 30 with its general fund \$2,250,064 "in the red"—a deficit of approximately \$1,000,000 than had been estimated last December.

Gov. O. Max Gardner, in announcing the deficit yesterday, said it was brought about by failure to realize estimates of revenue and "due, of course, to the distressful economic and business conditions."

## FATALLY HURT DURING FIGHT

### Albermarle Man Held For Slaying Member of Fishing Party On Yadkin River.

Albermarle, July 7.—(AP)—Guy Johnson, of Kannapolis, was fatally injured during a fight between members of a fishing party on the banks of the Yadkin river, near here, last night.

Eddie Page, who is charged with striking Johnson with a bread paddle, was being held in jail in connection with Johnson's death. W. H. Coe, John Watt and Mrs. E. W. Phillips were ordered held as material witnesses. All are of Kannapolis.

Testimony at an inquest was that Johnson had been disturbing the party and when Page sought to quiet him, he struck at Page with a bottle. Witnesses said Page then swung at Johnson with the bread paddle.

The blow broke Johnson's neck. He died on the way to a physician's office in New London.

## REPORT NEW PLANETOID

### Kyto Astronomical Observatory Discovers Heavenly Body Larger Than Earth

Kyoto, Japan, July 7.—(AP)—The Kyoto Astronomical Observatory announced today the discovery of a new planetoid. The heavenly body was calculated to be 11,000 miles in diameter, or somewhat larger than the earth. Its distance from the earth was figured at 180,000,000 miles, or somewhat less than twice the distance from the earth to the sun.

Its position was given as in the area south of the "Snake Charmer" constellation.

Pasadena, Calif., July 7.—(AP)—Dr. W. S. Adams, head of Mount Wilson Observatory, said today he doubted the discovery of a new planetoid of the size and distance from the earth as that described in dispatches from Kyoto, Japan.

"It seems impossible a planetoid of that size and but 180,000,000 miles from the earth could have escaped discovery before," said Dr. Adams. "This one is calculated to be 11,000 miles in diameter. The earth and Venus are around 8,000 miles in diameter, so this would make the reported new planetoid considerably larger than either. Its size would make it a planet rather than a planetoid."

## Seventy-Four New Physicians Pass The State Board

Raleigh, July 6.—(AP)—Seventy-four new physicians—all who took the recent medical examination—held licenses today to practice in North Carolina.

The licenses were awarded yesterday by the State Board of Medical Examiners. Dr. John W. McConnell, secretary of the board, said it was the second time in the history of the state that all who took the examination passed.

In addition to the 74, thirteen were issued licenses by endorsement of credentials from other states, making a total of 87 to receive licenses.

## SETS RECORD ON POTATOES

### Live at Home Farm Produces 160 Barrels to the Acre During Present Season.

In addition to demonstrating the live-at-home idea as enunciated by prominent agricultural leaders throughout the State, the State Live-at-Home farm on the Greenville-Bethel highway has established something of a record in the production of Irish potatoes during the present season, it was revealed today.

On two acres of land the farm produced 'spuds' at the rate of 160 barrels to the acre, including 20 barrels of No. 2s. The normal yield per acre, it was said, is around 60 barrels, which gives the farm a record that others may shoot at a long time before surpassing.

The farm had a total of 45 acres of potatoes under cultivation this year, and has already marketed 2,500 barrels of No. 1's, with an unestimated number of barrels of No. 2's yet to be disposed of.

The farm also expects to produce a bumper crop of sweet potatoes this year, and the first shipment is expected to be made around the middle of August.

Thirty-three acres of potatoes are under cultivation at this time, and if expectations are fulfilled this will yield around 50 bushels to the acre. The average production per acre in this country is estimated at approximately 30 bushels to the acre which will give the farm a clean gain of 20 bushels per acre over the general county average.

Other sections of the farm are confined to the cultivation of crops carrying out the live-at-home idea and show in an impressive way what can be accomplished in the various fields of agriculture.

The farm, embracing about 300 acres of fertile land, was established last year at the suggestion of Governor O. Max Gardner as a means of more fully impressing upon the growers the importance of raising more of the things which they consume at home. Scores of farmers have already profited by the plan and it is probable that Pitt county will produce more food crops this year than in any other year in the last decade.

## Drag River For Body Drowned Man

Goldboro, July 7.—(AP)—A search for the body of Clinton Lovett, 24, who drowned in Little River last night, was renewed here today.

Lovett, Southern Railway employe, was wading in the river, swollen by recent rains. He stepped in the channel and went down. Lovett was considered a good swimmer and Frank Moyer, his companion, said he believed he had been seized with cramps.

## FOREST FIRE RAGES IN CAL.

### Property Valued at \$1,000,000 Destroyed as Flames Sweep Stricken Areas.

San Francisco, July 7.—(AP)—Flames left, blackened wastes in more than a dozen different parts of California today as hundreds of weary fire fighters continued efforts to subdue the blazes in heat-stricken hills and plains.

Mountain towns, ranch houses, herds of cattle, stands of timber, ripened grain and valuable pasture fell before the onslaught of fire yesterday and early today.

A force of 700 men used every possible fire fighting trick in an attempt to control a 25,000 acre blaze which swept up three sides of Mount Diablo, Contra Costa county. Early today damage was estimated by fire officials at \$100,000. Several stands of timber and 500 head of cattle were destroyed.

The fighters were attempting to keep the blaze from Marsh Creek Canyon, on the west slope of the mountain, where dozens of summer homes and ranches are located. The blaze at some places burned on a 14-mile front.

Four dwellings and the school house at Birchville, Nevada county, were burned.

State Forester M. E. Pratt announced that danger had been lessened by higher humidity and officials looked for the situation to be brought under control today.

Pratt has launched a campaign against incendiaries. One man was arrested on a charge of setting eight fires in Tehama county.

## Police Investigate Killing of Child

Charlotte, July 7.—(AP)—The mystery of who shot and killed 10-year-old Martha Pearl Carter today occupied Charlotte police officers.

A bullet struck the child in the neck last night as she was playing with a group of other children near her home here. She died almost instantly.

The officers said the shot came from a pistol in a car parked nearby. They said they believed the shooting was an accident but they did not know who fired the bullet.

J. F. Doster, owner of the automobile, told officers he left a loaded pistol in the rear seat while he and his wife went to visit friends in an apartment on the street. Investigating after the shooting disclosed that one shot had been fired and the barrel smelled of freshly burned powder.

The authorities questioned the small playmates of the Carter child. They said they heard the report and saw a flash but did not know who fired the fatal shot.

## Conference of Experts Sought in Paris To Work Out Technical Details of Moratorium; British Gov. Renews Invitation For Conference of World Powers Chiefly Concerned; Agreement Between America and France Hailed With Delight Both in Europe and at Washington City.

Paris, July 7.—(AP)—The Havas News Agency announced tonight that the French government has accepted the British suggestion, transmitted by Lord Tyrrell, British ambassador for a meeting of treasury experts in London next week.

Negotiations already have started in Paris for a conference of experts to work out the technical details of applying President Hoover's moratorium plan, and the British government has renewed its invitation for a conference of the world powers chiefly concerned.

In all the capitals of Europe and at Washington the agreement between France and the United States was received with great satisfaction. London is of the opinion that much remains to be done, and Rome has expressed that it is ready to participate in any conference regarding operation of the plan.

The German government in a proclamation today promised that the money released by the moratorium will be used only to assist the country's economic recovery, warning the German people that they must economize now as never before.

At Washington, President Hoover announced the agreement with obvious pleasure and the State department has gone to work on the mass of detail which probably will occupy it for weeks.

Stock markets in all large cities reacted favorably to the announcement; of the accord, with prices rising in Paris, London, Berlin and New York.

Washington, July 7.—(AP)—The French and American governments are in agreement on the principal of President Hoover's plan for a year's holiday in international debts.

The accord was announced late yesterday by the Chief Executive at the White House. It brings every important creditor nation into agreement, thus uniting the former allies of the World War in a fight for general economic relief by a postponement of debt growing out of the four year conflict.

The agreement was reached 11 days after negotiations between the French government and Ambassador Edge and Secretary Mellon in Paris.

It constituted the acceptance by the United States of a formula offered by the French. It recalled the viewpoints of the two governments between the American position put forward in the president's plan and the French counter-proposals.

In the negotiations for a settlement many extraneous points, even some considered by the United States outside its province to settle, had arisen. These were adjusted amicably to the satisfaction of each.

Each side yielded points. Details which will make the agreement finally effective will be worked out by experts. Their work will be technical in character, but their results within the spirit of the Hoover proposal. In insisting on this instruction to the experts, the United States officials explained that decisions on method of procedure should not place burdens on Germany's treasury.

Weeks will be required, in the opinion of American officials, in the working out of the details. Meanwhile, the State department turned its attention raised by other countries, permitting their approval of the American position with regard to Rumania raised the loans. Each of the citizens who registered had in mind at the time an opinion either for or against the issue and it is to those citizens who now oppose the issue that we address ourselves.

As we have repeatedly stated, we are heartily in favor of the purchase of the plant by the city and have reasons therefor and if you are opposed to the purchase you, no doubt likewise have reasons for your stand. Therefore, we invite every person opposed to the issue of the bonds and the purchase of the gas plant by the city to come in and give their reasons for their stand, or write in if you prefer, and we will endeavor to show benefits to our city by the purchase, to more than offset your objections. Naturally you believe your stand to be to the best interest of our city and all concerned, of course we believe our stand in the matter to be the same. Now here is the opportunity for us to discuss this matter frankly and see just where we stand. We will not use your name in connection with answering your objections but will try to set forth clearly for the benefit of all the voters your objection together with our answer. News of the moving of headquarters of the district State Highway patrol to Greenville is a matter of much pleasure to the people of the community. The action not only means that this will be the central point for the operation of the district patrol, but that numbers of extra families will be brought here for permanent residence.

The district patrol is under supervision of Lester Jones, former chief of police of Greenville, who has been very active in development of the service since the patrol was conceived a few years ago.

Greenville is always glad to welcome the members of an organization of this kind and hopes they will find their residence here both pleasant and profitable.

The fact that Greenville passed unscathed through the Fourth of July should be a matter of much joy in face of the five hundred deaths which occurred in other sections of the nation during the two-day celebration.

It indicates that the people of this section have learned how to observe the birth of the nation in a sane and sober way thereby avoiding the horrible toll of death and destruction noted in other sections.

The observance of the Fourth is to be highly commended, but not at the sacrifice of human life. One may celebrate without carrying it to the extreme, and if this fact were kept forever in mind the list of death would be greatly decreased each year.

Pitt county has made a splendid start toward safe observance and it should be the purpose of the citizenship to see that the spirit of sanity and safety is increased with the coming of each year.

Children continue to take advantage of the supervised form of recreation in increasing numbers here at this time, fulfilling the hope of promoters that it will prove a boon to the youngsters during the hot summer months.

During the record heat wave which swept over the nation the last several days scores of youngsters visited the Westbrook swimming pool and enjoyed cooling plunges in the pool which has been set aside for their benefit. Scores also found their way to the golf course at the corner of Washington and Fourth streets, and putted their way around the eighteen holes at the price of five cents.

The first month's operation of the playgrounds has been guaranteed by a group of business men who realized the necessity for supervised recreation, but it is up to the public to provide sufficient funds to defray expenses during the remainder of the summer.

Persons who appreciate what is being done for safe-guarding the lives of the city's juvenile element should donate liberally to the cause and make it possible to continue the playgrounds during the remainder of the summer without financial handicap.

**Something About Wiley Post, The Globe Galloper**

By the time Wiley Post had achieved his position as chief test pilot at the Lockheed airplane factory at Burbank, Calif., he had won something of a reputation as a flier.

One thing that singled the former farm boy out for attention was the fact that he became a flier after he had lost sight of one eye in a machine shop accident. He is believed by Department of Commerce examiners to be the only licensed pilot in the country who learned to fly after losing the sight of one eye.

The medical examiner who examined Post when he obtained his license in August, 1928, said the depth of perception of the remaining eye was excellent and that Post was physically well qualified to fly, recommending that he be given a license.

A special waiver was granted, which has been carried on in subsequent examinations.

The accident is believed to have made Post an extremely careful flier since he perhaps feels that any type of mishap might reflect on his faulty eyesight and result in the departments rescinding the waiver.

Post is known to his friends as a very capable pilot, but one who often flies on "hunches." Although the weather may be perfect for a flight, if his "instinct" tells him that he should not, he absolutely refuses to go up.

One tells the story that Post has no use for a certain type of plane

and that one day he was ordered to test one. He refused, saying he had a feeling something would happen.

Finally he was prevailed upon to make the flight and took the plane over the desert wastes of Arizona, where he was forced down 15 miles from the nearest house and 25 miles from the nearest town.

He landed near a pipeline which he followed to the nearest settlement, through the heat of a blistering desert sun.

It was there that his stubbornness—or doggedness—came into play, for he refused to move on in the plane until it had been equipped with a new motor. He waited there for two weeks until a new power plant had been installed and he could fly away.

His friends further say that he often flies by "sense of feel" and that on cross-country hops he would neither look at a compass nor at maps. Fortunately he did not rely upon this system on his world trip, for at times over stretches of the flight, the instruments of Navigator Harold Gatty were all that saved the intrepid pilots from serious deviation from their course.

Wiley Post is known as something of a "daredevil" although he has never been known to take any chances until the groundwork has been laid thoroughly. Perhaps the "daredevil" description is a hang-over from the days when Wiley was wing-walking and parachute jumping with the barnstorming "air circus" in the southwest.

Post is exceptionally thorough in his preparations for any undertaking. He neither smokes nor drinks because he doesn't believe such habits fit in well with good flying. He keeps himself in good physical trim at all times and although he is but 5 feet 5 inches tall none of the mental or physical tasks of flying tire him.

Russell Pecht, who worked with Post on the coast, points out that one of the most difficult things a flier faces is taking off a ship heavily laden with gasoline.

"When a plane is heavily loaded with gas it takes tremendous exertion to get the tail up," Pecht said. "Only those who have taken 600 gallons of fuel off the ground in a ship like the 'Winnie Mae' know how a man has to push on that stick. He must have the muscles of a weight thrower and if he does not get it up, it's too bad. I've known pilots to take a Lockheed off with 600 gallons of gas and sit there in the cockpit for minutes after they are in the air almost exhausted."

Post knew what he was going up against and he prepared for it. Not by any special exercises or training, but by keeping himself in first class physical condition over a long period of strenuous flying.

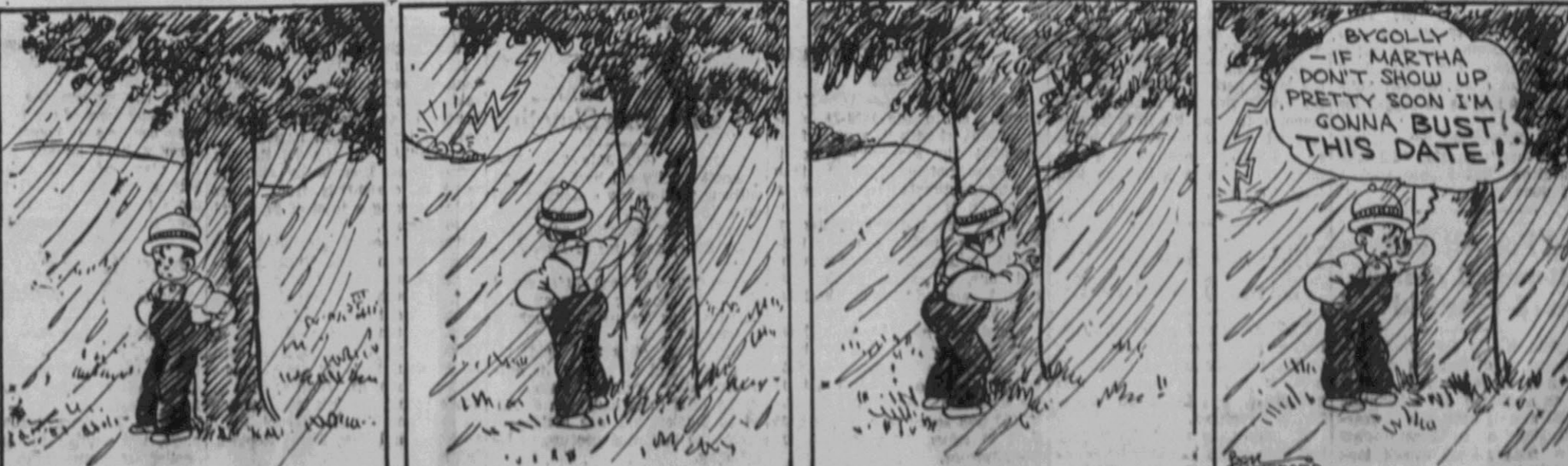
