

## OCEAN FLIERS ARE HONORED AT BUDAPEST

### Magyar and Endres Give Themselves Up to Plaudits of Their Countrymen

Vienna, July 17.—(AP)—Captains Alexander Magyar and George Endres who flew the monoplane "Justice for Hungary" across the Atlantic are to receive the Lord Rothermere prize of \$10,000 for the feat.

The British publisher today telegraphed congratulations from Baden-Baden and sent another wire to Premier Count Bethlen asking him to give the fliers the \$10,000 check representing the prize he posted for the first flight from the United States to Hungary.

Budapest, Hungary, July 17.—(AP)—Focusing the world's spotlight on their native land with the first trans-Atlantic flight from America to Hungary, Captains Alexander Magyar and Geo. Endres gave themselves up today to the plaudits of their countrymen.

They landed the monoplane "Justice for Hungary" near the village of Bicske, 14 miles from Budapest, at 7:40 P. M. (1:40 P. M. EST) last night, missing their goal by the scantiest of margins because their fuel ran out. They had flown 3,239 miles from Harbor Grace, N. F., in 26 hours and 22 minutes since Wednesday noon after a short hop from Roosevelt Field, N. Y., on Monday.

Their plane came down in a forced landing by the side of a railroad track, damaging the propeller and one wing but inflicting no injury on the pilots. They crawled out and telephoned the news of their arrival to Matyasfold airdrome. Another plane brought them to the city.

A crowd had waited to receive them but thousands had gone home in despair. The men were taken first to the home of Premier Bethlen where, and members of the cabinet felicitated them on their achievement in behalf of Hungary's rights.

Later, over tankards of beer, they told how diminishing gasoline over land and heavy storms over water had made their feat a hazardous one.

"We hardly saw anything of the ocean during the trip," one of them said. "It was wrapped in dense blankets of fog. We were overtaken by a severe storm towards midnight last night. The storm lasted three hours and shook the plane very badly."

"When we first reached Hungarian territory our fuel had nearly given out and in the neighborhood of Bicske we could not keep the motors running any longer and were forced to come down. It was a sad decision we had to make because landing but there was nothing else for it."

Captain Magyar said he was glad to be home again but he considered his companion more fortunate because he had a wife and children waiting for him. Both were in the Hungarian air force during the war and are now army reserve fliers.

They plan to remain here about a month and then make a return crossing of the Atlantic via Africa to South America. Their ship will be repaired and reconditioned before they can start the homeward flight to receive the congratulations of their adopted country.

Aviation authorities were enthusiastic in praise of the airman's piloting and navigation ability. It was pointed out that not since Col. Lindbergh made his historic hop to Paris and Coste and Bellonte backtracked the Lindbergh trail had any fliers come so close to their objective. Expert use of radio, intelligent blind flying and judicious nursing of their fuel were credited for their success.

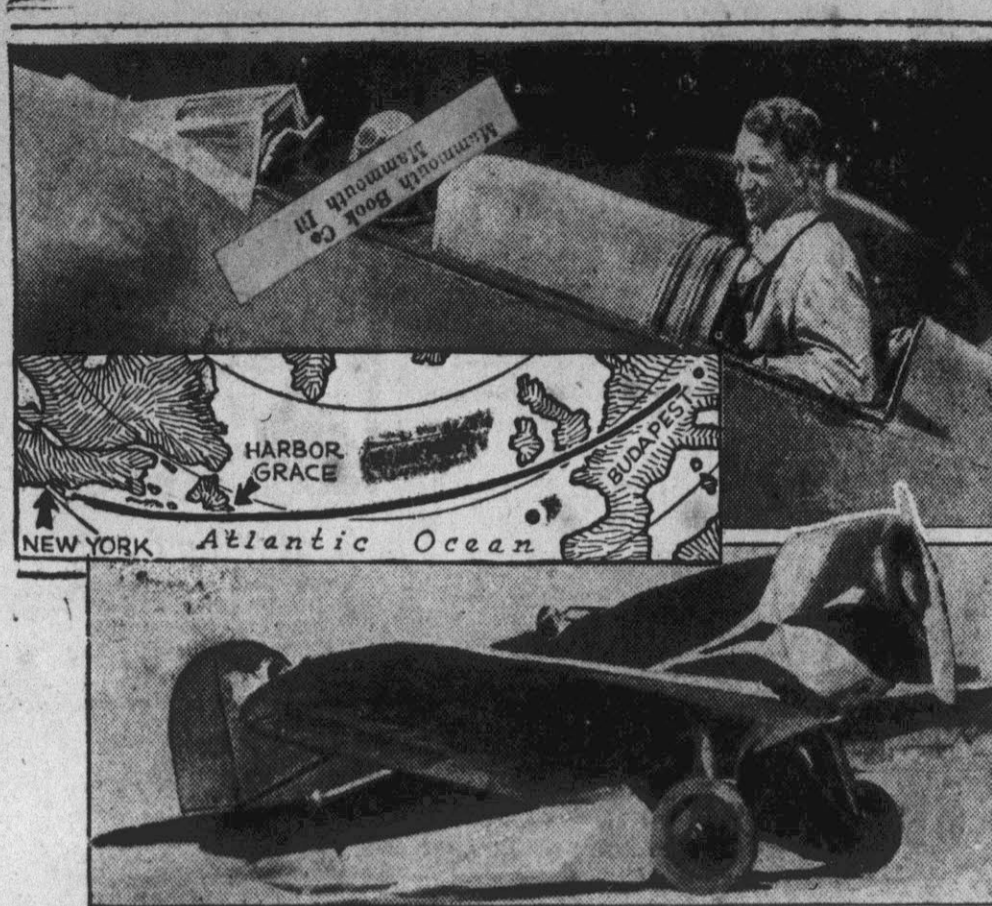
The object of the flight was to call the world's attention to what the airman considered were the wrongs suffered by Hungary by the treaty of Trianon. By that treaty her population was reduced to 7,500,000 and much of her territory was ceded to Rumania and annexed by Italy.

It was the twelfth successful eastward crossing of the North Atlantic by air and the third this summer. Wiley Post and Harold Gatty preceded them in the "Winnie Mae" on the first stage of their now famous circuit of the world and Captain Horris and Otto Mearns in the "Liberty" did the trick a few days later.

## Mellon and Stimson To Represent America At Conference In London

Washington, July 17.—(AP)—President Hoover has formally instructed Secretary Stimson to officiate active American participation in the London conference of ministers to economic issues.

The Chief Executive's instructions in Paris preparatory to his leaving for London to take part in the conference.

They followed a series of trans-Atlantic telephonic conversations direct between President Hoover and Mr. Stimson.

Washington, July 17.—(AP)—The American government will have distinguished representation at the conference Monday in London when European powers consider the plight on their central neighbors.

Secretary Mellon of the treasury and Secretary Stimson of the State Department have been designated by President Hoover to attend the conference. They are empowered to act in their discretion as to how far this government shall participate.

The Chief Executive late yesterday announced Mellon had been requested to be present provided it would not run contrary to his plans. Mellon is in southern France. Stimson now in Paris, already has made plans to attend.

The conference was called by England, France, Germany, Italy, Japan and Belgium also are to participate. Although economic questions of Europe are expected to be discussed, the White House announcement did not divulge what part either Mellon or Stimson would take in the discussions.

Indications were that President Hoover gave no specific instructions to either cabinet member. The announcement did not refer to the conference as economic in describing its purpose.

Acting Secretary Castle of the State Department, previously made known that this government planned to avoid any possible entanglements in European politics. However, Mellon and Stimson are to participate in the conference on an equal basis with the other nation's representatives, and not as observers.

In announcing this government's plans, President Hoover said: "As has already been announced, Secretary Stimson will attend the conference in London which has been called by the British government for Monday to consider the present emergency problems in Central Europe. I have asked Secretary Mellon, if consistent with his plans, also to attend in order that we may have the benefit of his advice as well."

"It is our understanding that the conference is limited entirely to the questions of the present emergency."

## SLAYER WANTS QUICK JUSTICE

### Insane World War Veteran Held for Killing Sheriff Says Nothing Matters

Charlotte, July 17.—(AP)—With blood on his shirt, bars before his face and his boy's future foremost in his thoughts, Scott Winters sat in the Mecklenburg county jail here today and mused that "nothing matters any more."

The blood was that of Sheriff Lock McKenzie, of Rowan county, whom Winters shot to death when the sheriff came to his Salisbury home yesterday to quiet the World War veteran who had threatened to "shoot up the town."

The iron bars preyed on his mind. They reminded him of other bars he had sat behind while being treated at the State Hospital for the Insane at Morganton.

"Will, it's all out and over," said the frail, thin man as he talked of his plight.

"I know I'm going to die. That'll be all right too. Nothing matters for me any more. I hope they get it over with in a hurry. I'll be hell-here in this jail—with these bars crowding around."

The bars would not have crowded around him had the two burly deputies who brought him here from Salisbury listened to Winters. "Gimme your gun," he told one of them as they marched him to his cell. "I'll end it all right now."

But they wouldn't listen to Winters and Winters wouldn't listen to pleading newspaper photographers who asked him to pose for a picture.

"I don't mind for myself," he said, "but it might reflect on my son. He's fine, just about the finest any father ever had, and I've worked for him ten long years when I should have been dead."

Then, he wasn't "dressed fit" to be photographed, he explained, and pointed out the bloody shirt and disheveled clothing.

"I hated to kill Bill," he rambled on, "he was as good a friend as I had. He fed me while I was in jail. He was good to me. I don't remember much about shooting him. I told him not to come in my house. He was going to keep me from my automobile. I was going to Charlotte. Next thing I remember he was on the floor."

Winters was "going to Charlotte" to "shoot up the veteran's bureau" here he told his wife. That's why she called Sheriff McKenzie and his deputy Arthur Shurtz.

## FIX DETAILS FOR RELIEF OF GERMANY

### Minor Parts of Plan Worked Out By Negotiators at Paris This Morning

Paris, July 17.—(AP)—American, British and French representatives today straightened out some of the details of the plan they evolved yesterday for extending financial aid to Germany, and interrupted their negotiations pending the arrival of Chancellor Brüning and Foreign Minister Curtius of Germany, who are expected tomorrow.

Secretary of State Henry L. Stimson, who attended with Ambassador Edge, said there wasn't any time to talk when he came out of the conference for lunch, and an official statement of the proceedings said merely that Germany's position was under discussion.

Nothing was said about Monday's conference of ministers in London, but there appeared to be some doubt as to whether that meeting will get under way on schedule.

It is understood that the French want to straighten things out with the German statesmen before going on to London, but it is not likely that there will be time for a general meeting of the German, French, British and American representatives here before Monday.

Today's meeting, it was believed, was concerned with financial arrangements for the \$500,000,000 foreign credit which is understood to have been proposed for Germany.

The outlines of the scheme are understood to have been sent abroad. (Continued on page four)

## WORLD FLIERS READY TO GO

### Pangborn and Herndon Have Narrow Escape in Attempted Take-Off Today

Roosevelt Field, July 17.—(AP)—Clyde Pangborn and Hugh Herndon who narrowly escaped crashing in an attempted take-off early today, announced shortly afterward that they would hop for Harbor Grace, N. F., about midnight, and from Harbor Grace to Moscow.

Their ambition is to lower the world-girdling mark of Post and Gatty.

In this morning's attempt their heavily laden plane ran down the full length of the 4,800 foot runway, went over an embankment onto Roosevelt Field No. 2, and still failed to rise.

The fliers dumped 600 of their 850 gallons of gasoline to save themselves from crashing. Their plane, suddenly lightened, leaped into the air and barely cleared a hangar, several electric light poles and high tension wires.

They circled around the field and flew back to the runway position.

They landed on the runway and taxied the plane back toward their starting point.

An escort plane, which took off when they started, with Mrs. Dixon Boardman, mother of Herndon as a passenger, landed before the Big Red Bellanca. Mrs. Boardman scrambled out of the escort ship and stood awaiting her son and Pangborn to bring their plane back to the hangars.

# One Killed And Five Injured As Negroes Clash With Officers

## Wealthy Tarboro Man Found Dead In Bathtub

### Body of Mabry Hart Discovered By Firemen Following Small Blaze in His Room at Carolina Hotel at Raleigh; Had Staged Wild Party; Two Women Held

Raleigh, July 17.—(AP)—B. Mabry Hart, wealthy Tarboro cotton manufacturer, was found dead in a bathtub in the Carolina Hotel early this morning following a small fire which was confined to his room and the outer hall.

Coroner L. M. Waring said he had learned that Hart was alleged to have been drinking last night and to have been one of eight persons on a "wild party" which started last night and ran well into this morning.

A formal inquest was set for 3 o'clock this afternoon while the coroner worked all morning in his investigation.

As a result of his preliminary investigation the coroner ordered two young women, Julia Clark of Kinston and Norma Brewster of Tarboro, held for the inquest. The two young women occupied the room next to Hart's.

The coroner said several hours after he started his probe that it appeared Hart was either overcome by smoke or fumes of the fire or was a victim of a heart attack. No evidence of foul play was discovered in the early investigation, Mr. Waring said, though he was still endeavoring to determine the cause of the fire.

An autopsy performed on Mr. Hart's body revealed no evidences of foul play, though it was at first thought there was a slight abrasion on his scalp, the coroner said. No traces of poison were found.

## GRIST MAY SUE PAPER

### Treatens Court Action As Result of Sarcastic Editorial in Greensboro News

Raleigh, July 17.—(AP)—Frank D. Grist, state commissioner of labor and an announced candidate for the United States Senate in opposition to Senator Cameron Cameron Morrison, today telegraphed the Greensboro (N.C.) Daily News that he would consider bringing court action against you for damages if statements made in an editorial in the paper today are not modified.

In an editorial entitled "Cam's Nemesis" the paper said in part: "Frank's an amiable chap. He would make an elegant dog catcher. Dogs would love him and could trust him unreservedly. He is honest; he is unselfish."

Mr. Grist's telegram follows: "Reference editorial Friday July seventeen entitled 'Cam's Nemesis'. Although you will not support my candidacy for United States Senate it appears that you should be fair and not refer to me in such terms as 'he would make an elegant dog catcher' and other sarcastic references. Do you think a man who suffered loss of his own blood in defense of his country in France is going to stand by and let such people as you belittle him in his desire to serve the public. Unless you modify your statement as set forth in today's paper I will consider bringing court action against you for damages."

## Protests of Blacks Against Sentencing of Eight of Their Race to Death At Scottsboro, Ala., Flares Into Warfare and One Negro Is Slain and a Sheriff and His Deputy Injured; Posse With Bloodhounds Searches for Negro Communist Organizers

Camp Hill, Ala., July 17.—(AP)—Protests of groups of negroes against the sentencing of eight of their race to death at Scottsboro, Ala., flared into warfare with Tallapoosa county authorities last night and today, and one negro was killed and a sheriff and his deputy injured; Posse With Bloodhounds Searches for Negro Communist Organizers

The sheriff, J. Kyie Young, was said by physicians to have only a slight chance to recover. The negro, Ralph Gray, was shot down in an exchange of fire last night but escaped, and was slain early today in a raid on his home in which eight other negroes were arrested.

Meanwhile a posse of 100 or more civilians and 40 officers from Here, Dadeville, Opelika, Alexander City and Wetumpka searched the county with bloodhounds for a number of negroes from Chattanooga, Tenn., who were described by the local chief of police, J. M. Wilson, as "Communist organizers."

Solicitor J. Sanford Mullins of Tallapoosa county, said further trouble was expected.

Some of the eight negroes sentenced to death in Scottsboro were from Chattanooga. They were charged with attacking two white girls who were hobnobbing on a train. The International Labor Defense, a Communist organization, has organized a world-wide protest against the death sentences on the ground that the charges were a "frame-up" and without factual basis. The case is now before the Alabama Supreme Court.

Chief Wilson said one meeting was held here Wednesday night by approximately 150 negroes who demonstrated that the governor free the Scottsboro group. The meeting was broken up last night, he said, another meeting to protest the death sentences were held and this time the negroes were armed. He went to Dadeville, the county seat, where another meeting of negroes, also in connection with the Scottsboro case was being held and at which speeches advocating social and political equality were being delivered. The sheriff's forces broke up this meeting and seized a large quantity of literature described as "inflammatory."

Enroute here the officers met Gray near the scene of the meeting and Chief Wilson said Sheriff Young asked Gray what was in a bundle he was carrying.

"It's none of your business," Gray was quoted as replying.

Then, according to Chief Wilson, Gray opened fire and Sheriff Young and Deputy Sheriff Thompson were killed, Thompson, however, not being wounded seriously.

The officers returned Gray's fire and he fell, presumably dead. He was left on the road while Sheriff Young was hurried to a hospital in Alexander City.

Later the officers were informed Gray had reached his home and had been given medical treatment. A posse immediately went to his residence and Chief Wilson said they were met by a hall of fire. Returning the fire, officers smashed down the doors, killed Gray, and arrested eight of his companions.

Chief Wilson said the number of negroes being sought today might number as high as 40.

The old warehouse was destroyed by fire one month from today, and a few days later construction work was begun on the new building. The loss was estimated at \$100,000 which was partially covered by insurance.

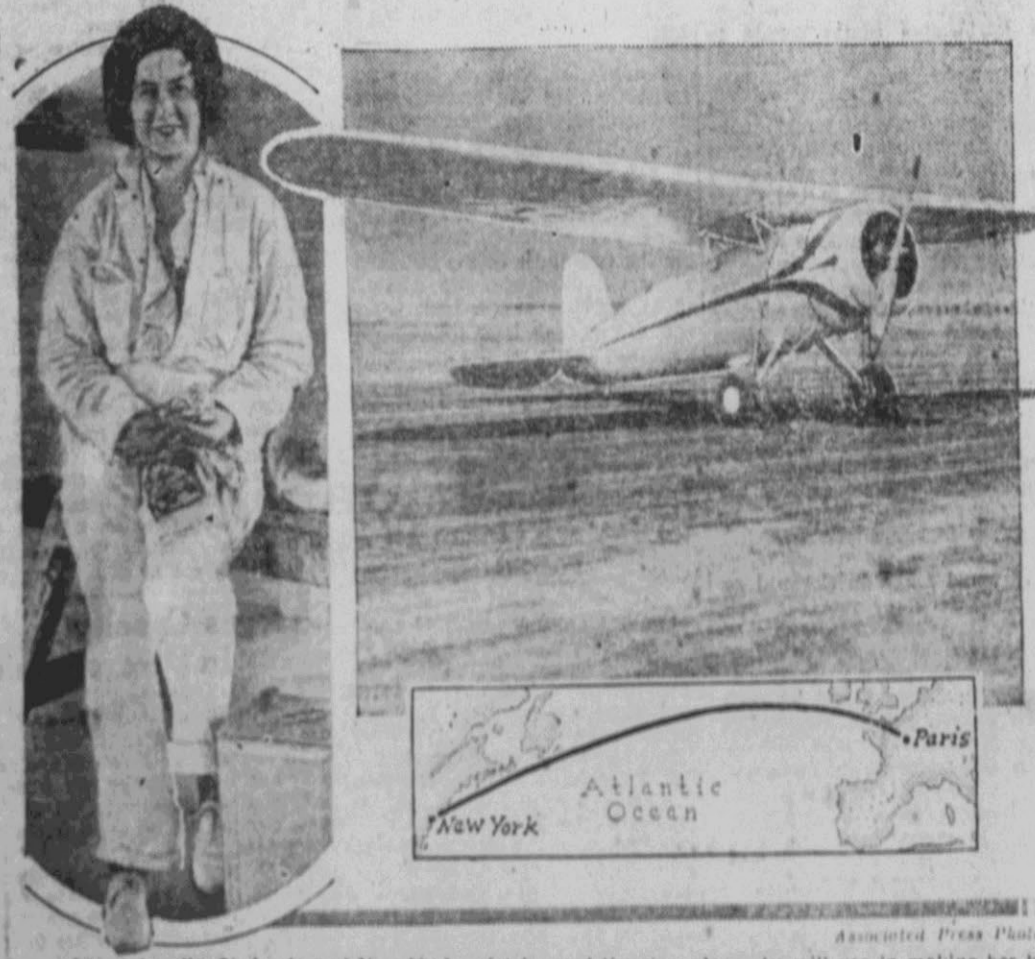

### Says the Schools Must Break Away From Their Fads

Chapel Hill, July 17.—(AP)—Robert M. Hanes of Winston-Salem, president of the State Bankers' Association, says that in his opinion the public schools have added "many fads and fancies that must be discarded as non-essential."

Speaking at the conference on elementary education here last night, Mr. Hanes said the cost of operating the schools has grown out of proportion to the increase in taxable wealth, increase in population and the ability of the taxpayer.

"I hope," he continued "it will not be necessary to lower our standards in those things that are essential and fundamental, but our progress and standards must be in keeping with the ability of the taxpayers to support them."

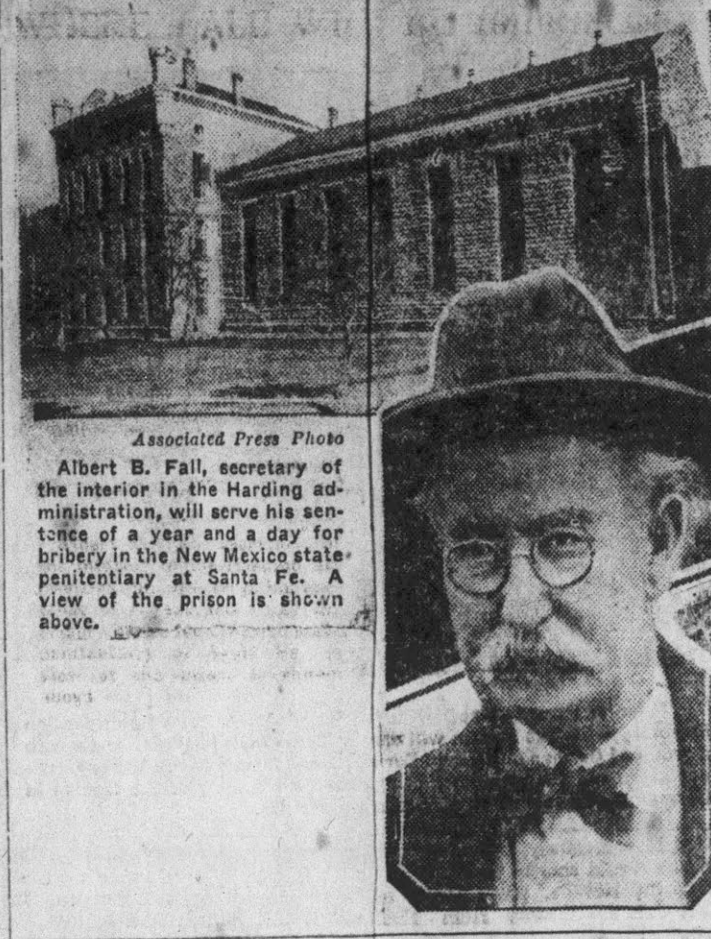

ready to Berlin, so that when Chancellor Brüning and Foreign Minister Curtius arrive, tomorrow they will be able to get down to business at once. It will be the first time the heads of the German government have been in Paris since signing of the Treaty of Versailles.

The newspaper L'Oeuvre says that France proposes the opening of a credit of \$500,000,000 to the Reichsbank and a similar amount to the German government, payable in ten years under well-defined financial and political guarantees. The loan would be granted by the American Federal Reserve system, the Bank of France and the Bank of England.

Although the conference thus far has been occupied with the financial details of the salvage plan, the political aspects have not been lost sight of for they are regarded here as of vital importance. It is believed that a formula has been found which is likely to be acceptable to Germany as well as to the powers who must furnish the money.

As to the conference of ministers called in London last Monday, its usefulness is questioned by most newspapers. In any case it appears that France will not be represented unless tomorrow's parley here reaches an accord in principle.

**WEALTHY TARBORO MAN FOUND DEAD IN BATH ROOM**

early this afternoon that death was caused by suffocation but still had been unable to ascertain the cause of the fire.

During the day he summoned George M. Fountain and H. B. Keechin of Tarboro and E. P. Meredith of Washington, N. C., to appear as witnesses at the inquest. All three, the coroner said, were with Mr. Hart last night and had come to Raleigh with him to attend a hearing before the Corpora-

tion Commission.

Three negro bell-boys were also summoned and officers were seeking another woman this afternoon.

Fire Chief Holland found the body. It was not burned, the coroner said, but was "baked." There was no sign of a struggle visible in the badly burned room.

The party in which Mr. Hart joined broke up between midnight and 1 o'clock, Mr. Waring said he was told.

Those participating in the party said they had been drinking and carousing most of the evening, the coroner said.

The fire alarm was sent in from the hotel at 4 o'clock this morning and after firemen extinguished the small blaze, which badly burned Hart's bedroom but only scorched the walls of the bathroom. The man's body was found in a dry tub.

Mr. Hart was in Raleigh for a hearing before the Corporation Commission involving a petition of the Hart and Fountain cotton mills of Tarboro for a reduction of rates charged by the Virginia Power Company.

In 1929, when as president of the Clinchfield mills of Marion, Mr. Hart attained more than state-wide newspaper attention as he was in the midst of a labor controversy and attendant disorders.

Mr. Hart was about 45 years old. He was a son of the late W. A. Hart, cotton manufacturer of Tarboro. He is survived by his widow, who was Miss Katie Barbee, and three sons, W. A., Vance and Claude.

Mr. Hart was generally known as "Peek" Hart. He attended the University of North Carolina where he was a star baseball player. His earlier education was obtained at Tarboro Male Academy. During his college career he pitched in a southern league under an assumed name and was drafted by a National League team. Before he reported the young man realized he was getting into deep water with his assumed name and withdrew from the arrangement.

He was president of the Hart and Fountain mills of Tarboro. Since the death of his father, who was a pioneer in textile manufacturing in Eastern North Carolina and a member of the first State Highway Commission under Governor Morrison, Mr. Hart has divided his time between Marion, Tarboro and New York. He was reputed to be the second largest manufacturer of print cloths in the United States.

At various times Mr. Hart lived at New Bern, Fayetteville, Raleigh and Marion. He owned several extensive farms in the vicinity of Tarboro, where he was very popular.

Marion, N. C., July 17.—(AP)—B. Mabry Hart, whose body was found in a bath tub in a Raleigh hotel room today, was one of the leading figures in strike disorders in Marion during the summer of 1929.

He was then president and principal owner of the Clinchfield cotton mills and when employees went on strike he recruited a number of loyal workers and ignoring threats of union leaders, resumed operations on a part time scale.

It was this trouble which prompted Judge N. A. Townsend, then executive counsel to Governor Gardner, to call out national guard units. For a time the troops were quartered at the courthouse and were not moved to the mills until the disorders arose while strikers were being ejected from homes needed for loyal workers.

Throughout the negotiations between the labor leaders and mill officials, Hart never acceded to the demands of the union.

Clashes with members of the McDowell county sheriff's deputies which occurred at the gates of the Marion Manufacturing Company on October 2, 1929, when several strikers were killed, focused attention of the entire country on Marion. This mill was only a short distance from the one owned by Hart.

Tommy sat in the sun at the ringside of Mickey Walker's training camp yesterday and for the first time watched another overgrown middleweight who aspires to the heavyweight crown go through his preparatory paces for a fifteen round battle in Ebbets' Field, next Wednesday night with Jack Sharkey, the Marvin Hart of the present fighting era, another big, tough fellow who can box and hit. He spoke as follows:

"If Walker can get past the first three rounds with Sharkey he will give the big fellow the licking of his life."

Tommy sat under a tree not far from the ringside where Walker had boxed rounds with his sparring partners and he placidly munched on one of the steaks Jack Kearns had barbecued for the visiting firemen.

"Heavyweights," he said, "always have the most trouble with little men. Hart couldn't beat me, Dempsey would not tackle Harry Greb, and Walker will beat Sharkey. He will beat him with left hooks to the body, by crowding him out-gaming him, taking the best Sharkey can throw, coming back for more."

"Walker apparently isn't a good gymnasium worker, but he rolls well with punches, never gets hit solidly. He has the chest and arm development of a heavyweight, and above all he has courage. He'll never quit trying. That will bother Sharkey."

He has never shown his ability to go the full championship distance against first class opposition. His worst two setbacks were at 15 rounds against Berlenbach and Schmeling. In the language of the turf, he appears strictly a sprinter.

## STOCK MARKET

New York, July 17.—(AP)—Stocks were content to bide their time today.

The Reichsbank's weekly statement, for the period ending July 15, bore striking testimony to the drain upon its resources. It showed a loss of some \$75,000,000 in foreign exchange and gold for the week, and reduction of the reserve ratio to 35.8 percent.

St. Clairsville Ohio, July 17.—(AP)—Mrs. Don Hardesty, wife of Police Chief Hardesty, was injured and her grandson was stunned by the explosion of an improvised bomb the child found in the yard of their home. Several windows were broken, a concrete sidewalk was damaged and a large hole was torn in the ground.

Chief Hardesty said a similar bomb had been found in another part of his yard. He said they were thrown into the yard during the recent hunger march of striking miners on St. Clairsville when he had orders to prevent the staging of any demonstrations.

## Oil Mill Destroyed By Fire This A. M.

Henderson, July 17.—(AP)—Property valued at \$40,000, including 858 bales of cotton, was destroyed last night by fire which swept through an abandoned oil mill and a storage house on the

outskirts of Henderson. The cotton was the property of the McFadden Commission Merchants of Atlanta, Ga. It was understood here that it was insured, determined but firemen said the loss for vagrants.

## Investigate Bomb On Vatican Grounds

Vatican City July 17.—(AP)—Removed from the interior of the church for examination, a bomb

exploded early today in the garden of St. Peter's cathedral six hours after it was discovered. It was found late last night near a portable pulpit, fifty feet from the great altar where the Pope celebrates mass on important occasions, and was removed to the grounds to await inspection.

The explosion was heard throughout Vatican City but was first attributed to backfire of a motor car. It damaged a few trees and was sufficiently powerful to have wreaked considerable harm on the cathedral.

The petard consisted of a tin pan containing a pound of explosive wrapped tightly with a piece of cord and was believed to have a lighted fuse. It was assumed to have been placed by anti-Fascists in an attempt to discredit the government during the church-state controversy and to be one of a series of bombing outrages which have occurred in recent months.

Premier Mussolini was informed of the incident when he awoke and the Pope learned of it later. Vatican authorities refused to become disturbed and informed Italian police who are aiding the investigation.

## Declare War On Gambling Places In New Orleans

New Orleans, July 17.—(AP)—Parish and city authorities today clashed over enforcement of anti-gambling laws as approximately 100 bookmaking establishments were closed and 58 bookmakers were under indictment.

Police Superintendent Hub H. Myers said his men had more important things to do than raid places where bets were placed on horse races. District Attorney Eugene Stanley, who had given Superintendent Myers a list of places to raid, replied that if the police did not enforce the law special deputies of the parish (equivalent to county and other states) would.

After hearing of Stanley's threat the downtown bookmaking establishments closed up and persons who wished to place bets had to seek bookmakers in the suburbs outside Orleans Parish.

The indictments were returned yesterday, but no names were re-

vealed because arrests have not yet been made.

Stanley started his war on gambling a week ago following demands of both ministers and business men to halt the activities of bookmakers. Business men said creditors were unable to pay their debts because of gambling losses.
