GERMANY WILL ATTEMPT HER OWN RESCUE

Group of Industrial Interests are Working for Economic Rescue of Nation.

Berlin, Aug. 1.—(AP)—The rescue which many Germans during the London conference expected from President Hoover from the seven-power conferees, is being effected right within the Fatherland.

The Darmstaedter and National Bank, known as the Danat, which everybody expected to be liquidated suddenly, has become solvent through the joint action of a group of industrialists in the Rhine and Ruhr valleys.

This outstanding manifestation of Germany's readiness to pull herself out of her mess, was taken today as an indication that other reservoirs of strength will open up as one situation after another calls for remedy.

Further evidence of Germany's determination to mend her own ills was seen in the action yesterday of the Reichsbank, which raised the discount rate from ten to fifteen per cent.

One prominent German spokesman told the Associated Press that the German people, finally freed of their illusions of an immediate long term loan, are beginning to see that the nation's financial apparatus was bloated from foreign loans and that the German people had lived relatively carefree lives on borrowed money without a thought for the day of reckoning.

This informant went so far as to say that even if Germany could get back all the short term loans cancelled since the announcement of the Hoover plan, it would be undesirable to do so, as there has been too much reckless borrowing.

From the attitude of this spokesman it was evident that Secretaries Mellon and Stimson made a deep impression upon Chancellor Bruening and Foreign Minister Curtius with their account of how the United States faced the financial crisis of 1933 and 1937. It was evident also that whatever may have been the German ministers' hopes of foreign long term credits, they now are convinced that foreign loans must be encouraged only in cases of absolute necessity and for really going concerns.

Herr Bruening is said to be greatly encouraged over evidence pouring in from every side of willingness to support the government and forget partisan politics.

Washington, Aug. 1.—(AP)—The suggestion that the American government might aid Germany further by conveying some of the Farm Board's wheat and cotton price stabilizing stock to that country at a fair price and on long term has been laid before President Hoover.

American Ambassador Sackett at Berlin first proposed the matter during the preliminary moratorium negotiations on intergovernmental debts. It has since been brought again to the attention of the administration by newspaper reports in Germany.

President Hoover, however, has been represented as maintaining the view that the initiative in such a move would lie with Germany and not with the United States.

While Germany undoubtedly would be benefited through the carrying out of the suggestion, the attitude here is that disposal of large portions of the stabilizing stocks would relieve apprehension among farmers and traders that the Farm Board might unload its holdings and thereby further depress the market prices.

The board has nearly 200,000,000 bushels of wheat and 1,300,000 bales of 1929 cotton on hand. Its pledge to withhold its 1929 cotton from the domestic market, expired last night at midnight.

It has not been decided how it will handle the 1931-32 crop. It has ceased to purchase wheat for stabilization purposes.

Governor Clears Desk For Vacation

Raleigh, Aug. 1.—(AP)—Governor Gardner today was engaged in clearing his desk preparatory to leaving for his vacation.

The executive hopes to leave here late tomorrow or early Monday. He will go to his home, Shelby, for the first week, but has not decided where he will spend the remainder of the time he is away.

Unless important affairs of state demand his attention, it is not expected that the governor will return to Raleigh until sometime after the middle of the month.

Report Says Nation's Police System Shot Through With Graft

Washington, Aug. 1.—(AP)—A blanket indictment against the police forces of the country was handed down today by the Wickersham Commission.

In its eight report to President Hoover the commission charged that with few exceptions units in the system were shot through with graft and incompetence and too often were under the direct control of dishonest politicians.

It asserted without qualification that major criminals in almost every large community are "well known to the police but, by reason of the sinister influence exerted by corrupt politicians over the chief

FIVE SHOT AS N. Y. MOPS UP GANG ELEMENT

Sixteen Police Cars, With Officers Armed With Shotguns, Patrol the City.

New York, Aug. 1.—(AP)—Sixteen police cars, each carrying four detectives armed with automatic shotguns, cruised the city today, to "meet with force," the gangsters responsible for the death of one and the wounding of two others in two more outbreaks yesterday.

The automobile squads, swept out of a dozen police stations at 6 P. M. and by midnight had already sent five men to hospitals, all suffering from bullet wounds. The five men were shot while attempting hold-ups last night. Two by a patrolman; three others by one of the shot gun squads.

The fatal shooting was in Brooklyn. The other was in East 103rd street, but a short distance from the Harlem neighborhood where one child was killed and four other shot on Tuesday.

The Brooklyn killing of Guido Ferreri, a mild-mannered youth who had had no underworld connections, was blamed on racketeers by police. He was evidently mistaken for a man well known in the clothing labor circles which has been terrorized by gangsters.

In the second shooting on East 103rd street, a large black touring car overtook a small roadster and eight men sent a salvo of revolver shots at the two men in the roadster.

They gave their names at a hospital as Joseph Gazola and Frank Christoffer. Both under thirty, neither would name his assailants, although both may die of their wounds.

The first policeman to put Commissioner Mulrooney's order into execution was Patrolman James MacFarland. He reported seeing three youths holding up a cordial shop. He fired. Anthony Rizzi, 19, was taken to a hospital, seriously wounded. A companion was slightly wounded and placed under arrest. The third escaped.

An additional reward of \$5,000 was made yesterday, bringing the total to \$30,000 in the hunt for the gunmen who shot Michael Venzalli, 5 years old.

Chicago Authorities Issues New List of Public Enemies, Headed by Capone

Chicago, Aug. 1.—(AP)—A new offensive against Chicago gangsters was opened today.

It took the form of the issuance by the Chicago Crime Commission of a new list of "public enemies," adding 28 names to the original roster of 28 which was headed by Alphonse Capone, overlord of Chicago gangdom.

The 28 additional names were made public in a letter sent to public officials, urging that the anti-gang campaign be continued. Among them were those of men who for years are reputed to have been pioneers in the racketeering field. They included Joe Fusco, an alleged Capone liquor lieutenant; Theodore "Ted" Newberry, once a power in the George (Bugs) Moran gang; Sam "Little New York" Campagna, a Capone follower; Claude Madox, a suspect in the 1929 St. Valentine's Day massacre of seven Moran Henchmen; Bernard O'Donnell, alleged beer racketeer; Anthony (Red) Kissane, reputed hoodlum; and John (Jack) Barry, alleged labor racketeer.

It is about 1,700 miles west of Irkutsk which the fliers had hoped to make their first stop after leaving Moscow.

They got away from Moscow at 5:20 p. m. yesterday and intended to stop only at Irkutsk and Khararok before attempting a non-stop hop across the Sea of Chkhotka and the Bering Sea to Nome, whence they planned a non-stop flight over the last leg to New York.

They were approximately ten hours behind the Post-Gatty flight at Moscow, but with fewer and shorter stops they hoped to reduce their disadvantage.

S. C. EDUCATOR DIES SUDDENLY

Dr. R. M. Douglas, University President Passes Away at His Columbia Home.

Columbia, S. C., Aug. 1.—(AP)—Dr. R. M. Douglas, president of the University of South Carolina, died suddenly at his home here early today.

Taken ill shortly after midnight, Dr. Douglas who was 62 years old, grew gradually worse, death coming before 5 o'clock. He suffered a stroke of apoplexy.

His widow and two daughters were at the bedside.

Funeral services probably will be held tomorrow, but definite arrangements had not been made early today.

Surviving are his widow, who before marriage was Miss Lydia, Welsh, of Pittsburgh, and two daughters, Miss Elizabeth and Miss Margaret.

Dr. Douglas became president of the University of South Carolina in 1927. Prior to that, he was president of Presbyterian College of South Carolina at Clinton for 16 years.

Davidson McDowell Douglas was born in Blackstock, S. C., June 20, 1869. He received his A. B. degree at Davidson college and took theological work at Louisville Theological Seminary and Columbia Theological Seminary.

He secured his Masters Degree at the University of South Carolina and took additional graduate work at Princeton and Johns Hopkins.

His alma mater, Davidson, conferred a Doctor of Divinity degree on him in 1912 and Southwestern Presbyterian University gave him an LL.D. in 1924.

He held pastorates in North Carolina and Maryland before becoming President of Presbyterian College in 1911.

He was a member of Kappa Sigma fraternity and of the honorary scholastic fraternity, Phi Beta Kappa.

In 1925 he was moderator of the Presbyterian Synod of South Carolina.

Immediate Destination of Famous Flier And His Wife is the Isolated Port of Moose Factory on The Southern Tip Of James Bay, 460 Miles From Ottawa; Perfect Weather Prevails as Giant Plane Darts Away Into The Clouds; Mrs. Lindbergh Continues Wireless Communication With New York

Ottawa, Aug. 1.—(AP)—Colonel Charles A. Lindbergh and his wife hopped off at 9:49 E. S. T. this morning on their vacation flight to the orient. Their immediate destination was the isolated port of Moose Factory on the southern tip of James Bay, 460 miles from here.

The Lindberghs arrived here two days ago to confer with Canadian airmen concerning conditions over the bad lands of the north-west. Their flight today was almost due north. They and perfect weather.

The famous flier and Mrs. Lindbergh arrived at the Rockliff airport an hour before their takeoff and spent the intervening time in checking over the motor and radio. It was expected that Mrs. Lindbergh would continue her wireless communication with New York as soon as the plane was on its way.

The government radio station established communication with the plane and at 11 o'clock, E. S. T., Mrs. Lindbergh reported that they were making good progress and were on a direct course to Moose Factory.

For the first time since they started their vacation flight the Lindberghs wore life preservers in addition to their parachutes when they left today. They were pneumatic vests which could be quickly inflated in case of need.

In Ottawa they added to their supplies a fishing net, a long knife, a coil of rope and a small quantity of food in addition to their 50 pounds of emergency rations.

Today's flight could have been made without recourse to navigation by following the Ottawa river, a rail line to the Abitibi river and that stream to James Bay. Col. Lindbergh preferred a straight line course, however and so he laid his route across chartered territory and flew by compass.

BOMB CAUSES PANIC IN ITALY

Hundreds are Arrested After Explosion at Genoa Prior to Arrival Royal Pair.

Genoa, Italy, Aug. 1.—Bomb exploded in a street in the heart of the business section today a few hours before King Victor Emanuel and Queen Elena arrived for the launching of the ocean liner "Rex." The bomb shattered windows and panic ensued.

It was believed that the bombing had some connection with the visit of the king and queen.

They, however, arrived in Genoa only a short time before the launch, coming by train from Sant'Andrea, their summer residence.

The bomb went off at 1:40 A. M., and the launching took place at 8 A. M.

The bomb was planted in front of the Italian trans-Atlantic Society building to which most of the damage was done.

Adjoining the building are two hotels in one of which Under Secretary of State Allieri was staying.

This was the fourth bomb explosion in Genoa in recent weeks. A consignment of fountain pens, loaded with explosives and addressed to the Fascist party headquarters, was delivered several days ago.

The city was subjected to a kind of martial law immediately after today's explosion.

Everybody in the neighborhood was searched and hundreds of persons were arrested. Apparently no one was injured by the blast.

When the king and queen were due to arrive at 7:30 o'clock, the train yards were placed under guard of hundreds of soldiers.

The royal train passed directly under the liner Rex which was lying on the ways ready for the launching.

The liner slid into the water at 8:02 A. M. In presence of a great cheering crowd and while Queen Elena waved good-bye.

After the ceremony the king and queen dedicated the new sailors home. Then, instead of going into the city they had lunch on their train, intending to leave immediately for their summer residence.

Expect Improved Price Situation on S. C. Market

Atlanta, Ga., Aug. 1.—(AP)—Planters and warehousemen today looked forward to an improved tobacco market as auctions of the 1931 season enter their second week Monday.

The opening week proved disappointing. Sales were slow, prices indifferent and the quality of the curtailed offerings was not as high as it was a year ago. There was a slight improvement in the market at the end of the week however, which led to the hope for improved conditions next week.

South Georgia markets yesterday said tobacco arrived in greater quantities generally and that buying was more spirited and prices higher than earlier in the week.

Adel reported increased offerings and a slight upturn in prices due to receipt of better grades of leaf. Prices averaged between 15 to 23 cents for the better grades. Approximately 200,000 pounds sold at Quinman yesterday at steady prices. The highest bid was 9.50.

At Hahira yesterday 79,000 pounds sold at an unofficial average of 9.75. Tifton sold 150,000 pounds at an estimated average of 9.07. Waycross reported 50,000 pounds sold at an average of 9 or 10 cents.

This will enable them to determine how much lime to use in the production of various kinds of crops, and should also be conducive to superior farming.

The farm department director declared some farmers used too much lime and others not enough, and expressed belief it would be to the benefit of the farmers to bring soil samples to the farm office and have them examined.

Government to Aid Drought Territories

Washington, Aug. 1.—(AP)—The Federal Government plans to operate with drought and grasshopper afflicted areas in the northwestern and central states in the setting up of an organization to meet the situation.

President Hoover yesterday directed agricultural department officials to undertake, in cooperation with local and state authorities, the formation of such an organization. He took this action before department officials in a conference, in cooperation with local and state authorities, the formation of such an organization. He took this action before departing for Rapidan camp in Virginia to spend the week-end. It was made public through a White House statement after his departure.

The Agriculture Department, the Chief Executive said, was engaged in a survey in the light of the changes in the last two weeks during which the drought situation and the grasshopper plague have become more serious. The area affected embraces sections in Montana North and South Dakota and portions of Iowa, Nebraska and Minnesota.

"What suffering within the areas affected in acute," the president said, "the extent of the dry weather and damage is comparatively minor to that which we confronted and surmounted last year. The Federal Government has already extended assistance in some portions of those localities and the Red Cross is actively engaged in relief work. Secretary Hyde is in touch with the situation. National and local resources are available and the problem will be taken care of."

SEES NON-STOP WORLD FLIGHT

John Polando Predicts Flights Around World Without Stop in Near Future.

Istanbul, Aug. 1.—(AP)—Before much longer, people will be flying around the world in airplanes without a single stop, John Polando predicted today.

He made the prediction while preparing to call on President Mustafa Kemal Pasha with Russell Boardman to receive the president's congratulations on their New York-Istanbul hop, a flight which convinced Polando that it won't be long before planes circle the globe without halt.

"It will be done," he explained, "by refueling in the air. The fuel question is the important thing. The greatest problem we faced in our flight was getting off the ground with enough gasoline to bring us here."

In addition to meeting the president, it was on the files, program for the day included a ceremony at which they were to receive gold medals, encrusted with precious stones: A call on the governor of Istanbul, and visits to the military commander and the president of the Turkish aviation league.

Boardman declared that their plane, the Cape Cod would have been good for 700 or 800 more miles if weather had been more favorable.

"There was fog over the Atlantic, storms over Ireland, England and France, airpockets over the Alps and heavy rain in the Balkans," he said. "That's what retarded us."

Both aviators were enthusiastic about the future of flying.

Boardman declared that within a few years it would be easier flying from Paris to New York than it is now to travel from Paris to Istanbul by train.

Their plans remained indefinite today. Asked whether he would like to fly back to New York without a stop, Boardman said:

"No, I would certainly want to stop off and see some of those pretty European cities we glimpsed from the air."

Seattle, Wash.—(AP)—Pioneering an air route along the Arctic rim of Alaska, Col. and Mrs. Charles A. Lindbergh will encounter Eskimos with a taste for grapefruit and other trimmings of modern civilization.

The Eskimos, practically all of whom talk English, would insist on grapefruit for breakfast if the traders could supply the demand, says Ralph Lomen of the Lomen Reindeer Company.

Even now the first trading ships of the season are threading their way along the Arctic coast toward Point Barrow, Alaska. For many years ships have managed to get by Barrow late in July or early in August.

Large power boats, whole buildings, knocked down, radios, food—almost everything conceivable form the cargoes of trading ships, which return to the States and British Columbia with holds laden with furs.

The natives live in frame houses brought in by boat from the outside or in esmi-dugouts covered with driftwood and skins. Many of them achieve comparative wealth from their fur trading.

(Continued from page one) is the lack of competent, efficient, and honest patrolmen and subordinate officers.

3. "The third great defect... is the lack of efficient communication systems whereby intelligence of the commission of crime and descriptions of the criminals may be quickly spread over a wide territory and as part of that, the necessary equipment in motors to pursue traces of the criminals making their escape.

4. "The well known and oft repeated alliance between criminals and corrupt politicians which controls, in part at least, where it does not wholly do so, the police force of our large cities might well be taken as a primary cause of inefficiency since it rules the head and every subordinate and lays a paralyzing hand upon determined action against such major criminals.

5. "There are too many duties cast upon each officer and patrolman."

A sixth charge was one of failure to make proper provision for the policing of millions of immigrants and of the influx of large numbers of negroes to the northern cities.

Of the cities specifically mentioned, Milwaukee was the only one to receive unqualified praise. The commission cited it as "a city free from crime or where the criminal is speedily detected, arrested and promptly tried and sent on his way to serve his time." It added that "no other city has such a record."

Government to Aid Drought Territories

Washington, Aug. 1.—(AP)—The Federal Government plans to cooperate with drought and grasshopper afflicted areas in the northwestern and central states in the setting up of an organization to meet the situation.

President Hoover yesterday directed agricultural department officials to undertake, in cooperation with local and state authorities, the formation of such an organization.

He took this action before department officials ti and riak, in cooperation with local and state authorities, the formation of such an organization. He took this action before departing for Rapidan camp in Virginia to spend the week-end. It was made public through a White House statement after his departure.

The Agriculture Department, the Chief Executive said, was engaged in a survey in the light of the changes in the last two weeks during which the drought situation and the grasshopper plague have become serious. The area effected embraces sections in Montana North and South Dakota and portions of Iowa, Nebraska and Minnesota.

"While suffering within the areas affected in acute," the president said, "the extent of the dry weather and damage is comparatively minor to that which we confronted and surmounted last year. The Federal Government has already extended assistance in some portions of those localities and the Red Cross is actively engaged in relief work. Secretary Hyde is in touch with the situation. National and local resources are available and the problem will be taken care of."

Sentence Suspended For Manslaughter

Oxford, Aug. 1.—(AP)—Graham Atwater, Granville county farmer, late yesterday was given a suspended sentence after being convicted in superior court here of manslaughter.

Atwater fatally wounded a negro helper on his farm near here Tuesday afternoon. He entered a plea of self defense when placed on trial. Testimony was to the effect that a quarrel preceded the shooting.

The man was sentenced to serve eight months in the county jail, the sentence being suspended upon the payment of costs.

TEXTILE MANUFACTURER DEAD AT GASTONIA

Gastonia, July 31.—(AP)—Frost Torrence, Gaston county textile manufacturer, died here today after a lingering illness.

SEES NON-STOP WORLD FLIGHT

John Polando Predicts Flights Around World Without Stop in Near Future.

Istanbul, Aug. 1.—(AP)—Before much longer, people will be flying around the world in airplanes without a single stop, John Polando predicted today.

He made this prediction while preparing to call on President Mustafa Kemal Pasha with Russell Boardman to receive the president's congratulations on their New York-Istanbul hop, a flight which convinced Polando that it won't be long before planes circle the globe without halt.

"It will be done," he explained, "by refueling in the air. The fuel question is the important thing. The greatest problem we faced in our flight was getting off the ground with enough gasoline to bring us here."

In addition to meeting the president, it was on the fliers' program for the day included a ceremony at which they were to receive gold medals, encrusted with precious stones; a call on the governor, Istanbul, and visits to the military commander and the president of the Turkish aviation league.

Boardman declared that their plane, the Cape Cod would have been good for 700 or 800 more miles if weather had been more favorable.

"There was fog over the Atlantic, storms over Ireland, England and France, airpockets over the Alps and heavy rain in the Balkans," he said. "That's what retarded us."

Both aviators were enthusiastic about the future of flying.

Boardman declared that within a few years it would be easier flying from Paris to New York than it is now to travel from Paris to Istanbul by train.

Their plans remained indefinite today. Asked whether he would like to fly back to New York without a stop, Boardman said:

"No, I would certainly want to stop off and see some of those pretty European cities, we glimpsed from the air."

Even now the first trading ships of the season are threading their way along the Arctic coast toward Point Barrow, Alaska. For many years ships have managed to get by Barrow late in July or early in August.

Large power boats, whole buildings, knocked down, radios, food—almost everything conceivable form the cargoes of trading ships, which return to the States and British Columbia with holds laden with furs.

The natives live in frame houses brought in by boat from the outside or in esmi-dugouts covered with driftwood and skins. Many of them achieve comparative wealth from their fur trading.

REPORT SAYS NATION POLICE SYSTEM SHOT THROUGH WITH GRAFT

(Continued from page one) is the lack of competent, efficient and honest patrolmen and subordinate officers.

3. "The third great defect... is the lack of efficient communication systems whereby intelligence of the commission of crime and descriptions of the criminals may be quickly spread over a wide territory and as part of that, the necessary equipment in motors to pursue traces of the criminals making their escape.

4. "The well known and oft repeated alliance between criminals and corrupt politicians which controls, in part at least, where it does not wholly do so, the police force of our large cities might well be taken as a primary cause of inefficiency since it rules the head and every subordinate and lays a paralyzing hand upon determined action against such major criminals.

5. "There are too many duties cast upon each officer and patrolman."

A sixth charge was one of failure to make proper provision for the policing of millions of immigrants and of the influx of large numbers of negroes to the northern cities.

Of the cities specifically mentioned, Milwaukee was the only one to receive unqualified praise. The commission cited it as "a city free from crime or where the criminal is speedily detected, arrested and promptly tried and sent on his way to serve his time." It added that "no other city has such a record."

STOCK MARKET

New York, Aug. 1.—(AP)—Week-end short covering gave the stock market a little boost today, although gains for the most part were narrow. Trading remained around minimum levels for the past several years, sales aggregating around 600,000 shares for the two hours.

Weakness of J. I. Case, which broke 3 points to a new low under renewed selling based on the uncertainty of professional traders as to the dividend maintenance, gave the whole list an easy tone during the first hour. Reactions, however, were narrow and shorts began to reduce their commitments in the second half of the session.

U. S. Steel and Bethlehem each closed half a point higher, but there were advances of 1 to 1 1/2 in such stocks as American Can, American Telephone, Consolidated Gas, Bendis, United Aircraft and Public Service of New Jersey. Numerous specialties did better including Columbian Carbon, Bohn and Coca Cola, in which the rise was 2 points. Nickel Plate preferred dropped 3 1/2 to a new low and Katy preferred sagged 2, also to a new minimum. Atchison, Southern Pacific and Rock Island firmed, Case reduced its loss to slightly more than a point.

News of the Franco-American credit to the Bank of England, taking the form of an agreement by the Federal Reserve Banks and the Bank of France to purchase up to \$250,000,000 in prime British bills when, as and if the credit is needed, was well received by the financial community.

Sterling exchange firmed with the announcement of the credit arrangement and cables reached \$4.86, up 1/4 cent. The French franc was steady.

Loss of Cochet Expected to Cost France Davis Cup

New York, Aug. 1.—(AP)—Henri Cochet's decision to turn professional will cost France the Davis Cup in 1932 in the opinion of leading tennis authorities here.

These experts believe the cup will be won either by the United States or Great Britain regardless of whether or not René LaCoste emerges from his retirement to aid the French defense. Doubt is expressed all along the line that LaCoste, troubled by illness for several years, ever again will reach the form that at one time made him the most feared player in the game.

The recent challenge round matches in Paris when France retained the cup by beating Great Britain three matches to two with Cochet figuring in all three French victories, revealed that the tri-conqueror no longer was the all-conquering tennis power it had been for four previous years.

Jean Borotra, who with Cochet and LaCoste, won the cup from the United States in 1927 and had sided in its defense in every year since lost both of his singles matches in the challenge round to Frederick J. Perry and Henry W. (Bunny) Austin. France's young stars, Christian Boususs and Pierre Landry, have yet to show they can fill the fading Borotra's place, must lose Cochet's place,

BATTING RACE STILL CLOSE IN THE NATIONAL

New York, Aug. 1.—(AP)—While the St. Louis Cardinals have taken some of the interest out of the National League pennant race by gaining a big lead, the leading batters of the circuit have kept their battled packed with excitement by sticking close together and passing the lead around with almost daily changes.

The first eight regulars on the National league list are separated by only eight percentage points according to the semi-official averages which include Thursday's games while the figures must be carried out to the fourth decimal to put Harvey Hendrick, Cincinnati ahead of Charley Grimm, Chicago in the race for the lead. Hendrick has a mark of 34.52 while Grimm's average is 34.48.

Virgil Davis, Philadelphia catcher, holds third place with .344 while his teammate, Chuck Klein, who recently held the batting lead as well as first place in most of the slugging departments, is now fourth at .342. Behind them come Hogan, New York, .340, Terry, New York and Hornsby, Chicago, .337, O'Doul, Brooklyn, .337; Roetger, St. Louis, .327 and Arlett, Philadelphia, .325.

Klein still holds the long distance hitting record with 23 home runs to his credit and has scored 85 runs and batted in 83 to lead in two other departments. His total of 132 hits gives him second place to Lloyd Waner of Pittsburgh, who has poked out 136 safeties. Rogers Hornsby of Chicago leads with 35 doubles and is second to Klein with 76 runs batted in. Pie Traylor of Pittsburgh has hit 13 triples, one more than Bill Terry of New York. Kiki Cuyler of Chicago still is the leading base stealer with an even thefts.

The second place roster is completed by Cuyler and George Grantham of Pittsburgh, each with 79 runs; Bartell, Philadelphia and Adams, St. Louis with 30 doubles each; Ott, New York, 17 home runs and Comorosky, Pittsburgh, and Frisch, St. Louis, with eleven stolen bases.

Chicago and New York are deadlocked in the club batting list with 293 averages but the Cubs are along at the head of the fielding averages with a .975 mark.

The Cardinals' victories are reflected in the pitching records were Jess Haines, Jim Lindsey and Paul Derringer are clustered around the top. Haines is rated as leading pitcher with eight victories and two defeats for an 800 average although Bob Osborn of Pittsburgh has won five games without a loss. Lindsey has won four games and lost one while Derringer is credited with 12 victories against four defeats.
