PRYOR AGAIN ON STAND IN TRIAL OF LEA

Real Estate Appraiser Explains Valuation on Lands Held by Tennessean.

Asheville, Aug. 17.—(AP)—E. C. Pryor, Nashville, Tenn., real estate appraiser returned to the stand here today as the trial of four men charged with conspiring to defraud the now defunct Central Bank & Trust Company entered its fourth week.

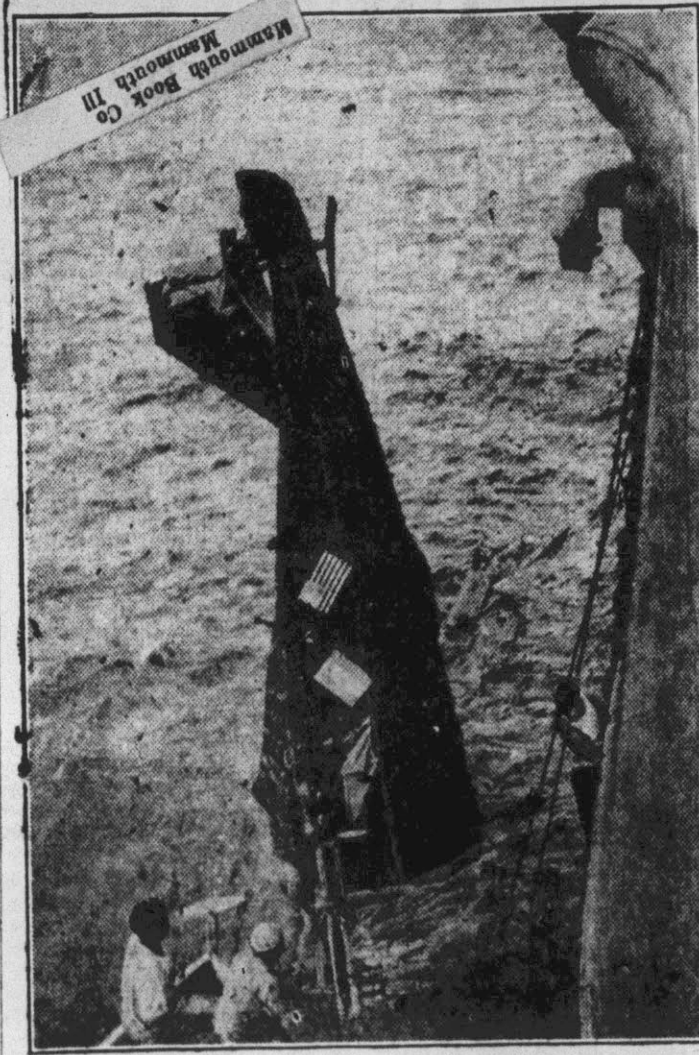
Col. Luke Lea, Tennessee publisher and politician, is one of the defendants, and indicted with him are Wallace D. Davis, Luke Lea, Jr., and E. P. Charlet.

Pryor who testified Saturday that the elder Lea issued bonds for twice the value of the lands on which they were based, was cross-examined today by Giles L. Evans, of Lea counsel, who, by obtaining detailed descriptions of the various tracts sought to show that Pryor's valuations were too low.

In explaining how his valuations were arrived at, Pryor said that three years ago Lea tried to get him to appraise a tract at \$1,500 per front foot, but that he refused to rate it a more than \$600.

Evans tried to show through questioning that Pryor had been in dicted for violation of the Tennessee real estate law, but Pryor said the Supreme court upheld him in that case.

SUGGEST WAR ON SLUMS OF THIS COUNTRY

Abolition of Breeding Spots of Crime Men- tioned in 12th Wick- ersham Report.

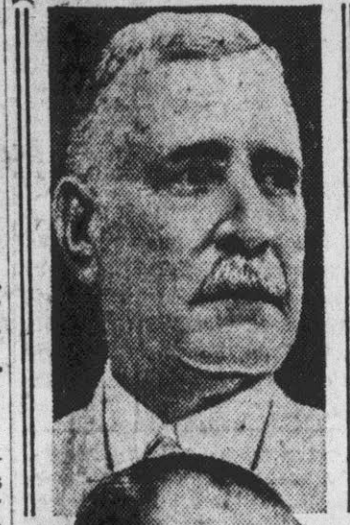
Washington, Aug. 17.—(AP)—A war against the slum sections of American cities—aimed at their abolition as breeding spots of crime—was suggested today by the 12th Wickersham report to President Hoover.

The commission itself, however, made no recommendations or suggestions. It merely appended to an 859-page two-volume report on the "Cause of Crime," prepared by half a dozen experts, a brief statement saying it was unable to discuss the subject.

One entire volume, however, was given over to an experts' report, setting forth figures to show that a steady stream of juvenile criminals was pouring from the disorganized area of half a dozen cities studied. Conversely, it maintained these same people, transplanted to other sections, were led less often into crime.

Accepting these conclusions, Col. Henry W. Anderson of Richmond, Va., who wrote a report of his own, recommended to the President that there be prompt and effective action to remove the slums in our cities and the underprivileged areas in the rural sections.

Martial Law Declared In Texas Oil Fields

Austin, Tex., Aug. 17.—(AP)—Governor Ross S. Sterling declared martial law and ordered all producing wells shut down.

The governor acted to prevent depletion of the resources of this vast field while the state railroad commission, Texas oil regulation body, put into action the oil con-

servation measure passed last week. Sterling said the commission would need a week or two to do this. Some oil men said 20 days would be required. The field's over-production is generally blamed by oil men for unsettling the industry and depressing prices.

Nineteen Lives Snuffed Out by Guns, Au- tomobiles, Fire and Knives in Various States; Woman at Mount Airy, N. C., Slashes Husband's Throat and Then Shoots Him to Death After Wounding 7- Year-Old Son; Far- mer's Wife is Shot to Death Near Lexing- ton.

Atlanta, Aug. 17.—(AP)—Guns, automobiles, fire and knives brought about the death of nineteen persons in the south over the week-end.

Near Pikeville, Ky., Howard Hall, White and Finas Williams, negro, killed one another in gun duels over a debt. At Shreveport, La., J. H. Atkinson, business man, killed his wife and then himself with a pistol.

Mrs. Alton Jarrell of Mount Airy, N. C., under commitment to an institution, slashed her husband's throat and shot dead her 7-year-old son, Mrs. Jake Barrier, a farmer's wife, was found shot to death at home.

Sheriff Oscar McGee of Griffin, Ga., who slept with a pistol nearby, was found dead in bed yesterday and a coroner's jury decided he accidentally shot himself in his sleep. Will Johnson was shot to death in a quarrel at Chester, S. C. Tom Smith, negro, was killed by officers at Florence, Ala., who he resisted arrest.

Dan Stevens 25, died of a butcher knife wound at Spartanburg, S. C., and his sister-in-law, Mrs. Nellie Collier was held.

At Greenville, Miss., George Rigney Jr., white, and Alex Williams, negro died in a fire of undetermined origin which swept the building used by the U. S. Government central area levee building forces and the Ernest Levy Transfer and Storage Company.

James Russell, 25 and Bill Orrby, 22, were killed near Centerville, Tenn., when their car overturned. D. Berger, former chief of police of Athens, Tenn., was killed in an automobile collision near there.

Charles Reid 8, was killed at West Blocton, Ala., when a car turned over. Ebert Gunn of Hanceville, Miss., was fatally injured by a passing car that struck him as he repaired a tire. Charles F. Patterson Glenn Allen, Ala., was killed in an automobile wreck at Texas, Ala.

At Tallahassee, Fla., Joseph Retze, 27, was killed when his car collided with that driven by his brother William.

Mount Airy, Aug. 17.—(AP)—Mrs. Alton Jarrell, who killed her husband, seriously wounded her 7-year-old son and attempted suicide, was held in jail here today pending her transfer to the state hospital for the insane at Morganton.

Mrs. Jarrell, wife of a tobacco farmer, was to have been taken to the asylum Saturday but the trip was delayed and in the interim she went into a hysterical rage that reached a climax with her efforts to wipe out her family.

Quitted afterwards, she told the police she awakened early yesterday morning and slasher her husband's throat with a razor as he slept. Turning to her son, Leslie, she inflicted two severe cuts across his jaws, one partially severing his tongue.

Her husband, fatally wounded, tried vainly to interfere with her assault on the child. Further enraged by his action, she shot him three times and he died at her feet.

Going into a hall, she raised the pistol to her own head only to have her brother-in-law, Arthur Jarrell, stop her before she had time to fire.

The child, patient in a hospital here, is expected to recover.

Manteo Prepares for Homecoming Crowds Tomorrow

Manteo, Aug. 17.—(AP)—Across the sounds, inlets and rivers that once held Dare county in almost virtual isolation, former residents of this section speeded today to join in "Homecoming" rejoicing to celebrate the spanning of these waters.

For more than three centuries, visitors to Manteo always came by boat. They came, however, despite inconveniences of ferries, to see the birthplace of Virginia Dare, first white child born in America, and the scene of the Wright brothers' first successful airplane flight.

They are coming in even greater numbers now that the hand of progress has laid a ribbon of concrete across these islands on the Eastern North Carolina shore and the greatest crowd of all is expected tomorrow.

The 344th anniversary of the birth of Virginia Dare tomorrow will be the climax of the "Homecoming" program.

At old Fort Raleigh, on the northern end of Roanoke Island, notable of the state and nation will gather to take part in the exercises.

J. C. B. Ehringhaus of Elizabeth City, will welcome the visitors and Josephus Daniels, former secretary of the navy, will respond for the guests.

U. S. Senator Cameron Morrison who will be introduced by Representative Lindsay C. Warren, will deliver the principal address while speeches will also be made by Senator Josiah W. Bailey of Raleigh; E. B. Jeffress, chairman of the State Highway Commission, and Tyre C. Taylor, executive counsel to Gov. O. Max Gardner, who will not be able to attend.

D. B. Fearing, chairman of the Dare county homecoming committee, will be in charge of the program while the Rev. Robert Brent Drane of Edenton, vice-president of the Roanoke Colony Memorial Association, will be master of ceremonies.

The U. S. Naval Band from Hampton Roads and local musicians under the direction of Miss Effie Reade Wescott, will furnish music.

Mystery Continues to Cloak Death of Davidson Woman

Lexington, Aug. 17.—(AP)—Mystery today continued to cloak the death Saturday of Mrs. Jake Barrier, 61-year-old wife of a Davidson county farmer six miles north of here, found shot to death at her home.

Investigating officers were unable to obtain a clue upon which to work. The body was discovered by a young negro employe upon his return to the house in the afternoon. The husband, working in a nearby field, said he heard no shot.

Bloodhounds, brought in an effort to ferret out the mystery, failed to take a trail. Mrs. Barrier was seen about 2 o'clock in the afternoon and her body was found two hours later. She was alone at the house when slain.

Speculation was rife as to the effect of the organization's attitude on the governor's chances for the Democratic presidential nomination.

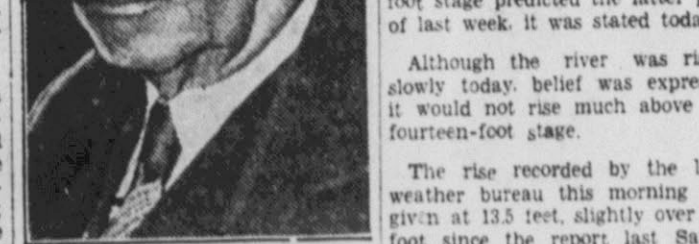
The governor's action in calling a special session of the legislature to increase the powers of the legis-

THREE SLAIN IN NEW YORK

Police Reveal Details of Most Brutal Murder in Crime Annals of Brooklyn.

New York, Aug. 17.—(AP)—Police today revealed details of what they called the most brutal murder in Brooklyn crime annals, the killing of three men who were made targets for flung knives in a spook-house.

The victims, Charles Maturo, Charles Simminelli and Joseph Barberi, were found dead in the cellar Friday, their heads crushed and their bodies covered with knife wounds.

Now, police said today, an eye witness has told them how it happened. According to this man's statement two girls had been assaulted in the speakeasy and returned with six men friends identifying Maturo, Simminelli and Barberi. (Continued on page two)

TWO IN RACE FOR GOVERNOR

J. C. B. Ehringhaus and R. T. Fountain Groomed for Battle of Ballots in N. C.

Charlotte, Aug. 17.—(AP)—Two candidates today were formally registered to run in North Carolina's 1932 gubernatorial derby while the public in the stands confidently awaited announcement that others would go to the barrier.

J. C. B. Ehringhaus, Elizabeth City attorney, Saturday added his name to the entry list that previously had contained that of Lieut. Governor Richard T. Fountain of Rocky Mount.

Although no formal announcements have come from other prospective candidates, the political fraternity has heard numerous reports that at least three others will offer for the office as Tar Heel's chief executive. They are Attorney General Dennis G. Brummitt of Raleigh; Commissioner A. J. Maxwell of the Department of Revenue and General Albert Cox of Raleigh.

In making his declaration for the race, Mr. Ehringhaus set forth four cardinal points of a platform, promised to amplify his remarks later and revealed plans for a campaign that will extend into every section of the state.

His preliminary quadrangular platform includes: Defense of the Democratic party record, opposition to general or luxury taxes, support of a quadrennial assessment plan in land taxation and a "strict but sane economy in government."

Repeated rumors have failed to provoke announcements from Cox, Brummitt or Fountain as to their intentions. The Democratic primary is to be run next June.

Trial Of Former County Officials Opens at Beaufort

Beaufort, Aug. 17.—(AP)—Trial of six former county officials, road contractors and engineers was to get underway here today at a special term of Carteret county Superior Court.

The defendants, Luther Hamilton county attorney; W. L. Stancil, former county auditor; George W. Huntley, former chairman of the board of commissioners; George J. Brooks and C. K. Howe, former county engineers; Simmons Construction Company and F. M. Simmons, road contractors, are charged with conspiracy to defraud the county of approximately a million dollars.

Four suits have been filed against the defendants by the county. They allege conspiracy to defraud the county in road building operations, in the collection of taxes and in other delinquencies in office.

Judge Clayton Moore of Williamson, is the presiding jurist. County counsel have announced they will seek a special venire from another county for selection of the jury.

THIRD UNION SERVICE HELD

Rev. A. W. Fleisch- mann Delivers Ser- mon at Methodist Church Last Night.

The third of the series of union services being conducted among city churches during the summer was held at the Methodist church last night.

The sermon was delivered by Rev. A. W. Fleischmann, pastor of the Memorial Baptist church, who spoke on the subject, "The Inevitable Cross." His text was taken from Mark 15:31, "He saved others; himself He cannot save."

The sermon was preceded by inspirational congregational singing. The sermon in part follows:

"Out of the long ago comes this word of mockery and derision. He saved others; himself He cannot save! It is not difficult to imagine the crowd surging around Calvary, many of whom were wagging their heads in imitation of the writhing agony of those who hung upon the crosses. Along with this one hears the shouted challenge to the sufferer upon the central cross as they cry, 'Save thyself, and come down from the cross!' Yet, upon this central cross we behold the unfolding of the Holy love of God working for sinners."

"Two things we would gather from this scene and these words: First, the cross was inevitable for the Lord Jesus and Christ, and second, it is equally inevitable for us who profess to be followers in His name."

"That the cross was inevitable for Christ is shown to us by two facts: First, every prophecy, whether in type or prophetic delineation pointed to this cross with unerring accuracy. Therefore He said after His resurrection in explanation of it, 'Ought not Christ to have suffered these things?' and added, 'Thus it is written, and thus it behooved Christ to suffer, and to rise from the dead the third day.'"

"Second, the cross was inevitable for Christ because He deliberately and voluntarily chose: the Father's will which included it. In this choice the Lord Jesus assumed tremendous obligations for those who accept Him and His leadership. He undertook to reconcile us to God, to bring us to a place of acceptance with Him, and to experience His gracious guidance and Jehovah's shepherd. He undertook, moreover, to provide the means whereby he could build a character out of this old nature of ours that would conform to God's ideal for us."

"The cross is equally inevitable for the follower of Christ. Here are His challenging words: 'If any man would come after Me, let him deny himself, and take up his cross, and follow Me.'"

"He has the absolute right to lay down these terms of His leadership because of what He undertook for us. There are the terms: There must be an absolute renunciation of self, that is, the transference of goal of allegiance in the life from self to Christ. There must be the personal acceptance of the cross in the follower's life, which means for him the paying (Continued on page two)

URGE PASSING COTTON LAWS

Governor Long And Rep. Fuller Propose Ways For Aiding Price Situation.

New Orleans, Aug. 17.—(AP)—Governor Huey P. Long, of Louisiana, has entered the south's battle against over production of cotton by proposing that the cotton growing state pass laws against raising of a single bale in 1932.

response to telegrams sent last night, proposing a meeting in New Orleans next Friday to prepare the way for enactment of such legislation. He gave assurance that Louisiana will enact the necessary laws if the other states will.

The telegrams were sent to all governors, United States Senators, Congressmen and lieutenant-governors of the cotton growing states.

If the plan is adopted, he said the farmers will get more money for this year's crop than at present, they will receive for this year's and the next two years' crop.

"The farmers yet have their cotton," he said, "and if action is immediately taken along this line, they will get the benefit of the price that will result from this move."

Columbia, S. C., Aug. 17.—(AP)—An act by Congress to regulate the cotton acreage in 1932 was proposed today by Rep. Hampton P. Fulmer, of the seventh South Carolina district, as one means of raising the price of cotton.

In a letter addressed to the Federal Farm Board, Representative Fulmer suggested as an immediate step toward relief of the cotton grower the board take over the present crop and sign up farmers "not to plant any cotton in 1932," continued, "pass legislation, which 'Let the next Congress,' he I believe it can do under the welfare of the United States, to regulate the acreage to be planted in 1932 and over a period of two or three years if necessary."

He said legislation was necessary for the success of the plan, because if the farmers merely signed an agreement, "many of them would break their contract. Others would refuse to sign and there would be thousands of new planters going into cotton farming to take advantage of any price that might accrue because of such plans."

Greensboro, Aug. 17.—(AP)—J. Coltrane, of Salisbury, today headed the North Carolina Education Association's committee on public relations.

Announcement of Mr. Coltrane's appointment was made here yesterday by Dr. John H. Cook, president of the Association, who is dean at North Carolina College for Women. Mr. Coltrane, a former president of the association, is superintendent of schools at Salisbury.

The committee's purpose is to familiarize the people of the state with developments affecting the schools. One of its duties will be to interpret reports made by the association's recently appointed research committee, a fact-finding body devoted to the systematic study of education in North Carolina.

LINDY STILL AT KAMCHITKA

While Flier and Wife Study Weather Re- ports, Nemuro Pre- pares Big Welcome.

Nemuro Japan, Aug. 17.—(AP)—A radio message from Paramushir Island, picked up here by the Ochikishi wireless station, indicated tonight that Colonel and Mrs. Charles A. Lindbergh were still at Petropavovsk, Kamchatka, studying weather reports. There was no intimation as to when they would start for nemuro.

The Paramushir station said it had received its information from the steamship Kokusai Maru which was returning from Japan after delivering gasoline supplies around the rim rim of the North Pacific for Seiji Hoshihara, Japanese flier who wrecked his plane on a flight attempt to the United States. The ship was off Petropavovsk.

Previous reports were conflicting. An earlier message from Ochikishi said the flying couple were planning to make the 897 mile hop down the Kurile Island to Nemuro immediately in view of weather reports forecasting the approach of bad flying weather. Still another, picked up from Japanese fishing vessel, said the flying couple had taken off.

Reporters and photographers were swarming into Nemuro for the first landing of the Lindberghs in Japanese territory. The only vacant rooms remaining were reserved for the Lindberghs.

These rooms were at the Nibiki Hyokan, which, freely translated, means "the two smiling beauties inn."

A check showed there were 89 news reporters and 27 photographers here and still more en route.

The Tokyo Tsahi, a newspaper which always has been much interested in aviation, has nine men and two airplanes here while the Tokyo Nichi-Nichi-Asahi and Nichi Nichi being the greatest rivals—has six men but no airplanes.

The Hokkai Times of Sapporo City, the largest newspaper on Hokkaido Island, has five reporters and one airplane.

Asahi brought an American girl stenographer from Tokyo to take down everything the Lindberghs say during a half hour interview being arranged. (Continued on page two)

MARTIAL LAW DECLARED IN TEXAS OIL FIELDS

(Continued from page one) The governor included four counties—Rusk, Gregg, Smith, and Upshur—the area covering 2,815 square miles. There are approximately 1,600 producing wells in their old with a recent daily average production of about 750,000 barrels. Notice of the proclamation was communicated to Brig.-Gen. Jacobs S. Walters, commander of the 56th brigade, who had 800 men mobilized at Kilgore ready to move into the adjoining oil fields. In his proclamation Governor Sterling asserted, "It is evident that there exists an organized and entrenched group of crude petroleum oil and natural gas producers in the East Texas oil field... who are in a state of insurrection against waste of crude petroleum and natural gas, and are in open rebellion against the efforts of the constituted civil authorities of this state to enforce such laws."

The governor expressed fear that citizens in the area might attempt to take the law into their own hands and by force or arms shut down the producing oil wells, unless the state acted. Issuance of the martial law ordered follows by nearly two weeks such action in Oklahoma by Gov. W. H. (Alfalfa Bill) Murray. Oklahoma's portaled areas were closed down August 4 when Murray's demand for a 1 barrel minimum for crude was not heeded. The order still holds.

Earth Tremors Occur in Texas

Dallas, Tex., Aug. 17.—(AP)—Earth tremors described by the Rev. James B. Acland, seismologist at St. Louis University, as strong enough to cause destruction if originating in populated regions of shock west and central Texas Sunday. No loss of life was reported throughout an area of which San Antonio was the largest city to report the shock.

The weather bureau at San Antonio reported the tremors lasted 72 seconds. Valentine, in the Southern Sierra Vieja mountains, seemed to bear the brunt of the shock. Adobe houses were wrecked. The town's brick school plant was damaged badly and every chimney fell. Corsicana was the farthest east city to report the tremors, giving the shock zone a width of at least 500 miles in Texas. Comanche Springs, flowing 60,000,000 gallons of water daily, spouted muddy water for an hour after the tremor but apparently the flow was not otherwise affected.

Mexico City, Aug. 17.—(AP)—Several walls collapsed and a few people were slightly injured in a strong tremor which shook Pinotepa, Oaxaca, early yesterday. Press dispatches said the shock, which occurred before dawn, threw the inhabitants into panic and that they abandoned their homes and spent the rest of the night in the open.

Woman Help Battle Roaring Forest Fires

Spokane, Wash., Aug. 17.—(AP)—Their homes threatened by two roaring forest fires, women grabbed axes, shovels and other equipment to battle alongside 700 federal and state fighters on the outskirts of Ione, north of here today. Residents spent yesterday afternoon and last night in terror as cinders and burning brands showered the town from a red sky. Automobiles and trucks were made ready to evacuate the town and a Chicago, Milwaukee, St. Paul & Pacific railroad work train stood on a sidetrack, ready to move out at a moment's notice.

But the wind shifted at the last minute and the fire leaped Clark Fork river into dry gulch. An hour or so later the breeze shifted again, scattering spot fires all around the town and fanning major blazes on two sides of the village into new activity. Later the wind died down. After two days of relaxation when most large fires in the Montana-Idaho region were controlled, more than a dozen blazes in north central Idaho spurred fighting forces into activity yesterday. Failure of predicted rains to come and continued hot weather, low humidity and winds made the situation critical, and foresters reiterated appeals to vacationists to refrain from smoking or building campfires in all timbered areas.

REVOLUTION NEARING END President Machado of Cuba Begins Drive Against Santa Clara Territory.

Havana, Aug. 17.—(AP)—Its principal spirits behind bars, Cuba's week-old revolution was viewed by the government today as nearing the stage of a lost cause. President Gerardo Machado concentrated his attention and armed forces of Santa Clara province where vestiges of resistance lingered. He will spend two or three days more here using his influence to have the rebels lay down their arms. General Mario G. Menocal, one-time president and reputed head of the government; Col. Carlos Medieta, veteran of the War of Independence, and a little band of men, who left Havana hoping to strike swiftly and surely at Machado's power, came back yesterday as prisoners of war aboard the gunboat Fernandez Quevedo.

While thousands watched from the great sweep of the Malecon waterfront drive, the Quevedo slid slowly into the naval base at Tiscornia, across the harbor from Havana proper. While press and movie cameras ticked away, the eleven captives came ashore and entered automobiles and trucks. In silence, they rode up the long hill, close guarded by Grim Cabana forces, where they will be confined until such time as President Machado and military courts pass judgment upon them. The seven days of revolution had taken bitter toll. The slender figure of Menocal was erect as ever, but new lines were in his face. The soldierly shoulders of Medieta were bowed, as though the weight of the skin cape that covered them

was too much. All were ragged, dirty, weary, unkempt and unshaven. In Santa Clara, the men who took the field at their call went down with their arms, but Col. Aurelio Hevia and Col. Roberto Mender Penabaz, two other old soldiers of the army of liberation, are reported still in the field. The insurgents say the revolution will not be over until all are dead or captured, or until Machado resigns. The government has in Santa Clara Col. Emiliano Ameila's regular tactical unit, plus some 4,000 soldiers sent there this week with much ammunition and six airplanes. Army headquarters and the president himself expect little more time will be needed to quench the revolt there.

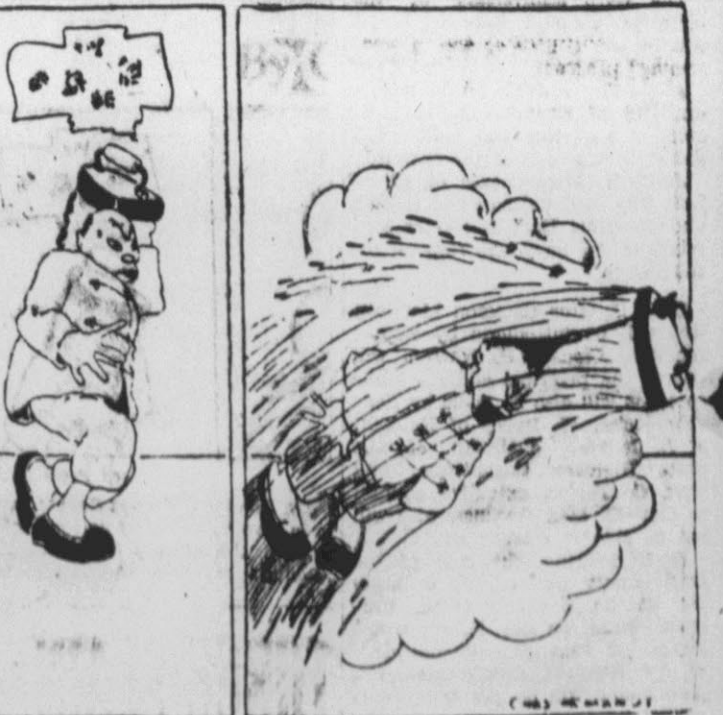
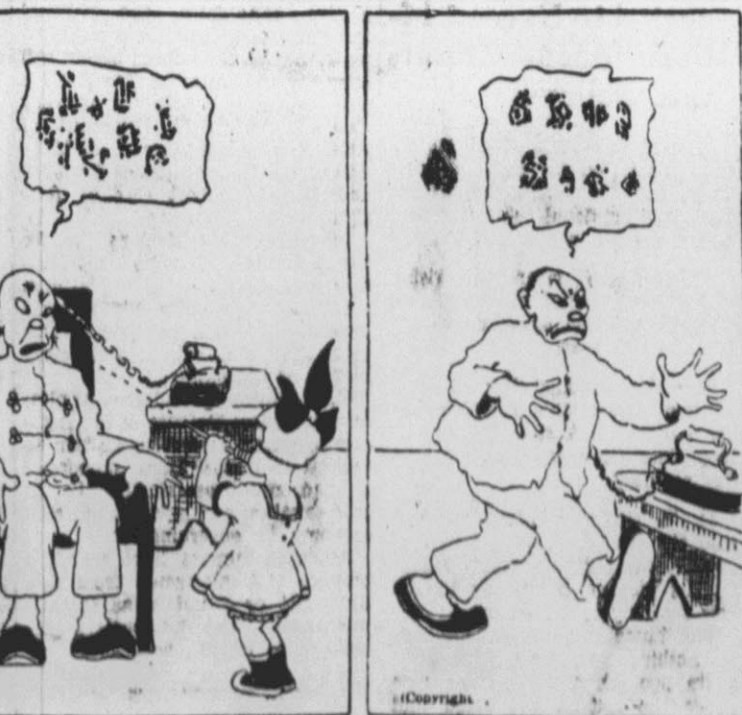

J. D. Langston, editor of the News, said relatives of Bufkin said he disappeared from his home in the Belvidere section of Perquimans county, near Bear Swamp, about 15 years ago. He lived for a while in Elizabeth City, Langston said he was told, and then disappeared.

Bufkin's near relatives are dead, an investigation revealed, but several cousins living in this section believe Peter Russell may be Bufkin. Russell is being shuttled back and forth between England and America because of doubt as to his birthplace.

The times Russell told immigration authorities he spent in Elizabeth City tallied with the time Bufkin's relatives say he lived there. And the time Russell said he went to sea nearly 15 years ago tallied with the time Bufkin disappeared, Langston said.

Liverpool and the continent were both credited with selling here while there was some commission house selling, presumably in liquidation of contracts bought on the rallies of late last week. October declined to 6.97 and March to 7.49 under the early pressure but offerings were not heavy and the market became quiet after they had been absorbed with the tone steadier at the end of the first half hour on covering. Some trade buying was also reported, while there was very little southern selling here and the absence of hedging seemed to have a sustaining influence on the market.

Liverpool cables reported local and Bombay liquidation in that market, but said the demand for cotton cloths from China was maintained.

STOCK MARKET

New York, Aug. 17.—(AP)—Bull leaders stepped aside at the start of the new week in the stock market, and prices fell back.

After the extensive advances of last week, traders were inclined to feel that the market might have to consolidate its position with a technical setback before the advance could be resumed, but with the absence of impressive signs of seasonal recovery in trade, and the bad psychological effect of the Toledo bank suspensions, the reaction was more severe than anticipated.

Selling was fairly active for a time in the morning, and numerous declines of 2 to 6 points appeared—the sharpest reaction since the response to U. S. Steel's dividend cut. The list turned dull around midday, however, and losses were moderately reduced for a time.

Issues making extreme declines of 2 to 4 points included such stocks as U. S. Steel, American Telephone and Telegraph, Southern Railway, American Can, Southern Pacific, New York Central, Woolworth, Sears and Electric Auto Lite, Case and Allied Chemical dropped 5 and 6, then recovered 2 and 3, respectively.

Bankers expect that the final arrangements for maintaining the existing short term credits in Germany will be completed this week. Wall street is watching with considerable interest the efforts to effect drastic economies in England.

On the whole, the international finance situation has been considerably ameliorated, but in important Wall street banking circles, it is pointed out that with the end of the Hoover debt moratorium now little more than 10 months away, the question of the resumption of payments will hang over the situation as an unsettling influence for some months and probably prove an important obstacle toward the funding of any of Germany's short term indebtedness.

Weekly reviews of two prominent financial advisory services appearing today were inclined to the view that despite the recent recovery in the share market, long term investors need be in no hurry to make commitments. One service, however, suggested moderate commitments in selected issues in periods of weakness by those with the larger portion of their funds uninvested.

GIANTS BEAT CARDINALS BY SCORE 7 TO 1

If the New York Giants had an entire pitching staff of men as successful as Southpaw William Walker, they might now hold the place of the St. Louis Cardinals at the top of the National League standing instead of being virtually tied with the Chicago Cubs, 81-2 games behind the Cards and one clinch point ahead of Chicago.

Walker, the leading Giant pitcher, has won his last five starts and in two games against the Cardinals has left the league champions and prospective pennant winners down with four hits. He turned in a second two-hit game against St. Louis in the first half of yesterday's double header to win a 7 to 1 count after beating them on July 18. He had another shut-out in eight yesterday until a walk and two errors in the ninth inning gave the Cards their run.

Carl Hubell, Walker's equal left handed running mate, was not so successful in the second half of the double header. He gave the Cards a run in the first inning and the Giants never overcame that margin against Flint Rhem's fine mound work. He scored twice after an injury forced him out, but Frank Frisch clouted a homer

with one aboard in the eighth to provide the margin of victory in the Card's 3-2 triumph.

Meanwhile Chicago's Cubs took two games from the Boston Braves in scores of 7-1 and 5-1 to regain some of the ground they had lost in the race for second place. Charley Root and Guy Bush gave the Cubs some fine hurling, the former giving the Braves seven hits and the latter five.

The Brooklyn Robins completed the National League program by winning their first double header since they took the July 4 tilt from the Giants. The victors were the Cincinnati Reds and the scores were 9 to 2 and 8 to 7. The Reds outbatted the winners in the first game and threatened seriously in the second when they scored five runs in the ninth inning.

Pittsburgh and Philadelphia had an off day. Babe Ruth's 33rd home run, which gave him the major league lead, one up on Lou Gehrig, was the big clout of the New York Yankee's 9 to 6 victory over the Detroit Tigers, but it took a three-run rally in the ninth to provide the winning counters.
