ORDER FLEET TO AID FLOOD AREA OF CHINA

United States Asiatic Fleet Mobilized All Useful Units For Duty On Yangtze.

Shanghai, Aug. 22.—(AP)—The United States Asiatic fleet mobilized all its potentially useful units today for emergency work in the great flood stricken areas along the Yangtze river.

Mobilization was carried out in obedience to orders from Navy Department at Washington.

The American navy already has afforded the most valuable aid, its wireless facilities being the only means of communication between Shanghai and Yankow. The Chinese telegraph system was virtually useless.

That branch of the American fleet known as the Yangtze patrol, composed of seven specially constructed river gunboats, put all its reserve units into commission to cope with the extreme problems which it expects to encounter up the river.

The navy carefully surveyed the situation at Hankow and ascertained no Americans were in need of foodstuffs or other aid for the present. The sailors prepared, however, to feed their compatriots if necessary.

American naval officers made known they were ready to aid the Chinese authorities where possible.

Meanwhile, death, destruction and desolation rode the crest of flood waters down the river, causing probably the greatest calamity in modern times.

Unknown thousands had drowned, destitute scores die daily of typhoid and dysentery.

Upwards of 30,000,000 persons were said to have been made homeless by the unprecedented surge of waters in the valley. In the Wuhan cities, Hankow, Wuchang and Haynang, 400,000 refugees were counted.

Hankow presented a picture of destitution. Tearing the native section of this city in a boat an Associated Press correspondent saw thousands of one-story buildings submerged under water that covers the district from 10 to 15 feet deep.

Larger edifices tumbled each hour as waters undermined foundations.

Military authorities, attempting to bring relief to refugees, fought not only the destruction of flood waters, but superstitions, which hold thousands of natives in its grip.

Many refused to move from the danger zone, convinced Hankow was doomed, refusing to help themselves or be helped and sat on their nearly submerged roofs awaiting inevitable death.

String of Jewels Dropped in River

Chicago, Aug. 22.—(AP)—The Chicago Tribune said today that a string of jewels was dropped by accident in the Chicago river near the Michigan bridge, by Mrs. Hugh Dillman, widow of Horace Dodge, founder of the automobile company bearing his name.

Mrs. Dillman was the purchaser of a rope of pearls, known as the necklace of the Empress Catherine II, a part of the crown jewels of the Czars of Russia, but whether these are the jewels she lost could not be learned.

The Catherine pearls have been appraised at \$825,000.

The Tribune said that Mrs. Dillman lost the jewels when she landed from the Dillman yacht several days ago, but added there was some doubt as to whether they were the Catherine pearls, as it had been reported at the time of their purchase that Mrs. Dillman had given them to her daughter, Mrs. H. H. Cromwell of Philadelphia.

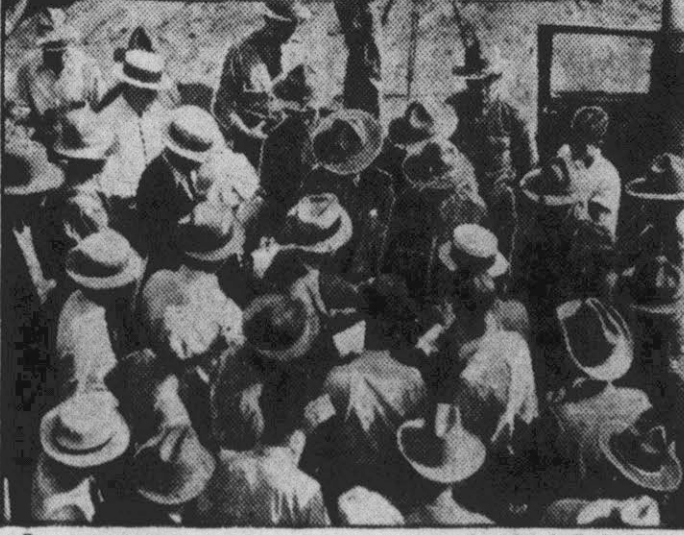
Beauty's Husband Jailed For Theft

MacDonald Government Faces Political Crisis

London, Aug. 22.—(AP)—Prime Minister Ramsay MacDonald and his cabinet, winding up their emergency session on the budget this afternoon, issued the following communique:

"The cabinet has been putting the finishing touches to its scheme which it is believed will meet the situation. The members will assemble tomorrow to hear the results."

The cabinet is caught in a dilemma in its efforts to bridge a gap in the budget estimated at more than \$600,000,000.

The Conservatives insist economies shall hold first place in the program and that drastic cuts must be made in the dole. The general council of the Trades Union Congress holds the situation shall be met by raising additional revenue and there shall be no reduction in the dole. The Liberals oppose a revenue tariff.

DO-X ARRIVES AT MIAMI, FLA

Miami, Fla., Aug. 22.—(AP)—Arriving in the United States on its journey from South America to New York, the German flying boat DO-X, landed here today after a flight from Antilla, Cuba.

The ship was first sighted at 10:45 a. m. EST, coming in over the Atlantic ocean. With its 12 motors droning, it swung over the downtown section, cruised a short distance up the coast, and then settled into the waters of Biscayne Bay some distance off the Dinner Key seaplane base.

Because of the draft of the huge plane, it was anchored some distance off the base and boats put out immediately with customs inspectors and welcoming.

As soon as customs clearance was completed, the officers and passengers were to be brought ashore for welcoming ceremonies. A luncheon by civic leaders was to be followed by various entertainment features during the day and a reception tonight.

Tomorrow a sightseeing tour of the area has been planned with a reception in the evening by German societies of Miami.

Present plans call for the plane to leave Miami Monday on its way to New York.

Shoots Man and Comrades Suicide

Colorado Springs, Colo., Aug. 22.—(AP)—Apparently a victim of mistaken identity, Raleigh M. Black of Charleston, W. Va., a resident of the Union Printers' Home here, was shot and fatally wounded last night by Lewis J. Walker, New York, also a resident, who then committed suicide.

Theodore Scott, former roommate of Black's, said he had been quarreling with Walker and believed he was the intended victim.

Walker shot twice from the doorway of Black's room.

SAYS COTTON MUST GO UP OR FAILURE SURE

Gov. Long Predicts Bankruptcy of South If Cotton Doesn't Go to 20 Cents Soon.

New Orleans, Aug. 22.—(AP)—Twenty cent cotton must prevail in the south in three weeks or bankruptcy will result to farmers and business, Gov. Huey P. Long said in a statement today which he issued as chairman of the steering committee of the New Orleans cotton conference.

"If the cotton growing states will act at once by absolutely prohibiting the planting of cotton for 1932 as recommended by the cotton conference held in New Orleans yesterday, the farmer will get the benefit of the best price for the biggest crop they have ever raised. If they will not do this, then we have nothing but calamity for the cotton farmer."

"Louisiana can be counted on as having as good as passed the law already. Prior to the adoption of the plan, a large majority of the members of the Louisiana Senate and House voluntarily endorsed the plan, and I am prepared to call the Legislature together within a few hours after the bill is written and looked over, and within four days secure the enactment of legislation prohibiting the planting of cotton in Louisiana for the year 1932, provided similar action is to be taken in a sufficient number of other states."

"Any amendment or modification of the plan will be fatal. It must be an entire 100 per cent prohibition against cotton planting for 1932 or nothing. I urge every county in the cotton growing states to immediately hold meetings and call upon their Legislators and their governors to adopt this plan. It is up to the governors and legislators of the south whether we shall have twenty-cent cotton in three weeks or bankruptcy."

Will Discuss Relief Plan

President Hoover and Walter Gifford To Outline Details While In Camp.

Washington, Aug. 22.—(AP)—Pleased with the response to his unemployment relief plan President Hoover today was prepared to work out its preliminary details with Walter S. Gifford, newly appointed director of the administration's activities in the field.

The personnel for carrying out the President's idea that relief should be furnished by local communities, counties and states, in addition to Gifford, included Fred C. Croxton, his assistant, and 30 odd members of an advisory committee.

Of 60 prominent men and women asked to service with Gifford, 52 accepted the invitation yesterday, 2 declined on account of illness and six had not been heard from. Mr. Hoover expects to add to the list, probably after the week-end conferences. Several sections of the country not now represented will have members before the committee personnel is completed.

Responses to his invitations to serve with Gifford were described by President Hoover as being "splendid."

Many communications from public officials and voluntary organizations are being received, he said, indicating much reorganization and planning now in progress in preparation for relief work for the fall and winter.

There is a very evident widespread resolution to meet the situation again, he said. "I cannot speak too highly of the actual results obtained by the multitude of committees and public authorities over last winter."

HOOPER AGREES TO LET BUTLER GO

Washington, Aug. 22.—(AP)—The stormy figure of Major General Smedley Darlington Butler is soon to pass from the Marine Corps.

President Hoover yesterday said he would be willing to grant the fighting marine's request for retirement with the understanding that his services will be readily available in time of war.

Six Slain In Gun Battle Between New York Police And Two Payroll Bandits

DOZEN PEOPLE ALSO WOUNDED

Two Policemen, One Robber and Taxi Driver Killed Outright; Other Robber and Baby, Hit By Stray Bullet, Die In Hospital; \$4,619 Payroll Recovered.

New York, Aug. 22.—(AP)—Six persons were dead today—one of them a baby—because two young thieves coveted a canvas bag and the \$4,619 payroll money it contained.

The money was recovered intact on the floor of the robbers' bullet-punctured cab. The price it cost after a 90-minute, running gun fight, across the Bronx, was the lives of two police officers, the two highwaymen, a taxicab driver—and four-year-old Gloria Lopez.

Twelve others, including policemen and firemen who plunged into the pursuit late yesterday afternoon, were wounded or injured, two seriously.

The first to die was Walter D. Webb, a police officer assigned to guard the payroll of the Mendoza Fur and Dyeing Company. He was shot, down without mercy.

That murder, occurring shortly after four o'clock, precipitated the carnage that followed.

The shooting was just outside the company's offices on East 133rd street. The robbers, one of whom held the canvas bag with the payroll while his right hand still clutched a pistol, abandoned their car at 163rd street, transferring to a taxicab.

Police have not determined whether the taxi driver, Herbert Hase, was in league with the bandits, or became an unwilling accomplice at the point of their pistols. He died before the shooting match was ended.

Hase, driving wildly north with his cargo of killers was challenged by Motorcycle Policeman Edward Churchill who raced after the cab and fired. Spurring flames stabbed back at him from the guns of the robbers, and one of the crack members of Central Park motorcycle squad number 1 fell dead from his machine. The riderless motorcycle shot across the street and piled up against the curb.

Vincent Hyde, a city fireman off duty who had witnessed the slaying of the motorcycle policeman and has picked up the officer's gun and fired at the fugitives, was shot down and seriously wounded. Five other persons were wounded before the bandit car, doubling back toward 163rd street, passed out of range.

Other traffic in the street was imperiled. In one of the passing machines, was the Lopez family, with Baby Gloria. It was caught in the crossfire from the fleeing gunmen and pursuing policemen. A bullet struck the child in the head.

At Morris avenue and 162nd street two more police officers were shot down, wounded, as the killers' cab raced ahead.

Finally at Dyckman street and Sherman avenue, a commandeered taxicab, carrying police officers cornered the killers' car at the curb, after a shot had torn a hole in the gasoline tank, and a truck had been backed into its path, all unwittingly by its driver.

In the face of fire from the bandits' machine, the police closed in, pistols blazing. Half a dozen other pursuing cars arrived.

Hase, the dive, and John Precht, one of the robbers were killed outright. The other bandit, Martin Bachorik, was fatally wounded, dying shortly afterward in a hospital.

In a pool of bandit blood on the cab floor was the payroll, unopened.

HOLD WOMAN IN TORCH SLAYING

Sweetheart of One of Three Killer Charged With Being Accessory to Crime.

Ann Arbor, Mich., Aug. 20.—(AP)—A warrant was issued today charging Catherine Keller, 25 year old sweetheart of Fred Smith, one of the three torch killers who slew and burned two young couples last week, with being an accessory to the crime in withholding knowledge of the slayings from authorities.

The warrant was issued by Justice of the Peace Jay H. Payne on recommendation of Prosecuting Attorney Albert J. Rapp.

Miss Keller was arrested a week ago Thursday night at her home in Ypsilanti after officers had returned from escorting Smith, David Blackstone and Frank Oliver to the state prison at Jackson. Deputy William Dailey and Detective Lieut. Neil R. Black of the state police reported finding bloody clothing belonging to Smith and a revolver which the girl said she had loaned to Smith on occasions.

The authorities said they are convinced that Miss Keller knew about the killings the night they were committed, whether or not she had been present at the actual slayings, and that her failure to communicate this knowledge to the officers made her an accessory after the fact to the crime.

BEGIN FINAL ARGUMENT IN TRIAL OF LEA

L. P. McLendon Makes Final Speech For State In Asheville Bank Case.

Asheville, Aug. 22.—(AP)—L. P. McLendon, special attorney for the state, delivered the final argument for the prosecution today in the trial here of four men accused of defrauding the Central Banking and Trust Company, of Asheville, of \$3,000,000.

After the closing of arguments Judge M. V. Barnhill recessed court until Monday when he will charge the jury and give the case to it. He cautioned the jurors just before recessing court not to make up their minds until they have heard his charge.

Colonel Luke Lea, Nashville, Tenn., publisher and financier, is on trial with his son, Luke Lea, Jr.; E. P. Charlett, a business associate, and Wallace B. Davis, who was president of the Central bank when it closed last November.

The state alleges the four conspired to defraud the bank and that the sum was actually misappropriated. Conviction on the conspiracy count carries a maximum sentence of 10 years imprisonment, a \$5,000 fine, or both.

A maximum penalty of 30 years imprisonment, a \$10,000 fine or both is prescribed by statute for conviction of misappropriation.

More than 1000 persons, drawn by the pyrotechnics of the attorneys' arguments, were in the courtroom as McLendon began speaking. Only a scattered handful heard the highly technical evidence.

McLendon spent much of his time in arguing the state had produced convincing evidence of a conspiracy.

He was interrupted by laughter from the crowd as he said Davis and Lea had planned a holding company and described it as "a company to get everything and hold everything."

The attorney read numerous letters already in evidence to support his contention that there was a conspiracy.

"No matter what happens down through the years, when man's memory has lost the picture of this trial, that boy," he said pointing to the younger Lea, "can stand up and say, 'I wrote them a letter.'"

He then read a letter from the publisher's son to J. Charles Bradford, who was cashier of the Central Bank and Trust Company, asserting it set forth details of what he described as "Lea-Davis infrenzied finance."

The letter, referring to efforts to reconcile the bank's books with Lea's books, said:

"We still have to account to you for \$100,000 worth of certificates of deposit. ... This does not take into consideration cashiers checks and certificates of deposit."

McLendon argued the sentences were proof of conspiracy from the Lea to use the bank's credit for their personal benefit.

"If Davis and Lea had no agreement," he said, "I ask you how Lea could have known that \$100,000 loan would be approved so he could draw checks on it, as he did two days before it was presented to the bank's executive and finance committee?"

"I can show you how he knew. Look at this letter to Davis, signed by Col. Lea, saying Lea enjoyed Sunday dinner with Davis and his wife a day or so before the loan was made. He and Davis had it all framed up. That's how he knew he could go ahead and write those checks."

B. F. Shelton Buried At Speed Today

B. F. Shelton, 74, former senator and master farmer, who died at his home in Speed Thursday night at 10 o'clock, was buried this morning at 10 o'clock in the Speed cemetery.

He was a member of the board of commissioners of Edgecombe county, and was one of the leading citizens of the community. He was a progressive farmer and was classed among the few master planters of the state by reason of his effort to develop the agricultural life of the section in which he lived.

He is survived by his wife, two daughters, Misses Annie and Ethel Parker; three sons, B. F., Jr., Henry and Hugh Shelton.

He is also survived by a number of relatives in Greenville and vicinity and the majority attended the funeral services.

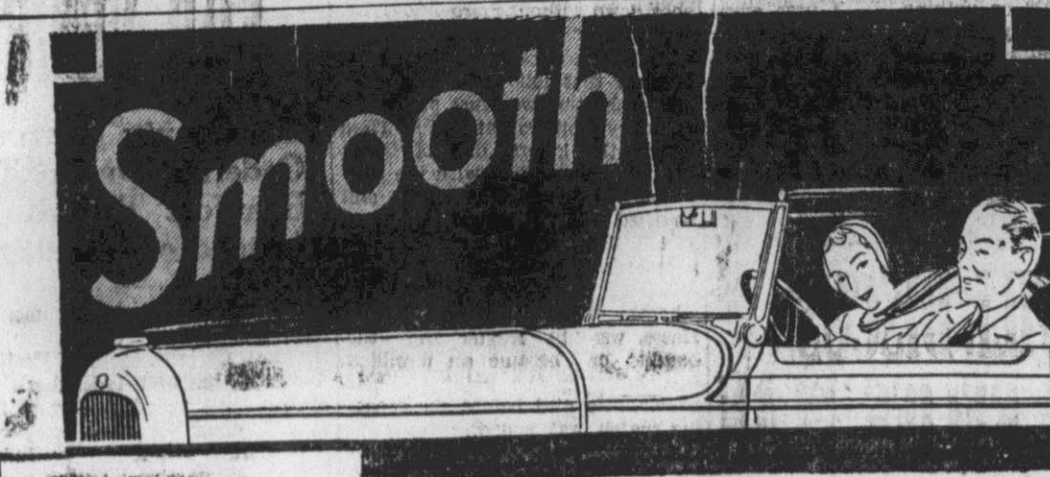

N. Y. COTTON

New York, Aug. 22.—(AP)—Cotton opened steady today, 10 to 11 points higher in response to relatively firm Liverpool cables.

The initial demand was quite readily supplied by liquidation, cobbed with local and southern selling, but there was some trade buying and week-end covering continued, giving the market a fairly steady tone. At the end of the first half hour December was selling around 7.03 and March 7.32 or about 10 points net higher.

Liverpool cables said the advance there was due to covering together with continental and Bombay buying but reported the British home trade in cotton cloths quiet, and Shanghai auction results unsatisfactory. The New Orleans resolution favoring a reduction in the cotton acreage through legislative action, was not generally referred to as an immediate market factor.

All deliveries of corn gave way under liquidating sales, and sold at a new 1931 bottom. Wheat was dragged down by corn. Almost the only market reaction from the Farm Board's exchange of 25,000,000 bushels of wheat for 1,000,000 bags of coffee from Brazil was to draw out caustic comments from traders. One suggestion was that other countries might offer to barter for American wheat. England offering rubber, China offering tea, Spain olive oil and Germany dyes, chemicals and toys.

Corn closed unsteady 3-4 to 13-8 down at the lowest figures reached; wheat 3-8 to 5-8 off oats showing 1-8 to 3-8 decline and provisions set back 12 to 25 cents.

STOCK MARKET

New York, Aug. 22.—(AP)—Financial markets ended the week in a highly uncertain trend today.

Trading in stocks came close to a standstill, and prices worked irregularly lower, although there was some stiffening toward the close, and losses in prominent issues were largely fractional. The bond market was dull, and there was some let-up in the recent pressure against the rail obligations.

Indications that the MacDonald government was reaching a crisis in England, in its efforts to effect an economy program, was an unsettling influence, and there was talk in brokerage circles of a little selling of stocks for foreign account.

Despite the better showing in rail bonds, which was not particularly convincing because of the extreme dullness of the market, rail shares were under moderate pressure. New York Central sold off nearly two points to a 10-year low on publication of its mid-year balance sheet, showing a reduction of surplus of \$12,000,000 since the first of the year.

The oil shares were steadied by further advances in crude oil and gasoline prices by various companies, but made no further important progress on the inside. Standard of California advanced more than a point on confirmation of reports that the merger with Standard of N. J. was again being discussed, but then lost most of that advance which had carried it out of line with New Jersey. A share for share exchange is generally looked for.

American Telephone, American Can and U. S. Steel sold off a point or so, then recovered to close virtually unchanged. Net losses of a point or two were recorded, however by Case, Eastman, Allied Chemical, Coca Cola, Sears Roebuck and Johns Manville. Air Reduction, on the other hand, advanced a point.

Foreign exchanges were narrowly irregular. Sterling cables eased only a shade, ruling at \$4.85 15-16, on news indicating that cabinet crises may have arrived. The Argentine peso was again a little firmer.

RUTH HITS HOME RUN, YANKS WIN

Babe Ruth has made 600 home runs in his major league career. In the third inning of the Yankee-St. Louis game yesterday he drove one of George Bleaeholder's offerings far over the bleacher roof at Sportsman's park. It was his 35th four-bagger of the current season and brought his total for the 18 years of his major league career up to 600, a mark never before attained or even threatened by any other major leaguer. The Babe reclaimed the pilet from the youngster who found it out in Grand Boulevard, in exchange for \$1 Oread and a new autographed ball.

The homer started the Yanks off on the winning rally in their 11-7 victory over the Browns. Lou Gehrig duplicated the swat a moment late and before the inning was over the Yanks had five runs and the game safely tucked away.

A few other American league teams tried to duplicate the Yank swatting feats in yesterday's game. Philadelphia's champion Athletics, and the Chicago White Sox hammered out 24 hits between them although the Sox had a 14-10 edge in the hitting. Philadelphia won 15 to 12. Ten walks by the Chicago pitchers and three errors proved too much of a handicap for the Sox to overcome while two of the A's "junior varsity," Roger Cramer and Dib Williams, came through with timely homers.

Washington's batters ranned out a total of 15 hits off Clint Brown and Pete Jablonowski to take the fourth game of the series from Cleveland, 6 to 3, after losing the first three. Lloyd Brown held the Indians to six hits.

Boston and Detroit produced hits in their class, but seven bases on balls off Eddie Durham and Wilcy Moore more than made up for the absence of blows and the Red Sox tossed in five errors to make things easy for the Tigers to walk off with an 11 to 5 triumph. Yesterday's defeats left Boston and Chicago tied for sixth place.

Only one game in the National league survived a spell of threatening weather. In it, the Boston Braves took a close battle from the Pittsburgh Pirates by a 2 to 1 count to increase their margin to 11-2 games in the struggle for fifth place. Wally Berger's 17th homer of the year was the important blow as Ben Cantwell held the Pirates to six hits while Boston made seven off Ervin Brame.

CAPS DEFEAT PATS 13 TO 7

Charlotte, Aug. 22.—(AP)—It seems that every time Raleigh wins a game, Charlotte wins one too, thereby cancelling the Caps' great effort to gain on the Piedmont league leaders.






