URGES HOOVER TO ACTION IN COTTON CRISIS

Gov. Gardner Thinks Special Session Of Congress Needed To Deal With Situation.

Shelby, Aug. 26.—(AP)—Because he believes cotton is an international and not sectional commodity, Governor O. Max Gardner today had called upon President Hoover to convene a special session of Congress to consider the cotton crisis.

Governor Gardner, in a statement issued from his home here yesterday, termed state legislation compelling abandonment of cotton "unsound" without some binding agreement with foreign growers to regulate their crops.

He pointed out that last year the United States produced 13,753,000 bales and foreign countries produced 11,724,000 bales. These figures, he said, clearly indicate that "cotton is not merely a sectional crop confined to the south but is a national and an international commodity."

"Before any governor calls a special session of the legislature," he said, "and as a condition precedent thereto, the President should call Congress into immediate session and lay before the states and foreign governments that grow cotton the absolute necessity for unified action and control."

"The several states can make no treaty with foreign growers. That is solely the function of the federal government."

"This movement should begin with a unified policy adopted by the national government and come down to the producing states, instead of beginning in confusion with the several state legislatures and finally heading up in Congress."

Columbia, S. C., Aug. 26.—(AP)—Devolving his time to the pressing cotton question, Governor Blackwood today pushed his movement to sound out sentiment among legislators and farmers on his proposal to call an extra session of the legislature to enact laws making it illegal to plant cotton next year.

He planned today to write members of the General Assembly, and solicit their views.

Under a proclamation issued last night, farmers of the state are called upon by the governor to meet at the various courthouses at 11 o'clock Saturday morning to express themselves on the governor's program.

Attention in Columbia today also centered on the meeting planned here by Senator Ellison D. Smith, who is working for his cotton plan which differs from that of Blackwood. He would have the Farm Board buy cotton from the farmers, store it, and re-sell it to the growers next year. Farmers would contract not to plant the staple next season.

Lumberton, Aug. 26.—(AP)—A \$5 excess acreage tax is the solution of the cotton problem, in the opinion of former Governor Angus W. McLean.

"Cut cotton acreage one-half in 1932 and let the cotton-growing states agree on a tax plan by which each cotton farmer would be allowed so many acres, tax free," suggested North Carolina's former chief executive, "and impose a privilege tax of \$5 an acre in excess of the amount allotted."

McLean says he considers it impractical to eliminate all cotton next year, as proposed by Governor Long of Louisiana. There are too many sections, he said, where farmers can't grow any other money crop.

Deal Death Blow To Rum Ring On Coast of N. C.

Wilmington, Aug. 26.—(AP)—With four men under arrest and the confiscation early yesterday of large quantities of liquor, federal officers here believe they have delivered a death blow to a rum syndicate operating along the North Carolina coast.

Prohibition agents under the direction of O. A. McCaskill swooped down on a lonely farmhouse two miles south of Shallotte, N. C., and rounded up the quartet, 185 cases of foreign whiskies and a truck.

Those arrested gave their names as Lennox Gore farmer, in whose barn the liquor was stored; James Crosby, alleged driver of the truck; F. J. Aldredge, who recently claimed a truck seized in a raid on the Lockwoods Ferry river, and "Chuck" Cummings, son-in-law of Aldredge.

Aldredge and Cummings were victims of a ruse carried out by prohibition agents Herman Barbary and S. L. McDuffy, who drove the truck to the Gore place under the guise of obtaining a load of liquor.

The agents, when invited to drive the vehicle into the rear yard and load a supply, arrested the two men.

CHILD UNHURT IN FALL HERE

Jean Baker Suffers Only Bruises In His Plunge from Second Story Window.

Jean, the two-year old son of Mr. and Mrs. A. P. Baker, had a miraculous escape from serious injury or death this morning when he fell from a second-story window of his father's studio in the Flanagan building on Evans street.

The child was immediately rushed to the hospital for medical attention, but an X-ray examination failed to disclose any broken bones. He was suffering severely from fright and bruises, however.

The baby climbed into the window while playing around in the studio, lost his balance, and toppled off the window sill into space. His body landed on an awning about four feet below, rolled down to the edge and hurtled about eight feet to the sidewalk.

A pedestrian picked the child up from the pavement and rushed it to the studio, from where it was immediately removed to the hospital for examination.

The baby landed on the pavement in a sitting position and fell over against the bumper of an automobile which had been backed up against the curbing at that point. A bystander said the body first hit the bumper and then the pavement but this statement was discounted by reason of the fact that it was believed such an impact would have produced more serious injury.

After examination at the hospital, the youngster was returned to the apartment of his parents at the studio. He was reported as resting comfortably, but was in a highly nervous condition as the result of his breath-taking spin through the ether.

"Wet" Candidate For Senate Hits Traffic Barriers

High Point, N. C., Aug. 26.—(AP)—Robert R. Reynolds, Asheville attorney, ran into traffic barriers here yesterday as he attempted to launch his campaign for the United States Senate on a wet ticket.

The candidate showed up at a public headquarters with a summons card for traffic violations and asked to be permitted to make bond.

The charges were quashed by Sergeant Eugene Parrish, who commented "I think you have a tough time ahead, anyhow."

BANK FAILS TO RECOVER

Belvoir Township Man Emerges Victorious in \$12,000 Civil Suit Here.

The Norfolk National Bank & Trust Company failed to recover in its suit against D. J. Holland of Belvoir township, Pitt county, a director of the Bank of Commerce.

A jury in the civil term of Pitt County Superior Court last night returned a verdict denying the claim of the bank for the recovery of \$12,000 from the plaintiff. The suit was the outgrowth of a deed of trust which Holland was said to have executed to his wife and in which the bank claimed it was involved.

The case was begun Monday morning and was not completed until about 7:30 last night. The jury remained out about an hour.

Court this morning began hearing the case of R. S. Atkinson against Greenville Oil & Fertilizer Company, in which the plaintiff is asking for \$120 a commission on the sale of a piece of land which he sold for the company.

Hawks Shatters Old Records on Flight to N. Y.

Captain Frank Hawks, making a non-stop flight from Atlanta to New York, roared across the Carolinas today leaving in his wake a trail of shattered records.

The speed aviator clipped four minutes from the old record in flying the first leg of the trip from Atlanta, Ga., to Greenville, S. C., in 46 minutes.

Hawks attained an average speed of 230 miles an hour when he set another record from Greenville to Spartanburg, S. C., by negotiating that distance in six minutes.

At Greenville, 5,000 persons greeted the airman and his mother, who is flying to New York. Hawks was presented with a good luck charm at Greenville by Boy Scouts. The memento had been carved from a piece of the hull of "Old Ironsides" Mrs. Hawks was presented with a bouquet of roses and a bolt of cloth made there.

He remained 22 minutes at Spartanburg before taking off for Charlotte, N. C., where he arrived at 11:25. Hawks is accompanying a plane bearing his mother from Ft. Worth, Tex.

Today's hopping was begun at Atlanta, Ga., which he left at 9:08 o'clock. Between the Georgia capital and Greenville, he said, he averaged 195 miles an hour.

JOHN YOUNG CARRIES GUN

Two Policemen Give Protection Following Threat of Gang Over Telephone.

New York, Aug. 26.—(AP)—Telephone threats against his life have put John S. Young, radio announcer, on his guard.

Not only is he carrying a gun under an official permit in defiance of any possible activity against him but two policemen were assigned to him today to give him a helping hand.

The threats, believed to have been made either by gangsters or cranks, followed Young's appearance as announcer at the broadcast of the New York City anti-gangster rally on Monday night by WJZ of the National Broadcasting Company.

Shortly after noon yesterday he was called on the phone. "You're a wise guy," said a voice sounding like that of a young man. "Your life might be worth only two cents to you, but it's worth thousands to NBC. We'll teach you wise." (Continued on page three)

DECLARE WAR ON ROOSEVELT

Tammany Hall Leaders To Fight New York Governor To the Last Ditch.

Albany, N. Y., Aug. 26.—(AP)—Franklin D. Roosevelt, Democratic governor of New York, and Tammany Hall have reached the parting of the ways.

Angered because the Governor yesterday refused their request for an investigation of alleged graft and corruption in Republican controlled cities upstate, Senator John J. Dunningan and Assemblyman Irwin Steingut, Democratic leaders, said they would "fight to the last ditch" the recommendation of Mr. Roosevelt that the Hofstadter committee investigating New York City be empowered to grant immunity to witnesses.

The declaration of war against the legislation was accepted generally as warfare upon the executive who recommended passage.

Senator Dunningan characterized the Hofstadter bills as among the "most unfair, unjust, inhuman, despotic, high handed and unnecessary bills ever sponsored by a major political party for purely political reasons."

"My present attitude," Steingut said, "is this: I shall decline to vote for any measure that puts a stamp of approval on the stool pigeon or tattler."

While the Democratic minority members probably will have opportunity in debate to refer to alleged corruption upstate, they will be powerless to introduce investigatory bills. The only way in which they could initiate such legislation would be through a supplemental message from the governor.

When asked if the door was open for an upstate investigation, Roosevelt replied, "I don't see it, do you?" "I have no expectation at present of sending an upstate investigation message."

Freeze Heads Odd Fellows

Raleigh, Aug. 26.—(AP)—Frank B. Freeze of Mooresville, today was the new Grand Patriarch of the Grand Encampment of North Carolina Odd Fellows.

Mr. Freeze was elevated yesterday from the position of Grand High Priest to the successor of R. D. Watson of Winston-Salem retiring head of the fraternal order in this state.

NEW MINISTRY IS LAUNCHED IN GREAT BRITAIN

Retiring Ministers Of Old Regime Visit King and Hand Over Seals of Office.

London, Aug. 26.—(AP)—Ramsay MacDonald's second labor government passed into history today in the presence of King George and his first non-partisan ministry was formally launched on its mission of balancing Great Britain's books.

The King received the retiring ministers of the old regime at Buckingham Palace and they handed over their seals of office. An hour later the tri-party members of the new cabinet called on him and he convened a privy council at which they were sworn in.

About 2,000 people stood outside the palace as the resigning officials came to surrender their authority. No longer using the official title of "His Majesty's Ministers" (Continued on page three)

TWO DEATHS IN FOREST FIRES

Gold Mine and Dozen Homes Also Destroyed By Raging Flames In Idaho.

Bois, Idaho, Aug. 26.—(AP)—Fire sweeping through the forests of central Idaho has added to its toll of destruction a valuable gold mine, a dozen homes and the lives of two fire fighters.

The burned bodies of Nolan Warner, 28, Fillmore, Utah, and Howard Harvey, Boise, were found on a ridge between Pioneerville and the south fork of the Payette river late tonight.

Reports said the men were trapped between the main fire and a spot fire which broke out behind them.

The wall of flame raging on a 20 mile front, broke through trenches on both sides of Grimes Pass, first sweeping the \$250,000 Golden Age Mine and several residences. The fighters fled.

Nearby, homes around the Mineral Mining Company mine was destroyed.

A group of National Guardsmen, members of a band of 100 sent to aid the civilian fighters, were routed by flames, which spread a huge crescent about them. They scrambled into trucks and escaped, leaving one of the trucks to burn.

Grimes Pass remained isolated as the fire continued to rage around telephone lines which were burned down during the night. Last reports said fire lines were holding and pumps were working.

Warner and Harvey were the first victims of the flames which have been licking at the doorsteps of a cluster of mining villages, ranch homes and mines for more than a week. Two other mines and two hamlets have been wiped out.

Spokane, Wash., Aug. 26.—(AP)—Eight new forest fires, seven of them described by officials as incendiary, burst out of control before high winds in Western Montana and southeastern Washington last night.

Federal officers at Colville, Wash., said the arrest of a 15-year-old Indian boy had solved at least six incendiary fires. The boy said he set them to see the smoke and flames.

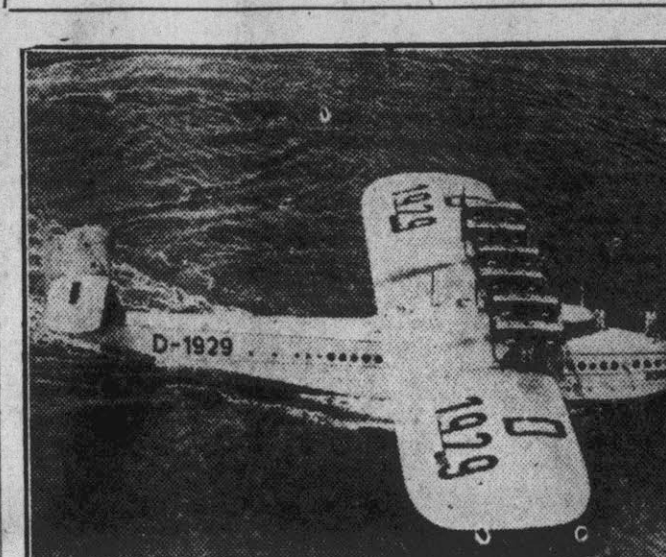
Agronomists Visit Experimental Farm

Raleigh, Aug. 26.—(AP)—Tobacco fields at Oxford and the varied crops grown on the North Carolina State College experimental farm near here today furnished 75 agronomists with further material for their scientific study of this state's fields, crops and soils.

The party of representatives from Florida, South Carolina, Tennessee, Delaware, Texas, Maryland, Alabama, Georgia, Virginia, Mississippi and the District of Columbia, arrived here last night from Chadbourn, where an inspection of strawberry growing was made. The party left Wilmington Monday.

Lunch at Duke University, Durham, and a visit to the University of North Carolina at Chapel Hill, were on today's program. Tonight will be spent at Salisbury and tomorrow the tour will be continued to Asheville, where the party will disband.

DO-X REACHES NORFOLK



Norfolk, Va., Aug. 26.—(AP)—The DO-X, giant German flying boat reached the Hampton Roads naval air station at 11:30 o'clock today after a flight from Charleston and flew over the City of Norfolk before landing. Thousands turned out on the streets to get a glimpse of the huge craft.

After circling over the city the DO-X alighted in Little Bay, off the naval base. Preparations were immediately begun for landing the crew and passengers, and for refueling the ship for the flight to New York.

PEOPLE FIGHT TO SEE LINDY

Crowds Battle With Police at Tokyo In Effort to Get a Peep at Flier.

Tokyo, Aug. 26.—(AP)—Men, women and children fought the police here today in a wild scramble to get a glimpse of Colonel and Mrs. Charles A. Lindbergh.

The famous couple entered Tokyo by train this evening after landing at Kasumigaura naval base, 50 miles from the capital, the official terminus of their 7,132 mile flight from New York.

At Ueno station the Lindberghs encountered probably the most dense crowd in their experience. Several times while the fliers and their official party were being seated in limousines the crowd became unmanageable and for a time it looked as though the Lindbergh automobile would be overrun.

The police were taxed to the utmost to keep the crowd away.

By JAMES P. HOWE Tokyo, Aug. 26.—(AP)—Col and Mrs. Charles A. Lindbergh today reached the official terminus of their 7,132 mile flight from New York to Tokyo, landing amid a thunder of cheers at Kasumigaura naval base, 50 miles from here, after a 613 mile hop from Nemuro.

Bringing their plane to the surface of the naval base lagoon at 2:09 P. M. (12:09 A. M. EST) while an enthusiastic crowd raised a chorus of Banzais, Colonel and Mrs. Lindbergh stepped ashore to receive the first of Japan's greetings from Admiral Abo, minister of the navy.

The crowd surged forward, looking for a close-up view of the famous couple, but sailors held it back. The Lindberghs seemed somewhat shy at first, but after shaking hands with Admiral Abo, W. Cameron Forbes, American Ambassador, and other officials, and seeing their plane receiving careful attention at the hands of sixty sailors they appeared at ease.

In greeting the Lindberghs Admiral Abo paid tribute to the colonel for his nonstop flight from New York to Paris in 1927, adding: "I am heartily glad for the opportunity of meeting personally such a gallant figure as Lindbergh in my own country, and especially in our naval airport."

Then, smilingly turning to Mrs. Lindbergh, he praised her as the first woman to fly across the north Pacific Ocean, and said: "We have the greatest admiration and respect for your courage and endurance, Mrs. Lindbergh. In (Continued on page three)

START WORK ON STOCKYARD

Atlantic Coast Line to Erect Livestock Pen Back Of Freight Depot.

Greenville's stockyards will become a reality in the near future. Construction work started on the new project this morning and will be rushed to completion in time to take care of the first shipment of stock to be made from this point September 10.

The yards are being erected by the Atlantic Coast Line railroad and will be back of the freight depot in the southwestern part of the city. Scales will be furnished by the Pitt County Department of Agriculture.

The stockyard will be of inestimable value to the growers of the county, members of the Board of Agriculture said, in that it will afford a centralization point for all shipments of this kind, and provide all facilities to expedite the handling of livestock.

Although one shipment of hogs has already been made from the county, E. F. Arnold, director of the Board of Agriculture, stated today that they were making arrangements for the shipment of two carloads of hogs probably on September 10. Each of the shipments will be handled at the stockyard.

A railroad construction crew began work at the stockyard site early this morning, and it was said this would be completed in ample time to take care of the next movement of stock. In fact, completion of the yards proper and installation of the scales will require only a few days, and when that has been completed the place will be ready for the first offerings of county growers.

Flying Brokers Off for New Orleans

New Orleans, Aug. 26.—(AP)—Captain James Goodwin Hall, New York broker and Andre De Coppet, landed here on their non-stop flight from New York today at 10:15 a. m. (CST).

Captain Hall left New York at 4 a. m., today, making the non-stop flight in 7 hours and 14 minutes. He said he believed he had established a record between the two cities.

The fliers beat their way through stormy weather in the wadup of their flight and alighted in New Orleans in a rainstorm. The return trip will be held up pending clearing weather, they said.

MAKE CHANGE IN SENTENCE OF YOUNG LEA

Judge Barnhill Tacks Suspended Jail Sentence To Fine of \$25,000.

Asheville, Aug. 26.—(AP)—Judge M. V. Barnhill today changed the sentence of Luke Lea, Jr., convicted yesterday of conspiracy to defraud the Central Bank and Trust Company, from a fine of \$25,000 to 6 years in prison on a \$25,000 fine, the prison sentence to be suspended upon payment of the fine.

Lea, son of Col. Luke Lea, of Nashville, Tenn., former United States senator, was convicted with his father and Wallace B. Davis, who was president of the Central Bank and Trust Company. The bank failed last fall.

Judge Barnhill's change in the younger Lea's sentence had the effect of eliminating the necessity for the 23-year-old Tennessee to post a bond to guarantee payment of the fine pending an appeal to the State Supreme Court.

An appeal bond of \$10,000 for Luke Lea, Jr., was fixed by Judge Barnhill yesterday. If the sentence had not been changed, he would have been required to post the \$10,000 and additional bond of \$25,000 to guarantee payment of the fine.

Under the new sentence, \$10,000 will be his entire bond. The sentence was changed after a conference of attorneys and Judge Barnhill. It was made to read one to three years on one count of conspiracy, sentence to be suspended upon payment of a \$10,000 fine; one to three years on another count of conspiracy, sentence to be suspended upon payment of \$5,000 toward the cost of the case and two to four years for misapplication, the sentence to be suspended upon payment of a \$5,000 fine and \$5,000 toward the cost of the case.

Judge Barnhill stipulated that the prison sentences for conspiracy and misapplication be served concurrently.

After changing the younger Lea's sentence, Judge Barnhill adjourned court until 2:30 P. M.

At that hour Judge Barnhill will receive the appeal bonds of the convicted men if they present them. Col. Lea, found guilty on the same counts as his son, was sentenced yesterday to six to 10 years imprisonment while Davi was given four to six years. Col. Lea's appeal bond was set at \$30,000 and Davis' at \$10,000. They were given 90 days to perfect their appeal to the Supreme court.

Nashville, Tenn., Aug. 26.—(AP)—D. D. Robertson, state superintendent of banks, in a statement today, accused J. I. Reese, state commissioner of insurance and banking, of making an "unqualified misstatement" regarding the use of certain Tennessee records in the trial of Colonel Luke Lea and three others at Asheville, N. C., on charges of defrauding the Central Bank and Trust Company there.

The records were those of the Liberty Bank and Trust Company, Nashville, of which Robertson is statutory receiver. He charged Reese told him in a telephone conversation a misjunction had been issued, restraining the removal of the records to North Carolina but that he learned no such injunction had been issued.

"It would not be necessary," Robertson's statement said, "for me to comment upon Mr. Reese's statement except for his unqualified misstatement to the effect that in a conversation with him, I expressed the wish that he should restrain me or interfere in the matter so as to prevent these records from going out of the state. No such conversation ever took place, and no such request or suggestion was ever made by me at any time, and no such though, ever entered my mind."

Gandhi To Attend Round Table Meet

Stima, India, Aug. 26.—(AP)—Mahatma Gandhi has agreed to take part in the second round table conference and will sail for England next Saturday, it was officially announced today.

The announcement that Gandhi would attend the conference came after a talk he had with Viceroy Willington this morning. It was said to have been highly satisfactory and that the conclusions would be issued in communique form. Gandhi is leaving at once for Bombay.

The Mahatma had previously said he would not attend the conference unless the viceroy appointed an impartial arbitrator to sound to hear his charges that dress had been used in collecting revenue taxes from peasants.

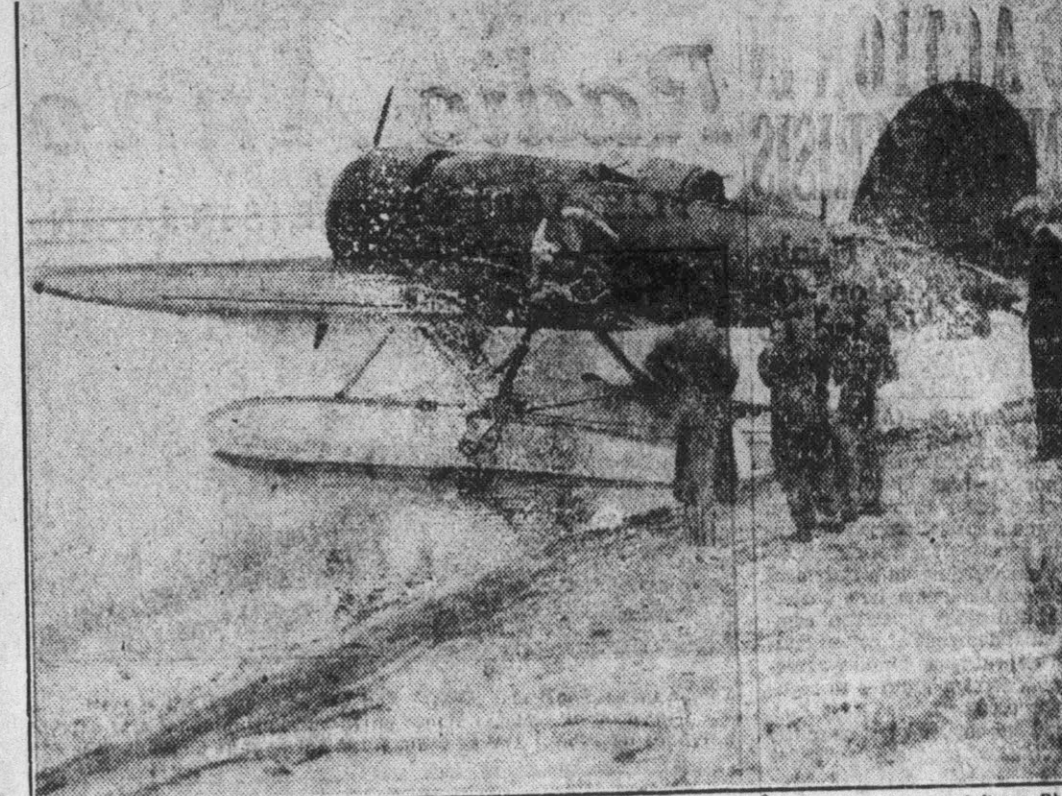

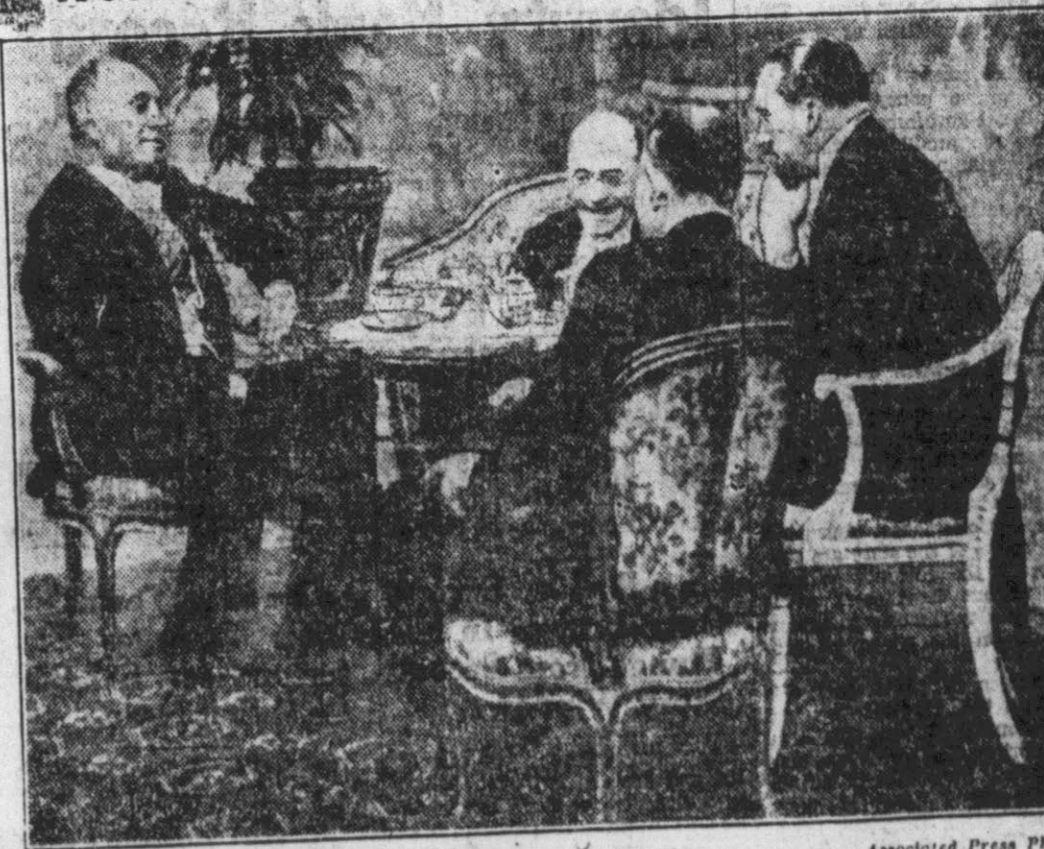

Eleven Pitt Men Compose Jury in Cartaret County

Beaufort, Aug. 26.—(AP)—An 11-man jury this morning began the hearing of evidence in the case of Cartaret County against former officials and contractors.

Two civil actions totalling \$800,000 named as defendants W. L. Stancil, county auditor from 1920-1928; G. W. Huntley, former commissioner, F. M. Simmons and his firm, Simmons Construction Company, George J. Brooks and C. K. Howe.

After the jury yesterday had been empanelled from a special Pitt County venire, Clarence Vincent, one of the members, became ill, but the defense and plaintiff agreed this morning to proceed with 11 peers.

The county alleges that it was defrauded of large amounts of money by the defendants in connection with a large road building program from 1924-1928. The county charges that several contracts were illegal, that non-competitive bidding was practiced and that inferior materials were used.

The county also contends that Stancil and Huntley represented the county without authority in several deals and that the two were guilty of derelictions in office. The defense has set forth that the roads were accepted by the county after being properly inspected by agents of the plaintiff.

IDENTIFY BANK RECORDS IN BISHOP CANNON CASE

The committee is seeking to determine the disposition of more than \$65,000 given to the bishop by E. C. Jameson of New York for use in the campaign and whether the law was violated in failure to report expenditure of all the funds.

John A. Booker, cashier of the Citizens Bank and Trust Company of Blackstone, Va., related that the Southern Methodist churchman had a checking account in his bank for 20 or 30 years.

Chairman Nye of the committee observed the Blackstone account showed "a total of Cannon notes for an even \$5,000."

One of the notes, he said, was for Edward Cannon.

"The record shows," continued Nye, "\$5,000 in Cannon notes were paid off between the period from June 1, 1928 to March 2, 1929."

Booker said that was the fact. Looking over the statement Senator Dill Democrat, Washington, said "It is evident that a number of political contributions of one and two or more dollars were put into this personal account."

"Was it kept as a personal account all the time?" inquired Dill.

"Yes, Sir," replied Booker. Senator Dill pointed out a deposit of \$200 in the Cannon account from Raymond Robbins on Sept. 24, 1928. He then read from a report of Miss Ida L. Burroughs, treasurer of the Virginia anti-Smith committee, showing a \$200 contribution by Robbins.

"So this was a political contribution," remarked Dill. Senator Nye read a letter from Bishop Cannon in October, 1928 to the Blackstone bank stating he had \$15,000 to \$20,000 for deposit as chairman of the Newspaper Supply Company of Richmond.

"Did you have any information that these funds were not of the Newspaper Supply Company?" Nye asked.

"No, Sir," said Booker.

Prime Minister MacDonald started his day as usual with a walk in St. James Park, accompanied by his daughter, Sheila, and was back at his desk at No. 10 Downing street before nine o'clock.

Having played his constitutional role in the nation's political drama, the King prepared to return to his castle at Balmoral.

Scotland, from which he was summoned Sunday when the cabinet split on the question of finances, and the administration started down the toboggan.

Mr. MacDonald already had received his seal of office on performing the ancient ceremony of kissing the king's hand when the latter gave him a mandate to form the national government, but he attended the palace gathering in order to be present at the privy council meeting.

Asked whether "the barometer still is setting fair?" he replied, "Yes, very fair." Upon leaving the palace he returned to Downing street for the first cabinet session of the new government, which convened at noon.

Defying the emittered Laborites, Mr. MacDonald led the combined Conservative and Liberal ranks in opposition to his own party. The ministers met behind the thick double-doors and sound-proof windows of the famous cabinet room at No. 10 Downing street.

Meanwhile one unit of the Labor party adopted a resolution recommending expulsion of Mr. MacDonald from the party ranks. It was the Hampstead division of London through which the Prime Minister holds his party membership.

But Mr. MacDonald, apparently anticipating some such move on the eve of the Labor party meeting scheduled for Friday, had forwarded to all Labor members of Parliament a personal message explaining the recent course of action.

"The financial crisis was approaching rapidly," he wrote. "I had become a matter of hours and we had to act immediately. The Labor government strove hard to agree about this issue so that it might continue its work in other fields, but it failed and had to face the consequences."

"If our financial stability is endangered and a run is made on our financial resources, the consequences would be too terrible to envision. This makes temporary entrenchment inevitable and imposes some amount of common sacrifice."

FALSE ECONOMY
 Announcement that the state aid to Greenville city schools for the six months term this year would be \$45,700, or approximately twelve thousand dollars less than state aid last year leaves our school system in a precarious situation unless the city taxpayers are willing to forego any hoped-for reduction in the city school tax. While everybody wants just as low a tax rate as possible we do not believe it to be sound economy to wreck our school system to make a few cents reduction possible and we hope that the Board of Aldermen will give the matter careful consideration from this angle before final action is taken.
 For the information of our people, we would call attention to the fact that last year in the list of more than forty chartered city schools in this state, the Greenville schools stood first in academic rating while in the per capita cost we stood just twelfth from the bottom of the list. In view of these figures there could not be the waste in our system that some of our people seem to believe. Already the school authorities are endeavoring to cut down enough to get by in the fact of the twelve thousand less funds from the state, but now if the city makes any large reduction in the funds for the school there is little hope that we will have a nine months school term. Despite the fact that taxes are burdensome and hard to pay, we do not believe that our people as a whole wish to lower the standard of our schools or to shorten the term, and we hope that no cut in funds that will jeopardize the efficiency of our schools will be put into effect. Of course we want our schools operated just as cheaply as is possible but to cut them below the danger point would be false economy.

ABOUT TOWN
 The British government seems to have its financial problems as much so as any other section of the country.
 So critical did the situation become that Ramsay MacDonald and his cabinet resigned, professing their inability to cope with the situation. In the face of a demand from the King that he try his hand at the formation of a new government, MacDonald did as requested, although he is admitted to have a hard road ahead.
 That other nations of the world will experience similar difficulty is not to be doubted. All are burdened by expense of improvements, which combined with the debt of the World War, makes it almost impossible for them to make ends meet.
 That England will come out of

the financial moras stronger and sounder than ever is believed by the leading financiers of the nation, but the pathway is a thorny one and MacDonald and his colleagues must necessarily incur scathing denunciations from opposing factions until the job has been accomplished.

If some of the leading business and professional men of the city were as inefficient at their work as they are at fishing it is impossible to say what would become of them. Certainly they would be out of lucrative employment, and eventually would be able to do nothing but sit on the banks of nearby creeks and rivers and practice their favorite sport.
 Several days ago some of these aspirants for fishing records drove over a hundred miles to make a record catch but were forced to return home at the end of the day without a single bite.
 Now we do not intend to attribute this condition to lack of skill in wielding the rod and reel, but to the fact that it was one of those days when the members of the finny tribe were visiting relatives in some other body of water and failed to return home while the Greenville men were seeking record catches.
 They say fish usually run in schools, and when one school sets the pace for a departure others are bound to follow. Someone has suggested that the local fishermen determine when the schools hold regular sessions and then go and get them.

In fact, opinion has been expressed that Bob Fitzgerald, superintendent of County Schools, might be able to furnish some valuable information on the subject. Anything the gentlemen should have to say would be deeply appreciated, we feel confident.

All roads will lead to Greenville next week as thousands of people from a radius of many miles make their annual pilgrimage here to see how the tobacco market opens.
 Beginning that day and continuing until the Christmas holidays, thousands of dollars will be released to the farmers of the community. This money will be distributed among every branch of business and the depression which has been holding sway for the last year will be relieved to an extent, especially if prices should be more favorable than last year.

Some have expressed belief that prices will be much stronger than in some of the other belts because of the fact that the crops through here is the best produced in years. The big companies are always ready to buy good tobacco at fair prices, and if they buy according to this standard this season the farmers have nothing to fear.
 Money derived from the sale of bright leaf always brings about improved conditions in a local way, and it is to be hoped the growers will settle up old accounts as quickly as possible and in that way relieve the hard-pressed merchants who came to their relief when credit was hard to get.
 By putting the tobacco money in immediate circulation business conditions will receive a greater boost than any single period in months and it is hoped that growers will do what they can to see that their funds cover as much territory as possible in the settlement of accounts.

AN ORDER AUTHORIZING THE ISSUANCE OF \$250,000.00 OF FUNDING BONDS OF THE COUNTY OF PITT, NORTH CAROLINA.
BE IT ORDERED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF PITT, NORTH CAROLINA, AS FOLLOWS:
 Section 1. There shall be issued bonds of the County of Pitt, North Carolina, in the aggregate amount of Two Hundred Fifty Thousand Dollars for the purpose of funding a like amount of valid outstanding indebtedness, evidenced by revenue anticipation notes of the County of Pitt, which were issued and outstanding prior to July 1, 1931, and were incurred for special purposes, which were necessary expenses of the County. One Hundred Fifty Thousand Dollars being for the expense of maintaining the schools for the constitutional term. Fifty Thousand Dollars being for the expense of improving roads, and Fifty Thousand Dollars being for the purpose of meeting debt service on bonds issued for Road, Road and Bridge, Road Refunding, Court House and Jail and School Bonds.
 Section 2. A tax sufficient to pay the principal and interest of said bonds shall be annually levied and collected.
 Section 3. Statements of the county debt incurred for school purposes and for other than school purposes have been filed with the Clerk and are open for public inspection.
 Section 4. This order shall take effect upon its passage and shall not be submitted to the voters.
 The foregoing order was finally passed on the 26th day of August, 1931, and was first published on the 26th day of August, 1931. Any action or proceeding questioning the validity of said order must be commenced within thirty days after the first publication.

BANDITS CONTINUE TO PICK ON EDWIN TUCKER IN NATION'S METROPOLIS

New York gangsters apparently have it in for Edwin Tucker, son of Mr. and Mrs. E. F. Tucker, of Greenville, who has been manager of Tom McAn Shoe Store in Brooklyn the last two years.
 For the third time within the last year, holdup men walked into the store several days ago, robbed young Tucker of \$14 of his own money, the store of \$20, and then appropriated about \$50 worth of merchandise.
 The gangsters posed as customers the third time and did not reveal their mission until they had clerks busy attempting to fit them with shoes.
 In the two previous robberies, the bandits were masked and brought their guns into play immediately upon entering the store. Money was obtained each time, although no large sums were represented.

COMMISSIONERS MEET TO GIVE BUDGET FINAL STAMP OF APPROVAL

The Board of County Commissioners was in session at the court house today, putting final touches on the tentative budget completed several weeks ago.
 The budget provides a 94 cent rate for the present year on a \$6,000,000 cut in valuations.
 The commissioners were proud of the saving they were able to make for the taxpayers of the county, especially in view of the fact that the rate is considerably lower than any other county in this section of the state.
 Although a few minor changes will probably be made in different parts of the budget before final approval, it was indicated that the tax rate would remain intact.

GREENVILLE TOBACCO WON GRAND PRIZE AT ST. LOUIS EXPOSITION

Although very few people are aware of it, Greenville Tobacco Board of Trade had the distinction of winning the grand prize on a display of tobacco at the St. Louis Exposition in 1904.
 This information was revealed this morning by K. W. Cobb, supervisor of sales of the local market, who carried a representative of the Reflector to his office in the Merchants Association building and displayed the large certificate of award.
 The certificate is encased in a wooden frame and is the pride of members of the Board of Trade by reason of the fact that the award was made in the face of competition from virtually all of the tobacco growing states of the country.
 The exhibit, composed of the finest offerings of this great cigarette-tobacco-producing region, was prepared by the late E. B. Ficklen, who was active in development of the market here and whose efforts were largely responsible for early expansion of the industry.

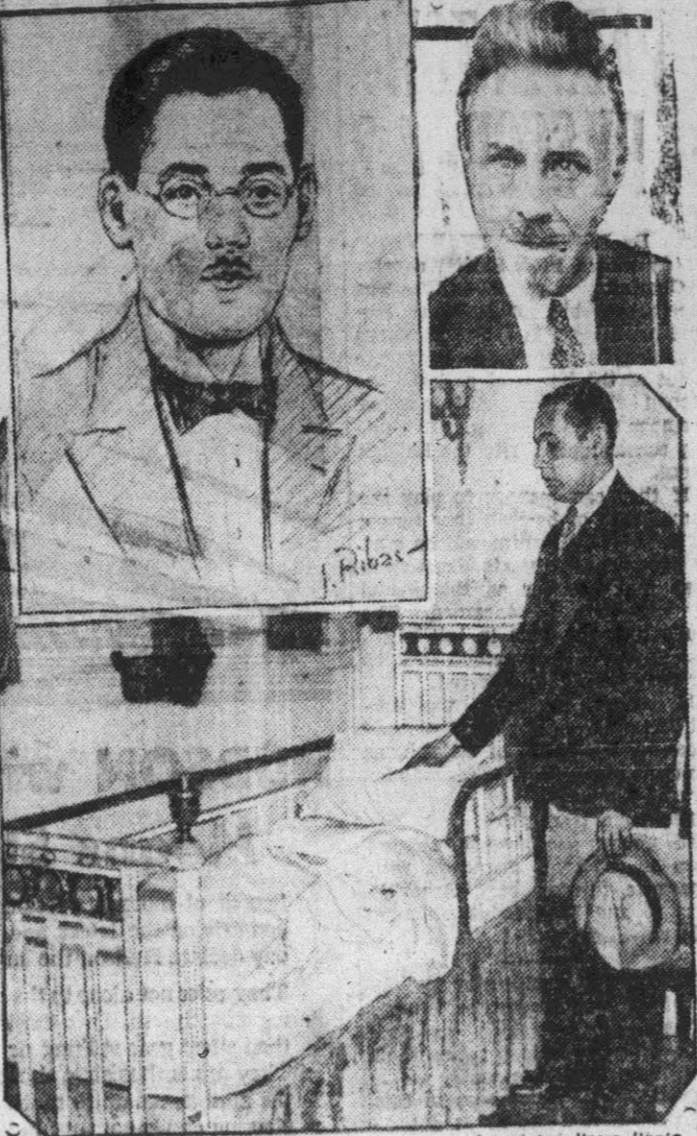

N. Y. COTTON

New York, Aug. 26.—(AP)—Cotton opened steady today 1 to 4 points higher on a moderate demand inspired by relatively steady Liverpool cables.

The buyers were supplied by overnight selling orders and prices eased off after the call with December selling off from 7.23 to 7.16 and March from 7.52 to 7.45, or 2 to 4 points net lower. The buying continued, however, while there seemed to be some covering in anticipation of bullish features in the weekly report of the weather bureau.

This was sufficient to steady the market up again and prices at the end of the first half hour were about net unchanged to 4 points higher. Private reports published this morning complained of too frequent showers or rains over parts of the South during the past week. Liverpool cables attributed the steadiness there to covering, trade calling and scarcity of contracts and said there was an improved inquiry for cotton cloths from the British home trade and India.

STOCK MARKET

New York, Aug. 26.—(AP)—The mid-week business statistics failed to provide a beacon in the murky surrounding the financial markets today, and trading was all but abandoned.

A hopeful glimmer or two were provided by the strength of sterling exchange and the more cheerful feeling in the London market, but these were obscured by the cloudy situation at home. The completely sold out appearance of the share market has been reassuring this week but convincing signs as to which way it will break out of its narrow trading rut have been lacking.

Share prices sagged a little at the opening, stiffened during the late morning, and eased off slightly after midday, with the bulk of the so-called pivotal issues showing negligible changes from yesterday's final prices.

Chemicals firmed up somewhat, possibly reflecting the revival of the European nitrate cartel. Allied rose nearly 3 points and others a point or so. Such stocks as U. S. Steel, American Can, American Telephone and New York Central sagged about a point, then recovered. American Tobacco B rallied a point, then fell back to show a loss of a couple of points. In the rail, New Haven sold up 2 points, then reacted. Norfolk and Western lost 4. Tidewater Associated preferred lost several points.

The freight car loadings reports have been scanned very closely of late for any advance signals of the autumn upturn in general trade. Today's figures covering the week-ended Aug. 15, showed a gain of roughly 8,000 cars from the previous week, but this was somewhat less than the usual upturn for that week.

If they can arrange that and, say, a shot-putting contest between Babe Ruth and Buzz Arlett, the fans will be assured some choice entertainment.

After beating Reynolds by some four yards in their special dash, Chapman utilized his speed in the game that followed to steal his fiftieth and fifty-first bases on the year. The last American leaguer to equal that mark was George Sisler of the St. Louis Browns, in 1922. He still, however, is far from Ty Cobb's record of 86 thefts.

The Yankees won, incidentally, 8 to 0, behind Herb Pennock's six-hit pitching. I was the first shut-out credited to the McCarthymen this season.

Eddie Rommel hurled the long-gone Athletics to a 4 to 1 victory over the St. Louis Browns, allowing only six hits along the way.

The Washington Senators, so far back now it scarcely matters, trumped the Detroit Tigers, 5 to 1. Rain prevented the schedule bout between Cleveland and the Red Sox.

Their sails all set for second place in the National league, the Giants helped matters along by trimming the Chicago Cubs twice, 5 to 3 and 7 to 1, stretching their lead over the Hornsby clan to five games.

The Robins, likewise nursing second place ambitions, divided a pair with the Pittsburgh Pirates. A four-run spurge off Watson Clark in the eighth inning gave the Pirates the opener, 5 to 3. Fred Heilmach squared matters by holding them to three hits and winning the nightcap, 5 to 0.

Cincinnati and Philadelphia took turns applying the whitewash, the Reds winning the first, 8 to 0, behind Lucas's brilliant pitching and the Phils taking the second, 1 to 0, as Jim Elliott busted young Si Johnson in a tight duel.

Old Socks Siebold held the Cards scoreless for eight innings, but they nicked him for one to tie the score in the ninth and then collected three more in the tenth to defeat the Boston Braves, 4 to 1.

SPORTS SLANTS

The tennis ranking lists that did not include Helen Wills Moody or Helen Jacobs booked no stronger than does the national amateur golf "seeding" list, minus Bobby Jones and George Von Elm.

The list that will be used at Beverly for "planting" the amateur aces, after the qualifying returns are in, has the name of Harrison R. (Jimmy) Johnson at the top.

This is a nice tribute to the popular Minnesotan, considering he did not qualify in 1930 at Merion. With Jones out, however, he is the latest of the available ex-champions, having triumphed in 1929 at Pebble Beach.

Not much fault, on the records, can be found with the placing of Gene Homans, Phillip Perkins and Johnny Goodman in the next three positions of this informal ranking list. Homans was a finalist last year, Perkins was the leading amateur in the U. S. Open this summer and Goodman has been consistently up around the top flight.

Some surprise, however, follows the listing of Charley Seaver, Francis Quimet and Maurice McCarthy ahead of George Voight and Dr. Oscar F. Willing, two of the most seasoned campaigners in amateur ranks, in the order in which we have mentioned them.

Seaver's feat in reaching the semifinals last year does not compare with Voight's all around match play record. Quimet no longer is more than a good golfing companion and a capable ex-champion. McCarthy has been forging ahead rapidly and has some claim to being a title threat.

There are no more difficult match players to shake off anywhere than Voight and Willing. They have it, it is true, fallen short of championship calibre so far but not by much. They will be two of the hardest to beat at Beverly, where your guess as to the winner will be as good as mine.

Jimmy's Health Doubtful Some disquieting word about the health of Jimmy Johnson, incidentally, was brought back from St. Paul by friends.

The former champion has been bothered by stomach trouble and was ordered to refrain from golf, for the time being, by his physician. "Jimmy" assured one and all, however, that he would be on the starting tee at Beverly and his folks hope he won't have to carry a handicap of ill health along with him.

Against the field covering on Chicago from all parts of the country, Johnson, as the official favorite, will need all the stamina he can muster to emerge on top.

Wouldn't Run "This game may be all right if you can get started," remarked Pennie Hill, the famous automobile driver, after he twice failed to negotiate as much as a lap in the old Cup speedboat race with Horace Dodge's expensive craft, Miss Syndicate III.

A pro at the auto game, Hill fills the requirement of being a gentleman amateur in the speedboat sport which bars the pro skipper from the wheels of the Gold Cup boats. He never had a chance to show what he could do, however, with the temperamental Dodge boat, which had several spasms of engine trouble at Lake Montauk.

"She just refused to run," Hill said, after being forced off the course the second time. "There must have been some thrills to this sport but I haven't been able to locate them as yet."

Meanwhile, Henderson was submitting to a licking by the same score at the hands of Raleigh, as the Caps turned in their second victory of the week.

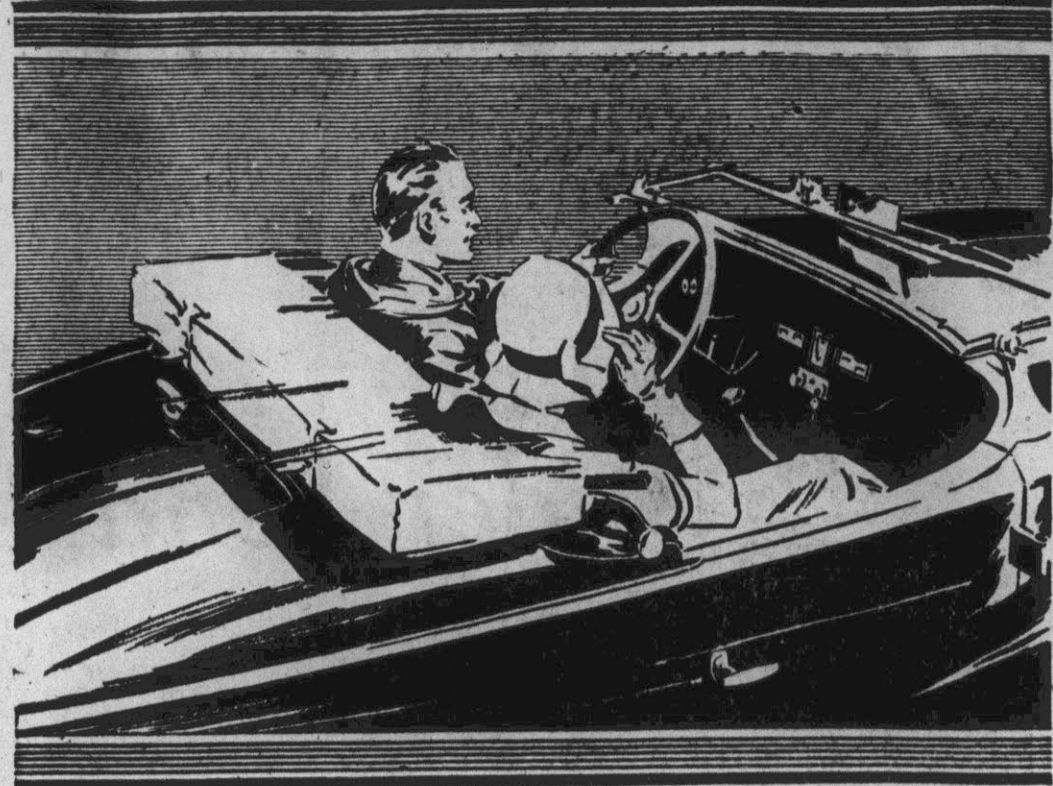
