## Doolittle Hangs Up New Speed Mark On Cross Country Flight

**WINS \$10,000 CASH AWARDS**

**Former Army Flier Captures the Bendix Trophy of National Air Races and Shatters by Hour and 15 Minutes the Record Set by Capt. Frank Hawks; Returns To St. Louis to Carry Friends to Air Meet.**

St. Louis, Sept. 5.—(AP)—Major Jimmie Doolittle, former army pilot, has been a bit tired today after shooting 3,362 miles through the skies yesterday to win the Bendix trophy in the national air races and later establish a new transcontinental airplane record but not too tired to plan to return to the scene of his triumphs.

With only a short night's rest behind him, Doolittle hoped to be back in the air today, speeding for Cleveland, where yesterday he was declared winner of the air race from Burbank, Calif., and from where he streaked onward to Newark airport, N. J., to break Capt. Frank Hawks' transcontinental record of 12 hours and 25 minutes by an hour and 10 minutes.

Doolittle's average speed for this 2,654 mile hop from coast to coast was 225 miles an hour. Richer by \$10,000, the former army pilot and stunt king returned to St. Louis at 10:22 p. m. last night because he had promised a group of friends with whom he is associated in business that he would take them to the air races today.

Feeling little effect from his long stay in the air, which began when he left Burbank at 3:35 a. m. yesterday, Doolittle pushed away from his well-wishes when he landed and hastened for his home.

He made his last hop—from Cleveland to St. Louis—as a passenger in the plane of Jim Halslip, also of St. Louis, having lost his prize winning and record breaking Laird solution type biplane in Cleveland.

Timed in 9 hours and 15 minutes, Doolittle led seven other contestants in the Bendix trophy race, arriving in Cleveland at 12:50 p. m. yesterday. In finishing first in this 2,046 mile flight, he received \$7,500 in prize money. The other \$2,500 was received for breaking Hawks' record.

After a brief pause in Cleveland, he left at 1:04 p. m. and arrived at Newark airport at 2:50 p. m. to wrest Hawks' crown. At 3:50 he was in the air again, headed for Cleveland where he arrived at 5:42 p. m. On the last lap to St. Louis he left at 6:53 p. m.

In the Burbank-Cleveland race, Harold S. Johnson of Chicago, was second, and the others finished in the following order: Beeler Blevins of Atlanta; Captain Ira Eaker of Washington; Art Goebel of Los Angeles; and James Hall of New York.

Another contestant, Walter Hunter of Sparta, Ill., crashed near Terre Haute, Ind., and although his plane burned he escaped injury. Lou Reichers of Arlington, N. Y., the last of the eight who started from Burbank was forced out of the race at Beatrice, Neb., after he had become lost.

"The toughest part of the flight, Doolittle told friends here, 'was getting in and out of Cleveland. It was raining and I had to watch my step.'"

Cleveland, Sept. 5.—(AP)—Jimmy Doolittle, whose public knows there is nothing in a name, is hanging up his racing helmet and goggles on a lofty peg.

To the former army daredevil, however, his final joust with speed is less interesting as a record breaking performance than an opportunity to study aviation engineering and design.

In his first lengthy pause here after winning the Bendix derby and setting up a west-east transcontinental record of 11 hours and 15 minutes, he chose to speak of his interest in the engine.

"My motor was perfect," he said, but even as he spoke the plane that was being given no more rest than the pilot was in a hangar where a geared Wasp will replace a Wasp Junior.

There was a full smile on the face of aviation's man of the hour, whose career has been one of paradoxes. (Continued on page three)

### FINDS JAIL UNSANITARY

### Grand Jury Also Declares Jail Prisoners Are Insufficiently Provided For.

The sanitary conditions of the county jail are not so good, the six-month grand jury of criminal term of Pitt County Superior Court discovered in making the regular inspection of county institutions here during the week.

The report also stated the prisoners were insufficiently provided for and that new mattresses are needed for the bunks.

The report did not contain recommendations for improving conditions but merely called attention to its existence.

The grand jury completed its work yesterday, with exception of the county home, which could not be reached on account of rush of business, but a special committee will be selected to make the inspection and will report at the next criminal term of court.

All offices and departments of the county were found to be in good condition, and the jury commended Judge N. A. Sinclair of Fayetteville, for the splendid way he conducted his court.

The detailed report follows: To His Honor, N. A. Sinclair, Judge Presiding: The Grand Jury of this, the August Term of Criminal Court, beg to submit the following report: The Grand Jury carefully considered and passed upon all bills submitted and presentments have been made in all cases where evidence so justified.

The Grand Jury has visited the various officers of the County, as follows: Clerk of Superior Court, Register of Deeds, Board of Education, Tax Supervisor and Auditor-Treasurer; Sheriff, Welfare Department and County Farm Agent.

It has found in each instance that the affairs of the County are being well cared for, that the offices are being efficiently managed. Due to rush of business we did not have time to visit County Home. We will select a committee to make proper inspection and report at next term of court.

The County jail was carefully inspected by the Grand Jury, the prisoners appear to be insufficiently provided for and the sanitary conditions of the building are not so good, and new mattresses are needed for bunks.

### STRIKE AGAIN IN BARCELONA

### Bloody Fighting Follows Resumption of Strike of Syndicalists in Spain.

Barcelona, Sept. 5.—(AP)—The general strike of Syndicalists which was called off last night after sanguinary clashes between strikers and police was resumed today.

The bloodiest encounter of the outbreak occurred when a body of strikers barricaded themselves in the Syndicalist headquarters and defied authorities.

Equipped with rifles, revolvers and plenty of ammunition, they held their own against the repeated assaults of police and civilian guards.

At the end of six hours they surrendered when police wheeled light artillery into position and threatened to bombard them. The casualty list read three killed and 5 wounded and the prisoners numbered more than a score.

Women were conspicuous in other skirmishes. One of them was killed and several wounded when they stormed the cathedral and sniped at police from the roof. Others stood on the streets and balconies and beseeched their men with tears to come home.

Syndicalist strikers called off the strike after the government had marshalled an imposing array of force and applied near martial law to the disorders.

They temporarily dropped their demands that political prisoners be freed and the civil governor resign, but they gave no assurance against further bloodshed.

The crackle of machine guns and the sound of rifle fire was heard all day. Strong police squads patrolled the principal streets and buildings. Those who refused to halt were shot down. All traffic (Continued on page three)

### LEAF PRICES REMAIN FIRM

### Market Paid out \$32,336.61 During Closing Sale of the Week Yesterday.

The Greenville tobacco market closed the first week of the current season yesterday with the price situation showing little change from the middle of the week. Good tobacco continued to attract attention of the buyers and prices for such grades showed considerable strength. The day's sale, as during the remainder of the week, was predominated mainly by inferior grades.

According to the official report of sales made public this morning by K. W. Cobb, supervisor of sales, the market yesterday disposed of 438,666 pounds of leaf for a total sum of \$32,336.61 at a general average of \$7.37.

Sales for the season were given as 1,931,162 pounds for \$141,632.06, at an average of \$7.33.

For the same period last season the market sold 1,707,186 pounds at an average of \$7.52 per hundred pounds.

Raleigh, Sept. 5.—(AP)—New bright belt tobacco markets were closed today. Figures for the first week's sales (including Thursday), as released by sales supervisors show price averages on most markets \$1 to \$2 lower per hundred pounds than last year. The average at Goldsboro, however, was 39 cents per hundred higher than for the first week last season.

The sales and average price per hundred pounds on the principal markets: Wilson, 1,731,574 pounds at \$8.25; Goldsboro, 358,016 at \$7.61; Kinston, 1,514,718 at \$7.98; Williamston, 380,523 at \$6.54; Robersonville, 435,025 at \$6.39.

## Chilean President Reports Surrender Of "Rebel" Fleet

### Rum Runner Killed As Coastguard Seizes Boat

Gloucester, Mass., Sept. 5.—(AP) by boatswain's mate Roy Fitzgerald. One man was killed, four others were arrested and a 60-foot speedboat carrying 400 cases of liquor was seized early today by coast guardsmen after a chase just outside Gloucester harbor.

Joseph Mello, 39, of New Bedford, was hit in the back when several shots were fired at the fleeing rum boat, the Lassgen, from the coast guard picket boat, 2394, commanded by boatswain's mate Roy Fitzgerald.

Fitzgerald said he ordered the speedboat to stop and after warning shots were ignored several shots were fired at the craft and it then swung about. Coast guardsmen then boarded the craft and arrested the crew.

Picket boat 158 towed the Lassgen and her cargo to the Gloucester coast guard base.

### WOULD REDUCE GINNING RATES

### Gov. Murray Presents Suggestion for Rehabilitation of Cotton Farmer.

Oklahoma City, Sept. 5.—(AP)—As a means of rehabilitating the cotton farmer, Governor W. H. Murray advocated today a slashing of ginning rates to 20 cents a hundred pounds, establishment of a prohibitive rate for ginning low quality cotton, and drastic cutting of gin profits.

Adoption of these measures was asked in a petition filed with the State Corporation commission by the governor's special attorney, Louis Fischl. Hearing on the proposals is scheduled for next Tuesday.

Gov. Murray said the present cost of ginning varies in the eastern and western parts of the state between 30 and 42 cents. He termed bolle cotton "a drag upon the market," which should be removed by fixing a high ginning rate to discourage picking.

A return of "not to exceed 6 per cent" on investments was declared to be reasonable for gins. Murray said the average profit for the past seven years has been 163 per cent.

### MARTIAL LAW IS DECLARED

### Rebellious Units Of Fleet Surrender After Brilliant Action of the Air and Army Forces; Bombing Planes Ordered Out After Rebels had Defied Ultimatum Calling Upon Them To Surrender; Invoke Martial Law for 30 Days.

Santiago, Chile, Sept. 5.—(AP)—Manuel Trucco, acting President of Chile, issued a statement through the war office today that the air fleet and army in joint action had forced the surrender of the rebellious units. The statement was issued shortly after it had been announced that bombing planes were converging upon the mutinous battle fleet off Coquimbo.

"The country is informed," this statement said, "that the army, carabinieri and the aviation corps in brilliant joint action, have obtained the surrender of the rebellious naval and land units."

Shortly thereafter, however, the government declared a state of martial law throughout Chile for a period of thirty days. The decree was signed by the acting president and by Premier Mera.

Bombing planes were ordered out after the rebels had defied an ultimatum calling upon them to surrender. Meanwhile, Federal forces occupied coast defenses and stationed troops to protect foreign holdings.

A guard was placed on a fuel oil base owned by the Anaconda Copper company at Tocopilla, but thus far no Americans have been injured and no American property has been damaged.

The government today disclosed that it had served an ultimatum last night ordering that the battle fleet surrender by 1 a. m. today. When that hour came the rebels were given 20 minutes grace and orders went out to attack the fleet from the air.

Santiago, Chile, Sept. 5.—(AP)—The Chilean government decided to attack the mutinous naval fleet at Coquimbo with all the forces at its command and ordered the arrest of all communist leaders in the nation, charging them with responsibility for the movement.

General Carlos Vergara, minister of war, was put in supreme command of the army, carabinieri and air corps, and was directed to prepare plans for battle. Acting President Trucco issued an official communique, signed by Premier Mera and all other ministers, saying the government's forces would move at once to the attack.

Valparaiso was inflicted with a general strike of laborers which tied up street car and bus service and disrupted railroad traffic between there and Santiago. This incident also was attributed to communist agitation.

Santiago was quiet on the whole but troops continued to patrol the business section under the authority of martial law. Trolley cars were suspended from service on the grounds that radicals intimidated their crews at terminal points.

### Mockville Murder Case Needs Jury

Mockville, Sept. 5.—(AP)—The ability of an 81-year-old farmer to premeditate and deliberate the murder of his son-in-law was a moot question today as attorneys argued for and against the conviction of John Henry Hauser, who slew Fred Styers.

Counsel for Hauser, after pleading self-defense, introduced four physicians who testified that although the defendant was capable mentally of distinguishing between right and wrong, he was physically afflicted to such an extent that he was incapable of deliberating and premeditating murder.

The state introduced lay witnesses, neighbors of Hauser, who said it was their opinion the aged man was sane and had reason at the time of the homicide.

The case will reach the jury today, only two attorneys' arguments and Judge John H. Chasness' jury charge remaining to be heard.

George Clark, Greenville chief of police, is as long-headed about police efficiency as the aldermen are in dealing with the various problems which come up before them from time to time.

Thursday night John and members of the board got together and the outcome was the decision to establish emergency telephone stations throughout the city to more completely protect public life and property.

The telephones will enable police headquarters to keep in touch with patrolmen at all times of the day and night and if trouble happens the entire force can be concentrated in short order.

It is the same system adopted by the largest cities of the country and should play a big part in dealing with crime here.

The cost to the city is slight consideration compared with the benefits to be received, and the aldermen and police head are to be congratulated in the far-reaching action.

Nothing has been done about the cotton situation yet but with Texas legislators in a mood for solving the problem the public is looking for something to happen in short order.

Practically every state of the southland is affected by the action and it is to be hoped it will be drastic enough to bring about concerted movement of planters everywhere.

We used to talk about reduction of acreage and never get anywhere but the time has come when something definite must be done, and the sooner the ball begins rolling the better off everybody will be.

Cotton and tobacco are two of the most important money crops of the south, and when prices are depressed by surplus production everybody suffers. The situation at this time is unquestionably the most severe in history and unless a solution is reached by the men capable of dealing with the problem the industry will suffer irreparably during the coming years.

The last of the series of union services which have been conducted among city churches during the latter part of the summer will be held at St. Paul's Episcopal Church Sunday night at 8 o'clock and the public is given a cordial invitation to attend.

## Wilkesboro Man Adjudged Guilty Of Manslaughter

Lenoir, N. C., Sept. 5.—(AP)—A. B. (Dick) Johnson, North Wilkesboro business man, convicted of manslaughter in connection with the death of Miss Dolly Greene, a nurse, today awaited the sentence of Judge Walter E. Moore. Judge Moore reserved sentence yesterday until today and released Johnson on \$10,000 bond.

The jury, which deliberated four hours, recommended mercy for the defendant. Miss Greene was killed January 8th when Johnson's automobile turned over near here. The state charged that Johnson was driving the machine and that he left his companion to die at the scene of the wreck while he was treated at a hospital. Johnson said Miss Greene was driving and he was knocked unconscious in the accident.

## Charges Leaf Men With Kidnapping

Boston, Sept. 5.—(AP)—George J. Wemyss of Quincy, in an affidavit which he signed at Boston police headquarters today, named three executives of a tobacco company he said were responsible for kidnapping him and confining him in a cellar of a Long Island, N. Y., shack.

He attributed the kidnapping to an attempt to force him to repudiate affidavits he gave the Federal Trade commission concerning the practices of a tobacco concern for whom he had worked. The name of the company was withheld.

Boston police were inclined to believe Wemyss' story. He recounted several attempts on his life previous to his abduction from the Boston beach.

The story he told Boston police has not changed from the tale he told police of New Hyde Park, N. Y., Thursday, seeking protection.

A checkup with the Federal Trade commission at Washington revealed that no investigation of a tobacco concern is being made.

## Ask Upward Revision of Furniture Rates

High Point, Sept. 5.—(AP)—The Southern Furniture Manufacturers' association today planned an appeal of the Interstate Commerce commission's decision authorizing an upward revision of furniture rates.

J. T. Ryan, secretary of the association, termed the decision "unfair to Southern shippers" and asserted an attempt would be made to reopen the case when the report had been studied in detail as the revision is "not justified by difference in transportation conditions, either as to cost or value of service."

Rates from High Point, Thomasville, Lexington and nearby points into Ohio, Illinois, Indiana, Michigan and Wisconsin under the report would be 14 cents higher than rates from Greensboro, Winston-Salem and Mebane into the same territory he said.

The report showed a rejection of nearly all suggestions regarding carload rates and mileage scales submitted by shippers.

(Continued from page one) met for the partial salvation of its growers only by the world-wide cooperation of cotton sections.

In 1929, the state-owned farms worked by prisoners, planted 3,600 acres in cotton, reduced the acreage to 2,600 in 1930, and this year planted only 1,300 acres in cotton.

"North Carolina," said the governor, pointing to this steady decrease in acreage, "can go out of the cotton growing business without any major readjustments of its farming operations."

"Cotton will be completely eliminated from state crops because neither the state nor individual

Corn, wheat, oats, rye and barley are among the principal crops grown on the farms this year in addition to cotton.

These grains are grown from pure-bred, certified seed and Governor Gardner plans to exchange them with North Carolina farmers who have grown inferior grades in order to introduce more widely the use of certified seed in this state.

(Continued from page one) waited action by Texas toward relief of the cotton crisis.

Meanwhile, Governor Huey Long of Louisiana, continued a radio campaign in behalf of legislation his state enacted to prohibit production of cotton entirely in 1932, and indicated he might make an airplane speaking tour of the south to urge general acceptance of the plan.

In his radio speech last night, Governor Long denounced Governor Sterling of Texas for failure to call a special session of the legislature on the "no cotton" plan. "I won't say why he wants to do so," Governor Long said, "but it looks like he is trying to wait until the crop is gone."

"Come on Georgia, Arkansas, South Carolina and other states," he urged, "so that when the people of Texas see that the only thing in the way of prosperity is their governor, they will be aroused."

Governor Long's plan requires occurrence of states producing

three-fourths of the cotton crop to become operative. Texas produces a third of the crop.

Governor Russell of Georgia and Governor Parnell of Arkansas yesterday reiterated they did not wish to call their legislatures into session until Texas leads the way. Governor Blackwood of South Carolina has said he might issue a call, however, without action by Texas.

Governor Sterling has announced he would call the Texas legislature together if the majority of state senators assured him they wished to.

Last night from Waco, Representative J. B. Ford announced Governor Sterling told him by telephone Agricultural Commissioner J. E. McDonald's statement that nineteen Texas senators favored a special legislative session was not correct. Sixteen would be a majority.

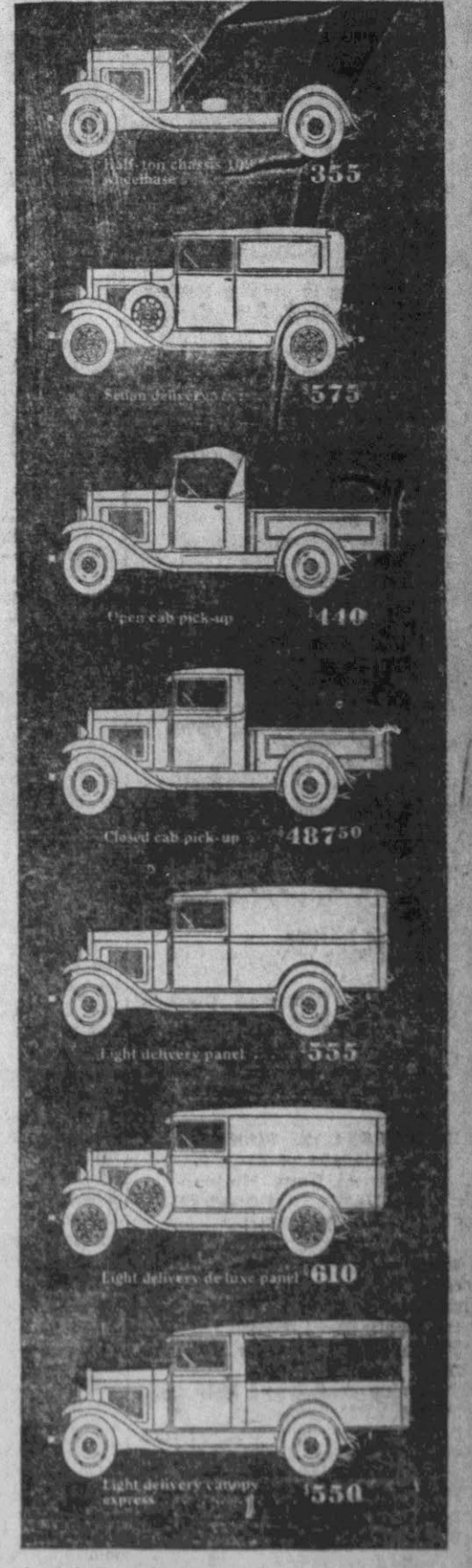

# PATS PLAN TO PROTEST 12 CONTESTS

Charlotte, Sept. 5.—(AP)—There's a war brewing that may cause Piedmont League fans who have settled down to watch the remainder of the season coast peacefully away, to sit up and take notice.  
Greensboro, if reports from the Pat town are correct, is planning to blast Raleigh right out of second place in loop standings and install therein none other than the Patriot outfit.  
John T. Rees, president of the Greensboro club, said he had heard rumors that his team intended to protest more than 12 games won by the Caps this season. Action, he said, must await the return of Joe Mathes, business manager, who is in St. Louis.  
The Pats would base their protest on the grounds that Raleigh violated the rookie rule by not having on its roster four players who have not been at bat more than 120 times in a previous season in organized baseball, as provided by the league's constitution. Sixty times at bat is the stipulation in the case of pitchers.  
But the threat holds no apparent terrors for Raleigh.  
"Let 'em protest," was the comment of Eddie Winston, business manager of the Capital City club.  
"President Branham has on file in his office the names of players on the Raleigh club at all times during the season and inspection of these records will show that the Raleigh club has at all times carried on the active roster the required minimum of four rookies as well as conformed with all other Piedmont League regulations."  
Should the protest be allowed, Greensboro would automatically move into second place, on the basis of present standings, and would rule a favorite to finish there with the season so near its end.

The Pats, however, are still doing their bit to get ahead of the Caps without the benefit of any advantage that may come through the reported protest. They licked Henderson twice last night 6-1 and 7-4.

At the same time Raleigh wasn't doing so bad, spitting a pair with Durham. The Caps took the opener 5 to 4 in 10 innings. It was Tripp Sewell's 16th win of the season. Tom Lanning, who used to pitch for Wake Forest, worked the five-inning nightcap and scored a 4 to 1 victory for the Bulls.

Winston-Salem and Asheville also split a pair. The Tourists taking the 4 to 0 and the Twins winning the second 1-0.

Charlotte had better luck. The Hornets won both ends of a double offering from Henderson 7-2 and 4-1.

# GROVE AFTER NEW RECORD; BLANKS SOX

Not at all worried by the fact that an unkind fate and the St. Louis Browns prevented his setting a new American League record for consecutive victories, Robert Moses Grove of the Athletics now is plugging away at another mark that has withstood the best efforts of American League hurlers for 19 years.  
Back in 1912, Joe Wood won 34 games for the Boston Red Sox and lost only five for a winning percentage of .872. It has never been bettered, but Grove stands an excellent chance of turning the trick this month.  
He rang up victory No. 27 yesterday at the expense of Boston, 2 to 0. He has lost three, giving him a percentage of .900 with some four or five games to go. That is, the A's have 25 more contests on their schedule, and the great southpaw has been working every fourth or fifth day.  
Yesterday's shutout was Grove's fourth of the year. He allowed only three hits and struck out seven batters.  
Waite Hoyt gave the champions a clean sweep for the day by beating the Sox, 6 to 1, in the second game.  
Gerald Walker, the youngster recently recalled from Toronto, gave the Detroit Tigers a 4 to 3 victory over Chicago when he hit his first major league homerun with two on in the sixth inning. Ted Lyons was his victim.  
The Yankees and the Senators scrapped through ten innings before Washington won out, 5 to 4. The victory put the Senators two and a half games ahead of third place Yanks.  
Led by Taylor Douthitt who cracked four singles, the rebellious Cincinnati Reds pounded three pitchers for 21 hits to make it 5 straight from the Chicago Cubs, 12 to 3.  
The Boston Braves suffered their 12th defeat in thirteen starts when the Phillies snowed them under, 11 to 1.  
Only one Robin got as far as 3rd base as Bill Walker pitched the Giants to a 3 to 0 victory over Brooklyn. It was the southpaw's 15th win of the year and his sixth shutout.  
Pittsburgh made it two straight over the St. Louis Cardinals when Heinie Meine bested Bill Halahan in a fine duel, 3 to 1.

# GEHRIG WINS BAT HONORS

Chicago, Sept. 5.—(AP)—Lou Gehrig, the New York Yankees' first baseman, has quite a climb ahead of him if he is to win the batting championship of the American League, but his right to the title of most valuable all-round batsman, right now is unchallenged.  
According to semi-official averages which include Thursday's games, Columbia Lou dominated five branches of offensive baseball, and ranked fourth in the percentage list, with .354.  
He batted in 23 runs during the past week to bring his total to 161, and put himself in a good position to regain the major league record for punching in scores which he relinquished to Hack Wilson last season. Gehrig held the record at 175 until Wilson accounted for 190 in 1930.  
Gehrig also headed the list in scoring, with 140 runs, 10 more than he had last week; made eleven hits to best his leading total to 185; had 361 total bases and 40 home runs. He raked opposing hurlers for six home runs during the period and moved out ahead of his famous teammate, Babe Ruth.  
The three other leaderships remained as they were. Earl Webb of Boston had 55 doubles; Roy Johnson of Detroit had made 16 triples, while Ben Chapman, the Yankee speedster, had 53 stolen bases.  
Al Simmons of the Athletics, although he failed to return to the runs, remained in the lead for the individual title with a percentage of .385, five points ahead of Ruth, who dropped a point during the week.  
Following the leading pair, among the regulars were: Morgan, Cleveland, .357; Gehrig, Yankees, .354; Goslin, St. Louis, .345; Webb, Boston, .344; Cochrane, Philadelphia, .341; Alexander, Detroit, .340; West, Washington, .338; Averill, Cleveland, and Stone, Detroit, .328.  
Cleveland batted at a 298 gait for another week and retained the team leadership, with the Yankees second two points behind. The Athletics fielded for 977, the same as last week, and held the top position by one point over Washington. The St. Louis Browns remained far out in front in accumulating doubleplays, with a total of 144, an increase of six during the week.  
Bob Grove, the A's peerless hurler, edged one victory closer to the 30 mark, and his record of 26 triumphs and three defeats left all opposition far behind. He also paced the league in strikeouts, with 144 in 35 contests.

Terry is back at his old post as the league's leading hitter with a mark of 348. Klein holds third place with 340. Terry has made the most hits, 182, and the most three-baggers, 17. Klein is the homerun monarch, with 31, leads in runs batted in, with 106, and has scored the most runs, 109.  
Terry finally managed to pass Virgil Davis, big backstop of the Phillies, during the past week. Davis, through Thursday, held second place with an average of .345.
