

HOOVER PLAN BRINGS STUDY OF BANK LAWS

Congress Certain to Make Examination of Whole System of Banking

Washington, Oct. 9.—(AP)—Microscopic study by Congress of the whole system of national banking laws on the basis of the last two years' business events is certain.

The emergency economic program advanced at this week's bipartisan White House conference will be the principal laboratory lesson from which Congress will build to guard against future credit strains.

While the congressional conferees agreed to the general program advanced by President Hoover, it was apparent today that there would be some sharp differences of opinion over details.

The main controversy is expected to center on the extent to which Congress will go with the presidential recommendation for broadening the base of paper eligible for rediscount by Federal Reserve banks.

Meanwhile, in New York formation of the \$500,000,000 national credit corporation undertaken by private financiers at the suggestion of President Hoover is near completion.

With stocks, cotton and grain prices pushed upward already under the stimulus of the proposed organization, Mr. Hoover was notified that it would be formally incorporated by tomorrow.

Soon thereafter the enormous strength of its pooled resources will be injected into a nationwide offensive to free frozen assets for commercial trading.

The corporation will be authorized to issue up to \$1,000,000,000 in debentures to subscribing banks throughout the country, which would contribute two per cent of their net demand and time deposits. At this time it is considered a temporary organization to meet the situation pending congressional action.

A preliminary hint of opposition to some phases of the administration's legislative program has come already from Senator Glass of Virginia. The former Democratic secretary of the Treasury gave notice that he would oppose proposals to include railroad, real estate and industrial securities in paper eligible for Federal Reserve rediscount.

As chairman of the Senate Banking committee, Glass has been studying this very problem and is preparing to cooperate for some liberalization of the Federal Reserve system. He will have wide influence on the action of Congress. He warned the White House conference to guard against too much expectation in the matter of broadening the base for rediscount.

Over in the House, Chairman McFadden of the banking committee also is carefully reserving judgment on just how far he would be prepared to go in extending the base of eligible paper.

OPENS BONDED COTTON HOUSE

E. G. Flanagan Announces New Enterprise for Storage of Cotton Crop

A bonded warehouse for the storage of cotton, the first in the history of this community, has been opened by E. G. Flanagan at the southern end of Evans street, it was announced today.

The enterprise will be known as the Greenville Bonded Warehouse and will be operated under the management of Mr. Flanagan.

The warehouse has a capacity of 1,500 bales, and is receiving cotton at a storage rate of 25c per bale per month.

Cotton stored in bonded warehouses enables planters to receive advances from the various buying agencies of the nation, and guarantees safety of the staple from the time of delivery until it is transferred.

Although Greenville has long been in need of an enterprise of this kind this is the first step that has been taken to insure the safety of the community's cotton crop, and it has already received wide interest from farmers in all parts of the community.

Mr. Flanagan said the bonded warehouse was opened because he realized the pressing need of a place of this kind for the handling of cotton on a higher basis, and expressed belief it would gain in favor as the planters begin to realize the advantage which they derive from storing their product in a safe place.

Pitt Medical Society Hears Health Leader

McGeachy, director of the Pitt County Department of Health.

Dr. Tom Watson read an interesting paper of "Prematurity," and case reports were presented by Drs. S. M. Crisp and J. L. Winstead.

Says Counties In Worse Shape

Wilmington, Oct. 9.—(AP)—A large number of counties in the Eastern North Carolina agricultural region find their economic situation this winter promises to be at least 50 per cent worse than last year.

Mrs. W. T. Bost, state welfare commissioner, told the annual southeastern district welfare conference here today.

Mrs. Bost said that her department had received reports from 30 of the 52 counties in the eastern part of the state, and that 17 of them reported the extreme situation, while all of the others reported less critical declines in employment and economic independence.

LEAF SALES MOUNT HERE

Make Gains Both in Poundage and Price Average Over Previous Week

Sales on the Greenville tobacco market showed a slight gain over the previous week, it was revealed today in the official report of K. W. Cobb, supervisor of sales. For the week the market sold 4,114,700 pounds against 4,007,890 for the previous week.

While the market was gaining in poundage, the price average also took on new life and recorded a gain of \$1.27 per hundred pounds over the corresponding week. The average for the present week was \$10.23 against \$8.96 for the previous week.

HOOVER BEGINS BOND INQUIRY

Washington, Oct. 9.—(AP)—President Hoover is making an extensive inquiry into possible means of stabilizing railroad bonds.

Hundreds of banks, particularly in the midwest, have invested in such bonds because of a steadily declining demand for loans in the agricultural areas.

Because of declining revenues many of the railroad bonds have been dropped from the list of securities eligible for purchase by banks and mutual savings associations.

These banks therefore, have asked that the general railroad bond situation be brought under the scrutiny of the president and such governmental agencies as would be available for such an investigation.

Akron Off On Test Flight

Akron, Ohio, Oct. 9.—(AP)—The U. S. S. Akron went aloft on her sixth test flight at 6:45 A. M. (EST) today.

The world's largest airship, was expected to remain in the air for the greater part of the day in a further test of her water recovery system and deceleration.

The flight was another of a series required by the Navy before it accepts the \$5,500,000 airship.

PROSECUTOR TESTIFIES IN CAPONE CASE

Vernon Hawthorne Tells of Gangster's Examination At Miami Recently

Chicago, Oct. 9.—(AP)—A former Miami prosecutor who participated in the attempt to drive "Scarface" Al Capone out of Florida, today noted the gang leader as saying his business was clearing and pressing, real estate and gambling—mostly gambling.

Vernon Hawthorne, who was state's attorney of the 11th Florida district in 1928, the first witness of the day in Capone's income tax trial, related an interview between Capone and Miami officials in the summer of that year. The authorities, he said, objected to Capone's presence there and wanted to know "what he proposed to do in Miami."

"I'm just here for a rest," he quoted the gangster as saying.

Capone at first refused to say what his business was, Hawthorne testified, but later announced, "all right, I'll tell you."

"He said he was in the cleaning and pressing business in Chicago," Hawthorne said. "I asked him what else, and he replied 'real estate.' Then said, 'as a matter of fact aren't you in the gambling business?' and he replied 'well, I have an interest in a dog track in Cicero, Ill.'"

The witness said he finally asked Capone if gambling were not his principal business. He quoted the "public enemy" as saying, "well, yes."

Condition of Inventor or Increases in Seriousness As He Slips Into Stupor

West Orange, N. J., Oct. 9.—(AP)—Thomas A. Edison slipped into a stupor today and death crept nearer to his bedside.

The world-famous inventor, an extremely light sleeper, was found to be in an unnaturally deep slumber this morning. At breakfast time he was aroused with difficulty. A stupor, forerunner of the coma from which a patient cannot be awakened, had gripped him.

He was persuaded to take a spoonful of cereal, but not nearly enough to combat the uremic poisoning which is combining with three other ailments to sap his strength day by day. Last night he took nothing and all day yesterday he went practically without

Seek Jury Probe of Conditions in Buncombe Co.

Asheville, Oct. 9.—(AP)—Wickes Wamboldt, city councilman and newspaper columnist who said "There is rascality in our courts" could cite no specific instances of legal misconduct when called before Judge John H. Harwood today by postmaster and a minister related incidents they said required grand jury investigation.

A crowd of 1,500 which cheered Wamboldt when he entered the Buncombe county courthouse roared at his explanation that he had "no reference to any particular court or judge" when he made his statement but listened closely while Carl W. Hunter, Alexander postmaster, and the Rev. George Floyd Rogers, D. D., pastor of Trinity Episcopal church, testified.

"Your honor," Wamboldt told Judge Harwood, "I had no reference to any particular court or judge when I made that statement before the Asheville Ministerial Association. Since then, however, numerous persons have come and told me that my statement applied directly to Buncombe county affairs."

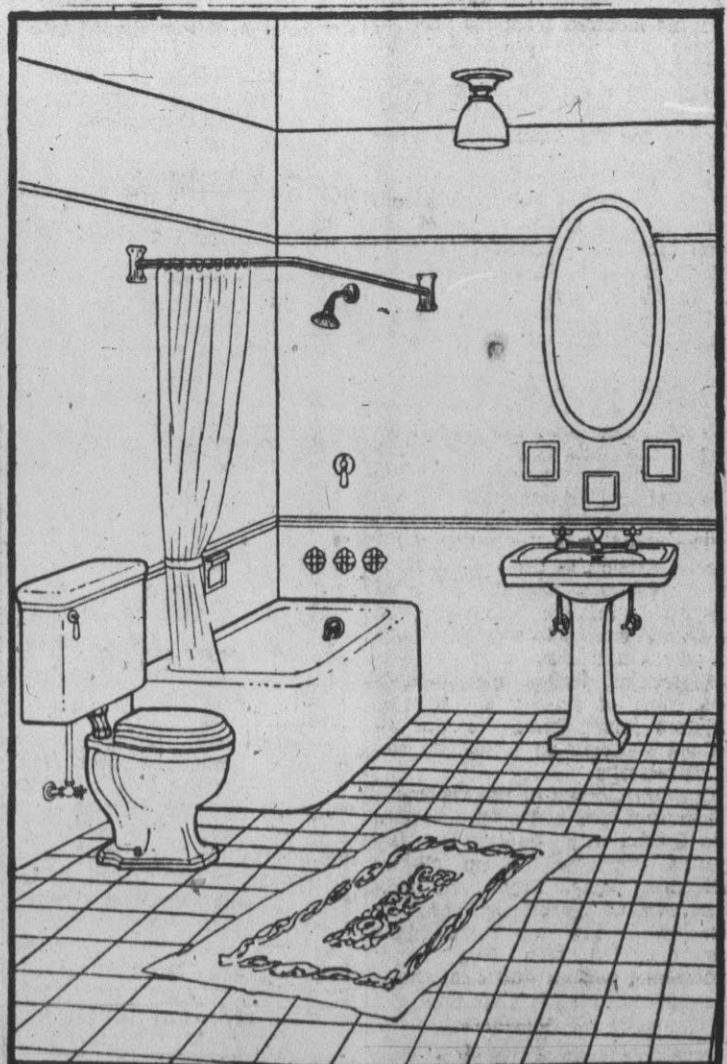

first of the many witnesses the government had subpoenaed in Florida in their effort to show that Capone had large sums of money, although he paid no income tax.

In a formal statement Federal Judge James H. Wilkerson reaffirmed his decision of yesterday to allow the government to present evidence of Capone's attempt in 1930, to settle up his income tax.

The court dealt mainly with the relations between the defendant and Lawrence P. Mattingly, who Judge Wilkerson said was more than an attorney. He acted as Capone's agent in the matter and therefore any act of his within the scope of his authority, could be considered as an act of Capone.

The court ordered the prosecution to read to the jury the principal Mattingly letter in which the attorney said Capone was willing to pay tax on an income of about \$226,000 for four years. The letter was admitted to the records yesterday but not read to the jury until this morning.

TOTAL WOMAN IN KANE CASE

Mrs. Elizabeth Dahl, of New York, May Be Asked to Testify in Wife Drowning

Bradford, Pa., Oct. 9.—(AP)—E. Kent Kane, attorney for his cousin Professor Elisha K. Kane, charged with murder in the drowning of his wife, revealed today he was considering calling Mrs. Elizabeth Harris Dahl, of New York, as a witness at Professor Kane's trial.

Professor Kane's wife, Jenny Graham Kane, was drowned at Hampton, Va., September 11. Investigation revealed a woman named "Betty" had written to Kane and Mrs. Dahl was alleged to be that woman.

The Bradford Era published a story today under the signature of Attorney Kane in which he said he had arranged an interview with Mrs. Dahl here with a view to possibly calling her as a defense witness.

"I am very much pleased to find that she is an intelligent, high-class woman and that her story entirely corroborates that of Professor Kane that they first met before his marriage and before the war and have had nothing to do with each other for approximately two years, excepting for the now famous letter of September 1, which she wrote him after her return from a trip to Europe which she thought would be interesting to him," the attorney said.

"I presume it will be great disappointment to some that the mystery is to be taken out of the 'mystery woman' and to find out that she is just an ordinary good friend, whose last letter, well-intentioned, unfortunately happened to fall into the hands of snooping, suspicious, letter-opening in-laws."

"The letter contained nothing remarkable. The only unfortunate thing was the time of its arrival. It clearly contained no suggestion of 'getting rid' of his wife and did contain the inquiry 'do you still intend to stick?'"

"I should be very glad to have the prosecution produce any other 'love letter' in their possession, and am sure the contents would not be nearly so thrilling as the heavy testimony with regard to them as told by the letter-openers," Attorney Kane said.

ABOUT TOWN

The Northeastern Athletic con-
ference is to be congratulated on its
house cleaning campaign.

The only way the athletic realm
can be kept clean, is through in-
vestigations such as that now un-
derway by the committee appoint-
ed here at the meeting of conference
members Wednesday night.

It was discovered that some of
the clubs were playing ineligible
men in violation of conference
rules, and while all of the guilty
ones were not rounded up the in-
vestigation is expected to effect this
end.

One team has been expelled, and
another faces expulsion, as result
of committee activities, and now
developments are expected when
the probe actually gets under full
swing.

Violation of conference rules
takes all of the interest out of the
game for the clubs attempting to
abide by restrictions, and if play
is to be kept on a high plane it is
necessary for the committee to see
that every regulation is drastically
enforced and that each club re-
ceives the same kind of treatment.

President Hoover's plan to ease
the financial strain on the nation's
banks is moving swiftly toward
actual operation.

The President was informed yester-
day that the Federal Reserve
system had virtually completed
plans for incorporation of the cor-
poration and that details of the
completed proposal would be laid
before every clearing house and
banking groups of the country at
once.

The \$500,000,000 plan presented
by President Hoover to amend the
Federal Reserve Act to permit
broader classes of paper to be
eligible for rediscount at Federal
Reserve banks is said to be de-
signed to replace and take over the
work to be carried on by the bank-
ers' organization which was re-
garded as only a temporary affair.

Some of the funds of the or-
ganization probably will be used to
advance to depositors of suspended
banks part of the money due them
and thus relieve acute situations.

It is impossible to foresee the re-
sults of this action on behalf of
relieving depression existing in all
sections of the nation, but the
effort in behalf of the depositors
alone should do much toward re-
juvenating many communities whose
financial fabric was badly torn by
the closing of leading banks.

It will be necessary for congress
to change the Federal Reserve act
to meet the requirements of the
corporation, but it was believed this
would be done as soon as the next
session meets, opening up a way
for immediate realization of the
movement.

This is Fire Prevention Week
throughout the nation and hun-
dreds of towns and cities are mak-
ing an effort to more fully en-
lighten the public as to safeguards
against further inroads by the fire
demon.

The Greenville Fire Department
has not been able to use any of its
equipment in a public demonstra-
tion, but Fire Chief George Gar-
dner has informed the people that
members of the department will be
glad to assist them in any way
possible.

The nation has reduced its an-
nual fire loss considerably the last
few years, but this condition can-
not continue unless the public aids
the firemen in prevention measures.
The fire loss in North Carolina
last year was twenty millions dol-
lars, or at the rate of \$100,000,000
tax every five years.

It is a staggering loss and one
that cannot be decreased without
the wholehearted support of men
and women—home owners—in
abiding by precautions outlined by
the fire departments from time to
time.

The hazards are called to the at-
tention of the public this week,
and it is hoped everybody appre-
ciative of what the firemen are do-
ing to save their property from de-
struction will see that they put
some of the suggestions into actual
practice around their premises.

Governor Gardner has called a
conference of mayors and members
of county boards of commissioners
for next Tuesday to discuss relief
measures during the winter months.
Although it was not stated what
action would be taken in this con-
nection, it is believed it is the pur-
pose of the governor to organize
committees in each community to
take care of the situation.

It is the purpose of the national
committee set up by President
Hoover to place the responsibility
for the poor upon each individual
community and it is to be supposed
that Governor Gardner will work
along the lines suggested by the
national organization.

That there will be much suffer-
ing this winter by reason of the
unemployment situation is not to
be doubted, and each community

unquestionably will be called upon
to give more liberally to this cause
than in any past year.

It is a great task but one that
must be handled to the best ability
of those charged with the responsi-
bility of putting it through, and it
is to be hoped everybody will join
and make it the success it
must be if human life is to be pro-
tected as it should.

LABOR PUSHES BEER DEMAND

**Federation, However,
Will Not Seek Out-
right Repeal of the
18th Amendment**

By CLEVELAND WILLIAMS

Vancouver, B. C., Oct. 9.—(AP)—
Organized labor's demand for 2.75
percent beer crystallized today at
the American Federation of Labor
convention and committeemen in-
dicated resolutions for outright re-
peal of the 18th Amendment proba-
bly would be sidetracked.

Matthew Woll, chairman of a
labor committee working for con-
gressional sentiment to change the
Volstead Act, explaining that 2.75
percent beer would be of the same
strength as the Canadian draft
brew sold here, and not the "dish-
water" some delegates had thought.

"By 2.75 percent beer I mean
about 3.10 percent by volume," he
said. "Just like the ordinary
Canadian beverage," am not re-
ferring to bottle beer or the strong-
er ales."

President William Green, who
also favors legalization of 2.75 per-
cent beer; W. J. McDonough, head
of the building trades union, and
other leaders indicated most dis-
cussion of resolutions dealing with
alcohol would take place behind
closed doors of the resolutions com-
mittee. However, leaders of the
"wet wing" girded for a possible
battle on the convention floor
shortly.

The committee is expected by
both wet and dry leaders to report
favorably on that section of the
executive council's report favoring
2.75 percent beer the committee
also is expected to report non-con-
currence on resolutions advocating
repeal of the 18th Amendment and
repeal of the Volstead Act.

Woll, explaining the stand of his
committee, said:

"We feel in the Volstead Act the
determination that one-half of one
percent alcohol is intoxicating is
carrying restrictions in manufact-
ured beverages to the point of
absurdity. It does not even com-
ply with the intention of the 18th
Amendment."

"Experts hold that even four
percent beer is non-intoxicating.
"Canadian draft beer is just
what we want in the States."

"What higher content is intoxi-
cating is something about which
authorities differ. We ask some-
thing within the law—within the
18 Amendment. No one can dis-
pute that 2.75 beer is permissible
under the 18th Amendment."

New Bern.—(AP)—Judge N. A.
Sinclair adjourned court after a
slight heart attack here while pre-
viously all cases set for next week
had been postponed because of con-
flict with Federal Court sessions.

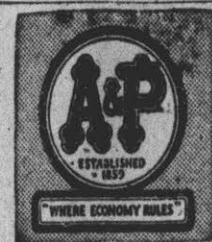

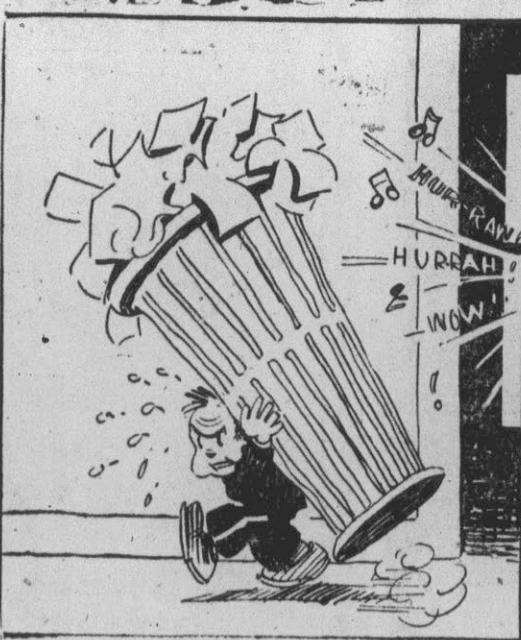

This game is probably the strongest test the Devils have had under Wallace Wade and a victory would send Duke stock booming.

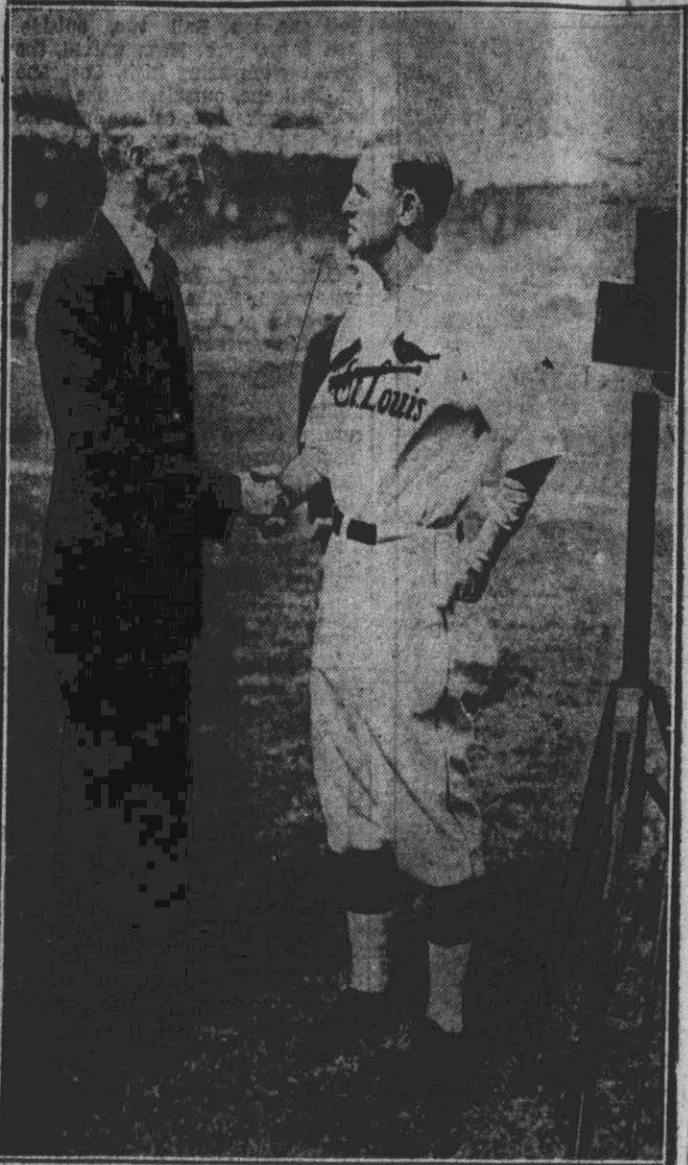

St. Louis, Oct. 9.—(AP)—Early in the spring of 1928 there stumbled into the lobby of the St. Louis Cardinals' hotel in Avon Park, Fla., a haggard, grimy, travel-stained youngster who looked like anything but a ball player.

His hawk-like face with the flashing black eyes was smeared with dirt and there were condors in his dark, tousled hair. Just about the last swag he could muster was in his slightly bow-legged stride as he marched up to the surprised desk clerk.

"Tell Bill McKeechnie," he announced with a weary grin, "that his new center fielder has arrived."

Sunk deep in an easy chair a few feet away, his face buried in a paper, Bill McKeechnie, then manager of the Cardinals, raised his eyes at the sound of his name. He looked from the husky figure of what might have been a hobo to the inquiring gaze of the desk clerk. He moved his head a trifle from side to side and retreated again behind his paper.

"He's not here just now," the desk man announced, "but I'll fix you up with a room."

Thus it was that John Leonard Martin, world series hero, joined the Cardinal ball club. He had spent the money sent him to pay his fare from Oklahoma City to the training camp. He had to ride the rods of freight trains to get there.

A hot bath changed his appearance considerably and he was back at the desk again, looking for McKeechnie. The first fellow he met who would talk to him was an old friend Blake Harper, owner of the Fort Smith club in the Western Association. It was Harper who had greeted Martin as follows when he appeared for work at Ft. Smith years before:

"What's your name?"

"Johnny Martin."

"Nope," said Harper. "You're Pepper Martin. There are too many Johnnies in the league now."

And that was the way he got his name.

For days McKeechnie, trying to tame the cocky youngster, gave him

what was politely known as the "run-around," avoiding him. Martin went out to the practice sessions and hung around the edges, sneaking in a catch here, a slug at the plate there, when he could horn his way in.
