TEN STATES BEHIND NEW CREDIT PLAN

Bankers Support the President's Effort to Hold Cotton Off the Market.

Atlanta, Oct. 21.—(AP)—Bankers of ten cotton states have aligned themselves officially behind a credit extension plan to keep approximately seven million bales of cotton off the market until after July 31, 1932 as a price stimulant.

Conferences on the program, conditionally approved recently by representatives of southern banking interests, the Federal Farm Board and the American Cotton Cooperative Association in an executive session at New Orleans yesterday. General approval resulted.

Under the plan, loan extensions by southern bankers on 3,500,000 bales of cotton would be followed by the Farm Board's continuation of American Cotton Cooperative Association obligations of approximately 2,000,000 bales and the withholding of 1,300,000 bales of stabilization cotton from the market at least until after July next year.

Texas bankers voted unanimously to hold every fourth bale of this year's cotton crop until next July. The Georgia Bankers Association voted to support the extension plan by financing 350,000 bales until next year.

The Bankers Association of Arkansas, besides voting full approval of the cotton holding program, adopted a resolution urging average restriction and pledged support to legislation to carry it out. West Tennessee bankers "approved and endorsed the general tenor" of the financing plan but thirty representatives of banking institutions said they should not be required to specify the exact number of bales they should finance.

Bankers of North Carolina voted to recommend that cotton loans be carried by the State Bankers' Association at least until July 31 next year and South Carolina bankers agreed to finance 225,000 bales through the period.

More than 100 Mississippi bankers approved the plan and pledged the financing of 369,000 bales of cotton. Louisiana bankers representing about one-third of the banks of the cotton growing sections pledged themselves to finance at least 158,700 bales and added pledges were expected.

Oklahoma bankers voted unanimously to cooperate with the other agencies in the plan but did not announce the number of bales they would finance. They predicted, however, that the state's quota of about 250,000 bales would be over-subscribed.

The Bankers Association of Alabama voted approval of the holding plan and announced pledges covering more than one third of the states 350,000 bales.

Smith Offered Presidency Of Elon College

Burlington, Oct. 21.—(AP)—Dr. L. E. Smith, of Norfolk, Va., today had under advisement the offer from its board of trustees of the presidency of Elon College, to succeed Dr. W. A. Harper, who resigned some months ago.

Dr. Smith was elected last night by the board, which met in conjunction with the session of the Southern Christian convention, sponsor of the college which it founded 40 years ago. He is pastor of Christian Temple church in Norfolk. He promised to accept or reject the offer by November 16.

The board did not give out the names of other men considered for the post. Dr. Smith is an Elon graduate.

Will Improve Canton Mill

Cincinnati, O., Oct. 21.—(AP)—The Champion Coated Paper Company will spend approximately \$1,750,000 in improvements at its subsidiary plant, the Champion Fiber Company, Canton, N. C., President Alexander Thompson announced.

The improvements include a contract for a large book paper machine, said to be the largest ever produced, to cost approximately \$500,000. The machine, to be built by a Wilmington, Del., company, will give work to more than 300 men at Wilmington, he added.

The addition to the Canton plant is expected to be in operation by next summer.

Fire Destroys Two Buildings at Hartwell, Ga.

Hartwell, Ga., Oct. 21.—(AP)—An early morning fire in the heart of the business section here today circumscribed two buildings, and caused damage to a third.

Several persons, one a fireman from Anderson, S. C., which sent a truck and crew to aid the Hartwell firemen, were injured by flying glass, none was seriously hurt. Chief Hoyt baker of the Hartwell fire department estimated the damage would reach \$100,000.

The fire started in J. Saul's department store. Flying sparks spread it to the Yates Hardware and Furniture Company building nearby and finally to Birdies Feed Store.

The department store and the hardware and furniture store were virtually destroyed and the feed store slightly damaged.

Dynamite in the hardware store was blamed for the explosion that shook the entire business section.

BUSINESS MAN SLAYS SELF

Jule C. Smith, Dean of Lexington Merchants, Shoots Himself to Death.

Lexington, Oct. 21.—(AP)—Jule C. Smith, 2, dean of Lexington merchants, shot and killed himself early today.

He left a note indicating his purpose and giving instructions for handling his business. "I have seen my best days," the note read. "Nothing seems to give relief. I am sorry."

A coroner's jury rendered a verdict of suicide.

Stokes A. Smith discovered his father's body lying on the floor of the living room with a sofa pillow under the head.

Evidence at the coroner's inquest was that Mr. Smith rose early today and made a hurried trip to his store. There he is believed to have written the note and secured his revolver.

Returning home, he went to the living room where he was accustomed to lighting a fire on coal mornings, laid down on the floor, carefully placed the pillow beneath his head and fired the shot.

Mr. Smith was one of Lexington's pioneer business men. For 60 years he operated a mercantile establishment. (Continued on Page Three)

Constitutional Commission to Meet Tomorrow

Raleigh, Oct. 21.—(AP)—The Constitutional commission named recently by Gov. O. Max Gardner in compliance with an act of the 1931 General Assembly will meet here tomorrow for the purpose of organizing.

It is anticipated that W. P. Stacy, Chief Justice of the Supreme Court, will be elected chairman. At least four persons are seeking the position of paid secretary, being: John A. Livingstone, former newspaper correspondent and now Supreme Court librarian; Charles Brantley Aycock, son of the former governor; William D. Harris, former director of the Department of Conservation and Development and now with the University of North Carolina; and Prof. F. E. Jenkins of the University.

The commission to study the revision of the Constitution was ordered at the same time that the legislature approved submission to the voters of an amendment to the Constitution which would permit amending the document at a special as well as a general election.

If this amendment is adopted the recommendations of the commission will be submitted to the voters at a special election without calling a Constitutional convention.

BLACK'S WIFE ALSO INJURED

Everett McLean Captured at Tarboro After Attempting to Escape on Bus.

Tarboro, Oct. 21.—(AP)—Everett McLean, negro, accused of shooting to death B. H. Beasley, chief of police of Southern Pines, near Durham early today was arrested a few hours later here.

His face was bloody and his clothes stained from injuries suffered when his automobile was wrecked after he shot Beasley.

Officers could not find the gun McLean used to kill Beasley, but a number of cartridges were in his pockets. He also had \$58.85. Officers expressed belief part of the money was taken from Beasley.

McLean's only comment here on the killing was to describe it as an accident. In his brief conversation he also indicated he believed his wife to have been killed.

Durham, Oct. 21.—(AP)—B. H. Beasley, chief of police of Southern Pines, was shot to death early today on the Oxford highway five miles from here by Everett McLean, negro who was being returned from Boynton, a. where he was to face trial on a charge of attempting murder.

Beasley was driving the negro's automobile and when he was killed, it was wrecked, fatally injuring Georgia McLean, sister of Everett. After shooting Beasley, McLean turned the gun on his wife, Pearl Gilchrist McLean, and shot her through the shoulder.

McLean made his way here, caught a bus to Raleigh and escaped. Junius Austin, negro, another passenger in the automobile, was (Continued on Page Six)

STILL SEEKING WOMANKILLER

Ruth Judd, Wanted in Double Trunk Murder, Evades Thousands of Officers.

Los Angeles, Oct. 21.—(AP)—Winnie Ruth Judd, 26, slender blonde wife of a physician and daughter of a minister, remained at large today despite the efforts of thousands of officers seeking her as the perpetrator of the Phoenix trunk murders.

The motive behind the slayings still was almost as much of a mystery as it was Monday night, when the bodies of the victims, Mrs. Agnes Leroy, 22, and Miss Hedvig Samuelson, 24, were taken from trunks which Mrs. Judd had shipped here from Phoenix.

"It must be a case of deranged mind—that's as much as we can say at present," said Detective Inspector D. A. Davidson, in charge of the homicide squad.

Search today was being concentrated in the vicinity of Laguna Beach, artists' colony 60 miles south of here, following a report given by a motorist that a woman hitch-hiker corresponding to Mrs. Judd's description had been given a ride to that point.

"We hardly expect to find Mrs. Judd alive," declared Inspector Davidson. "It is my opinion she will be found a suicide."

Officers again subjected her husband, Dr. W. C. Judd, and her brother, Burton J. McKinnell, to a thorough questioning. Both men had been held as material witnesses but were released from custody last night.

In the meantime word was awaited by the coroner for the disposition of the bodies.

Jewelry Store Window Looted

Charlotte, Oct. 21.—(AP)—A jewelry store window was robbed of goods valued at almost \$400 here this morning while a policeman watched two of the robbers.

One man cut the glass of a window in the entrance way while his confederates stood on the sidewalk and shielded him from the eyes of a patrolman four doors away. When the officer, A. L. McMan, realized what was up he gave chase but too late, and the trio escaped.

SAYS HE HAS NOT RESIGNED

Bishop Cannon, However, Admits Giving up Brazilian and Belgian Conferences.

Atlanta, Ga., Oct. 21.—(AP)—Bishop James Cannon, Jr., has relinquished supervision of the Brazilian and Belgian Congo conferences of the Methodist Episcopal church, south, but he says he hasn't resigned "from anything."

Last night the bishop, who is attending the Ecumenical Methodist Conference here, issued a statement that he had asked Bishop John M. Moore and Bishop U. V. W. Darling to take over supervision of his South American and African duties. It was variously interpreted and he was asked to explain.

"I haven't resigned as a bishop. I haven't resigned as chairman of the Board of Temperance and Social Service. I haven't resigned from anything. I have nothing further to say except what was in my statement."

Bishop Moore said he construed the Virginia bishop's statement to mean exactly what he said regarding the transfer of conference authority and that his position in the College of Bishops, the supervisory body of the church, was not affected.

The statement followed Bishop Cannon's indictment by a Federal grand jury in the District of Columbia on ten counts of violation of the corrupt practices act because of his activities in the presidential campaign of 1928.

The bishop said confidence expressed in both public and private to continue his "life long work for social betterment and especially against the liquor traffic," had laid on him an obligation "which I can not conscientiously ignore" to continue his activities to the limit of his strength regardless of court proceedings or continued attacks.

The reference to his indictment, he said he had received a copy of the charges and did not believe an indictment would have been rendered. (Continued on Page Three)

Slays Bride, Then Shoots Himself

Wendell, N. C., Oct. 21.—(AP)—Ivan Hinnant, 58, and his bride of one year, Mrs. Bertha Hinnant, were found dead in the Hinnant home four miles from here today, and first reports were that Hinnant apparently shot his wife and then killed himself.

Hinnant was a well-known Johnston county farmer. The bodies were found on the floor of the Hinnant home. Hinnant was believed to have shot his wife with a load of shot from one barrel of a double-barreled shotgun and then to have blown the top of his head off with the other.

RAISE CREDIT FUND IN STATE

North Carolina Bankers Join the Hoover Movement for Revival of Industry.

Greensboro, Oct. 21.—(AP)—North Carolina today had taken her place among those states which have joined with President Hoover's national credit corporation in an effort to relieve the country's stringent economic situation.

Bankers of the state, in session here, subscribed \$2,625,000 toward the \$500,000,000 being raised by the national corporation for the purpose of credit expansion.

BIG TRIBUTE FOR EDISON

Minute of Darkness Tonight at 10 O'clock to Honor Memory of Inventor.

(By The Associated Press) Americans made Thomas Edison's electric lamp today a beacon of tribute to his memory.

One minute of darkness at ten o'clock (EST) tonight—an hour when night will have enfolded all America between the two oceans—was suggested by President Hoover as a solemn tribute to the memory of Thomas Alva Edison.

"I suggest," the President said, "that all individuals should extinguish their lights for one minute Wednesday evening, Oct. 21, at 10 o'clock Eastern Standard Time. It is my understanding that the broadcast companies will undertake a brief program in respect to Mr. Edison's memory at this moment."

Mr. Hoover said the turning off of electrical current at generating plants as had been suggested, "would constitute a great peril to life throughout the country."

Wife of Slain Man Views Body

Rocky Mount, Oct. 21.—(AP)—The estranged wife of Tom Chappel, shot to death here yesterday by D. W. Coleman, a railroad detective, came to Rocky Mount today to view her former husband's body.

Chappel was slain as he dashed from the rear door of Coleman's home carrying his shoes in his hands.

Arriving from her home at Florence, S. C., where Chappel formerly was manager of a large baking plant, Mrs. Chappel went immediately to the funeral parlor where the body has been since the shooting.

Visibly moved by the experience, Mrs. Chappel offered no comment as she hastily left the undertaking establishment.

Meanwhile, Coleman, who returned home unexpectedly to find Chappel fleeing his house, and his attorney, Harold D. Cooley, of Nashville, prepared for a hearing which has been set for next Tuesday.

Neither would discuss their plans for a defense. Nor has there been any indication whether relatives of Chappel would employ counsel to assist the prosecution.

SPECULATION RISE IN U. S.

Government Officials Also Think French Premier will Discuss Drastic Arms Reduction as a Means of Relieving Tangled Fabric of World Economics; Not Believed He Will Ask for Guarantee of French Political Security.

Washington, Oct. 21.—(AP)—A broad readjustment of the tangled fabric of world economics, including possible debt revisions and drastic arms reduction, but involving no American guarantee of French political security, is conceived by the American Government to be the theme of Premier Laval's coming conferences with President Hoover.

There is no expectation here that any sort of prior commitment, in the form of a Franco-American consular pact or otherwise, will be discussed when the two statesmen sit down together at the White House later this week.

The United States does not consider itself in a position to make promises respecting the security of France or any other European nation. It will be a surprise if M. Laval actually suggests such a step.

The understanding here is that the side basis of the Hoover-Laval conversations will be world economic rehabilitation. France and the United States, holding between them most of the world's gold, stand in a position of special responsibility, and are expected here to approach their decisions with a full realization of that responsibility.

It now is recognized by many officials in Washington that revision of the war debts must come to the front in any such discussion.

All along, the United States has the yardstick of "ability to pay" in dealing with these obligations, and that yardstick again will be used by Mr. Hoover when he talks with M. Laval.

Ability to pay was the basis of the Dawes plan and the latter Young plan for German reparations. It was the basis on which, in the prosperous post-war years, the United States revised and refunded the war debts owed here by the Allies. Ability to pay now in a time of world upset, and prospective ability to pay, will be the basis on which Mr. Hoover lays his views before his French conferee.

All along, too, the United States has felt that an integral factor in world economic distress was the immense sum expended constantly on armaments.

From this economic point of view, for the moment, the whole armaments problem is under review by the president. France is a larger spender in military preparations. Mr. Hoover will try to make Premier Laval see how directly and powerfully, in the American view, this situation is reflected in the world financial balance.

Some reports have indicated that French statesmen are toying with a proposal whereby the United States either would agree to come to France's aid in war or at least consult with her upon the threat of war. There is no intention here of entertaining such a proposal, if it ever is made.

Washington, Oct. 21.—(AP)—President Hoover today wired Premier Laval of France a welcome in his own name and in that of the American people.

"As you near the shores of the United States," the president said, "I take great pleasure in extending to you a most cordial welcome in my own name and in that of my fellow countrymen."

The message was similar to that which the president wired to Prime Minister MacDonald of Great Britain, as he neared America two years ago.

Mexico City, Oct. 21.—(AP)—Major James H. Doolittle, noted American flier, was taking a day off today after having hung up a new mark for air speedsters yesterday by flying from Ottawa, Canada, to Mexico City, by way of Washington, D. C., in 12 hours and 36 minutes, linking three capitals.

Major Doolittle landed his swift plane, which he called his "Baby Powerhouse," at Valbuena Field at 3:16 p. m. mountain time. He took off from Ottawa at 4:40 a. m. and (Continued on Page Three)

Ask Governor to Call Conference on Cotton Relief

Raleigh, Oct. 21.—(AP)—Governor O. Max Gardner today was asked by the North Carolina Supply Merchants Association to call a conference of the governors of North Carolina, Virginia, South Carolina and Georgia to consider "definite and constructive steps" to curtail tobacco acreage.

Headed by State Senator W. G. Clark of Tarboro and President Raymond Turnage of Tyden, a delegation of 25 to 30 persons from the supply merchants body proposed that Governor Gardner immediately call a meeting of the governors, heads of the departments of agriculture and representative business men, bankers and farmers of the four states to draft an program to be adopted by the legislatures of the states. The legislation would cover tobacco, cotton, peanuts and other agricultural crops.

Governor Gardner told the delegation, which was the first of two to appear before him today, that the agricultural problem of the state was causing him more worry at this time than any other but that he had to think carefully over all propositions made before he could call a special session of the legislature. If it developed that such was the best course to pursue, a number of members of the Merchant Association, including J. E. Winslow of Greenville, J. H. Bicum of Greenville, J. H. Robinson of Martin county, and F. D. Finch of Wake, told the governor how serious they thought the tobacco situation in Eastern North Carolina is.

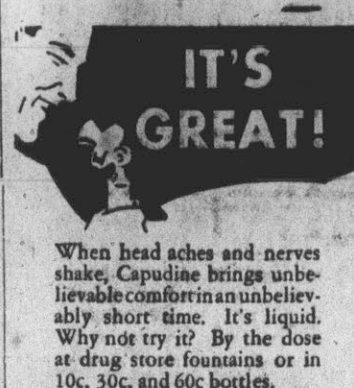

ABOUT TOWN

The shattering of records seems
to the order of the day on the
Greenville tobacco market.

Sales records have been shattered
twice this season, the last coming
Monday when the market sold
over 1,500,000 pounds.

In addition to this the highest
price average of the season was
established, bringing joy to the
hearts of the men who struggled
all summer with their crops in
preparation for the market opening.

The heavy sales of the last three
weeks have placed Greenville ahead
of all world markets by over three
million pounds. This gives us the
reputation as the greatest market
in the world, a distinction which
tobaccoists will do everything in
their power to maintain during the
remainder of the season.

Greenville has facilities equal to
no other market in the world, and
the five sets of buyers enable it to
handle just as much tobacco per
day as any market in the universe.

The tobaccoists have been
striving for years to achieve this
honor and now they have won it
they are going to do everything
within the power of human effort
to hold it.

Over seventy lives were claimed
by highway accidents during the
month of September in this state.
What a toll of human life to be
sacrificed at the expense of speed
and carelessness.

Accidents in many cases are
termed as unavoidable. The ex-
pression may cover the incident but
how different it would have been if
those involved had not been in
such a rush to get to their destina-
tion.

It is impossible to foresee what is
ahead of us when we go out on the
highways and it is nothing but
right for us to observe every pre-
caution in effort to lower the toll
of death exacted by the highways
each month.

Automobile drivers should re-
member the awful toll they have to
pay as result of wrecks and drive
as carefully as possible under all
circumstances, remembering that
faulty mechanism or judgment has
landed many a person in his grave.

The Interstate Commerce Com-
mission yesterday denied railroad
permission to increase rates
throughout the nation, bringing to
an end a long drawn out contro-
versy concerning the condition of
rail lines.

The decision undoubtedly will
receive approbation of the millions
of shippers throughout the nation,
although it will cause the railroads
to adopt measures of economy
vitaly affecting the workmen.

It is realized the rail lines have
suffered severely from lack of busi-
ness as result of truck competition,
but it is impossible to see where
they would benefit by increase of
rates. Instead of profiting it seems
that loss of business would out-
weigh any benefits to be derived
from higher rates.

Delegations from all parts of
Eastern Carolina went to Raleigh
today to attempt to impress Gov-
ernor Gardner with the necessity of
calling a special session of the
Legislature to deal with the cotton
and tobacco situation. They will
demand the passage of legislation
having as its purpose the reduction
of acreage along the lines adopted
by other cotton growing states of
the South.

Resolutions to this effect were
adopted by Pitt county representa-
tives, business men and planters
before Monday, and will be present-
ed by a delegation at the meeting
today.

Although it is a known fact that
Governor Gardner is opposed to
the calling of the Legislature to
deal with the question, it is the
hope of the delegations that suffi-
cient pressure may be brought to
bear to convince him that it is the
will of the people and must be
obeyed.

With both cotton and tobacco
markets congested until prices have
gone to the lowest levels in years,
it is evident something must be
done to prevent further glutting
of the supply. The time to strike
has arrived, and it is hoped North

Carolina will be no laggard in this
effort to rehabilitate the economic
condition of the southland.

Greenville Rotarians celebrated
"Charter Night" this week and
heard four of the six remaining ac-
tive charter members deliver in-
teresting talks dealing with club
activities.

Greenville Rotarians have many
things to be proud of—achieve-
ments that have placed them un-
mistakably in the front ranks of
other organizations of the kind
throughout the nation and world.

In the section of their own home
shortly after organization was per-
fected, the Roters, forged to the
forefront as the only club in the
world with a home all its own.
This one progressive movement
placed them in the spotlight of
world organizations, and in spite of
hard times which have gripped the
locality the last several years,
they have managed to hold their
own and to continue to gain addi-
tional honors.

The charter members are to be
congratulated upon their splendid
record of service. They have not
only achieved recognition for them-
selves but for the city and com-
munity, and nobody is more appre-
ciative of their work than the mem-
bers of other organizations and in-
stitutions armed in behalf of the
same cause—a greater and better
Greenville.

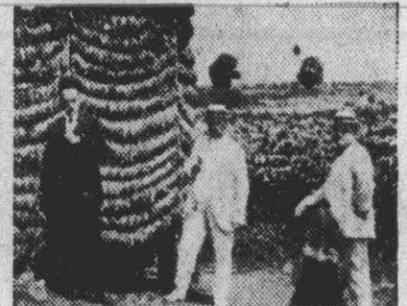

Is John Leonard (Pepper) Mar have been looking for all these years? In the second Ty Cobb that we have he the ball player destined to that has so long been dominated by furnish th popular, personal appeal Babe Ruth?

Is he the real goods, in other words, or just an inspired youngster who happened to start the world's series at top speed and keep it up?

I heard these questions debated all the way from St. Louis to Philadelphia, and back again, by some of baseball's oldest and best known observers. No doubt it was the talk of the crossroads, as well as Broadway while the big battle was on between the Cardinals and Athletics.

Men who have seen every inter-league war since 1903 never saw the world's series equal of Martin. Babe Ruth has gone on a greater long distance hitting rampage than anyone else. From Mathewson to Earnshaw, pitchers have held the spotlight.

Public Enemy
For one, two and even three games, stars have shone, but none ever sustained the pace of Martin at bat or on the bases. It was no wonder they labelled him "Public Enemy No. 1" in Philadelphia, tho they cheered the youngster vociferously there as well as in St. Louis.

"Martin's exploits are the closest I have ever seen to those of Ty Cobb, at the Georgian's best, but Ty never was the world's series terror that Martin has been," commented William Harbridge, new president of the American league during a breakfast chat.

"Cobb could demoralize a team completely on the bases, but I do not recall that he ever did anything to surpass Martin's achievements in a single series, especially with so much at stake."

There was nothing special in Martin's first year record with the Cards to forecast his sensational outburst. He hit around .350 in the International league with Rochester in 1930, but batted only .298 and stole 17 bases this year. It was good work for a newcomer, but that was about all.

When the boys were discussing Cardinal youngsters for the series they talked mostly of the chances of Paul Derringer, the freshman pitcher, becoming the big hero.

Martin may have been playing "over his head." No player could sustain so terrific a pace during the season, but baseball men, after looking him over, are convinced he has the stuff to go on to real stardom.

"Martin has found himself under the glare of the most piercing spotlight in the business," remarked an old-timer. "Apparently he's the type requiring a big objective to bring him out. If so, he is bound to be tough to stop."

"Don't forget either that although a first year major leaguer, he is 27 years old and experienced enough to keep a level head under all the praise and beniqueting that are going to come his way."

While little knots of football fans on streets from Wilmington to Asheville and beyond talk about him and alumni make plans for petitions for his reinstatement, they are keeping very quiet about him in Chapel Hill.

Chuck Collins, the Tar Heel mentor, quit talking about Johnny for publication when he announced the flashy quarterback and Roy McDade, tackle, were suspended for breaking training. And he has been going right along making his plans for finishing the football season without him.

Not even the reports yesterday of plans of alumni to ask the reinstatement of Branch moved Collins to conversation. He gave Stuart Chandler, his first string quarterback now, a rest and put Johnny Peacock, Chandler's understudy, through his paces as he drilled his team for the Tennessee game Saturday.

Peacock along with the rest of the Tar Heels looked good. They ripped off long gains in scrimmage and Collins announced more satisfaction with his boys than at any time in the past fortnight. Rip Slusser, Bill Groom and George Houston all showed up well. Frank Smith, tackle who has been out with injuries, was back in uniform. There was a lot of experimenting in both the Duke and Wake Forest camps as the Blue Devils and Deacons prepared for their important contest in the state race Friday.

Coach Wallace Wade had Erhsler and Sink alternating at the blocking back's position in a first string backfield which, also listed Brewer, Mason and Lane, the latter a sophomore punting and passing star. The combination demonstrated strong ground gaining ability in a scrimmage with the yearlings.

Heston Gives Up Grid Work

Ann Arbor, Mich., Oct. 21.—(AP)—Willie Heston, Jr., who wishes sometimes his name were Smith, is said by his friends to have given up football.

Willie Heston has been a name to conjure with at Michigan since a stalwart of that name plunged his way into the headlines and onto Walter Camp's all-American football team a quarter of a century ago.

Last year he played with the varsity in enough games to win his letter. This year he was assigned to the "B" squad. He didn't accompany the "B" team to Ohio State last Saturday and when he didn't appear for practice this week, someone asked him why. He said he needed the time for his studies. He expects to graduate in June.

His friends believe the responsibilities his name carried have ruined whatever chances he had to become a football star because coaches and fans expected too much of him. Some remarks he made a few years ago during his prep-school days would indicate he agrees with them.

Discourage Bout Between Uzcudun and Big Carnera

New York, Oct. 21.—(AP)—The New York State Athletic Commission has turned thumbs down on a heavyweight bout between Primo Carnera and Paulino Uzcudun on the grounds that it would be a "step-ladder" match.

Listen to William Muldoon on the subject:

"In the future we will insist that heavyweights must be well matched physically as well as in other respects. Carnera should fight men in his own size like Victorio Campolo, Arthur de Kuh, and Jose Santa, we don't want any more step-ladder matches, where one of the principals needs a soap box to reach the other's chin. I was against the Walker-Sharkey match for that matter and only approved it against my better judgment."

Carnera and Uzcudun were matched for a ten rounder at Madison Square Garden November 13 for a theatrical charity sponsored by Daniel Frohman. Uzcudun, despite his lack of height, gave Primo a close battle when they met at Barcelona months ago.

Jimmy Johnson, new general manager for the Garden, now hopes to persuade Campolo to take Paulino's place against Carnera.

New York, Oct. 21.—(AP)—Cotton opened steady today, four points higher to five points lower, with the near months relatively firm on buying against sales in the late delivery. General business was comparatively quiet and after easing off a few points the market held fairly steady on trade buying and covering.

After showing net losses of about 5 to 8 points, there were partial recoveries with the market ruling within 2 or 3 points of yesterday's closing quotations at the end of the first half hour. There was not much comment on the weekly report of the weather bureau, while reports that some of the state banking associations had endorsed the New Orleans plan for holding cotton, did not appear to be considered an immediate market factor.

Liverpool cables said that hedging and realizing had been absorbed by trade calling in that market and that sales of cotton yarns were in excess of production.

GRAIN MARKET

Chicago, Oct. 21.—(AP)—A fresh rise in wheat values late today coincides with a renewal of stock market rallies, and with enlarged estimates of North American wheat export business. About 1,000,000 bushels of United States hard winter wheat was said to have been taken today for shipment overseas. Official reports indicated that 1931 Northern Hemisphere wheat production would be 100,000,000 bushels short of 1930, exclusive of Russia and China, and that the Russian crop was also smaller despite increased acreage.

STOCK MARKET

New York, Oct. 21.—(AP)—The stock market refused to be downcast as result of the moderate and qualified increases in freight rates granted the railroads by the Interstate Commerce Commission.

The market was dragged down by a rather wide break in the carrier issues during the morning, and speculators who had endeavored to clean up on the basis of a partial leak on the decision yesterday, received burned fingers. After midday the market started upward under leadership of the utilities. The rails rallied only partially, but several of the utilities and industrials more than regained early losses.

American and Foreign Power soon recorded a gain of 2 points, and other issues up a point or more included Johns-Manville, American Power and Light Pacific Lighting, Hyers, and International Match preferred, and Coca-Cola. Such issues as American Can, American Telephone, U. S. Steel, Sears Roebuck and Consolidated Gas rebounded after selling off 2 to 3 points. In the rails, there were recoveries of 1 to 3 points, after losses of 4 to 8 in such issues as Union Pacific, Southern Pacific New York Central, Baltimore and Ohio and Pennsylvania. Trading grew active on the afternoon advance.

Mid-week business statistics indicated little important change in underlying conditions, but it was reported in important banking circles that confidence in American securities appeared to be returning both at home and abroad, and that careful buying was coming from leading financial quarters. Bankers said that several so-called menacing situations had been rectified, and that the outlook appeared greatly improved.

Laval Against War Debt Cut

S. S. Le de France, Oct. 21.—(AP)—Premier Pierre Laval of France, who will arrive tomorrow for conferences with President Hoover at Washington, believes that, as a favor to France, no proposal for a 50 percent reduction of war debt should be considered, it was understood today.

The majority of the premier's supporters in the French Parliament, it was said, are emphatic on that point.

The premier has certain convictions about the welfare of his country and is prepared to meet the American viewpoint only so far as it does not conflict with these. One of them concerns the linking of financial and military problems.

The French government and Parliament, it was understood, believe that war debt reduction would mean a financial loss to France, no matter what conditions were agreed upon.

The French, it was said, do not force any debt reduction plan which would not mean a loss in the income they regard as needed to cover the expense of restoring the devastated regions.

PITT DELEGATION ATTENDS CATHETER AT CAPITAL TODAY

Accompanied by several other men from different sections of the county, J. H. Blount of Greenville and J. R. Turnage of Ayden, left this morning for Raleigh, where they will present resolutions from this county requesting the governor to call a special session of the legislature to deal with cotton and tobacco acreage reduction.

Similar delegations from other parts of the eastern section of the state also attended the meeting which was held today at the noon hour.

The resolutions were adopted at a mass meeting at the court house here Monday and expressed belief that this state should adopt action to that taken by other states of the southland with a view of improving the economic condition.

COBB TELLS COLLEGE STUDENTS ABOUT TOBACCO

K. W. Cobb, supervisor of sales of the Greenville tobacco market, addressed students of East Carolina Teacher College yesterday morning. He dealt exclusively with the tobacco industry, explaining the handling of the leaf from the time it leaves the fields until it reaches the factory.

He informed the students that by selling more tobacco than any other market in the world, Greenville at the present time held the distinction of being the world's largest sales center. He also told them that Pitt county was the largest producer of bright leaf in the world which makes it the logical center for the world's largest market.

After the address, practically the entire student body, accompanied by several faculty members, visited the market and obtained first-hand information on auction sales.

A passing motorist discovered the wreck and Beasley's body and notified officers here. Everett, meanwhile, had made good his opportunity to escape.

Officers traced him to Raleigh and learned he took a bus there either for Norfolk, Va., or for some point in Northern Virginia.

NEW PROPOSAL FOR RAILROADS

Interstate Commerce Commission Presents Plan for Pooling of Monies.

Washington, Oct. 21.—(AP)—Flatly denied permission to raise freight rates 15 per cent, America's railroads have before then a new and untried Interstate Commerce Commission proposal for pooling monies derived from surcharges on freight bills to aid the less prosperous lines.

The railroads were left with no apparent alternative but to accept the plan. They were told by the commission their 15 per cent proposal would be harmful to themselves because of the growing use of trucks and pipe-lines. Their executives were directed to submit a plan for handling the pool by December 1 and were informed it could not operate longer than March 31, 1933.

The spectacular effort of the carriers, as a whole, was brought to a startling conclusion with an announcement late yesterday of the commission proposal. Railroad men and attorneys had scoffed at the plan when shippers suggested it at hearings. It was unwelcome, they said. The commission, however, today asserted it was workable.

At the same time the commission outlined the commodities on which it would permit surcharges. They were limited to a maximum of 10 per cent. Some commodities, including coal, ores of all kinds and forest products were limited to \$3 a carload; some others to \$6 a car and still others to one and two cents a 100 pounds. Major farm products—including wheat, corn, cotton, livestock, and most fresh fruits—were not to be levied against further.

The commission disclaimed any responsibility for keeping the income of the railroads up to the requirements of the New York and other state laws for investment purposes.

"We do not find that we are justified on this record to attempt," it said, "by a rate increase, to protect the margin of one and one-half times fixed charges set by the New York law. To provide so far as practical that actual interest charges be met is justified."

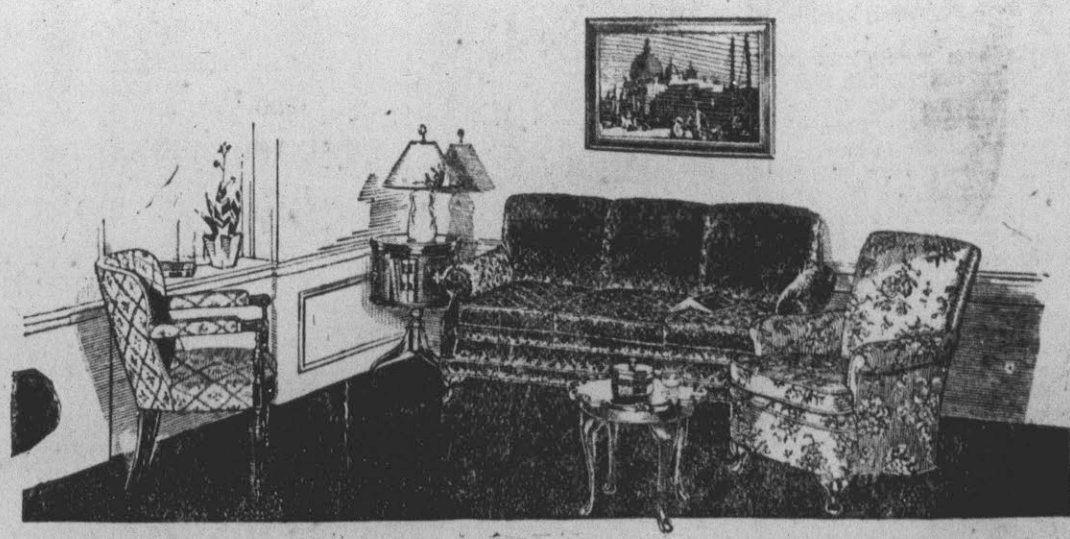
