STIMSON ELATED OVER OUTCOME OF MEETING OF HOOVER AND LAVAL

EXPECTATIONS FULFILLED

Administration Pleas-ed with Spiking of Rumor that France was Trying to Get U. S. Off the Gold Standard; Action on Reparations is Also Viewed with Pleas-ure; Germany Sees a Need of Interna-tional Conference.

Washington, Oct. 26.—(AP)—Secretary Stimson said today the Hoover-Laval conversations had fulfilled all his expectations.

The secretary declined to speak further for quotation on the French premier's visit, referring questions to the communique issued yesterday by President Hoover and M. Laval.

The administration feels that at least two concrete accomplishments resulted from the discussions. One was the definite spiking of rumors current in the last two weeks that the French government was attempting to drive the United States off the gold standard.

The second major accomplishment seen by high officials was in the field of reparations. France has always opposed any change in the payments by Germany, but it was agreed by the two conferees that during the period of depression Germany may need help.

The initiative is to be left to Germany, which is expected to ask soon for relief from her reparations. France is expected to agree provided the war debts are readjusted, and the United States is ready to consider proposals for such a readjustment.

Neither Mr. Hoover nor M. Laval was in a position to commit his government definitely. Any curtailment of war debts owed the United States must eventually have the approval of Congress, where the opposition is already preparing to give battle. The French Parliament might veto any cut in German reparations. Both President and Premier, however, rely apparently on the force of circumstances and the appeal of economic betterment to carry the point.

Only vague possibilities appeared today that the war-debt cut would be accompanied by such reduction of armaments so much desired by President Hoover. From first to last Premier Laval stood firm that France must remain arm until she has a better guarantee of security. That the United States would give any such guarantee, however, was so far out of the question that the premier did not even suggest it.

The more tangible immediate results of the negotiations embraced a pledge of mutual aid to preserve the French and American monetary systems on the gold standard; to cooperate in the stabilization of international exchange; and to work untidily for the liberation, not only of frozen securities, but of what Mr. Hoover calls "frozen confidence." No more French attacks on the value of the American dollar are expected. French gold withdrawals from New York already are being halted.

A long official statement issued last night from the White House set forth in general terms the scope and accomplishments of the Friday-to-Sunday conference. It was sponsored jointly by President Hoover and Premier Laval, and most of yesterday was occupied in casting English and French official

Raleigh, Oct. 26.—(AP)—Milton Martin, 18, of San Francisco, Cal., died shortly after 2 o'clock this morning in Rex Hospital here of injuries suffered when struck by a hit-and-run car between Raleigh and Wake Forest last night.

Martin and a chum, Markler Halton, 18, were hitch-hiking to California. They once lived in the same block in New York and had recently worked in the same shop in New York until unemployment and depression forced them out of work. They decided to go to California, where Martin's mother and a sister lived.

Late last night they were practically penniless but happy as they plodded toward Raleigh. Suddenly, however, Martin fell to the road screaming, fatally injured, and Halton found himself lying in a ditch with an injured leg.

It was half-an-hour before Halton could get any help. Motorists refused to stop—"I guess they thought we wanted to hold them up"—he said. Finally he found a farm house and a farmer and a woman stopped a car which brought the dying and injured youths here. Halton's first thought was to let (Continued on Page Three)

MUCH TIMBER IS DESTROYED

Hundreds of Animals and Fowls Killed by Devastating Flames Racing Across Onslow, Craven and Carteret Counties; Deer Hunter, Trapped in Pall of Smoke Escapes with Minor Injuries.

Kinston, N. C., Oct. 26.—(AP)—Thousands of acres of timberland flamed in three counties today and in the blackened wake of the blaze lay charred carcasses of hundreds of animals and fowls.

Fires in Onslow, Craven and Carteret counties burned from the village of Seattle eastward in what was described as one of the most devastating conflagrations in the section's history.

The flames roared through forests and scrub growth from the Neuse river on the north and White Oak on the west almost to the coast.

No loss of human life has been reported but one deer hunter was lost 24 hours east of Whiteoak before he finally made his way through dense smoke and flames to safety suffering from minor injuries and exposure.

Much game is being destroyed. The burned and blackened bodies of deer and fowls, dot the smudged countryside.

No rain has fallen in more than seven weeks on the forest which are dry as tinder.

R. B. Dunn, postmaster here, returning from Stella, said the rats in the road could not be seen because of the heavy pall of smoke that hangs over the entire section.

Forest fire wardens last week foresaw the danger of fire when they reported the timber dry and several small fires burning over scattered areas.

The discussions so far have been limited to the possibilities of arranging credit to stimulate consumption of these American produced commodities in Europe, particularly France.

Both France and Germany, Stone said, will need to buy wheat because of damage to their crops from adverse weather.

In their conference Stone and Du Pasquier surveyed the whole question of international finance, a subject in which the Farm Board chairman is intensely interested.

The purpose, as outlined by Stone, was not so much to sell stocks from the holdings controlled by the Farm Board, but to increase the cotton and American wheat and cotton in Europe.

Stone added it was immaterial to him whether the Farm Board stock was disposed of. Any possible sales could as well be made from the current crops, he said.

A short while ago, Stone appealed to American bankers to take the leadership in speeding up world trade and urged steps to provide international credit.

through the hard time period in much better shape than ever before.

This is indicative of the fact that the State is recovering from the nervousness existing last year and the early part of the present year. In fact, many of the leading institutions are in the most liquid condition of years, as recent statements will indicate, assuring the public of an extra safeguard against recurrence of the bank break epidemic.

Greenville banks are not only doing healthy business, but are in the most liquid condition in years, adding much to the general improvement of the community.

America had taken refuge during his declining days in the quiet fastness of his forest tract here. His home stood out in its spacious beauty against acres of untouched wilderness, much of it was overrun by animals which scurried through tangled underbrush as they did long before the white man came.

This later home of his was not so far from that 600 acre tract which, in other years, was the camp at which the Woodland Bards, the famous White Sox shooting Association, gathered for their autumnal feasts.

Comiskey's body today will be forwarded to Chicago where the "Old Roman" wrought his achievements.

Comiskey, who "fought for every point because, through bitter experience" he early learned that one lost decision may mean the loss of a pennant," began life on the sandlots of Milwaukee. His father, a politician, wanted to make a plumber out of him; but Charles Albert insisted on sneaking off to the ill provided diamonds to play third base at \$60 a month for a team entitled the Aetris.

He was 17, then, and he was graduated from Milwaukee to Elgin, Ill., as a pitcher. He won every game he played that year. At 19 he joined Dubuque of the Northwestern league, and changed, four years later, to the St. Louis Browns of the American Association.

Comiskey became a famous figure in the baseball world long before he established his White Sox in Chicago. He was a known fighter, a free spender, and loyal to those who were loyal to him.

After having built up the Sox from the beginning of the American League into an organization known the world over, the battling "Old Roman" caused a sensation when in 1920 he wrecked his machine on finding that the 1919 world series had been thrown to the Cincinnati club.

At one sweep, he suspended seven of his stars, losing contracts worth a million dollars.

Recovering from the shock, he gathered around him another team. For one player from the minor league he paid \$100,000, the highest figure ever paid for a minor league player up to that time. That was the price he paid for Willie Kamm of San Francisco.

The White Sox never quite recovered from their 1920 slump, but to the end of his days, the "Old Roman" fought on, hopefully, untiringly. He was the first ball player to rise from the ranks to the full ownership of a major league club, including both players and grounds.

George Jackson, 40-year-old farmer, apparently went insane as he sat in a Sunday afternoon gathering of relatives at an uncle's home near here, scattered the group with sudden oaths, killed five of them and went to the neighboring home of a cousin and fatally wounded him.

Armed with a pistol and shotgun, the death weapons, Jackson fled to a thick woods and early today had eluded capture by 75 possemen who sought him. An 11-year-old daughter, Lula, accompanied him. Bloodhounds aided the posse seeking them.

Those slain were Hemp, 52, and Hayes Jackson, 61, uncles; Mrs. Darl Jackson, 46, an aunt; her sons, Melvin, 28, and Bill, 22, and Herman Jackson, 50, the cousin.

The failure of officers to apprehend Jackson spread terror among his other relatives in this section who armed themselves in fear, they said, that he would attack them.

A police guard was set up about the home in nearby Orangeburg county of Mrs. Bell Williams, the mother-in-law of Jackson. Officers quoted her as saying Jackson came to her home early yesterday, inquired about his estranged wife, and then said:

"I'm going back to Bethcar (the section where he lived) and wipe out one family and then come back here and wipe out another."

Darl Jackson, uncle of George, was the only person at his home to escape the carnage spread by his apparently crazy nephew.

Telling the story of the sudden attack he said Jackson came to his home, sat down and talked quietly with relatives for several minutes and then suddenly arose, cursing and exclaiming:

"I am of a good mind to kill everyone of you."

Amid the screams of his victims Jackson shot down Hemp, Hayes and Melvin and then followed Bill, who had run from the house, and killed him in a field.

The slayer returned to the house, shot Mrs. Jackson, who was miffing to her wounded son, fired

another shot into the body of Hamp Jackson and killed him.

With his daughter he then fled into the woods. The slayer and his wife separated some time ago. She is reported to be in Columbia, S. C. now. Officers said Jackson shot and wounded her shortly before they separated and about 10 years ago shot Hamp Jackson over a quarrel.

New York, Oct. 26.—(AP)—Cotton opened barely steady today at decline of 10 to 16 points on selling orders principally from the south. There was also evidence of European and local selling.

There was enough covering and a moderate buying to give the market a fairly steady tone right after the call, however, the selling continued with December easing off to 6.71 and March to 6.95, or about 14 to 15 points net lower. Business was fairly active and some southern selling orders seemed to have accumulated over the week-end, as the offerings from that source were said to be larger than for some time. The report of the Census Bureau showing ginning of 9,080,041 bales prior to October 18, making an outturn of about 4,087,000 bales for the first October period, or the largest on record.

Liverpool cables reported hedging, liquidation and trade calling and said the demand for cotton cloths and yarns was well sustained with more mills reopening.

STOCK MARKET

New York, Oct. 26.—(AP)—The stock market found further bullish stimulation lacking at the start of the new week and prices drifted lower in slow trading. Bonds, however, held fairly steady.

While the announced results of the Hoover-Laval conference were widely hailed as constructive, they were too nearly in line with conservative expectations in Wall Street to provide further bullish impulse to share prices. There were occasional feeble rallies in shares, one occurring in the early afternoon.

Losses of 2 to 4 points had appeared in such issues as American Telephone, American Can, U. S. Steel Bethlehem, Allied Chemical, DuPont, Eastman and Westinghouse. Royal Dutch was weak, losing nearly 3 points. It was also weak in the London and Paris markets, reflecting a rumor that the company might pass its dividend.

Wall street was keenly interested in the closing of the Hoover-Laval conference, and several prominent bankers felt that the groundwork had been laid for a reopening of the intergovernmental debt question in a manner most likely to assure a reconciliation of the various nationalistic points of view. Some leading bankers have felt that further initiative in the matter should come from the other side of the Atlantic, as indicated in the Hoover-Laval statement.

Bankers said that pronounced

progress had already been made in the Franco-American banking conferences toward the cooperation for maintenance of the gold standard and stability in international exchange, as stressed in the joint statement by Premier Laval and President Hoover.

The copper negotiations were said to be progressing satisfactorily and coupled with the better demand for the metal, there was some suggestion in the copper trade of an early advance in prices from the current level of 7 cents a pound to about 8.

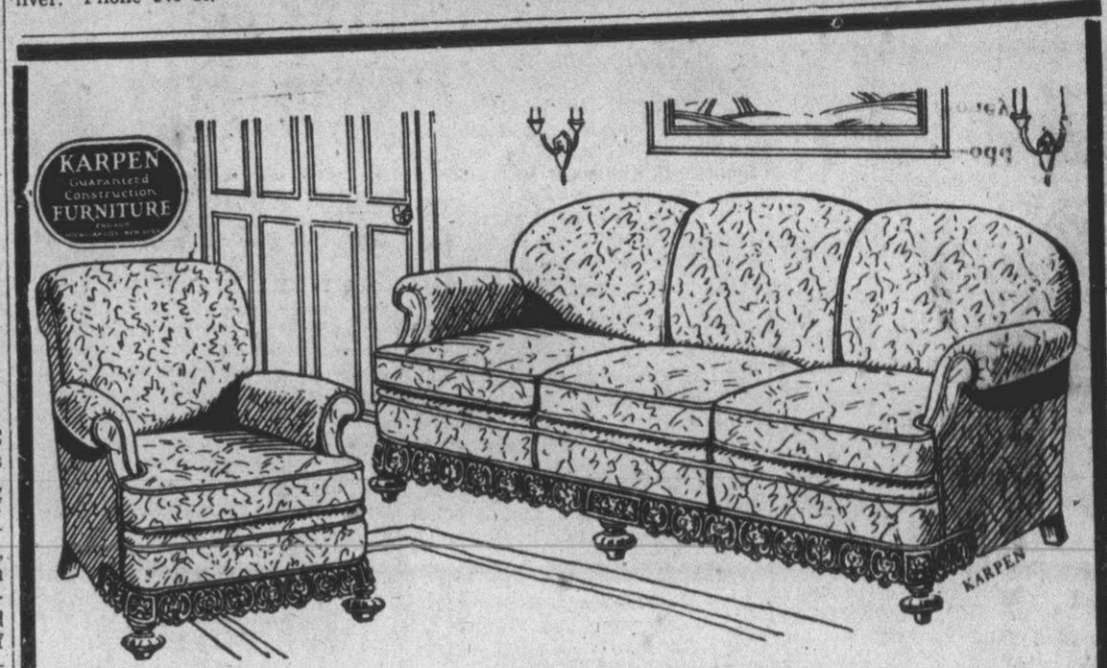
