HOOVER PLANS NEW ATTACK ON NAVAL CRITICS

President Will Try to Show True Purpose of Falsehoods and Their Origin

Washington, Oct. 30.—(AP)—President Hoover was described at the White House today as shaping a fresh attack upon the criticism of his policies by the Navy League designed "to show the true purpose of these falsehoods and the people who are interested in propagandizing them."

This statement supplemented a spectacular announcement by President Hoover last night that he would appoint a committee to investigate "untruths and distortions of fact" concerning his naval policy, which he said had been disseminated by William H. Gardner, president of the league.

The president then served notice he would expect a public apology and a correction of Gardner's misstatements.

The Navy League president, earlier, had accused the Chief Executive of an "abysmal ignorance" of naval needs and an effort to "starve" the navy.

Washington, Oct. 30.—(AP)—Fighting temper aroused, President Hoover intends to appoint the public as referee for an open bout with a navy league critic of his plans to shrink the naval budget.

With spectacular suddenness the president last night issued a formal defy, declaring the claims of William H. Gardner, president of the Navy League, to be "untruths and distortions of fact."

Even as Mr. Hoover was answering this attack, his administration's affirmative reply to a League of Nations proposal for a one year navy building truce participated in by 52 nations was en route to Geneva.

The president's statement said he would appoint a committee, upon which would be members of the Navy League, to make an inquiry into the merits of the attack upon him and his policies.

"Upon its completion," he said, "I shall expect Mr. Gardner to make a public correction of his misstatements and an apology therefore."

Apparently unperturbed by the turn of events, however, Gardner showed no inclination to apologize. He was "surprised," he said, that Mr. Hoover would appoint a commission of his own rather than sponsor a congressional investigation.

"Of course I should welcome the congressional investigation that would bring out and publish all the pertinent facts," he added.

The severity and suddenness of the president's move recalled his almost similar action of two years ago. Then, without warning, he struck at William B. Shearer, who claimed he had helped wreck the unsuccessful Geneva arms conference of 1927.

He called Shearer a "propagandist" who had "organized zealous support for increased armament" and criticized "all efforts of our government to secure international agreements for the reduction of naval arms."

Shearer came before a Senate committee. The president let it be known some weeks ago he would go directly to the American people, if necessary, to combat efforts to arouse public opinion in favor of increased naval expenditure.

He was represented then as indignant at supposed efforts of navy department personnel to block budgetary decreases he was advocating. Since that time the navy has submitted new 1933 budget estimates slicing approximately \$61,000,000 from its previous \$401,000,000 figures.

"It is desirable," Mr. Hoover's statement said, "for the public to know the character of this indirect campaign of misinformation to defeat the efforts of the high officials of the Navy Department and the administration or reduction of Federal expenditure not immediately essential in order that we may avoid increased taxation of the people of these times."

At that time plans will be laid for a great celebration in 1932 to commemorate the 350th anniversary of the settlement of the first English colony in the new world. The governments of the United States and Great Britain are to be asked to co-operate.

BIG TOBACCO HOUSE BURNED

Arch Stallings Arrested on Charge of Arson Following Blaze at Lumberton

Lumberton, Oct. 30.—(AP)—Arch Stallings was arrested and charged with arson today shortly after fire destroyed Lumberton's largest tobacco warehouse along with \$20,000 worth of tobacco, a residence and small garage and damaged another residence. The total damage was estimated at about \$65,000.

The blaze originated in the garage owned by Mrs. Minerva Inman Stallings, wife of Stallings. Officers said they were told Stallings was seen to run from the garage shortly after the flames were first seen.

Mrs. Stallings told police her husband had been drinking and yesterday quarreled with her and made threats. Firemen said that when they arrived at the scene flames were running over the ground, indicating, they said, that kerosene or some other inflammable liquid had been spilled on the ground.

Troops Called For First Time Since Aug. 1906

Greensboro, Oct. 30.—(AP)—The National Guard called out as a precaution as the trial of Asbury Respus began yesterday marked the first time troops had been called for emergency duty here since August 7, 1906.

Then the troops were called after Frank Bohannon, negro, had shot a construction foreman the day before a mob stormed the Salisbury jail and hanged three negro prisoners.

Bohannon was hanged February 8, 1907. In that day condemned prisoners were forced to ride on the gallows, sitting astride a coffin was carried in a wagon.

Older residents here recall the time when three men rode through the city in such fashion to East Market street where the hanging took place.

Fess Continues As G. O. P. Head

Washington, Oct. 30.—(AP)—Until the Republican party names its next presidential candidate, Senator Fess of Ohio expects to continue as chairman of its National committee.

Despite a previous expressed desire to be relieved before Congress convenes, he has informed party leaders he will continue until after the convention next June.

"Of course, with the selection of candidates," he said, "a manager for the campaign must take over the work."

This ending the quest of party leaders for his successor, the former college professor turned politician plunged back into the heavy duties of the committee.

LIQUOR STILL IS CAPTURED

Distiller and Considerable Amount Whiskey and Beer Taken By Federal Officers

Continuing their operations in Pitt county, Federal officers this morning captured a distiller, a still, a considerable amount of whiskey and beer in a raid five miles south-west of Greenville.

The manufacturer, D. J. Lockamy, was brought to Greenville and given preliminary hearing before U. S. Commissioner T. E. Beaman, and bound over to the next session of Federal court under \$500 bond.

He was ordered sent to jail in default of bond.

In addition to the steam distilling plant, the raid netted five and one half gallons of liquor and three hundred gallons of beer.

The plant was in operation, and so quickly was the raid prosecuted that the distiller made no effort to escape.

The round-up was conducted by the "wrecking crew" from Kinston, consisting of J. W. Thompson, J. D. Moseley and B. A. Dall, assisted by L. B. Tucker of the local police department.

New Book Tells of Hoover View On World War

New York, Oct. 30.—(AP)—Colonel Frederick Palmer's book, "New-ten D. Baker—America at War," which is published today, portrays Herbert Hoover in 1917 as opposing a separate American army in France. Mr. Hoover's idea, according to Palmer, was to use American troops as "manpower" within the ranks of the allies.

Colonel Palmer writes that Mr. Hoover's army organization views were made in a letter written Feb. 13, 1917 to Colonel E. M. House, President Wilson's confidential advisor. In the letter Mr. Hoover suggests that "if the government gave stimuli by provision of ensigns, etc., a large body of men could be recruited and sent simply as man power to France."

Mr. Hoover believed this plan more feasible, Palmer writes, than the long training which would be necessary in the organization of American expeditionary force and in view of the fact that large American army in France would have "political difficulties in association."

Bryant Buys Aladdin Plant

Wilmington, Oct. 30.—(AP)—J. N. Bryant, lumber plant operator here, has purchased the plant, site and equipment of the Aladdin Co., for the manufacture of furniture parts in cooperation with High Point firms.

TWO ENTOMBED MINERS ALIVE

Four Others Buried By Blast in Pennsylvania Last Saturday, Found Dead

Moranau, Pa., Oct. 30.—(AP)—Rescue workers shortly after six o'clock this morning brought out alive two of the six miners entombed last Saturday by an explosion at the local mine of the West End Coal Company. The others were dead.

Those rescued are John Tomashunis, 40, father of seven children, and Joseph Matzoni, 22. Mine officials said both were in excellent condition considering they had been buried alive for five and a half days. Both will survive the ordeal, physicians said.

The dead: John Molitoris, 35, father of three children; Jacob Timus, 45, father of four; Henry Geglarski, 23, single, and Paul Navak, 40, whose wife is in Europe. A crowd of about 200 was waiting at the mouth of the mine as Tomashunis and Matzoni were brought out and placed in an ambulance. Among the crowd was his (Continued on Page Six)

MARKET HERE LEADS BELT

Total Sales on Greenville Market Had Reached 36,318,932 Yesterday.

Tobacco sales continue to mount rapidly in Greenville, and the market was still leading all other markets of the belt by a comfortable margin, it was disclosed in the weekly report of K. W. Cobb, supervisor of sales.

Season sales were given as 36,318,932 for \$3,591,622 at a general average of \$9.88 per hundred pounds. For the week which closed yesterday, the market had disposed of 4,843,036 pounds for \$591,646.41 at a general average of \$12.21 per hundred pounds.

Sales yesterday were given as 614,188 pounds for \$70,741.77 at a general average of \$11.52 per hundred pounds. The market set a new price record for the season last Monday on the third largest sale of the year. With approximately 2,500,000 pounds (Continued on Page Four)

Man Killed In Fierce Encounter With Lion

Nairobi, Kenya, East Africa, Oct. 30.—(AP)—Details of a hand-to-hand encounter with a wounded lion near Tanganyika, in which W. H. Herren, American hunter, received fatal wounds, were revealed today.

A native gunbearer seized the wounded lion by the tail and pulled it away from Herren, a contractor of Aberdeen, Wash., it was learned, but his heroism went for naught because the victim died several days later while being taken to a hospital.

Herren, his wife and two other Americans were on a big game hunt in Tanganyika principally for purposes of photography when the tragedy occurred. Herren with Gus Peret of Portland, Oregon, separated from the other members of the party early last week and went to take pictures with only native gunbearers.

Subsequently Herren shot and believed he had killed a large male lion. Peret started filming the scene as Herren approached the beast when the latter suddenly shouted "Gus, he's got me!" The supposedly dead animal had suddenly leaped upon the hunter.

Herren fired but he was too late and man and beast soon were struggling on the ground with Herren's two hands in the lion's mouth, frantically trying to stave off a fatal thrust. His companion was (Continued on Page Six)

MUCH TIMBER IS DESTROYED

Flames Undiminished Today After Burning Over Hundred Square Miles; Considerable Damage Reported by Fires Burning Over Wide Areas in Georgia, Florida and California

Kinston Oct. 30.—(AP)—The big pocomin blaze throughout Catfish and Great Lakes ate its way on toward Bogue Sound today, undiminished by scattered rains over Eastern Carolina during the past 24 hours.

The fire has burned over a hundred square miles of grass, brush and timberlands. Several tracts of valuable pine and cypress timber were burning today.

Officials in Craven, Onslow, Jones and Cartaret, the counties affected, said there was slight chance the fire would be extinguished before coming to the sound unless heavy rains fell.

The section is virtually uninhabited and the fire has done little damage except to the tracts of merchantable timber.

Raleigh, Oct. 30.—(AP)—F. H. Clridge, assistant state forester, was sent to Duplin county today by the State Dept. of Conservation and Development to survey forest fire conditions.

Gov. Gardner was appealed to this morning to send a man into the territory to see what could be done as fires continued to burn.

At the governor's request, Col. J. W. Harrelson, director of the Conservation Department, ordered M. Clridge to survey the situation and report back here what steps should be taken.

Los Angeles, Oct. 30.—(AP)—High temperatures throughout Southern California, coupled with low humidity, has created an "exceedingly dangerous" fire situation in the forest and brush areas of this section, forestry officials said today.

Los Angeles yesterday experienced the hottest October 20 in the 54 years the weather bureau has kept records. The mercury mounted to 94. Pasadena reported 95 degrees and Santa Ana 105 degrees.

Grand Jury To Report Findings In Court Probe

Asheville, Oct. 30.—(AP)—The Buncombe county grand jury today was to begin preparation of a report of its findings in its investigation of court corruption allegations.

The report, based on evidence submitted to Judge A. M. Stack of Monroe, who ordered the inquiry after Wickes Wamboldt, Asheville city councilman, had charged that "judges and juries are bought and sold like sacks of corn."

The grand jury has heard, for the most part, of alleged criminal offenses by public officials and these connected with the now defunct Central Bank and Trust Company for which previous grand juries refused to indict.

Charges of jury tampering in recent trials growing out of the bank failure were also brought. The investigation was conducted behind closed doors.

**SLAYER OF SIX
TO DIE IN CHAIR**

Will Moore, Negro,
Sentenced to Death
After Conviction of
Killing Little Girl

Greensboro, Oct. 20.—(AP)—Will Moore, 36, negro who was reported to have confessed carrying death to seven people, today faced a similar fate as the result of his conviction here last night of first degree murder in connection with the death of little Vera Leonard.

Judge Thomas Shaw sentenced the negro to die January 8 in the electric chair.

Witnesses in the trial, which consumed all of yesterday, testified Moore had confessed seizing the child while her parents were away from home, dragging her to a clump of woods and attempting to assault her. When she screamed, he was quoted as saying, he struck her with a stick of wood, wrapped her unconscious form in bed clothes and burned the Leonard home down around her.

Officers said that Moore, during a recess of court yesterday before the verdict, told them he was responsible for the death of Mrs. Jim Glibreath in her burning home several years ago and for the beating to death and hanging and Mrs. Bobbie Stephenson seven years ago. They also quoted him as saying he slew four people in Northampton county several years ago.

AIR LIFE OF
PRES. HARDING

Woman Writer Says
Former President
Father of Her
Daughter

Toledo, O., Oct. 30.—(AP)—The trial of the \$50,000 libel suit of Nan Britton, author of "The President's Daughter," against C. A. Klunk, Marion, Ohio, hotel keeper, continued here today with the jury listening to the reading of Miss Britton's book "The President's Daughter" in which it is alleged that President Warren G. Harding was the father of Miss Britton's daughter Elizabeth Ann.

Reading by defense counsel from Miss Britton's book disclosed her assertion that letters received by her from President Harding, while he was United States Senator, were from one to sixty pages long. The Senator had suggested, the book states, that all communications interchanged between them be destroyed.

Concern for her child, Elizabeth Ann, because the ruling element in the mother after the death of President Harding while she was on an European trip from which she hurried home upon learning of his death, the book says. This is put forth by the author as the reason for her marriage six months later to a Captain Nelson, an ocean navigator, after he had agreed to set \$5,000 aside in a trust fund for the daughter.

The book discussed, as read in court, the author's reluctance at first in telling the captain that she had a daughter and who was the father. The promised sum never was paid, the author says, and her divorce from the vessel master followed in a short time.

In the "Answer to the President's Daughter" written by Joseph DeBarthe, Marion, Ohio, now deceased, as a defense of President Harding, and the offending book in the present case growing out of its alleged libelous contents, the assertion of Nan Britton that she had clandestine meetings with President Harding in the White House was discredited on the ground of impossibility. Counsel read portions from the book on this point as follows:

"Let us look for a moment at this historic place—the White House in which the president's wife is supposed to have led a lonesome life in the executive mansion while the complaining witness found it so remarkably easy to gain admission at will, day or night, and without the knowledge of the wife."

"It is impossible for any one to enter the White House except under rigid surveillance. If you doubt it, try it. The prisoner of Chillon enjoyed a privacy denied the Chief Executive of this nation."

All persons under 21 years old were barred from court by Judge John M. Killits who is presiding at the trial.

Judge Killits explained that he might exclude all visitors from the court room, adding that the time may come when it would be necessary to exclude even the press.

"This order is fundamental. It is a part necessary for the decent administration of this court."

ABOUT TOWN

Governor Gardner has called a conference of governors of four states to discuss the cotton and tobacco situation with a view of bringing about an improvement in the situation confronting the two crops as result of glutted markets. Although no definite date was set for the meeting, it will be held on some convenient date. The governors of Georgia, South Carolina and Virginia were invited because they represent the principal tobacco growing states of the union. Although the object of the meeting is to discuss both crops, it is evident from advance information sent out by the governor that he is more directly concerned with the tobacco crop. It is impossible to foresee what effect the conference will have on the economic situation, but as tobacco is the principal crop produced in all four states it is certain some definite action will be taken to bring about relief. Governor Gardner has refused to call a special session of the General Assembly to provide for acreage reduction, probably having in mind some plan which he deems more effective and far-reaching. However, the public will watch the conference with undisguised interest and everybody, especially that great army of people affected by the tobacco market, will hope to see good results eventuate. The tubercular clinic conducted in this county had a tendency to awaken the people to the importance of combating the disease in early stages. Dr. Thornton, representing the extension department of State Sanatorium, addressed several organizations of the county, and in each instance stressed the fact that is being carried on in all parts of the nation to reduce the annual toll of tuberculosis. Over 500 people were examined during the campaign in this county, and it is needless to say that good results will be obtained. Of that number over 400 were school children, and the 55 that reacted positively to the tests were advised what to do to protect themselves. Taken while in the incipient stage, tuberculosis may be completely eliminated, but permitted to continue until deeply rooted it proves one of the greatest destroyers of life. The annual toll taken by this disease has been reduced in practically every state, and with campaigns such as that just completed in this county it is easily believable it will be reduced still more in the years to come. Health workers were gratified at the splendid spirit of co-operation shown by the people of the county and expressed belief this would be a contributing factor toward more extensive and concerted fights against the disease in future years. Dr. G. W. Gasque, one of the leading Episcopal ministers of Atlanta, Ga., will begin a series of evangelistic services at St. Paul's Episcopal Church Sunday morning and the public is given a cordial invitation to attend. The singing will be in charge of Charlie Tillman, well known gospel singer, who will provide an inspirational song program for each service. The congregation of St. Paul's Church has been making extensive preparations for the coming of Dr. Gasque, and the rector, Rev. W. A. Lillyer, expressed hope the services would prove an uplift to the entire city.

CONCLUDES LECTURES AT METHODIST CHURCH

\$20,000 worth of tobacco, a residence and a small garage and damaged another residence here early today. Total damage was estimated at about \$65,000. The warehouse was operated by J. E. Davis of Martinsville, Va.; and his son, F. B. Davis of Winston-Salem. The fire started in a small garage and spread to the big Banner warehouse before firemen could bring it under control. The garage was owned by Mrs. Arch Sterling, whose two-story residence was also destroyed. Stored in the warehouse was between \$15,000 and \$20,000 worth of tobacco in hogheads belonging to the Lumberton tobacco redrying plant. As the heat grew these hogheads exploded, blowing one side of the warehouse across the street. Another residence was damaged before the fire was brought under control about 3 a. m. The warehouse was erected at a cost of \$40,000 several years ago and had been added to last year. It and the tobacco were protected by insurance. Firemen estimated the damage

New York, Oct. 30.—(AP)—Agitation to abolish the kickoff as a result of the death of Dick Sheridan in the Yale-Army game has met with a somewhat chilly reception from the football rules committee.

Six members of the committee of nine, when asked for comment by the Associated Press, indicated they favored retention of the kickoff. Two others declined to comment and the ninth could not be reached for a statement.

H. J. Stegeman of the University of Georgia expressed the views of most of the rules committee members when he called the kickoff one of the most spectacular in the game and declared it resulted in no more injuries than other formations.

Opponents of the kickoff have taken the position that its danger lies in the fact that it permits formation of the prohibition "ying wedge."

Ray Morrison of Southern Methodist wants the kickoff to remain just as it is but he favors the "complete elimination of the flying wedge which is considered the most dangerous formation in football."

M. J. Ahearn of Kansas State, W. O. Hunter of Southern California, W. G. Crowell of Swarthmore, and Amos Alonzo Stagg of Chicago all indicated they favored retention of the kickoff.

This was prompted by reports of firm spot basis in the southern markets and carried the active months about 6 to 7 points net higher with December selling up to 6.67 and March to 6.86 by the end of the first half hour.

STOCK MARKET

New York, Oct. 30. (AP)—The securities markets displayed a firm undertone today, but shares were unable to sustain a morning rally. Wall Street regarded the drop of \$24,000,000 in the volume of currency in circulation as the most encouraging news in weeks, providing tangible evidence of a return of confidence in banks. A better demand for bank investments was apparent in the bond market.

The stock market pushed up about 1 to 4 points during the morning, but its advance was virtually cancelled after midday. Pivotal shares generally stiffened around last night's final levels, however. Electric power and light turned weak, losing 3 points. Heaviness of this issue appeared to discourage buying. Some other utilities became heavy, North American and National Power and Light losing about a point. Union Pacific sold up 4 points, then lost its rise.

(Continued from page one) life, 35, was taken to the mine offices where officials assured her that her husband was in good condition.

"When I got the message that he was all right I felt just as if he had come from the dead," she said. From rescue workers it was learned that two of the dead men had been killed instantly by the force of the explosion and that the other two had been victims of after-damp. Navak, a brakeman, had gone out of the entry to get a car just as the explosion ripped through that shaft. He and Timus, a laborer who was working nearby, were instantly killed. Molitoris and Geglarski were uninjured by the blast, but they ventured out too soon afterward and fell victims to after damp.

BUSINESS AND INDUSTRY IMPROVING IN SOUTHLAND

(Continued from page one) N. C. new marble quarries are being opened. At Wilmington, N. C., in the eastern part of the state, mill activity is being increased and a new boat line for that seaport is being formed.

Plans for a \$50,000 community theater in Charlotte have been announced while at Durham, N. C., work is still going forward on the Duke University building program. An addition is being made to Oteen Hospital near Asheville.

Road building in South Carolina, where the state is spending millions on hard-surfaced highways, is giving employment to citizens in almost every section of the state.

Work on a new government veterans hospital to cost more than a million dollars will begin shortly near Columbia. At Laurens, S. C., a new silk mill is to be constructed soon that will give employment to 140 additional men.

In the lower part of South Carolina, work on hunting preserves and estates at this time of the year gives seasonal employment to many families.

In Georgia, the Clark Thread Company has completed a new plant and a mill village of 75 houses at Austell, near Atlanta, and expects to employ some 600 men and women when installation of machinery is completed.

Two hundred new workers have been employed in Virginia, beginning October 28, by the R. J. Reynolds Tobacco Company at Richmond, and report of Richmond customs receipts show an increase.

David Clark, of Charlotte, editor of the Southern Textile Bulletin reports that immense quantities of raw cotton are being bought and stored by the larger cotton manufacturing corporations of the Carolinas and the south, "in anticipation of sharp advances in prices within a year or two."

Tennessee, Alabama, Florida and other southern states report business activity and a healthy outlook.

At New Orleans, La., 178 new business concerns have opened and 193 old ones have expanded operations since the first of the year, and customs collections for September totaled \$1,903,231.32, a gain of 30 per cent over last year.

Louisiana records also disclose New Orleans customs collections for July, August and September combined show an increase of 93 per cent over the same period in 1930.

Richmond, Va., reports an increase of merchants' license taxes, based on purchases and volume of trade, over last year, and DuPont rayon mills at Richmond and Waynesboro are operating at full time.

The Newport News Shipbuilding and Dry Dock Company has launched a number of liners this year, including the President Coolidge and President Hoover, built for the Dollar Lines at a cost of \$8,000,000 each.

The Graddock Perry Soap Company of Lynchburg, has announced that all workers will be on full time effective Dec. 1.

In the Memphis, Tenn., territory cotton seed mills are operating day and night, and production of kilowatt hours of electric power for September was 500,000 ahead of the corresponding month in 1930.

Steel plants in the Memphis area report nearly normal distribution, and expenditure of some \$11,000,000 on Federal flood control work between Oct. 1 and June 1 next year, is scheduled.

The Standard Appalachian and Cherokee Spinning Company knitting mills in Knoxville, Tenn., have been operating at full capacity for the past few months, employing 2,600 persons.

The Austin Tobacco Company, a Knoxville concern, is considering a redrying plant and plans to employ 200 men by December 1, while construction of a \$1,000,000 city-county bridge across the Tennessee river is giving employment to 200.

In East Tennessee the new \$3-

000,000 alloy mill of the Aluminum Company of America, at Alcoa, has resumed operation, and the Borden Mills, at Kingsport, have added a night shift of 500 men. The large rayon mills at Elizabethton are operating at almost full capacity.

Employees of the Eureka Mills, manufacturers of knitted underwear, and the Englewood Manufacturing Company, hosiery manufacturers at Englewood, Tenn., who were laid off earlier in the year have been recalled. About 300 are employed.

Florida is preparing for the citrus harvest and packing plants are taking on additional help, while hotel operators report that several hundred persons will be given work during the winter season.

RUSSIA FLATLY DENIES ASSISTING THE CHINESE

(Continued from page one) based, the ambassador explained, upon statements of General Ma of the Chinese forces at Tsitsihar. General Ma was quoted by the ambassador as having said an agreement exists under which he receives military airplanes, anti-aircraft guns and aviators from the Soviet Union and that there are Soviet instructors in his army.

L. M. Kakakhan, acting foreign commissar for foreign affairs, replied that the Japanese statements were based on unfounded inventions and on rumors emanating from "irresponsible persons who apparently are interested in spreading provocative propaganda about the situation in Manchuria."

There are no Soviet instructors at Tsitsihar or in any Manchurian Province, he said, and arms or ammunition are being sent from Russia. The Soviet Union adheres to its policy of non-interference, he said, not because such a policy pleases or displeases any one, but because the government respects international treaties signed with China.

(Continued from page one) here belittles forecasts that the party will not organize the next House and elect its speaker, a new thought has been advanced into the discussion by Representative Treadway, a Massachusetts Republican.

From his home in Pittsfield, he proposed that William Tyler Page of Maryland, clerk of the House, be elected temporary speaker if a dead lock should ensue.

Pointing out that the debt moratorium must be acted upon before Dec. 15, Treadway urged that, if necessary committees be named only as needed to carry out President Hoover's recommendations.

Membership of these committees would be divided equally between

parties. Selection of the speaker could then await solution of pressing problems.

Meanwhile, Representative Wood of Indiana, was greeting with a gruff "bosh" the forecast of Senator Moses of New Hampshire, that the Democrats would organize the next House.

He expects the Republicans to fill four vacancies with party candidates before Congress convenes, which would give them a lead of one over the Democrats.

Two other Republicans—Representatives Britten of Illinois, and Hess of Ohio—yesterday voiced belief their party would control the House.

But from Representative Eandlin a Louisiana Democrat, came the expression that Senators Moses and Watson of Indiana, are "trying to force organization on the Democrats."

"The Republicans have gotten the country in a mess and now want the Democrats to take the responsibility of getting it out," he said.

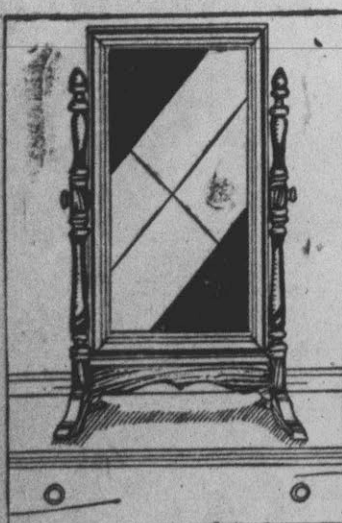
