AROUND THE WORLD AVIATORS LAND IN GERMANY

Garner To Fight Hoover To The Bitter End Over Relief For Unemployed

TELLS HOUSE OF HIS VIEWS

Taking Floor in Surprise Move After the Conference Between Congressional Leaders and President, Texan Shouted That the Chief Executive Wants 'Selected Clientele' to Reap Benefits of Reconstruction Body.

Washington, July 6.—(AP)—In a dramatic address to the House, Speaker Garner told his colleagues today that he would fight to the end against President Hoover's views on relief legislation.

Taking the floor in a surprise move after conferences between congressional leaders and Mr. Hoover had ended in a deadlock, the speaker shouted that the chief executive wanted a "selected clientele" to reap the benefits of the Reconstruction Corporation.

"We propose to say to the president that there shall be no more class legislation," Garner roared as the packed galleries and the silent members listened attentively.

"I can say now and I have the president's authority for it, that this country is in worse shape now than it has been in its history," Garner continued.

"For when I asked the president of 300,000,000 might lead to a panic, he replied that the appropriation of his policy has been so uncertain that if he looks for a panic around the corner, maybe we can look for good times."

Court Clerks are At Wrightsville

Wrightsville Beach, July 6.—(AP)—Superior court clerks of North Carolina will convene their 15th annual convention here tonight and remain in session three days.

C. L. Richardson, of Union county, president of the association, will preside.

Thursday round table discussions, miscellaneous problems and special talks will be the order of the day with a round of recreation coming in the late afternoon and a banquet of that night.

Reports will be heard Friday and after election of officers and selection of the 1933 convention city, the association will adjourn.

Tuesday Second Hottest Day Of Summer Here

Yesterday was the second hottest day of the year for Greenville and Pitt county, according to the records of B. T. Clark, local government weather observer.

The mercury hung around 96 degrees during the mid-afternoon and lack of breeze intensified the humidity. Cooling breezes came to the relief of the sweltering city last night about 9 o'clock and continued today with prospects of rain.

Mr. Clark said that while yesterday felt like the hottest day of the summer, it was behind one day last week when 97 degrees was registered.

Temperatures of over a hundred degrees were registered here several times last summer, but there is such a slight difference between 96 and 100 lots of people thought a new heat record had been established yesterday.

MURRAY LOSES IN OKLAHOMA

Most of Candidates Supported by "Alfalfa Bill" Beaten in Primary Election.

Oklahoma City, July 6.—(AP)—Incomplete returns today from Oklahoma's initial primary election showed leads in most major races for candidates who made their campaigns without benefit of Gov. William H. Murray's stamp of approval.

Nearly 9,000 candidates were in the field for offices ranging from township posts to U. S. Senate. Leading a group of candidates opposed by the chief executive, Mrs. Mabel Bassett, state commissioner of charities, held a lead.

AKRON JOINS BOAT SEARCH

Giant Dirigible to Attempt Locate Craft Missing in Ocean Race to Bermuda.

New York, July 6.—(AP)—The naval airship Akron had joined coast guard boats in search of the Ketch Curlew, long overdue in the ocean race from Montauk Point to Bermuda.

On government orders, the Akron took to the air last night and will cover most of the territory between here and Bermuda. She will remain aloft three days if necessary. Her course is being directed by coast guard vessels already engaged in the search.

The Curlew, sailing out of Throggs Neck, N. Y., started the race to Bermuda from Montauk Point, Long Island, a week ago Saturday along with 26 rivals. All the others reached Bermuda last week, some of them as early as Tuesday. An unofficial entrant in the race, the Bermuda Fisherman, Spanish Rose, reached Bermuda yesterday morning after being blown off her course and becalmed. Some sailors thought the Curlew might have gone through the same experience.

However there was some concern over the New York boat's failure to arrive because her crew was inexperienced in ocean yachting. She was commanded by Nat Lyon and manned by A. S. Rosenbergs, navigator, Benjamin Theeman, Frank Riger, Larry Weiss and Carl Parness. All are from New York.

SOLVE WAR GUILT PHASE AT LAUSANNE

Legal Experts Reach Compromise Agreement on Reparations with Germany.

Lausanne, Switzerland, July 6.—(AP)—It was reliably reported this evening that legal experts had solved the "war unit" controversy raised by Germany at the reparations conference by inserting a single phrase in the compromise agreement in which it is hoped to bring the conference to a close.

The phrase reads: "The Treaty of Versailles, insofar as it concerns reparations, is hereby abrogated."

The draft treaty was the subject of a conference this evening between Prime Minister MacDonald (Continued on page three)

SEEK SOVIET RECOGNITION

New York Industrialist Starts Movement to Establish Relations with U. S.

Moscow, July 6.—(AP)—An unofficial move to reopen the question of formal recognition by the United States of the Soviet government was under way here today and there was reason to believe it was being met with favor by the Soviet officials.

The move was made by Colonel Frederick Pope, New York industrialist, acting alone and in a private capacity. Colonel Pope presented to Soviet officials a suggestion that the United States send an unofficial commissioner to Russia as a preliminary to negotiations for the establishment of normal relations between the two countries.

He laid the matter before a special meeting of men high in the Soviet officialdom.

TYSON GREET'S JOHN GARNER

Greenville Lawyer the First to Congratulate Texan Upon His Nomination.

William S. Tyson, Greenville lawyer, who several months ago was appointed clerk of accounts of the U. S. House of Representatives, had the unique distinction of being the first person to congratulate Speaker of the House John Garner of Texas following his nomination for the vice-presidency by the Democratic national convention at Chicago last week.

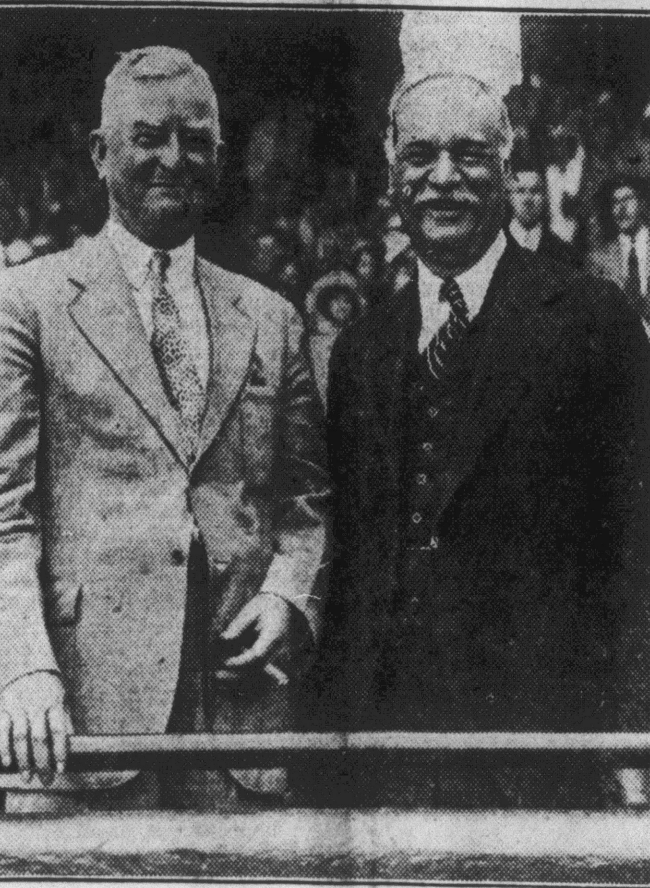
A letter received from Mr. Tyson here today graphically portrayed the receipt of the news over the radio at Washington and the reaction of the Texan to the high honor conferred upon him.

Mr. and Mrs. Garner and Congressman Walter Lambeth had gathered with Mr. Tyson at the office of Congressman Lindsay Warren to receive reports on the convention. As word of the nomination was flashed over the country, the Greenville man walked over to the Texan, shook his hand and told him how glad he was that he had been recognized by the party in such a splendid manner.

There were about a hundred newspaper men and movie-tongues waiting for the Speaker of the House, the latter said, but nobody knew where he was and he said he did not want to see them until Sunday. The scribes went about the capitol looking for the Texan but did not find him until Governor Roosevelt had almost finished his speech at Chicago.

Commenting on Mr. Garner, Mr. Tyson said, "He is certainly a fine man and one that would especially appeal to the people of Pitt county. He reminds me very much of several persons there. He is very outspoken and frank and has an (Continued on page six)

Final Rites for Prominent Business Man Conducted Yesterday Afternoon.

Funeral services for John L. Wooten, 63, prominent Greenville business man, who was found dead at his home early Monday morning, were held from his late home on Greene Street yesterday afternoon at 4 o'clock. The final rites were conducted by Rev. E. L. Hillman, pastor of Jarvis Memorial Methodist Church, assisted by Rev. J. C. Wooten, of Fayetteville, presiding elder of the Fayetteville district of the Methodist Church. Burial was made in Greenwood cemetery.

The funeral was largely attended and an extensive floral tribute bore mute evidence of the high esteem in which the deceased was held here and in other parts of the state.

A vested choir composed of voices from the various churches of the city rendered "Rock of Ages," and "My Faith Looks Up to Thee" during the service at the house and "Abide With Me" at the graveside.

Mr. Wooten, native of Lenoir county, came to Greenville when a young man and engaged in the drug business. After twenty-seven years in this field, he served as county auditor and then retired and gave his attention to the operation of city and farm property.

Washington, July 6.—(AP)—The political talk went on across the land today, stimulated by charges from administration Republicans in Washington that Gov. Franklin D. Roosevelt had surrendered to Tammany Hall and that his reforestation program is "utterly visionary and chimerical."

But one of his most ardent supporters, William G. McAdoo, in a New York speech summarized: "All this talk of deals and trades is simply and only echoes of a sharp contest and the disappointments that always follow such a battle."

He praised the Roosevelt acceptance speech as "masterful" predicting that enough voters would be "so that (he) is enabled to make it effective."

MATTERN AND GRIFFIN BRING PLANE DOWN AT AIRDROME IN BERLIN

Heir To R. J. Reynolds Millions Kills Himself

Winston-Salem, July 6.—(AP)—Smith Reynolds, youthful heir to a tobacco fortune, shot and fatally wounded himself early today on a sleeping porch adjoining the bedroom of his wife, the former Libby Holman, Broadway "torch singer," in his home here.

Whether the 29-year-old youth, who took Miss Holman as his second wife a few months ago, intended to kill himself or accidentally fired the fatal shot was in doubt.

Dr. W. N. Dalton, the county coroner, after an exhaustive investigation said he was convinced the death was a suicide or was accidental, but that it might be several days before he would be ready to render a verdict deciding between the two possibilities.

He said he learned no motive for a suicide in his investigation. He and Mrs. Reynolds entertained at an informal dinner party (Continued on page six)

MAKE TRIP IN 18 HOURS

Red, White and Blue Plane First Flown by Americans to Reach Berlin on Non-Stop Flight from Western Hemisphere; Stars and Stripes Raised Over Airdrome in Their Honor.

Berlin, July 6.—(AP)—The American round-the-world flying team, Bennett Griffin and James Matern, set their red, white and blue monoplane down in Berlin at 5:40 p. m. (11:40 a. m. EST) today, and thereby set two new marks for other aviators to shoot at.

They brought their "Century of Progress" across the Atlantic in the amazingly fast time of 18 hours and 41 minutes, and became the first American trans-Atlantic fliers to reach this capital non-stop.

Their fast crossing from Harbor Grace put them two hours and 55 minutes ahead of Post and Getty, the round-the-world record holders at the Berlin stage of the journey, on the basis of elapsed time.

Berlin, July 6.—(AP)—James Matern and Bennett Griffin, American round the world fliers, landed at Tempelhof airdrome at 5:40 p. m. (11:40 EST) today.

They brought their red, white and blue ship down on the field a little more than 18 hours after leaving Harbor Grace, Newfoundland.

More than two hours before they landed they had been sighted over Hanover. Usually the flight from that city is a matter of less than an hour and when they did not appear at Tempelhof within that time, those who awaited them at the field, including United States Ambassador Sackett, began to worry.

It developed, however, that there was some bad weather between here and Hanover, and the globe-girdlers had been obliged to go out of their way.

The Matern-Griffin ship was the first flown by Americans to reach Berlin on a non-stop flight from the western hemisphere, and officials at Tempelhof airdrome took note of the extraordinary occasion by raising the stars and stripes as the "Century of Progress" taxied across the field.

A band played the Star Spangled Banner.

Dallas Allen Hurt in Plane Crash, Virginia

Negro Outlaw in Toils of the Law

Lumberton, July 6.—(AP)—Harvey Wallace, one of three negroes outlawed after the slaying of N. T. Perry and Thomas Beal in a "guncock holdup" June 18, has been arrested here by local officers.

Beal was slain when he entered Perry's store while the negroes were staging the hold-up, and Perry was fatally wounded during the distraction when he sought to make his escape.

Charlie Myers, another negro, was arrested two days later, and officers are still searching for Elvin Morgan.

SNIPER KILLS POLICEMAN

Shot in Arm, Man At Washington gives up After Holding Cops at Bay 3 Hours.

Washington, July 6.—(AP)—A sniper whose rifle and pistols killed one policeman, wounded another and kept at least a hundred more, at bay for three hours finally was shot in the arm early today, surrendered and said simply that he had tried "to start some fireworks."

In his house on First Street, Southeast, just five blocks from the capitol, he ejected a son at pistol point, locked the doors and fought off death and capture despite riot (Continued on Page Six)

DOZEN CASES IN COURT HERE

Bus Driver Pleads Guilty to Charge Of Driving Under Age in County Court.

W. S. Babcock, of Tarboro, driver of the Tarboro-Greenville bus, was permitted to drive his bus back to Tarboro yesterday after pleading guilty to a charge of driving under age. He was ordered to appear before the court again July 12.

The young man was taken in custody by city officers early yesterday morning, given preliminary hearing in a magistrate's court and bound over to County Court.

He admitted that he was just slightly over twenty years of age when arraigned for hearing in County court.

Several other cases were disposed of during the session. They consisted of charges of larceny, assault with deadly weapon and violation of prohibition and traffic laws.

The North Carolinians opposed the repeal plank in the platform but now that it is in and they have no way of stopping it they are going to stand behind the platform in its entirety.

The convention was marked by harmony with exception of boos from the galleries and party leaders have returned home to do their best to out the Republicans in the next election.

Automobile accidents took a heavy toll of life in this country during the celebration of the Fourth of July, and this brings to our attention the transcendent importance of more fully observing highway traffic legislation.

While accidents of no serious consequence were reported from this immediate vicinity the toll was sufficiently staggering from other parts of the state and nation to cause us all to halt and consider the advisability to cut our speed and take the road more leisurely.

Human life is too precious to be risked in such a manner and those who make it a habit to drive at a terrific rate of speed under unfavorable circumstances are advised to consider the safety of the other man if not themselves.

It should be the purpose of Democrats everywhere to attempt to settle any little differences existing between them and turn their attention to the important business of defeating the Republicans in the November elections.

The fight is not among ourselves but with the party of privilege which has been unable to lift the country from the mire of depression in spite of the claims of its leaders that they would produce a period of prosperity such as the country had never before witnessed.

By coordinating their forces, the Democrats should be able to sweep the Republicans from the White House as cleanly as they themselves were swept out not so many years ago.

The time for concerted, harmonious action has come and if the people will rally to the standard and support their nominees victory is almost assured.

The Pitt County Board of Elections is to be congratulated upon the improvements made in handling the primary in Pitt county last Saturday. The addition of an extra balloting place at the courthouse greatly facilitated voters in registering their preference for the various candidates and was so far ahead of the old way of voting that it received favorable comment from hundreds of people.

Elimination of congestion and confusion has been needed here for years and especially during the first primary when it was estimated that at least four hundred people were not able to vote because they could not get to the polls.

There was no congestion in evidence last Saturday and anybody could vote in about one minute whereas it required about a half hour in the first battle of ballots.

This is a condition of interest to everybody and if continued in the November election the entire county vote should be handled much easier than heretofore.

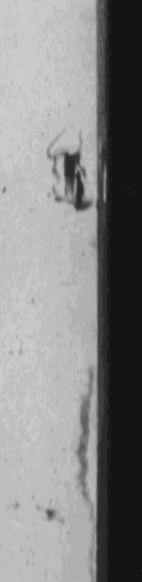

NEW TROUBLE IS BREWING IN THE PIEDMONT

Charlotte, July 6.—(AP)—With the fate of at least two member clubs hanging in the balance, Piedmont League directors gathered in Winston-Salem today to consider their situation.

With the Asheville franchise surrendered by the Louisville American Association Club, High Point was on the verge of being dropped to make an even six-club league.

President W. G. Bramham has been busy trying to interest some major league club in operating the Tourists, but early today had no success to report.

A fight which, if actually started, bids fair to spread far out of baseball circles was predicted for the directors meeting over a proposal for Sunday afternoon games. Many times fans and baseball men have argued, but always they have been met, in North Carolina, by civic interests which would not brook the pastime on the Sabbath.

But times are none too good in Piedmont circles these days and Sunday games are looked on in some quarters as a bid for increased patronage similar to that which brought night baseball.

Speaking of night baseball, Tuesday was full of it. Seven games, one of which ran 12 innings, decorated the schedule. And, incidentally, provided the club standings with some sort of division of places at which the various clubs could shoot.

Charlotte took full advantage of the situation, blanking the Asheville Tourists twice to take the top position. The scores were 5-0 and 1-0. High Point divided a double bill with Winston-Salem, winning the afternoon game 8-7 and losing the 12-inning night affair 11-10.

Greensboro won the first night game from Raleigh 3-4, but dropped the second 4-3, while Durham was losing one to Wilmington 6-0, and winning one 6-5.

The eight games left High Point, Raleigh and Durham tied a half game behind Charlotte, and Winston-Salem, Greensboro and Wilmington locked in the next bracket. Asheville held full cellar honors by right of the double loss to Charlotte after Monday's game was rained out with the score tied in the ninth.

Although there was no action in the American League, there was considerable news, and most of it exceedingly bad for the pace-setting Yankees.

Manager Joe McCarthy learned that his favorite catcher, Bill Dickey, had been set down indefinitely for his attack on Carl Reynolds of the Washington Senators the previous day, then discovered that Charley Devens is not quite ready to burn up the big time.

Devens, who stepped out of Harvard into a nice pitching contract with the Yanks last week, lasted only five innings against the Baltimore Orioles, during which he was touched for 12 hits and seven runs.

Jack Quinn of the Brooklynns, the oldest active player in either league, observed another birthday anniversary. The record book credits Quinn with 47 summers and autumns, and he still is one of the better relief pitchers.

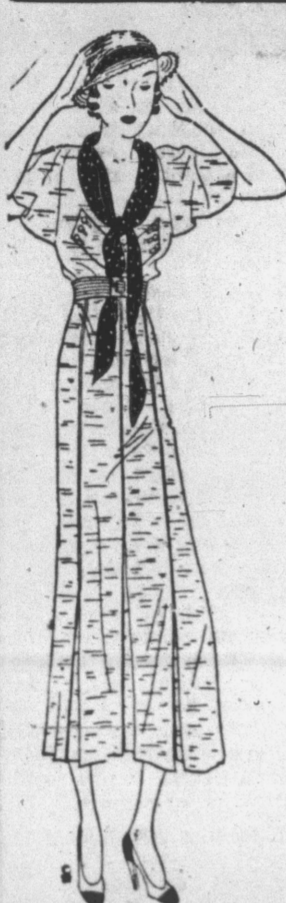

Stock Market

New York, July 6.—(AP)—Persistent strength in foreign government bonds bolstered the securities markets generally today, after shares had had a temporary slump during the morning.

German government bonds were said to have been heavily bought by London, in anticipation of an early announcement of a reparations agreement at Lausanne, although private cable advices to Wall Street from Paris were less optimistic. At any rate, the optimism in London served to prompt considerable short covering in the New York stock market.

American Telephone, after sinking nearly 2 points to a new low at 75, recovered, and by early afternoon, net gains of a point or so appeared in American Can, Allied Chemical, Case, and Standard Oil of California. Oils, which have resisted selling recently, were a conspicuously firm group, as fractional advances appeared in Standard of N. J., Texas Corp., Atlantic Refining, Royal Dutch, Pure Oil, Consolidated, Continental, and Socony-Vacuum. Some of the mining issues were again firm, and leading industrials and rails selling somewhat above yesterday's close included U. S. Steel, National Biscuit, Union Pacific, New York Central and others. International Shoe was a soft spot, dropping 6 points.

Wall Street has been somewhat less optimistic than London over Lausanne, and has been slow in drawing conclusions from the advance in German and other foreign bonds, in view of the false starts made in those directions in the past. Nevertheless, some quarters insisted that a decidedly constructive agreement was being reached at Lausanne, although it may take some time to put an official stamp on it, in view of political considerations in France and the United States.

Winston-Salem, July 6.—(AP)—Smith Reynolds, 20-year-old heir to the R. J. Reynolds tobacco millions, ended a spectacular career here early today with a bullet wound through his head.

The youthful scion of one of North Carolina's leading families died in the Baptist hospital at 8:25 a. m., EST, four hours after being brought there from his home at Reynolds, the family estate near here.

Ab Walker, of Winston-Salem, told authorities Reynolds shot himself almost within sight of his bride of a few months, the former Libby Holman, Broadway "torch

Walker, who was spending the night at Reynolds' home, said they were preparing to retire about 1 a. m. today and that he was closing the windows on the first floor of the palatial home when Reynolds appeared on a balcony outside his bedroom above. A moment later, there came the sound of a muffled shot and Mrs. Reynolds screamed that her husband had been shot.

Dr. W. N. Dalton, coroner of Forsyth county, ordered an autopsy performed on the body early today. He said he had not decided whether an inquest was necessary and that the autopsy was to determine the direction of the bullet.

Frank Bogler, Winston-Salem undertaker in charge of the body, told newspapermen there was every indication of suicide.

Young Reynolds first came into newspaper prominence three years ago when he and Anne Cannon, heiress to the Cannon textile millions, were married at 2 a. m. in New York, S. C. The young couple was accompanied to the South Carolina green by her father and his chauffeur.

Marital troubles soon developed and shortly afterwards Reynolds settled \$1,000,000 on his wife and infant daughter. A few months later, Reynolds flew his wife to Reno where she obtained a divorce.

Reynolds' interest in aviation prompted him to make several airplane jaunts, including one about the Far East with Jean Asolant, French flier. He was returning from this trip when Miss Holman went to meet him and they were married there. Announcement of the marriage was not made, however, until their return to New York several weeks later.

Anne Cannon Reynolds, shortly after her divorce, announced her engagement to B. Frank Smith, Jr., Charlotte hardware man. They were married at about the same time Miss Holman and Reynolds announced their secret marriage.

Miss Holman, six years older than Reynolds, is the daughter of a Cincinnati attorney. She was graduated from the University of Cincinnati where she studied law, and later rose to prominence on the New York stage.

Reynolds was the youngest son of R. J. Reynolds, founder of the tobacco fortune. An elder brother, R. J. Reynolds, Jr., engaged in numerous escapades which kept his name before the public. Like Smith, he has been highly interested in aviation and at one time owned Roosevelt field, near New York.

About two years ago while in England, R. J. Reynolds, Jr., struck and killed a cyclist with his automobile. He was arrested, convicted of reckless driving and served a prison sentence under the name of R. Joshua Reynolds. Members of the Reynolds household said R. J. Reynolds, Jr., is now somewhere in Europe.

Beside his brother, Smith Reynolds is survived by two sisters, Mrs. Charles Babcock and Mrs. Henry Walker Bagley, both of New York. W. N. Reynolds, racing enthusiast, is an uncle.

Neither Smith nor his elder brother was ever actively connected with the management of the R. J. Reynolds Tobacco Company. The share of each in the fortune left by their father has been estimated at around 25 million dollars. Their annual income was well above six figures.

He ran from floor to floor, window to window shooting at anyone in sight and appearing somewhere else as soon as the fire was concentrated on his last stand.

Searchlights throwing the house into brilliant outline failed to help the sharpshooters' aim.

Several police and bystanders, including an 18-year-old girl, were treated at the hospital for gas poisoning. Long, who said he was 48, was exhausted.
