BAD WEATHER GRIPS STATE AS PEOPLE GO TO POLLS

County Piling Up Big Vote For Democrats

Voting Continues Speedy Here Today In Spite Of Incessant Drizzle of Rain

ORDER HOLDS SWAY AT POLLS

Hundreds Stand In Line in Rain Awaiting Opportunity To Cast Their Vote For Favorites in National Election; Evident Democrats will Pile Up Great Victory In Spite of Rain; Voting Heavy in Parts of County.

HOOVER NEAR HOME TOWN

President to Make Final Speech of His Campaign at 3:10 This Afternoon.

Aboard the President's Special Train En Route to Palo Alto, Nov. 8.—(AP)—President Hoover neared his home today for the first time in four years ready to cast his ballot and await the decision of the nation's voters.

The Chief Executive brought his eleven thousand-mile campaign trip to a climax last night with a plea that voters "not be led astray by false gods arrayed in rainbow colors of promises."

His words were broadcast nationwide from the parlor car of his train at a stop at Elko, Nevada.

After crossing the California line about daylight, the President will run into a series of receptions beginning even before a half-hour stop of his train at Sacramento at 8:30 (Standard Pacific Time).

SAYS CAT HAS PLENTY LIVES

Cat Spends Night in Safe at Winterville and Comes Out in Good Shape

ROOSEVELT AWAITS VOTE FROM NATION

Democratic Nominee Will Cast Ballot At Hyde Park Town Hall this Afternoon.

Hyde Park, N. Y., Nov. 8.—(AP)—For Franklin D. Roosevelt the end of the day meant the Presidency or privacy.

The long campaign ended last night with the New York Governor's appearance at a rally of his neighbors in Poughkeepsie, county-seat of his home county, Dutchess.

The Democratic candidate planned to vote in the little town hall at Hyde Park. Afterward he will motor to New York to receive election returns at the Democratic National Headquarters in the Biltmore Hotel.

With Mrs. Roosevelt, Mrs. James R. Roosevelt, the Governor's seventy-eight-year-old mother, and Elliott second son, Mr. Roosevelt intended voting about 2 o'clock.

"To be the means through which the ideals and hopes of the American people may find greater realization of the best in any man, I am seeking to be only the humble emblem of this restoration," he told his Dutchess County audience last night.

And then he added slowly: "If that be your verdict," my friends of America and my next-door neighbors of Dutchess County and that be the confidence purpose behind your verdict, I shall in humility that suits such a great confidence seek to meet this great expectation of yours. With your help and patience and your generous good-will we can mend the torn fabric of our common life."

CITY IS SET FOR ARMISTICE DAY

American Legion To Sponsor Big Celebration Here During Coming Friday.

Plans had been completed today for the celebration of Armistice Day here Friday, and former service men and the public generally were looking forward to a genuinely big day with plenty of entertainment.

The observance is being sponsored by the Pitt County Post of the American Legion. Members of the Farmville post have accepted an invitation to attend and will take part in activities of the day.

The program will be composed of an address by Major L. P. McLendon of Durham; parade exercises at the college, dinner to former service men and a football game at Third street Athletic field.

In the parade which will form at the Atlantic Coast Line depot at 10 o'clock, will be seen ex-service men, local unit of national guard, Boy Scouts, high school band and hundreds of high school children.

The parade will move on to the campus building of East Carolina Teachers College, where the main exercises will be held, including the address.

After the speaking, dinner will be served former service men in the basement of the building. The feed is always one of the big features of the celebration and several hundred were expected to take part. The auxiliary will have charge of serving the dinner.

RAIN REDUCES LEAF OFFERING

Light Sales Reported on This Market Today and Yesterday Because of Drizzle.

Drizzling rain continuing almost incessantly since Sunday cut sharply into sales on the Greenville tobacco market yesterday and today, but the price situation was reported as very favorable.

K. W. Cobb, supervisor of sales, reported that sales for yesterday amounted to 362,774 pounds for \$49,782.26 at an average of \$13.72 per hundred pounds.

It was stated that the price situation on good tobacco was as favorable as any other part of the season.

Sales today were considerable lighter than yesterday, there being between two and three hundred thousand pounds of leaf here. Sales were completed before the noon hour, giving market employees an opportunity to go to the polls in plenty of time to cast their ballots in one of the most colorful national elections the nation has witnessed in some time.

With the last quarter of the crop being disposed of at this time, much common tobacco has appeared on the floors from day to day. In spite of this fact, the market average has remained favorable, showing up to better advantage probably than any other market in this section.

Is Politics Improving In United States Or Not?

By BYRON PRICE At the end of every national campaign, serious-minded persons are apt to be asking themselves whether politics is getting worse or better. Well, what about 1932?

Viewing the case now, while the animosities of battle still linger, a good many commentators are inclined to be pessimistic. They are appalled at the great quantities of slush and bunk dished out to the voter, and at the free and easy way in which charges of demagoguery and unfair tactics and even plain lying have been bandied about in the final weeks of the campaign.

They are unanimous in their conclusion that some of the materials which have gone into the fabric of 1932 politics never will be a source of pride in years to come, either to the respective parties which sponsored them, or to the American people.

But those who are inclined to be worried and discouraged at the current level of politics may modify their verdict somewhat when they have cooled off and remembered the past. Much that has been said this year was cribbed directly from the text-books of other campaigns. As bad, and in some instances far worse, appears to have happened more than once before.

And the optimists can find encouragement in the fact that, with all its faults, the present political year has contributed a few things at least to the brighter side of national life.

RICH WOMAN DIES IN N. Y.

Mrs. Mary Averill Harriman, Financier, Dies After An Operation.

New York, Nov. 8.—(AP)—Mrs. Mary Averill Harriman, financier and philanthropist, who became the richest woman in the United States in 1909, is dead. The widow of E. N. Harriman, financier, and generally known as "the little giant of Wall Street" succumbed last night in a New York hospital after an emergency operation. She was 81 years of age.

When Harriman died in 1909 he left a chosen word bequest of his estate to his widow, "absolutely and forever."

Mrs. Harriman amazed Wall Street by the sacrifice with which she administered the vast fortune. Harriman had a fondness for 10 per cent investments coupled with risk but she preferred 5 per cent investments with safety.

She later withdrew from speculative enterprises and created the Harriman National Bank of New York.

LIGHT VOTE AT RALEIGH

Barring Something Unforeseen, Unofficial Returns of Nation's Vote Will Be Available by Midnight; Associated Press Engaged in Great Task of Compiling Returns.

Raleigh, Nov. 8.—(AP)—Mean Mr. Weather covered most of North Carolina today as thousands of Tar Heels wended their way to ballot boxes to elect their public servants for the next four years.

First scattered reports indicated that the trend varied, some places reporting a heavy vote during early hours while others found balloting light.

One Raleigh precinct with a registration of one hundred had voted 65 hundred and fifty persons at 7:15, while one with 1,500 registration voted only one hundred during the first hour.

From Manito to Murphy the Tar Heels were on the march to cast their vote for President, Vice-President, Senators, a Governor, eleven Congressmen, 170 members of the Legislature, and county officers in each of the one hundred counties plus township and district officers.

Four proposed Constitutional amendments were also before the voters. Poles opened at sunrise and will close at sunset throughout the State.

Barring something unforeseen, the official results of the major races showing State vote for President and leading offices will be available at midnight.

As soon as poles close this afternoon tabulations of returns will be completed by The Associated Press member newspapers and early tonight the definite trend of voting should be revealed.

C.—The small son of Martin Metts, who lives near Pollockville, was fatally injured yesterday afternoon when he ran across the Trenton highway from his school bus and was struck by a Chevrolet sedan owned by Uley E. Austin, of Raleigh, traveling salesman for the American Sales Book Company, and driven by a negro chauffeur. The accident was termed unavoidable, but the negro was held for a hearing in Trenton.

The bus had parked on the highway in front of a large apple truck. The little boy alighted from the bus and crossed the road in the opposite direction. His skull was fractured in several places, both thigh bones were broken, his face was terribly bruised and there was a gash over the right eye.

Bad Dry For Rattlesnakes Scottsbluff, Neb., Nov. 8.—(AP)—Mr. and Mrs. Charles Janshart shot twenty-five rattlesnakes in one day near Mitchell recently and quit only because "they got tired."

Duke Snatches Potato-Growing Honors in Pitt

Speaking of potatoes and turnips, it is probable that Duke Duke has grabbed honors from growers of this section through the production of the largest potato and turnip seen in this city this year.

Reading about a large potato exhibited at the Reflector office yesterday, Duke brought his specimens to the office this morning. The potato tipped the scales at 7 1/2 pounds and the turnip at 6 1/2 pounds.

The potatoes were raised on one of the R. E. Harris Company farms near Greenville and shows what Pitt county growers are capable of doing when they put themselves to a task.

GEORGIA COUNTY MARKETS FARM CROP EVERY MONTH

Tifton, Ga., Nov. 8.—(AP)—A farm program that sends farmers to market with some crop every month in the year has made Tift County one of the leading agricultural counties in Georgia.

The county's four principal crops are cotton, tobacco, peanuts and watermelons. In January, February and March cabbage and onion plants furnish income; in April and May it is potato plants. June brings string beans and other truck. Late June and July is watermelon time. Tobacco starts selling in July and up to September. Cotton and peanuts are sold through November and December brings syrup, velvet beans, sweet potatoes, peaches and corn.

Tift County produced about one-sixth of Georgia's tobacco crop this year—2,168,386 pounds which brought \$241,490.

Late News Flashes

Testimony Begins—Kinston, Nov. 8.—(AP)—Testimony as to the whereabouts of Herman Casey on the day J. C. Causey, lumberman, was killed, was introduced in court here today as the state sought for the second time to convict Casey of the murder.

Evidence was largely a repetition of that given during the first trial and followed on the heels of testimony by Milton Woods who claimed to be an eye witness that he saw Casey shoot Causey.

Woods was given a long cross-examination by defense counsel who testified that Casey shot Causey and placed the body in a car and set fire to it, but he denied the story.

Hoover In California—Sacramento, Cal., Nov. 8.—(AP)—Coming into the capital of California today Herbert Hoover told the throng that greeted him at the station that he had been the subject of "unceasing misrepresentation by the press of William Randolph Hearst."

Remarking at the outset that the "election is on today and most of you have already made your conclusion," the President asserted "the people of California have not been given a full account of the crisis through which the nation has passed."

At the station a crowd standing in bright sunlight applauded the President when he said "the nation is again on the road to prosperity."

Rescue Man Buried Alive—Scranton, Pa., Nov. 8.—(AP)—Thomas Coleman, 35, one of two men buried alive under a slide of rock today at Aboca while digging fuel, was rescued alive today and went to Taylor hospital.

Louis Doran, who was trapped with Coleman, was still in the cave and rescuers were working to save him.

Coleman and Doran both of Aboca were digging coal for themselves in the shaft. They were at the bottom of the pit when the slide buried them. Rescue gangs from the Pittston Company rescued Coleman.

Heavy Vote—The American electorate rendered its verdict today in an avalanche which bid fair to establish a new voting record in many States and led to scattered disorders in a few of them.

Democratic gains were noticeable in a few fragmentary returns in New England, the South and part of the Mid-West. Fights were far too small to be decisive.

Under the general cloudy skies in some places amid rain and snow voters not only registered their preference but sometimes riotously.

## DUCE'S FROWN ENDS TURATI'S CAREER

Rome, Oct. 31.—(AP)—Mussolini's stern discipline that sweeps into oblivion those who fail to maintain Fascist standards has its most recent example in the fall of Augusto Turati.

Scores of men, big and little, ministers, deputies and party leaders, often his friends and comrades, have gone the same way, suddenly, from power into the darkness of the Duce's scorn.

**Resigns Two Positions**  
Turati for nearly five years was secretary of the Fascist party spokesman and strong right arm of Mussolini. When he resigned, two years ago, there were reports that the Duce was dissatisfied with him but soon afterwards Mussolini made him mediator of the powerful Turin newspaper La Stampa.

In August Turati resigned again and now it has been confirmed by government officials that Turati is in a sanitarium for nervous diseases. Gossip had it that correspondence of his caused him to be sent to "confinement" but officials emphasized that Turati was a patient, not a prisoner. Quite unofficially they added that his public career had ended.

He was one of Fascism's brilliant men, an editor who wrote well, an orator who galvanized crowds to frenzied action, a veteran with med-

als for valor and widely commended for organizing ability.

Tall, slender, elegant and a scholar, Turati had the quick grasp of a

fine athlete. Often he displayed tremendous strength and he was among the world's best fencers.

Roberto Farinacci, Turati's predecessor as party secretary and of opposite type, drew public rebuke from Mussolini a few years ago for his manner of publicity exposing Ernesto Beloni, mayor of Milan.

### Millions' Also Hit

Mussolini sent Beloni to exile for malfeasance in office, but he reprimanded Farinacci for flaunting the scandal in his newspaper.

Riccardo Gualino, once Italy's great after-war mushroom multimillionaire and trust former, was brought to trial and sent to "confinement" by Mussolini's insistence at a time when Gualino himself apparently thought he was too powerful to be touched. He was released recently.

Umberto Nobile, famed for his flight with Amundsen and Lincoln Ellsworth over the North Pole, dropped from a pinnacle of obscurity after the ill-fated dirigible Italia expedition to the pole.

Many others have faded out without scandal. Men found wanting in character or ability have been removed as promptly as they were elevated and, being out of favor, they have disappeared into silence.

**CORN TO BURN**  
**Nebraskans to Feed It to Furnaces This Winter**  
Lincoln, Neb., Nov. 8.—(AP)—Corn will be fed to the furnace in some parts of Nebraska this winter. This practice, resulting from low prices, is limited and has not been encouraged by experts at the Nebraska Agricultural College. But there is no doubt, the experts say, that some of the corn will be disposed of in this way. Corn cribs will be heaped high with a bumper yield, and county commissioners at Schuyler will buy corn on the cob at \$8 a ton to heat the courthouse in preference to coal at \$12 a ton. Yet in the opinion of Prof. E. E. Brackett of the college, using ear corn for fuel is not generally practical. Coal costing \$12.50 a ton and corn at 20 cents a bushel, produce about the same amount of heat per dollar in the testing laboratories, but the common type of stove or furnace is designed for coal or wood and will not develop the full value of quick burning ear corn.

**OHIO YOUTHS TO SPEND YEAR IN NORTHERN WOODS**  
Orr, Minn., Nov. 8.—(AP)—Two young men from Columbus, O., are going to solve the unemployment problem by living in the wilderness of Northern Minnesota. Fishing, hunting and trapping will keep the two youths, Lewis Wheeler and Ray Hensel, busy—something they were unable to do at their Ohio homes because of failure to find jobs. The boys plan to spend a year in the woods at Lake Klostad, about twenty miles from the nearest settlement at Ohio State University, while Hensel is a recent high school graduate. This winter the youths plan to walk twenty miles to Orr once a month for provisions.

**POLAR BEARS DUCK BLACK ONE TO DEATH**  
Milwaukee, Nov. 8.—Two polar bears systematically drowned a black bear after he fell into a pool at the Washington Park Zoo here. First one of the polars seized the intruder and pulled him under the water. Then the second polar bear repeated the process. This ducking was continued until the black bear was dead. Other bears gathered around the pool and grabbed the carcass as the polar bears pulled it from the water.

**FEMININITY ENEROACHES ON VANDY, MAN'S DOMAIN**  
Nashville, Tenn., Nov. 8.—(AP)—Masculinity, which once ruled Vanderbilt University with a strong hand, is slowly retreating. Back in 1879 the first woman graduate remained discreetly in the background. Her father received her diploma at the formal exercises. By 1897 only professors' daughters were allowed in class-rooms of the academic school. Then only Nashville girls unable to go elsewhere were permitted to enroll. Next spring about one hundred girls will receive diplomas. The engineering, law, medical and theological schools have their coeds. The women even have forced their way into campus politics, joining in the men's elections and securing one or two of the class offices for themselves each year.

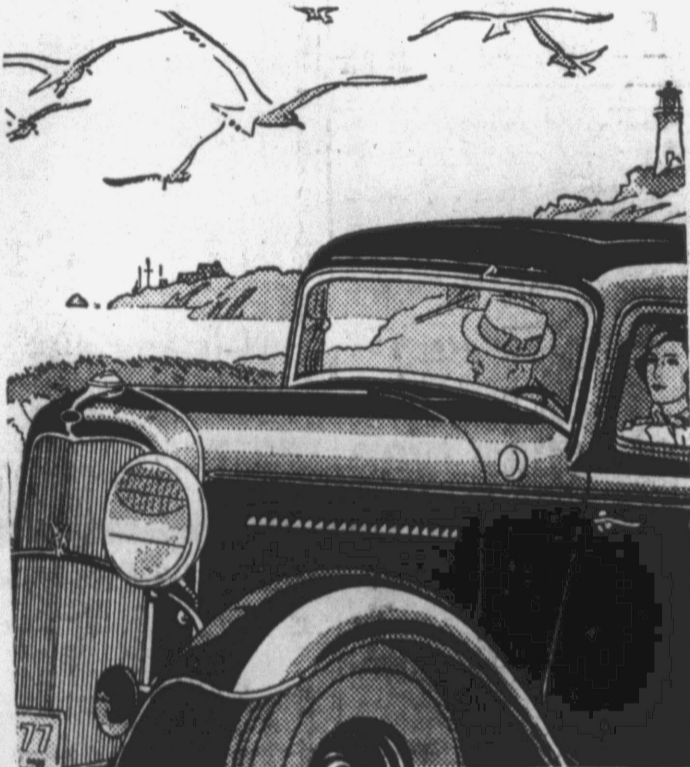

Another argument used is that fall planted legumes and small grains occupy the land at a time when it would otherwise be bare and exposed to the leaching out process of the soluble plant food, and to the erosion of the soil itself. While the chief advantage of winter hay crops is that they furnish a good crop of fresh feed at a time when it is likely to be low, there is another advantage, especially where legumes are grown, that the fertilizer bill may be reduced and the land put in such shape that the fertilizer, used will pay better in returns.

We don't need to be afraid of losing the fertilizer value of the stable and chicken manure by spreading it on the ground and leaving it uncovered. Far less plant food is lost in this way than if left in piles to

heat and have the nitrogen go off in the form of smoke, which is ammonia, or an impure form of nitrogen. The accumulations should be in the garden for the benefit of your spring vegetables.

As soon as the fall crop of Irish potatoes has been killed by frost they should be either dug and stored or cut the tops off with a hoe. They will keep in the ground during the winter and may be dug as needed. If handled in this way, it is advisable to throw enough dirt on them to be sure the potatoes do not freeze. Digging and storage is, though, the best method to keep the potato crop.

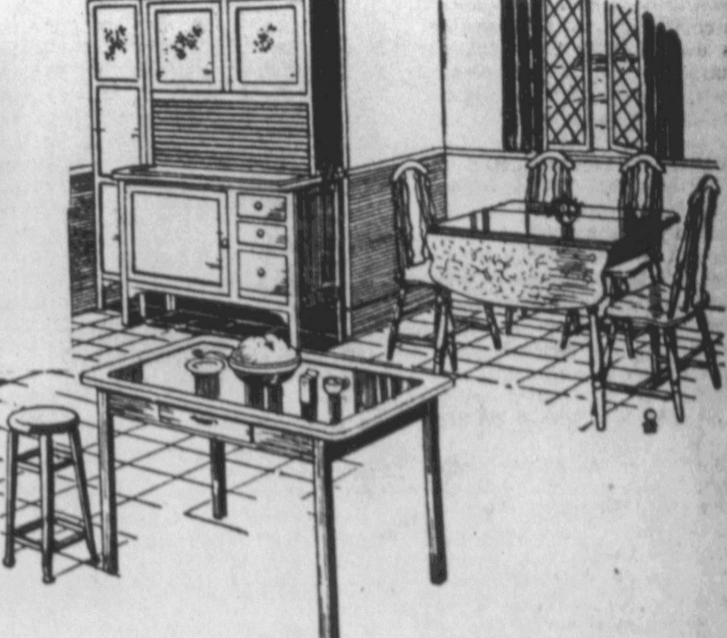

It was so sudden that it left the football world a trifle unbelieving despite the fact that Army capped the climax the following week by running a 14-0 over the Irish at the Yankee Stadium for a two-touchdown victory.

Just why there should have been a tendency this year to "throw those two out," as the boys say, and again put the plaster of incincerity upon the Notre Dame gridiron product, is difficult now to fathom.

We did not, of course, figure Pitt's Panthers to turn the tables so quickly and deflate the Irish bubble this early in the current campaign, but it was nevertheless a noteworthy contribution and perhaps all for the best, for Notre Dame and for football in general.

**Natural Decline**

The decline since Rockne died in the fortunes of Notre Dame, is not only definite but natural. Whether or not the decline is only temporary is another matter. No system, however, founded so much upon the personality and genius of one individual, pulling all the intricate strings of the puppet show, could continue to operate with consistent effectiveness without the master's touch.

With sweeping colors, moreover, Rockne painted his last two football seasons vividly. The 1929-1930 Notre Dame teams were the nearest thing to perfection, in gridiron skill and power, that we have ever seen.

**It's the Contrast**

Like most everything else, football fortunes move in cycles. Of course there are certain, definite factors entering into the production of winning teams, such as the fundamentals of coaching and material. Even the best systems strike slumps.

It just so happened that Notre Dame, under Rockne, kept the average so high that a dip in the results always seems to shock the general populace. They immediately view with alarm.

It would seem about time to change the subject and worry over what Tennessee is going to lose another football game.

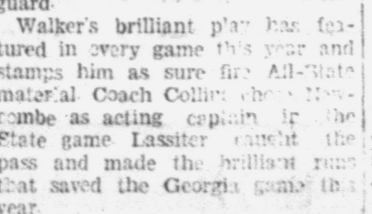
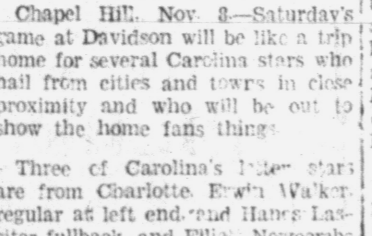

### JAPANESE GENERAL REVEALS PLAN FOR ADDING JEHOLO TO MANCHUKUO

By JAMES A. MILL  
Mukden, Oct. 27.—(AP)—Lieutenant General Kuniaki Koiso, chief of staff of the Japanese army in Manchuria, frankly admitted here that Japan intends to annex the province of Jeholo, north of Peiping, to the new state of Manchukuo.

He added that it would take two or three years and the efforts of 80,000 Japanese soldiers to suppress banditry and bring real peace to this troubled land. He said Japan now had only 35,000 troops in the whole of Manchuria.

"It is essential," he said, "that we put Jeholo under Manchukuo's control. Without order established there, peace cannot be maintained on this side of the present border."

"We may launch our Jeholo campaign within a few weeks; certainly it will start before spring."

The general blamed the Jeholo situation and the resurgence of banditry, train wrecking and kidnapping hereabouts, on Marshal Chang Hsiao-Liang, who was ousted as war lord of Manchuria in the autumn of 1931.

"Chang is doing everything possible to undermine the new government of Manchukuo and, by inspiring bandit raids and kidnappings, is

trying to give foreign powers the impression that neither Japan nor the new state can keep order here.

"We do not seek further clashes with his armies, but he probably will force them upon us. He must take full responsibility for the consequences."

The general asserted that Japan had no intention of absorbing Manchurian territory as an integral part of the empire.

"We want Manchuria only for commercial and industrial purposes," he said. "Also we need it as a home for those of our surplus population who wish to come here."

"Japanese immigrants are excluded from the United States, Australia, New Zealand and several other countries. Brazil welcomes us, but mostly we are driven toward China which has no barriers against our race."

"Also we must depend increasingly upon this territory for coal, timber, foodstuffs and other raw materials. Manchurian trade, in fact, is vital to our national existence."

"If the League of Nations or any one or two power tries to thwart our plans, we must resist with all our might. Hence it follows that we cannot accept in any sense the dic-

tates of the report which the Lytton commission made at Geneva.

"But it will be necessary to allow Manchukuo to develop her own policies. Japan will give the new state every legitimate assistance, but we shall not attempt to dominate the government nor force our will upon the people."

"If it is to succeed, Manchukuo will require the continued help not only of Japanese experts, but of engineers, architects, business men and advisers from other foreign countries like the United States. She also will require foreign capital to exploit her enormous natural resources, lay new roads, construct railways, build electric power plants and erect factories."

General Koro said it was also Japan's aim to assist Manchukuo in the development of a "moral civilization."

"We wish to teach the people here the principles of what we call 'the kingly way,' which is the code of our life in Japan," he explained. "In that code we find the foundation of our ethics, our conduct, and our lives."

"If Manchukuo follows this 'kingly way,' she cannot fail to become a great nation."

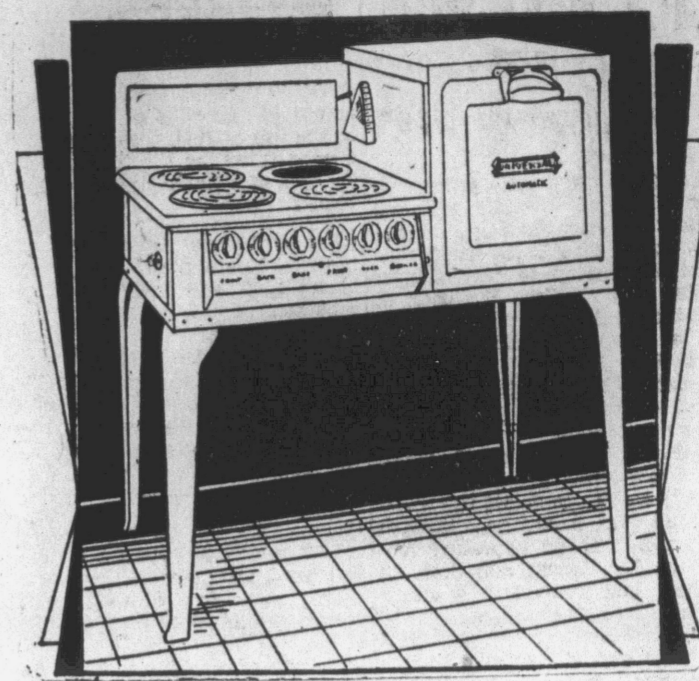

# Water & Light Commission

### Hints on Contract Bridge Up-to-Date

(By L. A. M. Gruenther, U.S.A.)  
The new International Contract Bridge Code which became effective in the United States, France and England Nov. 1 should be enthusiastically received. It is a definite step forward.

Penalties for infringements of the laws have, in general, been considerably ameliorated. Following is an analysis of new and old rules:

**Examining a Quitted Trick**  
New Law—A trick may not be examined after it has once been quitted, except to settle a dispute involving ownership of trick. Penalty—Declarer or left hand opponent may call a lead when next it is the turn of the offending side to lead.

**Old Law**—Any player could examine quitted trick until he or his partner had played to the next succeeding trick. There was no penalty for infringement.

**Comment**—It always has been annoying to have a player look at a quitted trick. There is no good reason why a player cannot remember cards as they are played.

**The Revoke**  
New Law—(a) A player "revokes" when he fails to follow suit when able to do so. However, revoke penalty is not assessed until "the revoke becomes established." The revoke is established as soon as the offender or his partner leads or plays the next trick.

(b) Penalty for established revoke is two tricks for first revoke and one trick for each succeeding revoke. Tricks shall be transferred to the non-revoking side and scored as if that side had actually won the tricks in play.

(c) If no tricks are taken by revoking side after revoke has been committed there shall be no penalty. If only one trick is taken then only one trick shall be paid to the non-revoking side. Thus, assume that South is playing a contract of four hearts, and that the East-West pair win the first four tricks, the fifth trick being won by Declarer; and on that trick West revokes. If Declarer then wins the remaining tricks there will be no penalty for revoke, since revoking side failed to win any tricks after the revoke. The Declarer, therefore, has been set one trick on his four heart contract.

**Old Law**—The penalty of two tricks for first revoke and 100 points for each succeeding revoke was prescribed under the 1926 code of laws. Furthermore, there was no consideration given to the question as to when revoke actually took place.

**Comment**—It always has been considered unfair to collect tricks on a revoke penalty when revoke could have no possible effect on the play. The term "renounce" (failure to follow suit when able to do so) has been abandoned. Now instead of a penalty for a "revoke" and another for a "renounce" there is one penalty for "an established revoke" and a different penalty for a "revoke."

**Corrected Revoke**  
New Law—If an opponent of Declarer revokes and his attention is called to the irregularity before revoke becomes established, Declarer is permitted:

1. To treat the card played in error as an exposed card, or
2. To require the offending player to play the highest or lowest card of the suit in which he failed to follow.

**Old Law**—Penalty under old law was the same. It was known as penalty for a renounce.

#### Insufficient Bid

New Law—If a player makes an insufficient bid and attention is directed to the error by either adversary or by partner, the bid must be made sufficient, though there is no requirement that it be made sufficient in the same suit. Thus a player who makes an insufficient bid of two clubs over two spades may change his bid to three no trump if attention has been called to the insufficiency. The partner of the insufficient bid is then barred from bidding when next it is his turn to declare. Thereafter the partner may reenter the auction.

**Old Law**—The old penalty barred the partner of the insufficient bidder from any further bidding on that deal.

**Comment**—The penalty imposed by the former law was too severe.

**Review of the Bidding**  
New Law—During auction any player may ask for review of bidding

when it is his turn to declare. After auction is completed, and before first lead is made, any player may ask for complete review of bidding. After opening lead has been made any player may demand to know final bid but review of bidding may not be requested.

**Old Law**—No review of bidding was permitted after last player had passed.

**Comment**—The vast majority of bridge players have always permitted review of bidding until opening lead was made.

### Scanning NEW BOOKS

By JOHN SELBY

New York, Nov. 8.—Perhaps Lewis Browne's most valuable asset, when he sat down to write "Blessed Spinoza," proved to be his knowledge of Jewish and Jewish history—a knowledge to be pre-supposed in a writer whose adult career began as a rabbi.

Certainly Spinoza's modern biographer could scarcely have provided a better background for his subject than Browne's glowing story of the perils and pilgrimages of the Spanish and Portuguese Jews, their eventual settlement in Holland and the development of their community there.

The introduction is long; one has read through a good many pages before the child Spinoza appears. But when he does there is no resisting him. Theoretically a "good life" is rather dull pickings for a biographer; if so, "Blessed Spinoza" is an important exception. In these hour-long, in the evocative Mr. Browne finds material quite as appealing as lies in the conventional adventures of a more usual biographical subject.

**Two Novels**

In "Invitation to the Waltz," Rosamond Lehmann, now a poised and sure craftsman, takes an even slighter subject than she treated in her earlier books and makes a great deal more of it.

In this story of a dance and the events leading up to it, Miss Lehmann strikes the same quivering emotional chords she found in "Dusty Answer," but now she strikes them from knowledge rather than "by ear."

A good deal like the Lehmann book in its emotional aliveness is Elizabeth Thomas' "The Story of Silas Woodward." But this is the story of a young man, a girl, and the young man's mother in a Rhode Island setting, a curious, sometimes tortured story not comparable to the record of Olivia's first dance.


Few writers have Miss Thomas' gift of fixing deftly upon the precise word to express sensory excitements. Nor is her understanding of nature and its effect upon human beings a common one. "Silas Woodward" contains also three differing persons entangled in a curious plot.

**Boleslavski**

With the help of Helen Woodward, Richard, Richard Boleslavski has caught in "Lances Down" both the spirit and the letter of some exciting days in the bloody Russian October of 1917. But there have been innumerable descriptions of such scenes, and very few intimate recitals of doings among the Moscow Art Theater members. Wherefore the pages dealing with that institution are particularly valuable.

So, too, are the innumerable friendships and acquaintanceships of Hamlin Garland, as described in the third volume of his reminiscences, "My Friendly Contemporaries," covering the period from 1913 to 1923.
