U. S. COMMISSIONER JAILED ON BRIBERY CHARGE

Liquor Ship Seized On The Coast

Growers Of Six Counties Honored By Bankers Of State Here Last Evening

CERTIFICATES ARE AWARDED TO PLANTERS

Forty-Odd Growers Receive Awards for High Type of Farm Operation; Dan H. Otis, of the National Bankers Association Delivers Principal Address; Number of Other Prominent Men Speak.

Forty-odd farmers from six counties of this part of the State were awarded "Grade A" certificates by the North Carolina Bankers' Association at a "banker-farmer" banquet at the Woman's Club here last night.

The presentation was made by Millard Jones, third vice-president of the State Bankers' Association in the absence of Robert N. Page, president, who was prevented from attending on account of illness.

It was an inspiring scene as the crack growers of the various counties gathered in front of the speakers' table and accepted certificates which gave them the distinction of being growers of the first water, men who have passed the acid test as provided through the agricultural commission of the State and national bankers' organizations.

Paul Brown, of Raleigh, secretary-treasurer of the North Carolina Bankers' Association, presided, taking the place of Norman Y. Chambliss, of Rocky Mount, chairman of the agricultural committee of the State Bankers' Association, who was detained on account of illness.

Brown expressed appreciation on behalf of the bankers of the fine spirit exhibited by the growers and predicted that the movement would be filled with greater possibility in the future as the farmers begin to more fully realize the importance of being at home instead of placing all dependence upon cash crops.

J. H. Rose, superintendent of city schools, pronounced the blessing over the bountiful supply of turkey, oysters, cranberry sauce and other good things which had been provided for the occasion. The club room was decorated in keeping with the Christmas season. A delightful musical program was provided by an orchestra headed by Prof. Eugene Robeson, of the high school, and composed of members of the high school and college student bodies. Miss Eva Hodges assisted at the piano.

Dan H. Otis, director of the agricultural commission of the American Bankers' Association, was the principal speaker and brought to his hearers a message showing the possibilities of a well-balanced farm program.

The speaker was introduced by W. H. Woolard, vice-president of the Greenville Banking and Trust Company, and member of the agricultural committee of the State Bankers' Association, who had charge of arrangements for the banquet. He expressed appreciation of the interest manifested by both bankers and farmers, and said the future was bright for expansion in the agricultural field.

From charts showing operations on farms in Wisconsin, Illinois and Texas, Mr. Otis revealed the results of tests made among farms in the various States, showing that growers who kept accurate checks on all phases of farm life obtained a much higher ranking with revenue doubled and trebled in many instances. He emphasized the need of a well balanced program, enabling growers to live at home all the year around and to keep an accurate account of their operations so that they might know where they stand all the time.

J. H. COWARD ELECTED AS PITT AUDITOR

F. C. Harding Named County Attorney by Commissioners Here This Week.

J. H. Coward, prominent Ayden business man and district representative of the North Carolina Joint Land Bank, was elected auditor of Pitt County at the regular meeting of the new Board of Commissioners here the first of the week; it was revealed today.

It was stated yesterday election of an auditor to succeed J. Thomas Clifton, who resigned several days ago, was deferred until the first of January, but this was a mistake caused by confusion in the minutes of the session.

In addition to naming the auditor, the board also appointed F. C. Harding as county attorney, succeeding J. B. James, who has held the position for a number of years.

The new county auditor was chosen from a number of applicants for the position in view of his wide business experience and wide knowledge of local conditions.

He is a native of the Ayden community and has spent the major part of his life in business associations in this community. Because of his intimate knowledge of conditions in this section, he was named representative of the Joint Stock Land Bank several months ago.

He will take charge of his new duties the first of January, it was said, and that at that time other changes in the office will be completed by commissioners. Other departments are due to come under the paring knife of the economy program launched by the new board following their induction last Monday afternoon.

Mr. Harding, the new attorney, is eminently qualified for his duties, having served the legal profession here for many years. He is considered one of the leading members of the bar in this part of the State and is sufficiently versed in affairs of the county to render invaluable services.

COTTON CROP IN U. S. GROWS

DEBT NOTE IN BRITAIN

United States' Reply to Request for Suspension Sent to Ramsey McDonald.

London, Dec. 8.—(AP)—The United States government in reply to Great Britain's second appeal for extension of the debt due next week arrived today and its contents were sent to Prime Minister Ramsey McDonald and after cabinet members.

Early publication of the note is expected soon.

Paris, Dec. 8.—(AP)—An official communique was issued today after the meeting between Premier Herriot of France and Prime Minister Ramsey McDonald.

France and Britain will continue their policy of independent action with regard to the American debt, but all will continue their effort to obtain by international co-operation measures to promote conciliation and restoration of the world, the communique said.

"The two governments have explained to one another the state of public feeling," said the communique, "in a very exhaustive exchange, and they have considered 're-position in regard to the Lausanne agreement and have settled difficulties growing out of the payment of debts due December 15."

Negro Faces Death.—Raleigh, Dec. 8.—(AP)—Jake "Sunshine" Jones, 19, negro, who was convicted of the murder of J. H. Pool, filling station operator, prepared on death row at state prison today to be electrocuted tomorrow.

Jones' last chance lay in the probable extension of clemency by Gov. Gardner. Tyre Taylor, the governor's executive counsel, who investigated the clemency application and makes recommendation to the governor was out of the city today.

Woman is Husking Champion.—Bluffton, Ind., Dec. 8.—(AP)—Husking corn is a job that women can do with speed. Mrs. Stella Murray is this county's champion woman corn husker this year. Competing with five others, she husked 63 bushels of corn in thirty minutes.

Capital Quiet On Debt.—Washington, Dec. 8.—(AP)—Indication from Paris that England would pay her war debt installment on December 15 and that Premier Herriot would recommend Parliament that payment be made lightened the atmosphere in Washington but failed to bring official comment.

BIG CARGO OF BONDED RUM IS CAPTURED

Nine Men Also Taken Aboard 'Yiddish Of Nassau', Captured Between Portsmouth and Cape Lookout.

Morehead City, N. C., Dec. 8.—(AP)—The boat Yiddish of Nassau, and flying the British flag, today was seized by Federal authorities after seven hundred cases of bonded liquor were reported found on the vessel.

The boat, a new one, equipped with twin motors and smoke screen equipment, was seized between Portsmouth and Cape Lookout by Coast Guard boat 232 under the command of Boatwain C. H. Parker.

Lawson Christen, executive officer of the Coast Guard base headquarters, is being given credit for the capture.

Some time ago Christen's suspicions were aroused by a New York automobile in this vicinity, so he took the license number and wrote to Coast Guard headquarters in New York for information regarding the car.

The reply said the car belonged to a group of gangsters employed in rum running. Another Coast Guard unit found the gang had a new smoke screen aboard and ascertained from Nassau the route which would carry it over the course to Cape Lookout.

A party was supposed to meet the ship, but evidently the plans went wrong, and when the boat failed to appear, the British vessel ventured in to close.

Nine men were taken aboard the boat, it was announced at Wilmington, by Mrs. Fannie Paison, Collector of Customs of North Carolina.

The feature of the Duke University Day dinner of the Pitt County Duke Alumni Association, to be held at the High School cafeteria on December 9 at 6:30 o'clock, will be an address by Herbert J. Herring of Duke University. He will bring a message regarding the aims and purposes of the institution and various phases of its growth and development at this vitally important period of its history. His subject will be "Duke University: The Privilege and Responsibility of Her Alumni."

In addition to the address of the evening, there will be a number of other interesting features, including the election of officers for the ensuing year. There will probably also be brief remarks by one or two members of the local group, and perhaps a short musical program.

The Duke University Day dinner here is one of many to be held in North Carolina and other States in commemoration of the eighth anniversary of the creation of the Duke Endowment, making possible Duke University, on December 11, 1924. HELD UNDER \$10,000 BAIL HERE TODAY

Federal Officer And former Minister taken into Custody By County and City Officers Last Night; Was Receiving Bribe from Negro When Arrested; Arrest follows Four Weeks' Investigation.

Thomas E. Beaman, U. S. Commissioner and former minister, was being held in the county jail here today charged with receiving bribes from bootleggers and conspiracy to violate the national prohibition laws.

He was arrested by county and city officers last night, and will be held for Federal authorities. His bond was \$10,000.

The arrest of Beaman, who for the past three years has been prominent in the prosecution of whiskey interests in this territory, followed a four weeks' investigation conducted under the direction of Sheriff Sam Whitehurst and Chief of Police George Clark and reached its climax when Beaman walked into the draught of the law at W. A. Shine's, colored, on Twelfth street.

Officers said Beaman was the head of an organization hanging around the law-enforcement offices of the city supposedly for the purpose of giving them government aid, but principally for the purpose of informing bootleggers and whiskey interests of the movements of the law and then demanding bribes.

They said Beaman told his victims that if they would pay him a certain amount of money he would defend them, that he represented all of the law-enforcement agencies of the county and could prevent their prosecution.

Acceptance of bribes had been checked on three different occasions prior to the visit to Shine's place last night, officers said.

As Beaman approached Shine for a \$3 bribe last night, Sheriff Whitehurst and Chief of Police Clark suddenly made their appearance at both entrances to the building. Beaman was told he was under arrest, and in searching him the officers found a revolver and the three one dollar bank notes which Shine had just paid him.

Sheriff Whitehurst said he had previously marked the bank notes before delivering them to Shine, who instead of being a bootlegger as Beaman supposed, was being used by the officers in obtaining final evidence on the former preacher.

In addition to his position as U. S. Commissioner, Beaman was said to be the head of a local detective agency, which over a year ago was used in rounding up violators of the national prohibition law.

Over a year ago Beaman directed raids on numbers of whiskey sellers in this immediate section. He obtained the information, it was said, and Federal officers prosecuted the raids. Many of the defendants arrested in such instances found their way to the Federal penitentiary.

The emphasis may be momentarily on other things, but the problem of relief of human suffering sounds one deep, insistent undertone of universal uncertainty as Congress resumes its sessions.

Fundamental considerations pose the question: Can the country come through the winter without resort to some form of dole?

The ready answer of most political leaders is that it can. When it comes to devising an effective alternative for direct, personal aid to the unemployed, however, the replies are vague and contradictory. The question will persist.

Prohibition, budgetary reform, taxation and farm relief may all be high placed on the Congressional calendar, but the issue of what to do about those who are cold and hungry has a status which in time may easily transcend legislative programs.

A Big Problem

Estimates of the number of jobless in the United States vary from 10,000,000 to 13,000,000.

A more nearly exact conception can be aimed from the expenditures for relief. When it is realized that Chicago alone has been spending \$100,000 a day to feed the hungry, no one can fail to understand the magnitude of the problem.

Recently one of the best-known industrial leaders of the country said at a private luncheon:

"The one big question is the question of relief. The States and municipalities rapidly are exhausting their resources. Voluntary charity is capable of only so much, and the amount needed can no longer be raised by local taxation."

So far as the Federal Government is concerned, it can loan to the States through the Reconstruction Finance Corporation, but the au-

Congress Takes Notice
All proposals to deal with the problem still are in the formative stage. It is not considered likely that any considerable group will advocate an outright dole.

The recent American Federation of Labor endorsement of State unemployment insurance testified to the changing opinions of the times, for it represented a reversal of the Federation's policy over many years. The Chamber of Commerce of the United States now is actively interesting itself in the relief puzzle and may suggest legislation.

President-Elect Roosevelt, in a magazine article published recently, put unemployment high among the urgent issues of the next few months. Senator Hiram Johnson, on his return to Washington, described it as the "transcendent" public problem.

"Marches" Don't Impress
Washington has not been very much impressed, on the other hand, by the activities of those who call

themselves "hunger marchers." Not one of these pilgrimages to the capital has failed to leave a trail of antagonisms behind it. Whatever relief measures may come out of the session are more likely to flow from the prayers of the patient millions back home than from the demands of the demonstrators. Congress is that way.

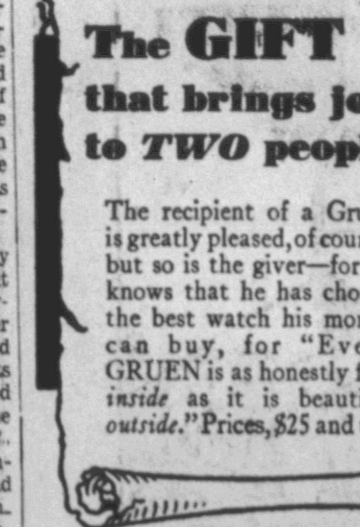

ABOUT TOWN

The Farm Board is trying to put agricultural prices on the same basis as other products produced in the country, but the plan has not assumed tangible form.

Tails was recommended in a special report to Congress yesterday, and while Congress may be disposed to approve the proposal, it would like to know how it is to be done probably.

President-elect Roosevelt may be able to give the Farm Board some assistance after he enters the White House. He has already proposed giving farm product the same tariff protection as enjoyed by manufacturers and this may be instrumental in lifting the price situation for products of the farm.

If there is anybody needing assistance of the federal government it is the sorely pressed farmer of the nation, and it is hoped Congress will consider all proposals and do its best to bring desired relief.

The meeting of bankers and farmers held here last night was

inspirational and shows what the bankers are doing to interest growers in the improvement of farm life. It is something of a distinction to be able to pass the "Grade A" test of the North Carolina Bankers Association and growers able to do so receive more consideration when they apply at the banks for financial assistance.

The object of the bankers in awarding certificates to growers passing the test is to make more of the farmers self-sustaining, capable of providing for their families in time of stress. Diversification is one of the requisites and this walks hand in hand to the live-at-home program enunciated by Governor Gardner two years ago.

The fact that Pitt county has more "Grade A" farmers than any other county in the state shows what our growers have been doing to improve their condition. It means they will be among the first sections of the country to see the prosperity people have said hides just around the corner, and their recovery should be speedier than those who have given little attention to farm development.

When those packages and letters are prepared for mailing be sure to see that they contain one or more of the Christmas seals being sold for the purpose of helping tubercular patients confined in our various hospitals.

A Washington Daybook

By HERBERT PLUMMER

Washington, Dec. 7. (AP)—Roughly estimated this short session of Congress will have in that period extending from noon, December 5 to noon, March 4, something more than 50 days of work.

The question uppermost in the minds of almost everybody now, and particularly to President-elect Roosevelt and his advisers is what will be accomplished in those days.

For it is as near certain as things like that can be, there'll be an extra session of Congress next spring unless legislation now pressing for consideration is disposed of in some fashion during the coming weeks.

Governor Roosevelt, as well as most of the Democratic leaders in Congress, has been represented as being opposed to an extra session.

As far as the President-elect is concerned he merely shares the views of practically every man just elevated to the presidency. All of them have shied around the idea.

Except in a few cases no President has benefitted much by them. There's the example of President Hoover. Some administration troubles seem to date from the time he convened Congress in special session to consider farm relief and revision of the tariff.

The foundations for the political downfall of President Taft were believed to have been laid in the special session he called after his inauguration in 1909.

Cleveland didn't call one in his first term, but in his second the financial condition of the country was such that he couldn't avoid it. But what that 89-day session in 1893

did to him and his party is now history.

McKinley dared to call one 11 days after his inauguration and survived the next presidential election. Woodrow Wilson convened the Congress in special session to con-

sider the tariff and currency situation and was re-elected.

But there's seemingly a political jinx about these extra sessions which Presidents in the past have respected. Governor Roosevelt is probably no exception.

Shepard's big task is to re-organize Tom Alexander, All-Southern guard, and Paul Edwards, veteran and steady center. There is considerable material available, but players like these come few and far between, and the Tar Heels will have a big job rebuilding as strong as last year.

Building Improves.
Baltimore, Dec. 8.—(AP)—A sharp rise in industrial construction contracts awarded in November contributed to building today \$29,227,000 in southern states, which exceeded in value contracts awarded in

November, 1931. The current issue of the Manufacturer's Record says. The award for new industrial plants for the month rose to \$2,247,000 from the total of \$1,493,000 the preceding month.
"Manufacturers are taking advantage of low prevailing prices for material and equipment to go forward with improvements so they will be in position to fill orders on the run of business," the Record said.

Congress At Work In Earnest.
Washington, Dec. 8.—(AP)—Congress pitched into the work of its short session in earnest today perfecting organization, taking up legislation and laying plans for speedy

handling of farm relief and the veterans' economy question.
Before taking up the Philippine independence bill expected to be passed in about a week, the Senate agreed to realignment of the Republican committee posts necessitated by vacancy. Democrats passed up the task to seek control.
The rush to cut out a beer bill for House consideration continued in the ways and means committee, with witness after witness testifying in favor of 1-2 per cent brew.
The drys will be heard later.
The joint veterans committee decided to meet tomorrow for a short hearing.
Representative Patman of Texas renewed his drive for payment of

the bonus, making a speech to the House.
Hearing on the Democratic farm aid program will be launched next Tuesday by the House committee with a plan to limit the study to one week and then put the bill up for passage.
A federal tax purchasing plan intended to reduce production, remove surplus and increase the price to the farmers was called for in a bill introduced by Sen. or Smith (D) of South Carolina. The bill would set up a cotton purchasing board in the Agriculture Department empowered to buy in the open market 1,000,000 bales at 100 a pound. Cotton would be withdrawn from the market and resold on credit to cotton producers who would agree not to grow more than 20 per cent of their 1932 crop.
Representative Rogers of Massachusetts introduced a resolution authorizing the Farm Board to turn 35,000 bales of cotton over to the Red Cross for clothing for the needy.

A statement made from the Alumni Office of Duke University is to the effect that there are now in the office files the names of 7,000 located alumni of the institution. Every State in the Union is represented in the alumni list, and all the hundred counties in North Carolina. Names in the alumni files represent twenty-nine different countries outside the United States.

Charles A. Sheffield, assistant director of the agricultural extension department of State College, spoke on the subject, "Grade 'A' Farmer, What Is He?" From a chart he explained the different type crops necessary to a well-balanced program and said a "Grade A" farmer is the one that follows a well balanced program and through that provides a steady flow of revenue all the year around.
L. O. Moseely, of Kinston, told of "What I Think of the 'Grade A' Farmer Movement." He, too, stressed well balanced crops, and said they should aid in the improvement of the agricultural life of the State.
Fred Latham, prominent grower of Belhaven, told how to get a loan from a hard-boiled banker, and advised the growers to work in close co-operation with the financial leaders and let them know what they are trying to do.
H. M. Cox, of Mount Olive, was introduced by Mr. Brown as the instigator of the movement to recognize "Grade A" farmers of the State. Farmers receiving certificates were:

New York Cotton

New York, Dec. 8.—Cotton futures opened fairly steady, seven to thirteen points decline in response to lower Liverpool cables and pre-liquidation.
Trade interests were buyers on the scale down and further coverings appeared, but prices worked off to 5.42 for January and 5.71 for May, or about 14 to 15 points net lower by the end of the first half hour.
Early selling continued, and when trade was suspended to receive the government crop report the active months were about 14 to 15 points net lower.
There was heavy selling when business was resumed, but it was absorbed by trade buying and covering on further decline of some five to eight points and action of later suggested that long interests had been liquidated.
January broke to 5.43 and May to 5.68, or about 21 points below yesterday, but by midday prices rallied 10 to 12 points from the lowest.
