Japanese Campaign In Jehol Province Said To Have Begun Today

Modern Army Starts Drive to Annex Chinese Province to Japanese Sponsored State

Changchun, Manchuria, Feb. 24.—(AP)—Japan has officially started its military campaign to annex the rich Chinese province of Jehol to the Japanese sponsored state of Manchukuo. The most powerful Japanese force in Manchuria since hostilities began seventeen months ago was being gathered east of Jehol today along two routes about 150 miles apart. The modernized Japanese army with tanks, bombing planes, armored cars and about 60,000 trained troops is expected to raise the flag of the Rising Sun over Jehol or Shihfeng, the provincial capital within anywhere from a week to a month. Opposing this army are about 150,000 poorly equipped Chinese under several commanders. A report from the northern starting point of the drive said an infantry division fresh from Japan, a veteran cavalry brigade and a force of native troops were plodding through a snowstorm against Chinese volunteers in the Kailu region. A big force of Japanese cavalry infantry and artillery is directed against Chaoyang, second largest city in Jehol over the shortest route to the seat of the Chinese government of Jehol. These included mostly veterans of the battle that resulted in the conquest of Chankiawan early in January which closed the eastern pass in the great wall blocking more Chinese troops from reaching Jehol from that direction.

JAP DELEGATES WALK OUT ON LEAGUE MEET

Adoption of Recent Report on Manchurian Situation Cause Of Action

Geneva, Feb. 24.—(AP)—The Japanese delegates walked out of the assembly of the League of Nations today after adoption of the report condemning the Japanese policies in Manchuria and urging a continuance of non-recognition of the Japanese sponsored state of Manchukuo. The delegation announced that it could no longer co-operate with the League in its stand on the eastern situation.

Siam was the only country represented not voting. There were forty-two voting yes. Absentees were Cuba, Salvador, Nicaragua, Peru, Bolivia, Paraguay, and Chile.

Yosuke Matsuoka, head of the Japanese delegation, told the assembly, however, that Japan would co-operate with the League as far as circumstances would permit. When the Japanese delegation walked out, Paul Hymns, Belgium, chairman, without any expression of regret, said the assembly would reconvene at 5 o'clock this afternoon. It was clear that Japan had not definitely withdrawn from the League. Neither did Matsuoka assert it was withdrawn. In announcing Japan's rejection of the finding, Matsuoka, repeated his charges that chaos existed in China and narrated again it was an oasis of armed intervention by great western powers in China to protect the lives of their nationals.

HAVANA SCENE OF BOMBINGS

Eight Bombs Explode As Capital Begins Celebration of Independence Day

Havana, Cuba, Feb. 24.—(AP)—A series of bombings early this morning on the twenty-eighth anniversary of Cuban independence climaxed shortly before noon when a railroad bridge near Camaguey was blown up with dynamite. Eight bombs were exploded within two hours as the twenty-eighth Cuban independence anniversary had begun. Meanwhile the capital scanned the reports anxiously to determine if the rumored revolution had taken form. Mexico dispatches recently had predicted a movement of rebels from the mainland to coincide with the bombing of Havana. Three of the bombs were large ones and the other five smaller.

ASSERTS AGE FOR EXPANSION IS CONCLUDED

Says No More Land Should Be Seized For Occupation By American People

Chapel Hill, Feb. 24.—Delivering the last of the annual series of Well lectures on American citizenship here last night, Dr. Charles Austin Beard, distinguished author and historian, formerly professor of political science in Columbia University, asserted that "the age of Jeffersonian expansion has closed—that there is no more free and unoccupied land to be seized or bought or occupation by the American people. Explaining that his views were his personal opinion based on his studies and travels, Dr. Beard declared that "the addition of other territories occupied by alien races that cannot be assimilated to American citizenship is a betrayal of American nationality, however large the profits reaped by investors and manufacturers from such operations. "Congress has declared a restriction of immigration based on nationality; let it extend the principle, and apply it to peoples that cannot co-operate in the maintenance and development of American society," he urged.

"This means," added Dr. Beard, "absolute independence for the Philippines and also for Porto Rico." He pointed out that thousands of Perio Ricans have been pouring into the United States as American citizens only to find themselves unemployed amid the miseries of our great cities.

Imperialism, continued Dr. Beard, "is up a blind alley and doomed. It is impossible to use armies and navies to conquer and exploit backward peoples without incurring the risks and ruin of world wars. It is impossible to expand continuously American foreign trade to take care of the so-called surplus of our expanding industries and provide sure investments for American capitalists. International commercial rivalry will not permit it."

IN WET AND DRY FIGHT

Drys And Antis Gird For Repeal Fray With Battle Lines In 48 States

Washington—(AP)—As the prohibition battle shifts from Capitol Hill to separate fronts in 48 states, forces of attack and defense alike enter the fray with expressed confidence of victory but a healthy respect for the "enemy." "We do not concede a single state," says a spokesman for the Association Against the Prohibition Amendment. "If the state conventions represent the real opinion of the people, we are bound to win." is the opinion of an Anti-Saloon League official. As news was flashed from the capitol that the house had passed the resolution to submit the repeal question to the states, plans for the separate battles in the states already were being laid in the red brick headquarters of the Anti-Saloon League across the park. In nearby headquarters of the anti-prohibitionists meanwhile, there was taking shape a drive by which it is hoped to "jam through" approval of the repeal resolution within a year. Prohibition defenses may be expected to undergo their hardest onslaught on the eastern front, where the Anti-Saloon League considers wet sentiment strongest. In the south and west the drys count on their most reliable support. The anti-prohibition offensive probably will be concentrated in about 20 states that are considered supporters at present of the dry cause. Among these states the Association Against the Prohibition Amendment lists in the south, North and South Carolina, Tennessee, Arkansas, Alabama, Mississippi, Kentucky, Georgia and Virginia; in the west, Kansas, Oklahoma, Iowa, Idaho, Utah and North and South Dakota; east, Vermont and Maine. The "general staff" of the drys is the national conference of organizations supporting the eighteenth amendment. Chief among its members are the Anti-Saloon League of which Dr. F. Scott McBride is superintendent, Dr. Ernest H. Cherington, director of education, and Edward B. Dunford, general counsel; the Woman's Christian Temperance Union, Mrs. Ella A. Bolen, president, and the Women's National Committee for Law Enforcement, Mrs. Henry W. Peabody, president. Directing the fight for repeal will be the United Repeal Council, "under the leadership of Pierre S. Du Pont. Affiliated with it are the Association Against the Prohibition Amendment, Jouett Shouse, president; Women's Organization for National Prohibition Reform, Mrs. Charles H. Sabin, national chairman; the American Hotel Association, The Crusaders, Veterans' Repeal League, Inc., and Voluntary Committee of Lawyers, Inc.

The plan to have the question of repeal submitted to state conventions rather than to the legislatures is regarded by the Association Against the Prohibition Amendment as favorable to its cause. The convention plan also is held to be an advantage by the Anti-Saloon League, at least in states whose legislatures are wet. For this plan, it holds, gives the dry another chance to seek and perhaps win dry support. Actions by some states in the November 8 election, by which state dry laws were repealed or repeal of the eighteenth amendment advocated, are not regarded as necessarily significant by the Anti-Saloon League. The league believes such action in many cases was taken as the result of what it terms political pressure and "machine control" of the elections. The Association Against the Prohibition Amendment probably will concentrate its forces in the "doubtful" states.

Late News Flashes

Today In The Legislature. Raleigh, Feb. 24.—(AP)—The lower division of the General Assembly was tied up for more than an hour today during consideration of its local bill calendar while Representatives Grant and Newman of New Hanover, disagreed over the Grant bill that would allow consolidation of the Wilmington and New Hanover governments. The bill was finally passed. With 32 state-wide bills on its calendar predictions of night sessions were frequent. In the Senate the Ehringhaus endorsed bill to amend the laws relating to tax penalties so as to abolish those of the last five years, and allowed persons whose property had been sold for taxes a period of five years was discussed for an hour but practically no opposition was expressed. The measure passed its second reading.

WILL REQUIRE UNEMPLOYED RAISE GARDEN

Will Make Effort To Place As Many Relief Subjects As Possible On Farms

Representatives of the various relief organizations in Pitt County and the County Board of Agriculture met with Charles A. Sheffield, assistant director of agricultural extension at State College, Thursday afternoon. They discussed in detail the relief gardening program in Pitt County. This program has been worked out by the State College Agricultural Extension Bureau and the State Relief Office. This gardening is intended to supplement and eventually to supplant food relief. It is only by forcing the indigent people to grow their own food that they can be made self-supporting. The major objectives of this garden program are: First: To get every rural relief subject to grow foodstuff enough for spring and summer use; and conserve enough for winter use. Any relief subject given an opportunity to grow a garden, and failing to do so, will be given no further consideration by Relief Agencies. The garden seed are to be furnished them and the gardens to be grown under the supervision of the County Farm Agent and his workers in co-operation with the heads of the various Relief Agencies. Landowners are especially urged to co-operate with them in providing every indigent family a plot of land large enough to grow a year's supplies, about an acre being needed. The second objective is to provide community gardens for the city relief cases. This is to be worked out by the city—the Relief Association (Continued on Page Four)

Recover Goods Stolen Last Night Together With Other Stolen Property and Seize Quantity Liquor

Local police and county officers had quite a time of it from midnight until early today with the capture of two storebreakers, recovery of goods stolen last night from the store of J. A. Watson, arrest of a party wanted for former gasoline robberies here, recovery of several automobile wheels and tires stolen from this city at various intervals in the past few weeks, seizure of several gallons of liquor and the arrest of the owner of same. As a result of these few hours of activity four persons are in jail here awaiting hearings on the various charges.

It all came about when the night policeman making his rounds about midnight in the business section noticed that the side door of the J. A. Watson store on the corner of Fifth and Washington streets was standing open. He immediately made his report to headquarters and Mr. Watson, owner of the store, was called to the scene. Upon examination it was found that the robbers had taken a thousand pounds of sugar, a case of cigarettes, about 30 more packages of cigarettes from the showcase and made their getaway. An investigation immediately got under way and about four o'clock two young white men, Luther Dunn and David Dudley, who reside on the north side of the river, a short distance from the city, made their appearance at a local cafe to get something to eat, and acting suspiciously they attracted the attention of one of the local officers. The young men were apprehended and about 25 packs of the stolen cigarettes were found on Dunn's person and 25 pounds of sugar in the car used by the young men. The boys at first denied any connection with the robbery and officers went to the neighborhood where they resided to make further search for the stolen property. In addition to finding the same more of the cigarettes, the officers found at Dunn's house several automobile wheels and tires alleged to have been stolen in a series of robberies in this city during the past few weeks. Having in their possession a warrant for Paul Griffin wanted for a part in recent gasoline stealings in which Dick Everett last Monday was bound over to county court by Mayor Flanagan, the officers being in the neighborhood of Griffin's home, proceeded there to make the arrest. As they arrived near the premises they saw George Griffin, father of the boy, showing fear lest something be discovered and prompted by this the officers made a search of the premises that resulted in the capture of several gallons of liquor and the senior Griffin, too, was taken. COMMITTEE IS FOR SALES TAX

Joint Finance Committee Says Some Form of Sales Tax Necessary

Raleigh, N. C., Feb. 24.—(AP)—The General Assembly's two finance committees today voted 10 to 10 that it was the sense of that group that the State budget could not be balanced without a levy of some form of sales tax. "It is the sense of this committee that it can find no practical and feasible means to balance the budget without some form of sales tax" was the motion adopted. The committee refused this morning to reverse its position taken a month ago that the revenue from some source other than ad valorem tax on land must be found to replace the 15 cents levy on land for school purposes.

Hold Two Youths In Lindbergh Case

Roanoke, Va., Feb. 24.—(AP)—Two defendants charged with an attempt to get \$50,000 out of Col. Charles A. Lindbergh by threats of harm to his second child were bound over to the Federal Grand Jury meeting next July, when the case was called before United States Commissioner here today. In continuing the case, the commissioner allowed Joe Bryant, nineteen, and Norman Harvey, 26, who have been in jail since they were arrested after Bryant attempted to cash a \$17,000 planted check, bond of \$1,000 each.

See Little Hope For Mayor Cermak

Cermak Growing Weaker. Miami, Fla., Feb. 24.—(AP)—His strength drained by complications following the bullet wound received from the gun of Giuseppe Zangara, assassin, Mayor Anton J. Cermak of Chicago, today was given little chance for recovery. His physicians labored to bolster up his exhausted vitality through intravenous injections. They were in constant attendance at his bedside. Dr. Frank Jirka, Cermak's son-in-law, said he had but little chance to live. Jirka said Cermak was critically ill, his pulse was acting very strangely, showing that he was making a desperate effort to live. Even when he is asleep, Jirka said, he is talking about the possibilities of paying Chicago employees, especially the school teachers, policemen and firemen.

State In Receipt Of Official Notice Of Dry Law Repeal

Raleigh, N. C., Feb. 24.—(AP)—Governor J. C. B. Ehringhaus today laid on the corner of his desk a notice from the Secretary of State of the United States to North Carolina that Congress had voted to submit the repeal of the Eighteenth Amendment to the States. "I have just laid it over on the side of my desk to think about it and what to do with it," the governor said. He said he intended to notify the Legislature that he was in receipt of the Blaine resolution passed by Congress, but that he did not know when and what recommendation, if any, he would send with the measure.

STAGE HOLDUP NEAR THIS CITY

Traveling Man Is Victim Of Holdup Men On Bethel Highway last Night

N. W. Laucian, traveling man of Benson, was the victim of a holdup on the Bethel highway about half way between Greenville and Bethel early last night, the robbers relieving him of \$26 in cash. Shortly after eight o'clock Laucian arrived in this city and reported the holdup to officers and returned to the scene of the robbery with Sheriff Sam Whitehurst, but the robbers having long departed left no clues as to their identity. According to Laucian's story, he had pulled his car to the side of the road and alighted for a moment when another car stopped alongside and two men getting out asked him if he had any trouble. He stated that he advised them that there was nothing wrong and at that juncture one of the men, a young man well dressed, covered him with a gun while the other relieved him of his cash. Apparently money was all that they wanted as they did not take his watch or other personal effects. Keeping him covered with the gun the men got into their car and then ordered him into his own and told him to get going toward Greenville. Laucian obeyed the order and the holdup men sped away in the opposite direction.

MCD. HORTON PASSES AWAY

Prominent Pitt County Citizen Dies at His Home in Farmville Early Today

McD. Horton, 61, one of Pitts County's most prominent and highly esteemed sons and beloved citizen of Farmville, died at his home at 3:30 o'clock this morning after an illness of several weeks. Funeral services will be held tomorrow morning at 11 o'clock with the following ministers officiating: Rev. J. R. Roberts of Greenville, Primitive Baptist; Rev. C. B. Mashburn, Christian Disciples; Rev. J. Q. Beckwith, Jr., Episcopal, and Rev. H. L. Hendricks, Methodist. Interment will be made in Forest Hill Cemetery, Farmville.

Mr. Horton was the youngest son of the late M. Donald Horton and Lanie Tyson Horton. He was reared throughout the State as a business man of outstanding integrity and prominence, his genial and cordial nature, together with his splendid qualities of head and heart winning for him a distinct popularity among varying classes of people who came within his acquaintance.

He served his fellow-citizens in the State Legislature, as County Commissioner, and in several town offices, faithfully and well for many years. He was a charter member of the Farmville Lodge Knights of Pythias and the Rotary Club, and a member of the Washington Elks Lodge. **GENERAL SALES TAX SHOULD NOT PASS**

Despite the predictions that the Joint Finance Committee would definitely decide on the eight or six months school question yesterday and get down to real business so that the legislature might finish its task within a reasonable time, today finds the matter again in a muddle with the Senate Committee voting in favor of the eight months school and the House Committee standing 14 to 13 for the six months term.

During the last campaign when the present legislators were seeking the support of their constituents they promised the most possible tax relief and, as we see it, the eight months state operated school paid for from revenues derived other than through the general sales tax is the best way that legislators can carry out their promises to the people. The eight months school operated by the state can, we believe, be carried on more economically than under the plan of the state operating for six months and then the various districts carrying on the balance of the term, and we are likewise convinced that there are sufficient sources of state revenue to get the money needed to carry out this program.

Of course there are those in the assembly apparently representing interests that are determined that no further tax shall be placed upon said interests regardless of how much money they make or regardless of how little other taxpayers are able to pay in taxes, and these forces are determined that there shall be no tax other than a general sales tax placing the burden upon the bare necessities of life just as much as upon those most able to pay.

HELPING SPEECH  
 (By Alice Judson Peale)

The average child begins at about 18 months to try to make its wants known through words rather than through crying, reaching and pointing as heretofore.

At this time it is well to encourage the new tendency by listening appreciatively and answering immediately. The association thus set up in the child's mind causes him to try again, for one tends to repeat what has already brought satisfaction.

If you want further to help your child develop his powers of speech you must say for him the words in which he can make his wish known when he merely points or cries and encourage him to repeat these words after you before you grant his wish. This, however, must not be forced.

The cause for which the staff is working is the student loan fund and it is to be hoped that enough will be realized from the plays to keep several students from being forced to drop out of college because of lack of funds.

### D. A. R. History In Library.

The State D. A. R. Conference held at Greensboro in March, 1930, found that no permanent record was being kept showing the work done by the individual chapters in the state. To correct this they planned to gather histories of the 62 chapters in the state and publish them in book form, the first volume to close with 1930. At the close of each decade an additional volume should be prepared. Volume one bears the date 1930, in 1940, Volume two should appear and Volume three in 1950.

The 1930 volume compiled by Gertrude Sloan Hay, state historian 1930-1933, has been placed in Shepard Memorial Library by the Greenville Patriots Chapter D. A. A. They have given also a Roster of Soldiers from North Carolina in the American Revolution. This copy is number 85 of the autographed edition of this book and contains the signatures of Mary L. Jackson Cooper, state regent, and Gertrude Sloan Hay, state historian. Both books are printed on an all-rag paper and are beautifully bound in blue with gilt lettering and decorations, including the official D. A. R. insignia. This is a splendid addition to the reference shelves in the library.

Ernul, taught a school perhaps at that time but that was in a building still standing in the neighborhood of Arthur, so cannot be credited to Ballard's, though some of the children here attended this school.

### Call Meeting Stockholders Of Farmers Bank

Boyd B. Massagee, liquidating agent of the Farmers Bank, under the direction of Guernsey P. Hood, State Commissioner of Banks, has called a meeting of all stockholders, depositors and claimants of the bank to be held in the courthouse at 8 o'clock on the evening of March 1. The meeting, according to the announcement, is for the purpose of placing before these interested parties a full statement of the affairs of the closed institution and to devise a plan for the completion of the liquidation.

The Farmers Bank, the first bank failure ever to occur in Greenville, failed to open its doors for business on February 1, 1930. Since that time the affairs have been in the hands of liquidating agents.

STATE ACTION ON DRY REPEAL PROBLEM NOW

Much Discussion As To Extent Congress Can Go In Case States Fail To Act

By HERBERT PLUMMER Washington, D. C., Feb. 24.—In the wake of Congress' approval of the prohibition repeal move there has been started on Capitol Hill a wave of discussion on just how the various States would go about ratifying or rejecting the proposed amendment.

There are many different opinions. Recognized experts on constitutional law are finding themselves stumped on the seemingly simple question of:

"When and what is a State convention?"

The whole argument is occasioned by the fact that for the first time in the history of the country State conventions are proposed as instruments to deal with the Constitution. Whether the Congress or the States have the authority and jurisdiction is the question.

A Test For Congress

As a matter of fact, the whole discussion at the moment is probably nothing more than academic. With forty-one State legislatures in session and two more scheduled to meet soon the question of jurisdiction may never be raised.

However, should there be a disposition on the part of some of the State legislatures to act tardily or even to shelve the proposed amendment entirely, then undoubtedly Congress might test its power to act.

In such a case two schools of thought, each represented by expert constitutional authorities, would be heard from.

The first, headed by A. Mitchell Palmer, Attorney General in the Wilson administration, says Congress has the power to set up the conventions. Representative Beck, of Pennsylvania, a former solicitor general, holds that the States alone have such power.

So many arguments are heard on each side that it itaves them all confused.

Secretary's Responsibility

The Secretary of State might, after all, be the one to "put on the spot" in the controversy.

It is he to whom Congress would forward the proposed amendment with instructions that it be submitted to the States. In the absence of instructions from Congress he would have to be guided by whatever opinion he found the most convincing.

Then, too, there are some States who have as a part of their constitution the provision for the initiative and referendum. In such States should the legislature refuse to act a sufficient number of citizens could force action themselves.

Winston-Salem, N. C., Feb. 24.—(AP)—Helen Moyer, nineteen-year-old high school girl charged with stealing two diamond rings from Mrs. H. H. Scott, was dismissed in municipal court here yesterday when Mrs. Scott admitted consulting a fortune teller to learn where the jewelry might be.

The girl denied the charge and said she had devoted her time to studies at the Scott home where she was being cared for.

Mrs. Scott admitted walking in her sleep and going to see fortune tellers so Judge Watson advised her to return home, "spit in the palm of your hand smack it" and the direction the spittle flies will lead to the lost jewelry—according to tradition.

Trial Of Barry Presents Senate Puzzling Problem

By HERBERT PLUMMER Washington, D. C., Feb. 24.—Curiously enough, although the Senate's trial of David S. Barry, its Sergeant-at-Arms, on charges of libeling members of Congress proceeded in informal fashion, nevertheless it followed very closely the long-established pattern for impeachment of public officers.

Charges of impeachment by law must originate in the House of Representatives. Then, if they are sustained, the one charged is called before the bar of the Senate for trial.

Quite by accident, perhaps, this is much the way the 73-year-old Barry found himself on trial before the Senate.

His statement appearing in a magazine that "there are not many Senators or Representatives who sell their votes for money, and it is pretty well known who they are," was first brought to the attention of Congress in the House.

It was the fiery LaGuardia of New York who first read the lines on his side of the Capitol only a few minutes after the House had convened for the day's session.

And it was LaGuardia's demand made amid applause from his colleagues, that Mr. Barry make good or retract the statement and then apologize to this House that launched the Senate on its way toward calling its existence as a court of impeachment, but this is the first instance it has ever had to deal with such a charge. Heretofore the grievance has been malfeasance in office.

Moses, of New Hampshire, President pro tempore of the Senate, openly expressed the situation when he said that the chair was without precedents for procedure.

Not since 1912, when the Senate impeached Judge Robert W. Archibald as an Associate Justice of the United States Commerce Court, has it called a person before its bar.

A Note of Sympathy

It was a memorable scene, a dramatic climax to one of the most unusual sessions of the Senate in history, to see the stern, erect figure of Barry with his bristling white mustache facing that battery of irritated and indignant Senators.

It is truly terrifying to be subjected to a grilling such as Norris of Nebraska, Walsh of Montana and Reed of Pennsylvania—to mention only a few—gave Barry.

But with it all as harsh as it sometimes appeared to be, there seemed to be a note of sympathy for him. His fourteen years in the service of the Senate seemed to be not entirely forgotten.
