

GERMANY WITHDRAWS FROM LEAGUE OF NATIONS

Nation Refuses To Take Further Part In Confab To Reduce World Arms

ACTION CAUSE OF SADNESS OVER WORLD

German President Issues Decree Dissolving Reichstag and All State Parliaments; New Elections Called For November 12; Washington Officials Confer Upon Being Advised of Action

(By The Associated Press.) Germany notified the world today that it would leave the League of Nations and the World Disarmament conference because it considered itself unable to participate further as a second class nation deprived of justice in the negotiations which could lead only to new decisions.

Announcement of the action was made in Geneva with consternation and sadness and the dictum was hailed in Paris as the gravest news in twenty years.

Simultaneously with Chancellor Hitler's action a decree was issued by President Von Hindenburg dissolving the Reichstag and all state parliaments and setting a new Reichstag election for November 12. This was done so that a vote of all Germans by endorsing the Nazi members of the Reichstag would demonstrate to the world the country's solidarity behind Chancellor Hitler in the crisis.

The German decision was first in a dispatch last night from Geneva when it was indicated that the German might leave the conference and even the League of Nations because English and French opposition to her claim for defensive armaments.

Officials at Washington were taken by surprise by the Hitler move. They viewed it as making the task of reconciling the differences of the nations views on disarmament difficult if not impossible.

It was said that effort would be made to renew the good offices of the United States to change the German decision.

London official circles declined to comment. It was indicated when the Hitler announcement was received that possibilities of the conference would be discussed.

Explains Germany's Position

Berlin, Oct. 14.—(AP)—Germany's chancellor, Adolf Hitler, said tonight in a speech to the world that Germany is ready to go to the limit in disarmament but the German demand for equality with other nations are to be armed must be sidetracked.

"If the world decides to remove all weapons to the last machine gun," the speaker said, "Germany will fall in line and the same applies to other categories of weapons."

He warned if certain weapons are allotted to other powers the German nation is not ready to "permit ourselves to be excluded therefrom as a nation of inferior rights."

The chancellor furthermore said there was no possibility of territorial conflict with Germany's neighbor, France, as far as the Reich is concerned, for after the return (Continued on Page Four)

TWO MASONIC LODGES MERGE

Greenville Organizations Consolidate at Meeting Here This Week

Consolidation of the two Masonic lodges of Greenville was announced by members of the organization today, and the action now awaits authorization of the Grand Master of North Carolina before finally becoming effective.

MONTGOMERY RAPS STATE SCHOOL LAW

District Governor of Kiwanis Speaks at Divisional Meeting Last Night

Asserting the new school legislation in effect in North Carolina at this time had set public education back ten years, District Governor William Montgomery, of Wilmington, spoke at a meeting of Seventh Division Kiwanians at the Woman's club here last night.

The speaker described the new school act as the most deplorable legislation that has affected education in this state in many a year, and urged Kiwanians to look forward to the next session of the Legislature in the hope of effecting a change in the situation.

He said he was unable to see the wisdom of placing teachers on the same salary plane with untrained labor when they were charged with the responsibility of directing the educational training of the youth of the land after spending both time and money in preparation for the responsible task.

He stated the correction of the laws of the new school law was a special objective of district Kiwanians and urged his hearers to give due consideration to the question.

Referring to the activities of Kiwanis, which he pictured as a philosophy of life, he said the district was backing the National Recovery Administration in its efforts to bring about better economic conditions in the country and impressed his hearers with the importance of backing the NRA to the limit of their resources.

He dwelt at length on the ideals of Kiwanis and the fine work the organizations in various parts of the country were accomplishing in behalf of underprivileged children, vocational training, and referred to student loan funds, hospital and milk funds, and work among the (Continued on Page Four)

FEWER WARNINGS AND MORE ARRESTS

According to announcement from Raleigh, Captain Charles Farmer of the State Highway Patrol has ordered his men to make more arrests instead of giving warnings to motorists and letting them continue on their way. It has been the policy of the highway patrol to call attention of motorists to minor violations of the law and letting them go, making arrests only when it was deemed absolutely necessary but the ever increasing number of accidents in the state has caused Captain Farmer to order his men to be more strict than heretofore and to make more arrests if necessary to cut down the number of accidents.

The mill overlooking Lincolnton on which this famous Revolutionary battle was fought is just a half mile north of the county courthouse. Lincolnton people will ask Congressman Bill Winkle and Senators Bailey and Reynolds to lend their aid to the project. McCarty, construction engineer in charge for the government. A total of 392 32-foot piles in steel casing are to be laid, the first use of the new, modern method in this region. While the laborers were digging up the dirt under the historic structure, where once President George Washington was entertained, they unearthed a 24-foot cistern where the colonial residents used to store their drinking water for the summer.

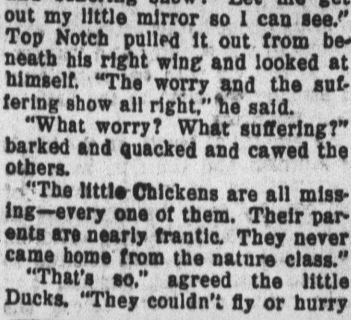

Gold Fever Attacks Philippines

By EDWARD E. BOMAR Manila, P. I.—(AP)—A gold rush of big proportions was stimulated both in the mountains of northern Luzon and in Manila by the order of President Roosevelt opening the higher-priced foreign markets to the output of mines in the United States and possessions.

In the mountains the activities of prospectors brought a dispute with Igorote tribesmen which threatened to develop violence.

At Manila millions of shares of stock in concerns with actually producing mines and in others more recently organized to exploit claims have changed hands.

In one recent week transactions in mining shares on the Manila stock exchange totalled 2,250,000 shares.

The par value of most of the securities is small, ranging from five to fifty cents in American currency, but the quotations on the stock of the two chief producing concerns, Benguet Consolidated and Balatoc Mining, reached up to \$18 a share.

The stocks are distributed among some thousands of Filipinos and Americans, but some of the recent speculative buying has been for Hong Kong and Shanghai purchasers, brokers stated.

Visions of war between the Igorotes, diminutive half-wild tribesmen, and the "wild cat" prospectors reminiscent of the clashes between prospectors and Indians in the American west of another day, were aroused by urgent appeals from the Bontoc country to Manila representatives. Provincial and cantonary officers were directed to take steps to prevent an outbreak.

The prospectors, it was claimed, trampled the laboriously constructed rice terraces of the Igorotes on the mountain sides in staking claims and digging tunnels.

Representative Hilary Clapp, himself an Igorote, went to the Bontoc section in response to a report that 4,000 of the tribesmen were disaffected, and that 300 had threatened to attack laborers at one tunnel.

The known gold-producing area is near Baguio, a mountain resort about 150 miles north of Manila and it has been staked out for many years. Several thousand workers are employed.

JAPAN'S SPECIAL RIGHTS VACATED IN MANCHUKUO

Changchun, Manchuria (AP)—Japan intends to set an example to other powers by being the first to relinquish extra-territorial rights for its citizens in Manchukuo.

September 1, 1935, has been set as the date on which Japanese consular court will close.

Also on that date administrative powers in the South Manchuria Railway zone, together with rights relating to taxation, will be handed over to the new state.

In preparation for these events the Manchukuo government has hired 1,000 Japanese policemen to instruct natives in law enforcement duties.
