SEVERAL CHILDREN DIE IN TRAIN-BUS COLLISION

Forty Injured As Train Hits School Truck

BUS DRIVER REPORTED AS BADLY HURT

**Wildest Confusion
Prevails at Scene of
Accident Six Miles
From Crescent City,
Fla.; Screams of In-
jured Children
Mingle With Cries
of Parents Attempt-
ing Rescue; Many
Rushed to Hospitals**

Crescent City, Fla., Dec. 14.—(AP)—At least seven elementary school children were killed and between 30 and 40 others injured, some of whom were expected to die, when a freight train crashed into a school bus six miles south of here this morning.

None of the dead or injured were immediately identified as parents and others crowded about the wreckage in an effort to find their little ones and for aid and rescue work.

There was the wildest confusion with cries of parents mingled with screams of the injured children. Bodies and parts of bodies were strewn along the railroad right-of-way for a hundred yards.

The driver of the bus, D. R. Niles, was among those critically injured. All available ambulances from Palatka, DeLand and Crescent City rushed to the scene, loaded quickly with dead or injured, and hurried to hospitals, complicating a quick check of the casualties.

TO EXHUME COX'S BODY

Second Bullet Fired Into Murdered Man's Body To Be Removed Today

The body of Floyd Cox, who was mysteriously slain on the old Stokes road several miles north of Greenville Wednesday night of last week, will be exhumed under the direction of Coroner A. A. Ellwanger this afternoon in an effort to find a second bullet fired into his body by his slayer.

One bullet was removed from the body at a post-mortem examination shortly after the slaying, but officers decided the second bullet would be necessary for them to be able to continue the chain of evidence picked up during the investigation.

Heber Ayers, young white man living near the filling station where Cox was employed, is held in the county jail in connection with the crime. He was arrested when Sheriff Whitehurst said the bullet taken from Cox's body was the same caliber as Ayers' pistol. He also stated that footprints found at the scene of the murder were similar to those of the prisoner. Ayers stoutly denied any knowledge of the slaying until after the body was found.

The exhumation was scheduled to begin at 2 o'clock, and probably will be completed about 4 o'clock.

TONG WARFARE BREAKS OUT AT MONTREAL

Several Chinamen In- jured In Disturb- ances Over Gambl- ing Territory

Montreal, Canada, Dec. 15.—(AP)—Police feared a Tong war outbreak today when wild disturbances in Chinatown sent six Chinamen to hospitals with injuries and sixteen more to police stations for questioning.

Three of the injured were in serious condition.

The disturbance broke out in the Dat Coon Club in the heart of Montreal's Chinatown. Police explained that rival factions of Tong had been in dispute for some time over gambling houses, each accusing the other of "muscling in" on their territory.

No guns were used in the fighting. Chinese wounding knives supplemented, by iron bars used as clubs.

Expect Report Soon From Ballistic Ex- pert on Pistol in Mur- der Mystery

Sheriff Sam Whitehurst returned last night from Washington City where he went to confer with a ballistic expert regarding bullets taken from the body of Floyd Cox, who was mysteriously slain on the old Stokes road several miles from this city Wednesday night of last week.

The sheriff was accompanied to the national capital by Lieut. Lester Jones of the State Highway Patrol, who also had some official business to look after there.

Sheriff Whitehurst said the expert in ballistics had not completed his examination of the bullets and pistol belonging to Heber Ayers, held in jail here in connection with the slaying of Cox, when he left Washington, but probably would make a report in the next day or so.

The sheriff at an inquest conducted the latter part of last week said the bullets were of the same caliber as that of Ayers' gun. However, he wanted to be certain the bullets were fired from the same pistol and that is the reason he appealed to the expert on projectiles.

The two officers did considerable getting about while at the capital and visited several points of interest. Chief Jones induced the sheriff to accompany him to the bureau of identification in the Department of Justice building so they might properly identify one another before returning home. The sheriff was rather recalcitrant about that identifying business, but the chief said he liked it after he got started.

Chief Jones, who fell at his home here several days ago and severely cut his hand, knocked a hole in the pavement as he left the Justice Department building. It had begun sleeting while he was in the building, and when the chief stepped briskly out into the open, his feet refused to stay with the other part of his body, and he hit the pavement with a resounding impact that jarred Washington. And when you jar the capital you are doing some jarring.

The sheriff managed to keep his feet and head, too, under control, so he returned home in tip top condition and with plenty of laughs on the chief's inability to control his feet.

NEW RULING ON SALES TAX

Revenue Department Straightens Out Points in Wholesale Lumber Business

T. T. Hollingsworth, deputy tax collector, has received a new ruling from the Department of Revenue. Sales made by a lumber dealer or hardware store to a contractor, to be used by such contractor in the building of structures under contract with another, when such sales are made in what is generally known as a wholesale manner, in wholesale quantities and at whole prices, should be treated as wholesale transactions and the wholesale tax of one twenty-fifth of one per cent (1-25 of one per cent) be applied and that such sales would be subject to the 3 per cent (3 per cent) retail tax. This ruling applies to brick mortar, cement, paint, and other building materials. An individual who buys a small quantity for their use is subject to the regular 3 per cent sales tax.

The Department of Revenue has received numerous inquiries asking are churches exempt from paying sales tax. The Department has ruled that churches are not exempt from paying sales tax, and the merchants are instructed to collect 3 per cent on all sales made to churches.

Late News Flashes From Over World

Leaf Market Will Suspend Work Friday
The Greenville tobacco market today was leading all markets of the bright leaf belt by over a million pounds, it was revealed by records of the various markets published yesterday.

The market here jumped into the lead shortly after the enforced holiday and has maintained it ever since.

It was indicated that suspension of sales for the Christmas holidays Friday would find the total poundage standing at over 68,000,000 pounds.

While the market is scheduled to resume work January 2, it has been suggested by some of the other markets that this date be set back to the 9th. Although this has not been definitely decided, it was said Greenville would abide by action of the remainder of the markets.

The official report of K. W. Cobb, supervisor of sales, made public this morning showed that the market yesterday handled 556,076 pounds of leaf and paid out \$89,977.57 with an average of \$16.18 per hundred pounds.

Season sales amounted to 66,449,472 and farmers have been paid \$11,198,092.53.

It was stated there was a million pounds of leaf on the floors of the various warehouses today with indications that sales would be completed during the late afternoon. Floors will then be cleared and gotten in readiness for the heavy offerings expected to be poured on the market tomorrow as growers make an effort to provide themselves with sufficient funds to take care of the demands for Santa Clause.

Crime After Repeal? It's Up To The Public

Discussion of the crime situation after repeal of the eighteenth amendment can only be predicted. And prediction is always hazardous. But the purpose of forecasting is the practical one of trying to foresee what may happen, and of forestalling with due vigilance any evils we can forestall through knowledge of past experiences.

The illicit sale of liquor aided by lack of public support of prohibition did three things to the world of crime.

1. It brought new criminals into the field.
2. It transplanted many of the more fertile-minded, bolder criminals into easier and more profitable work.
3. And, most important, it permitted the former safecracker and stick-up man, abhorrent types, to put their feet up on the same desk with responsible citizens.

It was not unusual for "John Smith," a former safe-cracker turned bootlegger, to visit a business man and end up in conversation. They actually sat down and talked.

The criminal became less of an outcast. He came to know politicians and some types of law-enforcement officers who were not one-hundred per cent scrupulous and yet not wholly dishonest.

Bootleg Taint Politics

Before prohibition these politicians and officers would scarcely have known a safe-cracker and certainly would not have associated with him. But they did, and do associate with bootleggers. The criminal forced the officer from a twilight zone into actual corruption.

The result was that bootleg rings had power with politicians. Now, recent experiences lead me to believe that this alliance is disintegrating. Such political alliances of criminal with law-enforcement agent are breaking up. Crime conditions are cleaning up in metropolitan areas because revenue is slipping out from under the world of crime.

Here is an example. In the recent trial of Roger Touhy on a charge of kidnaping in St. Paul it developed that Touhy wanted to sell his house.

A Home Fit For Royalty

That home was like a baronial estate. He had shifts of guards, a swimming pool, his own telephone system. He had offered his best plant equipment for sale at \$5,000 and the plant had a capacity of 72,000 barrels a year. He must have seen the handwriting on the wall for his type and for his form of making a living.

Touhy had been picked up in July with a party in a high powered car that contained six guns which would have been too big for Jesse James and a bag of ammunition that one man could not have carried. Why did he have them?

Generally, that situation is one we must guard against. We prophesied that these liquor barons would be turning to some other form of work. Now we have the evidence that points in that direction. That means we must be all the more on the guard.

But the department of justice is preparing by making a complete record of all bootleggers in the various areas. When and if crime breaks out in other directions we will be prepared to bring the criminals in.

KILL BEAR WITH KNIVES AND THEN HE IS STOLEN

Asheville, N. C., Dec. 1.—(AP)—After a fight lasting more than fifteen minutes, two hunters Sunday killed a 400-pound bear near Asheville with their hunting knives, and when they left the animal to stalk a deer, the bear was stolen. F. T. Hicks, of Asheville, and Seb Jones, of the Avery's Creek section, were the hunters.

Mr. Hicks said the fight took place in a dense laurel thicket, and the bear fought furiously but the thicket hampered his actions. The hunters were on government land and had left their guns at the boundary line and the knives were the only weapons they had.

WINTER HAZARDS

The coming of winter, as
the National Safety Council
points out, brings with it a
number of varied and im-
portant accident hazards.

Carbon monoxide is one of
the foremost. Motorists
warm up their cars in closed
garages—and the inevitable
result is more unnecessary
tragedies to add to the an-
nual death toll. Another
field where winter brings an
increase in fatalities is in
hunting—nearly one-half of
all firearms deaths each
year occur from November
to February. Careless or in-
experienced sportsmen carry
loaded guns in vehicles,
leave them leaning against
trees, draw them barrel fore-
most after them when cross-
ing fences, shoot at moving,
unseen objects, and so on.
And the accident toll soars.

To most of us, winter
driving presents the princi-
pal hazard. Streets are wet
and ice-covered. Darkness
comes early. Driving prac-
tices that are reasonably
safe in the summer, become
extremely dangerous. The
condition of one's tires,
brakes and windshield wiper
is vastly more important
than at any other time of
the year.

Every motorist should
have his car examined at
the beginning of winter to
make certain it is in good
operating condition. Then he
should remember that only
15 per cent of car accidents
can be laid to mechanical
failure, and that in the bal-
ance the human element
must bear the blame. The
only course to pursue is to
drive with a maximum of
care under any and all con-
ditions—and drive as little
as possible when road and
weather conditions are ex-
ceptionally bad.

In automobiles, in homes
and in sport, winter presents
a thousand menaces to life
and health and property.
Practically every one of
them can be offset by care,
competence and thought on
the part of the individual.

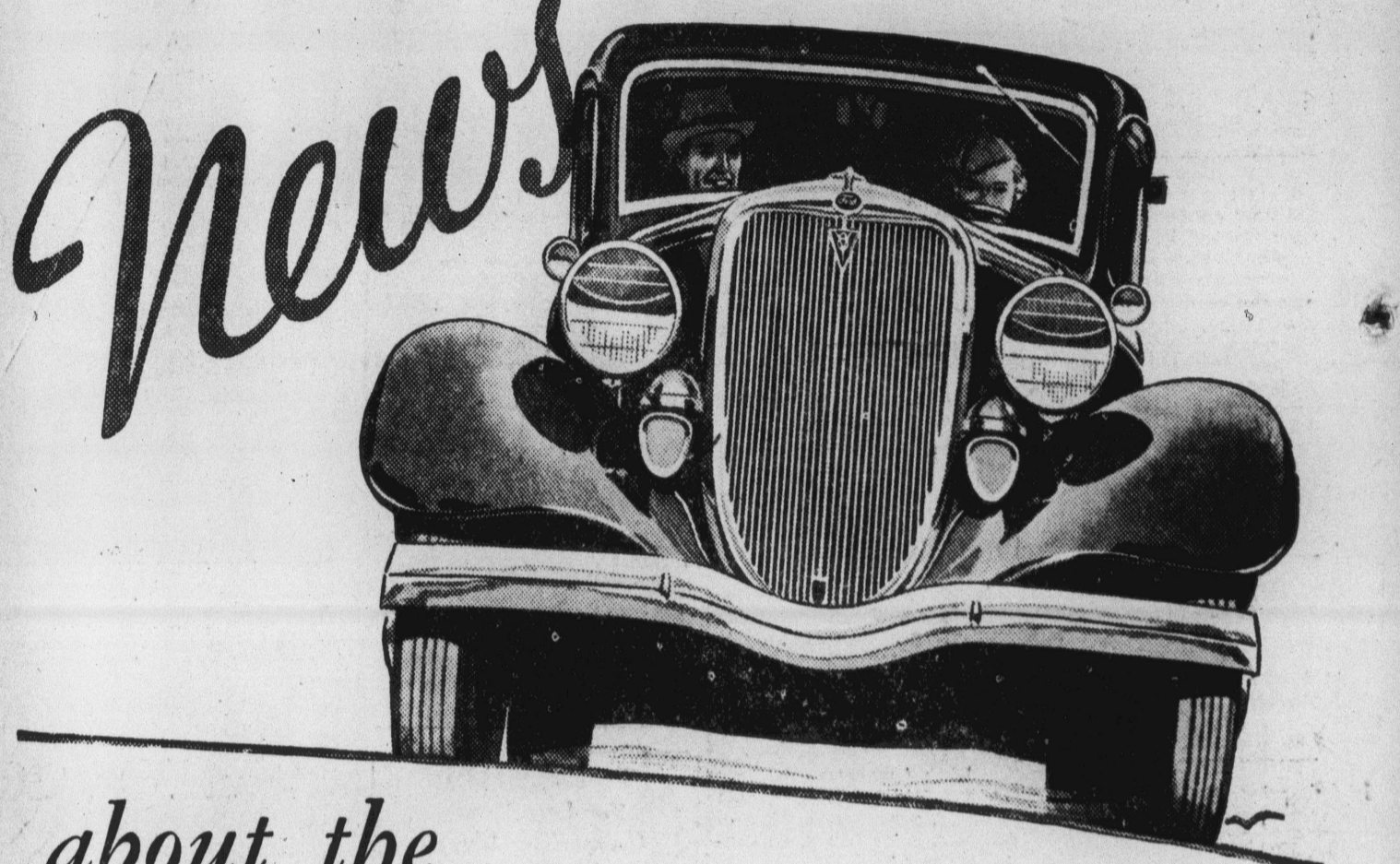

SPORT SLANTS

The retirement of Helen Willis Moody from tennis competition, at least for 1934 and possibly for good, not only leaves the field wide open next year but marks the climax of perhaps as remarkable a career as we have ever had in sports, by man or woman.

Over a period of ten years the Californian, before and after her marriage to Frederick S. Moody, Jr., was not beaten in an American singles championship tournament. True, she did not compete annually without interruption. Illness twice kept her from the lists at Forest Hills prior to the circumstances which brought about her default last summer. But she nevertheless was completely dominant.

Since 1924, Mrs. Moody has met with only one real setback on European courts. That transpired in a special match on the Riviera in the winter of 1926 against Suzanne Lenglen. The famous French girl won in straight sets, 6-8, 6-6. It may seem like so much flag-waving to say that Lenglen was favored by the circumstances of this encounter, also that it came before the American girl was at the full power of her game and experience. The fact is, however, that many observers feel Mrs. Moody in her prime, from 1927 to 1932, inclusive, would have been more than a match for Lenglen or any other women tennis players who ever reached the top.

The point is that for the better part of ten consecutive years, at home or abroad, Mrs. Moody was so far above most of her rivals that her tournament progress became almost monotonously successful. In six years she did not lose so much as a single set at home or abroad. In no other sport, except for something like the long way Jay Gould sustained in court tennis, has there been any greater consistency of individual performance.

Sensible

Mrs. Moody has been criticised for walking abruptly from the championship match at Forest Hills against Helen Jacobs, her long-time California rival, last summer, the idea being that it would have seemed more graceful for Helen the First to have made a more sporting gesture in declining further issue. Instead, she walked away from there as quickly as she could, betraying to the last none of the emotion she must have felt.

To a man who felt, as she said, that she was about to faint, the idea of avoiding further scene must have been paramount in mind. Subsequently she was specific and outspoken in the praise of Miss Jacobs.

Over the span of years' further more, in international competition have followed Mrs. Moody's record for sportsmanship or deportment, or of the courts.

Victory
"From this point of view alone," wrote Piffessor William Lyon Phelps of Yale in a recent magazine (Delineator), "all Americans should be proud of Helen Willis Moody. She won a victory greater than any tennis match. Every American knows that whether Helen appears on the courts in France, Germany, Spain, Belgium or England, she will be a model of behavior."
"She is, then, an example to all of us."
Her greatest conquests are those over her own temperament. She is naturally excitable, hungry for fame, with a mind in constant activity; yet in action she has a face that never betrays emotion. Thus it is possible to achieve complete self-dominance."
