## Important Rebuttal Witness Will Be Used Against Bruno Hauptmann

### STATE MOVES TO TEAR DOWN MONEY STORY

**Hauptmann Faces Further Cross-Examination Today; Mrs. Hauptmann Expected to Follow Husband on The Stand Late This Afternoon; Rebuttal Witness to be Used To Say That Hauptmann Was Evasive About Money**

Flemington, N. J., Jan. 29.—(AP)—The state presented a letter from Bruno Hauptmann to the family of the dead Isador Fisch today in an attempt to blast away Hauptmann's claim that Fisch gave him incriminating money.

Before bringing out the letters, Attorney General David Wilentz cross-questioned Hauptmann closely in his transactions with Fisch in the fur business and stock dealings. One showed Fisch had put \$2,000 in the fur business. Hauptmann claimed Fisch gave him several sums to invest in stocks. These sums, he said, were erroneously computed by the state as among his assets after payment of the \$50,000 Lindbergh ransom. He also claimed that Fisch left the \$14,600 ransom money that was found in Hauptmann's garage.

"Is this one in your records that shows that Fisch gave you one dollar outside of \$2,000?" Wilentz asked Hauptmann.

"No, there is not," Hauptmann admitted.

The letter accepted in evidence and translated by Madison Priest, professor of German literature at Princeton, said:

"Dear Mr. (Pincus) Fisch: A week ago I received your sad information concerning the death of your dear brother and my best friend. Please pardon the delay in my reply. It was however not possible for me to realize that I cannot see Isador again. He was my best friend as I was his.

"He will always remain in my memory for he was the only man with whom I could talk about everything, of private matters or business matters.

"I made the acquaintance of Isador in 1932. We often met in the house of a family we know who live in the same house where he lived (Continued On Page Six)

### Poison Liquor Claims 11 Lives In New York

Gloversville, N. Y., Jan. 29.—(AP)—The total of liquor deaths in this Fulton County glover-making city was increased to 11 deaths with the death of three other men.

Three others are critically ill. The latest victims are Bert Grant, Charles Bates and Alford Reinold, found by police

wandering dazedly in the streets. Arrests appeared imminent as Federal county and city authorities pressed an investigation into the source of the liquor held responsible for the deaths.

"We believe we have the flow of poison liquor stopped for the time being," Third District Attorney Willard Best, said. "There are may be arrests in a short time."

### LIBBY FIGHTS FOR HER SON

**Broadway Actress Seeks Part of Reynolds Millions in Court Today**

Winston Salem, N. C., Jan. 29.—(AP)—It was Libby Holman, black-eyed, black-haired Broadway actress against the field today in the complicated court battle over the disposition of the \$30,000,000 estate left by her late husband, Smith Reynolds, tobacco heir.

Waging a fight to obtain for her two-year-old son, Christopher, a portion of his father's vast wealth, the erstwhile torch singer was confronted by a double challenge to the legality of her message to the Reynolds' son involving, of course, the inheritance right of the boy born of that union.

Smith Reynolds' elder brother, R. J. (Dick) and his two sisters, Mrs. Henry Babcock and Mrs. Charles Babcock, formally raised the question of the validity of the divorce obtained from young Reynolds by his first wife, the former Ann Carolina of the millionaire North Carolina textile family, in a response filed in Superior Court here yesterday.

Ivan Puderjaj, romantic adventurer who married Yugo-Slav army officer, who formed the 43-year-old woman lawyer here more than a year ago, and then sailed away alone, came back in the brig of the U. S. S. President Polk today, guarded by a detective, Jacob Weinstein, of the New York police force.

### SEEK SPEED FOR POTATO CONTROL BILL

**Tentative Draft For Proposed Legislation Set For Coming Tuesday**

Washington, D. C., Jan. 29.—(AP)—Final action on the tentative draft of proposed legislation being prepared by the Farm Administration today, was set for next Tuesday, but speedy action was promised when the measure reached the floor.

Representative Warren of North Carolina, who will sponsor the bill, and who had hoped for introduction this week, said, many difficulties have arisen in the preparation of the proposed legislation.

He said Representative Brewster of Maine, and Bland of Virginia, who are also interested, conferred late today with Farm Administration officials.

Brewster said speedy action was needed as the early Southern potato States are already ready to plant. That section is represented as being highly desirous of immediate legislation.

It was learned that the House Rules and Regulations Committee have promised to expedite action on the proposed control bill before it reaches the floor.

### HILLS ORDERED TO PAY \$250

**Family of Greek Cafe Operator Also Taxed With Cost in Assault Case**

Mrs. Paul Hill, Staff Hill, and Lucille Hill, wife, son and daughter of a Greek cafe operator here, were ordered to pay \$250 to Miss Asaph Corbett, former cashier in the Hill Cafe, in the opening session of the County Court here today.

The defendants were charged with attacking and badly beating Miss Corbett in the cafe early on Monday morning, after the cashier, who accepted a position with another firm, later returned to her old job. Miss Corbett was so badly beaten she had to remain in bed several days, reports stated.

In addition to the payment of \$250, the defendants were also required to pay the cost of action.

Several other cases had been disposed of when court recessed for lunch today. It was indicated, however, that work would continue throughout the afternoon and probably a part of tomorrow before the docket of fifty or more cases is cleared. Judge Dink James presided.

Two or three defendants appeared on charges of driving while drunk this morning and other were fined and had their driver's license revoked or found their way to the roads.

R. H. Warren, charged with driving drunk, was fined \$50 and cost and had his driver's license revoked for six months. He appealed.

Parke Cade was sentenced to six months on the roads after being convicted of driving drunk. He filed notice of appeal to Superior Court.

### MAGISTRATES HOLD MEETING

**Legislative Matters Discussed at Monthly Meeting Here Yesterday**

Legislative matters affecting the county and state were discussed at the monthly meeting of the Pitt County Magistrates' Association at the court house here yesterday.

Colonel Albion Dunn was scheduled to speak to the magistrates, but owing to the small crowd he was asked to wait until the February meeting.

Only about half of the magistrates of the county were actually in attendance. J. I. Smith of Greenville, elected president of the organization meeting held here last month, presided.

It was decided the next meeting of the organization would be held here on the night of February 28, at 7:30 o'clock. The previous two meetings have been held during the day, but owing to the fact that many members found it impossible to attend the day meetings, it was decided to hold the next gathering at night.

Although several other matters affecting law enforcement in this locality were taken up, the magistrates confined attention principally to discussion of legislative matters, not only affecting their immediate vicinity, but the entire state.

The organization is cooperating with other bodies of the kind throughout the state in sponsoring appropriate legislation in the general assembly, especially as it affects the magistrates themselves.

### Merchants Will Offer Sales Tax Substitute

Raleigh, N. C., Jan. 29.—(AP)—Definite substitutes for the retail sales tax will be offered the General Assembly by the N. C. Merchants' Association when it appears before the joint finance committee here tomorrow.

"I don't know if it is known that the association and its friends already have drafted bills designed to get the money where the money is," and at the same time eliminate the retail tax. Those bills will raise, not decrease, the amount of tax collected, but to be raised from the sales tax but at least \$25,000,000 in new revenue.

These definite proposals will be an answer to critics of the anti-sales tax group that while it opposes the sales tax it has offered no substitutes.

It is highly probable that the association will lay before the committee a complete financing program in effect a revenue bill. Instead, however, the association may present to the committee all its plans, that is, the committee would be telling the choice in the levying of taxes. Legislation of whiskey does not figure in the association's plans for new revenue. No proposal along that line will be made by the association itself, although individual spokesmen may follow the lead of some individuals of the Fair Tax Association and suggest such a plan.

### GIRL ADMITS SHE SAW HER MOTHER SLAIN

**Miss Ouida Keeton Says She Helped Employer Dispose of Body**

Laurel, Miss., Jan. 29.—(AP)—The strange story of a daughter who officers said admitted she witnessed the slaying of her mother by her elderly former employer and then helped dispose of her body, was being given close study today by Jones County officers.

Miss Ouida Keeton, 33, has confessed County Attorney Jack Deavers said that she saw her mother, Mrs. Daisy Keeton, 52-year-old widow, killed with an iron poker and then helped the slayer, whom she named as William Carter, 55, prominent Laurel, Miss., business man, dispose of the body which was cut to pieces.

Carter is in jail at Jackson, Miss., charged with murder in connection with the slaying while Miss Keeton is being held in the Jones County jail at Laurel also for murder.

The slaying, officers charged, occurred Saturday night, January 19 at the Keeton home when Carter called on his former secretary.

### CHILD LABOR AMENDMENT DRAWS FIRE

**Growing Opposition To Federal Child Labor Causes Delay in Ratification**

Raleigh, Jan. 29.—Growing opposition to the federal child labor amendment has resulted in indefinite postponement of the introduction of a resolution for its ratification in the North Carolina legislature. Strangely enough, most of the opposition comes from Eastern North Carolina and not, as might be expected, from the industrial Piedmont region.

Although the amendment has the approval of Governor Edinburgs and the resolution was scheduled to have been introduced by Representative Ben Cone of Greensboro, a large employer of labor, there has been a marked increasing sentiment in the legislature against ratification.

The East, it appears, is opposing the amendment because of the belief that congressional legislation growing out of adoption of the amendment would prevent farmers using their children's labor. Proponents of the amendment have, however, that it is not aimed at farm and home labor, but at the use of child labor in industry.

Perhaps the greatest enemy of ratification is lack of interest. Because child labor is but little used in North Carolina it is not a live issue in this state. The state is far ahead of most Southern states in that respect because of existing laws and the NRA edict which forbids the use of child labor in cotton mills. For that reason many see no need for further regulation. Others see in the amendment encouragement upon states' rights.

The ratificationists, however, are using North Carolina's near-freedom from child labor as an argument for adoption of the amendment. A uniform federal law would, they point out, place industry in other states employing child labor on an equal footing with North Carolina manufacturers. They contend that industry in this state is handicapped because it must compete against goods manufactured in other states with the use of child labor. Georgia, Alabama, and others are cited as "horrible examples."

"Misleading work," and plenty of it, must be done among members of this legislature before a ratification resolution can pass. Advocates of the amendment will wait awhile before making the attempt.

# SEEK TO GET REVENUE BILL BEFORE HOUSE

## All Factions of Legislature Combining to Get Measure Out of Committee

Raleigh, Jan. 29.—The big push now is to get the revenue bill reported out by the combined finance committees and get it into the floor of the house within ten days. The anti-sales tax forces admit they are beaten in the committees, with the result that they are not going to make any effort to beat the sales tax section of the bill in the committees. Aside from voting "no" on the sales tax section of the revenue bill, they are not expected to offer any opposition whatever to its being reported out virtually as recommended by the Budget commission. They are going to hold their fire until the bill gets onto the floor of the house. Then they are going to start shooting off the firecrackers. According to one of their chief spokesmen, they have plenty of fireworks in reserve and will put on a real display when the proper time comes in the house.

The tax advocates, realizing the advantage they have in the finance committees, are likewise anxious to report the bill out and get it before the house as soon as possible. In the first place, they are confident that they have about as good a working majority for the sales tax in the house as a whole as they have in the committees, although they know that the anti-sales taxers will make their big fight on the bill after it gets into the house. In the second place, they want to get the bill before the house as soon as possible in order to cut short the "missionary" work being done among the members who have not yet completely made up their minds as to how they are going to vote on the sales tax. For while those who favor the sales tax are confident that they have a majority in both houses at the present time, they agree that the anti-sales taxers are working night and day both to hold and augment their present strength and that no one knows what they may be able to do 30 days or 60 days from now.

While they concede they are wasting time in offering any opposition to the sales tax section of the revenue bill in the finance committee, the anti-sales tax forces are convinced that as soon as the bill reaches the floor they will be in a position to make some substantial progress. For they are confident they will be able to offer substitutes for the sales tax that will get the support of a majority of the house members, even if they have been outnumbered in the committees. They also know that they will get a great deal more publicity for their attacks on the sales tax and the substitute plans they will offer for it after the revenue bill gets in the house than if they made these attacks and offered these substitutes in the committees. Part of their strategy, of course, is to arouse the public and get the voters "back home" to apply pressure to their representatives in the general assembly. But it takes publicity to get the voters aroused.

So it is generally agreed here that the hearing put on here last week by the Fair Tax Association was largely for publicity purposes and that the hearing here Wednesday, at which representatives of the North Carolina Merchants Association will be heard in opposition to the sales tax section of the revenue bill, will be staged more for publicity that will result rather than from any hope that the hearing will change the attitude of the committee members.

As a result of this combination of circumstances, it now seems certain that the revenue bill will be reported out by the committee ahead of the appropriations bill, probably within the next ten days. For after the hearing for the Merchants Association Wednesday, no other major hearing is scheduled.

So quite a number believe that the joint committees will be able to re-write the revenue bill include in it what changes it decides to make and report it to the house certainly by the latter part of next week.

This procedure would not only hurry up consideration of action on the revenue bill and the sales tax, but would also require the assembly—or the house at least—to dispose of it before taking up the appropriations bill. Some think this very advantageous, since it would require the assembly to first find out how much revenue it can raise before making its appropriations bill. In the past the appropriations bill has usually been passed first, leaving the finance committees and the assembly to then struggle to find the required revenue.

city council voted to build a municipal power distribution system and purchase current from the Authority. One contract for structures at dTupelo, Miss., Athens, Ala., and Pulaski, Tenn., as well as scores of farmers. The Authority claims are saving thousands of dollars annually as a consequence of TVA rate.

Plans of the Authority to purchase distribution systems in Alabama and at Knoxville, Tenn., have been halted. The restraint came in the form of suits filed in Alabama and Tennessee by coal and ice dealers and preferred stockholders of the private companies that proposed to sell their systems.

In the face of that the city of Knoxville took another path leading toward obtaining TVA power. The costing \$197,575 was let and bids were sought for building the remainder of the system.

Only in Mississippi has the TVA's hydro-electric program progressed extensively without serious opposition. Tupelo, a city of 6,000 population was the Authority's first municipal power contracting for Wilson Dam power last February.

Tupelo Takes Contract

Tupelo signed a 20-year contract with the Authority February 6, 1934, agreeing to purchase electricity at wholesale rates fixed by the TVA.

# CAN HAUPTMANN DEFENSE BREAK THIS CHAIN?



Defense attorneys in the trial of Bruno Richard Hauptmann are trying to break this chain of circumstantial evidence forged by the State of New Jersey in an attempt to prove the Bronx carpenter guilty of murdering the Lindbergh baby. Beginning with events on the night of March 1, 1932, the state has presented dozens of witnesses to try to prove its contention that Hauptmann went to Hopewell, kidnaped the baby, killed it when he fell from the ladder and a month later collected \$50,000 ransom. Hauptmann has denied any connection with the crime and the defense staff has expressed confidence that it can break down the state's story.

The city further agreed to adhere to resale rates determined by the Authority.

Under the contract, the TVA is given general supervision of Tupelo's power system which is operated as a separate unit of the municipality.

Athens, Ala., is another TVA customer which has its own distribution system.

Corinth Buys Power

Corinth, Miss., and Alcorn County organized a co-operative electric association and are buying TVA power at rates that are about 40 per cent less than those formerly paid.

More recently the TVA movement gained further impetus in Mississippi when twenty-one cities organized to petition the Authority to make power available to them. Cleveland, Friar Point, Greenville, Greenwood, Gunnison, Itta, Ben, Lambert, Merigold, Beulah, Coffeeville, Duncan, Grenada, Houston, Idianola, Leland, Morehead, Rosedale, Shelby and Tunica.

Memphis Moves Toward TVA

Memphis, Tenn., more than 300 miles from Wilson Dam, is the latest majority city to take decisive action to secure TVA power. In a municipal election last November citizens voted 32,735 to 1,868 for the issuance of bonds to build a municipal system for distributing current from the Tennessee River.

Thus for thirteen cities have signed contracts with the TVA for electricity and twenty-five others in Alabama, Tennessee and Mississippi have held municipal elections looking toward the use of Muscle Shoals power. Twenty-one voted for the plan and four against it.

Interest in obtaining TVA power is not restricted to the immediate Tennessee Valley, records of the Authority show. Among the cities that have made inquiry as to the possibility of securing it are St. Louis, Indianapolis, Atlanta, Cincinnati, Tulsa, Okla., Louisville, Miami, Fla., Nashville, Tenn., and Cape Girardeau, Mo.

Welder Dam, now under construction fifteen miles above Muscle Shoals will have a generating capacity of 275,000 horsepower and Norris Dam on the Clinch River above Knoxville will generate 12,000 horsepower. Pickwick Dam, construction of which is just starting, will have a capacity of 275,000 horsepower.

# NEW MOVIE ADDS LOTS OF CHARACTER SHAKESPEARE'S DREAM

New York—(AP)—Another storm in the works of the Bard of Avon, this time in Hollywood, where a company producing "A Midsummer Night's Dream" has taken the liberty of adding a character to the cast.

The character added in the film version is Mrs. Bottom, a role portrayed by Sarah Haden. Bottom himself is played by Jimmy Coney, who heretofore has confined his efforts principally to gangster roles.

The producing company has taken the precaution of arming itself with expert opinion defending additions to the works of Shakespeare. Dr. Allison Gaw, University of Southern California English department head, has approved the addition, pointing out that practically every stage producer has taken liberties with the bard's original text.

# EASY LIQUOR SWAYS STATE LEGISLATORS

Members of General Assembly Amazed At Revenue Poured Into Virginia Coffers

Raleigh, N. C., Jan. 29.—The case with which bottled-in-bond liquor is obtained in Raleigh is creating an impression on legislators here. "As near as your telephone" is idle comment on the whiskey situation. Those who prefer the personal touch can easily obtain well-known establishments. Most of the whiskey being sold, apparently, is bottled-in-bond and bears in addition to the Federal stamp the now-familiar Virginia ABC label as well.

Quite a number of legislators have expressed themselves as being very frankly amazed at the amount of revenue which undoubtedly is pouring into Virginia's tax coffers as the result of North Carolina's unopposed patronage. Many impartial observers estimate that Virginia's State treasury has benefited at least \$1,000,000 from the sale of liquor in North Carolina. Many of those who have attended several sessions of the N. C. Assembly say that in former years put jars and jugs, filled with untaxed liquor of course, were familiar sight during the legislative session. Now the picture has changed. The liquor is here, and plentiful, but most of it is in Government-stamped bottles.

Last Saturday night one of a half-dozen well-known Raleigh whiskey dealers was arrested. In fact, more than 175 gallons of liquor was seized. Most of it was bottled-in-bond and well-known brands, and bore the ABC stamp. It is reported that he was arrested solely because other bootleggers turned him up and because they thought he was getting more than his rightful share of business.

All this is having its effect on the legislators. Even those who are teetotalers are getting an eyeful. Back home they do not see liquor because everyone knows they are dry and, therefore, keep it carefully out of their sight. Here it's a different story. Most of them still refrain from drinking, but they cannot help seeing the deluge from their vantage point on the very bank of the apparently endless, swift-moving stream.

Many who fall in the class of non-drinkers are impressed by the scene. It is an open secret that some legislators, once dry in the sense that they abstain and believed firmly in the Turlington Act, have decided that the State is not dry after all. They are still dry, but this is significant—they have swung around to the conclusion that they might as well face an existing condition.

# A Washington Daybook

Washington, D. C.—One of the most persistent rumors in Washington, revived with increased authority every time Huey Long, of Louisiana goes on a rampage in the Senate, is that the "Kingfish" plans a personal invasion of two Southern States in 1936 for the avowed purpose of defeating two of his colleagues.

The two mentioned are Joe Robinson, of Arkansas, Democratic leader of the Senate, and Pat Harrison, of Mississippi, chairman of the Senate's power finance committee.

Robinson and Long already have exchanged darts on the floor of the Senate. During the last Congress the "Kingfish" observed that he had settled a political matter with Robinson when he campaigned for Mrs. Hattie W. Caraway in her successful bid for the Senate and shouted: "I'll go back to the people of Arkansas again and see who comes back to the Senate."

Robinson's reply was that "if he comes into Arkansas, I'll take the liberty of going into Louisiana."

May Inevade Mississippi

While he has made no such open threat against Harrison, Southern politicians who profess to know say they have no doubt he has plans to invade Mississippi.

One disclosed to the writer recently the details of a conversation he had had with Long in the Louisiana States capital only a short while ago. He was visiting Baton Rouge in a private capacity when a messenger from Long informed him "the Kingfish" wants to see you.

This individual called on the "Kingfish" who, with much emphasis and frankness, he says, revealed just what he thought of Harrison and what he planned to do to relegate him to political oblivion in 1936.

He'll Be Busy

The Louisiana Senator, however, has rapped out such an ambitious political program for himself in 1936 that many believe it will be a physical impossibility, even for the "Kingfish," to accomplish all of it.

For one thing he has intimated that 1936 may find him running for the presidency on his "Share-the-Wealth" platform. If so, it will not be in the Southern States where he will pick up electoral votes. He must confine most of his efforts to populous section of the country.

It is true that he has persuaded his State Legislature to advance the primary election date in Louisiana and will have more time for outside work than ordinarily he would have had. But the fact that he will be seeking re-election to the Senate himself in 1936, perhaps running for the presidency and threatening to bring about the defeat of colleagues, too, prompts Robinson and Harrison to take the threats of the "Kingfish" rather lightly.

Washington, D. C.—When the returns of the last November election were tabulated and it became known

that both Senate and House were preponderantly Democratic, Washington politicians began to speculate.

Roughly speaking, their speculations followed lines like these:

(1) Is the administration safe in face of such party power?

(2) Can Mr. Roosevelt control his second Congress as he did the first?

(3) Will the House of the 74th Congress be as "wild" as the election returns seem to show?

Congress—the 74th—has been in session nearly a month and no one from the upper to the lower end of Pennsylvania Avenue in Washington can answer all three queries. The huge Democratic majority has them baffled.

Garner Mentions An Ideal

Back in the days when "Cactus Jack" Garner was Speaker of the House he was fond of describing his idea of a "workable" party alignment in the House.

"In some ways," said Mr. Garner, "it is to be regretted that the gentleman from New York (Bert Snell, Republican leader of the House) will not have quite as large a following as he has had."

"The best proportion for the House of Representatives," continued "Cactus Jack," "could be arranged that way is a majority of about 50 or 60 on one side whether it be Republican or Democrat."

"I speak of an ideal House," the then Speaker repeated, "and an ideal division, whether it be a 50 to 60 Republican majority or a 50 to 60 Democratic majority."

I one could gain access to the innermost thoughts of the man who now is Speaker of the House and who has to contend with a major numbering 322 Democrats to 102 Republicans, to say nothing of the farmer-laborites and progressives, probably would echo his predecessor's voice.

Speaker's Problems Great

It must be said, however, that when Mr. Garner described his "ideal" political alignment in the House he probably never thought he would see on his side of the dividing political alignment in the House he probably never thought he would see on his side of the dividing political aisle as many Democrats as Mr. Byrns of Tennessee, must face every day.

With such a huge majority, which even under ordinary conditions would present a difficult problem to the leadership Speaker Byrns and his associates know only too well how thin the ice is on which they are skating.

### TOO MUCH SPEED

With it being admitted that a great number of highway accidents are the result of too much speed it is to be hoped that while the legislature is taking steps to provide greater safety on our highways it will decide just exactly what the legal speed limit is to be and then make it mandatory that the highway patrol enforce this phase of the law also.

The present speed limit in this state is 45 miles per hour, yet there are very few motorists who even pretend to stay within this limit and there seems no tendency on the part of officers to enforce this part of the law. When automobile salesmen get after a prospect their first sales talk is on the speed of the car they are selling and some of the manufacturers are using as a strong advertising point that their cars will run a hundred miles per hour, or more than twice as fast as it is legal to operate a car in this state.

There is of course a division of opinion as to what is a safe driving speed but certainly we should not have a law setting forth one figure and then permit the motoring public to pay little or no attention to the law. If our present law should be increased then let the legislature increase it to what they think is a safe limit or if it is felt that the present 45 miles limit is high enough, then certainly motorists should not be permitted to continuously break this law every time they venture on the highway.

We believe that a reasonable speed limit law rigidly enforced will do much to decrease the tremendous number of serious accidents on the highways of this state.

the NRA organization. Whiteside's absence from the first White House conference to map out new legislation was commented upon in business circles.

Many think Williams is about ready to go back to his tobacco interest and let NRA shift for itself. Business representatives who have almost daily problems to take up with the deputy administrators literally don't know what's going on in the shop. They are said to be twiddling their thumbs in the dark.

**CUTS:** Meanwhile President Roosevelt and Boss Coordinator Richberg are struggling to work out a bill that will continue the life of NRA in a fashion satisfactory to industry and labor alike. It is some assistance.

White House inclination is to retain a mere skeleton of the old NRA with hours, wages, and child labor as the basic structures. But a ready capital and labor are fighting over how that Section 7A clause, which provides for collective bargaining shall be handled.

Further, although industry is perfectly willing to let the Federal Trade Commission resume full policing of "fair trade practices," many important sections of it are crying out against any possible abandonment of existing code provisions for minimum prices, elimination of cut-throat competition, etc. They say they traded shorter hours and higher wages to get these guarantees because only so could they raise wages and shorten hours with a "reasonable profit."

**HEADACHES:** Tomorrow the enlarged executive council of the American Federation of Labor meets here. Eighteen members are now sitting instead of eleven. They are going to have plenty to consider.

Two points will be uppermost in all minds when President William Green bangs the gavel. First is the bitter row that has split the building trades wide open. Second is the threat of industrialists to set up a national association of company unions that would function in organized opposition to the A. F. of L.

Both are large-sized headaches for the laborites.

### New York

By JAMES McMULLIN

**BANKS:** The Treasury's proposal to float baby bonds direct to small investors has New York by the ears. The boys don't quite know whether to cheer or view with alarm.

It's O. K. with the big banks where their own interests are concerned. While they will buy all the federal obligations Secretary Morgenthau throws their way they won't mind in the least if somebody else shares the load. Many of their depositors would probably withdraw funds to take advantage of the U. S. bonds—but that's all right too. They have more time and money than they know what to do with and find it difficult to invest at a profit. They would probably do so far as to urge their line depositors to make withdrawals for the purpose. Experts here are no doubt that the public would respond adequately.

The move would have the important by-product of curbing enormous excess reserves. Again no objection from the big fellows. These reserves are a drug on the market now.

The point is that the time money pulled out to buy bonds would come back to the banks in the form of government demand deposits. But demand deposits require a higher reserve ratio. Q. E. D. Incidentally this might prove a useful method of controlling credit inflation—which is likely to spread like a forest fire once it gathers real momentum.

The reverse of this pleasant picture applies to the small commercial banks through the country. They have a much larger proportion of time deposits than the top-flight institutions and can't afford to lose them. They're having a hard enough time making ends meet as it is. Also they would have to go back to super-liquidity—thereby aggravating their earnings problem—to have a safe cash margin against probable withdrawals. This would hit the banking structure in its weakest link and keen observers don't care much for that.

**BONDS:** Add to signs of recovery. Company issue for high grade municipal bonds is getting very keen.

It is no longer possible for an investor to pick up an attractive bond with any old offer. Cities with good credit standing can't service with a smile from Wall Street, any time they wish.

**LABOR:** Mr. Roosevelt's decision to transfer newspaper labor disputes from the National Labor Relations Board to the Newspaper Industrial Board may cut more ice than he intended. Organized labor had come to regard the Labor Board as the one New Deal agency it could trust. The transfer of jurisdiction from Francis Biddle and his associates has stirred real bitterness—however FDR tries to justify it. If Biddle resigns his successor will have a tough time gaining the union's confidence.

The merits of the Jennings case are relatively unimportant. What does count is that labor sees additional evidence in the move to support its suspicion that the administration has gone over to the opposition. This doesn't augur well for the peaceful settlement of labor problems.

**MORTGAGES:** New York real estate circles fail to endorse about Governor Lehman's State Mortgage Commission as a cure for the guaranteed mortgage mess. They admit the theory's O. K. but everything depends on the personnel—and the political plums are extremely alluring.

At that they rate it an improvement on the bright idea of one of Tammany's elder statesmen. He proposed a separate receivership for each of the defunct mortgage companies. You can picture what a harvest that would have been for the faithful.

Insiders understand that Congress will be asked to broaden RFC authority to permit more constructive contributions toward rebuilding the mortgage market. Real estate will not come up for air until mortgages again become an attractive investment.

The bills have the backing and endorsement of the North Carolina Association of County Commissioners and are a part of the legislative program backed by the county commissioners. It is expected that a good many county commissioners will be present tomorrow afternoon at 2:30 to advocate the enactment of the bills in the hearing before the House committee on counties, cities and towns. Indications are, however, that the county commissioners will be far outnumbered by the county officials the bills would affect and who are going to oppose them.

The hearing will be held in the hall of the House of Representatives. A reception for the members of the general assembly will be given in the ballroom of the Sir Walter Hotel here tonight by the Young Democratic Club of Wake county of which Mrs. Bessie B. Phoenix, chief information clerk in the State Department of Revenue, is president.

The reception will start at nine o'clock and last until midnight and promises to be one of the most important social events yet tendered members of the general assembly. No announcement has been made yet concerning the program, but it is being intimated today that change for a certain fixed period will be very short and say, three years. ### POLITICS AT RANDOM

By RYON PRICE

(Chief of Bureau, The Associated Press, Washington)

In spite of all the talk about the World Court, the bonus, the social program and the problem of relief, it is the money question which now occupies the undivided pinnacle of Washington concern and speculation.

Six months ago, three principal things were troubling those business and industrial interests who can do most, if they will, to help recovery. Business men complained that from these three causes arose nearly all of the suspicion, hesitancy and lack of confidence which stood in the way of a really convincing upturn.

One thing was the prospect of another unbalanced budget. One was the dispute over the future of NRA. The third was uncertainty over the currency situation.

Recently two of these factors have lost much of their potency. Business in general has accepted the new unbalanced budget without great protest, generally conceding it to be inevitable. Further consultations have relieved concern in many quarters over the remarking of NRA, and business seems to have greater confidence it will get something like what it wants.

The third of the three problems—the money problem—alone remains critical, and it has grown worse, rather than better.

**Money Nervousness**  
Supreme Court consideration of the gold cases, while it greatly increased interest and speculation on this subject, by no means was the only factor in that new period of money nervousness which gripped the capital and many of the world's principal market places soon after the opening of the new year.

The gold litigation involved directly only that section of the law making it no longer necessary for the government and private debtors to pay off gold bonds in gold. Not involved, except by association and indirect relationship, was the broader field of dollar devaluation. Whatever the court might do about the gold clause, there would remain on the one hand the demand that the government immediately set a stable value for the dollar, and on the other hand the agitation for inflationary action of the most energetic kind.

Quite aside from the Supreme Court proceeding, powerful business interests were asking that the President remove the third obstacle of which they had complained, and say definitely that the dollar would henceforth have a certain value in gold, and that value would not be changed for a certain fixed period.

Releigh, Jan. 28.—Two playful prisoners who amputated the appendages of two prison bovines at Caldonia prison farm in Halifax county are now in solitary confinement there eating bread and water, according to L. G. Whitley, assistant director of the prison division of the State Highway and Public Works Commission. Whitley is considering substituting cow tail soup made from the amputated tails. He believes that cow tail soup should be almost as palatable as ox tail soup, advertised as being a great delicacy.

The two prisoners, Gordon Brown of Blaine county and R. S. Lloyd of Wake, both white and in A grade, worked in the cow barn at Caldonia. They evidently became irritated because the cows scratched their tails while they tried to milk them. So they decided to cut the tails off entirely.

Brown and Lloyd have not only been placed in solitary confinement for bobbing the tails of the two cows, but have also been reduced from A grade to C grade, meaning that they will again have to wear prison stripes.

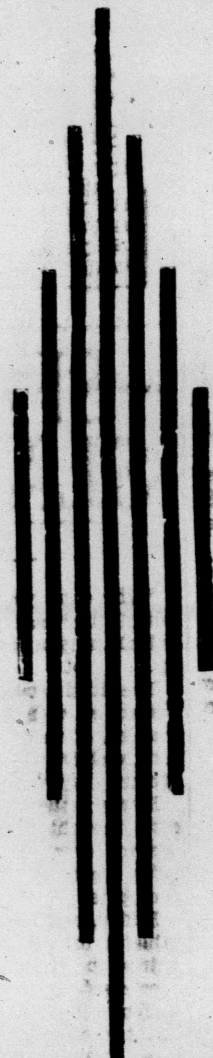
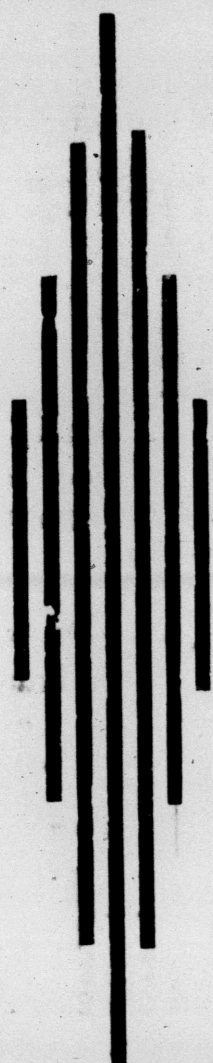
