MANY DEAD AS COLD WEATHER GRIPS NATION

Toll Of 12 Known
Deaths Levied In
Several States

NIAGARA BRIDGE SPAN COLLAPSES

Storms and Floods
Add to Cold Weather
in Tying up Industry,
Transportation

(By Associated Press)

Tons of ice poured over
the twisted steel of Honey-
moon bridge in the Niagara
river gorge as a cold wave,
storms and floods levied
fresh toll in several states
today.

The 1,200-foot bridge at Niagara
Falls collapsed late yesterday under
the pounding of the floods and
fell 200 feet. Another span was
blown over by a wind storm in 1889.
Weather deaths of the week rose
to 12. Two coal miners were found
drowned on a bank of flooded Six
Mile creek near Paris, Ark. A man
was lost overboard from the Nor-
wegian freighter Nordward in
rough seas en route from Baltimore
to New York.

Arkansas rivers spilled into low
lands around Calion and McNab,
forcing families and livestock to
higher grounds. Railroad box cars
were provided for refuge at Cal-
ion.

Twenty oil wells in Creek Bot-
tom north of Eldorado were closed.

Niagara river ice menaced prop-
erty above and below the falls. On-
tario hydro-electric commission of-
ficials estimated damage in their
generating plant at \$1,000,000.

The Lewistown, N. Y. steamship
dock was badly damaged. Cottages
and boat houses were swept away
in several communities.

Continued cold was forecast for
much of the East and Southeast.

snakes, rattlers and buttons."

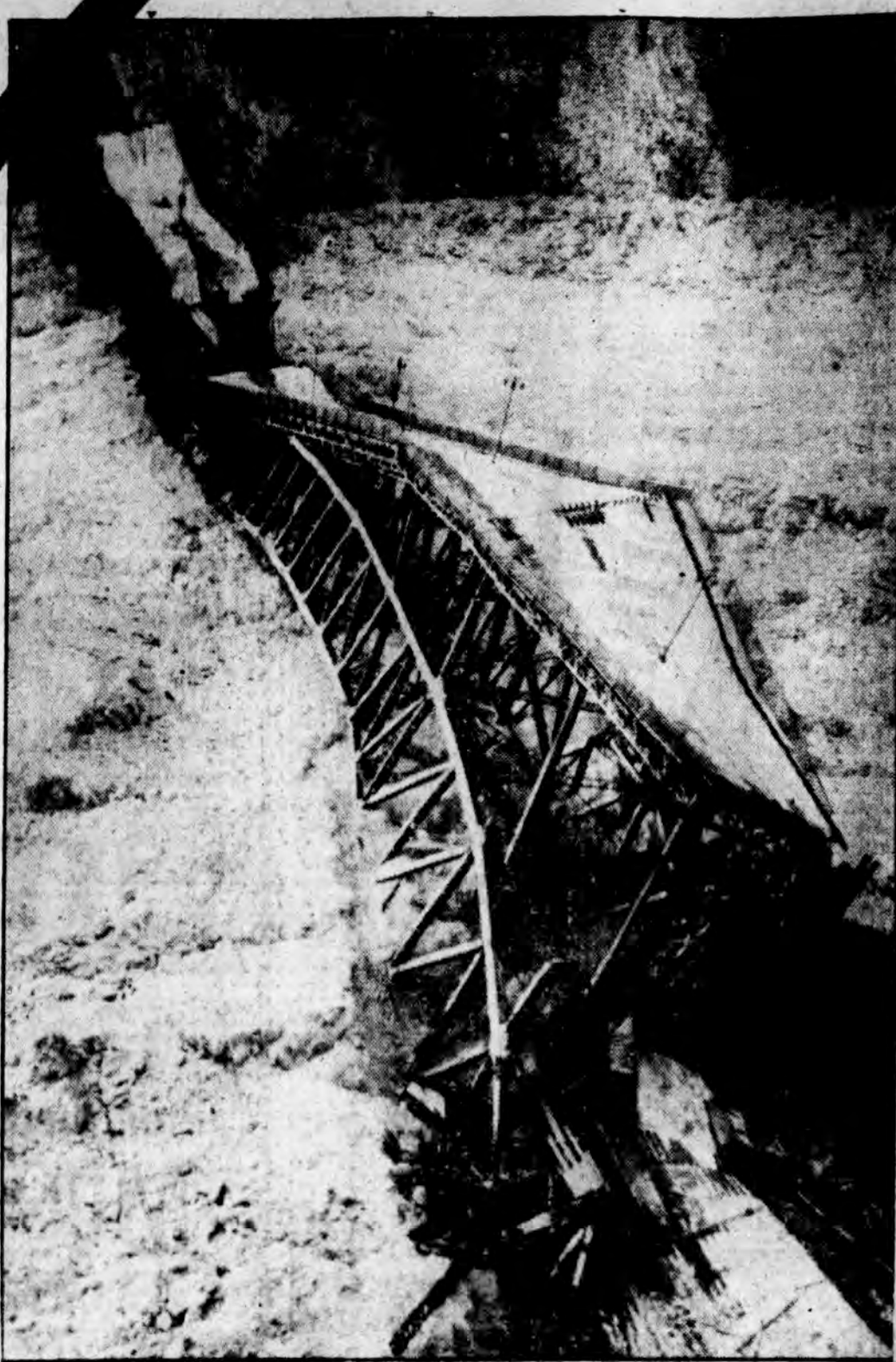
PREHISTORIC JAWBONE IS BOILED AWAY

Folsom, Calif.—(AP)—There may
have been a Folsom man rivaling
the Piltdown man or Peking man
in the history of the early human
race, but it appears science will
never know.

Prisoners excavating for a new
building unearthed a jawbone which
some anthropologically minded offi-
cials recognized as a prehistoric hu-
man relic. Placed in some boiling
water for cleaning, the bone was
forgotten. When the pot boiled dry
the relic was reduced to dust.

VESSEL SINKS IN CAPE CANAL

Waters Searched For
Oiler Believed To
Have Drowned

Sagamore, Mass., Jan. 28.—(AP)—
While Federal investigators hurried
here to investigate, coast
guards searched waters near the
eastern end of Cape Cod canal
—day for Samuel Siragusa, 37,
of the Malden, an oiler believed
drowned when the New York tug
Plymouth sank last night after
colliding with the Boston Collier
Everett.

Fifteen officers and crew mem-
bers of the Plymouth were found
to jump for their lives when the
tug went down in five minutes.
Nearby rescue boats brought them
safely ashore.

Chief Mate Leonard Goodwin of
Norfolk, Va., was revived with dif-
ficulty after a boat crew took him
from the water in a semi-con-
scious condition.

Captain Joseph Goodwin of Or-
lando, Fla., commanding the tug,
said the "Everett rammed us amid
ship."

The rescued men, included Cap-
tain Goodwin, Chief Mate Good-
win, his brother, Dallas Goodwin
and Wilbur Goodwin, both of Roe,
(Carteret County,) North Carolina.

MERCURY SETS TWO-YEAR LOW

Minimum Tempera-
ture of 17 Degrees
Recorded Here

A minimum temperature of 17
degrees was registered in Green-
ville last night, the lowest official
reading for at least the past two
winters.

B. T. Clark, in charge of the lo-
cal weather bureau, reported that
the mark of 17 degrees was one de-
gree lower than was registered
during the 24 hours ended at 8
o'clock yesterday morning.

A cold wave which swept into
Dixie from the Mid-West brought
a sharp drop in the mercury. The
reading Tuesday morning showed
that the lowest temperature record-
ed during the night was 37 de-
grees, 20 above the reading this
morning.

Increased Army Advocated By Japan's War Minister; Charged American Insolent

Nippon Spokesman
Declares Sentry
Only Doing Duty

HOLDS APOLOGY
ONLY COURTESY

Military Attache Con-
tends Jap Soldier
Had Right to Shoot
Embassy Official

Shanghai, Jan. 28.—(AP)—
A Japanese military
spokesman declared today
that the Japanese sentry
who slapped the face of
John M. Allison, ranking U.
S. diplomat at Nanking, was
"only doing his duty," and
would not be punished.

He added anyone disobeying or-
ders of a Japanese sentry could be
shot and said an apology tendered
to Allison merely was "a gesture of
courtesy."

Earlier the Japanese spokesman
had said Allison, third secretary in
charge of the United States Em-
bassy, had adopted what Japanese re-
garded as an "insolent attitude"
and Japanese authorities were tak-
ing a serious view of his actions.

Allison was assaulted in Nanking
yesterday when he supposedly at-
tempted to enter a Chinese house
after having been forbidden by the
Japanese sentry. The Japanese
contend that the American Em-
bassy official had no right to en-
ter and, having no official business
in the building, his insistence was
considered "insolent."

Slapped By Sentry



The Japanese news agency Do-
mei reported that a Japanese
sentry slapped the face of John

Allison had no right to enter it.
Allison is at present in charge
of the embassy.

STATE OFFERS NEW EVIDENCE

Payne Quoted as Say-
ing Penn "Had It
Coming to Him"

Asheville, Jan. 28.—(AP)—A Fed-
eral agent testified today that Bill
Payne said he shot Highway Pat-
rolman George Penn to death last
August because "he had it coming
to him, he was such a damn fool."

The witness, J. H. Polkinghorn
of the Federal Bureau of Investi-
gation, took the stand in the trial
of Payne and Wash Turner on first
degree murder charges growing out
of the slaying of Penn.

He told the Buncombe county
jury that Payne made the state-
ment in reply to another FBI man
who, after the capture of the two
escaped convicts at Sanford Jan-
uary 3, asked him:

"Payne, why did you shoot Penn?
Polkinghorn, the last of several
witnesses called by the state before
the luncheon recess, said he had
been in Charlotte, Greensboro, Dur-
ham, High Point, Asheville, Ral-
eigh, Wilmington and numerous
bank robberies and kidnappings be-
fore FBI agents arrested them
without a struggle.

Testimony that Turner told his
companion Payne that he wasn't
going back to Caledonia (prison
farm) alive but would shoot it out"
was heard earlier in the trial.

Mrs. Bettie Jane Cox, the first
witness today, who said she knew
the defendants, but not by their
names, while operating a tourist
camp at Myrtle Beach, S. C. told
of an arrangement Payne and Tur-
ner had in her presence at a tour-
ist camp there.

Turner called Caledonia "a living
hell," the witness testified.

R. E. Marlow, 18 employee of a
service station near Southport, told
of driving two men 60 miles to
Hallsboro last December after they
had asked for help when their auto
broke down.

He identified the two as Payne
and Turner.

Urges Preparation for
Country Other
Than China

SAYS SITUATION
GROWS GRAVER

Asserts Foreign Sup-
plies Entering China
Through Indo-China,
Mongolio, Canton

Tokyo, Jan. 28.—(AP)—
The war with China has
reached so critical a state,
War Minister General Gen
Sugiyama told the nation's
Parliament today, that
Japan must now "prepare
for a country other than
China."

Replying to a flurry of question-
ing by Diet members the General
urged for the second time in a
week that an increased army be
thrown into the conflict.

He acknowledged the "current
incident gradually is assuming
greater proportions and the situa-
tion rapidly is becoming more
grave."

Foreign supplies are entering
China through Mongolia, Canton
and Indo-China. "I believe the
volume is considerable, but actual
figures are unobtainable."

"In any event the Imperial army
holds the key to settlement. Tak-
ing warning of experiences gained
through the Chinese incident, and
also to cope with this new situa-
tion developing, I believe the army
forces must be increased."

GREEN WISHES TO FACE FOES

A. F. L. Head Would
Like Attend UMW
Convention

Miami, Fla., Jan. 29.—(AP)—Wil-
liam Green, president of the Ameri-
can Federation of Labor, said today
he desired to meet his opponents
"face to face" at the Washington
convention of John L. Lewis' United
Mine Workers, now in session.

"I wish very much I might meet
my accusers face to face at the
Miners' convention and make an-
swer to their unfounded charges,"
Green said in an interview. He in-
dicated he would do so, possibly
next week, if he is able to get away
from the A. F. of L. executive coun-
cil meeting here.

The Mine Workers have threat-
ened to revoke Green's membership
in their union on the grounds of
fostering dual unionism, and other
charges.

The A. F. of L. president was
summoned by letter to appear be-
fore the Miners' convention for
"trial" on the charges. His reply
asked that the accusations be speci-
fied and that the United Mine
Workers' officials cite the section
of their constitution he allegedly
had violated.

The main basis of the dual union-
ism charge was Green's issuance
last May of a local charter to the
Progressive Miners of America in
Illinois, an offshoot of the United
Mine Workers. This union now
seeks an international charter.

Held In Death Of Negro on Highway

Fountain Worthington, Winter-
ville white man, was ordered held
under bond of \$1,000 at a coroner's
inquest in Ayden yesterday after-
noon into the death Monday of a
16 year old Negro.

Worthington is alleged to have
struck the youthful Negro, who
was skating on the Ayden-Kinston
highway and failed to stop to ren-
der aid. He was arrested shortly
afterwards, however, and the in-
quest set for yesterday afternoon.

The Negro, David Lee Fournes,
was said to have suffered a fractur-
ed skull and breaks to both his
legs. He died almost instantly.

Vanceboro Citizen Freed At Inquest

J. G. Blow of Vanceboro was ex-
onerated at an inquest this morn-
ing into the death of Alfred Fran-
cis Simmons, who was fatally in-
jured Saturday night when struck
by an automobile driven by Blow.

Simmons was walking along the
Falkland highway in company with
three companions when he was
struck. A dense fog prevented good
visibility and Blow was absolved of
all blame in the fatality.

Miner Seeks A New Silver Bonanza In Tabor's Abandoned "Matchless"

LEADVILLE, Colo.—Old Tom Palmer, digging on Fryer Hill, hopes to write a new chapter in the story of "Haw" Tabor and his \$11,000,000 Matchless silver mine.

Palmer thinks Tabor had a "dam wife, the once plump, blonde and pink-cheeked Baby Doe, to 'hold on to the Matchless.' He's digging the old workings to find out the reason.

Through years of pinching poverty Baby Doe guarded the mine with a shotgun and sharp words. Three years ago they found her in the Matchless shack, her body frozen and her stiff fingers clutching a purse with two wrinkled dollar bills, last of the Tabor millions. Palmer is an optimist, disregarding mining men who call the Matchless "an incredibly hazardous" financial gamble.

Palmer Moved In

He risked his life to climb down alone into the old shaft with its rotted timbers to see if mining men knew what they were talking about when they said the honeycomb workings were flooded. Now he is willing to risk "my last penny" to renew Tabor's hunt for a new bonanza.

Palmer made the old Tabor shack comfortable and moved in at the Matchless after Baby Doe died. Palmer's father worked the matchless for Tabor.

"Tabor simply had to quit digging because the bottom dropped out of the silver market. 'Now that silver is up again the mine will make money. Who knows? Maybe we may even hit bonanza again.'"

Tom Palmer's blue eyes kindle when he says that. He winks and the pipe in his mouth tilts to a jaunty angle.

Found 'Pay Dirt'

"I decided last March to find out if the Matchless was flooded," Palmer explains. "I had a friend lower me on a 200-foot rope. The water is below the third level, about 325 feet underground."

Palmer interested a group of locomotive engineers from his home town of Grand Junction, Colo., in the venture and they obtained a lease from the Shorego Mining

can't keep optimism from his voice when he calls that "pay dirt."

"It runs about \$30 a ton and that is about as good silver ore as I have heard about in a long time around here," he says.

Palmer has dug up an old chart of the Tabor workings.

Pocket Possible

"This over here is all worked out," he explains as he points to one section of the property. "But this over here has barely been scratched. That is what Tabor meant when he told Baby Doe to 'hold on.'"

Mining men concede he may yet stumble on a pocket of ore that Tabor overlooked, one of the kind that netted "Haw" \$100,000 in a day.

N. Y. U. CAGERS CLASH AT HILL

To Invade South For First Time in Eighteen Years

Chapel Hill, Jan. 28.—Sporting an impressive record of 10 victories and only one defeat, New York University's colorful basketball team heads South for the first time in 18 years next week to engage Maryland, Richmond and North Carolina, respectively on Thursday, Friday and Saturday nights.

NYU's last trip into Dixie was most auspicious. The 1930 Violet team with its present coach Howard G. Cann, setting the pace, won the National A.A.U. tournament held in Atlanta.

The Violet record to date shows victories over Newark 47 to 30, Seton Hall 51 to 27, Upsilon 60 to 34, Brooklyn 55 to 37, Wagner 75 to 21, St. Francis 43 to 34, Georgetown 49 to 41, Manhattan 42 to 37, Union 47 to 33 and Colgate 43 to 42. Only defeat of the season came at the expense of Minnesota's giant ball-hawkers 36 to 31.

North Carolina and NYU are meeting for the third time. The Violet won both previous contests—55 to 33 in 1936 and 37 to 30 last season. Both games were played in New York City's spacious Madison Square Garden.

Simon Boardman, forward, and Irvin Witty, center, are the leading scorers on the NYU team. Boardman has tallied 109 points—43 field goals and 23 fouls and Witty 101 points—43 field goals and 15 fouls.

Seven other contests are listed on the Tar Heel athletic program next week, five of these to be played at Chapel Hill.

Prior to meeting NYU the varsity basketball team will oppose Clemson here Tuesday night. The freshmen and Mars Hill will meet in the preliminary.

Varsity and freshmen boxers will move over to Raleigh for contests with N. C. State's varsity and yearling teams Friday night. At the same time the Tar Heel varsity and freshman wrestlers will make their home debut against Washington and Lee.

The lone other scheduled event is a basketball game between the Carolina freshman and Georgia Military Academy here Thursday night.

BRITAIN'S ROBOT SHIP WILL FIND NO PEACE

Portsmouth, Eng. (AP)—Britain's robot warship Centurion is going to have a troublesome year.

During the spring, she will be fired at by every ship in the Mediterranean fleet. In the summer and autumn, ships of the home fleet, aircraft and home defense forts will practice bombing and gunnery on her.

While under fire the Centurion will be without a crew, and will be controlled by radio from a destroyer some miles astern.

Officers and crew, when they board the vessel after bombardment, often find their cabins ruined by shell-fire.

Freddie Steele's Knockout By Apostoli First Major Upset In Sports For 1938

NEW YORK — After watching Freddie Steele pummel Freddie Steele into utter helplessness it is difficult to imagine Steele successfully defending his middleweight title when he risks it against the belting bellhop from Trisco.

The word along Rue Cauliflower is that they'll meet in an outdoor championship tussle, this summer. Although Steele has made no announcement it is likely he will retire if he loses his crown. Meanwhile, Apostoli will box Glen Lee of Omaha, Neb., in New York February 4.

A few months ago Steele said he planned to quit the ring in a year or so and enjoy the sizeable fortune his fists have brought him.

He is too intelligent a youngster to imperil his health by taking many more bad beatings for the sake of money. He's only 25 and undoubtedly has several more years of good fighting in his system but he's been tossing and taking leather for a decade. He is as clean-cut a boxer as the ring knows, with none of the marks of his profession, and our guess is that he will retire.

Surprised Everybody
No matter what else happens in the ring this year, Apostoli's decisive triumph in their over-the-weight bout in Madison Square Garden a few nights ago, will stand as one of 1938's major surprises. Apostoli, beaten by Freddie several years ago, was on the short end of 3-1 odds. Many expected a good fight, for Apostoli had come along strong and unquestionably was the outstanding contender, but few looked for an Apostoli triumph and perhaps none fancied his winning by a technical knockout.

In previous tilts with challengers Steele has shown himself a master boxer and a hard puncher with either hand. But Apostoli fought so aggressively at close quarters that Steele had little chance to box or to rely on his customary long distance artillery.

After taking a good early licking Steele found himself and was the champion of old in the fourth and fifth rounds but from the sixth Apostoli took complete charge.

Steele's Evens
Apostoli's low blow at the start of the seventh round undoubtedly hurt Steele but apparently it served only to shorten the encounter.

Steele showed himself a courageous champion by the manner in which he took Apostoli's assault without going down. By actual count Steele absorbed 51 punches in the eighth round.

Steele said he was accustomed to more tape and bandages than the New York commission allowed and was so aggravated by its ruling that he declared he would never fight here again. He also explained that Freddie may put up a much better scrap when the title is involved this summer but Apostoli looks like the new champion any way you figure it.

This registered Holstein cow, owned by the State College dairy department, has just completed a record of 17,547 pounds of milk and 514.3 pounds of butterfat in 298 days. The record makes her the champion four-year-old Holstein cow in North Carolina.

In making this record, she averaged daily seven gallons of milk. In one month she produced 1-4 tons of milk or an average of nine gallons a day. R. H. Ruffner, head of the college dairy department, pointed out.

NO FORTUNE IN THIS BUSINESS

Dr. Hamilton Warns No Profit in Guinea Pig Industry

Reflector Bureau Raleigh, Jan. 28.—There's no fortune to be made raising guinea pigs and there wasn't any too much truth in the famous Ellis Parker Butler story "Pigs Is Pigs" Dr. J. H. Hamilton, in charge of the State Board of Health Laboratory here, wants the public to be warned in his behalf.

"Since publications of a story that the Board of Health is having a hard time getting enough guinea pigs for its syphilis experiment, I've had to spend most of my time convincing people not to go in for raising them on a big scale," grinned Dr. Hamilton.

"Each one of the darned things will eat 40 cents worth of food during its short existence," he said, "and ordinarily they will only sell for about 25 cents apiece. Right now they're bringing 90 cents, but there just happens to be a temporary shortage."

When this correspondent cited "pigs is pigs" as an authority for belief that guinea pigs multiply with such rapidity that there should never be any shortage of the animals, Dr. Hamilton said that there was much more humor than truth in the famed tale of the railway agent whose station was overrun with guinea pigs because he would not deliver a pair to their consignee except upon payment of the freight rate "pigs."

"As a matter of fact, guinea pigs come about three to the litter and the female will have no more than three litters a year," he said.

It was suggested that even this rate of increase is quite rapid and would make raising the animals rather easy, the doctor commented: "Yes, if they didn't die so easy."
