SENATE VOTES EXTENSION IN RFC AUTHORITY

Agency Would be Empowered to Lend to Businesses

LOANS TO STATES ALSO INCLUDED

Supporters Of Reorganization Measure Battle Through Vigorous Opposition

Washington, April 1.—(AP)—The Senate passed today a bill to give the RFC wide new authority to lend to business enterprises. It also would revive RFC loans to states and sub-divisions for public works construction.

The administration measure now goes to the House.

The bill, by Senator Glass (D-Va.), would extend the scope of RFC lending and permit that agency to make available about \$1,500,000,000 for long time loans.

Loans to states and sub-divisions would be permitted not only on so-called "self liquidating" projects, but on all projects where the RFC finds there is reasonable assurance of repayment.

Supporters of the administration's reorganization bill battled through vigorous opposition delay tactics to force the House to resume consideration of the measure, meantime.

Speaker Bankhead announced the vote was 206 to 139 on a motion to proceed with debate. Opposition members had tried in vain to block nomination of the discussion, begun yesterday.

A few references were made in yesterday's House debate to President Roosevelt's denial that he aspired to become a dictator.

Representative Warren (D-N.C.), who played a large part in framing the general reorganization provisions, remarked:

"Congress can try from now until eternity and will never make a dent in the bureaucracy that exists today. It can only be done by one man."

"If you lack confidence in that man, if you distrust him... then you ought not to vote for this bill."

Other developments:

An overwhelming majority of favorable replies to Secretary Hull's program for international aid to political refugees is coming into the State Department.

Senator LaFollette (Prog.-Wis.) decided to carry to the Senate floor his fight to broaden the income tax base.

Another Succumbs Of Cancer Serum

Orlando, Fla., April 1.—(AP)—Mrs. Lida Morrison, 49, of Orlando, died early today, bringing to eight the number of fatalities among patients given injections of a serum for treatment of cancer.

Six women died Wednesday and as seventh yesterday after receiving injections of the serum. Symptoms resembled lockjaw, physicians said, in each case.

Three other patients who had taken the serum, known as encol and said by Doctor T. A. Neal to have been administered at his clinic from a single bottle, remained gravely ill.

"We have not given up hope in any of these cases," hospital attaches said.

Homicide Charges Made By Coroner

Tarboro, April 1.—(AP)—Coroner J. G. Raby issued a warrant today charging J. K. Young, 28, with homicide as a result of the death of John Collins, 25-year-old Negro.

Collins, employee of a laundry managed by Young, died last night of pneumonia in a hospital where he had been treated for burns since March 24.

Witnesses testified at an inquest the Negro's clothing, saturated with a cleaning fluid, caught fire when Young flipped lighted matches at him in the laundry.

JUDGE TRIES TO DISMISS ALL THE CASES HE CAN

Athens, Ga., (AP)—Judge Vincent Matthews of police court had the stripes taken off prisoners at the city stockade.

Now he is trying to see how many cases he can dismiss. If he can't dismiss the charge, he tries to put the offender on probation.

"My idea," he explains, "is that the chief aim of police court should be to make good citizens. Give the fellow another chance if you can."

"This policy spells the end of the old rock-pile, pick and shovel basis for conducting the court."

PUPILS ESCAPED DEATH IN THIS SCHOOLHOUSE



One hundred and ten schoolchildren were rescued without fatality when a twisting tornado slashed through the upper story of the Highland grade school at Columbus, Kas. Here is a picture of the building after the roof collapsed and three classrooms crumbled. The tornado was one of several that lashed across five states, leaving at least 27 persons reported dead.

TWO PERSONS DIE IN FLAMES

Three Others Burned In Johnston County Home Blaze

Goldsboro, April 1.—(AP)—Two persons were burned to death and three others injured, one seriously, early today when their farm house 18 miles southwest of Goldsboro, in Johnston county, was destroyed by fire.

Mrs. Oscar Ballree, 48, and her daughter-in-law, Mrs. Emmett Ballree, 15, died in the flames.

Emmett Ballree, 22, a farmer, suffered serious burns from the waist up and at the hospital here said his condition was critical.

Less seriously injured were Woodrow Ballree, 18, Emmett's brother, whose hands were burned, and Emmett Capps, four, who received burns on the hands and face.

Emmett Ballree told officers he awoke at 2 a. m. to find the home enveloped almost completely in flames. He had no idea of the cause of the blaze, he said.

He said he and his wife were sleeping in a back room of the small dwelling and he saved Emmett Capps, but was unable to get his wife, Woodrow, he said broke a window and jumped to safety.

Murder Case Now In Hands Of Jury

Charlotte, April 1.—(AP)—The case of Bruce Shue, Mooreville truck driver, charged with murder in the fatal shooting of Huntersville Policeman J. A. Pope last January 1, was given to a jury in Superior court here shortly before noon today.

The jury got the case after a long charge by Judge Frank Armstrong of Troy. Arguments of attorneys were completed yesterday.

Rape was shot to death before day January 1, when he went to question a stranger prowling the streets. Two of Rape's companions identified Shue as the stranger.

Shue told the jury he was in South Carolina at the time Rape was killed.

Oil Industry Organizes Anti-Diversion Machine

Raleigh, April 1.—The last cog was fitted into a potentially powerful anti-diversion "machine" last night with formation here of the Wake County Petroleum Industries Committee, the 101st unit of its kind in the state organized or revitalized by State Senator S. Gilmer Sparger, secretary of the North Carolina Petroleum Industries Committee.

There is now a local Petroleum Industries Committee in every county of North Carolina, Mr. Sparger said, with two such in Guilford county, one in High Point, the other in Greensboro. Work of organizing the local groups was started by Mr. Sparger last November 4th and since that time he has visited every county in the state in the interests of his plan.

Whether or not this oil organization will later take up other subjects is something only the future can tell, but the only announced "drive"

is set to conduct is for enactment by the 1939 General Assembly of a resolution enabling the people to vote on a Constitutional amendment forever prohibiting diversion of highway funds to other purposes.

Even this campaign will be one of "education," Mr. Sparger said, rather than of "pressure," not to say coercion. The Petroleum Industries Committee's plan is to acquaint all voters of the state with the diversion problem, which in this state amounts to nothing more or less than the use for general fund purposes of approximately ten per cent of gasoline tax receipts, Mr. Sparger declared.

In addition to the oil industry as a whole, there are numerous Highway User groups affiliated in the anti-diversion drive. Among them Mr. Sparger listed the North Carolina Grange, the Rural Letter Carriers Association, the North Caro-

The jury failed to place the blame on either driver, but did absolve Deal of any negligence.

DEATH CLAIMS DR. M'BRAVER

Southern Pines, April 1.—(AP)—Dr. L. B. McBrayer, 69, president of the State Tuberculosis Association and former president of the State Medical Society, died early today.

Dr. McBrayer had been ill several months of pernicious anemia and his condition became critical a few days ago after he had shown some improvement.

Hope was abandoned yesterday and he died at 2:15 a. m. at the home of his daughter, Mrs. P. P. McCain, at Mockrose near here. The funeral will be at Aberdeen at 4 o'clock tomorrow afternoon.

Dr. McBrayer was a native of Buncombe county and was graduated from the University of Kentucky Medical school in Louisville, Ky., in 1899. He returned to Asheville where he started his professional career.

He was a pioneer in preventive medicine and in 1908 became a member of the Board of Health of the city of Asheville. He was part-time health officer there from 1910 to 1914. In 1914 he became head of the State Tuberculosis Sanatorium near Aberdeen, now known as Sanatorium.

He already had welcomed the chief executive to the State when he boarded his special train at the Northern border March 23 and appeared on the platform with him at Gainesville, when the President made his "surprise" speech labeling Southern wages as "far too low."

There were no callers listed at White House headquarters for the day.

Negro Convict Hurt In Fall From Truck

William Ward, Greenville Negro, who was injured when he fell from highway prison camp truck Wednesday, has been returned to his home after completing serving his sentence.

The Negro was sitting on the rear end of the truck and fell off when it turned a corner. A trusty, he was not bound in any manner nor was he under guard. Although he suffered severe lacerations about the head, no bones were broken and he was not injured internally.

The slave trade began in 1503 when the Portuguese landed the first shipment of Negroes at Santo Domingo.

HOOD ALLEGES DAWSON SHORT IN BANK FUNDS

Banks Commissioner Files Petition in Lenoir Court

SAYS SHORTAGE EXCEEDS \$45,000

Counsel for Former Democratic Chairman Deny Charges In Their Entirety

Kinston, April 1.—(AP)—Gurney P. Hood, State Commissioner of Banks, has filed a petition in Lenoir Superior court, Clerk J. S. Davis said today, alleging that John G. Dawson, former Democratic State Chairman, is short "more than \$45,000" in his accounts as receiver of the Farmers' Bank and Trust Company of LaGrange.

The petition and motion asks that rehearings be ordered on orders signed by Judge N. A. Sinclair early last year relating to attorney's fees, commissions and expenses of the receivership, and relating to a "final report" as receiver. The bank closed in 1920.

L. R. Varner of Lumberton and Matt H. Allen of Kinston, counsel for Dawson, issued a statement saying "all the allegations in the motion are emphatically denied."

The petition was signed by Jesse A. Jones of Kinston and the legal firm of Ehringhaus, Royall, Gosney and Smith, by Kenneth Royal and requests a hearing on the petition and motion at 2:30 in the afternoon of April 11 at Kinston.

Mrs. P. S. Moore, 59, of Gardner's Cross Roads, died at her home at 11 o'clock this morning, following an illness of three weeks. Funeral services will be held at the residence at 3 o'clock tomorrow afternoon.

Rev. Gilbert Davis, Christian minister of Bell Arthur, will conduct the services. Burial will follow in the Gardner cemetery.

Mrs. Moore was the daughter of the late Mr. and Mrs. J. B. Kilpatrick. She spent her entire life in the community in which she died. Surviving are her husband; three sons, Edward, Francis and William Moore; one daughter, Miss Pauline Moore; four brothers, Moses Kilpatrick of Norfolk, Va.; Jesse Kilpatrick of Zebulon; Edward Kilpatrick and Paul Kilpatrick, who is enrolled in the CCC; and two sisters, Mrs. C. W. Worthington and Mrs. Lula Chapman, both of Ayden, R. F. D.

Annie Gorham Wilson, Negro woman of Pacolet township, is believed to be one of the oldest persons receiving aid under the Social Security old-age benefit program in the State.

Annie claims to be 108 years old and acquaintances, both white and colored, in the section bear her out. Affidavits in the office of K. T. Futrell do not give her exact age, but two statements declare she was in her "middle age" years and years ago.

In fact, she has a living son, who was not the first born, whose age is reported in the 80's. The son, Jeff Wilson, is blind and lives with his mother.

DECISIVE CONFLICTS BELIEVED UNDER WAY IN TWO MAJOR WARS

J. Nat Harrison Heads Chamber Of Commerce

Other Officers Elected at Meeting Here Last Night

President

J. Nat Harrison, a comparatively new comer to Greenville, but one who has taken an active interest in civic affairs and has won quite a reputation as one of the city's most public spirited citizens, last night was elected president of the rejuvenated Greenville Chamber of Commerce.

Mr. Harrison was elected to head the body at a meeting of 20 representative business and professional men held at the city hall at the call of Mayor M. K. Blount and with the endorsement of old officers of the organization.

J. B. Kittrell, Greenville broker, was elected vice president and Joseph M. Taft, member of the Board of Aldermen and a local furniture dealer, treasurer.

All three officers were named unanimously.

W. H. Dail, Pitt county horse and mule dealer, Farm Bureau enthusiast and farmer, always can be counted on for a rousing talk and at last night's meeting pointed to the need of such an organization here.

He declared that Greenville had gone far without any organized efforts and predicted even greater things with an active Chamber of Commerce. He said that Greenville stood to secure new industries and large pay rolls if they were "gone after."

Others made talks, all emphasizing the need of a sponsoring body for Greenville.

The new president was presented by H. H. Waldrop. Mr. Harrison outlined in brief some of his ideas for developing a wide-awake Chamber of Commerce. He pledged to give the movement his whole-hearted support if those connected with the organization would do the same.

L. A. Stroud and J. H. Blount were named as a committee to confer with the Merchants association in regard to the possibility of the two working in co-operation.

President Harrison has taken the helm in other movements since he moved here from Petersburg, Va. Although handicapped because of opposition to an individual drive for the Red Cross, he handled the annual Roll Call last fall and established what is believed to be a national record in the percentage increase in membership. He has been active in the local movement to secure the \$150,000 veterans' hospital for this community. He is engaged in the insurance business and a member of the Kiwanis club.

Warns Farmers Not Start Unauthorized Brush Fires

Raleigh, April 1.—Beginning today landowners in 58 of North Carolina's 100 counties cannot set fire to brush on their own land without a permit—and that's no April Fool joke, either; it's the law of the land.

After June 15 and until All Fools Day comes around again next year they will not need to ask anybody whether they can start a brush fire or not.

The Department of Conservation and Development, through Assistant State Forest W. C. McCormick, in charge of the forest fire prevention division, has just issued warning to that effect.

The law applies in the 58 counties cooperating in the forest fire control program. In them persons desiring to start brush fires on their own land must first obtain a permit from the county or district Forest Fire Warden. The law also provides that any person setting fire to brush after having obtained the

necessary permit, must watch the blaze and extinguish it before it spreads onto any adjacent land.

No burning permits are required in the 42 counties not participating in the fire control program, but the law does require that fires started in these counties must be watched and kept under complete control.

Another provision of law called to general attention by McCormick is that any person, firm or corporation operating a tar kiln, charcoal pit, or who sets fire to any grass, brush or other material which might endanger any abutting property, shall maintain a watchman for such burning operation under penalty of a fine of from \$10 to \$15.

"We have been getting excellent cooperation from the landowners in many counties and we feel sure this cooperation will continue since more and more of them are becoming aware of the damage fires can cause if they are not properly set and watched," McCormick said.

CHINESE AND SPANISH ARMIES ARE BEING FORCED BACK

SPAIN PREPARES NEW DEFENSIVE

Chinese, Meanwhile, Fight Desperately to Defend Little City of Taierschwang

(By Associated Press)

Both the Chinese and Spanish armies fought with their backs to the walls today in battles that may prove decisive in the wars of East and West.

Spanish insurgent commanders declared they had seized dominating positions at Lerida, "gateway" to Barcelona, the Government seat and hub of its resistance.

Government forces, however, had prepared a new defensive line 10 miles to the east, on which to fall back if their hold on Lerida, 80 miles from Barcelona, is broken.

Border reports told of a steady stream of soldiers and civilians fleeing to France from Spanish Government territory. One thousand troops and 2,000 civilians crossed the frontier yesterday. French guards were posted to control the border as the flow continued today.

Bagneres de Luchon, France, sources said, thousands of Spanish military and civilian refugees fleeing before the great insurgent drive through northeastern Spain packed that French mountain resort after days of terrible hardships in the Pyrenees.

Through deep snow the refugees plodded toward a haven in friendly France, but many of their companions already had met death in plunges into snow-filled canyons.

The refugees arrived in desperate need of food and shelter. But all were warned their respite in France would be brief.

Chinese, meanwhile, desperately defended the little city of Taierschwang, where fierce street fighting has continued for eight days with all the modern weapons of war and with primitive knives and broad swords.

Taierschwang, in Shantung province, may be the key to Japanese drive south toward the east-west Lunghai railway.

Disbarment Case Arguments Heard

Raleigh, April 1.—North Carolina's Supreme Court has taken under consideration the question whether the State Bar, a body vested with wide power to discipline members, can disbar an attorney for offenses committed before July 1, the effective date of the act creating the organization.

In the case of John M. Brittain, a practicing attorney of Randolph county, Judge J. A. Rousseau in Superior Court held that the Bar has no such power and sustained a demurrer filed by the respondent. The State Bar appealed and the case was vigorously argued Thursday before the Supreme Court.

It is another chapter in interpretation of the State Bar act—an act which has been before the Supreme Court many times since the legislature took away from the courts many of the functions they had previously exercised, including the examination of prospective lawyers.

According to the record and arguments in the Brittain case, the lawyer pleaded guilty in a North Carolina court in January, 1933, to a charge of false pretenses and was sentenced to serve two years in state's prison. The offense was alleged to have been committed on January 16, 1933. In Federal court he pleaded guilty to a forgery charge. In September, 1933, the offense having taken place August 2, 1932.

In the State Bar's brief before the court it is contended that the mere fact that the offenses were committed before effective date of the State Bar act does not take away the power of the Bar to disbar. They point out that the admitted felonies show him to be professionally unfit to practice law just as clearly where the acts were committed prior to July 1, 1933 as if they had been committed thereafter.

It's all quite involved in technicalities, but it is a question of live interest, particularly to the legal profession.

Chairmen of the various committees for the World Trade Exhibit which is being sponsored jointly by the A. A. U. W. and the Greenville Council for Peace Action, met early this week to report on work done and progress made in the preparation for the exhibit.

Mrs. E. L. Hillman of New Bern, general chairman, attended the meeting and received the reports. Throughout the session there was marked evidence of intense interest and enthusiasm for this project as the various plans were outlined.

Washington Daybook

By Preston Grover

Washington — So thinned out are the ranks of elder statesmen in this country that if Chief Justice Hughes should resign from the Supreme Court now he probably could have the chairman ship of the group.

In reality there is no such thing as a chairmanship of the elder statesmen but it would be hard to point to any of the remaining senior statesmen who could present such credentials.

All this develops, of course, out of the death of Colonel House, whose rocket-like career during President Wilson's administration gave him a high rank in history, although in just what capacity will be known only a century from now.

Within the past year or so death has taken such figures as Newton D. Baker, wartime Secretary of War; Elihu Root, Secretary of State, and now House. Among those remaining are Bernard Baruch, chairman of the War Industries Board in 1917-18; President Nicholas Murray Butler of Columbia and Hughes. Others could be named, but we have to stop sometime.

Hughes, on a showdown, could point to service as Secretary of State; two periods on the Supreme Court, the second as Chief Justice; governorship of New York; and a presidential nomination.

Sought Peace
Doubtless Hughes would have his critics, and House had his. Even when House died there were some here who would not comment at all upon the event. Propriety prevented their saying anything bad about him and they would not be caught saying anything good.

House fit and bled trying to lead the United States into the League of Nations. He said recently in an interview that he wrote the first draft of the League, after discussing it generally with President Wilson. Both he and Wilson were ailing at the time they returned from France to present this new cooperative peace move to the United States. Besides that, Wilson had strangely cooled toward House.

It was a sample of the disunion of forces which peace-planning societies experienced so often afterward that House, about two years ago, set out to do something about it, although he then was 77 years old.

He brought about a meeting of himself, President Butler of Columbia, Newton D. Baker, and Senators Thomas of Utah and Pope of Idaho. The Senate had just rejected a further proposal for U. S. adherence to the World Court. The five were virtually unanimous in the opinion that failure of peace organizations in the country to work together was responsible for defeat of the World Court adherence.

All is not peace, even among the

SHORT SHOTS

Raleigh, April 1.—Considering the fact that even judicial races have distinct political angles, it is worth noting that in only one of the ten Superior Court contests this spring is there any possible "factional" angle; and that angle isn't too apparent in that one instance.

Down in the Second it may be that Timous Valentine is trying to make political capital out of his well-known and long-standing "Anti" classification; but even here the gentleman named "after the famed Saint" isn't basing his case primarily on opposition to the state Administration. It's true that he savagely fought Governor Clyde R. Hoey's election, while incumbent Walter Bone was for the present Mansion occupant; but Timous had cast his hat in the ring as an opponent of Judge M. V. Barnhill (now comfortably assured of reelection to the Supreme Court bench) ever before Bone was named to the post.

Elsewhere along the line every single solitary judicial aspirant supported Governor Hoey either in both primaries, or at least in the runoff of 1936. This column has the Governor's word for that and it is on his authority this state is made.

In the First, Herbert Leary and C. A. Thompson were Hoey men from A to Z.

In the Sixth, James A. Powers started and finished as a Hoey booster. Henry L. Stevens fought hard for Sandy Graham in primary number one, but was Hoey in the second.

In the Eighth, John J. Burney backed Sandy in the first, Hoey in the second primary. Clifton Moore was on the winning side all the time.

And so on down the line. Even in the five-cornered Ninth District race there isn't a contender who was for McDonald—at least that's what the Governor says, this correspondent wouldn't know of his own knowledge.

Pursuing the same thought into the statewide primaries, it can be said that "factionalism" isn't factor in any of them, although an effort has been made to cast Paul Grady of Kenly in the role of Anti-Administration Candidate for Utility Commissioner. This effort was rebuffed by Grady in his announcement in which he went to particular pains to speak of "our great governor."

It isn't likely that either U. S. Senate Candidate supported Governor Hoey in the first primary in 1936. Authentic reports have it that "Our Bob" Reynolds cast his absentee ballot for McDonald in both primaries. Frank Hancock was a reputed Graham supporter in the first primary and wasn't a bit vocal in the second.

And in the Congressional contests the only effort to inject the 1936 issues has come from Major Edey Ridge in the Sixth. The Greensboro radio station manager has given wide publicity to his endorsement by McDonald.

In other House seat races there may be under cover behind the scenes efforts to cash in on past intra-party squabbles, but they have not yet come to the surface.

Speaking of political appointments—though nobody was two nominations to office made by Governor Hoey as unadulterated, uncondemned rewards for help put him in the governor's chair have resulted in a 50-50 split between happy and embarrassing results.

Hubert Olive of Lexington, placed on the Superior Court bench solely because he managed the Hoey drive in 1936 is being almost unanimously acclaimed as an able judge and a credit to North Carolina Judiciary.

Cutler Moore, assistant to Olive in the gubernatorial primary, has received more criticism—deserved or undeserved—as chairman of the state liquor board than any other Hoey appointee. He has been constantly in an unfavorable limelight. It may be that the place he fills is one which is calculated to draw criticism, but whatever the reason, Moore has had more than his share.

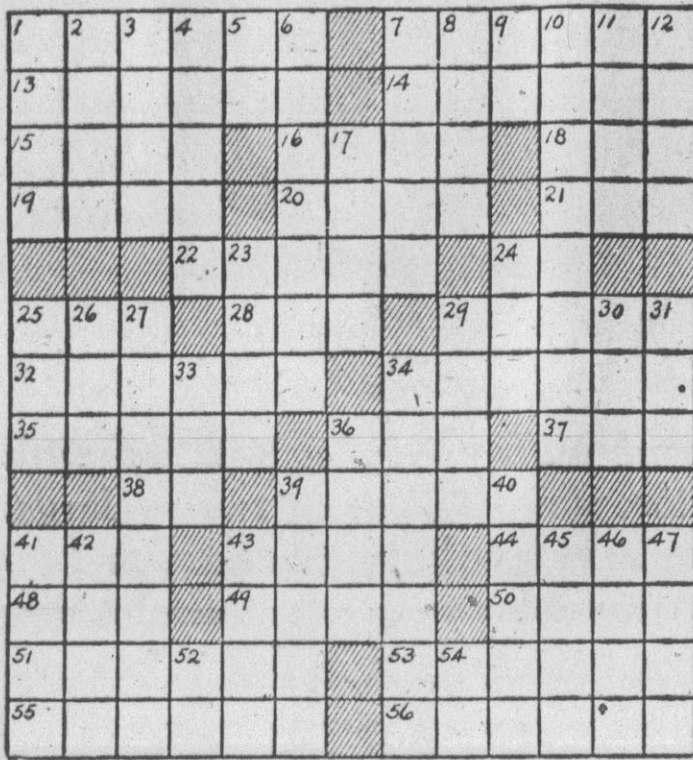

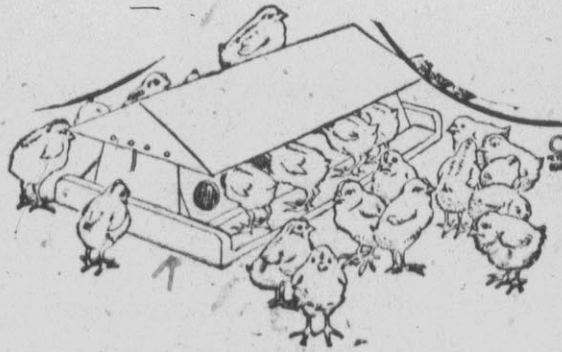

Air "Squeezing" Is New Means Of Heat Control

Spokane, Wash., March 31.—(AP)—"Pasteurized" air conditioning, achieved by an air "squeezing" process so simple its inventor hesitates to apply for a patent, has been developed by a Spokane theater engineer.

Using an ordinary air-compressor, an expansion tank and sundry other pieces of equipment already on the market, Vernon L. Hickey devised the revolutionary compressed-air-conditioning principle.

Hickey achieves his cooling through expansion of the compressed air, eliminating the use of ice or other cooling agents.

Temperatures rise from 240 to 400 degrees when the air is compressed, killing the germs and performing the pasteurization.

The compressed air is released into an expansion tank where it "un-squeezes" and drops water and other foreign particles. Pipes from the expansion tank go directly to the rooms to be conditioned.

The principal advantage of his system, Hickey says, is the complete control of humidity and temperature. The humidity may be held to any point from zero to the dew point and the temperature anywhere between zero and 120 degrees.

Through conservation of compression heat, Hickey believes he will be able to air-condition modern buildings and homes on a year-around basis, cooling the mirth sterile air in the summer and heating them by the same method in the winter.

He estimates a three-fourths horse power motor would air-condition, cool and heat the average eight-room house.

The East Carolina Teachers College baseball team is stepping into big time baseball Saturday afternoon when they tackle the strong Ohio Wesleyan University team of Delaware, Ohio, in a doubleheader beginning at two o'clock.

The Ohioans boast of one of the strongest teams in the Buckeye Conference and have won four of the five games played on this trip. The Visitors are coached by Chas. Gauthier, former big timer league baseball player and long recognized as one of the top coaches in the game. Coach Boland Farley's boys have won four of their four starts and are hopeful of giving the invaders a good game despite the fact that the visitors have a much larger student body from which to draw and due to their superior experience in baseball. It is likely that Bill Holland will pitch one of the games against the Ohio University team and Kelly Martin the other. In Robin Blatz the visitors have one of the finest college catchers in America. He is much sought after by big league scouts and it is probable that he will enter professional baseball upon graduation this June.

Since this marks E. C. T. C.'s debut into big time baseball a record crowd is expected.

Republicans Have Seven Candidates Out For Congress

State GOP to Offer Opposition To Democratic Candidates in Only Seven of 11 Districts

Raleigh, March 31—North Carolina Republicans will this fall offer opposition to Democratic congressional nominees in only seven of the state's eleven districts. Two years ago the G. O. P. put up candidates in all eleven.

The difference is that there was a national presidential campaign in 1936 and the minority party tried hard to get out its full vote in all sections by putting up as many local and district candidates as possible.

There hasn't been a Republican elected to Congress since the 1928 upheaval which saw Herbert Hoover carrying the state and carrying Charlie Jonas and George Pritchard into Congress along with him.

There isn't, according to the present outlook, more than an exceedingly remote chance for any Republican to pull through this time, as it would take nothing less than a political earthquake to shake the tremendous Democratic majorities of the 1936 elections.

The G. O. P. will attempt to do a bit of shaking, however, in the Fourth, Fifth, Seventh, Eighth, Ninth, Tenth and Eleventh Districts.

In the Fourth they have put up Willis G. Briggs, Raleigh lawyer, as a sacrifice to Harold C. Cooley. Two years ago Cooley polled 56,703

votes to the 17,179 cast for A. L. Feree, his Republican opponent.

In the Fifth John W. Kurtes, Jr. of Winston-Salem will battle the Democratic primary winner, who will almost certainly be Long Folger. Two years ago Republican Edward F. Butler got 17,671 to the 48,500 cast for Frank Hancock.

John R. Jones of North Wilkesboro, will try to win the Eighth against one of the five Democratic nomination seekers. The district was Democratic in 1936 by 54,846 to 30,659.

Monroe Adams in the Ninth must reverse a 60,223 to 32,659 vote given R. L. Doughton in 1936.

Morganston's Frank Patton, faces the biggest Democratic vote piled up in 1936, the 81,059 cast for Major A. L. Bulwinkle to Calvin Edney's 42,650.

Young L. Gudeer in the Eleventh succeeds to the biggest G. O. P. vote in any district in 1936, but that was only 43,346 to Zeb Weaver's 73,645.

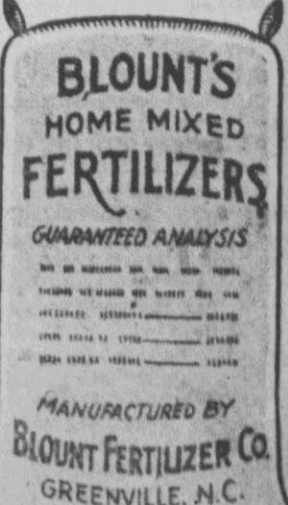

Young Persons

Rocky Mount, April 1.—Rela-
tives of several young men and
women in this section have received
Government checks, recently, in
payment of death claims for old-
age insurance provided by the So-

Social Security Board at Rocky
Mount, said today. Benefits which

ployees are not lost, in case the
young man or woman dies, after
working for awhile in a job cov-
ered by old age insurance provisions
of the Social Security Act. "Whether a deceased worker may
have been 16 or 60 makes no dif-
ference," said Mr. Adams. "If his
wage or salary record shows that
he had participated in the Govern-
ment's old-age insurance program,
