

DECREE POWER FOR DALADIER UP TO SENATE

Proposal Backed By Huge Majority of Deputies

STRIKERS BEGIN RETURN TO WORK

Deputies Talk Excitedly of Renewal Of Confidence in New French Government

Paris, April 13.—(AP)—Backed by huge majorities in the Chamber of Deputies, Premier Daladier rushed to the Senate today for final action, his "national defense" ministry's bill, giving him power to govern French national economy by decree.

Socialist and Communists joined Centrists and Rightists yesterday in the House in passing, 508 to 12, the decree power bill, the power that was refused Socialist Premier Leon Blum twice and Radical Socialist Premier Camille Chautemps once.

Deputies talked excitedly of a renewal of confidence in the government as a result of Daladier's victory in the Chamber, together with approaching settlement of widespread metal workers strikes.

Strikers began returning to work in the aviation plants this morning allowing partial resumption of production of planes and motors for France's armament program after Daladier had threatened to end the strikes by force.

Work was resumed in two factories and it was announced operations would resume tomorrow in a number of other factories involving a return of 25,000 men altogether.

The strikers feared after the Premier's threat that they would be mobilized and sent back to the plants as soldiers.

Teachers' Checks Here For Delivery

BIG FIRE LOSS REBEL FORCES IN MORGANTON QUICKEN PACE

Heart of One of Main Business Blocks Destroyed

Morganton, April 13.—(AP)—Fire of undetermined origin destroyed the heart of one of Morganton's main business blocks early today, causing damage estimated at more than \$50,000.

The blaze, which began around 1 a. m., destroyed the furniture and hardware store of Kirksey and company and gutted the Morganton Industrial bank and the Burke County Building of Loan Association which occupied part of a large two-story building.

Firemen and equipment from Hickory, Lenoir and the State hospital joined the Morganton firefighters in fighting the flames, which for a time threatened the whole block. The blaze was brought under control within two hours.

The fire was confined largely to one building, opposite the Burke county court house, and damage to this structure was estimated at \$20,000.

Officials of Kirksey and company said their entire stock, which they valued at \$35,000, had been lost.

With The Insurgents in Spain—April 13. (AP)—The insurgent drive toward the Mediterranean quickened its pace today on the southern sector of General Francisco Franco's troops captured Cien, only 14 miles from the coastal city of Vinazco.

The insurgents also occupied two rugged highlands lying north and south, respectively, of the vital Morla-Venezuela highway.

A point three miles north of San Mateo was strongly defended by Government infantry, supported by artillery and airplanes.

On the front further north the insurgent command have blasted their way through the Government's last mountain defense on a part of the Catalan front.

Elsewhere north to the French frontier, insurgents appeared to be checked.

The battle in the south, however developed into one of the most brilliant tactical operations of France's campaign.

MAY INCREASE FEDERAL ROAD APPROPRIATION

Budget Bureau Probably Will Recommend Increase

PRESIDENT URGES TAX ON PROFITS

Declares Opponents' Suggestion Would Strike at Fundamental Tax Principles

Washington, April 13.—(AP)—A House Appropriations Committee member said today the Budget Bureau probably would recommend that the House add \$92,000,000 to the \$100,000,000 road fund carried in the pending Agriculture Department supply bill.

Chairman Cannon (D-Mo.), of the Appropriation sub-committee, which prepared the measure, said that D. W. Bell of the Budget Bureau, "is studying the increase and we hope he will approve the increase before we pass this bill."

Meanwhile, President Roosevelt urged Congress to retain the principle of the bitterly disputed undistributed profits tax, but met stubborn resistance from the Senate Finance Committee.

Attacking provisions of the Senate tax bill which would eliminate the undistributed profits tax, opposed by business, and substitute a flat capital gains tax for the graduated system now used, President Roosevelt wrote chairmen of the Senate Finance and House Ways and Means Committees:

"The repeal of the undistributed profits tax and the reduction of the tax on capital gains to a fraction of the tax on other forms of income, strike at the root of fundamental principles of taxation."

"Business will be helped by these suggestions."

Chairman Harrison (D-Miss.), of the Finance Committee, commented tersely: "The Senate conferees will insist in conference on the amendments adopted by the Senate."

The President and his economic advisors worked at top speed to complete a new recovery and relief program, apparently agreed upon at a long night conference at the White House.

While the conferees did not disclose details, it was indicated the key element probably would be a proposal to spend \$1,500,000,000 on public works as a means of reviving business and industry.

Both public works and relief proposals were expected to be covered in the presidential message to Congress tomorrow noon.

The President will have a final talk on the message with congressional leaders at 5 p. m.

Court Dismisses Appeal For Kings

Raleigh, April 13.—(AP)—The Supreme court dismissed today the appeal of Paul and Everett King, operators of the Ideal Social club here, who were convicted of possessing liquor for the purpose of sale.

Counsel for the Kings had failed to perfect the appeal as required by court rules. The men were sentenced in Wake Superior court to six months each on the roads.

The court was to hand down opinions late in the afternoon and tomorrow was to hear more oral appeal arguments, probably reaching the case in which Bill Payne and Wash Turner, convicted desperadoes, are appealing from death sentences for the killing of George Penn, highway patrolman.

GROVER SMITH OUT FOR POST

Announces for Commissioner Against Roy T. Cox

Grover Smith, at present constable of Chitwood Township, today announced his candidacy for Commissioner from the Fourth district, which position is now held by Roy T. Cox, who has announced for re-election.

"This makes contests for two of the five seats on the Board of County Commissioners, G. H. Pittman of Falkland, and B. M. Lewis of near Farmville, incumbent, having announced from the Third district."

To date these are the only two districts in which contests for the board have developed.

A review of the political situation in Pitt county shows contests for several offices which promise to be spirited.

To date two candidates have announced for sheriff, an office now held by S. A. Whitehurst, who is expected to announce later. R. W. King and E. L. Nichols are the two who have publicly stated intention to seek the office.

Three candidates are out for the judgeship of County court, Dink James, incumbent, J. W. H. Roberts and Ham Hannah, all Greenville attorneys.

So far no one has publicly announced for the solicitorship of the court, although Charles Whedbee is expected to seek re-election.

The office of Clerk of Court is to be filled at this election. So far no one has announced for the post, but the veteran clerk, J. F. Harrington, is expected to seek to retain the post.

J. C. Gaskins, Register of Deeds, will retain his office without the possibility of a contest, the term not expiring this year.

Two candidates are out for the State Senate, Arthur B. Corey and J. Con Lanier, both Greenville attorneys.

Four candidates are out for the two Pitt county seats in the State House of Representatives. They are John S. Moore of Bethel, incumbent, William S. Tyson, H. H. Duncan and Sam O. Worthington.

Two Pitt county men are seeking the district solicitorship. They are D. M. Clark, incumbent, and John Hill Paylor, members of the House of Representatives for the past several years.

To date only one contest has developed for the office of township constable. In Chitwood three candidates are out for the office. They are Zeno Dixon, J. H. Harris and Jasper Lee Mills. The only other candidate known to have publicly announced for constable is Aaron Mills in Winterville.

Candidates for county offices have until April 23 to file with the County Board of Elections.

STATE CLAIMS LIFE OF NEGRO

Pays Death Penalty For Murder In South Carolina

Columbia, S. C.—April 13.—(AP)—Twenty-three hundred volts of electricity stiffened the body of Ernest Gaines, 28-year-old Saluda county Negro, into eternity today as the state claimed his life for the slaying of B. Coleman last January 30.

The Negro died at the penitentiary without giving the motive for the killing. His last words were: "If my folks were here I might tell more."

Two brothers, H. V. Coleman and Weyman Coleman of Columbia, who attended the electrocution told news men they believed robbery was the motive, as their brother's pocketbook was never located after the slaying.

The sun was coloring the horizon as the switch was thrown on. The current was left on for a while. Physicians declared the prisoner dead two minutes and 35 seconds later.

Gaines prayed for himself, kneeling at his bunk.

Officers brought the Negro to the chair. He went to his death before 60 witnesses in the death chamber. A majority of the white men present were from Saluda county.

Scott Cites Record As Answer To His Critics

Raleigh, April 13.—Kerr Scott, state Commissioner of Agriculture, hardly takes the trouble to answer the many criticisms hurled at him and his department but under-officials and employees—all of whom appear to be stout defenders of their boss—emulate Al Smith in demanding: "Let's look at the record."

They cite facts and figures designed to show that the department, in its something more than a year under the Scott regime has in fact been revitalized; and the claim that the progress already made will be consolidated and extended.

Here are listed some of the things Commissioner Scott's friends point to with pride, as conclusive answers to his criticism.

1. Appointment of an Assistant to the Commissioner, D. S. Coltrane, in charge of fertilizer, feed and seed inspections. His work is bringing up to date the seed, feed and fertilizer laws is claimed as an outstanding achievement.

2. Increase in number of seed inspectors from two to four, which has doubled the efficiency of the feed inspection service.

3. Merger of the pure food and fertilizer analytical divisions under one administrative head (the state chemist) with resulting increase in efficiency and economy. Increase in food inspectors from two to four.

4. Addition to the Seed Laboratory—been tripled and this year more than 100 samples were turned out each day. Since Commissioner Scott took office the department has more than tripled seed services and test to the farmers.

LUCAS FORGES INTO FRONT OF ILLINOIS RACE

Takes Lead for Democratic Senatorial Nomination

EARLY RETURNS PUT IGEO AHEAD

Both Candidates In First Primary in Nation Pledged to Back Roosevelt

Chicago, April 13.—(AP)—An avalanche of late down-state returns today swept Congressman Scott Lucas, adherent of Governor Henry Horner, into the lead for the Democratic U. S. Senatorial nomination.

Lucas forged in front after whittling down a lead of 70,000 votes piled up earlier by U. S. District Attorney Michael Igoe of Chicago, who was backed in yesterday's primary election by the Democratic organization headed by Edward Kelley, Mayor of Chicago, and National Committeeman P. A. Nash of Chicago. Lucas and Igoe had pledged allegiance to President Roosevelt.

Returns from 6,451 of the state's 8,286 precincts gave Lucas 602,281 and Igoe 601,674.

Lucas is serving his second term in Congress.

Governor Horner and State's Attorney Thomas Courtney of Cooke county joined in a statement that all candidates on the ticket had been nominated by safe majorities.

The Democratic factions contested for the nomination of 27 Congressmen, including two at large, State Treasurer Superintendent of Public Instruction and Clerk of the Supreme court in the state-wide primary, first in the nation this year.

Republican candidates, behind when party organizations had united, were nominated without a struggle.

Concerns Observe Walsh - Healy Act

Reflector Bureau.

Raleigh, April 13.—North Carolina industrial concerns with government contracts are scrupulously observing provisions of the Federal Walsh-Healy act, Commissioner of Labor A. L. Fletcher said today.

The State Labor Department has been cooperating in checking on compliance with this statute and so far not a single violation has been reported, Major Fletcher said. The act has been in effect for something like a year.

Under provisions of the Walsh-Healey act, all firms supplying goods to the United States under contract are forbidden to work an employee more than 40 hours a week and are also forbidden to employ any child labor.

Inasmuch as the state's laws regulating hours and age of employees are quite different from the Federal act's requirements, all North Carolina firms which have won government contracts are observing its terms.

Major Fletcher said that his department is from time to time notified by the Federal government that certain firms in North Carolina have been awarded government contracts for certain goods. The State Department is asked to check up on observance of the Walsh-Healey act, and to report to the Federal authorities the results of the check-up.

Cooperation with the Federal government is not difficult or expensive, Major Fletcher said, as one of the state's labor inspectors is certain to be within easy distance of the firms on which a check-up is desired, and it is usually possible to make the inspection asked by the U. S. officials at the same time as a regular state check-up.

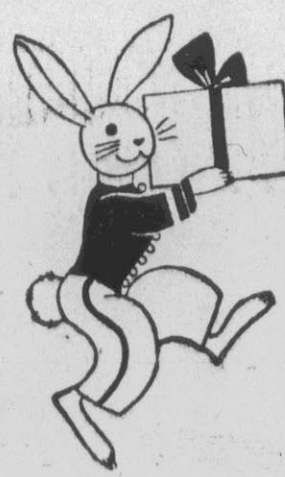

Hollywood Sights And Sounds

By Robin Coons

Hollywood—if you take a drug called "paradol" your sensations—before you die—will be amazing.
Edward G. Robinson detailed them to his victim, having just "poisoned" Humphrey Bogart with it for a scene in "The Amazing Dr. Clitterhouse." It was a curand scene, besides. A close-up of Robinson, scientifically intent on the "dying man," the scene operated without benefit of Bogart, whose lines were read by the dialogue director.

After a good stiff drink of this "paradol," however, this is what happens: the room's walls shrink every object contracts in size, the victim hears a rumbling in his ears, and then—this on testimony of Bogart—you don't hear "very good."

A Screen Invention
All this is amazing for two reasons: first, that Robinson seems to know more about it than Bogart, who's supposed to be dying from it; second, there isn't any such drug as "paradol." Dr. Leo M. Seauinman, the film's medical adviser, coined the word—because movies mustn't give people ideas.

Cameramen on this film is Tony Gaudin, who's been shooting stars since the Biograph days. Tony's Italian-born and there's still a bit of it in his speech. But not much which ought to make this funnier: Tony was behind the camera when Greta took her first Hollywood tests, and he shot her first two pictures here. In those silent days the players read lines even though there weren't mikes, and Greta's English was mostly Swedish. Well, Tony left M-G-M, and he hadn't seen Greta in all those years until the day he visited her set while she was making "Conquest."

She greeted him like an old friend, and then in some amazement cried: "Ah, but Tony! You speak with a dialect."

No Recession For Them
They say there's a recession hereabouts, but Fred MacMurray and Douglas Fairbanks, Jr., haven't heard of it. MacMurray technically is in three films at once. Barely finishes "Cocoanut Grove" in time to go into "Sing You Sinners" with Bing Crosby, and all the time he's the lead in "Men With Wings," although they haven't come to his scenes yet.

And Fairbanks, doing a \$100,000 job with Danielle Darrieux in "The Rage of Paris," does night work on the re-takes of "Having Wonderful Time."

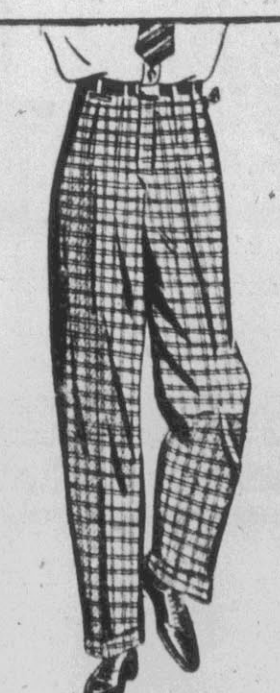

Washington Daybook

Washington—Senate hearings on
the War Department appropriation
bill indicate the United States army
is on the defensive—against getting
too much money.

That any government depart-
ment should back away from pro-
fessing of favored budgets is almost
more than this city of continual
emergencies can endure. The sock-
is almost killing us. But put your
ear down and listen.

Senator Copeland: Ought we
to have some good modern 16-inch
guns to protect New York harbor?
General Craig (chief of staff):
The present seacoast armament in
the harbor defenses of Sandy Hook
is considered adequate.

Copeland: As far as Fort Tilden
(on Long Island) is concerned,
are the conditions there satisfac-
tory to you?
Craig: Yes, sir.

London Is Different
In turn, General Craig assured
Senator Copeland about the har-
bor defenses of Boston, Portland,
Me., and Philadelphia. They don't
need any more money for coast
guns than already is in sight, the
general said.

He was more eager about anti-
aircraft guns. For complete de-
fense of strategic objectives within
striking distance of a flying enemy
the army should have 408 anti-air-
craft guns costing \$40,000 each,
Craig said.

But, said Copeland, London
alone has 900 guns. Craig said con-
ditions there were different. He
explained that 34 regiments equip-
ped with anti-plane guns could
take care of both U. S. coasts. The
guns could be moved about fast
enough to meet any enemy threat.
Of the 34 regiments needed, the
army has four in the regular ser-
vice and ten in the national guard.
The other 20 will be shaped in the
regular army on an emergency
basis, when the time comes.

Craig was willing to go slow,
seemingly content with the 141 anti-
plane guns to be provided in the
appropriation bill as it passed the
House, although he said the re-
maining 267 were "essential" for
true defense. Before the commit-
tee finished, however, it had
doubled the \$12,700,000 appropri-
ation for anti-plane guns and eq-
uipment so the army can have 308
as fast as it can build them instead
of only 141.

Thought For Today
Just so you won't worry so much,
you should understand that it isn't
necessary for an anti-aircraft gun
to hit a plane to bring it down. Said
Craig.

"A high-explosive shell burst-
ing in the upper atmosphere has
the same crushing effect that a
depth bomb has upon a subma-
rine."

If it explodes anywhere near
the plane, it wrecks things.
Craig would not be drawn into
the argument as to whether a gun
on the ground can cripple a plane
before the plane bombs the gun on
the ground. "I don't know," he
said.

He did agree that the army's
plans for anti-aircraft defense
could be completed for something
under the price of one 45,000-ton
battleship.

lina Kiwanians will meet here April
19 to hear Dr. Harl D. Douglass,
head of the educational division,

guidance conference.

Allison W. Honeycutt, of Chapel
Hill, chairman of the Carolinas
district guidance committee, said
today representatives of 75 clubs
were expected.

Carolinas District Governor Ames
Haltiwanger, of Columbia, S. C.,
and lieutenant governors of the 9
Carolinas divisions also will attend.
Dr. Douglass will speak on "The
Youth Problem and Kiwanis Inter-
national." Pearson, member of the
international committee on voca-
tional guidance, will discuss "Re-
sponsibility of Kiwanis leadership
in vocational guidance."

those with whom this correspond-
ent has talked give the Wilson man
a fair chance to unseat the incum-
bent. Warning is issued that many
said the same thing about A. O.
Dixons two and four years ago, yet
Judge Kerr is still drawing \$10,000
annually (plus mileage and perqui-
tes).

Third: Congressman Graham A.
Barden will not have as tough a race
against Charles L. Abernethy, Jr.,
as he did in 1936.

Fifth: The size of Lon Folger's
majority over George Fulo and Mar-
shall C. Kurfies is about the only
question here.

Sixth: Here we've got something
—no less than eight candidates. Al-
most all prophets agree that Oscar
Barker of Durham, will get into a
run-off with somebody; this predic-
tion based on the fact that there
are so many Oulford entries in the
race. Latest tip is that Lewis Teague
of High Point, is running strong not
only in his home county but in Al-
lance. Major Edney Ridge may
kindle enough Roosevelt and New
Deal enthusiasm to surprise reason-
ed observers. George Penn isn't to
be sneezed at as a vote getter.

Eighth: Another horse race with
five entries. At a distance and with
no real inside information, it looks
like William O. Burgin of Lexing-
ton, against one of the "lower" dis-
trict entries (Roland Beasley, C. B.
Deane and George Ross).

Tenth: Major Bulwinkle to pull
through by reason of Mecklenburg's
well-known inability to give its own
a united backing. Ham Jones has
lost twice before and probably has
the habit.

This is the season of the year when

glades?

itting silent but cruel "Ha's" when-
ever the fragile heroine hove into
sight. The Hotel New Yorker has
begun a series of revivals for din-

tures of Helen Holmes, leaping off
trains, and of Ruth Roland who
laced a thousand deaths every Sun-
day night in the old serials, each
episode ending with a iron claw
clutching at her throat, or the hero

How's Your Health?

Edited for the New York Academy of Medicine

GLAUCOMA

If neglected or improperly treated, glaucoma (green eye) frequently results in permanent blindness.

The condition arises from a disturbance in the circulation of the fluid content of the front portion of the eye. This disturbance subjects the eyeball and its contents to increased pressure. If unrelieved, the nerve of the eye is ultimately destroyed, and blindness results.

Glaucoma is rare before the age of 40. The specific cause of the condition is unknown, but pre-existing eye strain and uncorrected defective vision are known to contribute to its development.

Every adult should know the common and suggestive symptoms of glaucoma. These are:

Hazy or foggy vision; colored rims around artificial lights; the loss of all or some vision lasting for a few minutes; a desire to change to stronger reading glasses; inability to see objects from the corner of one's eyes; that is, those not directly in front.

Together with these eye symptoms, there may be constitutional disturbances such as severe pain in the eyes and head, nausea, vomiting and fever.

Should any of these symptoms be experienced, it is imperative not to delay consulting a physician or eye specialist. Delay is dangerous and may lead to loss of vision.

An attack of glaucoma may last a short time and then subside, only to reappear in a week or two, or even sooner.

Unless the sufferer recognizes the nature of his symptoms and secures the required medical help, he may believe he is the victim of nervous headache, indigestion or biliousness. Treating himself accordingly, he is likely to waste precious time.

An injury to the eye—even a mild blow—may be followed by the development of acute glaucoma.

And then he was kissing the children goodby, kissing her, promising to write—He was going to work—going to the woods—to tall trees, leaping streams—

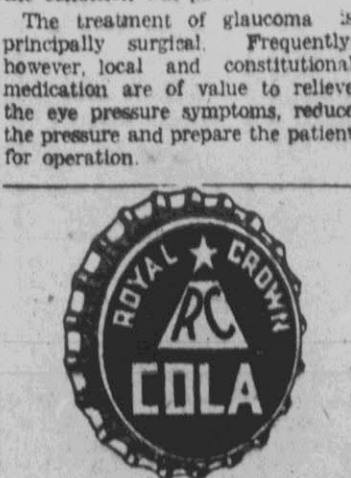
A rattle, a wheeze, the stench of motor exhaust, a cloud of dust—Reuben was gone—

Glaucoma does not tend to cure itself spontaneously. Hence there is no warrant for the hope that the condition will pass.

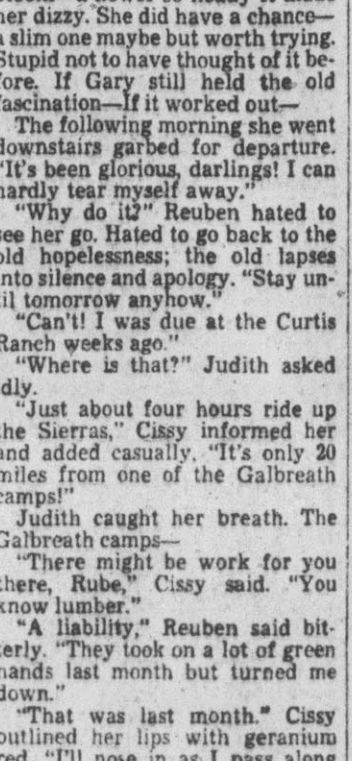

Warning Released By Department On "Adjuster" Frauds

Insurance Division Finds Many Tar Heels Paying Money To Concerns offering Training

Raleigh, April 12.—Warning was issued today by the State Department of Insurance that persons paying money to concerns advertising that they train insurance adjusters probably would not get any business and would in addition, be out of pocket just what they paid for the so-called "training."

The warning was specifically issued at the office of Commissioner Dan Boney when the representative of this bureau called attention to the fact that "Associated Adjusters of Milwaukee, Wisconsin," have been sending out literature in this section.

This particular concern, it was stated, were some time ago cited in a Federal fraud order for alleged misuse of the United States mails. The Department did not know what the outcome of the order was, or whether action on it is still pending.

Under North Carolina regulations, however, every insurance adjuster must have a license—and this license is granted only upon application of the adjuster and only when the ap-

plication is sought for him by the company by which he is to be employed. The Insurance Department has a special form for this application, which is signed on one side by the would-be adjuster and on the other by the company for which he is to work.

It follows that there cannot be any independent or free-lance adjusters in the state.

According to the literature sent out by the Milwaukee concern, it conducts an association which trains its members to become adjusters in cases of injuries and damages from accidents. A \$5 admission fee is charged, a commission is to be paid by the adjuster during the first year and thereafter a fee of \$1 per month for advertising by the association.

abroad.

7. Employment of A. B. Harless to give growers and others up-to-date information on the market conditions, prices and movements of crops.

8. Revamping of the fertilizer laboratories to the point where, with the same personnel, the department is now able to turn out 20 per cent more work. Two additional laboratories have been built, giving the farmers for the first time information on every sample as to whether the fertilizer is acid forming and the degree to which it is guaranteed.

9. Initiation of plans for building a cotton grading building to furnish growers additional information as to grade and staple of their product.

10. Commissioner Scott has secured \$4,500 from the general fund to match an equal amount from the Department of Agriculture to promote organization and auditing of rural and urban Credit Unions. State chartered Credit Unions have increased their resources by 36 per cent and their membership by 34 percent in the past year.

11. Operation of the State Fair by the state in such a manner that North Carolina had its finest fair in years, with a net profit of \$8,000 in cash and an additional \$7,500 in permanent improvements placed on the Fair Grounds. The number of individual exhibits was doubled.

12. Increase in membership of the State Board of Agriculture from five to ten, with authority on matters of policy transferred, at request of the Commissioner, to the board.

13. Appointment of a bee specialist to curb foulbrood disease.

14. Addition to the personnel of a gin inspector, to inspect and regulate cotton gins.

15. Addition of an agricultural statistician.

16. Complete revision of seed, feed and fertilizer laws to increase protection given the buyer as well as the honest manufacturer and grower.

17. Establishment of a peanut test sub-station at a cost of \$25,000.
