BOOST SOUGHT IN PASSENGER RATES DENIED

Interstate Commerce
Commission Renders
Decision

FIND PROPOSAL
NOT JUSTIFIED

Petition For Eastern
Roads Originally A
Part of Request On
Freight Rates

Washington, April 14.—(AP)—The Interstate Commerce Commission denied today an application by the Eastern railroads for permission to increase passenger coach fares from two to two and a half cents a mile.

The Commission, in its order, said it found the proposed increase not justified.

Railroads had estimated the half cent increase would have added \$30,000,000 to their revenues.

The eastern territory, in which the increase was sought, is bounded on the west by Lake Michigan, Chicago, Peoria and Springfield.

County Furnishes Ten Boys for CCC

Pitt County furnished ten boys for service in the April quota for the Civil Conservation Corps and this number was enrolled at Washington, N. C., Tuesday morning.

All enrollees for April are to have service in the Ninth Corps Area, which is Washington, Oregon and California. Pitt County boys and all boys received at Washington were immediately entrained to Fort Bragg for ten days seasoning before enlisting for the CCC camp on the West Coast.

They are enrolled on the condition that they re-enroll at the end of six months, which means that they must serve a year in camp. CCC authorities predict rather heavy enrollment for the next quarter in July but until that time no applications will be received for entrance in the CCC.

HANCOCK BIDS FOR DRY VOTES

Only Surprise Contained in Opening Campaign Talk

Raleigh, April 14.—Frank Hancock's opening "Senatorial song" of Tuesday night continued only one surprise note—a somewhat subdued but none the less resonant strain call for the dry vote to rally to him against incumbent Robert R. Reynolds.

Twice in the ten by-innuendo attacks on Reynolds he slurred the Buncombe man's stand on liquor. His lead-off "promise" took a pot shot at "Our Bob" for making a Senate speech in favor of liquor sales in the District of Columbia. His "fifth" was directed at a Reynolds bill which, in Hancock's words provided that "liquor may be given to dumb animals."

There wasn't a mention of Reynolds' name in the entire speech, both Frank and "Our Bob" having adopted the opera bouffe, musical comedy stuff of refusing to recognize the other's existence.

But there is no doubt in the mind of any listener or commentator that the ten Hancock promises were ten definite attempts to dress Reynolds in the "accoutrements of the clown," and the fact that two of them referred to the well known Reynolds witness—even though the (Continued on page eight)

S. C. HOUSE IN LONG SESSION

Single-Handed Twenty-Hour Filibuster Finally Crushed

Columbia, S. C.—(AP)—The house of Representatives ended its longest session on record at 7:27 a. m. today closing a 20-hour filibuster and giving final passage to the hotly-contested truck regulation measure.

Doggedly determined on forcing a third reading vote on the measure to increase truck weights from 20,000 to 40,000 pounds and widths from 90 to 98 inches, a majority of the representatives held the house in session continuously from 10 a. m. yesterday.

Representative Marion Horne of Richland broke all house records for a single-handed filibuster when he held the floor for 20 hours and 32 minutes in an attempt to stave off the vote.

Obviously whipped down by his experience he gave up the floor a few minutes after 7 a. m. and the weary-eyed Representatives immediately forced a vote, which was 55 to 21 in favor of the truck measure.

Members and house attaches agreed the session broke all South Carolina records since the body did not halt the meeting for meals or anything else.

The truck bill came as a surprise amendment to a bill which would require 50-mile-an-hour governors or motor vehicles. The amendment, adopted on second reading after debate was shut off, was identical to the bill passed by the senate and pending far down on the house calendar for weeks.

The Governor feature was removed from the bill in the amendment adoption.

COUPLE TAKEN AT NASHVILLE

Sheriff Whitehurst Leaves To Return Pair Here

It was revealed at the office of Sheriff S. A. Whitehurst today that he left this morning for Nashville, Tenn., to return Randolph Brown and Miss Hilda Ward Taylor to Greenville, possibly to face charges. Greenville, possibly to face last week and were arrested in the Tennessee city for local officials, but the exact charge or charges brought against them could not be learned.

Mr. Brown, a married man with children, has been in the employ of Clark Maytag company, while Miss Taylor has been employed as cashier at Laureates candy parlor.

Sheriff Whitehurst left here after receiving a telegram from Elkins Lewis, chief of detectives at Nashville, that he had the couple in custody and that they had signed papers, agreeing to return here without fighting extradition.

Brown's home is in Elizabeth City, only having been here a few weeks. The couple is said to have left an automobile belonging to the Clark Maytag company in Weldon and to have gone from there to Tennessee via train.

CHINESE LOANS CONSIDERED BY GREAT BRITAIN

Gov't. May Make Recommendation to English Banks

CHINESE CARRY BATTLE TO JAPS

Artillerymen Strike From Vantage Point At Japanese Garrison at Shantung

London, April 14.—(AP)—The government "has under consideration" recommendations to British banks that they grant long-term loans to the Chinese government, the House of Commons was informed today.

Dr. Sun Fo, China's Ambassador at large who came to Europe to seek financial help for China in her war against Japan, has been in London the last two weeks urging British loans.

Financial Secretary to the Treasury Colville told Commons if British banks approached the government for permission to lend to China such requests would be "sympathetically considered."

He added the Chancellor of the Exchequer was considering action to "encourage" the granting of loans.

Shanghai, April 14.—(AP)—Yihsein rapidly was being reduced to a war-torn city today as Chinese artillerymen from vantage points in surrounding hills bombarded the Japanese Garrison in south Shantung province.

Chiang Kai-Shek's warriors claimed to have scored a fresh success as they carried a small village commanding the gateway to Yihsein in the face of heavy fire from Japanese entrenched in the walled town.

Japanese, they said, had been reduced to receiving food supplies by airplane so severely were their fail communications crippled.

Yihsein is 25 miles north of Tairongwang, sup. railroad town north of the Grand canal, where Chinese last week forced Japanese to retreat from their advance down the Tientsin-Pukow line toward the Suchow junction with the east west Lunghai railway.

Negroes Strike As Whites Employed

Fayetteville, April 14.—(AP)—The Central Weaving and Spinning company, a silk mill employing Negro labor, was closed today after workers walked out when the management announced plans for the employment of some white labor.

The Negroes walked out last night when a small number of whites reported for duty and today the Negroes had formed picket lines.

There was no violence, although officers were called to the scene. Plant Manager M. Lefkowitz said it was not the intention of the management to replace Negro labor with white labor, but rather to increase the efficiency of the company by the employment of a few whites.

MEXICO SILVER SALE ALLOWED

May Be Sold to U. S. Through Means Of N. Y. Market

Washington, April 14.—(AP)—Secretary Morgenthau said today the Treasury had not barred Mexican silver from sale in this country.

Clarifying for the first time his announcement of two weeks ago that the Treasury was suspending its arrangements for purchase of 5,000,000 ounces of silver monthly from Mexico, Morgenthau said Mexico can still offer its silver for sale to the U. S. Treasury on the New York silver market.

"We buy all the silver offered us on the New York market at the price fixed each day," Morgenthau said. "That has always been our policy and we have no change in mind."

In effect, the only change made by the suspension of the Mexican silver agreement, he explained, was to eliminate the 5,000,000 ounce quota which gave Mexico advance assurance of how much silver it could sell the United States each month.

PLAN DEVISED AID BUSINESS

Chief Executive Declares Government and Business Must Work Together In Attack on Recession

Washington, April 14.—(AP)—President Roosevelt proposed today a \$7,000,000,000 recovery program, embracing \$5,000,000,000 of Federal spending and lending, and a \$2,000,000,000 expansion of bank credit.

Setting forth to Congress measures by which he said the government could "help to start an upward spiral," and summoning a "united national will" for a vigorous attack on the recession, Mr. Roosevelt told regulators who recently have dealt stunning defeats to major administration measures:

"Our capacity is limited only by our ability to work together. What is needed is the will."

"The time has come to bring that will into action with every driving force at our command. And I am determined to do my share."

The President declared that the will to cooperate passed "on all of us the duty of self-restraint" and that "there can be no dictatorship by an individual or a group in this nation save through division fostered by hate. Such divisions there must never be."

The chief executive reiterated in a message read to the House and Senate that "improvement in government and business practices must go hand in hand with recovery," adding:

"The Congress and the chief executive can ill afford to weaken or destroy great reforms which during the past five years have been effected on behalf of the American people."

The President started his program, designed to start national income upward again, into three groups of measures. The first involved mainly additional appropriation for the fiscal year beginning (Continued on page eight)

To Hear Evidence on Proposed Radio

While hearings on the proposed radio station for Greenville will not get under way before the Federal Communications Commission in Washington until May 3, preliminary government investigation of the matter will get under way here tomorrow when federal representatives will take depositions at the office of J. C. Lanier, local attorney. Both tomorrow and Saturday will be devoted to taking these depositions preparatory to the hearing in Washington in May.

Several months ago L. B. McCormick, of this city, filed application for a permit to erect a station here but his application was later withdrawn and the application now on file was made by J. J. White for the Greenville Broadcasting Company. If the permit is granted work will get under way immediately thereafter for the erection of a 250 watt station that will serve a 100-mile radius territory. The station will use the most modern equipment and be up-to-date in every respect, Mr. White said this afternoon, in announcing that the taking of depositions will begin tomorrow.

Hold Up Contracts On Road Projects

Raleigh, April 14.—(AP)—The Highway and Public Works Commission approved low bids today on seven of 11 projects which it received Tuesday.

Bids on a job for Tyrrel county were rejected as too high and projects in Halifax and Anson counties and roadway work in Haywood county were held in abeyance.

Chairman Frank Dunlap said he thought it might be night before the commission reached allocation of \$2,000,000 made available by Governor Hoy for secondary road work.

It was voted to have concrete paving on the northern approaches to the Albemarle sound bridge and sand asphalt on the south.

our forest fire fighting organization to the limit," he said. "In the first place, we had a very dry winter so that the woods were like tinder. Then came the warm, spring-like weather in February and March during which farmers and landowners started clearing and burning—which always means forest fires. High winds during March made the situation worse."

"Many of the county and district wardens frequently went 25 hours or longer without sleep, going from one fire to another. In one county 16 forest fires were burning at one time and in many others from ten to twelve fires would be located within a single day. No wonder we were glad to see rain come the first part of April."

The district and county fire wardens and the hundreds of volunteer and paid fighters who help them control and extinguish these fires deserve a great deal of credit for their work, McCormick said.

Hendaye, France, April 14.—(AP)—The Spanish Insurgent command at Irun reported today a "large force" of Government militia was surrounded east of Gandesa, freeing the sector from pressure.

The Government's troops retreat to Reus toward the coast was cut off, it was declared.

Insurgent field headquarters declared the movement was of great strategic importance, though war bulletins telephoned from the Catalonia front did not specify the exact area in which the encirclement was claimed to have been made.

Early April Showers Save State Forests From Fires

Raleigh, April 14.—Early April showers have been more welcome than pennies from Heaven to Assistant State Forester W. C. McCormick and his forest fire fighters who through February and March have battled the worst conditions in many years.

March reports have not yet been consolidated, but it is predicted that final figures will show more than 1,200 forest fires during the month, a near-record which followed right on the heels of the 875 reported in February.

Recent rains have done much more than insure the traditional May flowers—they have greatly lessened the danger of forest fires, have put out many small ones and are bringing out the foliage so that the danger of more fires has been greatly decreased, McCormick said.

The 45 days from the middle of February to April 1 were the worst we have had in years and taxed

Tarboro Fire

Tarboro, April 14.—(AP)—Fire swept the Tarboro cotton yards here today, destroying more than 225 bales of cotton and burnings up two warehouses stocked with merchandise. The damage was estimated unofficially at from \$22,000 to \$28,000.

Police Chief Robert Worsley said a Negro woman told him she saw two small Negro boys run from the cotton yards after she saw flames and smoke rising from the spot.

One firm, Rogers and Company of Tarboro and Norfolk, Va., reported loss of 185 bales of cotton, all insured.

The warehouses burned were used by the Marrow-Pitt Hardware Company and Murphy, Jenkins and Company, all product distributors.

Before the blaze was controlled it threatened a broker's warehouse containing 30,000 bags of peanuts.

Spend Day At New Bern.

Equivalent To War.

Washington, D. C., April 13th, 7:30 p. m.—After the most exciting scenes, personal encounters, etc., that have occurred since the Civil war, Congress rejected the minority report of the Foreign Relations Committee by a vote of 150 to 191.

The majority report was then adopted by a vote of 374 to 20. This is equivalent to a declaration of war.

The Spanish minister has been recalled and the French ambassador here will look after the Spanish interests.

Ill In Hospital.

Friends of James W. Sanderson, assistant manager of the Evans street A. and P. store, will be sorry to know that he is ill in Pitt General Hospital.

Health Officials Here.

The local Health Department was visited yesterday by J. M. Jarrett, consultant in sanitary engineering, division of State Health Department; B. L. Jesus, state director of community sanitation, and T. P. Williams, district supervisor of community sanitation, in connection with the W. P. A. privy program now being put on throughout the county and being sponsored by the local Health Department.

According to Dr. N. Thomas Ennett, Pitt county health officer, not only the local Health Department, but the State Health Department, also is anxious that the citizens of Pitt county avail themselves of the opportunity to secure a sanitary privy by simply paying for the material, W. P. A. furnishing all the necessary labor, even furnishing the labor for painting the privies.

The health officer expressed the belief that as soon as the public in general learned about the terms on which they could get these sanitary privies, more orders would come in than could be promptly filled.

In commenting on the attractive terms upon which it is now possible to secure state approved privies, Dr. Ennett was hopeful that it would not be necessary to enforce the state privy law.

Pastel Easter Dessert.

Combine violet and yellow in your Easter dessert. Put a layer of Spanish cream in a mold. Top it with jellied grape juice. Chill. Serve plain or with whipped cream.

Taste Pickle-Upper.

Add diced celery to your next dish of macaroni and cheese. A third of a cup of celery will be enough for three cups of macaroni and cheese.

Trade Exhibit Week.

In connection with plans being made in the graded schools of the city for observance of Greenville's International Trade Exhibit Week, April 18-23, Mrs. Edw. Batchelor, chairman of the committee handling such arrangements for the grades, reports, among other things, that the sixth grade at the E.C.T.C. training school, under the supervision of Miss Matheson, has just completed a large picture map of the world, 3 by 4 feet. The map is entitled "Peace on Earth, Good Will Toward Men," and has on its border in colors small pictures of the different peoples of the world. These pictures show among their subject-matter: Reconstruction in the East, International Good Will Through Travel, International Peace Bridge Between the United States and Canada, etc. The map, being mounted, is to be shown to the different grades and put on public exhibition during International Trade Exhibit Week here.

Many pamphlets and booklets dealing with international good-will have also been procured for the libraries, and to be used by teachers and pupils. These pamphlets, etc., to be emphasized the week of April 18-23, will remain school property for use in teaching the value of co-operation between nations during the coming school year and beyond.

A few of these are listed as follows: "Peace Action," the N. C. P. W. News Bulletin; "The Teaching of Geography in Relation to World Peace;" "Notes on What Other Schools are Doing;" "The Whole World Next Door;" "Reproductions of Famous Paintings Reflecting the Spirit of Peace;" and "Portraits of Peace Makers;" "Games of Many Lands;" and "Youth and the New Patriotism."

"Our aim," said Mrs. Batchelor, "is to instill into the minds and hearts of the boys and girls in the elementary schools in some small way the necessity of world friendship and the true significance of the words 'Peace on Earth, Good Will To Men'."

World Peace—World Trade.

For farm prosperity, we are told, the United States should export at least 50 per cent of its cotton, 39 per cent of its tobacco, 34 per cent of its pork products, 40 per cent of its dried fruits, and so on, with other products of the soil.

For industrial prosperity, similar quantities of manufactured products must be exported.

But such exports must be paid for by imports to keep trade moving.

According to government figures for 1919-35, factory employment has increased, rather than decreased, with an increase in imports.

Likewise the income of the farmer in the United States has been highest when both exports and imports have been at their peak.

Free exchange of commodities between nations depends largely on the existence of friendly relations between them. Thus, world peace is a necessity for better economic life for all.

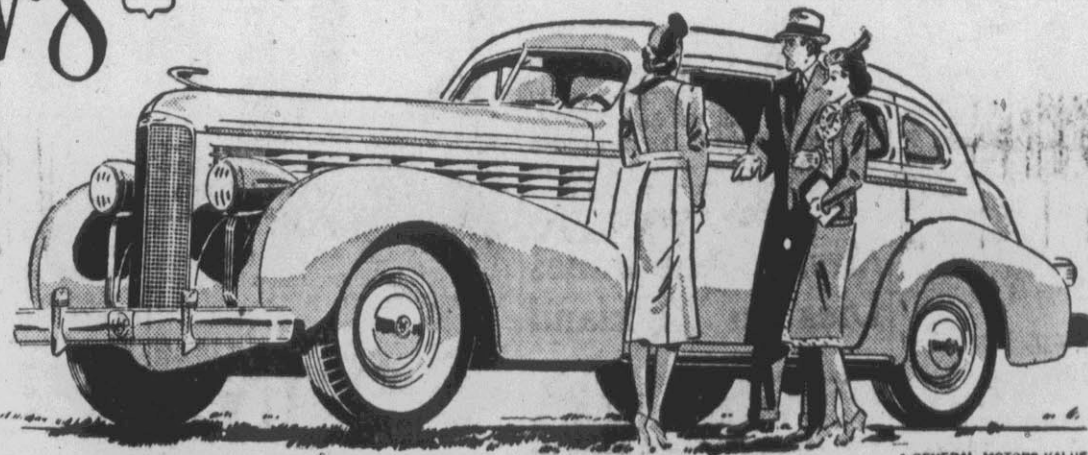

Raleigh, April 14—When the Davis

of the 1937 North Carolina House
(George E. Hyde, Roy L. or Dare
and W. Bryan of Randolph) your
correspondent raised an eyebrow in
surprise that they outnumbered the
Smiths, the Joneses or any of the
other families with common names.

But now comes news which sends
both eyebrows up in practical as-
tonishment. In Carteret county
eleven candidates have so far an-
nounced for office. No less than
six of them are Davises—and to add
to the confusion (or it is simplicity)
there's another Davis in office who
doesn't even have to run again this
year.

It seems that the entire Carteret
board of county commissioners is
likely to get up and start for the
phone if a clerk says "Mr. Davis,
your wife's calling you." Three com-
missioner candidates are Davises—
Cleveland, George and Raymond.
Then there's Earl C. who wants
to come to the Legislature to re-
place Fred Seeley, a candidate for
re-election. And there's M. Leslie
who'd like to be solicitor of the
county recorder's court.

Irwin W. has the laugh on the
others. He's register of deeds and
has more years to serve before
coming up for approval of the
voters.

Caesar's "All Gaul" was divided
into only three parts, thereby tak-
ing a seat so far back from North
Carolina that it just isn't in the
running.

North Carolina is divided into 100
counties and no less than 1,855 vot-
ing precincts, according to records
at the office of the State Board of
Elections. And this year the cry is
to divide many of these 1855 in
smaller voting centers.

Frank Hancock charges Bob Rey-
nolds with being a playboy and
too fun-loving to accomplish any-
thing for his state in Washington—
but this very characteristic has, on
one occasion at least, produced re-
sults where more serious minds
failed miserably.

Folks with long memories may
recall that North Carolina secured
some half a million dollars or more
to buy school buses some years
ago when the depression was on in
real earnest. Incidentally the state
was the only one in the Union to
get such a gift—it was later declar-
ed illegal by the Comptroller Gen-
eral, but that did no harm, because
North Carolina had the money and
had spent it.

Your correspondent has it on
unimpeachable authority that "Our
Bob" got this money for the state
after Senator J. W. Bailey, Con-
gressman Bob Daughton and other
"weighty" minds had failed dis-
mally to get to first base.

The story comes from a high-
grade former state official, who
incidentally is now supporting Han-
cock with all his might—so it isn't
Reynolds propaganda. It goes about
like this:

North Carolina school officials
(our informant was one of them)
went to Washington to try for the
allotment of funds by PWA to buy
the buses. They tried Bailey, No-
results. They tried Daughton. Still no
soap. As what was to them frankly
a last resort, they went to Rey-
nolds, told him that a certain PWA
official had it in his power to ap-
prove the allotment—nobody else
could. Could he help?

"Why sure," said Reynolds. "I've
been on a party or two with him at
the Mayflower. Let's go see him."
So they went.

Breeding past secretarial out-
posts with usual Reynolds spright-
liness, the party entered the of-
ficial's office. Bob laid the case be-
fore him. The PWA man looked
highly important, hummed, hawed
and began to make excuses and
objections.

"Don't look at me like that," said
Bob. "I want you to look at me like
you looked at that blonde last
night." That did the trick. The
official loosened up, began smiling
and in five minutes North Carolina
had its bus money.

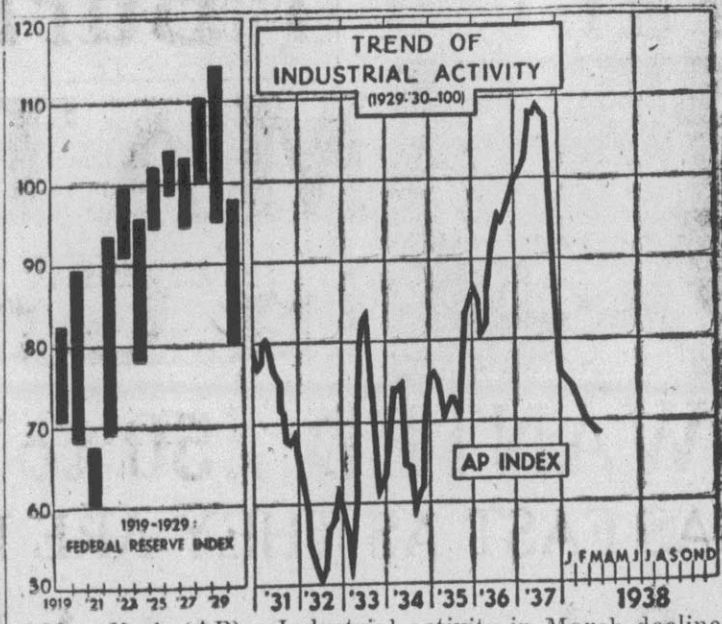
ROOSEVELT CALLS LEADERS TO DISCUSS PROGRAM

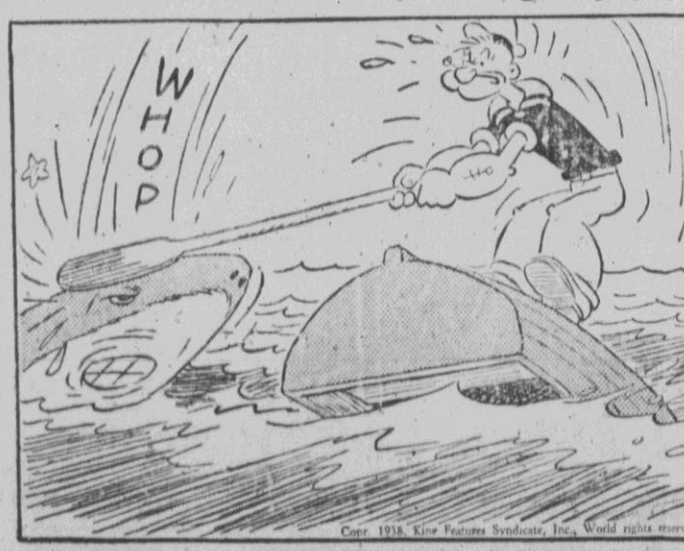

ALLOW FISHING DURING EASTER

Ban to be Lifted During Holidays in All Sections

Raleigh, April 14—Anglers who have suppressed their desires for an excursion to their favorite fishing grounds during the current closed season will have the opportunity of indulging in this sport with the temporary lifting of the ban during the Easter holiday period, J. D. Unalk, Commissioner, Division of Game and Inland Fisheries, Department of Conservation and Development, announced today.

The lifting of the closed season restriction will apply to all sections of North Carolina and to all species of fish found in inland waters of North Carolina, beginning Saturday, April 16, at midnight and extending to Monday, April 18, at midnight. The privilege applies only to legal methods of fishing in the inland waters.

Commissioner Chalk announced that the exception this year follows the custom of the past several years during which the sportsmen have enjoyed a wholesome spirit of cooperation in the observance of the fishing and hunting laws.

Fishermen who land any un-

spawned female fish during the period of grace are urged to release such fish carefully after dampening their hands. The taking of one fish which is not spawned, according to the Commissioner, would result in the destruction of possibly several thousand of eggs and many mature fish in future years.

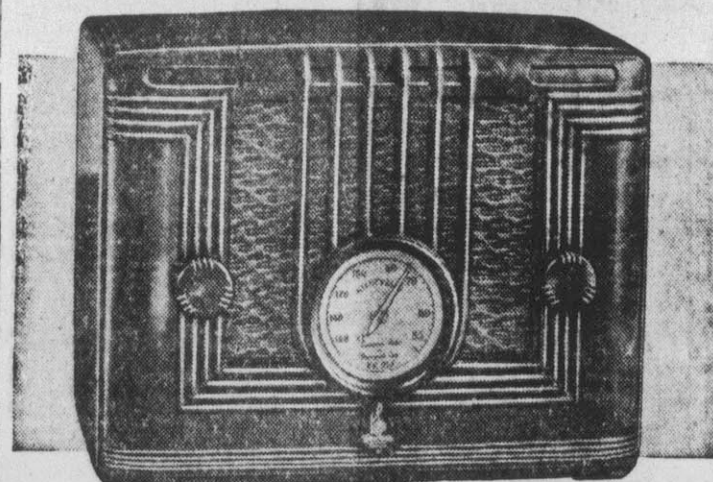

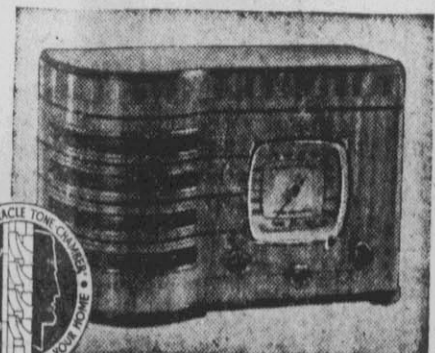

EDWARDS WELL JUALIFIED TO HEAR DAWSON WRANGLE

(Continued from page one)

Armistice was signed.

The case he will hear has excited no end of comment from one end of the state to the other. Dawson, whose home is in Kinston, has been Speaker of the State House of Representatives and chairman of the Democratic State committee.

The controversy is somewhat technical and is of such long standing that it is quite involved. It stacks up about like this, however, when reduced to as simple terms as possible.

The LeGrange bank went broke in November, 1920, and in December, 1921, Dawson was named receiver. He took possession of the books, records and accounts of the bank and the Commissioner of

Banks alleges that these records, etc., have been kept out of the clerks office for more than 15 years. Time marched on and no accounts were filed, despite numerous demands by depositors, until in 1936 the Commissioner of Banks (whose office had been created only a short time before) began to ask for an accounting.

In June, 1936, the Commissioner's petition averse, Dawson caused an order to be signed by Judge H. A. Grady, resident judge of the Sixth District, authorizing employment of an auditor to settle the accounts. In this order no time limit was set for a report, the petition recites.

When Dawson continued to fail to file any report, the petition continues, the Commissioner, through his attorney J. A. Jones, secured an order from Marshall Spears re-

quiring Dawson to turn over all books, records, etc., of the bank to the Commissioner. This order was never obeyed by Dawson, it is contended. Judge Sinclair says he never knew of this order and charges Jones with keeping it out of the record.

In March, 1937, Dawson, without notice to the Commissioner it is contended presented an order to Judge Sinclair making certain allowances and approving certain fees. This was signed. On April 5, 1937, the complaint continues, Dawson procured at a civil term (petition says no civil business had ever been transacted at such a term in 20 years, Judge Sinclair says it was common practice to transact it) and declares Jones knew it approval of the alleged audit and is own charge as receiver.

Banks avers that on April 5 the audit hadn't even been completed and that when it was finished it wasn't a true audit. He avers that a true audit will show a shortage of \$45,000 in Dawson's account.

After all this legal shouting and shooting, Judge Sinclair set aside his own order discharging the receiver and approving the audit, making a statement with which no disagreement has been heard.

"The interests of everyone concerned requires a full and impartial examination of the contentions."

(Continued from page one) Ill., St. Louis, Mo., and Cairo, Ill. From Cairo the southern boundary of the territory follows the Ohio river to Huntington, West Va., and then extends eastward to the Norfolk, Va., area.

The passenger fare application originally was a part of a request by the carriers for a 15 per cent freight rate increase to bolster dwindling rail revenues and relieve financial distress.

Last month the ICC granted freight rate boosts which it is estimated will return \$175,000,000 additional annually.

The program, which will be held from 9:30 until 12:30, will include a talk by Dr. Roy Norton of the State Board of Health.

Included on the program will be a course of study in health: objectives and results to be expected; beginners' day program, pre-school clinics.

Some health problems and their solutions will be discussed, including contagious diseases, physical defects and how to remedy them.

Preventing undue emotional strains will be the topic of Dr. Norton.

The service of the health nurse in promoting the health of school children will be outlined by Mrs. H. P. Guffey, State Board of Health nurse.

A discussion of the proper feeding of school children by Miss Mary E. Thomas, nutritionist of the N. C. State college extension service, will complete the program.

Teachers of both the city and county schools are supposed to attend the institute.

brigades were pushing down the road to the sea. Insurgent claimed to have captured San Mateo. "The living wall of the defense has been destroyed," Insurgent reports said, "our troops on a 13-mile front from Capi to Chert to Rosell are moving slowly ahead."

At the southern end of the 160-mile battlefield Insurgent claimed the capture of the Key city of San Mateo. Although they were 12 miles from the sea, an advance of seven or eight more miles would attain their practical objective, as their guns then would sweep the coastal highway, last line between Barcelona and Valencia.

July 1. It was: \$1,250,000,000 for the WPA; \$175,000,000 for the Farm Security Administration; \$75,000,000 for the NYA; \$50,000,000 for the CCC; and the \$1,500,000,000 made available to the RFC for lending to business enterprises.

In the second group of measures, Mr. Roosevelt asked: \$300,000,000 for immediate expansion of the house and slum clearance work of the U. S. Housing Authority; \$1,450,000,000 for public works, loans and grants; an additional \$100,000,000 for public roads; an additional \$37,000,000 for flood control and reclamation projects already authorized; an additional \$25,000,000 for Federal buildings.

A third group listed by Mr. Roosevelt referred to private credit. It involved de-stabilization of \$1,400,000,000 of gold and a reduction by the Federal Reserve Board of member bank reserve requirements which would add another \$750,000,000 to the credit resources of the nation's banks.

J. W. Haynes of Asheville argued for Payne and Turner that the trial court admitted "incompetent evidence" which served to "prejudice" the jury. He contended a verdict of second degree murder would otherwise have been returned.

The defense listed 668 exceptions

in its appeal.

Attorney-General A. A. F. Seawell argued for the State that the alleged "incompetent" evidence was necessary in tracing minutely the movements of Payne and Turner to show they were "desperate men" who were "prepared to commit murder" to save themselves from capture.
