CataloniaMOST LOYAL OF
ARMY OFFICERSInsurgents, With Banner

on Mediterranean,
Push Northward

Madrid, April 16.—(AP)—General Miaja became the supreme head of military and civilian affairs today in the southern four-fifths of Government Spain, cut off from Catalonia by the insurgents' break through to the sea at Vinaroz.

The "Savior of Madrid," most famous of the few army officers who have remained loyal to the Government, was vested with the highest powers several days ago by Premier Negrin, Government Minister of National Defense. However the appointment was confirmed by radio last night.

General Miaja's first act was to declare the government would continue its fight despite the Vinaroz setback and that every effort would be made to maintain normal conditions in the territory under his control.

Hendaye, France, reports said said General Franco's Insurgents their banners planted in the sands on the Mediterranean shore, pushed relentlessly northward along the coast.

They began closing in on a delta town. Their strategy was to force a crossing of the Ebro river and take Tortosa from the east.

With Government Spain split in two fighting was resumed. Desperate bands of Government militia tried to block the path of the Insurgents.

Loyalists aviation bombed towns freshly fallen to the Insurgents.

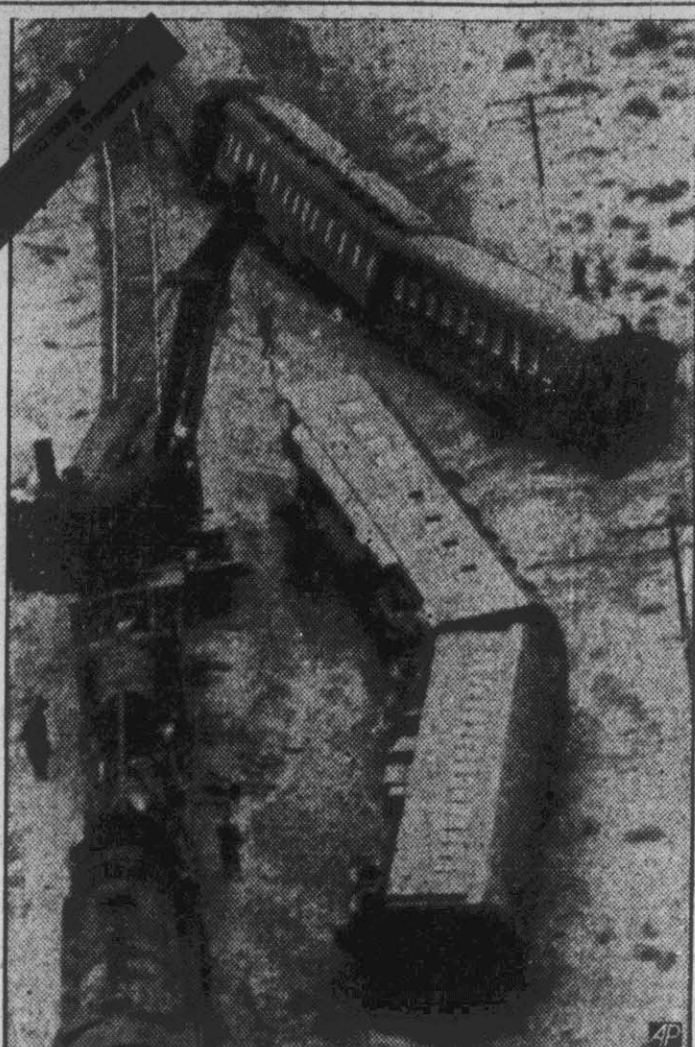
RETURNED TO CITY

O'Connor Seeks
Bring Wage-Hour
Bill Before HouseChairman of House Rules Committee Asks
All Members of Group to Give Careful
Consideration of Legislation

Washington, April 16.—(AP)—Chairman O'Connor (D-N. Y.), asked members of the House Rules Committee today to back him in a move to bring the new wages and hours bill before the House this session.

O'Connor wrote all members of his committee asking careful consideration of the new legislation, approved this week by the house labor committee with a view to giving it privileged status before the house.

A Coalition of Southern Democrats and Republicans on the committee bottled wage-hour legislation at the regular and special sessions last year, handing the administration one of its most severe defeats.

Opponents of the administration's "big navy" bill centered their efforts meanwhile on an attempt to eliminate authorization for three 45,000 ton super dreadnaughts.

"If we can't defeat the bill, we

may at least be able to stop the building of more battleships," said Senator Nye (R. N. D.).

The Senate naval committee approved the \$1,155,000,000 expansion bill by a unanimous vote yesterday, but three Democratic members who did not vote said they would oppose it on the floor, perhaps when it comes up for debate Tuesday.

Senate and house were in recess today and will also be in recess Monday.

Other developments: Congressional leaders eager for quick action, considered drafting an "omnibus bill" to carry through congress President Roosevelt's main relief and public works program for spending to end the recession.

J. Noah Williams, Greenville business man, today announced his candidacy for the Board of County Commissioners from the first district, composed of Greenville township.

Mr. Williams will oppose Walter Cherry, incumbent, who already has announced intention of seeking reelection.

The announcement of Mr. Williams assures three contests for seats on the board, Grover Smith, at present constable of Chicod township, has announced against Roy T. Cox, incumbent, and G. H. Pittman of Falkland, has announced against B. M. Lewis of near Farmville, incumbent.

Mr. Williams has been in business many years. He has served two terms on the board, being elected in 1932 and 1934. He retired at the completion of his second term, however, deciding not to seek the post for a third term.

Two members of the present board so far are without opposition, Frank Kilpatrick and David T. House, Jr., from the fifth and second districts, respectively.

Prospective candidates have until next Saturday, April 23, to file with the County Board of Elections.

Babson Finds Washington Trying To Outlaw Human Nature

Washington, April 15.—Here I am at the Nation's Capital. This is what I find: Twenty billion dollars have been spent on pump-priming since 1933. Now, after five years, unemployment is almost as bad, business is not much better, and losses in some industries are greater. It should be obvious that something is wrong with the pump. The fault is that we have been trying to change human nature overnight. It is time we went to work and corrected the situation. The issue is far bigger than party politics. The fu-

ture of America is at stake! The easiest thing in the world, of course, is to sit back in the gallery and "kibitz." During the past few years there has been an endless barrage of destructive New Deal criticism by businessmen without constructive suggestions. "Let business alone" is a favorite slogan when times are good. "Do something for business" is the cry when things are slow.

One of the biggest faults of the New Deal has not been in writing "Reform" legislation, but rather in going too far with such legislation.

What we need today is to take a thorough inventory of recent laws, chop out the bad parts, and keep the good. Throw away the acts aimed at changing human nature, and keep those designed to strengthen human beings.

Instincts Cannot Be Legislated There has been too much loose thinking in connection with the "ill-housed, ill-clad, ill-fed." These unfortunate people never will be properly taken care of until we get down to fundamentals. Human nature cannot be outlawed or outmoded by the waving of a wand.

The world is still ruled by the instinct to own and to protect private property.

Moreover, the system of doing business for "profit and loss" is ingrained. It has been developing through thousands of years. It can never be changed overnight. Hence, I feel strongly that the President not now attempt another surgical operation, but follow the best physicians by letting Nature make the cure. He should start now by preaching some basic economic truths.

Securities Commission
Eliminates 'Red Tape'Action Make Credit Easier
Follows Recommendation
Of President

Washington, April 16.—(AP)—"Little business" wanting more capital so it can be bigger, got a boost today from the Securities Commission.

In response to President Roosevelt's suggestion that SEC red tape be cut in order to help small business raise capital more easily, the Commission decided:

1. To establish a unit in the registration division to deal prospective registrants.
2. To reduce the amount of financial information required in registration statements for small issues of established enterprises.
3. To broaden the exemptions for issues of less than \$100,000.

Meantime, Secretary Ickes resumed public works spending with allotments totalling \$3,119,902 in loans and grants to help finance construction of 58 schools and school additions in 27 states.

These allotments represent resumption of the present PWA program, Ickes said.

The projects, all for school construction or improvement, and the grants, included:

North Carolina, Raleigh \$35,802; Franklin county, \$29,250.

TERRORISTS ENGAGE
BRITISH IN BATTLE

Jerusalem, April 15.—(AP)—A battle between British troops and terrorists raged in the Jenin area, about 50 miles north of Jerusalem, today while the Holy City quietly awaited tomorrow's Easter services.

Unofficial reports from Arab sources at Jenin said 19 Arabs had been killed and two wounded in a battle which was still underway. Military authorities confirmed reports of a heavy engagement, but listed no casualties.

Officials said scouting planes sighted a large band and British troops clashed with it. In another outbreak which shattered the pre-Easter calm of the Holy Land, terrorists' bullets killed three Jews.

As the devout trod the age-worn streets of Jerusalem awaiting tomorrow's holy observances, military authorities announced that troops had been sent to Bessa, a village near the Syrian border, where an armed gang ambushed a car load of Jewish travelers.

The chief executive and First Lady will attend morning services at St. Thomas' Episcopal church, Mrs. Roosevelt also will attend sunrise services in Arlington cemetery and place a lily cross on the unknown soldier's tomb.

CHINESE ARMY
SEEKS REPEAT
GREAT VICTORYWages Vigorous At-
tack on Shantung
Province CityGUNS HAMMER AT
JAPANESE LINESMeanwhile at Tokyo
Premier Konoye Re-
ported Threatening
to Quit His Office

Shanghai, April 16.—(AP)—A Chinese army vigorously assaulted Yihsein in Shantung province today with artillery, bombing planes and infantry, determined to repeat the great victory it tasted at Taierchwang, 20 miles further south.

New field guns hammered at the walls after cracking Japanese positions on the east, southeast and northeast and planes dropped bombs.

Chinese infantry systematically attacked Japanese machine-gun nests dotting the hills and countryside surrounding the town.

Generalissimo Chiang Kai-Shek's commanders declared all its supply lines were cut.

A considerable part of the town was in flames.

From foreign sources it was learned another Japanese force had met a serious reverse in Kangsu province, where the infantry vanguard had outdistanced its supporting artillery and been ambushed.

Tokyo, April 16.—(AP)—Faced by the insistence of army and navy leaders for sweeping measures to push to a quick conclusion the conflict in China, Premier Prince Konoye today was reported threatening to resign.

The cabinet was said to be split on the issue of support of the Premier providing the first real Government crisis since the undeclared war in China started more than nine months ago.

As a result of a strict censorship on news from China, where Japanese army spokesmen have refused to confirm or deny reports of great losses in fighting at Taierchwang, the public was in the dark on developments and wild rumors were circulated.

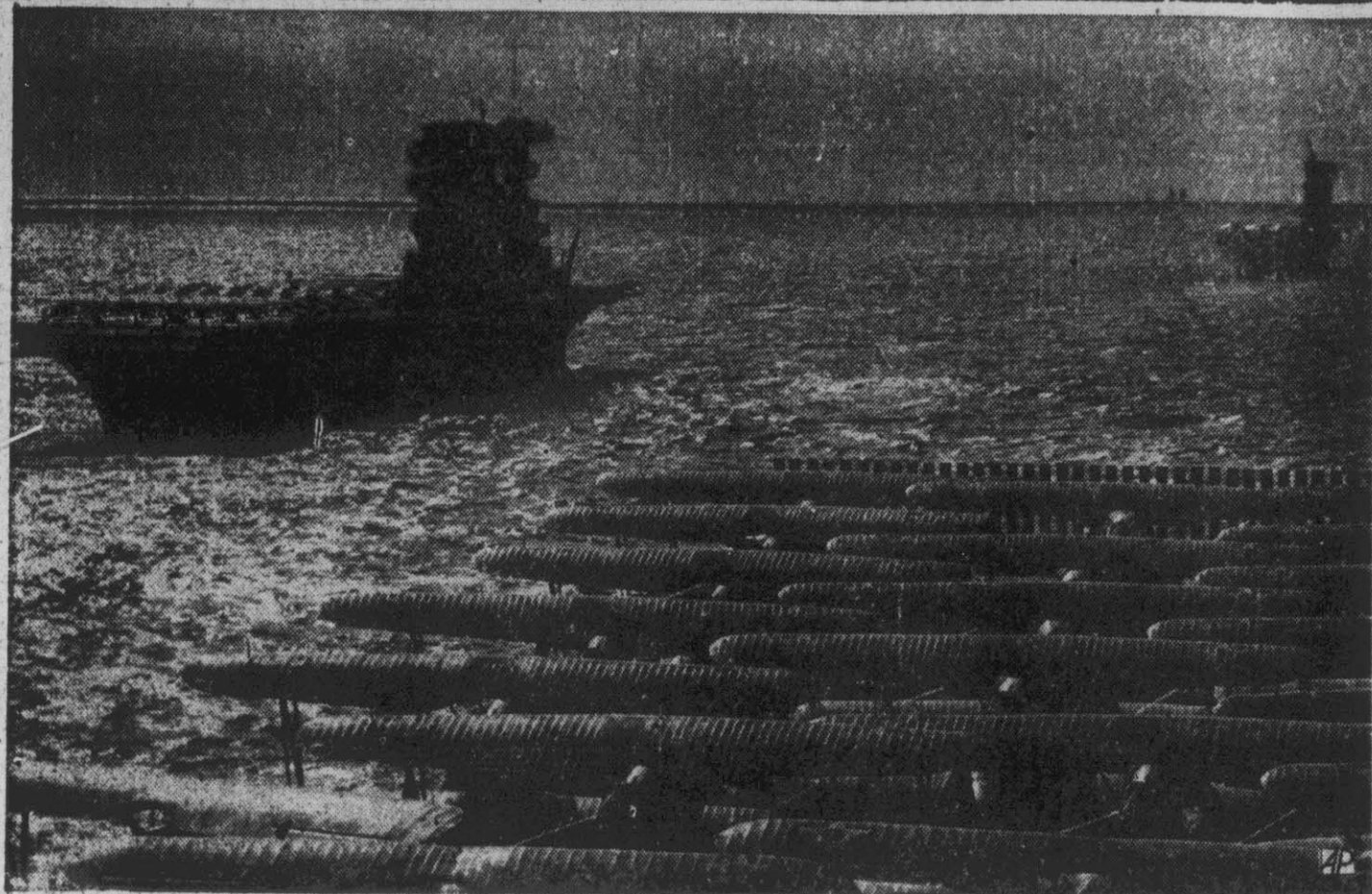

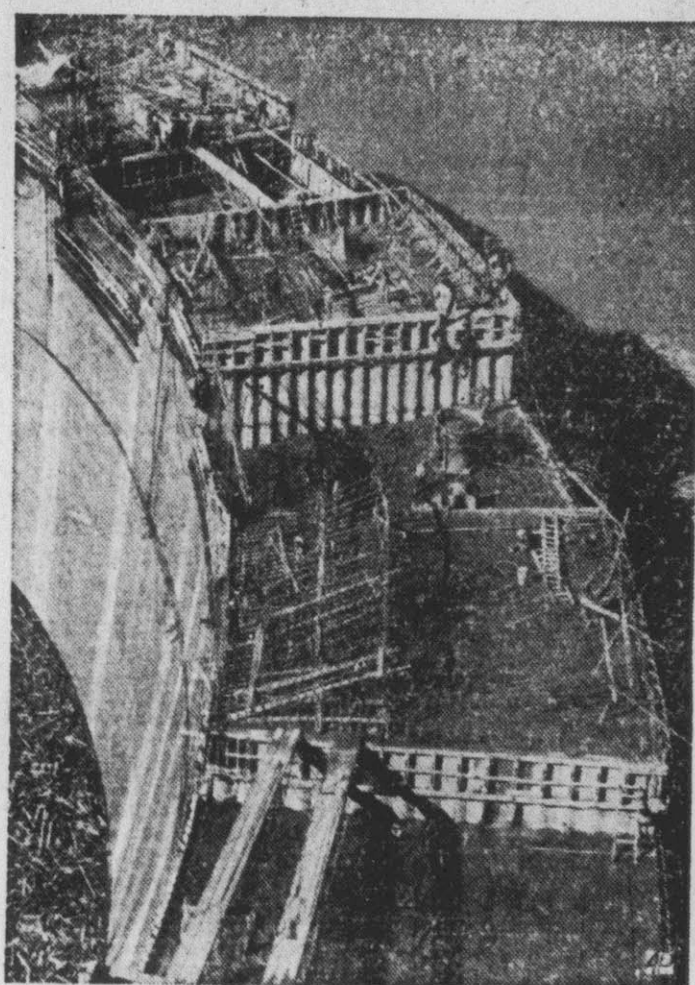

CORRUGATED EDGE of interlocking forms is an architectural note at Parker dam on Colorado river 150 miles below Boulder dam. Concrete is now being poured.

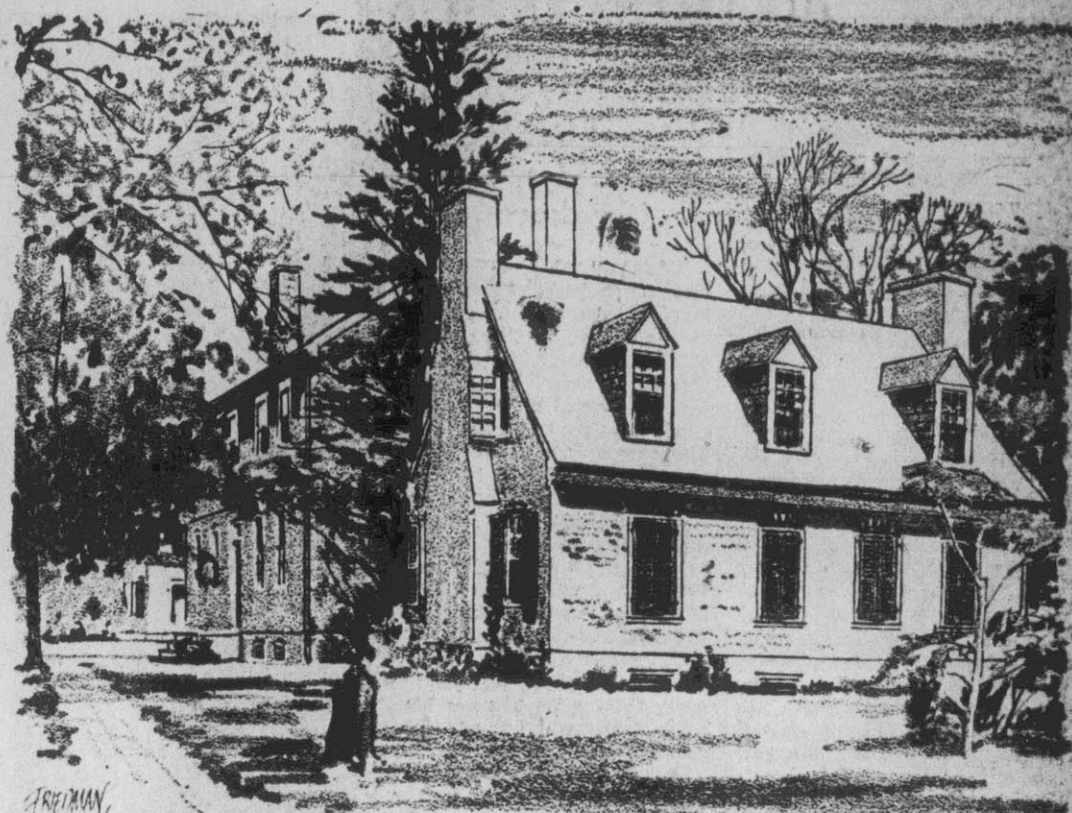

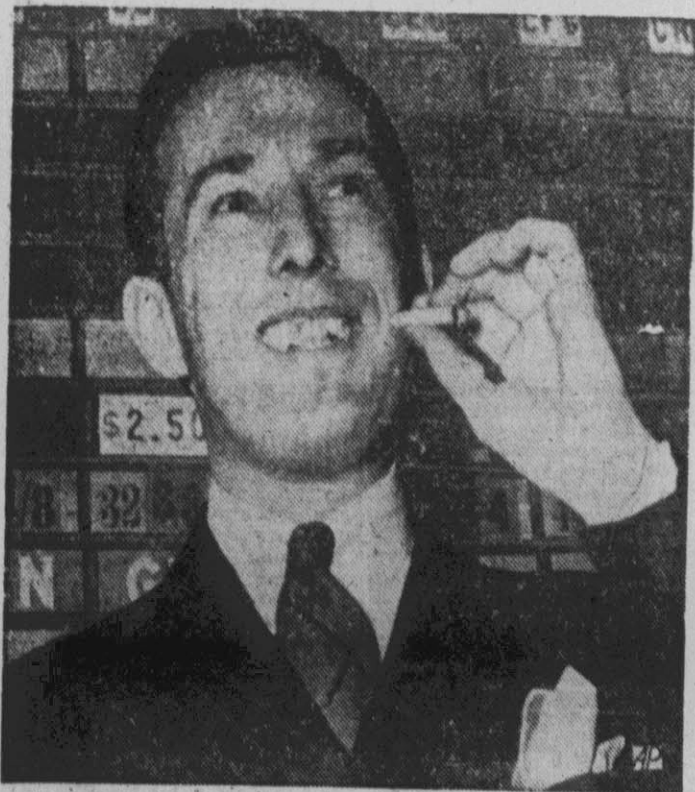

Washington Daybook

By Preston Grover

WASHINGTON — The man who keeps the Ambassador from Spain from meeting head-on at the White House with the Ambassador from Germany, and who sees that Mrs. Noody-in-Particular is kept from boring Senator Hotpotato, and who sees that the right Mr. Jones gets in to see the President and who has a car ready for Mrs. Roosevelt and who keeps cigarette stubs from accumulating in the East Room—that is Mr. Howell Crim.

Mr. Crim is the new head usher in the White House, a job for which he was trained under the late Ike Hoover, who spent 42 years at the White House and then wrote a book about it to the delight of many and the dismay of others who were looked upon by the observant Mr. Hoover as nothing much.

Being head usher at the White House is something like being manager of an exclusive hotel. When state dinners are held he greets all the guests, sees to it that everybody meets everybody else, and that the right gentleman finds the right lady to take to the right place in the dining room.

It's Done By Formula

Mr. Crim is altogether nonchalant about the ambassadors and the Joneses. Seating them at dinner is all worked out according to formula. If Mr. Krakonki of a certain legation thinks Mrs. Saloni, wife of an acting minister, is an old sputter-bug, it means nothing to Mr. Crim, although he may know all about it. When the formula of rank and precedence calls for Mr. Krakonki to take Mrs. Saloni to dinner he will take her and make small talk about Washington laundries or the plight of the second secretary whose wife would up and have twins just as he seemed to be doing so nicely in the diplomatic service.

"They are steered to that sort of thing," says Mr. Crim.

He once had to stop a dog fight right in the middle of a room full of guests. Mrs. Boettiger, the President's daughter, had two bird dogs which had the run of the White House before they moved with the family to Seattle. When Jimmy Roosevelt came from Boston he brought a bird dog. Mrs. Boettiger's dogs were quietly sleeping in a corner of the big East Room when Jimmy's dog hove in. The fight was instant and furious, and the guests seemed to enjoy it.

Guests who come to the White House for the first time are usually awed by the size of the East Room. Converted into a barn it would shelter 30 head to Jerseys and 10 tons of hay. When guests ask what it is used for Mr. Crim always tells them dances and receptions. Often he is tempted to tell them: "Sometimes we have dog fights in here."

He never has told a guest that, however.

A Coolidge Remark

Once a guest remarked that he had slept in the East Room. Later he explained that a violinist playing for the Coolidges had soothed him to sleep with languorous notes. When the playing ended, President Coolidge, sitting beside him, shook his knee to awaken him.

"The concert is over," the President announced, Coolidge-like.

Mr. Crim arranges for about 400 overnight guests at the White House each year but doesn't live there himself. Tall, dark haired, partly bald, he walks 15 blocks to work and home again at night. He began government service as a stenographer in 1916, served three years in the navy, refused a White House ushering job in 1920 but accepted early in the Hoover administration.

He has two assistants, one of whom is Charles Clauch, a top-flight sailorman who acted as President Roosevelt's secretary on the South American trip. Clauch's enlistment expires in September, when he will accept the job as assistant usher.

But the man to envy is the colorful doorman. He has the most beautiful blue vest we ever saw.

SOCIAL SERVICE MEET APRIL 24

Annual Conference to be Held in Greensboro

Raleigh, April 16.—The 26th annual North Carolina conference for Social Service will be held this year in Greensboro, opening on the night of Sunday, April 24 and extending through Tuesday, April 26. It has been announced by Mrs. W. T. Bost, president of the conference and commissioner of the State Board of Charities and Public Welfare.

Many prominent persons from the state and national fields of social and welfare work have been secured as speakers for the sessions. Mrs. Bost said. Included are Wayne McMillen, professor of Social Service Administration, University of Chicago, who will deliver one of the principal addresses of the conference at the evening session Monday, April 25, taking as his subject "Government as an Agency for Human Welfare," the theme of the conference.

The conference sessions will begin at 7:30 o'clock on the evening of Sunday, April 24, when Dr. Frank Porter Graham, president of the Greater University of North Carolina, will conduct a memorial service for the late Dr. William Louis Poteat, conference president in 1919-20, and president emeritus of Wake Forest College. The opening session will be held in Greensboro's First Baptist Church. All other sessions will be conducted in the West Market Street Methodist Church.

Dr. O. T. Binkley of Chapel Hill, will deliver an address on "Conservation of the Family" during the initial meeting.

Numerous group meetings will be held Monday morning prior to the general session, which starts at 11:45 o'clock. "Public Medical Care" will be the subject of an address at this session by Dr. Ellen C. Potter, director of medicine, Department of Institutions and Agencies, Trenton, N. J. Dr. Martha Elliott, assistant chief of the Children's Bureau, Washington, D. C., will be the chief speaker at the luncheon immediately following.

bitzer," let me tell you what I would do right now "if I were President." I think the following moves would cure the basic troubles which are allowing people to starve in this great land of plenty:

Stop "Price Freezing"
(1) I would assure the nation a free market for labor and commodities. All attempts to "freeze" the price of either market lead directly to more unemployment.

This applies to labor unions, farm organizations, and business corporations. All forms of monopolies add to joblessness. Hence, price-fixing of all kinds should be stamped out as harmful to the nation as a whole.

Politicians talk about "over-production." It is true that an individual industry may get out of line by producing too many goods at one time. There, however, can be no over-production in all industries. It would teach the people that only as more is produced, is there more to divide. The standard of living can be raised only through boosting total production; never by curtailing it.

(2) I would endeavor to have the Securities and Exchange Acts and Federal Tax Legislation amended so as to encourage—rather than to discourage—new enterprises. Congress should differentiate between speculation in new risks and speculations in outstanding securities. More income may be needed by the Treasury after eliminating business taxes. If so put a special tax on Trust Funds.

Money in Trust Funds is "dead" money. It is divided only in old industries. It never takes a risk. As Trust Funds grow, unemployment likewise grows. The sharp drop in stock prices, and the drying-up of new capital issues, caused by unwise legislation, is responsible for much of our unemployment.

(3) I would preach continuously the importance of self-dependence. Our various government are engaged in all kinds of propaganda. Most of such efforts result in more joblessness. They are fitting men and women to seek positions in crowded occupations. Women have entered industry to stay; but if so men must do house-work and bring up children.

It is dangerous to interfere with the balance of nature. We cannot let people starve; but we can put a social and family blot upon the acceptance of relief. Civilization has depended upon such a stigma for centuries. Its sudden removal has been a primary cause of unemployment.

(4) I would kick "politics" out of the White House. Leaders of both great political parties agree that this would do much to aid employment. They, however, add that it would be suicidal for either the Democrats or the Republicans independently to risk cutting out "politics." This means that the sensible people of both parties should temporarily unite in this emergency.

Let us follow England's example by having a coalition government. Probably the most practical way of accomplishing this would be for the Republicans to nominate a sensible Democrat in 1940. There are today in our United States Senate many good possibilities for such a candidate.

The New Deal has done many worthwhile things. In many ways it has made a better nation. But its attempts to change human nature have resulted in unnecessary unemployment. Let us continue the good legislation, but amend the bad. This will restore the confidence of

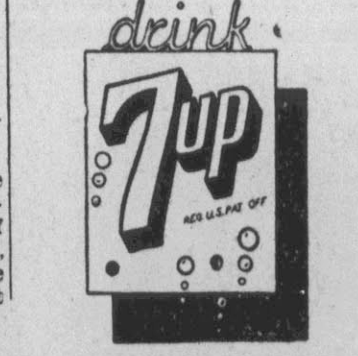

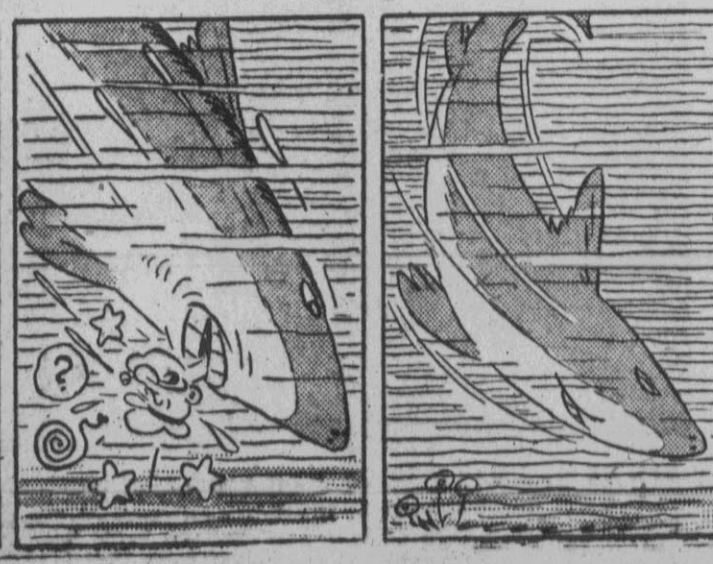

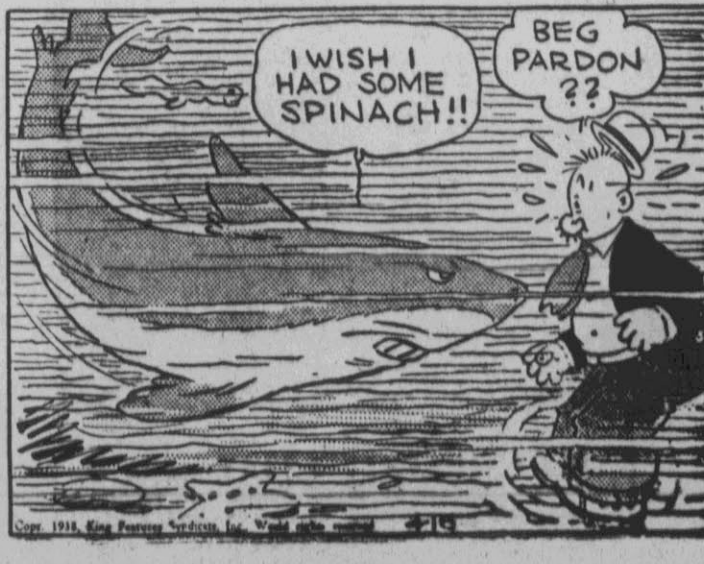

Man About Manhattan

New York—Writing a New York column can be so easy! Like today, for instance. There was a story under a Tokyo date line about Izo Abe, elderly Japanese statesman who was set upon recently by three thugs. I happened to remember that his son-in-law, Dr. Roy Akagi is advisor to the South Manchuria Railway in New York. He has an office at 62 East 42nd street, just a few blocks away.

So an interview was arranged for dinner. At one of the hotels. And it wasn't long before your correspondent and his Japanese scholar who has had 30 years in America and has gone through four American universities were deep in discussion about his father-in-law and a subject that is close to millions of Americans. Baseball. For Izo Abe is the father of baseball in Japan.

He introduced it to the millions of Japanese who play it today on corner lots and well-ordered playgrounds just as millions of Americans play it in Texas and Utah and Georgia. He is the man who arranged an "exchange" with the University of Chicago, so that American teams visited Japan and Japanese players visited the United States.

And despite a political career in the islands that has occupied every moment of his spare time and gained him the title of "the Ramsey MacDonald of Japan," for he is labor's champion, the elder Abe would consider it an ill spent day that he didn't keep an eye on the big league races. Of visitors he inquires: "How's Lou Gehrig going? or that Dimaggio? I don't think they will ever beat Babe Ruth's record, do you?"

From 7 o'clock till 20 minutes of midnight, your correspondent plied Dr. Akagi with questions about Japanese expansion, his own career, undeclared Chinese war the feeling among the rank and file of Japanese concerning America, and vice versa.

And this man who has made 650 speeches in three years, who has written books and been a professor at Columbia University, replied:

"When the west, at the point of guns, opened Japan's eyes to the advantages of trade and commerce with foreign powers Japan realized that education was essential to the development of any intelligent people. And so today 99.7 of the children of school age in Japan are actually in school. We think education is the finest cure in the world for economic and social ills.

"As for China, Japan desires only to protect her interests there. The United States has only 2 per cent of her foreign investments in China. But Japan has nearly 82 per cent of her investments in China. We could lose 2 per cent and not feel it, as the United States could but we could not lose 82 per cent of our investments without suffering a paralyzing blow. That is why armed authority is necessary to protect Japanese investments. When the day comes that China becomes an organized, intelligently governed nation the need

In the scene, 300 cats rush into a room and overwhelm Adolphe Menjou as the grand finale to a comedy song.

The British magazine itself had no opinions but published a report from a Los Angeles organization which declared:

"From eight in the morning until seven at night the cats were worked . . . were chased on to an office set by means of a severe air hose . . . the scene had to be repeated over and over again. Many were frightened into a frenzy. By mid-afternoon the poor animals were weary enough to lie still wherever they happened to drop." The censors relented after Samuel Goldwyn cabled a denial of cruelty, backed up by affidavits from the American S. P. C. A. and the California State Humane society.

PEACE MOVEMENT 'IN BUSINESS' TO KEEP AMERICA OUT OF WAR

Washington — Peace has jumped into the "big business" category. More than \$2,000,000 will be spent this year to persuade Americans that the rattlings of sabers in Europe and the Orient should find no echo here. Millions of people have bought common stock in the enterprise.

Peace societies have snapped their programs into businesslike patterns. Here's an example: a report from one paid worker for the National Council for the Prevention of War (and the Council has 50 such). ART IN PLACING OF FERTILIZER

Much Valuable Information Gained By Experiments

Raleigh, April 16—There's an art in placing fertilizer on cotton land,

say agronomists of the Agricultural Experiment Station at State College.

Since 1931, these specialists have been experimenting with placing fertilizer under seed, over seed, and to the side of the seed.

Much like the artist, they have added a touch here and there and then stepped back to note the results. By carrying on a series of different placements, definite possibilities and advantages have been secured.

On flat prepared seed beds, fertilizers placed either in a 1.75 or 3.5 inch band at distances of 1, 2, 3, and 4 inches directly under the seed at time of planting delayed germination and reduced the stand of plants. These adverse effects were severe at the 1 inch depth but became less marked at the deeper placements.

Mixing the fertilizer throughout the soil zone 3.5 inches wide and 3 inches in depth, located under the seed, retarded germination and reduced the stand particularly under the less favorable moisture conditions.

However, the specialists found that fertilizer placed at time of planting in a narrow band at each side of the row in a zone ranging from 1.5 to 3.5 inches laterally from the seed and 1 to 3 inches below seed level resulted in the most rapid germination and seedling growth. In addition, highest yields of seed cotton were secured.

Complete information on these experiments are contained in Bulletin 318 just released by the Experiment Station. Free copies may be obtained from the Agricultural Editor at State College.

P.-T.A. Convention Opens Wednesday

Winston-Salem, April 16.—The 19th annual convention of the N. C. Congress of Parents and Teachers to be held in Winston-Salem on Wednesday, Thursday and Friday of next week will be a prideful parade of forces at work from many angles to benefit "The Child in the Community" which has been selected as the 1938 convention theme.

Mrs. J. Buren Sidbury of Wilmington, who is completing her second year as state president, will preside over all business sessions. Headquarters will be the Robert E. Lee Hotel, and the gathering is expected to bring together many hundreds of parents and educators. The state enrollment has passed 60,000 for 1938, a figure that tops every Southern state, and local units that conform to exacting standards set by the state board have greatly increased in number over last year.

Ahead of the convention proper, meetings of the executive committee and of the board of managers will be held on Tuesday, April 19, at 11 a. m. and 3 p. m., to consider policies and plans of work to be presented. The Winston-Salem P. T. A. Council, of which Mrs. Melville Prongay is president, will entertain at an executive luncheon on Tuesday at the Country Club.

Opening business sessions will be held on Wednesday, April 20 and will include presentation of national P. T. A. officers present, including Mrs. Wm. T. Bannerman of Washington, D. C., national legislation chairman and an active worker in educational circles in the District of Columbia. North Carolina claims the distinction of providing the national organization with its music chairman, Miss Grace van Dyke of Greensboro, head of the department of Music Education at the Woman's College of U. N. C.; Miss Moore will direct the Mothersingers' Chorus at the Winston-Salem convention, and in May in Salt Lake City will fill a similar place on the program at the national P. T. A. convention. A luncheon on Wednesday for all visiting delegates will feature greetings from many cooperating state organizations.

STATE SERVICE LOCATES MANY

More Placement During March Than Since October

Raleigh, April 16.—More job placements were made in March than in any single month since October, 1937, said R. Mayne Albright, director, in announcing the month's activity of the State Employment Service. "While the usual seasonal upturn has been less than expected, the 5,903 placements made this month were 47 per cent more than in February."

Of all the placements made during March, 64 per cent were in private employment, and 54 per cent of the private placements were of regular duration.

During the months of January, February and March, offices of the Service received registrations from 66,311 job-seekers and made 13,293 placements.

Placements in March were well distributed throughout the State and among all industries. Building construction led with 1,880 placements. Personal service followed with 1,589; miscellaneous manufacturing, 356; hotels, restaurants and amusements, 350; and retail distribution, 307. Textiles came sixth with 201 placements.

In the first three months of 1937 442 placements were made in textile plants. In this quarter, 468 such placements were made directly by the Service and 422 limited placements were made in which the Employment Service rendered aid but took no credit for the placements.

Registrations of job-seekers with the Service in March totaled 14,941 of which 9,756 were men and 5,086 women.

Manufacturing as a whole contributed more largely to unemployment in March than in February. February showed 49 per cent as having been last engaged in manufacturing, while March registrations showed 51 per cent last employed in this group.

In March, 446,850 persons made calls on offices of the Service either in connection with benefit claims or employment. The original claims filed during the month totaled 30,957 and continued claims totaled 299,506.

In January, February and March, 1,175,465 personal calls were made to the offices and 915,394 claims filed. Of these, 143,430 were original claims.

A decline in registrations of 15 per cent is shown for the Rocky Mount district during March with an increase in placements of 34 per cent. Manufacturing accounted for 60 per cent of all new applications during the month and miscellaneous manufacturing largely tobacco and fertilizer, furnished 67 per cent of these; textiles only 18 per cent. The active file in this district on March 31 was 14,016. The Greenville office in the

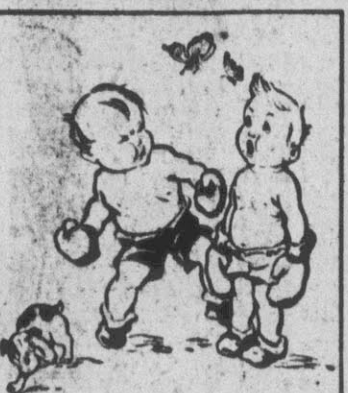
