PAIR INVOLVEDChain Letter Propaganda Charged Both
for and Against Administration AimsWashington, April 26.—
(AP)—The State Department
implied to the House
Foreign Affairs Committee
today that it believed Italy
and Japan had violated international
treaties in operations
against Ethiopia and China.Chairman McReynolds (D-Tenn.)
read to the committee a letter from
Sumner Welles, acting Secretary of
State, which cited previously de-
partmental expressions of its views
on the observance of international
obligations.The letter was in response to a
request for the department's opinion
of a resolution by Representative
Scott (D-Calif.), which asked the
President to specify what nations
in recent years have violated
treaties to which they and the United
States are signatories.On the Senate side of the capitol
today Senator Norris (Ind.-Neb.),
usually an ardent administration
supporter, said he would vote against
President Roosevelt's naval expansion
bill.Other developments:
Representative (R-N. Y.) accused
Harry Hopkins of inspiring
"chain letter propaganda" in favor
of the President pump-priming program.Taber's statement to newsmen
came while House members had before
them an anonymous letter to
President Roosevelt telling of "new
propaganda about to be launched
against your recovery program." A
petition form was attached to the
letter, which the writer said originated
in a large corporation in New York.A joint conference committee
completed work on a compromise
draft of conflicting Senate and
House tax revision bills.With differences between the two
bills composed, Chairman Harrison
(D-Miss.), of the Senate Finance
Committee, said the compromise
measure "is the most forward step
in years toward helping employment
by private initiative through a fiscal
policy of the Federal government."N. C. Descendant

united in mass weddings throughout
the Kingdom today in honor
of King Zog's wedding tomorrow
to the Countess Geraldine Apponyi
of Hungary.Fifty were married at the Sovereign's
expense and 100 at the
expense of various municipalities.
They were selected by local authorities.A large crowd gathered to witness
the ceremony at the Tirana
city hall, where 14 couples were
married.In Berlin it was announced Chancellor
Hitler sent King Zog an automobile
bearing the Albanian Royal
court of arms and also a helmet
of the Albanian national hero,
Skanderbeg, as a wedding present.Raleigh, April 26.—(AP)—The
marriage tomorrow of Countess Geraldine
Apponyi of Hungary and
King Zog of Albania is entirely a
love match, Raleigh relatives of the
Countess said today, and the queen
to be has "American Southern
charm" from her North Carolina
ancestors.The Countess is the granddaughter
of the former Virginia Harding,
a native of Raleigh, who is the wife
of Baron Strade d'Eka, Swedish
Minister to Austria.Judge George Paul, a member of
the old State Corporation Commission,
had a letter from his cousin
Madame d'Eka, saying that King
Zog "fell in love with pictures of
the Countess and for months sent

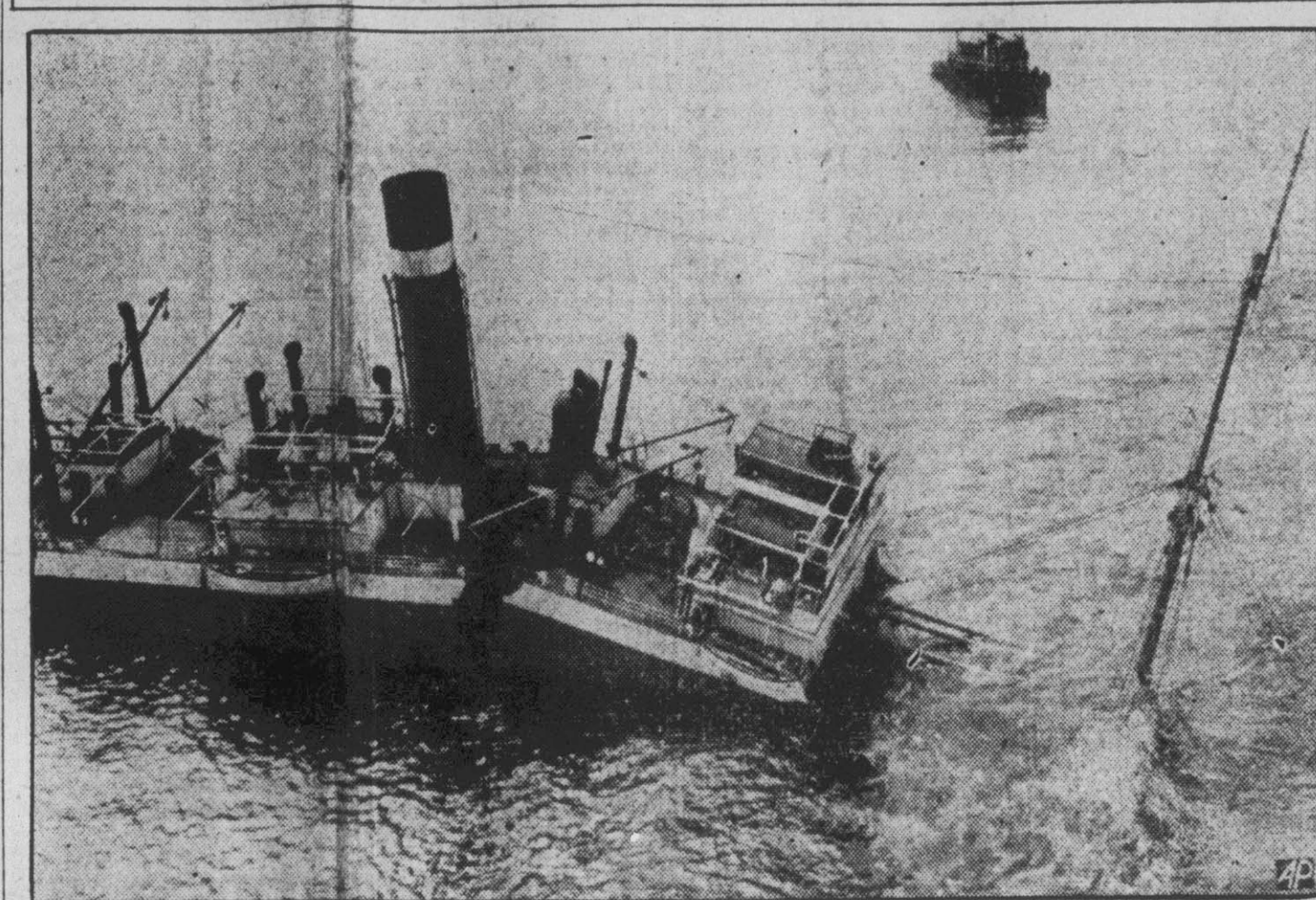

IN N. C. TOWNSDedicates Postoffices
At Mooresville and
NewtonMooresville, April 26.—(AP)—
Postmaster General James Farley
complimented Mooresville on the
growth of its postal business today
as he dedicated its handsome \$60-
000 new post office.The building, of colonial design
with brick exterior walls and lime-
stone trim, was completed last year
and has been in use since August.Farley recounted that the Mooresville
post office was established on
August 7, 1871, and the order estab-
lishing it fixed the postmaster's salary
at \$12 a year. By last year receipts
here had grown to nearly
\$19,000.Later at Newton, Farley dedicated
Newton's new \$60,000 post office and
asserted that Newton's growth and
its postal business in recent years
were ample evidence of its industry
and community spirit.In the past 11 years, about four
billion pounds of industrial ex-

Governor Hoey appointed
Attorney General A. A. F.
Seawell to the State Supreme
Court today and named Har-
ry McMullan Attorney Gen-
eral to succeed Seawell.McMullan will name a new as-
sistant Attorney General later.
Seawell, a veteran public servant
succeeds the late Associate Justice
George Connor, who died suddenly
Saturday."A large number of worthy and
capable men were presented, but I
could name only one man and I finally
decided to select the Attorney
General," Hoey commented.The court does not sit for hear-
ings this week, but Clerk Edward
Murray said it might meet in special
session for administration of the
oath to Seawell.McMullan said he was not cer-
tain just when he would take his
oath.Seawell will serve as an associate
justice of the court and McMullan
as Attorney General by appoint-
ment until the November election.
The executive committee of the

must nominate candidates for the
posts and the winners will assume

Attorney General will serve the two

THIS DISTRICTBest Record for Entire
State Set in This
SectionAlthough they could hardly be
held responsible for highway fatali-
ties, patrolmen are pleased more
than anyone else when they are
able to make a report showing a
low accident rate, and the March
report made the officers situated in
District 2, Troop A, feel especially
good.Troop A is divided into three dis-
tricts. Last month 13 persons were
killed in highway mishaps in the
division. Of the 13, however, only
one was in this district, which in-
cludes Edgecombe, Martin, Pitt,
Tyrrell and Washington counties.Sergeant D. G. Lewis of Rocky
Mount is head of the district, which
is included in the troop under the
supervision of Lieut. Lester Jones,
with headquarters in Greenville.District 1 reported five fatalities

BRIEF RECESSNo Cases Heard At
Superior Session
This AfternoonPitt Superior court took a recess
this afternoon after disposing of
several cases at the morning ses-
sion, but hearings will be resumed
tomorrow morning.Zeno Bill Allen was convicted of
illegal possession of whiskey and
given an eight months sentence, sus-
pended for 12 months on condition
that he pay the costs, remain of
good behavior, refrain from the use
of intoxicating beverages and not
operate his filling station on the
Falkland highway in any manner
that will involve possession or traf-
fic in liquor in any form.Robert Dixon pleaded guilty to
driving drunk and was given a six
months sentence, suspended upon
good behavior and further provision
that he pay the costs of court and
a \$50 fine. The defendant's license
was revoked for 12 months.Willie Dixon pleaded guilty to
driving with insufficient brakes after
being freed on a verdict of driving
drunk. He was ordered to pay \$25

Lunghai RailwayShanghai, April 26.—(AP)—Japa-
nese, driving forward savagely only
12 miles from the East-West Lunghai
railway, their objective in four
months of fighting, reported today
the entire Suchow area was being
evacuated by Chinese civilians.A Japanese army spokesman said
aerial observations showed all roads
in the sector choked with Chinese
farmers carting their belongings
southward and westward in appar-
ent expectation of a rapid Japanese
advance on Suchow, the strategic
junction of the Lunghai and North-
South Tientsin-Pukow railway.At the same time a wide shake-up
in the Japanese naval command in
Chinese waters was announced.Transferred to unidentified posts
were Vice Admiral Hasegawa, com-
mander-in-chief of the third fleet
in Chinese waters throughout the
Shanghai operations; Rear Admiral
Honda, who issued many of the
navy's statements and explanations
at the time of the sinking of the

OF ABDUCTIONChildren Taken from
Mother and Return-
ed to U. S.Nassau, Bahamas, April 26.—(AP)—
Forrester Scott, Philadelphia law-
yer, and Stanley Boynton, an avi-
ator, were acquitted by a directed
verdict today of charges of attempt-
ed kidnapping.The two were accused of at-
tempting March 16 to seize Scott's
daughters, Eve and Zoe, and fly
with them back to the United
States. The children had been
brought here by Scott's former wife,
now Mrs. Harry Clerk Boden.Sir Richard Tute, scarlet-robed
presiding justice, directed the ac-
quittal on the grounds that Mrs.
Boden's testimony for the prosecution
was inadmissible because British
law does not recognize Reno
divorces. Also that a wife may not
testify against her husband.Scott and Boynton in jail in de-
fault of bail, were discharged from
custody and received congratula-
tions from many in the crowd out-
side the courthouse. Boynton and
his wife wept in relief.Scott said he planned to return
immediately to Philadelphia, while
Boynton said he would go to Rock-
land, Maine.Little Conway Girl
Suffers Broken NoseMartha Conway, eight-year old
daughter of Mr. and Mrs. E. R. Con-
way, is in Pitt General hospital suf-
fering with a broken nose as a re-
sult of a collision yesterday after-
noon between her bicycle and an
automobile driven by a Negro.Mr. Conway said this afternoon
his daughter was not seriously in-
jured and he hoped she would be
out of the hospital in a few days.
Mrs. Conway was in Kentucky vis-
iting relatives when the accident
occurred.The name of the Negro driving
the automobile is not known to Mr.
Conway, but he is understood to
have gone to the hospital after the
accident. Mr. Conway, however re-
mained with his daughter and did
not talk to the Negro.Illiteracy Rate High In
County Home PopulationRaleigh, April 26.—Illiteracy well
may be one of the principal reasons
for the establishment and main-
tenance of county homes in North
Carolina, according to a survey re-
cently completed by Dr. J. Wallace
Nygard, director of the Division of
Institutions and Corrections, State
Board of Charities and Public Wel-
fare.Dr. Nygard's report on the sur-
vey shows that of the 2911 inmates
of 85 county homes in the state
during February, 1938, there were
1,367, or 47 per cent who have had
no schooling whatever."The county home residents," he
said, "are decidedly low in educa-
tional training, as 47 per cent are
illiterates, completing no grade in
school; 21.4 per cent stopped school
while in the elementary grades, 19.2
per cent had had training in the
grammar grades; 5.2 per cent were
in high school when their educa-
tion ceased, and 27, or 9 per cent,
were in college or were college
graduates."Almost 33 per cent of the insti-
tution inmates had defective vision,
the report discloses, adding:"In any county home survey it
is necessary to know the number
of inmates with defective vision who
are eligible to receive Aid to the
Blind assistance. Since the survey
was made by social workers, rather
than by experts on vision, for the
purpose of this study the instruc-
tions defined an individual having
defective vision as one who cannot
read ordinary newspaper with the
aid of glasses, or, if illiterate, can-
not count fingers at 20 feet; with
the aid of glasses. With this de-
scription, 957, or 33.8 per cent, of
the total number of inmates are
listed as having defective vision.
The Blind Commission has been
supplied with the names and data
on all individuals so listed. Arrange-
ments are being made for ophthal-
mological examinations, and fol-
lowing this fitting for glasses, Aid to
the Blind or rehabilitation will be
provided as the examinations indi-
cate."GREAT BRITAIN
BOOSTS RATE
OF INCOME TAXIncrease Made Help
Pay For Cost Of
ArmamentsSIR JOHN SIMON
REVEALS ACTIONAlso Discloses That
Britain Already Has
Purchased Wheat,
Whale Oil, SugarLondon, April 26.—(AP)—
The British government
jolted the nation today by
boosting the income tax
from 25 per cent to 27 and
one-half per cent to help pay
the costs of the staggering
rearmament program.Britain's rearmament program
confronted the British tax payer
with the largest peace time budget
bill in the nation's history, totaling
\$44,398,000 pounds (\$47,190,000).Sir John Simon, Chancellor of the
Exchequer, making his budget
speech in the House of Commons,
announced that the government's
need, for the 1938-39 fiscal year
were 81,500,000 pounds (\$87,500,000)
more than for the previous year.To an intent house he disclosed
the government already had bought
"sufficient supplies of wheat, whale
oil and sugar" to maintain civilian
needs for the first few months if
war broke out.Makes Report On
Grading Of MilkJ. T. Welch, Greenville City
Sanitary Inspector, has just re-
leased through the Pitt County
Health Department the grades made
by all dairies holding permits from
the local health department, and
the grade made by the pasteurization
plant. This report covers the first
quarter of the year and is as fol-
lows:Harvey's Dairy, Greenville, Grade
A; Blount's Dairy, Bethel, Grade
A; Harvey Williams Dairy, Wash-
ington, Grade A; Pecan Grove Dai-
ry, Farmville, Grade A; Steadman's
Dairy, Pinetops, Grade A; Andre-
olis' Dairy, Pantego, Grade A; T. S.
Little Dairy, Farmville, Grade A;
Carolina Dairy Pasteurizing
Plant, Greenville, Grade A.Mr. Welch stated that it was
gratifying that the dairy managers
had shown great interest in im-
proving their dairy products. He
called attention to the fact that it
appeared that some citizens were
under the impression that the milk
ordinance did not permit the sale
of raw milk in Greenville. He ex-
plained that there was nothing in
the ordinance prohibiting the sale
of raw milk if the milk came up
to the Grade A standard. In other
words, insofar as the ordinance is
concerned, raw milk, if Grade A,
has all the privileges accorded pas-
teurized milk even though it is gen-
erally conceded that by pasteurizing
raw milk an added element of safety
is secured.In commenting on this milk
grade report, Dr. Ennett, Pitt County
Health Officer, stated:"There is no substitute for milk as
a food for the young and the old.
The one requirement which every
citizen should insist upon is that
the milk come from cows known to
be tested for tuberculosis and for
Bangs' disease, and that the milk
be handled in a sanitary manner.
The great reduction in the number
of cases of tuberculosis in infancy
and the great reduction in the num-
ber of infant deaths from diarrhea
and enteritis has been largely due
to the enforcement of milk regu-
lations."Federal Purchase Of
Cabbage to be SoughtRaleigh, April 26.—(AP)—The
North Carolina State College Exten-
sion Service announced today that
arrangements had been made with
the Federal Surplus Commodities
Corporation to buy cabbage in East-
ern North Carolina to remove a sur-
plus from the open market.L. P. Watson, extension horticultu-
ralist, will go to New Bern this
afternoon to arrange office space.Tomorrow at Wilmington a com-
mittee of growers will meet with the
county agent and a representative
of the Surplus Commodity Corpora-
tion to establish a price for the
cabbages.

Raleigh, April 26.—Given just one
more vacancy between now and the
general election, Governor Clyde R.
Hoey would have a majority of his
own appointees sitting on the Su-
preme Court bench.

Justices M. V. Barnhill and Wal-
lace Winborne were put on the
bench by a Hoey commission and
by the time this appears in print
someone may be qualified to succeed
Justice George W. Connor. Which
will make three out of seven for the
Governor.

And all this without getting all
heated up about "court reform" like
President Roosevelt did—and a bet-
ter percentage, too, as F.D.R. only
aimed at having six out of fifteen.

Sen. Hoey Governor Hoey falls
short of the mark of tobacco-chew-
ing Cam Morrison who named three
members of a five-judge Supreme
Court bench during his term as
governor. Morrison put Justices
Adams, Clarkson and Connor on
the court.

Incidentally the high mortality
among Supreme Court judges is
making a confirmed hypochondriac
out of Chief Justice W. P. Stacy, his
friends say. Up to a few years ago
the Chief Justice, who isn't an old
man by any stretch of the imagi-
nation, was as sprightly as you
please, but now he walks around
with a cane, stoops over like a bar-

case of Justice Heriot Clarkson, who

F. W. HANCOCK NOT IN LEGION

(Continued from page one)
the ruling of October 29, although North Carolina Department head-
quarters on that date wrote the Ad-
jutant of Ernest F. Hart Post of

the Legion, at Oxford, that the re-
cord of service submitted by Han-
cock did not entitle him to mem-
bership in the Legion.

Department Commander Hector Blackwell, at Fayetteville, told this correspondent that the Hancock membership card, issued by the Ox-
ford post, was received at head-
quarters on October 27 and that, without challenge on the part of anyone, the Department Adjutant notified the Oxford adjutant under date of October 29, that Hancock was not eligible on the face of the record showing that the Oxford man served briefly in the first Of-
ficers Training Camp at Fort Ogle-
thorpe.

Commander Blackwell expressed the opinion that not only is Han-
cock ineligible under the Legion's
Constitution and By-Laws, but under the Federal charter granted the
Legion by the U. S. Congress. He
said no statement had been made
by the Department because he felt
that Hancock had acted in full good
faith and had not been informed
of his ineligibility.

He said he could not understand
why the Oxford post officials had
not notified Hancock and taken up
the membership card issued him in
October.

In response to a request from
this bureau for a statement regard-
ing the matter Representative Han-
cock wrote, under date of April 23:
"In May 1917, shortly after the
United States declared war, I vol-
unteered for service in the Officers
Training Camp at Fort Oglethorpe,
Georgia. Because of circumstances
of a delicate and sacred nature in
my family, I could not complete my
training and I was honorably dis-
charged after a short service."
"In October of last year, I was
invited and urged, as I had been
many times before, by officers of

the Ernest F. Hart Post of the
American Legion to become one of
its members. I turned over to the
Adjutant of the Post my honorable
discharge certificate with the card
discharge, and in my absence from
Oxford, he returned to my office the
membership card, issued by the Ox-
ford post, was received at head-

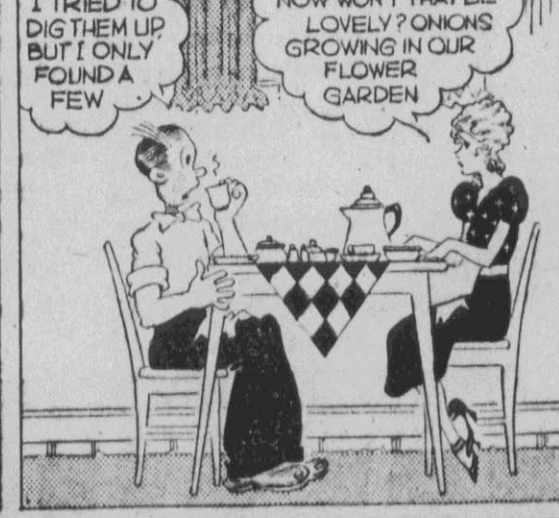

Corn Production In Cotton South Off From Average

Yield for Three of Past Five Years in Southern States Below 1928—1932 Production

Raleigh, April 26.—Corn produc-tion in the cotton South has dipped under the average for the 5-year period of 1928-32 in three out of the immediate past five years, according to Dr. G. K. Middleton, agronomist of the State College Experiment Station.

Although the number of bushels of corn produced in these states during 1933-37 has been smaller, there has been a small increase over the previous five years in corn acreage.

The 1928-32 average of corn acreage in these states was 28,807,000 acres. The 1933-37 average was 30,247,000 acres. However, the acreage in 1937 was 28,730,000 or slightly less than the 1928-32 average.

The average yield of corn in these states is 15.3 bushels per acre, although the North Carolina figure is a few bushels higher. This compares with an average yield of 25.4 bushels per acre for all farms in the United States, and an average yield of 38.3 bushels in Iowa.

The Southern states have about 2-1-2 times as much corn acreage as Iowa, yet that Mid-Western state produces as many bushels as all the twelve states.

STATE UNABLE HOUSE INSANE

Points Out Need Of Hospitals In N. C.

Raleigh, April 25.—Four per cent, or 116 of the 2,911 inmates of 83 county homes in North Carolina during February of this year were actually insane, and 910, or 31 per cent were feeble-minded, according to a survey of those institutions recently completed by the Division of Institutions and Corrections of the State Board of Charities and Public Welfare of which Dr. J. Wallace Nygard is director.

The results of the survey, Dr. Ny-gard said, showed that 1,272 inmates were normal, 580 were "harm-lessly deteriorated," and 33 were not placed in a definite category as to mental status.

The division director defined the feeble-minded as "those individuals incapable of managing their affairs with ordinary prudence because of lack of mental development from birth or early infancy." The definition for the actually insane was "those who are disturbed, hallucinated, or have delusions, extreme de-pressions, maniacal symptoms or suicidal tendencies," while the

"harmlessly deteriorated" are de-scribed as "those whose minds are falling from old age."

Dr. Nygard said that the number of actually insane persons who are inmates of county homes "indicates the need to increase state hospital facilities to meet this situation."

"North Carolina's state institu-tions for mental patients are like those in other states—limited as to capacity," he asserted. "Caswell Training School, an institution for the mentally deficient, and the unit for Negro feeble-minded at the Goldsboro State Hospital, are especially crowded. County homes will nec-essarily have to continue caring for many elderly individuals whose minds are failing from old age, and for many of the feeble-minded who cannot be cared for in any other way."

The report recommended that the "actually insane (sufficient to en-danger themselves or others) should be transferred to state hospitals as soon as possible."

TO BEGIN WORK ON N. C. ROADS

Wheels of Idle Machinery to Turn Again Shortly

Reflector Bureau. Raleigh, April 23.—Now that the \$2,000,000 allocation for secondary road improvement has been divided up among the road districts of the state, some of the \$1,000,000 worth of idle road machinery in North Carolina has begun to hum.

The wheels will continue to turn for much of this equipment only for a comparatively brief period, because the State Highway and Public Works Commission is com-pelled to keep nearly \$4,000,000 idle in its coffers because of the ever-present threat of diversion. If this constant threat could be removed, anti-diversionists point out, this state's secondary roads could be put in much better condition and hun-dreds, even thousands of men now idle could be put to work.

Publicly, State Highway Chair-man Frank Dunlap couldn't be pried loose from a statement that there has been \$1,000,000 worth of machin-

ery idle because of lack of funds to put it to work, but privately high officials of the department make no bones about the fact.

These "off the record" spokesmen aver that the situation is made the more galling by the fact that there is WPA money available for labor to go along with the operation of the road machinery, but the labor is useless without funds for materials and other construction and maintenance expenses.

The \$2,000,000 allocation will un-doubtedly be swallowed up by the secondary roads in double time or-der and few are hardy enough to predict that the filling of a few mud puddles will be any great ad-vance in the condition of the road system.

Opponents of diversion declare that if the idle \$4,000,000 could be added to the \$2,000,000, the High-way Commission would really have something and that motorists would get something real in return for the tremendous load of taxation they bear.
