Great Volume of Records Yet to Be Considered

Further Cross Examination of Auditor Is Delayed by Agreement of Counsel

Proceedings on the petition of members of the County Board of Commissioners to remove Sheriff S. A. Whitehurst from office entered the second week this morning with the entire morning's session being taken up with the testimony and cross examination of one witness.

At the beginning of this morning's session W. L. Patrick, assistant clerk and assistant tax collector, for the city of Greenville, who had been acting as special court officer, asked to be relieved and E. G. McQuinn, former highway patrolman, was appointed by the court to succeed Patrick. Miss Hilda Jacobs, of New Bern, court stenographer for this district, who covered the first week of the hearing on the ouster petition, found it necessary to attend a criminal session in another part of the district this week and Miss Kate Wade, of Goldsboro, is recording the testimony this week.

When court recessed Friday afternoon L. R. Ausbon, employee of Williams and Wall, was still on the stand undergoing cross examination on his testimony regarding his audits of the jail fees accounts. By agreement of counsel this morning, his further cross examination was delayed while the court heard the testimony of T. A. Henderson, clerk of court of New Hanover County. Mr. Henderson dealt with eleven summons issued from his county and served through the sheriff's office of Pitt County, on which it is alleged the sheriff failed to turn over the fees to the county. The total amount involved in the New Hanover summons was \$33.66.

The early part of the hearings, which began last Monday dealt with testimony tending to establish the bribery and failure to perform duties in the way of arresting bootleggers and other criminals as charged in the petition and since that time the testimony has dealt with the matter of failure of the sheriff to turn over certain fees to the county. During the past two days only two witnesses have taken the stand and one of these is yet to complete his cross examination. With the great volume of details and records yet to be considered, neither Judge G. V. Cowper, presiding over the case nor counsel for either side would hazard a guess as to when the case might come to the end. The testimony of the petitioners is expected to consume several more days for hearing and more than one hundred witnesses have been summoned by defense.

CLAIM SUCHOW ENCIRCLED BY JAP SOLDIERS

Dispatches Contend Troops Closing In On City

PREDICT FALL OF STRATEGIC TOWN

Nippon Troops Pushing Westward After Having Cut Lung-hai Line

Shanghai, May 16.—(AP)—Japanese dispatches declared today that Suchow had been completely surrounded and Japanese troops were closing in from all sides on thousands of Chinese trapped in the area around the vital Central China rail junction.

The Japanese asserted it would be only a matter of hours before they actually assault the strategic city, for which they have been fighting for months.

Encirclement of Suchow was accomplished, the Japanese said, by closing the last gap to the west below the Lung-hai railway near Pang-shan. This railroad town is about 50 miles west of Suchow.

Troops fighting toward the railway from the north and south converged near Tangshan, the Japanese reported, and then fought their way eastward along the railway to Hwangchow, only 30 miles from Suchow.

The Jap said troops, which yesterday cut the Lung-hai line were pushing rapidly westward.

Farley Attempts Solve Party Row

New York, May 16.—(AP)—Postmaster-General James A. Farley said today he felt the political situation in Pennsylvania "imperils the success of the Democratic party in the November election." He spoke as chairman of the Democratic National committee.

Farley said that "in my judgment, the only way to protect the interests of the people in that state (Pennsylvania) would be to nominate Tom Kennedy for governor and George Earle for the senate in tomorrow's primaries."

"This will not be a complete victory for either faction, yet I am convinced it is the only solution of the present situation."

In Philadelphia Governor Earle, saying "the Democrats of Pennsylvania will not turn their party over to John L. Lewis," assailed Farley's naming of Earle and CIO-backed Kennedy as a team Pennsylvania Democrats should support.

SPUD GROWERS VOTE CONTROL

Raleigh, May 16.—(AP)—Tish potato growers in Currituck, Washington and Edgecombe counties reported heavy votes for a proposed control program today and North Carolina State college extension officials said a two-thirds favorable majority was assured.

Nearly complete returns from 31 North Carolina counties which took part in the referendum on Friday and Saturday showed 1,129 votes for control and 581 against, a favorable percentage of 66.02.

Similar votes were taken in 13 states.

The growers balloted their opinion on control individually, but also had to list their poundage. The control program may be made effective if approved by either two-thirds of the growers or growers representing two-thirds of production.

COURT ORDERS FIVE STRIKERS BE REINSTATED

Upholds Right Strike Over Unfair Labor Practices

PROTECTION FOR WORKER ASSURED

Supreme Tribunal Also Agrees to Review Litigation Brought by Private Utilities

Washington, May 16.—(AP)—The Supreme Court ruled today that working men who strike as a result of an unfair labor practice by their employer, are entitled to protection of the National Labor Relations act.

This decision was given in upholding an order by the National Labor Relations Board directing the MacKay Radio and Telegraph Company to reinstate five employees who had gone on strike in San Francisco.

Justice Roberts, who delivered the decision, asserted that the strikers remained employees under the labor act "and were protected against the unfair labor practices denounced by it."

Roberts announced no dissent. Justices Cardozo and Reed did not participate.

The court agreed to review litigation brought by 18 private utilities challenging constitutionality of the government's Tennessee Valley Authority power program.

In an order the tribunal consented to pass on a decision by a three-judge Federal District Court in Eastern Tennessee that the companies "have no immunity from lawful competition even if their business be curtailed or destroyed." Justice Reed did not participate.

At the request of the government, the court ordered the Third Circuit Court of Appeals at Philadelphia to show cause why it should not permit the National Labor Relations Board to recall its order against the Republic Steel Corporation directing the corporation to reinstate 5,000 workers who struck last summer.

Trio Ordered Put Children in School

Three Negro defendants haled in to City Recorder's court on charges of failure to send their children to school received suspended sentences from Judge W. A. Darden this morning upon condition they put their children in school as prescribed by law.

The three were Emma Morris, Annie Hyman and James Filmore.

H. C. Bobbitt and James Williams were haled into court on charges of careless and reckless driving. Bobbitt was ordered to pay one-half the court costs and Williams was given a 60-day sentence, suspended upon condition he pay half the costs and \$25 for property damages sustained by the prosecuting witness.

Lula McLean Negro, was given 30 days for drunkenness; Julian Vines, Negro, was sent to the roads for 90 days for larceny of a lawn mower from the Home Furniture Company and Henry Hathaway Negro was sent to the roads for 30 days each on a charge of drunkenness, engaging in disorderly conduct and resisting arrest.

From 50 to 65 Declared to Have Been Registered

INJURED KNOWN TOTAL THIRTEEN

More Than a Dozen Rescued or Leap to Safety as Old Structure Destroyed

Atlanta, May 16.—(AP)—Flames which started in a basement kitchen killed 25 persons at the Terminal Hotel early today, left 13 injured and others missing.

More than a dozen persons were rescued or leaped to safety.

The number of victims unaccounted for was a matter of conjecture. Reports to firemen and police indicated that from 50 to 65 persons were registered in the 62-room, five story brick and frame building.

City sanitary crews were sent to work in mid-morning removing the debris. Engineers estimated two days would be required to clear the wreckage.

Many of the dead were found in charred embers and steel which dropped from the roof, carrying away the burning floors.

Police Chief M. A. Hornsby expressed belief 10 or 15 more bodies would be found in the mass of debris piled up on the street level.

Police with bulldozers gained headway amazed witnesses.

A police lieutenant said he was five blocks away in a patrol car when he saw the fire shoot up and that by the time he arrived smoke veiled all the building.

Raleigh, May 16.—Governor Clyde R. Hoey climaxed a more or less routine week at the state capital last Friday by appointing W. C. Feinster, Newton lawyer, to the State Liquor Board for a term of three years, succeeding T. J. Murphy of Greensboro, who was not re-named because of ill health.

The appointment was a major one and upon the work of Mr. Feinster on the board depends largely the success or failure of the county option plan of liquor control. The new appointee is a life-long dry and the western part of the state and advocates of control are somewhat fearful of any dry on the board.

The Governor, too, is thought to have played more than a quiet part in selection during the week by Attorney General Harry McMullan of Lee Overman Gregory of Salisbury as an Assistant Attorney General, Wade Bruton, one of the staff of assistants for some time, was moved up to principal aide to McMullan.

At Raeford, dedicating an armory Wednesday, Governor Hoey departed from his usual pacific role and stoutly called for a naval and military establishment strong enough to keep this "have" nation from the aggressions of the "have nots," whom he did not name.

WHAT IT MEANS: That Pennsylvania Primary

(The Pennsylvania primary campaign has been described piece meal in the bitter charges and counter charges of the candidates. Morgan Beatty here strips down this important indicator on the national political horizon to a simple analysis of what it means to an outsider.)

Washington—Nearly every politician has wet his finger and stuck it into the breeze kicked up by that Pennsylvania primary campaign.

Here are two main reasons why the Quaker state results may tell which way the national political winds are blowing:

1. Both major parties have split roughly into conservative and liberal wings, so the primary should show the way the public is leaning these days—to the right or to

the left.
2. One wing of the Democratic party is frankly supporting a dyed-in-the-wool labor leader for governor—the first such candidate who ever had more than a forlorn hope in an important primary. The candidate is Thomas Kennedy of John L. Lewis CIO. The questions are: as a major party wise to boost labor to a commanding position in party leadership? Will labor support a CIO candidate solidly, or will the break between the American Federation and Lewis cancel out the labor vote?

Both Parties Split

The main thing to remember is that the Republican and Democratic parties are picking nominees for United States senator and governor, who will run for election in November.

The candidates have ignored

many party lines: so you may assume for the moment that there are four political parties in Pennsylvania:

1. Conservative Republicans.
2. Progressive Republicans.
3. Regular Democrats.
4. Labor Democrats.

Cause for the split, as usual, was the rival ambitions of political leaders. It just so happens that the division gives a fairly clear-cut issue in each party between regulars and progressives.

The bitter fight has divided the Democrats.

The regular party organization, led by Philadelphia contractor Matthew H. McCloskey and Chairman David L. Lawrence, picked a team for governor and senator. Thereupon the state's recognized party leader, Senator Joseph F. Guffey, snarled at McCloskey and threw his influence with one labor candidate for governor. Just to be sure he would nick some of McCloskey's Philadelphia vote, Guffey also backed Mayor S. Davis Wilson of Philadelphia for senator.

The Democratic Fight
So the Democrats have to choose

also between rival party leaders. In one corner is Joe Guffey, an original Roosevelt Democrat who got his first real taste of Pennsylvania patronage when Roosevelt was elected in 1932. (Pennsylvania went Democratic for the first time since the Civil war four years later.) In the other corner, you have Matthew H. McCloskey, holder of millions of dollars worth of federal and state contracts since the Roosevelt election.

The regular or McCloskey slate: For governor, Charles Alvin Jones, a Pittsburgh lawyer who is getting his first real baptism of political fire; for senator, Governor George H. Earle of Philadelphia, a former Republican who swung to Roosevelt.

The labor or Guffey slate: For governor, Thomas Kennedy, international secretary-treasurer of

the United Mine Workers, and lieutenant governor under Earle, a Catholic, steady, resourceful; for senator, S. Davis Wilson of Philadelphia, a political chameleon who hasn't been able to get along with the leaders in either party but who can get along with the voters of Philadelphia.

There is one lone wolf Democratic candidate for governor who kicked up more than the usual political ruckus and cry of "scandal" in the last stages of the primary. He is Charles J. Margiotti, former Republican but Democratic attorney general under Governor Earle until Earle fired him.

The Republican Fight

The Republican scrap is mild in contrast.

The familiar Republican conser-

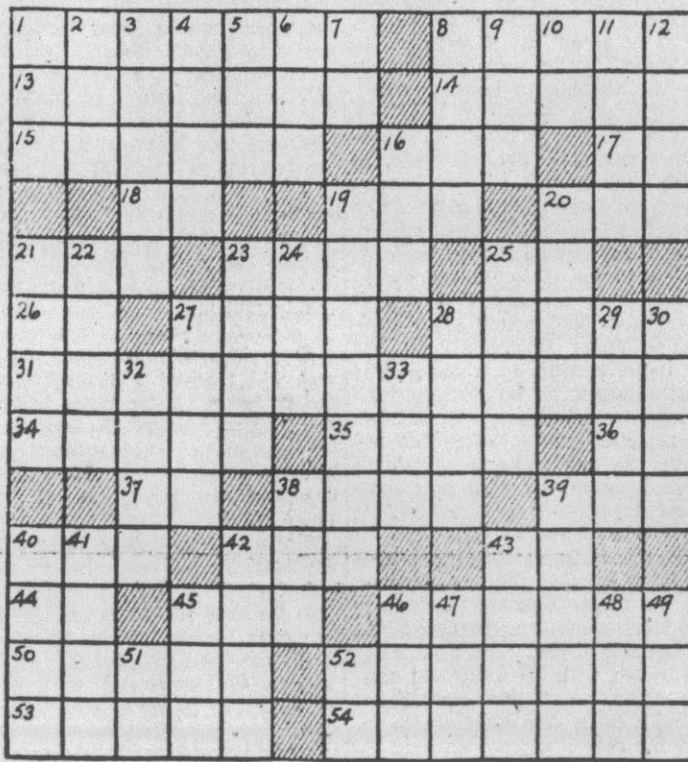

On the other side of the Republican fence is mustached, wealthy, famous Gifford Pinchot, twice beaten in his own party for a nomination to the United States senate, yet strangely enough twice governor despite the opposition of the regular Republican leadership in primaries.

Pinchot is 72, active and an old Bull Moose progressive, who helped Teddy Roosevelt take Pennsylvania away from regular Republican Taft in 1912. He is bidding for a unique record—a thrice-elected governor.

Another independent Republican is Senator James J. Davis—"Pudler Jim" of steel mill and Moose lodge fame—who wants renomination. He is a member of many fraternal organizations and a top notch hand-shaking, catch-as-catch-can vote getter.

The Issue

Thus both parties offer, roughly, a choice between liberals and conservatives with a few Pennsylvania dog fights thrown in to cloud the issue.

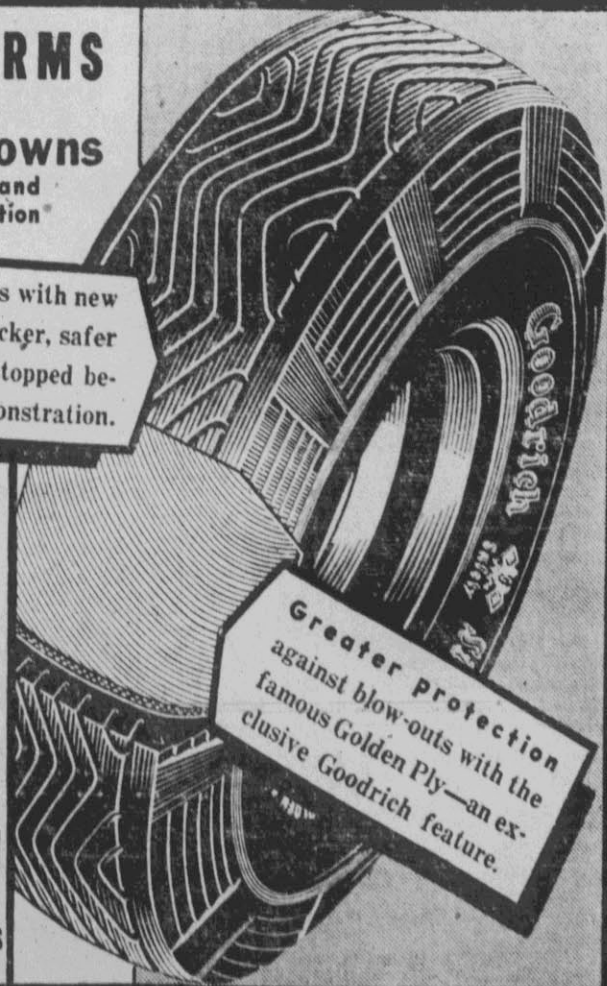

Washington Daybook
By Preston Grouse

Washington—When the back to the farm movement starts, we will be absent because our mathematics, while thorough, is slow and we would not be able to work out our soil conservation contract in time to get at the fall plowing.

Take corn. Last year the farmers planted 49,000,000 acres which produced 2,600,000,000 bushels. That, the department computes is 350,000,000 bushels more than we can eat or sell abroad. So the plan was adopted of reducing the present year's plantings so the country would produce 350,000,000 bushels less than it needs—so that the corn canned over, added to the amount grown, would just equal what we can eat and sell.

The department computed that 40,000,000 acres would produce the desired amount, a cut of 9,000,000 acres below last year. So out to the corn belt went the order to cut acreage 20 per cent. That sounds very simple, for if a farmer last year had 40 acres in corn he could plant 32 acres this year and put the rest in beans or catnip. It does not work out so simply.

Room For Argument
First, it should be understood that the farmer is paid for abiding by the regulations. His farm is assigned a quota of corn, based on how much corn he has grown in the past, the kind of land he owns, the kind of farming he has done and how much tillable acreage he owns. That leaves room for differences of opinion.

When the quota is determined the farmer is promised 10 cents a bushel of "benefits" if he "cooperates" or abides by regulations. Moreover, he is promised a government loan on his crop.
Suppose his quota for his 40 acre farm is 30 bushels an acre or 1,200 bushels. His benefits then will be \$120. But if he decides that maybe the market price this year will be good, he may want to plant five acres more than his 32 acre allowance. Go to it, says the Department of Agriculture, but it will reduce your benefits by 50 cents a bushel. Five acres times 30 bushels times 50 cents as \$75, leaving only \$45 of benefits. Moreover, the farmer loses his right to a government loan.

Sectional Conflict
Now these regulations apply in detail only in the 12 states of the corn belt. To be more exact, they apply only to about half the countries in the 12 states. The result is that a farmer on the corn belt side of a county line may be under these particular crop restrictions while a farmer on the other side is not—and yet the latter gets his benefits right along although under a different sort of soil conservation schedule.

And the end is not yet. In July, a quota is to be decided on for wheat growers. Already it is imposed on tobacco and cotton growers. But while the ticks may pour in, the evidence continues that most farmers like it. More than 90 per cent of the tobacco growers voted for marketing quotas such as have not yet been imposed on corn or wheat.

Raleigh, May 15.—A day or so ago your correspondent listed Harris Newman, of Wilmington, as one of the "wet" Senators likely to hold seats in the 1939 General Assembly; but today this assertion was briskly challenged by Sam Seigler, one of the best-known Wilmington characters, and one of the closest students of political affairs in New Hanover county.

"Listen, you're all wrong. Emmitt Bellamy is going to beat Newman for the Senate five to one," quoth Sam. "Emmett has the support of labor organized and unorganized—of the Coast Line Clerks, of the Veterans and of practically all the plain people," continued Sam.

"They've put the Swastika on Newman's door," concluded the really wrought-up Mr. Seigler, by way of emphasizing his point. "Be that as it may, there still wouldn't be any change in the wet dry lineup, for Mr. Bellamy is just as strong for the county ABC plan as Mr. Newman or anybody else."

Talk of Dick Fountain as a possible candidate for Governor in 1940 reminds that Dick is an unusual political character—one who gets more in the way of votes for less money expended than any candidate in the state, in all probability. Given a sizeable campaign fund and Dick would likely have beaten either Ehringhaus in 1932 or Bailey in 1936. As it was he was just out-spent, if not out-counted.

Most prospective candidates would count their change and decide. "No mon, no run" but with Dick it's different. "No mon, some fun."

Pertinent Query: Who is responsible for the fact that the directory in the Department of Agriculture Building shows its personnel "As of January 1, 1935" The D of A has its roster, with their offices, complete and up to date on the left hand side of the directory board, but the rest is a joke—showing for instance that "W. A. Graham" has "Room 109" and "W. H. Richardson" has "Room 121." Everybody knows what happened to these gentlemen in the Scott whirlwind of 1936.

The rendezvous of Blackbeard, the famous old Pirate, and his racking accomplices in the state government of some 200 years ago, at Bath, is to be restored to its colonial glory, according to reports. "Oldest town in North Carolina," Bath will need little "restoring" to look like its oldtime self, for it is no larger now than the little village it was in 1701.

Pist annual dinner of the Friends of Wake Forest College Library will be held Friday evening, May 20, at the Sir Walter Hotel here. It has been announced by R. W. McMillan and Willis G. Briggs, Raleigh attorneys who are making plans for the meeting. Dr. Joseph Quincy Adams, director of the Folger Shakespeare Library in Washington, D. C. and chairman of the National Committee of sponsors of the organizations will come to Raleigh for the dinner and will deliver an address.

Four additional highway markers have been approved, and will be erected soon. It has been announced by Dr. C. C. Crittenden, secretary of the North Carolina Historical Commission.
Places to be marked are: Birthplace of the mother of James Whistler, famous painter, in Wilmington; the Yellow Mountain Road over which the "over-mountain" men marched to victory at the Battle of Kings Mountain, 1780; the battle of New Bern, fought a short distance south of that city on March 14, 1862; and the site of Fort Totten, just west of New Bern one of the fortifications erected by the Federals after they had gained possession of the town.

Raleigh, May 16.—In Raleigh the latest part of last week's local business, Mercer J. Blankenship, candidate for the State Senate from Mecklenburg, added something to the scramble to take the Unemployment Compensation Commission out of Raleigh and install Charlie Powell and his aids in another city—Mr. Blankenship, quite naturally, plumping wholeheartedly for Charlotte.

The Mecklenburger pointed out to Mr. Powell that more than half the claimants of unemployment compensation come from Mecklenburg and the textile counties such as Gaston immediately adjacent thereto. Hence, he contended, it would be much more logical to locate the office which serves these claimants where it can be reached without traveling some two hundred miles. Not only is this true now, argued Mr. Blankenship, but it will be true every winter from now on, for textile plants are going to use the U. C. C. as a means of taking up the seasonal slack in their operations.

In the future, asserted Blankenship, it is going to be the common thing for textile plants to work during the summer and fall, store up a surplus of goods, then close down in the winter and let the U. C. C. take care of the employees. The employers' argument is that they have paid the money in for unemployment benefits, why not let it be spent in slack periods.

Mr. Blankenship said he represented between 200 and 300 mill workers who have been unemployed for many weeks and have received practically no unemployment compensation. He did not blame the commission but, on the contrary,

expressed the opinion Mr. Powell's department is doing all it can in view of the bad conditions under which it is working, with special reference to the crowding of workers until they rub elbows at the slightest motion.
On the subject of his own campaign, the Mecklenburger was optimistic.

Frank Hancock's speech at Winston-Salem Saturday night is being generally acclaimed here as the bald-faced straddle on the Wage-Hour bill yet to be recorded.

Hancock's position seems to be that he was against the bill as it formerly passed the Senate, but he doesn't know let what is in the new bill and therefore doesn't know whether he's for it or against it.

In his own words: "I shall not, however, be in position to reach a definite decision on the new bill until I have carefully read the final draft which will unlikely be available before the 23rd of this month."

All the pretty political bubbles blown about the lady on the State Liquor Board burst with a loud bang when Governor Clyde R. Hoey Friday named W. C. Feimster of Newton to replace T. J. Murphy of Greensboro. The feminine angle was a good yarn, at that—interesting, even if not true.

Appointment of Mr. Feimster, a life-long dry, will undoubtedly draw criticism from county opinion advocates who believe that the system set up by the 1937 ABC law has a right to a fair chance to prove its worth. A dry, they insist, will go on the board prejudiced against, and perhaps more interested in wrecking than in helping county opinion.

Harry McMullan, Attorney General, has received a request from Cutlar Moore, liquor board chairman, asking whether the ABC law confers on the board authority to assist in prohibition enforcement in those counties which are still, in name, "dry."

While no reply has yet been given, most lawyers say the answer will be "No." Their contention is that the state board was specifically set up to exercise certain functions with reference to counties which vote for ABC stores and that it has no powers or duties in others.

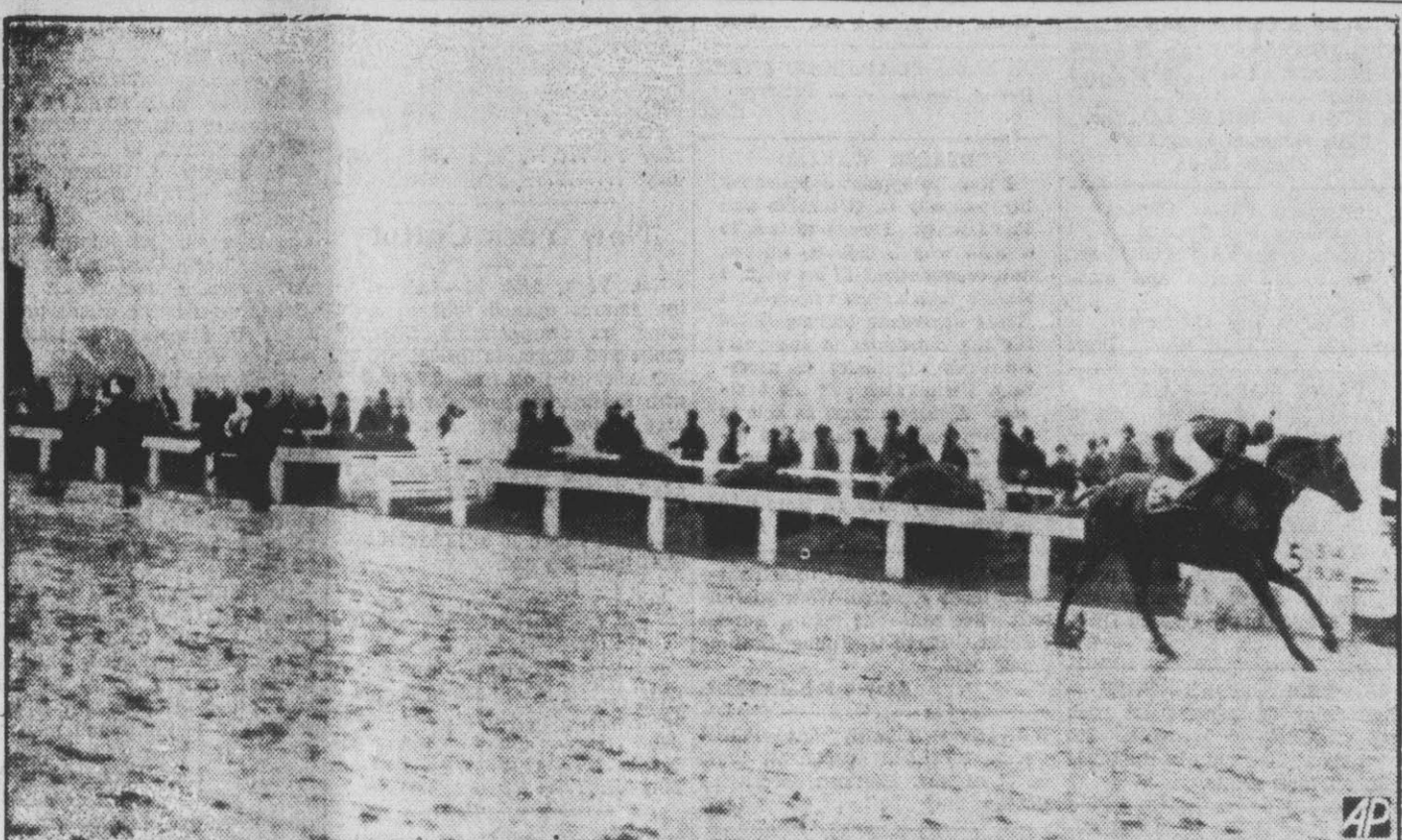

N. Y. Stock Market

New York, May 16.—(AP)—Stock market leaders dallied in an exceptionally narrow range today. Dealings were the slowest in weeks. A few aircraft, after a mild opening slip-up, and one or two rails and specialties clung to minor gains. Fractional declines, however, were in the majority near the fourth hour. The list got off to a sluggish start, with steel and a number of recent favorites late in making their appearance on the ticker tape. Analysts were again encouraged somewhat by the lightness of offerings, these recalling that in the past several weeks the only real volume has been on the advancing side. Tomorrow's Pennsylvania primaries, brokers said, combined with shifting Washington currents to keep speculative forces from doing much either way. Bonds and commodities were uneven and the European securities markets inclined to give ground. Many leaders yielded fractions to more than two points in the final hour, when selling picked up a bit and declines became more pronounced. The turnover of about 400,000 shares was one of the smallest in two weeks.

Ban On Diversion Would Be Seen As Boost To Safety

State Senator S. Gilmer Sparger Expresses Opinion Constitutional Amendment Would Aid

Raleigh, May 16.—A Constitutional amendment forbidding diversion of highway funds would be a long step toward promotion of safety on the state's roads, in the opinion of State Senator S. Gilmer Sparger, secretary of the North Carolina Petroleum Industries Committee, who is waging an intensive drive over North Carolina for adoption of such an amendment.

"The amendment would promote safety in two ways, at least," he said. "First, it would permit the building of safer roads because there would be more funds available for road building, and secondly, it would be possible to increase the personnel of the State Highway Patrol with the funds which would be made available by stopping diversion."

He pointed out that no one can expect the state to build all its roads of a type designed especially to accommodate careless and irresponsible drivers (roads as nearly "fool-proof" as possible), it is a recognized fact that too many accidents are directly attributable to defective and inadequate highways. And thousands of miles are thus in adequate and defective because funds from automotive taxes have been diverted to other uses.

Recently published statistics regarding the mileage covered by the State Highway patrol of 120 officers indicate that there is a real need for an increase in personnel, Senator Sparger said. With such an increase much closer supervision could be exercised over drivers, he added.

"This wouldn't mean that more people would be arrested or more fines imposed," he said. "It means that driving would be safer because drivers would be much more careful. It is an acknowledged fact that every driver on the road is more careful when in sight of an officer, or when he expects to see an officer any minute. It follows that if there were more patrolmen to see on the roads, driving would be safer. And if it weren't for diversion there could be an increase in the Highway Patrol personnel."

Los Angeles — (AP)—The All Year Club of Southern California estimates that Eastern tourists pour a stream of trade at the rate of \$24,000 an hour into Southern California.

In the first quarter of 1938, there have been 212,106 motoring tourists in the state, the club reported an increase of 15.1 per cent over the corresponding period of last year.
