ANOTHER WEEK CONCLUDED IN OUSTER TRIAL

Assistant Clerk of Lenoir County On the Stand Today

J. F. HARRINGTON ALSO TESTIFIES

Clerk of Pitt Court Called to Stand For Third Time During Deliberations

The second week of hearings on the petition of individual members of the Board of County Commissioners to oust Sheriff S. A. Whitehurst from office, was concluded this afternoon, when Judge G. Vernon Cowper recessed court until Monday morning.

The court was in recess yesterday to permit attorneys and others to attend the Democratic convention in Raleigh. The hearing again dragged slowly this morning as a result of detailed testimony regarding documents upon which audits being offered in evidence are based.

With the testimony of the first auditor still incomplete, and with other auditors to take the stand, the prosecution probably will not complete offering its testimony until some time next week. More than a hundred witnesses have been summoned by the defense, indicating that the hearing still has many days to run.

This morning's first witness was Miss Doris Sutton of Kinston, assistant Clerk of Superior Court of Lenoir county. Miss Sutton's testimony was in support of certain documents upon which she testified when she appeared on the stand last week. The matter dealt with certain summons issued from Lenoir county and served through the sheriff's office of Pitt county. Her testimony this morning included the introduction of judgment dockets from her office showing disposition of the cases and payment for service of the summons. On cross examination she admitted that in several instances her docket was incomplete in that it did not show service by one of the sheriff's deputies although the original summons did show such service.

J. F. Harrington, Clerk of Court of Pitt county, took the stand this morning for the third time since the hearing was begun and indications were at the noon hour that his testimony would consume most of the afternoon session. The clerk's testimony dealt with a large number of bills of cost as covered by one section of the audit. Mr. Harrington identified 134 documents as being bills of cost which originated in his office. On cross examination the witness testified that he had not compared these bills of cost with the audit and could not say whether they were all that were included in the office. In producing the judgment docket, covering many of the cases had been dismissed by the court in February, 1938.

On the matter of these dismissed cases the defense counsel indicated that it would claim that there was no bill of cost because the cases were dismissed. Prosecution counsel, on the other hand, indicated that the cases had remained open for several years while the sheriff failed to collect the costs and fines in question and that as a result of this failure a term of court early this year issued capias and ordered them served by members of the State Highway Patrol, and it was following this action that the cases were dismissed.

This matter of the original bills of cost was produced in court this morning as a result of demands by defense counsel last Tuesday that the same be produced in court before the audit reporting to have been made from same be admitted into evidence. It was revealed by counsel this morning that while only 134 bills of cost were presented to the court today, the audit covered more than 200 bills of cost.

"Irreligion" Topic Of Rev. J. L. Lane

An indictment against "Irreligion" was the subject of a forceful message preached by Rev. J. L. Lane at Memorial Baptist church last night. His text was from Romans 1:28. By way of introduction he pointed out that irreligion is a revolt against God, Russian people have as a nation turned atheistic, Germany has done practically the same thing. In our own southern states over 24,000,000 people make no profession of faith whatsoever.

But the situation is as deplorable right in your own city, said Mr. Lane, speaking of the poor church attendance of people in Greenville. (Continued on page two)

SCHOOL FINALS DRAWING NEAR

Record Number Of 115 Graduates To Receive Diplomas

On Thursday night, June 2, the Greenville High School will graduate the largest class in its history, one hundred fifteen boys and girls.

Dr. Chester Alexander, pastor of Howard Memorial Presbyterian Church of Tarboro, will deliver the sermon to the graduates on Sunday night, May 29; and Dr. Holland Holton, head of the department of Education of Duke University, will deliver the address to the graduating class on graduation night, June 2. On Wednesday morning, June 1, the graduates of the junior school will be received into the first year of the senior high school. The ninth grade marks the completion of the junior high school program and the tenth grade is the first of senior high school. The elementary schools will wind up their affairs and give out all promotion cards on Friday morning, June 3. The annual senior play will be given tonight at eight o'clock in the high school auditorium.

The year coming to a close is regarded both by the pupils and teachers as one of great achievement. The graduating class is not only the largest in the history of the high school, but also one of the best. In making student government work in the high school, this class has reached a real objective. Also for the first time in the history of the school there are more boys than girls in the graduating class.

This is the last regular graduating class under the eleven year plan of the Greenville High School. Four years ago the Greenville schools were re-organized on the twelve year basis; therefore, this year's tenth grade will not graduate for two more years. Most of the state is now pausing after what Greenville did four years ago. Next year there will be no regular graduating class; there will be some who are holding over from this year, others who have moved into Greenville.

Practically Every State Agency Lauded By Warren

Reflector Bureau Raleigh, May 20—More or less overshadowed for first hand "spot" news stories of Congressman Lindsay Warren's keynote address to the Democratic State Convention yesterday was his enumeration of the accomplishments of various divisions of the state government. For practically every one of the agencies, the First District Congressman had a good word to say—a pat on the back usually backed by facts and figures to prove his laudatory remarks well deserved. Specifically he referred to the State's administration of schools, roads and prisons, to the notable reductions in electric power rates made by the Utility Commission with Stanley Winborne as Chairman (though he mentioned no names), to the outstanding development of rural electrification in North Carolina, and to the accomplishments of the Department of Revenue, Agriculture and Health.

PARIS PLACES AGREEMENT UP TO MUSSOLINI

France Relying On Close Alliance with Great Britain

NO NEGOTIATION SINCE MAY 11TH

Great Britain Calls Committee Meeting In Effort To Settle French-Italian Row

Paris, May 20.—(AP)—France, relying on her close alliance with Britain, has put the question of a friendship pact with Italy squarely up to Premier Mussolini.

Political informants made it clear that negotiations, deadlocked since May 11, will have to be reopened by Italy.

France seemed to have found the formula she hoped would check Spanish civil war as an excuse to break France's alliance with either British or Russia.

French acceptance of a British plan for ending intervention in the Spanish war assured her of Britain's support. Should Mussolini refuse to negotiate a friendship with France on the basis, Britain could not hold France responsible.

In London Great Britain called a meeting of the non-intervention committee for May 26 in an effort to settle the French-Italian quarrel.

Britain hopes to expedite the procedure by which France would close the Biscayas frontier temporarily while a non-intervention commission arranges for withdrawal of foreign fighters from Spain. In this smoothed for a French-Italian way it is hoped the way will be friendship agreement.

WILL DEDICATE AYDEN CHURCH

Special Ceremonies Planned for Sunday Morning Service

The Ayden Free Will Baptist Church will be dedicated at services at 11 o'clock at which time the pastor, Rev. R. F. Pittman, will preach. Special musical numbers will be presented, with Prof. K. E. Hurst, violinist of Goldsboro, assisting in the program.

Construction of the new church was begun in 1933 on a "pay as you go" plan. The building consists of an auditorium and twelve rooms to be used for classes, library, etc. It has a seating capacity of approximately 400.

A revival service is being conducted in the church this week, with Rev. R. N. Hinnant occupying the pulpit. Rev. Mr. Hinnant recently returned from a trip to the Holy Land. Rev. Mr. Pittman is leading the singing.

Swimming Pool Here To Open Tomorrow

The Greenville municipal pool was being filled with water this afternoon, preparatory to the scheduled opening tomorrow morning. Officials decided some time ago to open the pool on May 21 and the weather man handed up some promising forecasts just before the scheduled opening.

Stadium Contract Awarded By City

The Virginia Bridge company of Roanoke, Va., today signed a contract with the City of Greenville to complete the stadium at the athletic field development on the old fair grounds site by August 1, 1938.

The Virginia concern was awarded the contract by the Board of Aldermen in a special session this morning, called for the purpose of opening sealed bids. The contract price was \$12,500.

Specifications call for a steel stadium erected on a foundation to be provided by the city, a complete steel deck with a seating capacity of 1,375, the chairs to be provided by the contractor.

City Clerk J. O. Duval declared the city effected a savings of \$710 by accepting the Virginia Bridge company's bid, with the contracting firm working out an agreement with the Peaden Steel company of Raleigh for providing the steel. The Peaden company also submitted a complete bid. The Bristol Iron & Steel Works of Bristol, Tenn., was the only other concern to bid on the project.

The contract let this morning was for the steel stand and seats only and does not include a roof, dressing rooms, etc., nor the plumbing, for which a contract will be let at a later date.

SEVERAL FACE CHARGES OF DRUNKENNESS AND DISORDERLY CONDUCT HEARD

Charges of drunkenness, disorderly conduct, traffic violations, etc. were aired before Judge W. A. Darden in City Recorder's court this morning.

A. C. Christopher was convicted of crashing a red light and ordered to pay the costs of court. He also was convicted of being drunk and disorderly, and was given a 30-day road sentence, suspended upon payment of the costs of court.

Arthur Jones pleaded guilty to being drunk and disorderly and was given a 60-day sentence, suspended for six months upon payment of the costs and good behavior.

J. F. Harris and Joe Carter paid the costs in a charge of drunkenness.

Walter Doughty was acquitted of driving drunk and hit-and-run, but was convicted of operating an automobile after his driver's license had been revoked and was given a four months sentence, suspended upon condition he pay a \$50 fine, costs of court, and \$80.53 property damage caused by a wreck.

Spinning Industry Off During April

Washington, May 20.—(AP)—The Census Bureau reported today the cotton spinning industry operated during April at 85.7 per cent of capacity on a single shift basis, compared with 101.1 per cent during March this year and 146.7 per cent during April last year.

Spinning spindles in place April 30 totaled 26,539,440, of which 21,886,054 were active at some time during the month, compared with 26,524,914 and 22,288,098 for March this year.

Spinning spindles in place April 30 in cotton growing states totaled 18,816,872, of which 16,428,336 were active at some time during the month, compared with 18,793,508 and 16,793,508, and 16,790,022 for March this year.

MANY CHINESE SURROUNDED SUCHOW AREA

Jap General Claims 160,000 Unable to Escape

IMPORTANCE OF VICTORY HAILED

Chinese Forces Reported by Japs to be Breaking up in Leaderless Disorders

Japanese Army Headquarters South of Suchow, May 20.—(AP)—The general commanding the Japanese army which advanced from the south to capture the strategic Suchow, said tonight that 40 Chinese divisions were surrounded in the Suchow area without a chance to escape.

He said most of these troops were provisional levies which averaged roughly 4,000 men to a division and were inside Japanese lines enclosing an area of about 25 miles by 15.

The General said the magnitude of Japan's victory at Suchow, nerve center of China's central front, resistance was not yet generally apparent.

The Japanese commander said the huge Chinese forces around Suchow were breaking up into leaderless disorder and suffering terrible casualties under steady merciless attacks by the Japanese air corps.

Other officers of the Japanese command said the fall of Suchow by no means marked the final phase of the 10-month-old war.

Americans known to be in Suchow include Dr. A. A. McFayden of Morgantown, N. C., Dr. Paul White of Hertford, N. C., was at Kiffin. Mr. and Mrs. Wilfred McLaughlin of Wadesboro, N. C., were in Hainchow.

SOUTH SEEKING FULL WPA PAY

Want all Differentials Removed if Labor Bill Enacted

Washington, May 20.—(AP)—Southern Senators demanded elimination today for regional differentials in WPA pay in the event Congress enacts a nation-wide minimum wage.

Many southern legislators have criticized the wage-hour bill, which the House will debate Monday, because it does not provide a lower scale for the south. The WPA, they pointed out, has a generally lower rate for that area.

Their informal discussion of an amendment to standardize WPA pay schedules if the House bill passes came as a Senate Appropriations sub-committee gathered to approve the \$3,000,000 public works bill.

The sub-committee meeting followed a statement by Harry Hopkins, WPA administrator, that there was an immediate need to increase WPA rolls in all large industrial cities.

"We are going to have a serious relief problem in the near future," Hopkins said, explaining that many persons who lost their jobs a few weeks or months ago have exhausted their resources.

Federal work relief rolls now list 2,600,000 persons. The administrator said that number soon would reach 2,800,000 and possible 3,000,000. The (Continued on page six)

DOWELL HEARD AT MEET HERE

State Secretary Addresses Greenville Merchants

Greenville merchants, at their annual dinner meeting last night at the Woman's club, heard Willard Dowell, executive secretary of the North Carolina Merchant's association, trace the growth of the state organization and enumerate several of its current objectives.

Approximately 100 were present for the session, at which Mrs. Cora S. Powell, secretary of the local association, presented her report.

Mr. Dowell said that he received and answered every day asking information about Greenville and Pitt county. Among other activities of the association, as related by Mrs. Powell's report, included the sponsoring of a vocational course for employers and employees, investigation of advertising mediums as to their value to the merchants, decorations aiding new comers to the city, providing credit reports and various other tasks.

At the conclusion of Mr. Dowell's address J. Nat Harrison president of the Greenville Chamber of Commerce, and Mayor M. K. Blount spoke briefly regarding co-operation of the Merchant Association and the Chamber of Commerce.

Mr. Dowell stressed the importance of cooperation, declaring that every worthwhile cause had had the support of co-operative efforts.

The executive secretary recommended that the state organization was founded in 1900 and related some of the problems facing merchants of those days.

Coming up to the present day functions of the association, he declared that much of the organization's efforts was in regard to taxes. "Much of our time and energy is aimed at keeping down taxes on the merchants," he said, adding that only one tenth of the population was engaged in the merchandising business, but (his small) group pays 10 per cent of the taxes.

He explained that the organization also is interested in the reduction of electricity rates charged the merchants, branding them as out of reason. He also said the merchant was charged excessive freight rates.

He mentioned many abuses suffered by the merchandising trade and said his association was doing all in its power to curb them.

RELIEF FUNDS ARE ASKED FOR EIGHT MONTHS

Senate Sub-Committee Boosts Figure by \$175,000,000

\$1,425,000,000 SUM NOW IN PROSPECT

Additional Month To Give Next Congress Time to Supplement Appropriation

Washington, May 20.—(AP)—A Senate Appropriations sub-committee decided tentatively today to increase from \$1,250,000,000 to \$1,425,000,000 the works relief appropriation in the administration's spending-lending bill.

Chairman Adams (D-Colo.), said the increase would finance the WPA for eight months, instead of seven. The House voted \$1,250,000,000 to carry on work relief from July 1 to next February 1. Adams told reporters the sub-committee thought it desirable to provide funds for an additional month in order that the next session of Congress would have more time in which to make a supplemental WPA appropriation.

Adams said that the committee had reached the tentative decision to increase WPA funds in a preliminary survey of the relief bill this morning.

He added that final decision on this and other points would be made when the bill is formally reported to the full appropriations committee.

Two Stills Found By ABC Officers

J. M. Ward and J. L. Taylor, Pitt county ABC law enforcement officers, assisted by Beaufort county ABC officers, this morning located and destroyed two stills in Belvoir township, each with a 100-gallon capacity.

Both of the plants had been operated, during the night, the officers said, adding that they were hot. When the officers came upon them, however, no one was at either still.

Two thousand five hundred gallons of beer was destroyed at the two plants. No whiskey was found.

One of the stills was located near the old Parker place and the other near the Porter road, about half a mile from the Bethel-Tarboro highway.

The two stills destroyed this morning made four the officers have cut down this week in Pitt county. In addition they aided Beaufort county officers in destroying two in that county.

Making Progress In Harlan Trial

London, Ky., May 20.—(AP)—A jury of eight farmers, two county store-keepers, a bookkeeper and a carpenter was accepted by both government and defense today for the trial of Harlan county coal operators, peace officers and corporations charged with conspiracy to deprive miners of labor organization rights.

Before the 12 regular jurors were sworn in, the government dismissed charges against one corporation and one company official, bringing the number of corporate defendants to 20 and the number of executives on trial to 23. Also accused as conspirators are 22 former or present Harlan law officers.

City Firemen Called Answer False Alarm

Greenville firemen last night answered an alarm from box 21, at the intersection of Fifth and Summit streets, only to discover that the alarm was false.

So far during May the city has a good record, 30 fires having broken out since the first of the month.

Chief George Gardner, ever anxious to keep the fire loss down, warned citizens to be careful in burning trash about the house these spring days and not allow the blaze to get beyond control.

Citizens Asked Help To Curb Mosquitoes

E. G. Lynch of the Greenville street department, today urged residents to clean up all cans, trash and other possible mosquito breeding places around their homes and vacant lots.

Mr. Lynch declared that if the citizens would cooperate, the mosquito problem could be greatly diminished. He especially urged that residents remove cans and other refuse from vacant lots.

Governor Hoey Rated Top Of N. C. Popularity Heap

Reflector Bureau Raleigh, May 20—If there were a "cheerometer" designed to measure the intensity and spontaneity of applause, an observer equipped with one and attending yesterday's Democratic State convention, would be able to give figures proving that Governor Clyde R. Hoey is easily "top" in popularity with the nearly 3,000 Democrats attending the convention.

Even without such an instrument there could be no doubt of the high regard in which the affable, Democratic (starting both "d" and "d") chief executive is held by the people of his state.

First proof came when the Governor entered the Auditorium. Forth with and immediately there was a real ovation as he walked down the aisle to the stage. Practically everyone in the hall rose and stood until the Governor was seated.

Next demonstration came when Congressman Lindsay Warren first mentioned the Governor's name during his keynote speech. Again the rafters (figurative) of the Auditorium rang as the delegates stamped, clapped their hands, whistled and made other cheerful noises.

The final test came when the Governor spoke briefly after the keynote had been struck and before the convention recessed for lunch. Again the proof of popularity was overwhelming.

Other names and personages were applauded, with obvious sincerity and spirit, but not even mentioned of President Franklin D. Roosevelt produced the same enthusiastic response; though the delegates were quite clearly almost unanimously of a mind to pay tribute to the chief of the New Deal and the nation.

IT'S ODD, But It's Science
By HOWARD W. BLAKESLEE (AP Science Editor)

Washington—Behind the scenes of the national capital, discussion is given on "balance in nature."

This is a new idea in conservation. Representatives of government departments have been talking it over with Dr. John C. Merriam, president of the Carnegie Institution of Washington.

Balance in nature means you cannot conserve by picking out only the things men and governments want to preserve for posterity. Or even for present consumption.

In any locality nature builds the environment out of thousands of humble living things. Clear out the dead branches and some kinds of birds or insects cannot stay there. With their departure other forms of life lose natural controls. Too much of one kind may develop, too little of another.

The Carnegie Institution has made a study to prove this. It is a census of Point Lobos reserve, a California promontory on the Pacific.

The census shows, in 336 acres, 300 kinds of flowering plants, and thousands of lesser organisms too subtle for adequate understanding. There are 176 kinds of vertebrate animals. Of these one-quarter depend for their activities on bare trunks of dead limbs of trees.

Workers on the federal writers' project believe that Capt. William Moore, born in Ulster county, Ireland, in 1726, was the first white settler in North Carolina west of the Blue Ridge mountains.

A new variety of cotton which is said to be resistant to fusarium wilt, a plant disease prevalent in the Mississippi Delta, has been developed by Louisiana and Federal farm experts.

The cost of living in Great Britain on April 1, 1938, was approximately 54 per cent above the level of July, 1914, states the "Ministry of Labor Gazette."

Students From Here Make Good in College

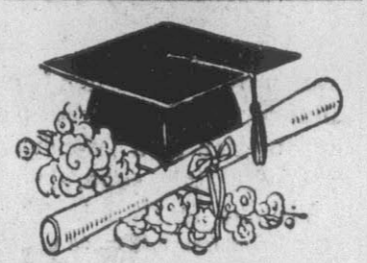

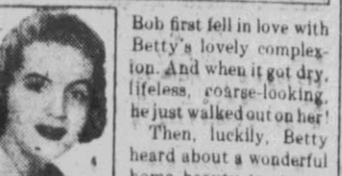

Washington—It is a shame to come all the way to Washington and then order bean soup and apple pie, but it is surprising the number of people who do just that—at the Senate restaurant.

First off, the price is low, the two items coming only to 25 cents. But more important—the restaurant is more noted for those two dishes than for any other.

The apple pie is deep and consistently good. The soup has its off days. But the odds are that on any given day the soup will be good. We don't know where to buy better.

And it is well to understand that, taken together, apple pie and bean soup will be about all you can manage, particularly if you plan to stop in the gallery and hear a learned debate on something or other. Because in that case it will take next to a fist fight on the floor to keep you awake.

Sea Food, River View

Major top flight eating spots can be found either right in town or hidden away in some suburban spot under a spreading elm tree. But anybody not too fastidious about smells can find something to do about food down on the water front. Herzog's hangs right over the wharf, and diners or lunchers sit on a balcony from which they can look through yacht masts to the Virginia shore a mile across the Potomac.

Back from the wharf a bit are several other restaurants specializing in sea foods and Potomac views. They don't try to polish up much, but the fish dishes are beyond complaint. One of them, Paul's has a long and interesting history. It has been a hangout for some government group or other on week nights for years without number. A story is told about an

early day President who used to frequent the place—but that for other times.

Sancho, My Lance

For more than a year Secretary Ickes has been conducting a D-N Quixote battle against steel companies, cement companies and others he accuses of collusive bidding on materials for public works projects. He refuses to think it is coincidence when cement companies offer identical bids right down to the penny for cement for dams and bridges, even though one manufacturer may be right next door to the job and others a thousand miles away. The same about steel companies.

Repeatedly he has turned these identical bids over to the Department of Justice for investigation. If the companies are getting together before submitting bids it is illegal under the various fair trade acts. Fines and prison sentences can be imposed. Nothing much has happened yet in the way of prosecution, although J. Edgar Hoover's G-men are working on some cases. The companies deny any collusion.

Meantime Ickes works his own little trick. When the bids come in all identical as to amounts, he gives the job to the company farthest from the dam or bridge being built. If they are going to do that, says he, we might just as well give the railroads a little of the money by letting them haul it the longest possible distance.

The Comptroller General once tried to interfere by insisting that when identical bids were offered the decision should be made by drawing lots. But Ickes demurred; as an executive officer, he said he would decide how the contracts should be awarded. And he does.

most extraordinary results.

Here, for example, is Jacob Yerushalmi, Ph.D., of the division of maternity, infancy, and child hygiene, New York State department of health, who has drawn up a time schedule for parenthood.

Starting with the premise that the strongest babies are those who most successfully resist the forces of death during the first month of life, he has figured out that the best babies are born to fathers aged 25 to 29 years.

The best ages for mothers, in terms of the order and number of their babies, are:

Birth	Mother's Age
First	21-26
Second	23-28
Third	24-29
Fourth	26-31
Fifth	28-33
Sixth and Seventh	29-34
Eighth and ninth	32-37
Tenth and later	36-41

Of course, one may protest that these findings, interesting as they are, are somewhat beside the point. Not everyone is free to choose his age and her time for parenthood, nor to space one's children quite according to the statistically ideal time table.

And yet the study is not without solid value. The obvious deduction is that girls married in their teens, who become pregnant, and women who first pregnancy occurs at a comparatively late time in life, require especially thorough prenatal care. The same type of prenatal care should be given to mothers who have had a large number of babies. In this way they may be helped to overcome the handicap of not having their babies during the most fitting years of their lives.

To those who are in a position to choose their years of parenthood, this "time table" should prove a useful guide.

There is one other item that bears on having children at the right age. The child's chances of being well formed are best when the mother is not too old.

However, the older "potential" mother should not take this time table too seriously. With good prenatal care and the service of a competent obstetrician and a first class maternity hospital, she runs no greater risk even when her pregnancy is "behind schedule."

In medicine it is widely accepted that "the whole man is greater than the sum of his parts."

Medicine's great progress during the last 300 years came largely through the study of the body's parts. But as Raymond B. Fosdick, head of Rockefeller Foundation, recently said:

"Medicine runs the risk of letting synthesis wait too long upon analysis, of ignoring the whole in the knowledge of some parts."

"Historians estimate that the mass delusion of witchcraft in the middle ages resulted in the torture and execution of over a quarter or a million individuals whose only offense was that they were insane, mentally defective or highly susceptible," Fosdick writes.

"In seventeenth century England, admission was charged at Bedlam, the London madhouse, to those who wished to amuse themselves with the spectacle of the violently insane. As late as the early nineteenth century in America, insanity was not regarded as amenable to therapy. The insane were confined but were not treated. Mental hospitals were called asylums and were classified with prisons."

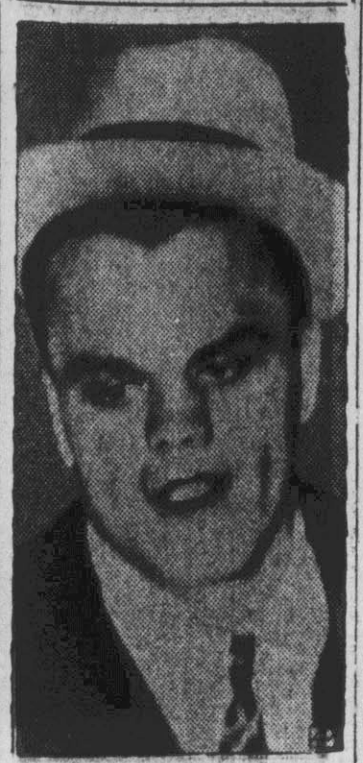

Convention Shows Reynolds Still A Master Showman

Raleigh, May 20.—Senator Robert R. Reynolds, for all the newly donned dignity of campaign methods, is still the same old showman, yesterday's Democratic state convention revealed.

That convention was run with a very laudable intention not to give any candidate a "break"; to maintain perfectly the balance of impartiality as between rivals within the Democratic party.

Whereupon "Buncombe Bob" immediately showed that he needs no breaks made for him—he'll make them for himself.

Here's how he did it and how he made it clear that under the surface of Senatorial dignity, he'll still be the same old Bob when it comes to claiming the spotlight:

State Chairman Gregg Cherry, on the rostrum at the Auditorium, had completed the routine matters of opening the convention and was in the act of introducing Congressman Lindsay Warren, the keynote. On the stage were members of the N. C. Congressional delegation and all the other notables in attendance. Bob was nowhere to be seen.

Intoned Mr. Cherry: "I now take pleasure in presenting a distinguished North Carolinian—" when in popped Bob Reynolds at the very front door of the Auditorium (although there were any number of side entrances available and nearer the stage), followed by a group of devoted admirers.

Perhaps as a signal, someone near the entrance let out a rebel yell, or a good imitation of one, and North Carolina's junior senator, sardoniously perfect and wearing the broadest of broad smiles, marched the full length of the Auditorium aisle, waving jaunty greetings to all.

And Frank Hancock, sitting somewhat glumly on the stage, must have felt a twinge of political apprehension at the volume and length of the cheering outburst that greeted his rival. More than half the delegates rose as the Reynolds procession moved down the aisle, but it may be that much of the rising was from curiosity to see who was coming in.

Senator Halstead Make Plunge For Legislative Plum

Raleigh, May 20.—Senator W. I. Halstead, Camden, and the First District representative in the upper branch of the General Assembly made the state convention yesterday a very fine springboard for a swift plunge squarely into the middle of a campaign to land him the "Presidency Pro Tem" of the 1939 Senate.

The post is more honorary than influential, but it is still one of the most prized legislative plums and is always preferred to the chairmanship of even the most important Senate committees.

Senator Halstead said that response to his candidacy has been very pleasing. He added that he has found ready support for his candidacy both from members of the 1937 Senate and from other candidates who appear likely to win.

There can be no more than 16 repeaters from the 1937 Senate if all those are re-elected who are seeking to come back.

Senator Halstead said he is seeking the place more because he feels his section is entitled to the honor than for any purely personal motives, though he freely declared he

N. Y. Stock Market

New York, May 20.—(AP)—Agile bearish ammunition was plentiful in today's stock market, most potential sellers were so timid that offerings dwindled to a minimum and prices stiffened after a moderate relapse in early dealings.

The list hit its low level in the first few minutes of the proceedings. The pace for a brief period was fairly fast. Support soon appeared and extreme losses running to a point or so were reduced substantially or replaced by gains near the fourth hour.
