\$10,000 PAID IN RANSOM FOR ABDUCTED BOY

Father Expects Son To Be Returned Momentarily

TAKEN FROM BED SATURDAY NIGHT

Money Thrown From Automobile Along Route Outlined in Kidnapers' Note

Princeton, Fla., May 31.—(AP)—W. P. Cash said today the \$10,000 ransom demanded by the kidnapers of his five-year-old nephew, James B. Cash, Jr., had been paid.

The money was thrown from an automobile, he added, by the lad's father, who made two trips over routes outlined on a map provided by the kidnapers.

Returning from the second drive the father, wealthy merchant, reported the contact and said he expected to be notified momentarily of the release of his son, taken from his bed Saturday night.

W. P. Cash said his brother tossed out the bundle of currency in five and ten dollar denominations after blinking the lights of his automobile in accordance with instructions contained in notes from the kidnapers.

The father appeared jubilant and confident young Cash's release was imminent.

"Everything is favorable," Cash said. "I expect to have the boy back by 12 o'clock. x x x it's just a matter of waiting."

It was learned a map provided by the kidnapers showed two routes. Cash made a circuit of one route, the northern one, he said, and returned home in 10 minutes. Then he drove away again and upon return said the contact had been made.

The money he presumably paid over was obtained from a Miami bank Sunday.

Bionde, blue-eyed James B. Cash, Jr., five and a half years old, was stolen from his bed while his mother went next door to help her husband close his grocery store for the night.

COURT REPLIES TO CRITICISM

Denies Allegations That Kansas City Decision Reversed

Washington, May 31.—(AP)—The Supreme Court replied to criticism by administration officials today by denying flatly that it had reversed itself in the celebrated Kansas City stockyards decision.

Chief Justice Hughes read an opinion, to which Justice Black dissented, denying a government petition for reconsideration of the April 25 decision.

The tribunal had condemned procedure followed by the Secretary of Agriculture in ordering a reduction of charges permitted commission men at the Kansas City stockyards. Hughes said assertion by Solicitor General Robert Jackson that the court had reversed itself were "unwarranted."

Both Jackson and Secretary Wallace had contended the court, in its April 25 decision, had termed "fatal defective" procedure to which it had not objected in an opinion two years earlier.

Also the court ruled that the National Labor Relations Board may withdraw from the Third Circuit Court of Appeals at Philadelphia litigation involving an order directing the Republic Steel Corporation to reinstate 5,000 striking employees.

Justice Roberts delivered the opinion that reversed a decision by the Circuit Court judges refusing permission to withdraw and directing the board to proceed with the litigation by filing a transcript of the records. Justices Butler and McReynolds dissented and Justices Stone and Cardozo did not participate.

"The circuit court," Robert said, "was without jurisdiction of the subject matter. If the board had complied with the order made, a hearing would have resulted respecting the legality of supposed action of the board which was not in law, nor fact, the final action, review of which the statute provides."

"No adequate remedy would be open to the board by way of certiorari from the court's ultimate review of an order which the board was authorized and desired to set aside."

James Brown, 75-year-old prominent Greenville man, died at 1:10 o'clock in the local hospital this afternoon following declining health for a year, and one week of critical illness.

Funeral services will be conducted tomorrow afternoon at 3 o'clock, at Jarvis Memorial Methodist Church, with Rev. T. McM. Grant, pastor, in charge. Burial will follow in the family plot in Cherry Hill cemetery.

Active pallbearers will be W. S. Tyson, R. C. Stokes, James S. Jenkins, F. W. Brown, J. R. Edwards, and B. B. Sugg.

The Board of Trustees and Board of Stewards of Jarvis Memorial Methodist Church will serve as honorary pallbearers.

Mr. Brown, a son of Dr. W. M. B. and Jane Greene Brown, was born and spent his entire life in Greenville. He was engaged in farming until his health necessitated his retirement.

Mr. Brown was married to Miss Elvira Serena Moore February 2, 1887. The couple celebrated their golden wedding anniversary last year. He was one of the oldest members of Jarvis Memorial Methodist Church and was a member of the boards of trustees and stewards. He also was one of the oldest members of Greenville Lodge No. 284, A. F. and A. M.

Besides his wife, he is survived by five sons and two daughters, J. Key Brown, Mrs. Ellie Brown Tolson, both of Greenville; Dr. James Brown of Baltimore; Dr. Garland Greene Brown of Chicago; Mrs. Lallah Brown Watts of Carthage; Dr. W. M. B. Brown and Harry M. Truck And Buses Show Improved Safety Record

Raleigh, May 31.—While the general accident was reaching a new high in 1937, trucks and buses were reducing accidents in which they were involved by 18 per cent, Chas. Ray, director of safety engineering for Market Service, of Raleigh, said today.

Mr. Ray was commenting on recent editorials that followed an accident to Dr. Douglas Freeman of Richmond whose car collided with a truck near Fayetteville. Prominence of Dr. Freeman focused attention on the matter of truck accidents and there were some expressions of opinion that many accidents are caused by reason of the lack of regulation over the hours truck drivers work with the result that many become exhausted.

The safety engineer did not attempt to go into the merits of the question of reducing driving hours for truck drivers, but did cite statistics of the National Safety Council showing that of all trucks, inter-city trucks had the best safety record per 100,000 miles driven, with 2.62 as compared with 3.44 for all trucks.

"There has been a noticeable trend toward safety in the truck record of common carrier drivers in the past year, 1937, with miles operated without an accident, is a direct challenge to private car drivers, and a record of 1937 stands out most noticeably. The operators and drivers have worked together, both being interested in a clean record, and they exercise every care and caution that they might at the end of twelve months get a coveted award of a bonus or a pin."

HUNDREDS DIE FROM AIR RAID ON BARCELONA

At Least 430 Known To Have Been Killed in Capital

BRITISH VESSEL BOMBED, SUNK

Freighter Third British Boat Sent to Bottom Off Valencia Recently

Barcelona, May 31.—(AP)—At least 430 persons were killed today in an insurgent air raid on a town 16 miles north of Barcelona. That many bodies were taken from the ruins and authorities believed 100 more still were buried.

Forty bombs were dropped by five tri-motored bombers, 12 of them plunging into the market square at its most crowded hour.

Earlier reports indicated most of the victims were women and children.

Other bombs fell in the potato distribution district.

Madrid, May 31.—(AP)—The British freighter Penthames was bombed and sunk in an air raid on Valencia harbor this morning. No lives were lost.

A Spanish vessel also was sunk. Air raid alarms kept the harbor district in a state of tension from 11 p. m. last night until after daybreak.

The British freighter was the third British ship sunk recently at Valencia, Spanish government port on the Mediterranean.

A French sailor was killed yesterday and several British seamen wounded in Valencia Harbor raids.

Political Races In Home Stretch

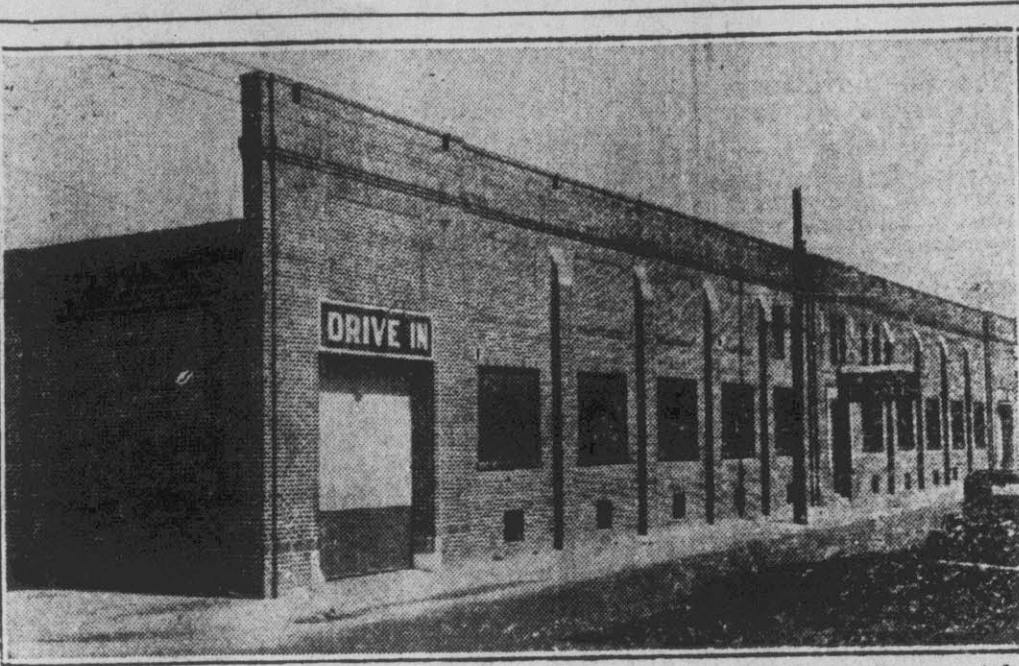

RESUME TRIAL ON WEDNESDAY

Ouster Case May Be Completed Within One Week

Albion Dunn, of defense counsel in the Sheriff S. A. Whitehurst ouster case, said today that the trial probably would be completed within a week.

"It all depends on the time consumed in cross-examinations," declared Judge Dunn.

He said that approximately 80 witnesses would be called to the stand by the defense, adding that Sheriff Whitehurst would take the stand some time during the week.

The trial, which started on May 9, was recessed by Judge G. Vernon Cowper Friday afternoon after the petitioners had completed their evidence to allow the defense time in which to prepare their case.

The petition, filed by individual members of the County Board of Commissioners, charges the sheriff with advising bootleggers in advance of raids, failure or refusal to collect fees and court costs and with converting trust or fee funds to his personal use.

A large crowd of spectators followed proceedings the first week of court, but the crowd began to dwindle until the last week of the hearing only a scattering few attended.

Plans Already Announced For Replacing Structure

Webb's tobacco warehouse on Albenmarle avenue, burst into flames from an undetermined origin shortly before noon today and within less than 30 minutes the roof had fallen in and the building was completely razed.

J. H. Blount, one of the owners, declared this afternoon that the building would be replaced for use this fall. He estimated that damage at \$75,000 and said approximately \$35,000 insurance was carried.

Firemen were unable to cope with the blaze and concentrated their efforts on saving nearby buildings, none of which was destroyed. Within 20 minutes after the fire was discovered the building was practically destroyed. The steel reinforced roof fell with a crash, partly smothering the flames and sending clouds of smoke skyward.

The heat caused the concrete floors to expand and burst, hurling pieces high into the air through the flames and smoke. It was believed by some that something stored in the warehouse was exploding, but Mr. Blount declared nothing was in the building at the time.

Heat from the fire broke out window panes in stores located on Virginia avenue and Pamlico street to the rear of the warehouse.

The building was owned by J. H. Blount and brothers and L. B. Garis, and for the past few seasons had been operated by C. H. Webb. Smith and Sugg, however, had leased it for the coming season, and will operate the new building which will replace the burned structure.

INVADING JAPS STRIKE BY AIR

Wage Bitter Assaults On Canton - Hankow Fronts

Shanghai, May 31.—(AP)—Japan's air forces struck heavily today at two centers vital to Chinese resistance, Hankow, provisional capital, and Canton, southern metropolis and gateway for war supplies from abroad.

Thirty planes attacked Hankow and Japanese accounts said they shot down 18 Chinese planes in dogfights over and near the city. The Hankow airfield was heavily bombed. Japanese admitted one of their own planes was missing.

It was the first big raid on Hankow since that of Emperor Hirohito's birthday, April 29, in which more than 50 Chinese and Japanese planes fought a half hour's indecisive battle. Each side declared the other lost heavily in the April 29 fight.

Canton, through which most of China's munitions from abroad pass was raided for the fourth successive day, but Chinese said that four of 22 attacking planes were shot down.

Hongkong dispatches said the Japanese air forces spread their attacks over a wide area around Canton raiding many towns in Central and northern Kwangtung province.

Refugees, including some American and other foreign women and children, poured into British Hongkong for safety. Hongkong officials estimated the colony had received 24,000 refugees since Saturday.

Meanwhile Chinese said large numbers of Japanese were trapped in a 21-mile square segment of the 250-mile Central China front, from which the Japanese hope at a strategic moment to try a general offensive on Hankow.

Hankow, China, sources said American and British missionaries escaped from Kweichow, just before an intensive Japanese artillery bombardment Sunday, the United States and British Consulates were informed.

PATH CLEARED FOR SPEEDING AD JOURNMENT

Administration Will Shelve Reorganization Measure

DECISION MADE AT WHITE HOUSE

Action Expected To Make Easier Sledging For Spending-Lending Bill

Washington, May 31.—(AP)—President Roosevelt and congressional leaders have shelved the government reorganization bill for this session, informed members of both the House and Senate reported today.

They reported this course was agreed upon at an early morning conference at the White House as a means for clearing the way for action on pending bills, including the spending-lending measure and the spending of final adjournment.

Formal disclosure of the plan was expected to be made in statements which Senate Majority Leader Barkley said, upon leaving the White House would be issued "in a day or two, probably tomorrow."

Barkley was said to have reported to President Roosevelt that there was "growing opposition to the spending bill because of uncertainty over whether the reorganization controversy would be revived."

A definite statement that the legislation would be discarded for the session, Barkley reportedly advised the President, would break dilatory tactics in the Senate against the spending-lending measure.

Meanwhile Senator Wheeler (D-Mont.), demanded that the Treasury give Congress an accounting of the use of the \$2,000,000,000 stabilization fund designed to help maintain international monetary equilibrium.

"It seems to me to be time that the Congress of the United States knew something as to what is being done with that \$2,000,000,000," he declared.

His remarks were prompted by an assertion by Senator Logan (D-Ky.) that "we will never get the country out of its difficulties by appropriating money to spend for relief unless something else is done."

He advocated Federal Reserve Board action to lift prices to the 1936 level with monetary and credit levers.

Los Angeles, May 31.—(AP)—A slight earthquake jarred a million Southern California homes at 12:35 a. m. (PST) this morning, but spared the area of damage.

The quake, one of the most severe since the disastrous one in 1933 was felt for 200 miles along the Pacific coast from Santa Barbara to San Diego and inland 150 miles to the Mojave desert and the Coachella valley.

Alarmed families were frightened out of sleep by the rippling side-wise motion of the earth. Dishes rattled in cupboards. Lights swayed. Houses creaked.

Long Beach, center of the destruction in 1933, quickly reported "all well" and other cities such as Santa Barbara and San Jacinto, which were hard hit by past earthquakes, went through today's quake without harm.

The early shocks, three in number, lasted several seconds. They were strongest on the Los Angeles ocean front, stirring up high waves.

'Great Argument'
The preface to "Great Argument" invites the reader's interest in this new novel by Phillips Gibbs.

This is the deeply moving story of a man who held peace precious in a world lit by the fires of coming war. It is a brilliantly written novel, filled with characters who never become mere symbols, characters whom the reader learns to know and to love, whose actions, tragic, humorous or pathetic, he follows with breathless interest. But it is more than a novel. It is an impressive statement of the profound bewilderment of the minds of millions of intelligent, tolerant, peace-loving men in a world in which intelligence, tolerance, and the love of peace seem to have given way to prejudice and brutality. Through its pages echo the agony of a kindly idealist, a man who lived through the terrors of the last war, and with his whole soul learned to hate war's grim stupidity. Mr. Jesson Labourite, M. P., is a man among men, a complete individual, he forgets important papers, his blood pressure mounts when he has to make a public speech, he loses his temper with his wife, and his trousers get baggy at the knees. But to the readers of this book he will come to mean something more; he will come to mean for them their own honest and pitiful perplexity in a world in which millions of men are busily preparing to slaughter millions of other men for whom they feel no personal hatred. For Edward Jesson loved peace and he detested the leaders of those predatory nations which seemed to be leading the world to Armageddon. Every attempt to talk them in their aggression seemed to him another step towards war; the path of peace had become the road to war.

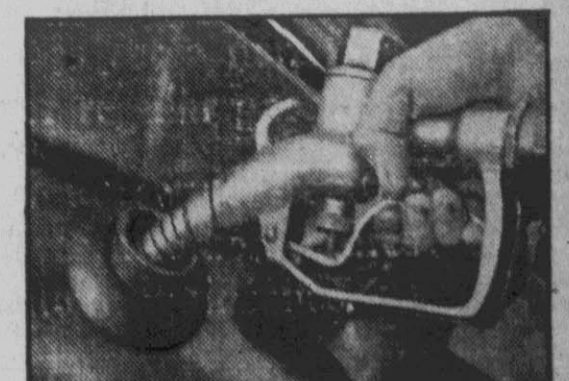

Washington Daybook

By Preston Grover

Washington—Freshly delivered to Congress is a little bundle containing some of the first laws produced by the new and independent Philippine commonwealth. One of the initial efforts was a measure to outlaw cockfighting at polling places.

Under the new independence act, all laws enacted by the Philippine Congress must be submitted to this government for approval.

They give a close-up glance at a little country putting on its first long pants in the big wide world and if some of the output sounds trivial it must be conceded that other ideas are good and might be followed in the United States without harm.

In the pile of laws is an act abolishing the poll tax, which in times past has been used to harass voters in the same manner as once was complained of generally throughout the south. Under the terms of poll tax laws in the Philippines no one could sign an official document unless he had paid this tax. It was used at times to frighten away aspiring voters who sought to approach the polls without first having paid the poll tax.

Tough On Nicknames
One law prohibits a candidate from using more than one nickname on the ballot, so if Bopar bal Celeste wants to run for the job of provincial governor or mayor of Zamboanga he can identify himself as Bongo Bill or the Sultan of Sulu, but not both, even when some friends call him one and some the other.

Side by side with that act is another prohibiting candidates for provincial governor or mayor from spending in the campaign more than one-third of the pay they expect to get from the office, a provision which would raise Old Ned in many a spot in this country.

Appointive officials can't run for elective office on government time, if they want to campaign they first must resign. Something besides novelty could be found in one act denying the vote to persons who cannot mark their own ballots, or another requiring voters to place their thumb mark on a detachable stub on the ballot.

To take care of any illiterates who might be bothered in marking a ballot there is an increased appropriation for new elementary schools. There is also a restriction on a gambling game something akin to the numbers business.

Soft On Prisoners
Appropriations are made for production and cheap distribution of various preventive serums, including "ild tiki" to check an island ailment akin to rickets. Another bill sets up a fund for collecting folk lore and folk songs, and money is set aside to give certain employees at the Culion leper colony a 28-day vacation with pay.

Farming is the Philippine life-line, so students of agriculture are admitted to the school of agriculture without tuition or matriculation fees.

War veterans or political favorites drawing pensions or gratuities from the government may not draw government pay for other jobs unless they give up their pensions. As much as five centavos is to be paid for each rat or mouse killed in the Manila rat extermination campaign.

An occupation tax lists lawyers, physicians, architects, engineers and insurance salesmen in the top bracket at 50 pesos annually; dentists, veterinarians and photographers in the 40 peso bracket, and pharmacists, manicurists and tattooers in the 20 peso bracket. (The Philippine silver peso is 50 cents at par).

Nattiest of all is a law which says "When, in the judgment of the secretary of justice, a prisoner merits consideration, his wife, family or fiancée may be permitted to join him, and the transportation from their homes to the penal colonies may be paid."

SHORT SHOTS

Raleigh, May 31.—There have been plenty of hard knocks exchanged and hard words spoken during the present campaign in North Carolina, but this column hasn't yet seen the equal of Stanley Winborne's characterization of the campaign of his opponent for the Utility Commission, Paul D. Grady of Kenly. Winborne certainly pulled no punches in his Charlotte speech last night when he said, according to full text of his address furnished this bureau:

"The work of the Utilities Commission is largely technical and is not understood by the people generally who have not taken the time nor the trouble to investigate it. My opponent, Mr. Grady, knows this and he is seeking to take advantage of the situation by conducting a campaign of misrepresentation and distortion of facts. There has never been a campaign made by any candidate for any office within the state in which there has been more wanton and utter disregard for the facts and a more deliberate attempt to deceive the people. The charitable conclusion to place upon the statements of Mr. Grady is that he is merely the Charlie McCarthy, or mouthpiece, of some individual or group of people who wish to vent their spleen against me and reap a selfish interest."

On the other hand, Mr. Grady himself loosed a few really vitriolic remarks at the Winborne head not so long ago—as for example: "Mr. Winborne shows a surprising ignorance of what has been going on and demonstrates that his chief duties have been as a filine clerk for the public utilities in North Carolina" and "It is difficult to believe that Mr. Winborne has learned so little in the long time knows he has been in office."

Kind words may, butter no parsnips as the old saying goes but harsh one like those in paragraph one supra and add bit of seasoning to political sauce.

Both Commissioner Winborne and Mr. Grady are experienced hands at the business of vote getting. Primary figures for 1932 are unavailable to this correspondent on short notice, but in the General Election of 1932, Mr. Winborne polled 499,207 votes against his Republican opponent, while in the same polling redoubtable Bob Reynolds garnered nearly 10,000 less against Jake Newell for the Senate.

In 1936, Grady led a three man field in the first primary for Lieutenant Governor, with 162,221. In the runoff he raised this to 208,248 but still lost to Wilkins P. Horton by a scant 9,000.

And so neither of the contestants can be sold short on a basis of past performances at the polls.

So many candidates are on the local ticket in New Hanover county that the ballots are described as "in three sections, looking like a telephone directory."

The jobs of clerk of superior court and constable seem to hold a peculiar attraction for the folks down by the sea.

If a blanket endorsement from Ralph W. McDonald will accomplish it, Titmouse Valentine is already "in" as judge in the Second Judicial district race. Valentine is displaying a campaign card with the following message from McDonald on one side:

"Titmouse T. Valentine has a great mind, a great heart and a great soul. I have known him intimately and I know that men never grow any cleaner than he. I will stake my life that he will never stoop to anything little or selfish or tainted with wrong. With his absolute honesty, his sober sense of justice for rich and poor alike, his thorough knowledge of the law and his unusually fine judicial temperament, Titmouse T. Valentine will make one of the finest judges this state has ever had."

But It's Science

New York—Geriatrics is to be the great medical practice of the future.

The name comes from a Greek word—geron—meaning old man. The prediction is from Prof. Henry A. Christian, M. D., of Harvard Medical School in a report to the American College of Physicians.

More people are living longer than ever. He says, but old people are not living any longer than before.

He denies the popular belief that the span of life is lengthening. It is merely that preventive medicine has permitted more and more people to live until they are old.

"Curiously enough," he states, "statistics indicate that, while older people grow more numerous, the really old do not increase but even seem to decrease."

More individuals will develop degenerative diseases, which are the main cause of illness in the aged, and the younger ones among this aged group. Dr. Christian thinks, will become increasingly susceptible to the degenerative diseases and will be likely to have them longer.

Yellow Jack Hero A Deputy Sheriff

John R. Kissinger, one of the two survivors of the original "Yellow Jack" mosquito tests and who was the key man in that experiment which paved the way for the Panama Canal, is at present a deputy sheriff of Huntington, Ind.

"Yellow Jack," starring Robert Montgomery and Virginia Bruce, will be shown at the Pitt Theatre in Greenville Wednesday and Thursday.

The fact that one of the unsung heroes is still alive makes the story even more interesting. Mr. Kissinger is an average citizen of Huntington. He is a member of the Kiwanis and Rotary clubs and takes his place in other activities of the city.

When the picture was shown in the Capitol theatre in New York, Mr. Kissinger made a personal appearance. He was awarded a royal welcome.

Kissinger made the celebrated mosquito inoculation test at the age of 21 while a hospital corpsman in the United States army and was awarded the Congressional Medal of Honor for undergoing the experiment.

Movies Made of Big Kite Fleet and Mass Boxing

Raleigh, May 30.—Martin Cooke, cameraman for Fox Movietone News, last week filmed two outstanding North Carolina features: "Highest Kites in the World" and "Mass Assault and Battery" for reels which will be shown in thousands of cities over the nation so at least 30,000,000 persons a week.

The kite film was shot at Lees-McRae college, at Banner Elk, where Cooke directed some hundred and fifty college girls in a feature which included flying of what are believed to be the world's smallest and largest kites.

As the great kite fleet was launched skyward from a field more than 4,000 feet above sea level, the Cooke title "Highest Kites in the World" is believed to be perfectly authentic.

The baby kite was a box affair, three inches high and an inch square, while the giant flyer was the flat type, 15 feet tall by 10 feet wide. This required a half dozen fair dandies to hold while in the air.

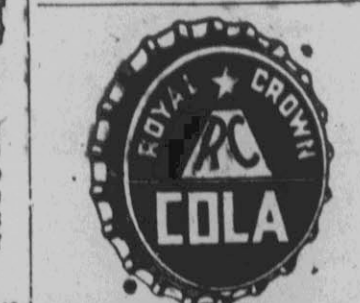
Some hundred and fifty girls participated with about half that many kites in the air at the same time. More than 10 miles of string were attached to the kites.

The assault picture was taken at Chapel Hill where Cooke shot some 150 University students in the largest mass boxing exhibition ever filmed. He made pictures of about 50 punting boys and 40 about 75 pairs of boxers taking simultaneous swings at one another. To conclude his reel he matched the best of U. N. C. boxers in special bouts and cranked away.

The Cooke visit was made possible through the Advertising Division of the Department of Conservation and Development, whose officials feel the state will obtain nationwide advertising absolutely free which couldn't have been bought for \$50,000.

Cooke said he was enthusiastic over North Carolina as a prospective site for many feature films. He said he not only found the scenic background necessary for his work, but had received the finest and most enthusiastic co-operation from all Tar Heels.

for hire trucks may not remain on duty more than seven consecutive hours, and not more than 14 in any 24-hour period. After any 15-hour period the driver must be off duty as much as nine hours.

Originally scheduled for last Thursday night, the fight twice was postponed because of rain. Promoter Mike Jacobs will try to go thru with it at all costs this time, in order to concentrate his attention and ballyhoo on the June 22 heavy-weight scrap between Max Baer and Joe Louis.

Ross declared in A-1 condition by his handlers, will rest until ring time. He did not even visit the gym today. Only limbering-up exercises were scheduled for Armstrong.

Jacobs, who had hoped for a state of between \$200,000 and \$250,000, now will be satisfied with \$175,000, due to the postponements, but he says good weather today may boom receipts to the \$200,000 mark.

Despite the appearance of additional Armstrong money in the midtown district, odds continued about the same with Ross a 5-to-7 shot. There is a possibility they may go as low as 5-6 by tomorrow night.

Raleigh, May 31.—At 83, R. T. Kernode is not too old to adopt new farming practices to keep the soil from washing off his farm in Alamance county.

Mr. Kernode became a copertor in the erosion control demonstration project near Burlington in March, 1938. With 653 acres in his farm, he agreed to practice contour cultivation on 250 acres, to terrace 182 acres, to set up approved rotations on 210 acres, to establish the new practice of approved rotations on 210 acres, and to establish the new practice of strip cropping on 45 acres.

At the present time he has constructed more than 31-2 miles of terraces on 36 acres of land. The terraces were built with a combination of a two-horse plow and a Martin ditcher drawn by three mules.

Mr. Kernode had never grown any lespezeza on his farm before, but this year he bought seed and planted approximately 20 acres to lespezeza to get his erosion control program started. When the program is in full effect he will have from 50 to 60 acres in lespezeza every year.

With six tenants on his farm, all of whom are interested in the new program for conserving the soil, Mr. Kernode figures he won't be handicapped by getting somewhat of a late start with erosion control practices on his farm. The tenants are pooling their teams to get the program under way as rapidly as possible.
