PRESIDENT AND LONDON ENVOY IN CONFERENCE

Jos. Kennedy Among Callers at Hyde Park Home

MUCH WORK ON FDR'S SCHEDULE

Sec. Hull in Washington, Meantime, Considers Program To Humanize War

Hyde Park, N. Y., June 21.—(AP)—President Roosevelt shifted briefly today from the clean-up work after a session of Congress to an important discussion of what's going on in Europe.

Joseph Kennedy, home from his ambassador's post in London, was on the Chief Executive's engagement list for a morning call.

The terse White House disclosure Kennedy would head the presidential study on his second day back in this country gave no hint of what course the conversation would take.

Persons close to the situation, however, expected the President and his trusted advisor to discuss the pending Anglo-American trade treaty and what Kennedy has observed in general in his six months as a diplomat.

Before and after Kennedy's call, Mr. Roosevelt had much work to do on bills passed by Congress in the final days before adjournment.

Also, officials of the National Foundation for Infantile Paralysis presented to the President a check for \$1,010,000 to be used in the Foundation's nation-wide drive to wipe out the disease.

At Washington, meanwhile, Secretary of State Hull has begun developing a program to humanize warfare, with the particular aim of stopping aerial bombings of civilians.

Persons close to the State Department disclosed Hull is devoting much of his time to this subject, brought to his attention by airplane attacks on Spanish and Chinese cities.

SPY ACTIVITIES ARE REVEALED

Amazing Story Unfolded Following 18 Indictments

New York, June 21 (AP)—An amazing story of one of the most extensive spy rings ever discovered in this country unfolded today in the wake of a federal grand jury indictment of 18 persons, headed by 12th German officials.

The defendants were charged with conspiring during the last three years to obtain United States defense secrets and of delivering them to the German government or "factions" in Germany. Two other indictments detailed specific acts—stealing of plans for an army pursuit plane from the Seversky plant at Farmingdale, Long Island, and theft of an army and navy code book.

The indictments resulted from four months of federal investigation and five weeks of jury hearings.

Of the 18 persons indicted, only four are available for prosecution—in jail here under heavy bail.

They are a former woman hairdresser on the German liner Europa, two former U. S. army soldiers and a former Seversky plant mechanic.

The participants were divided into five groups.

1—The high German officials who named the agents, directed their operations and paid them.

2—The "working" group here.

3—An intermediary group in New York City which passed on the information group two obtained.

4—A messenger group who worked as crew members on German liners.

5—An agency at Dundee, Scotland, through which orders, information and pay were sometimes routed to avoid suspicion.

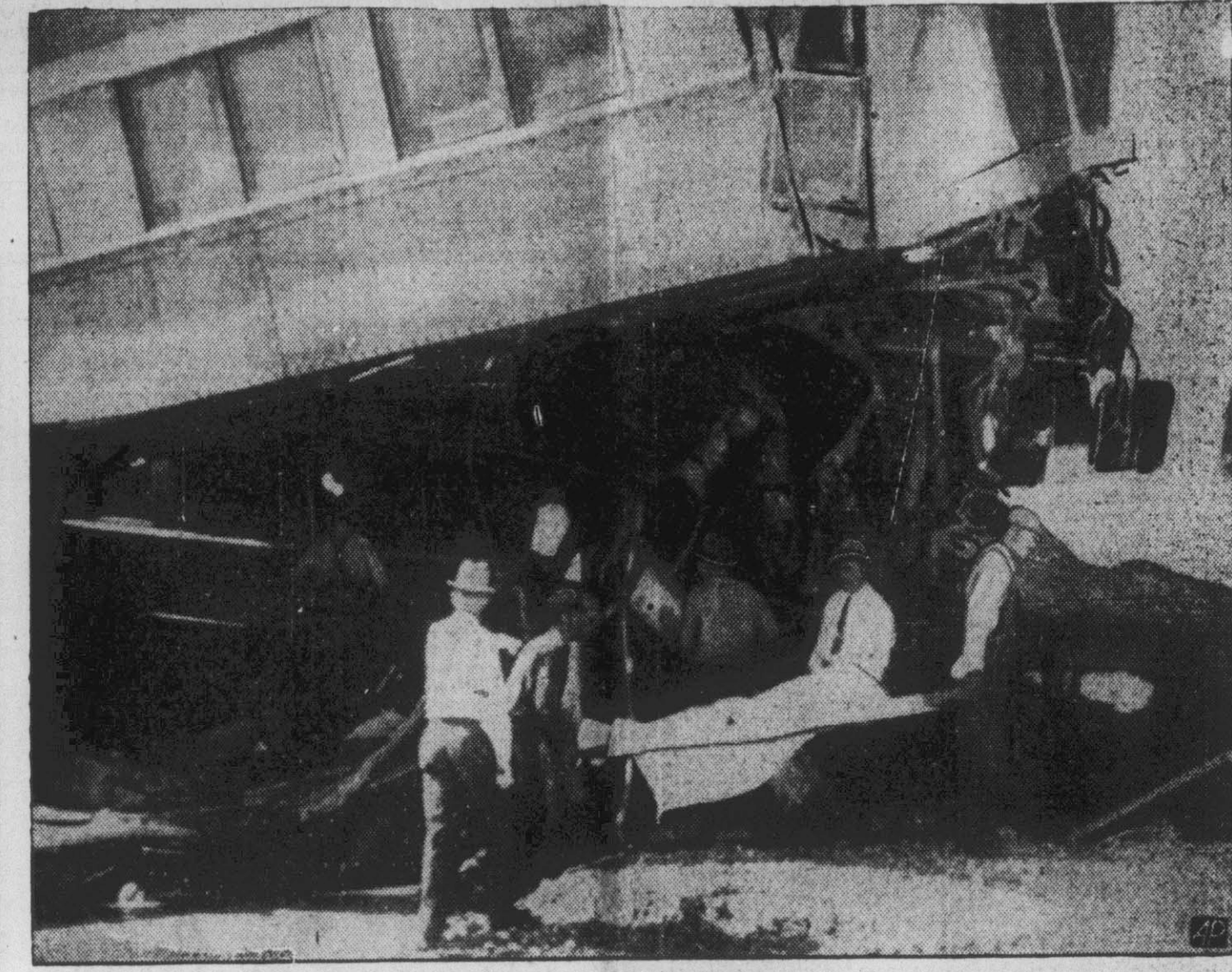

STILL UNABLE REACH VICTIMS

Thirty-One Known Dead in Montana Train Wreck

Miles City, Mont., June 21.—(AP)—With 31 already known dead, fatigue-worn searchers worked today to lift up again from the silt-oozing bed of Custer Creek, a tourist sleeper which railroad officials said contained 12 more victims of the nation's worst railroad tragedy in a decade.

Twenty-three of the 31 known victims were identified. The bodies of two unidentified women were taken last night from the sleeper which plunged with the Milwaukee Railroad's crack "Olympian" train through a flood-weakened trestle early Sunday. Other bodies were found early yesterday and a woman died in a hospital.

The sleeper, submerged nearly 36 hours by the cloudburst "flash flood" that filled Custer Creek with a torrent 20 feet deep, was jacked up on blocks after hours of slow toil last night.

Suddenly the heavy steel car split loose and sank again into the silt left in the stream's bed when the flood subsided yesterday.

Grimly the 75 railroad workers and volunteers started their slow job again, working without halt during the night. Meanwhile railroad and government officials began an investigation of the wreck.

All except one of the victims met death instantly, officials said.

Slight Loss By Fire In City Monday P.M.

A fire shortly after 5 o'clock yesterday afternoon at the home of Janie Ricks, Negro, of Clark street, burned a mattress and two quilts, but was extinguished before it was able to make any further headway.

Firemen declared the cause of the blaze was unknown, but expressed the opinion someone lying on the bed smoking dropped a spark on the bed.

Eastern Carolina Rivers To Flood

Raleigh, June 21 (AP)—Lee Denson, in charge of the weather bureau here, said today waters of the upper Neuse river would go into flood late this afternoon and an overflow of the Roanoke river in Halifax county was in prospect.

All streams in eastern North Carolina were heading for flood levels because of excessive rains in the past four days, Denson said.

Smithfield on the Neuse, reported another inch of rainfall in the past 24 hours ending this morning, to add to three inches Sunday. Rougemont, in Durham county, had two inches yesterday, while Kenly had one inch, Enfield 1.71 inches, and Rocky Mount 1.29 inches.

Definite flood forecasts may be issued tonight, Denson said.

It drizzled steadily here today and similar conditions prevailed in most of the eastern part of the state.

Will Impound Ballot Boxes

State Board of Elections Takes Hand in Alamance

Raleigh, June 21.—(AP)—Secretary Raymond Maxwell of the State Elections board said today ballot boxes in some precincts of Alamance county had been ordered impounded pending a decision on whether a recount of the June 4 primary vote was justified.

Maxwell said Chairman W. Q. Lucas of Wilson had notified the impound the boxes after citizens county election board chairman to impound the boxes after citizens of Alamance county had visited him Sunday and outlined their complaints.

Formal petitions were due to be filed with Lucas during the day, Maxwell said, and "if a recount seems to be warranted the chairman may go to Alamance tomorrow with me to supervise it."

The secretary did not know the precincts involved nor the petitioners, but expressed the opinion the protests were the same which the county board overruled immediately after the primary.

COUNTY COURT HOLDS SESSION

Trials Held In Court Room First Time Since May 3

Judge Dink James conducted hearings in the court room this morning for the first time since the first week in May, and a large number of cases were disposed of during the session. Weekly hearings have been held in the armory, the grand jury room or not held at all since the sheriff ousted hearing began on May 9.

Clarence Frizzelle was convicted of non-support of his children, but upon recommendation of the Welfare Department, prayer for judgment was continued.

Fountain (Doc) O'Neal, convicted of driving careless and reckless, was fined \$25, costs to be deducted, and had his license suspended for 30 days. The defendant appealed and bond was set at \$100.

Jackson Atkinson, Negro, was fined \$25, costs to be deducted, and had his license suspended for six months upon conviction of operating an automobile in a careless and reckless manner.

Fargo Best, Negro, was given four months on the roads after pleading guilty to a charge of larceny.

Memom Spelman, Negro, was allowed temporary freedom when judgment was suspended in a case charging him with assault with a deadly weapon.

Willie Ebron, Negro, was convicted of trespass and given a six months sentence.

Judgment was suspended upon payment of costs in a case charging Steve Manning with disposing of mortgaged property.

A nolle pro with leave was taken in a case charging Jack Blount with being drunk and disorderly and a nuisance.

Meeting Is Held On ACL Proposal

Representatives of a number of cities and towns to be affected by the proposal of the Atlantic Coast Line to discontinue passenger trains Nos. 38 and 39 met here today at the call of N. G. Bartlett, secretary of the Eastern Carolina Chamber of Commerce.

The meeting was scheduled to get under way at 3 o'clock, but some time after that hour all of the representatives had not arrived and the meeting was delayed in starting.

The purpose of the meeting was to discuss the proposal and consider means of opposing the petition.

Rainfall

An average of an inch of rainfall fell in Greenville the last two days, B. T. Clark, in charge of the local weather bureau station reporting that 1.11 inches fell during the 24 hours ended at 8 o'clock this morning, and .81 of an inch during the period ended yesterday morning.

So far this month a total of 5.80 inches have been recorded. Five inches for a month is regarded as "extra heavy." For the first 20 days of the month an average of .29 of an inch of rain fell here.

Mr. Clark reported the temperature as about normal.

RAINS DAMAGE TOBACCO CROP

Fair Weather From Now on Needed for Ample Yield

County Agent R. R. Bennett declared today that tobacco and other Pitt county crops had been permanently damaged by recent rains and that unless the downpours cease further loss would be experienced by farmers.

Mr. Bennett said that tobacco on sandy soil had suffered the worst damage. He said the original root had died and the plants had to develop new ones.

The county agent declared that farmers, who already have not done so, should put all dirt possible around the plants which have not been topped. He added that numerous farmers already were taking this course.

Well developed tobacco also was hurt, in that it buttoned out before the plants were full grown and as a result would grow but little more.

In order to get satisfactory yields tobacco needs weather in which it can grow every day from now on, declared Mr. Bennett.

The corn crop of the state also has been damaged by the recent rains and the yield will be much smaller than it was for the past two years.

PLAN TO CLOSE BRANCH OFFICE

Resettlement Administrator Transferred to Washington

Raleigh, June 21.—(AP)—James M. Gray, former assistant regional director of the Resettlement Administration, left Raleigh today to become principal administrative officer of the Agricultural Bureau of Economics in Washington.

In recent months Gray had been acting in charge of land utilization work in this region. Effective July 1, the land utilization division here will be consolidated with other southern regions, with headquarters in Atlanta. The personnel employed here will be transferred to New Haven, Conn., Atlanta and Washington.

The regional offices here of the Farm Security Administration will continue to handle rural rehabilitation work, and tenancy and farm ownership programs.

Few Jailed In City During Past few Days

N. C.'s "Public Enemies" Not Products Of Parole

Raleigh, June 21.—Whatever may be the case in other states, and no matter what "incontrovertible statistics" G-Men No. 1 Edgar Hoover may produce, North Carolina's criminals who have reached the status of "Public Enemies" are neither the product nor the beneficiaries of the state's parole system.

Commissioner of Paroles Edwin Gill told your correspondent today.

So far as I can recall, and so far as I can find by search of files in this office, not one of North Carolina's Public Enemies was on parole at the time he reached the status of a real gangster and not one of them was at liberty on parole when he was killed or captured to end his criminal career," said Mr. Gill.

EVACUATION FOREIGNERS IN SPAIN SOUGHT

European Powers To Send Commissions To Spain

BRITAIN SEEKING TO OBTAIN TRUCE

Govt. Militiamen and Insurgents, Meanwhile, Engage in Desperate Battle

London, June 21.—(AP)—Delegates of Europe's major nations today agreed to send evacuation commissions to Spain in an effort to remove foreign troops from the 23-months-old civil war, and Britain tried to make this a means of obtaining a truce.

Agreement on the evacuation commissions, feature of a revised British plan for withdrawing alien soldiers from Spain, was reached in a morning sitting of the chairman's sub-committee of the 27 nation non-intervention committee.

Even Soviet Russia, which hitherto has opposed frequent obstacles to the powers' search for a Spanish peace, bowed to the will of the other powers.

The sub-committee was to meet again late today. Meanwhile, members worked on texts of notes to be sent to Spanish government and the insurgent regime, seeking approval for the evacuation commission's plans.

The British government exerted pressure on France and Italy, respectively friendly to the government and insurgents, to get a truce in Spain to permit the commission to operate.

Necessity of obtaining acceptance of the warring Spanish factions for the evacuation plan now becomes the biggest hurdle to be taken in the program of Britain's Prime Minister Chamberlain for general European appeasement.

Much depends on Premier Mussolini of Italy.

Hendaye, France, June 21.—(AP) Government militiamen and insurgent veterans fought a desperate battle today for three miles of low-lying hills along the Eastern Spanish coast, possession of which might decide the fate of Valencia.

Benefit Payments Received By Many

Raleigh, June 21.—A new high in numbers of checks issued and amount of money involved in the payment of unemployment benefits was reached by the N. C. Unemployment Compensation Commission last Thursday when 11,459 checks totaling \$98,333.77 were written and sent out to unemployed or partially unemployed workers in the state.

Through last week, the Commission had paid out \$4,379,47, included in the \$78,685 checks issued thru that week. Nearly 300,000 individuals have been or are being paid benefits since the first check was issued January 29, last.

The balance in the State's unemployment fund through last week including interest from the U. S. Treasury on the deposit balance was \$9,145,435.71, even though nearly \$4,400,000 had been paid out in benefits.

Mrs. Davenport, who lives in the Supperrong township two miles from here, walked half a mile from her home to the river shore. There her body was found in waist deep water 75 yards from shore by her husband, I. R. Davenport, Sr., and two neighbors, Wade and Thomas Davenport.

Surviving, besides her husband, are two sons, one daughter, three sisters, including Mrs. Lydia Norman of Plymouth.

Funeral arrangements had not been completed.

When Nazis Splice The Matrimonial Knot

Berlin (AP)—By official order, those German weddings that aren't held in churches are more dignified than they used to be. But many June weddings still seemed odd affairs to those not versed in Nazi lore.

Ancient Teutonic ritual frequently is used—with many variations.

One of the Germanic Faith movement's formulas read to couples runs: "May Mother Earth from whom all love proceeds, and Father Heaven, who blesses with his light and his weather, and all good powers in the air, rule over you until your destiny is fulfilled."

'Yes, Heil Hitler'
A semi-religious sacrament was introduced not long ago by a Nazi sectarian movement.

On a rostrum in a Berlin meeting hall was an arrangement of swastika flags, and a version of the Bible which had been "cleansed of all Jewish taint."

The bridegroom was asked: "Art thou ready to take this woman as thy wife, and live with her in marriage according to German customs?"

He smartly gave the Hitler salute and cried: "Jawohl, Heil Hitler!"

The bride answered in the same way to the question: "Art thou ready to stand at the side of this man in the hard struggle in behalf of the German Fatherland?"

The couple was then enjoined "to have many children, of whom the Fatherland may be proud."

Enjoyable Hokus

But in essence the treatment of cancer still remains—surgery and caustics, with the aim unchanged—destruction of the cancer cells.

This must not be taken to mean that all other lines of attack upon cancer have been exhausted.

Cancer is a wild and unregulated growth of certain body cells. It has been widely assumed that the cancer cells must differ in certain respects from the normal cells of the body. Many attempts to treat cancer medicinally have been based upon this assumption. For it is at the abnormal cells to some destructive agent.

between the cancer cells and the normal cells could be well defined, we could find also, perhaps, some agent—chemical, heat or other energy form—which would be effective in destroying the cancer cells without injuring the normal tissues.

This, incidentally, is the principle behind some of the most effective chemotherapy.

For the treatment of syphilis, Paul Ehrlich produced his "606" an arsenic-containing compound which proved "poisonous" to the spirochete (the syphilis-causing germ), but comparatively non-poisonous to the human body. He took advantage of that narrow margin of difference in susceptibility to the poisonous effects of the arsenic compound between the syphilis germs and the body cells.

The quest for a medicinal cure for cancer aims at the discovery of just such a difference between the susceptibility of the normal and the abnormal cells to some destructive agent.

N. C. PROGRAM IS RECOGNIZED

Campaign Designed To Promote Health In Industries

Raleigh, June 20.—North Carolina's industrial hygiene program, carried on for an accurate evaluation of the siliceous dust problem in the State, through examinations made at plants widely distributed over a territory that extends 600 miles in an east-west direction and an average of 100 miles from the northern to the southern boundaries, has been accorded international recognition.

This phase of the State's activities in behalf of the people, designed to promote health among workers employed in siliceous dust industries, is carried on by the Industrial Hygiene Division of the North Carolina State Board of Health, of which Dr. H. F. Eason is director, as a cooperative undertaking with the North Carolina Industrial Commission, composed of Van Buren Jurney, chairman; J. Dewey Dorsett, and T. A. Wilson.

The current issue of "Industrial Medicine," devoted to occupational diseases and traumatic surgery, published in Chicago and read by physicians and surgeons in foreign countries as well as the United States, contains a comprehensive article on this work by C. R. Matheson and M. F. Trice, technician and engineer, respectively, of the Division of Industrial Hygiene, of the State Board of Health. The article describes in detail the field equipment used in making examinations throughout the State.

During the past two years, X-ray films of the chest have been made of 6,458 persons working in foundries, brick and tile plants, granite quarries and stone-cutting sheds, also in mines that produce feldspar, mica, kaolin, quartz, copper, talc, pyrophyllite and gold. Of this number, 2,560 were examined in the mobile laboratory during the past year.

"It is interesting to note," said Dr. Eason, "that among the first 4,357 examinations the number of persons having various diseases and conditions included: Thirty-nine cases of suspicious and definite silicosis, 6 of asbestos with infection, 44 of suspicious and definite pneumoconiosis, 5 of pneumoconiosis and infection, 175 of childhood type tuberculosis, 39 of childhood type tuberculosis and latent pulmonary tuberculosis, 22 of active pulmonary tuberculosis, 36 of apparently healed pulmonary tuberculosis, 47 of suspected pulmonary tuberculosis, and 60 of high blood pressure

Branch Passenger Lines Disappear In North Carolina

If Present Trend Keeps Up State Will Be Left With Practically No Passenger Train Service

Raleigh, June 20.—North Carolina will eventually be left with no rail service except upon the main lines of the trunk systems, if the present trend continues for any length of time, Utility Commissioner Stanley Winborne told this correspondent today.

But competition is the basic reason for this gradual abandonment of branch passenger lines, but the present financial plight of the railroads is the moving cause of the present flood of applications to discontinue passenger service, the Commissioner said.

"The railroads are making desperate efforts to cut down all kinds of expenses," he said, "and the savings effected by abandoning service on branch lines is often a considerable item."

As an indication of the almost total loss of business on the branch lines Mr. Winborne cited recent hearings in which Seaboard Air Line witnesses testified that the average daily receipts from passenger service between Lewiston and Boykins, Virginia, amounted to \$1.01 during 1937, dropping to 89c for the first five months of 1938. Another instance was the Louisville-Franklin passenger service, from which receipts for the first five months of this year averaged only twenty cents per day.

No opposition was made to the continuance of these lines (where service is being given on "mixed" trains). This, too, is becoming more and more frequent, Commissioner Winborne said.

"It used to be that there was a storm of opposition every time a railroad attempted to discontinue a passenger line," he said. "But nowadays it is not at all uncommon for a petition to be heard

without anyone appearing against it."

An exception, he said, is developing in the matter of the A. C. L. line between Kinston and Weldon. Notice of the railroad's intention to ask for discontinuance of this line having already brought counter-notice that opposition will be determined and widespread.

Washington Daybook

By Preston Grover

Washington—Once there was a
camel shivering outside the tent of
his master, Mustapha, and he growl-
ed and shuffled about until his mas-
ter could not sleep.

"Be quiet, O offspring of a sour-
belled ancestor," said Mustapha,
sticking his head through the tent-
flap.

"Master, it is cold out here, and
the sand beats upon my tender
parts," replied the camel. "Please
let me put only so much as my
nose in the tent."

Mustapha did, and the camel did,
and presently the camel wanted to
put in his head, and his neck, and
—well, everybody knows the rest
of the story.

That, in a parable, is what many
observers expect will be the ulti-
mate outcome of the wage-hour bill,
and a brief tracing of its recent ex-
perience in Congress tends to sup-
port the view.

When it first appeared, the bill
included just about all classes of
labor. The 40-cent-19 hour floor
was in the bill as a foundation. But
the bill also included hour and wage
regulations all up the line, even to
the dollar-an-hour help. The whole
camel was already in the tent.

Principle's The Thing

Surprising as it may be to some,
the first and most impressive pro-
tests came from labor leaders. They
argued that such a measure would
transfer to the federal government
the whole business of negotiating
wages and hours, leaving organized
labor no field in which to operate,
literally no purpose in life. Industry
joined in the protest for other rea-
sons.

The first real step involved a
change in the philosophy of the bill.
A Senate sub-committee decided to
avoid any immediate effort to regu-
late the higher paid brackets of la-
bor. It narrowed the field to the
classes getting under 40 cents an
hour and working more than 40
hours a week.

But even the "44" floor had to
be modified to avert opposition
which would have killed the bill.
Its sponsors did not hide their pur-
pose. Their aim was to get a bill
on the books; almost any kind of a
bill, the most effective possible, of
course, but nevertheless one which
would contain the principle of put-
ting a "fair labor" floor under low-
paid labor.

First off, agriculture was exempt,
and so were such plants as canner-
ies and country dairies which had
the "first processing" of farm prod-
ucts. High pressure seasonal jobs
like fisheries had to be exempt.

The south, slowly building up in-
dustrially (partly because of its
low-priced labor) protested at losing
this advantage by which it had been
enticing away New England cotton
mills. So a cushion had to be left
there.

Between The Lines

When the legislation goes into ef-
fect, about mid-October, it will af-
fect surprisingly little labor—mostly
in the south—with its 25 cents-an-
hour, 44-hour week. That is \$11 a
week. In one year the minimum be-
comes \$12 a week for 42 hours, and
in seven years \$16 a week for 40
hours—with certain exceptions. At
each upward step more and more
employees will be affected directly
as well as indirectly.

The thing creeps. Observers, ex-
pecting many of its sponsors, expect
to see the legislation extend from
one industry to another. The more
it expands the more it is compelled
by economic laws to expand further.
By indirection, it sets up a divi-
sion of government which can act
as a modified industrial planning
board. The wage-hour division which
administers the act can grant ex-
emptions from the wage-hour levels
to industries affected by high trans-
portation costs and low living costs.
By a hard-handed policy it could
make or break an industry in a given
locality. The Congress was ought
to set up protective restrictions
against such tactics. The opening
remains.

They'll Spend Your 4 Billion Dollars

WASHINGTON—Eight men in Washington are ready to open wide the money bags which will pour some \$4,550,000,000 in cash and credit to fight de-pression. These are the men and this is how they'll spend the money:



Slim, pallid Harry L. Hopkins, 47 has spent billions on the needy since the New Deal started its work relief program in 1935. For 20 years he was a social worker in New York City. As administrator of WPA he probably knows more about federal relief than anyone else in the government. He has played 1,500,000 to 3,000,000 jobs a year. He gets at least \$1,250,000,000 out of the emergency spending-lending bill for new relief jobs. His salary is \$12,000.



Jesse Jones, frank and square-jawed has already started to pass out some \$1,500,000,000 in loans to business, big and little, which can't borrow from the banks. But the RFC head is in a class by himself because he doesn't expect to spend all he gets—since he deals in loans, not grants. A member of the RFC board since Hoover days, the 64-year old Jones was made RFC chairman by President Roosevelt. His salary is \$10,000 a year.



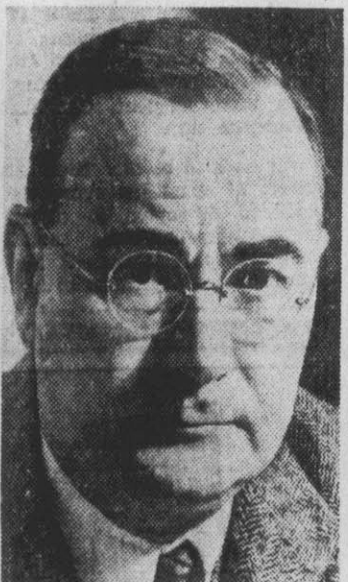
Harold L. Ickes, 64-year old Secretary of Interior, already has spent more than \$4,000,000,000 as the first administrator of PWA and he's slated to spend some more. The stout, bespectacled Chicagoan, who recently married a 25 year old girl, will lend and spend nearly a billion dollars on a new PWA program of public works. An ex-newspaperman lawyer, Republican, Ickes gets \$15,000 a year. He has been Secretary of the Interior since 1933.



Nathan Straus, administrator of the United States Housing Authority, calls his half billion dollar low-cost housing program "slum drainage." To build more houses at low rents, and help prime the economic pumps, Congress is giving him another \$300,000,000. Straus has been reporter, merchant, author, philan-
thropist and office holder in New York state. He has been interested in housing almost since he entered politics. His salary is \$10,000.



Henry A. Wallace, a slowspoken phrasemaker, who coined the New Deal slogan "more abundant life" is slated to get some \$175,000,000 to help needy farmers. The son of a former Secretary of Agriculture Wallace has been trying to devise a "more abundant life" for the American farmer since 1933. Once a Republican, he left the editorship of a prominent midwestern farm journal to become Secretary of Agriculture under Roosevelt. His salary is \$15,000.



Tall John M. Carnody's share in the spending-lending fund comes to some \$100,000,000. He is administrator of the Rural Electrification Administration, which loans money to electrify farm communities. Born on a Pennsylvania farm 50 odd years ago, the big-voiced, blue-eyed REA administrator went through high school, was a steel worker and later a production manager in the coal, steel and garment industries. His salary is \$10,000 a year.



Aubrey Williams, another ex-social worker in the New Deal's relief lineup, is director of the National Youth Administration and assistant to Harry Hopkins. The son of an Alabama planter, he once studied to become a preacher, later took a degree in philosophy at the University of Bordeaux, France. For young people who need help, Congress is giving Williams some \$75,000,000 on the recommendation of President Roosevelt. His salary is \$9,500.



To heavy set Robert Fechner, who got his start as a railroad worker, goes \$50,000,000 for the Civilian Conservation Corps, one of the New Deal's first relief agencies. He runs his organization quietly, says little in public and gives few speeches, but frequently travels about the country on inspection tours. Fechner came to Washington in 1933 to start the CCC. His \$50,000,000 is in addition to regular CCC funds totaling \$226,331,000. His salary is \$10,000.

SHORT SHOTS

Raleigh, June 21—Henry L. Stevens, Jr., one time National Commander of the American Legion, has by his nomination for judge of the Sixth Judicial district added a very important bit of evidence to disprove the oft-heard maxim "They Never Come Back."

In 1931 when he fled the country's biggest and most powerful veterans organization he seemed headed for high honors in whatever sphere he chose. He had everything. He was (and is) without doubt the peer of any orator in the country. He was popular with every group in the Legion.

Then came the bonus controversy and Henry Guesses wrong. He allowed himself to be quoted as saying that the rank and file of the veterans did not want the bonus paid them—a statement absurd on its face. Perhaps he was misquoted—though that seldom happens. At any rate it killed him dead. When Admiral Dewey who gave his wife the home popular subscription had bought.

Henry almost got a good job in the War Department at the start of the Roosevelt administration (rumor having it that he had even picked out his desk as assistant Secretary) when the thing rose to plague him.

He couldn't have been elected dog catcher. His name was anathema in practically all veteran circles.

Then it was that the Warsaw man showed he can "take it" with the best of them. He kept plugging away, though quietly. Two years ago he came out in the open as one of Sandy Graham's ablest—certainly the most eloquent—advocates. The bonus had been paid. Time had mellowed the insubordinate. He thought of the governorship, sent up a trial balloon last year—saw it fall for lack of puffing. But when Judge Henry A. Grady decided the Sina Godwin case would prevent his renomination, Henry L. saw his opportunity and grabbed it quickly.

His two to one victory over veteran Solicitor Powers shows that they do come back.

It appears on the report of Marshall C. Kurfess, unsuccessful candidate for Congress in the fifth. Note: Mr. Kurfess "good time" was had before, not after the voting.

I have had a lot of fever in the past few days, but that is a small price to pay for the sweets of convalescence. To me convalescence is

an endless daisy-chain of long dreamless sleeps, and loving friends bringing you new books in bright shining jackets, and telephone calls filled with drama and suspense. For you never know who those calls are from until someone answers and you try to piece it out from the talk at this end. Perhaps it is from the office wanting to know if you will have those columns on time. Or maybe an old friend has bobbed up in town anxious to go on a spree. What fun to hear them tell him, "A party! Why, he is practically at death's door."

No such thing. You couldn't kill me with an ax. They think I am in a pretty bad way because I lie so quietly. But that is what I like to do. Just close my eyes and be lazy while people fuss over you. I lie quietly like this when I am in the best of health.

But this, this is something special. Days and nights no longer have any significance. I drift off to sleep, and waken refreshed. I read a book. I thumb through all the new magazines. It may be three o'clock in the morning. It may be 11th noon. The hours mean nothing. Sometimes, in a vindictive mood, I set the alarm for some ridiculous hour, and when it goes off I lie here and thumb my nose at it because I don't have to get up. That's getting even! That's telling 'em, eh, Sugar? Ain't dat puttin' ol' Clock in his place?

WANT ADS PAY

Maxwell's Safety Campaign Pleases Anti-Diversionists

Two of Six Points Bing Used As Arguments for Program Aimed at Constitutional Change

Raleigh, June 20.—Two of the six points of Revenue Commissioner A. J. Maxwell's recommended program for better highway safety are being used by opponents of diversion as excellent arguments for their program of getting thru a Constitutional amendment forbidding use of automotive tax revenues for any other purpose.

The two points are (1) Increase in Highway Patrol personnel and (2) Construction of semi-hard surface shoulders on all curves in the state, even if it should be necessary to refund some of the state's bonds in order to get the money to do it.

The meat in these two cocoanuts, so to speak, which Anti-Diversion folks like particularly is the implication that there will be need for highway purposes more money than is now being spent thereon.

Not that these people are in favor of more taxes. On the contrary, quite the reverse; but it gives them a better chance to argue that all revenue from automotive taxes must be kept intact for highway purposes, because there is the more need for them to be applied in that fashion.

In short, they will be able to argue that only way in which the patrol can be increased and the roads made safer from an engineering viewpoint is to use every available penny on them instead of diverting some of the highway revenues to other purposes.

If these revenues are not kept sacred to the purpose for which they were originally intended, the result will inevitably be a necessity for levying higher taxes—or of refunding bonds the state is now retiring in regular order.

In other words, anti-divisionists will contend, the only way to get real road improvement without increasing either taxes or debt is to spend road receipts on the roads. And the only way to insure that is the proposed Constitutional amendment.

It's Odd But It's Science

Alliance, Ohio—The moon may not be so dead as has been thought says Dr. Walter H. Haas, Mount Union college astronomer.

His suspicion of some form of life on the moon is based on studies of Aristarchus. Aristarchus is one of the prominent craters on the moon. The ancients, lacking telescopes, thought these craters were seas.

The moon craters are from five to 60 miles in diameter, much larger than earth's volcanic craters. The walls of the moon craters are mostly steep. They stand out brilliantly in sunshine and pass into shadow. These changes make the contours very clear.

But Dr. Haas finds something puzzling in certain dark bands that appear on the walls around Aristarchus. He describes the bands in Popular Astronomy.

The dark bands do not appear to be shadows, he says. They come on gradually. They lead to a suspicion of some sort of surface change during the noonday heat on the moon.

Furthermore, Dr. Haas says this peculiar phenomenon is not confined to Aristarchus. It is brilliantly visible there, but it occurs in other craters.

Crane Loses His Shirt To Wrens.

Austin, Tex. — (AP) — Edward Crane, law professor at Texas University, hung a shirt out to dry. Next day he found a pair of wrens keeping house in a rolled-up sleeve. Crane let the wrens stay there—he even rigged up a canopy to protect them.

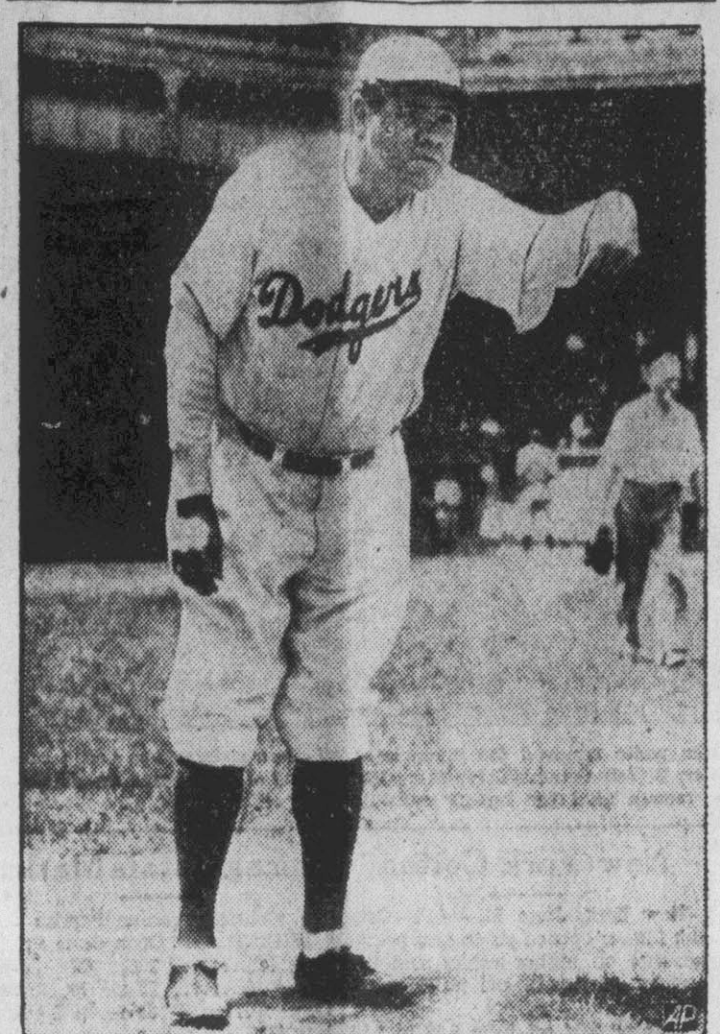

Tunney Picks Louis To Win Over Schmeling

By ALAN GOULD

New York, June 21.—(AP)—Sizzling in the high temperature of their own arguments, as well as the current June heat wave, the fistie faithful tonight gravitated toward the big town and the big fight.

The approach of the near-million dollar spectacle this Wednesday evening in the Yankee stadium, featuring Ducky Joe Louis and Teutonic Max Schmeling in a 15-round match for the world heavyweight boxing crown, seems to be more conducive to more fever than fact-finding.

Although the climax of training camp activity produced nothing more startling than re-assurance that both gladiators had worked themselves into the traditional peak of condition, it developed that week-end betting had made Champion Louis a more pronounced favorite to turn the tables on his challenger.

There has been little tendency to "go overboard," either financially or for literary effect, but Broadway Jack Doyle reported his latest wagering quotations as follows: 1 to 2 against Louis to win; 17 to 10 against Schmeling, on a decision; 9 to 10 against a knockout by Louis, 5 to 2 against a repetition of his 1936 K. O. by Schmeling.

A Stronger Favorite

"Louis will become a stronger favorite, if the present trend continues, and may be the 2 to 5 choice by Wednesday," Doyle added. "It is interesting to note that, so far, more people are betting on Schmeling but more money is being wagered on Louis. This is one of the biggest betting fights we have had in many years."

Barring sudden developments, calculated to sway pre-fight opinion, there's little reason to doubt that Joe and Max will enter the ring as closely matched as any title pair since the Dempsey-Tunney days. The usual eleventh-hour rumors have begun to develop along cauliflower row—most of them designed to hint that "Louis can't lose"—but this is a characteristic of the fight game, in its bigger business dealings. It can be discounted now, as heretofore.

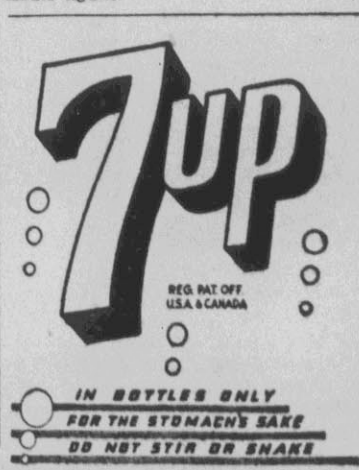
Behind some "inside talk" is the idea that Schmeling, if he repeats his victory of 1936 and becomes the first ex-champion to regain the crown, will put the championship "on ice" back home in Germany.

This, of course, would be a severe blow to the industry now dominated by Promoter Mike Jacobs. It doesn't hold very much weight, however. Schmeling is already under contract to defend the title, not later than 1939, and probably could be persuaded to stake it against Max Baer this fall, for a substantial cash consideration.

It is no secret, however, that Jacobs will be much better pleased if Louis gets the revenge he is seeking and remains the king of the heavyweights. The Negro is under long-term contract with "Uncle Mike" and is certain to defend the title again this year, if he turns back the German.

Louis, satisfied that he is on edge, tapered off today at Pompton Lakes, N. J., with roadwork and a motor trip. The champion's last serious workout, with the gloves on, impressed a capacity gallery of fans and critics yesterday. Joe will motor to New York Wednesday morning for the official weighing-in.

Schmeling, after a brisk four-round drill in the ring at his Speculator, N. Y., camp this afternoon, echoed his handlers' assertion that he is in the best fighting trim of his career. Said Max: "I'm satisfied that I've reached unsurpassed condition. I expect to win over Louis again."

N. C.'S "PUBLIC ENEMIES" NOT PRODUCTS OF PAROLE

Interviewers for the parole commission that they were not the type deserving clemency.

Dwight Beard did receive a commutation of a death sentence, Mr. Gill said, but he was not turned loose by the parole system and, he pointed out, the commutation was granted only because four out of five members of the State Supreme Court, the trial judge, the prosecuting solicitor and the jury that tried Beard requested clemency on the grounds that there was doubt of Beard's guilt of first degree murder.

Records in the parole office show that Cobb was classed as habitual criminal" and "unable to reform even if he wanted to" by parole investigators.

Neither Coley Cain nor Otis Wood noted bad men who were killed by officers during their criminal careers was a parolee at the time of his death, nor had either ever previously had a parole.

Mr. Gill said the parole granted Gus Langley was "unique" in that

it was granted him instead of a full pardon in order that there might be some supervision over him as a "mighty sorry character" although the Governor and the Parole Commissioner became confident he was innocent of the crime for which he had been convicted.

"Of course we make mistakes—the only way they can be prevented would be to abolish all paroles—but not one of these mistakes has been in the case of a true gangster type bad man" said Mr. Gill.

"It may be true that in some other states the parole system has broken down and it may be that clemency has contributed to the making of public enemies elsewhere but our North Carolina system has done no such thing" he added.

In a recent publication "Parole Facts" Mr. Gill outlined the strict supervision which is exercised over parolees in North Carolina and asked for "public confidence" in the system as the best way to make it work in a satisfactory manner.

Farrington says a new profession for women is being opened up.

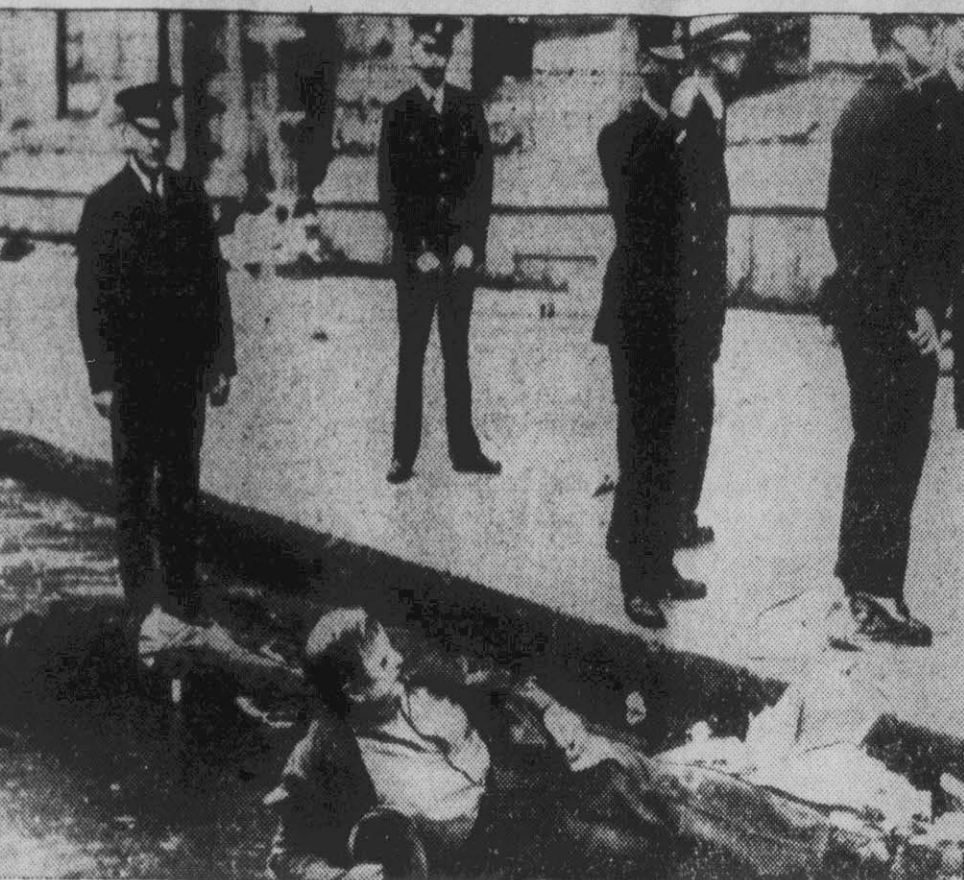

Housing Solution Found For Agency

Raleigh, June 21.—Solution of the housing problem for the N. C. Unemployment Compensation Commission has apparently been solved by the offer of Dr. James R. Rogers to erect a \$100,000 building as a permanent home for the Commission, facing westward on Wilmington street toward the southeast corner of Capitol square.

The building will be 105 by 105 feet square and will contain 10,000 square feet on each of the three floors and in the basement, to be used for boiler room and storage. The structure will be of brick and concrete, with limestone facing, in keeping with the State buildings around the square. It will give adequate space for the permanent State agency after completion, by December 1. The Commission will remain in the inadequate quarters on Fayetteville street until the new building is finished.

The Commission has been seeking larger space for its operation for six months or more, and had spent offers from Greensboro, Winston-Salem and Charlotte. The new proposal will result in its remaining in Raleigh.

NOTE INCREASE IN JOBS FOUND

Private Industry Is Helping To Absorb Unemployment

Raleigh, June 21.—Each successive month of 1938 has shown an improvement over the previous month in placements made by the employment office of the state, according to a report issued today by R. Mayne Albright, director. May, with 7,182 placements, represents the best month since October, 1937.

Private industry absorbed 65 per cent of these. Building construction led with 2,464; personal service followed with 1,575; next came agriculture with 1,373; hotels took 447 and manufacturing 371.

The Edenton district led the state with 1,293 placements. Elizabeth City topped all other cities with 742.

During May 28,277 persons were recorded as applicants for work. Of this number 16,549 had never registered before, while 11,728 renewed former applications.

The active file in the state is now 160,079; 107,325 men and 52,754 women. This number represents an increase of 90 per cent over May 31, 1937, when the active file stood at 84,210.

May showed a drop in original claims of 12,384, the total being 28,506. Continued claims for the month were 443,439, an increase of 8,638 over April. Personal calls, numbering 501,308 for the month of May, increased 48,425 over April. Registrations in the Rocky Mount district during May were 1,703, an increase of 125 over April. Of this total 987 or 57 per cent, had been employed in manufacturing. Placements for the month, 827, were 158 more than for April. The active file is now 17,141, an increase of 1,585 from April 30.

WEED BROUGHT \$143,115,000

Income From Tobacco 53 Per Cent of Farm Income

Raleigh, June 21.—Representing 53 per cent of the state's total farm income from all sources, North Carolina growers received \$143,115,000 for their record tobacco crop during the calendar year 1937, the State Department of Agriculture reports.

Tar Heel growers produced 595,530,000 pounds of tobacco in 1937, or an average yield per acre of 884 pounds on 674,000 acres. The acreage devoted to tobacco last year was an increase of 12 per cent over 1936.

Department statisticians reported that producers' tobacco marketed on the warehouse floors of the state during the 1937-38 season averaged 24.4 cents per pound as compared with 22.9 cents received during the previous season.

The seasonal average price of producers' sales in the different belts was reported as follows:

Old Belt, 23.4 cents per pound compared with 22.7 the previous season; New Bright Belt, 25.8 cents

compared with 23.2 cents; Border Belt 22.4 cents compared with 21.7. Burley tobacco averaged 21.4 cents compared with 38.8 cents the previous season.
