

FDR SUPPORTS CANDIDATE IN OHIO PRIMARY

Exercises Previously Declared Right To Take Sides

SPEAKS OUT FOR SEN. BULKLEY

Favorite Supported Court and Executive Reorganization Proposals

Marietta, Ohio, July 8.—(AP)—President Roosevelt stepped into the Ohio Democratic primary today with a word of praise for Senator Robert Bulkley.

Bulkley, candidate for renomination, was the only individual mentioned by the President in his first address of a trans-continental speaking tour, except in his introduction.

Introduced by former Governor George White, Bulkley's opponent, to a crowd celebrating the 150th anniversary of the settling of northwest territory, the chief executive said:

"Governor Davey, Senator Bulkley, Chairman White—"

Later in the body of his speech the President said:

"The cavalry captain who protected the log cabins of the northwest is now supplanted by legislators like Senator Bulkley toiling over the drafting of... statutes and over the efficiency of government machinery to administer them so that... protection and help of government can be extended to the full."

The President thus exercised at the outset of his journey across the nation to California his previously declared right to intervene in primaries.

Bulkley favored Mr. Roosevelt's court reorganization plan and voted for final passage of the executive reorganization measure.

People, four or five deep, pressed against the ropes which blocked off the speaker's stand in a park as the chief executive served notice he was pressing on with his program and expected popular support.

"I believe," the President said, "that the American people, not afraid of their own capacity to choose forward-looking representatives to run their government, want the same co-operative security and have the same courage to achieve it, in 1938 as in 1788."

"I am sure they know that we will always have a frontier—of social problems and that we must always move in to bring law and order to it."

Delay Hearing On Petition of A. C. L.

Postponement Granted on Request of Committee from Eastern Chamber of Commerce

The organized opposition to the Atlantic Coast Line's request to remove passenger trains operating between Weldon and Kinston daily, as well as other trains, won a temporary victory yesterday when the Utilities Commission delayed the hearing until August 1.

Besides the Weldon-Kinston trains, which operate through Greenville and other Pitt county towns, the petition involves routes between Tarboro and Plymouth and Plymouth and Washington.

Postponement was granted upon request of a committee from the Eastern North Carolina Chamber of Commerce, which is opposing the proposed discontinuances. The railroad contends it is losing money on the three schedules.

The opponents submitted a list of questions which they said they wanted the carrier to answer.

George M. Fountain, Jr., Tarboro attorney, appearing with the Chamber of Commerce committee, said his group had not been shown that the passenger service resulted in losses. He added that the opponents believed the entire services of the railroad over the lines, including passenger, freight and express business, resulted in a profit.

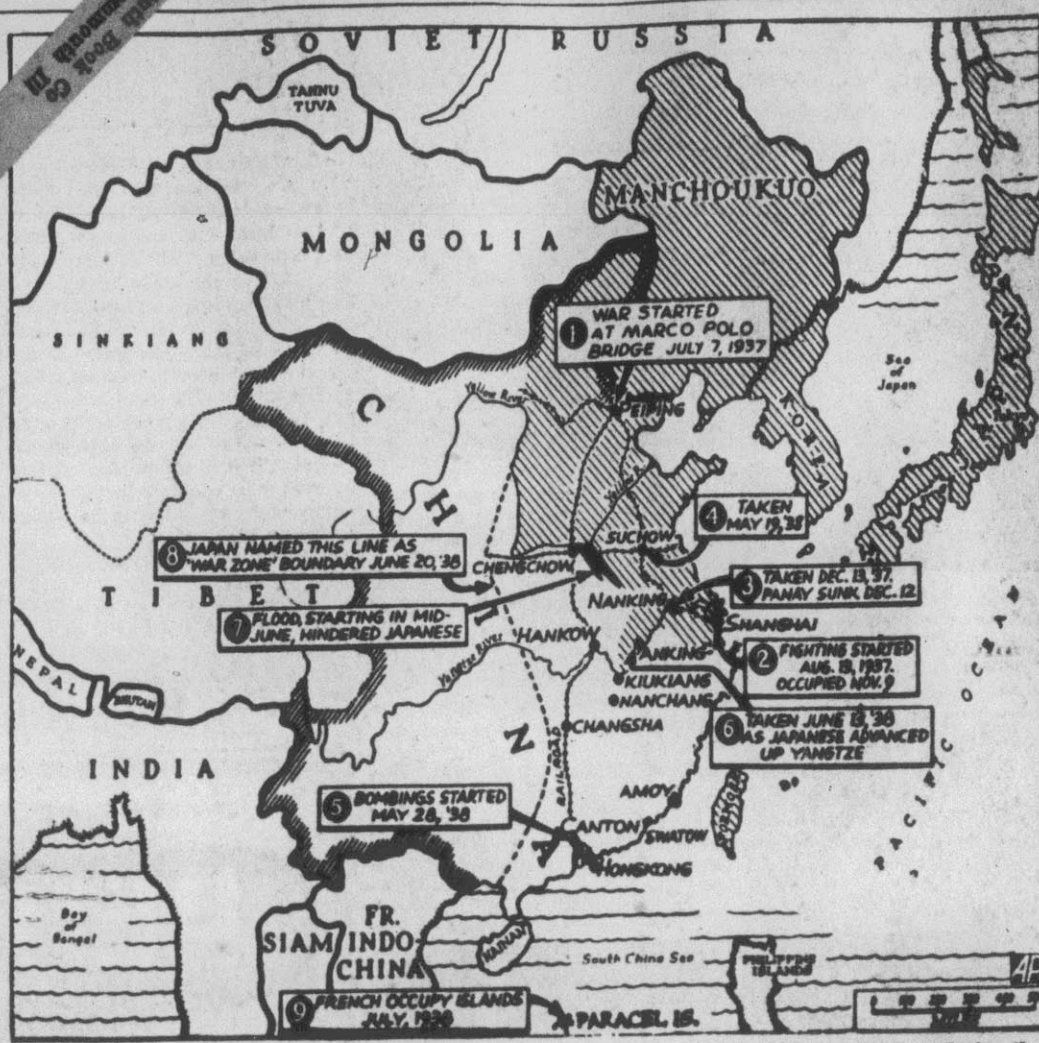
Still Destroyed

NINETEEN FACE VICE-RECORD'R

Large Number Cases Tried Here Today In City Court

Nineteen defendants faced Vice-Recorder L. C. Skinner in City court this morning, charges involving whiskey and assault being in the majority.

Clifton Williams, Negro, was ordered to pay one-half the costs on a charge of assault. Jarvis Anderson was convicted of driving while drunk and given a 90-day sentence, suspended upon payment of a \$50 fine, costs of court and \$5 to pay for damage caused to another automobile.

D. E. White and Jack Basnight faced charges of reckless driving as a result of an automobile accident. Both were freed however, a note pros having been taken in the case as it applied to Basnight and White having been acquitted.

Roy Taft, Negro, arrested under the "Peeping Tom" act, was acquitted.

Wilbur Dixon, Negro, was convicted on a whiskey charge and given a 12-month sentence, from which he appealed. Bond was set at \$200. The Negro also was convicted of operating a disorderly house and given 12 months on that charge. The sentences to run concurrently.

William Burse, Negro, held on a whiskey charge, asked for a trial by jury and the case was transferred to Superior court.

E. D. Anderson, convicted of driving while drunk, was given a 90-day sentence, suspended upon payment of a \$50 fine and court costs. The defendant appealed and bond was set at \$200.

William Green, Negro, was charged with assault on a female, but his case was transferred to Superior court for a trial by jury.

William House, Negro, was convicted on a whiskey charge and given a 60-day sentence, suspended upon payment of \$25, costs to be deducted, and upon further condition he remain of good behavior.

Allen Thomas, Negro, was given a 30-day sentence, suspended upon payment of costs, following his conviction on a charge of being drunk.

Would Ask Federal Aid For Marketing Program

Raleigh, July 8.—Commissioner of Agriculture W. Kerr Scott intends to press his campaign for a better marketing program on all fronts. Including the federal congressional.

He now proposes federal legislation in aid of a marketing program for the South, with funds from the federal treasury to be matched by the states. Previously the commission had announced his intention to ask the North Carolina legislature for funds to improve the marketing of North Carolina crops, but his advocacy of federal aid is a new point in his aggressive program.

Last night he told the Wendell Grange that he intends to request North Carolina's Congressmen to draft a federal marketing plan.

Today he reiterated the necessity for better marketing and for additional funds for such a program.

REVEALS SUMS SPENT ON ACT

Total \$480,906 Spent in North Carolina on Farm Program

Washington, July 8.—(AP)—The AAA reported today local farmers' committees and associations spent \$480,906 in North Carolina to execute the 1936 Agricultural Conservation program between July 1, 1936 and February 28, 1937.

The total for the country was \$19,406,614.

AAA officials said compliance payments under the 1936 program went to 3,961,598 individuals. FAYETTEVILLE GETS HOSPITAL

President Accepts Recommendation Of Sub-Committee

Washington, July 8.—(AP) Frank Hines, veterans' administrator announced today President Roosevelt had approved a recommendation of the Federal Board of Hospitalization that a new veterans' administration hospital for North Carolina be located at Fayetteville.

Hines said the board, in reaching its conclusion, took into the account Fort Bragg was near the chosen city.

In event of an increased demand for hospital facilities at the Fort a veterans' hospital at Fayetteville would be of great value, Hines said. More than 30 cities in North Carolina were visited by a veterans' administration sub-committee in its study of possible locations for the new 300-bed hospital, to cost about \$1,500,000.

Hines said the sub-committee, after giving full consideration to the veteran population of the area to be served, transportation facilities of essential utilities and accessibility of buying centers, had decided Fayetteville would be the best location.

ENDORSES ACT FOR OFFICIALS

Vandenberg Would Publicize Officials' Private Income

Grand Rapids, Mich., July 8.—(AP)—U. S. Senator Vandenberg (R-Mich.), proposed today that government officials be required to make public the amount of income they derive from market transactions, personal holdings for private services.

The senator, in a statement from his home here, said need exists for regulation to protect the public from "outright exploitation."

"We constantly hear ugly rumors about 'leaks' that have been capitalized for public profits," Vandenberg said.

"None of them ever come to proof. Most of them probably are untrue. The best protection which honest officials can have in such circumstances, is a publicity requirement, which makes the whole record public."

He said that if incomes of public officials are enhanced by private personal services or by sources that might be affected by governmental action, it is the public's business and it is the public's right to have indisputable facts.

"If it was logical for the President to warn all federal employees against stock gambling, it is logical to require a public record if this gambling occurs."

ONE KILLED AS PLANE WRECKS IN TAKING OFF

Seven Others Injured at Billings, Mont., Airport

UNABLE TO GIVE CAUSE OF CRASH

One Person Declares Pilot Didn't Seem to Be Able to Control Transport

Billings, Mont., July 8.—(AP)—A Northwest Airlines transport plane carrying eight passengers and a crew of two crashed at the end of the field while taking off here early today, killing one person and injuring seven.

Mrs. N. S. Mackay, Evanston, Ill., died at a hospital in Billings shortly after the crash, the hospital announced.

Her husband was taken to the hospital, but the extent of his injuries was not known.

Mrs. W. J. Tisdale, Sloan, British Columbia, also was being treated at the hospital, but attendants said they did not know whether she was seriously hurt.

The other five passengers were released after treatment for minor cuts and bruises.

A. T. Peterson, Northwest Terminal manager here, said the plane took off at 2:53 a. m. (4:53 a. m. EST) for Chicago and crashed about 1,000 feet from the end of the runway on the edge of a canyon.

He said the pilot, Walter Bullock of Minneapolis, could give no reason for the crash, the other member of the crew, Peterson said, was Co-Pilot L. Dean of Minneapolis. Neither was injured.

The plane was demolished, Peterson said, when it smashed on a small knoll. He said the tail and one wing struck first. The pilot cut the switch, preventing fire.

A superintendent of the Montana division of the Consolidated Freight lines told the Associated Press "the pilot didn't seem to be able to control the plane...."

STATE AUDITOR IS COMMENDED

Hoey Praises Work of Pou in Completing Audits

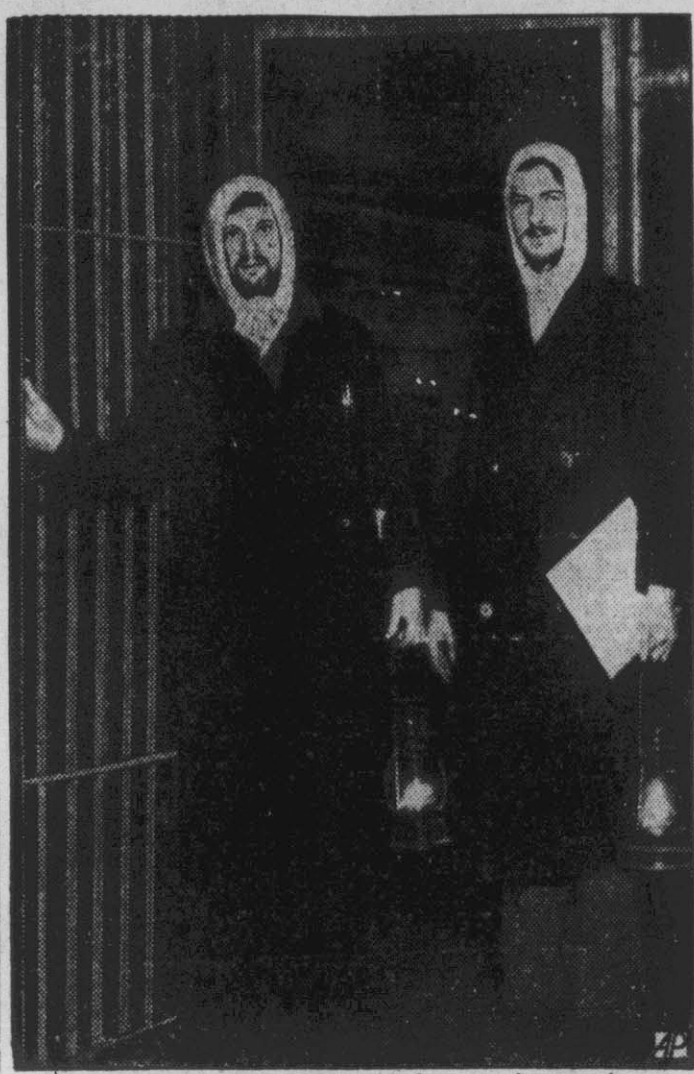
Raleigh, July 8.—(AP)—State Auditor George Ross Pou reported to Governor Hoey today, apparently for the first time in a decade or more, complete audits had been made in one fiscal year of all 68 state agencies.

Governor Hoey issued a statement commending Auditor Pou, saying it could be seen that the work "is a monumental task, and this is the first time in many years that an audit of this kind has been made."

Pou said the reorganization of his department as authorized by the 1937 Legislature, made the result possible and pointed out that "insofar as the records of this audit disclose, this is the first time in a decade or more that proper audits of all state institutions, departments and commissions have been current."

"I wish to commend Auditor Pou and his department upon the completion of this splendid work," said Governor Hoey, "and I feel that the Legislature acted wisely in providing for this audit to be made by the state agency specially charged with this responsibility, and I regard this as much more preferable to have the particular agencies audit their own accounts. The result of this audit is most gratifying and I am sure will be reassuring to the people of the state."

Four More Are Slain In Jewish-Arab Outbreaks

Britain Dispatches Warship and Additional Troops

Jerusalem, July 8.—(AP)—A bomb blast at Jerusalem's busy Jaffa gate today killed four Arabs and wounded 36 in a new outbreak of deadly terror which Great Britain is trying to crush with warships and troop reinforcements.

The bomb tore apart a bus in the crowded Arab bus station and a vegetable market in the shadow of David's tower.

The vehicle was filled with Arab country folk about to leave for Hebron. Its blood-stained and twisted framework was scattered in a roadway filled with panic-stricken humanity.

Troops of the Scottish Black Watch regiment, with fixed bayonets, cleared the square and started hunting the bomb thrower.

One Jew, surrounded by an Arab mob, was rescued by police and hustled to safety.

About the same time a general strike broke out in Amman in neighboring Transjordan. Workers struck in sympathy with Palestine Arabs, victims of bomb throwings at Haifa, Palestine's chief port.

Today's violence raised the casualties in nine days of riots and extension to 37 killed and 150 injured.

The British battle cruiser Repulse one of the world's largest battleships, steamed into Haifa harbor to take the place of the British cruiser Emerald. The Repulse trained her guns on Haifa.

Two battalions, at least 1,600 men of British troops rushed from Egypt to reinforce the 10,000 British soldiers, armed police and aviators who had failed to halt the bloody reign of terror which Jewish leaders feared might develop into civil war between Jews and Arabs.

SHORT COTTON CROP SEEN BY 1938 ACREAGE

Less Than 27 Million Acres Under Cultivation

SMALLEST TOTAL IN PAST 38 YEARS

North Carolina Acreage of 911,000 Only 82 Per Cent of That Cultivated in 1937

Washington, July 8.—(AP)—Cotton planters have less than 27,000,000 acres under cultivation this summer, the smallest total since 1900.

The Federal Crop Reporting Board reported July 1 acreage today at 26,904,000. This figure, 78 per cent of the comparable one a year ago, indicated cotton farmers, as a whole, are complying with the production restriction program. They planted 35,000,000 acres in 1937.

The Agriculture Department, confronted by a surplus of a year's supply of cotton, had allotted growers 27,527,586 acres for planting under the new crop control law.

"Among the causes for the sharp reduction," the board said, "are the agricultural adjustment program, relatively low prices received for last year's crop and difficulties in securing stands because of unfavorable weather."

Growers last year produced a record crop of 18,946,000 bales. The board made no forecast of this year's production. Should the yield equal the 1932-33 average, however, the production would be about 10,000,000 bales. Yields last year averaged considerably higher than the 10-year average.

The acreage in cultivation July 1 and percentage of the 1937 acreage, by states: Inhabited North Carolina, 911,000 and 82 per cent.

The estimated acreage in cultivation compared with the following state acreage allotments made under the crop control law in an effort to restrict production: North Carolina, 1,002,225 acres.

Chief Justice Of Highest Tribunal Busiest On Bench

Wrote More Opinions During Fall and Spring Terms Than Any Other Member of Court

Raleigh, July 8.—Chief Justice W. Stacy is the busiest member of the North Carolina Supreme court when it comes to writing opinions of the state's highest tribunal—at least he wrote more during the Fall and Spring terms than anyone else except that fellow "Per Curiam" who corresponds to "Anonymous" in lay literature.

The court decided 473 cases in all, 110 of them "Per Curiam," a method of disposing of the more open and shut causes without assigning a particular justice to the task of citing the law and the logic of the matter.

Of the 363 decisions written by the individual justices the Chief Justice wrote 61, four more than the next prolific member of the bench, Justice W. A. Devin, who had 57 to his credit.

The opinion-court of other justices were:

M. V. Barnhill 56, M. Schenck 54, Wallace Winborne 49, Heriot Clarkson 47, George W. Connor (deceased) 31 and A. A. F. Seawell (only quite recently appointed) 8.

In connection with the number of opinions written, however, it should be remembered that they are not all equal or even approximately equal in difficulty and in the amount of study required to arrive at them—and therefore form no true basis of any justice's ability or application to his duties.

Of the 473 cases decided, 397 were civil and 76 criminal. In 324 of them the decisions of the lower courts were affirmed, giving the judges of the inferior courts a rating of 68 1/2 per cent correct. Reversals were proportionately much higher in civil than in criminal cases, the percentages being approximately 52 and 27, respectively.

Contact With The Earth

A Greek myth tells of Antaeus, a huge wrestler whose strength was invincible so long as he touched the earth. But Hercules, knowing the source of his ever renewed strength, lifted Antaeus off the ground and kept him in the air until he was exhausted.

We don't intend to fall into Francis Bacon's error of regarding all ancient myths as parables. But the story of Antaeus holds a lesson for every man, and it amounts to this:

Contact with reality in its primitive forms, contact with the earth through our elementary senses, can afford us new strength.

Vital to every age, this lesson is perhaps most so to our own. Never before in history has so much been interposed between man and his life source, the earth.

There are countless young children whose experiences have led them to believe that the earth is an asphalted desert, dotted sparsely by "keep off the grass" signs.

There are many adults who have forgotten the soothing effects of verdure, of flowing streams, of the breathless silence of a summer's midday, of the inspiring vastness of the heavens scanned at night. Coated by everyday cares, many seek refreshment in stimulants, competitive games and time-killing entertainment, who would do better to touch earth again.

Earth need not be taken literally, though tending to one's garden is a great satisfaction, as Voltaire's *Candide* found. Rather the earthly—that is the simple, direct, the most meaningful, the palpably significant—activities are intended by the expression "to touch earth again." Such activities make for health and are an antidote to much that is inescapably unwelcome in present day life.

Precisely how you may "touch earth again" is a problem which you must solve for yourself.

Some who work with their brain solve it by working with their hands. Others who perform one repeated act in a chain of activities, the beginning and end of which they cannot encompass, find satisfaction in creative accomplishments in which they do all the planning and executing.

The point is to know that the earth is a source for renewed strength, and to find ways to gain its benefits.

STUDY SET FOR N. C. BANKERS

More Than 200 Expected at University Conference

Chapel Hill, July 8.—More than 200 bankers are expected to attend the second annual North Carolina Bankers Conference to be held at the University of North Carolina next week, July 11-15. Dr. John B. Woosley, of the School of Commerce, a member of the committee on arrangements, announced here today.

The conference, held for the first time last year, was so successful it was reported, that as many as 12 other states desired to conduct similar forums at their respective universities this year.

Conducted under the combined auspices of the North Carolina Bankers Association, the Commissioner of Banks and the University, the conference will give bankers of this state an opportunity for study and discussion at leisure.

A number of speakers of national prominence in the fields of banking and economics appear on the program. Among them are Dr. E. M. Bernstein of the University School of Commerce, who will speak Monday evening, July 11; Dr. Marcus Nadler of New York, director of the Institute of International Finance, Tuesday, July 12; Marshall A. Diggs, Washington, D. C., Acting Comptroller of the Currency, Wednesday, July 13; and Dr. Harold J. Stonier of the American Institute of Banking, and Philip A. Benson, vice-president of the American Bankers Association, Thursday, July 14.

Discussions and open forums on investments and credits, costs-analysis and banking regulations, public relations, and research are scheduled for the morning and afternoon sessions.

SMITHS FAR IN LEAD ON ROLLS

Jones in Sixth Place On Old-Age Insurance List

Rocky Mount—Claims of the Smith family to numerical superiority over all other family groups are supported by a survey the Bureau of Old Age Insurance has made of the 39,000,000 social security account numbers it has assigned, George N. Adams, Manager of the Rocky Mount office of the Social Security Board, announced today.

Account numbers have been issued to approximately 470,190 Smiths. Next in order are the Joneses with 348,530, the Browns with more than 253,750, the Williams' with 249,312, and the Millers with 238,980. The Joneses stand in sixth place with 232,540. All variations in the spelling of a name are grouped together. For instance, Schmidt, Schmitz, and Smythe are considered part of the Smith family.

According to Mr. Adams, when the old-age insurance system was being planned, statisticians estimated that accounts would have to be set up for about 25,000,000 persons. On the basis of this estimate, filing space was provided for the accounts of 294,000 Smiths, 227,000 Joneses, 165,000 Browns, 156,000 Williamses, 147,000 Joneses and 137,000 Millers.

Mr. Adams stated that John J. Corson, director of the Bureau of Old-Age Insurance, cited the high registration of workers in these largest name groups as an added justification for the Board's requirement that every worker have an individual account number. Without such an identifying number, it would, he pointed out, be difficult, and in many cases impossible, to keep accounts straight.

The Bureau's survey of its millions of listed workers also discloses that the shortest family name in the records is "E. Whether." "E" is a man or a woman the Board would not say, in conformance with its policy of holding its files confidential. The longest name yet located is Xenogianokopoulos.

I have in mind those warrens of streets off Tenth avenue where thousands of children are huddled like rabbits with nothing but the baked cement on which to play.

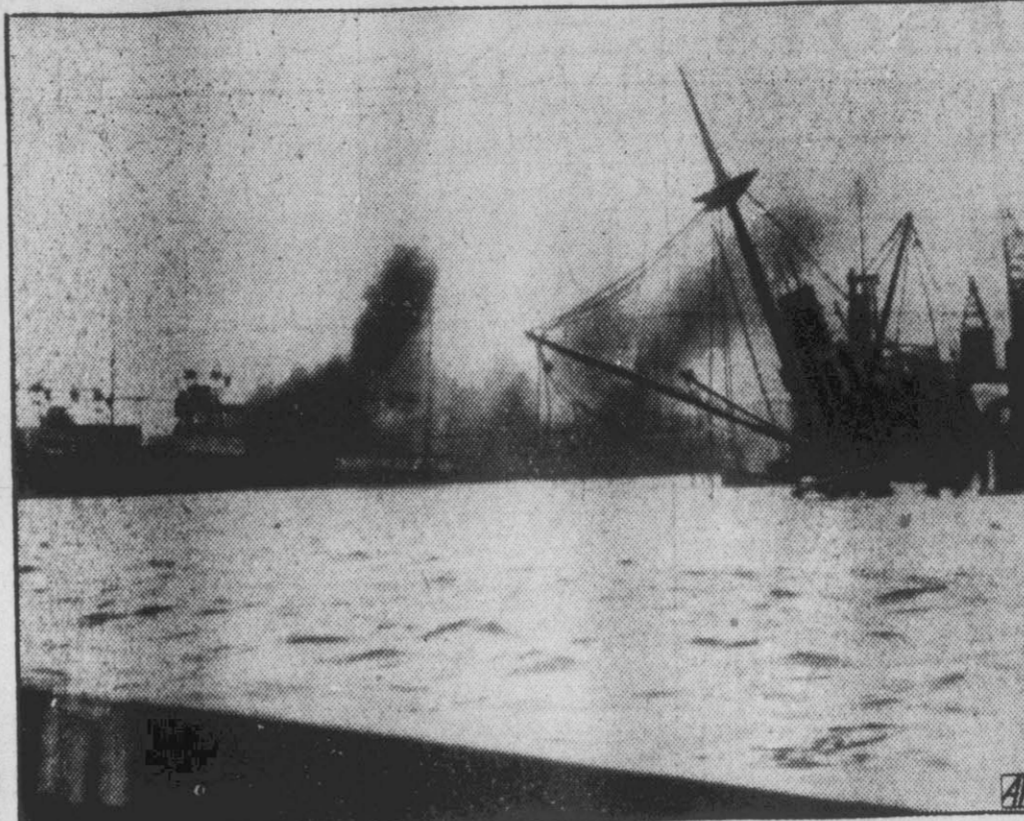

Washington Daybook

By Preston Grover

Washington—The President's it-
inerary indicates that the only spot
on his westward trip where he
could begin a "purge" of reluctant
Senators is in Colorado against
Alva Adams, and from there and
from here we get reports hinting
that peace, not purge, is in prospect.
His appearances elsewhere are in
states where definitely pro-New Deal
Senators are up for election.

Repeatedly Senator Adams has
been listed by observers as among
the conservative Democrats, al-
though the record of his votes does
not show him altogether in that
light. Nevertheless, when the Pres-
ident first roughly outlined his
western trip to include Colorado,
the Adams camp deemed it omi-
nous.

But in between the time of the
announcement of the trip and the
actual start, the President deliv-
ered his fireside talk. He promised
to take part in the primaries where
he felt there were "clear cut"
cases involving conservatives and
liberals. He would be, he said, for
the liberals. Moreover, he said he
would judge the liberal attitude
by the long-time record, and not
on the basis of just one vote.

A Conservative—But
That reference to just one vote,
Adams supporters were prompt
to point out quietly, brought the
Colorado Senator within bounds.
He had opposed the reorganization
bill. Outside of that he had voted
for most major administration
measures. He never was publicly
committed on the court revision
bill until the final defeat when he
joined opponents and several ad-
ministration leaders in voting to
send it back to committee.

Regardless of this record, how-
ever, Adams was invariably listed
here as on the conservative side.
Such polls as were published dur-
ing the court fight usually listed
him either as opposed to the bill
or at least doubtful. His position
was such that Colorado politicians
were not surprised when an op-
ponent came out in the primary
campaign with 100 per cent New
Dealism as his major talking point.
It was Benjamin C. Hilliard, 70-
year-old member of the Colorado
Supreme court.

Looking for Boundary
But word from Colorado sources
is that Adams' supporters now
are confident that the President
will not speak against the Senator
but instead may put in a word for
him.

In any event, such are the me-
chanics of the Colorado nominat-
ing machinery that the man with
organization support has an inside
position. Adams appears to have
that.

Whatever action the President
takes, the Colorado situation prob-
ably will be the most closely
watched of any on his tour. He is
certain to speak out for Senator
Barkley of Kentucky and Senator
Thomas of Oklahoma, in whose
states he is listed for formal talk.
There is no question about their
100-per centism.

Should he choose to speak for
or against Senator Adams, or per-
haps take no purging action there-
whatever, it would help observers
to find the boundary between those
the President classifies as liberals
and those he hopes to see elimi-
nated.

SHORT SHOTS

Raleigh, July 8.—Progress and de-
velopment from the wild to the civil-
ized state is generally the goal of
most public activities nowadays, but
in at least one instance the aim and
object of federal conservation and
development folks is to return a size-
able region to the days when it was
covered with a forest primeval.

On Hatteras, the Park Service has
planted thousands of acres of sand
bar in tough grass, anchoring the
shifting sands. It has also erected
several miles of brush fence desig-
ned to build up the beach.
The idea is this: When Sir Wal-
ter Raleigh's men first sighted the
shore, the Outer Banks were thickly
wooded, and it is hoped to return
the banks to their aboriginal state
as the government lays plans for its
great National Seashore.

North Carolina paid out a grand
total of \$13,632,894 on its debt serv-
ice during the fiscal year which
ended June 30, according to State
Treasurer Charles M. Johnson.

The bonded debt was reduced by
paying off \$6,924,000. Interest
charges amounting to \$6,708,894
were paid.

Of the bonds paid off, \$2,599,000
were due July 1, and the treasurer
sent a check to New York for this
amount several weeks in advance,
of the due date.

Farm and Home Week at North
Carolina State College has been set
for August 1 to 5. Many features

special courses have been mapped
out to suit all sorts of tastes.

ing.

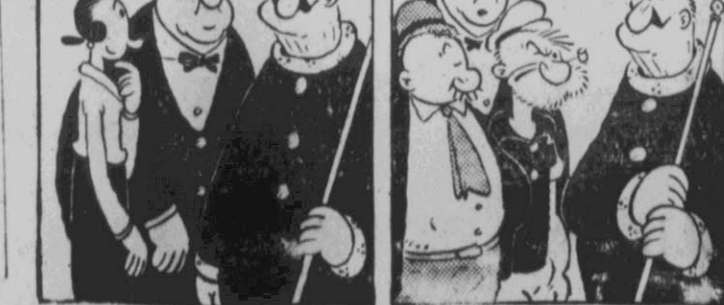
Funny At The Time

ORDINANCE AUTHORIZING \$37,000 BONDS FOR NEW WATER AND SEWERAGE SYSTEM FOR TOWN OF WINTERTVILLE, NORTH CAROLINA

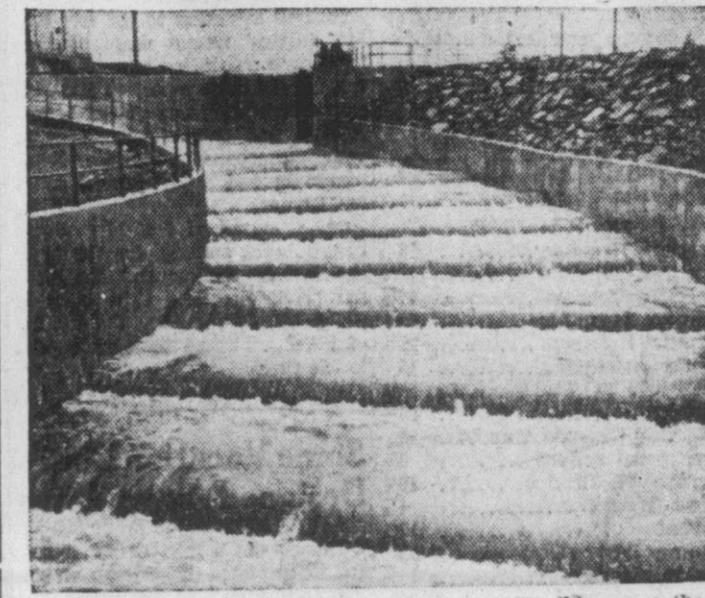

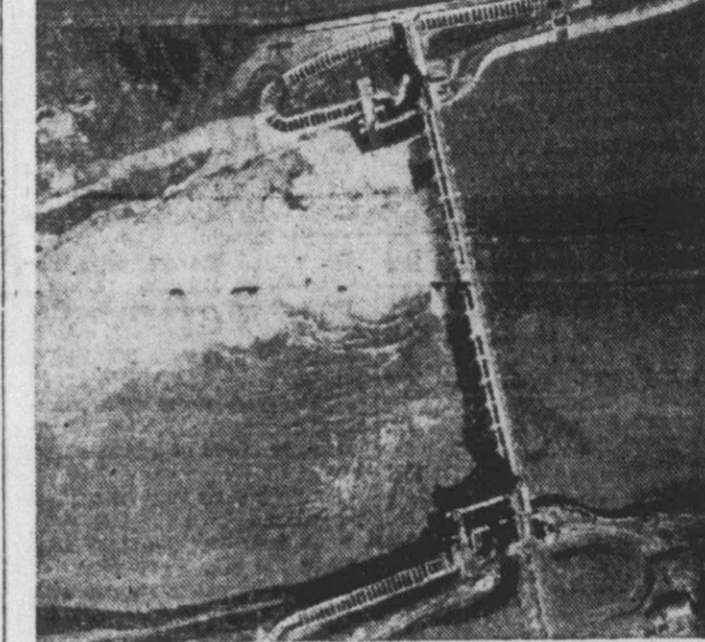
Fish Climb Ladders Like Firemen, First Tests At Bonneville Dam Show

By SAM JACKSON (AP Feature Service Writer) Bonneville, Ore.—The United States government is solemnly on record that fish can climb ladders, and on the correctness of that belief depends a \$10,000,000-a-year industry.

The tests have gotten under way at giant Bonneville dam.

For uncounted centuries salmon have been ascending the Columbia river once a year to lay their eggs. In the upper reaches of the stream the tiny salmon hatch and grow into fingerlings.

Then they descend to the ocean and a goodly number are eventually caught and find their way to America's dinner tables.

Salmon leap up catarracts in their annual migration, but they can't hurdle Bonneville dam. Consequently the government designed "fish ladders"—great, curving aqueducts connecting the upper level of the dam with the stream below. The ducts are 40 feet wide and the ascent is made by means of a series of little waterfalls each one foot high.

Early Fish Untroubled Whether the salmon would enter these artificial waterways, and whether instinct would make them leap up the series of man-made waterfalls, has been a subject of argument among sportsmen. Now the salmon run has started.

"We anticipate no difficulty whatever from this source," says Captain Colby M. Myers, acting district engineer at the dam. "A portion of the fishway system has been in operation since the middle of February.

"The fish that have appeared have passed with no difficulty and no evident delay in finding the fishway entrances."

Johnson Says He's Taking No Part In Speakership Race

Raleigh, July 8.—Taking belated notice of reports published through this bureau, Robert Grady Johnson, director of the penal division of the State Highway and Public Works Commission, today declared he has not taken any part in the campaign now under way for Speakership of the 1939 House.

(As a matter of fact Adkins was categorically cited to your correspondent as the Johnsonian emissary particularly active for Bryant.)

"As a matter of fact Mr. Adkins hasn't been working for me since the first of the month," continued the penal director. (The story to which Mr. Johnson was making de-
nial was published some time prior to the first.)

- Don't make fast the main sheet.
- Don't jibe in a heavy wind.
- Don't be afraid to shorten sail.
- Don't attempt to carry sail thru a thunder squall.
- Motor boats have particular hazards.
- Don't take chances with fire and explosion.
- Don't tolerate an installation which lacks modern safeguards.
- Don't allow gas or oil in the bilge.
- Don't forget your wake can damage others.
- Don't operate near swimmers in the water.
- Violation of these ordinary precautions can bring disaster.
