GOV. CHANDLER IS CRITICIZED BY ROOSEVELT

FDR Says He Was Placed in Disagreeable Situation

SEAT IN SENATE BEHIND WRANGLE

Chief Executive Says Chandler Wanted Him to Traffic in Appointments

Washington, July 9.—(AP)—President Roosevelt has accused Governor Chandler of Kentucky of placing him in a "disagreeable situation" by proposing that a way be cleared for Chandler to run for the Senate.

The Governor, Mr. Roosevelt said in a letter to Senator Logan (D-Ky.), wanted him "to traffic in judicial appointments," a proposal which he said put him, Logan, and Senate Majority Leader Barkley of Kentucky "into a most disagreeable situation and wholly without any cause therefor."

The letter, given out by Logan's associates here today, was dated February 1. It was written shortly after Logan had announced he would not resign from the Senate to accept a judicial appointment.

His resignation would have opened the way for Governor Chandler to run for his Senate seat. When Logan did not step out, Chandler announced in opposition to Barkley. Yesterday the President, in a speech at Covington, Ky., endorsed Barkley's candidacy by citing his record in Congress in a lengthy and laudatory manner.

Just before the President's letter to Logan was given out today new charges of political activity by the WPA in Kentucky in behalf of Barkley brought a complete denial from Harry Hopkins, administrator of the works agency.

Senator Vandenberg (R-Mich.) wrote Hopkins asking about a distribution of groceries or other commodities in a large paper bag bearing the name of Senator Barkley, candidate for re-nomination.

Vandenberg had sent Hopkins a photostatic copy of a bag which bore the legend "paper bag donated by friends of Senator Alton W. Barkley."

Hopkins said that an "unnamed friend" of Barkley had supplied the bags to a general store across the street from the WPA commodities distribution center in London, Ky., where they "were handed out to anyone who asked for them to be used for any purpose that they might see fit to put them."

Meantime the President's first address on his western tour dispelled any doubt for capital politicians as to the vigor of the campaign he intends to wage for a clear-cut political division of "liberals" and "conservatives" as he defines them.

In Ohio and Kentucky he made sharply clear that he would like to have Senators Bulkley and Barkley returned to Congress because of their support of administration measures.

Welfare Official Praises CCC Work

K. T. Futrell Declares Camps For Boys Best Work Being Done by Govt.; 25 Sent from Here

K. T. Futrell, Pitt county welfare officer, today took occasion to praise the work being done by the CCC camps in announcing that 22 white and three Negro boys from this county were sent to camps during the July enrollment period.

"In my opinion it is the best work the government is doing," declared the welfare officer. He added it provided a stepping stone for ambitious boys, in addition to providing their dependents with \$25 monthly. The boys themselves are allowed to keep \$5 monthly and also are paid additional for outstanding work.

The 25 Pitt boys were enrolled at Washington, N. C., and will be located at camps in this state.

Mr. Futrell said three numerous cases where the camps had made men out of shiftless boys. He cited one case where "one of the widest boys in his community stayed at the camps for a while and returned and now is manager of a reliable concern, and added there were plenty more similar cases.

The second annual Pitt County Farm Tour, covering 107 miles with approximately 50 farm men and women participating, was even more successful than the 1937 tour, declared R. R. Bennett, farm agent today.

There was an average of 15 cars with 65 people participating throughout the entire day.

The group enjoyed roasted peacans and lemonade at Mrs. Leon T. Hardee's and an ice cold bottle of sweet milk at J. T. Thorne's. The men, as well as the women, were interested in the comfortable homes with modern conveniences observed at Mrs. J. Brooks Tucker's, Mrs. Walter Cherry's and Mrs. Clarence Whitehurst's. Mrs. Hardee's lawn and outdoor living room was viewed with much interest.

At J. V. Taylor's the group gave their attention to the new beef cattle barn, ridge method of tobacco cultivation, and hog cafeteria.

D. J. Wilson explained his crop rotation, cotton variety demonstration, and thirty pig demonstration to the tourists.

Marvin Taylor explained his cotton variety tests and the object of cotton seed certified.

Wiley Speight gave an interesting explanation of his tobacco variety demonstration and the object of having his tobacco and cotton seed certified.

At J. T. Thorne's, the tourists evidenced interest in the success he had made with his Services and Kobe Lescpedez for hay. Many of the men and women viewed electric milking machines in operation for the first time.

At Mr. J. B. Tucker's, the group observed a 4-H Club corn project, the results of tobacco and corn following crimson clover, a 4-H Club baby beef project, and a poultry project.

L. T. Weeks, tobacco extension specialist, and K. J. Shaw, who is working on tobacco diseases, of State College, led the discussions at many stops.

TO BRING TRIO BACK TO STATE

Men Wanted for Tar Heel Robberies in Savannah, Ga.

Raleigh, July 9.—(AP)—Governor Hoey has signed extradition papers asking the return from Savannah, Ga., of three men wanted on charges of secret assault with intent to kill, breaking and entering and safe blowing at Red Springs June 25, the governor's office said today.

The papers list the men as Joseph N. Gupton, Franklinton native; Harlan Massey of Texas, and Clint White of Indiana.

Director W. P. Whitley of the Raleigh-Wake County Bureau of Identification, said he understood Savannah authorities had agreed to their return. All three, he said, escaped from a Texas prison May 25 with two other prisoners.

He said Red Springs Police Chief M. N. McRainey was in Atlanta getting the papers honored.

The trio has confessed taking part in the Red Springs and Franklinton safe robberies, alleged to have totalled several hundred dollars in cash and checks, Whitley said.

Red Springs Night Policeman A. J. Breedon remains in a Lumbermen hospital with spotgun wounds he suffered during the night of the recent robbery there.

STATE TO PAY DEATH BENEFIT

Dependants Of Officers To Get Up to \$1,500

Reflector Bureau Raleigh, July 9.—Hereafter the State of North Carolina will pay benefits not exceeding \$1,500 to the widow or other dependents of its officers who are killed while in the actual discharge of their duty. George Ross Pou, Chairman of the Committee for the Administration of the Law Enforcement Officers' Benefit Fund, said today.

The State Auditor was named chairman of the group which was authorized by the last legislature to make a study of the matter and devise some plan for payment of benefits in cases where officers are killed or seriously wounded on duty.

So far no regulations have been adopted except for death cases, but Mr. Pou has written a circular letter to all state sheriffs and chiefs of police to all state asking that they furnish him with a complete roster of their forces. The sheriffs and chiefs are also being asked to send in monthly statistics on such officers as may be killed or seriously wounded.

Benefit regulations approved by the Governor and adopted by the committee are:

To widow of deceased officer, or other nearest relative if no widow survives, for funeral expenses, \$300.

To each dependent child under 18 years old \$100.00.

To each dependent son or daughter over 18 and physically or mentally incapable of making a living, \$100.00.

To the widow, \$500.

If no eligible widow is living, then the sum of \$500 may, in the discretion of the Committee, be paid pro rata to the children; if there be no children, then to the surviving parent or parents; and if no parent or parents, then to a surviving dependent brother or sister under 18.

Total benefits shall in no case exceed \$1,500 the regulations provide.

BOARD FAVORS NEW PROJECTS IN GREENVILLE

Approves City Hall, Fire Stations, Street Dept. Yard

RESOLUTION YET TO BE PASSED

Total Cost of \$210,000 Would be Divided \$115,500 by City --\$94,500 by FWA

Proposals to erect a new municipal building, a central fire department station with a sub-station in the residential section of the city, and a street department yard, provided a PWA grant can be secured and the citizens favor the issuance of bonds for the projects, were approved at a called meeting of the Greenville Board of Aldermen last night.

The projects have been under discussion for some time, but last night's action was the first official step taken. The meeting was called in order that George A. Snyder, architect of Frank W. Benton, architect of Wilson, could discuss in detail plans for the various projects. The session was called by Mayor Pro Tem L. B. Fleming, in the absence of Mayor M. K. Blount.

The regular monthly meeting of the board, postponed from last Thursday night, is set for this coming Thursday, at which time a resolution probably will be passed calling for a bond election to determine if the citizens desire to borrow money to provide 55 per cent of the total cost. An application also probably will be forwarded to the PWA for 45 per cent of the funds. It is the opinion of board members that there will be no difficulty in securing the 45 per cent outright grant from the federal government.

If the board passes the resolution calling the election it will be necessary to wait 30 days before holding the election.

The undertaking would be one of the most extensive ever started in Greenville. The total estimated cost of the projects would be \$210,000, of which \$94,500 would be contributed by the federal government.

Last night's discussions brought in the public for the first time the proposal to discard the old fire station and erect a new one near the business section of the city. It was the idea at first to use the old fire station for the central department and construct a sub-station on Dickinson avenue. The newest plan is to move all the city departments from the present site, the police station, will be located in the proposed new municipal building, and sell the entire city plot on Fifth street. By doing this, it was pointed out, the city would get the full receipts from the sale while federal funds would be used to help pay for the new sites. Of the 210,000, \$43,000 would be used for the two fire department stations.

The proposed municipal building would cost approximately \$125,000 and would be located on a site to be determined later. There is some talk of locating it at the present site, but the board passed a resolution at a previous meeting instructing a committee to proceed with investigating the possibility of purchasing a new plot. At least three places have been mentioned. They are the Flanagan property on Evans street, next to the liquor store, the Stokes property on Washington street, between Second and Third, and across from the county property.

Latin-American Nations Open Doors To Refugees

Other Nations, However, Reject Mass Immigration

Evian-Les-Bains, France, July 9.—(AP)—Three Latin-American nations offered today to open their doors to German and Austrian refugees after other countries had told the Evian conference they could not permit mass immigration.

Mexico pledged "asylum to foreigners who are afraid for their lives" and promised opportunities for them to work.

The Dominican Republic promptly followed suit, as did Peru, the latter making an exception, however, of refugee intellectuals.

V. T. Molina, Dominican delegate, announced both agricultural and professional men would be accepted. He said large areas suitable for farming were available and the West Indian republic would provide seed and technical advice.

Garcia Calberon, Peruvian delegate, said Peru would welcome farmers and all agricultural workers, but would "place restrictions on lawyers, doctors and other professional immigrants."

Moderate selected immigration would be helpful to Peru, he said, but the nation would not compromise its national stability.

The Mexican delegate, P. V. Michel, told the conference "our collaboration will make it possible to carry out the migration of refugees from Germany and Austria in an orderly manner at the rate appropriate to each country's requirements and possibilities."

WHAT IT MEANS: The Wheat Crisis

By MORGAN M. BEATTY (AP Feature Service Writer) Washington—The year 1938 is all set to go down in history as the eighth year of the great American wheat crisis. It marks another year of America's reluctant retreat from the world wheat market—a retreat that began to take a definite trend in 1930.

All the big wheat-growing nations of the world are raising good wheat crops this year. It begins to look as if they will pour four billion bushels of the golden grain into the world's bread basket. Four billion bushels is 900,000,000 bushels too much wheat.

Trade Would Help True calamity could overtake part of the crops. Bugs or disease could do a lot of damage. Or a war could come along. In that event cautious nations would store wheat. But it's doubtful that these things will happen. The best thing would be a revival of world trade.

PARAGUAY AND BOLIVIA SIGN PEACE TREATY

Agree to End Century-Old Fight Over Gran Chaco

PACT NOW GOES TO GOVERNMENTS

Accord Calls For Determination Bolivia-Paraguay Border by Arbitration

Buenos Aires, July 9.—(AP)—Foreign ministers of Paraguay and Bolivia adopted and sealed with a kiss today a preliminary accord to end the century-old territorial fight over the almost worthless Gran Chaco border area.

The agreement must now be submitted to the two governments for final approval, whereafter mediators of six countries who have tried since 1935 to keep Bolivia and Paraguay from warring again over the "green hell," hope for a final treaty which can be signed in five or six days.

The accord is to determine the Bolivia-Paraguay boundary through arbitration.

The precise formula of the agreement was withheld, pending formal approval by the two governments, but information from reliable sources indicated its main part was that Bolivia and Paraguay agreed a zone varying from 12 to 50 miles through the Gran Chaco was subject to arbitration.

After the initiating ceremony, which followed a three and half hour session of the Chaco peace conference in the foreign office here, 76-year-old Foreign Minister Medina of Bolivia and Paraguayan Foreign Minister Bass embraced warmly.

S. Hraden of New York, United States representative, and delegates of Argentina, Brazil, Chile, Peru, and Uruguay also put their initials on the document.

Japanese Beetles Not Found in Pitt

County Agent R. R. Bennett said today so far as he has been able to learn no Japanese beetles had been found in this county.

Traps for the beetles were scattered throughout the county recently for the purpose of determining whether any were in this section. The traps also were distributed in other sections of the state.

Mr. Bennett said that not a single report of any beetles being found in this county had been made. The traps are checked by officials of the State Department of Agriculture.

Dan Cupid Set Back Following Holidays

Dan Cupid suffered a setback this week, following the July Fourth holiday, only two marriage licenses having been issued here this week up to today.

Alf A. Forbes and Carrie Evans, both of Greenville township, was the only white couple to secure a license. One colored couple, Lee Lay and Sarah Spell, also of Greenville township, secured a license.

Negro Youth Accused Of Robbing Laundry

Bernon Williams, 17-year-old Greenville Negro, was arrested last night and is being held in the city jail on a charge of breaking, entering and larceny in connection with the robbery at the Eureka laundry earlier in the night.

The Negro is alleged to have stolen \$3.70 in cash from the establishment, of which D. D. Overton is manager. He probably will be tried Monday in city recorder's court.

No Church Services At Immanuel Baptist

The regular 11 o'clock church services at Immanuel Baptist church will be dispensed with tomorrow morning, the pastor, Rev. Clarence Patrick, having gone to the Kiwanis International convention in San Francisco.

Better Business Ahead Babson Says June Saw Turning Point Of The Recession

By ROGER W. BABSON Omaha, Nebraska, July 9.—Business has finally hit bottom and is bouncing back. Conditions have improved sharply in the last several weeks. Sentiment has changed almost overnight. Sensitive business barometers have risen vigorously. They forecast that the turn has been made. Business should now continue to pick-up very rapidly, at least until Election Day. Everyone should be cheerful and happy over the events of the last few days. Had the recession of 1938 continued at the rate it was traveling in recent months, the only result could have been economic chaos in the United States. Business today is nearly five per cent higher than a month ago. It reached 28 per cent below normal on the Babsonchart at the bottom of the dip compared with minus 40 per cent at the extreme pit of the old depression. Today, it has recovered to 25 per cent under normal and is rising weekly. While we have had several false starts in this recession, I am convinced that this one is the real turning point. The other temporary pick-ups were not preceded or accompanied by the traditional signs of an important change in the business trend. This current turn has come with most familiar barometers forecasting better times ahead. Here are some of the most important of these indicators:

Barometers Confirm Them 1. BOND PRICES have been slowly edging forward in recent weeks. Such a rise ordinarily indicates that investment cash is piling up and the temptation to accept handsome yields on good bonds cannot be overcome any longer. Hence, bond investing increases, prices rise slowly, yields fall, and buying power spills over into stock market barometers. (Continued on Page Four)

Unable To Find Cure For Election Fraud Cancels

Reflector Bureau Raleigh, July 9.—North Carolina's political doctors—maybe they should be called physician-politicians—seem to be of many minds about the epidemic of election fraud cancers which have been discovered on the state's body politic this hot summer. Certainly they express almost diametrically opposite views on the best remedies and preventives. Certainly it is obvious to all concerned that something should be done about conditions which give rise to the almost innumerable cries of thievery and skulduggery which have arisen in all quarters after both the first and second primary votings. But taking at random three opinions which have been voiced by prospective members of the 1939 General Assembly, it will be noted that they are far from agreed on what should be done. Representative John Caffey of Guilford, for instance, says the absentee ballot law should be repealed. Representative J. B. Vogler of Mecklenburg declares that to repeal the absentee ballot law would work a hardship on many voters. He proposes to make the absentee law "foolproof" but is more than a little vague in details of how that is to be done. Senator-nominate John W. Umstead, of Orange county, thinks the chief trouble with the present law is to be found in the provisions allowing "markers" and permitting solicitation of votes near the polls. And there you are—three doctors three remedies. Grand juries in one or two sections seem to have hit upon what perhaps the best way to clean up the entire mess—namely, put a few violators of present laws behind the bars. It apparently never has been done in North Carolina, certainly not on any big scale. It might work at that.

Colored winter coats—fashion orphans for the last few years—will come back to Fifth avenue and Main street this fall if the coat and suit division of the Fashion Originators' Guild of America has its way. The 12 designer-manufacturers of the division defied midseason emphasis on black by staging an entire coat and suit fashion show in one color—"rural autumn"—a rich red rust. Although all of the models shown were in one shade, the division pointed out that this particular hue was not to be regarded as one of outstanding significance. The point of the display was not the importance of this particular color—but the accent on color—in coats.

The show was part of a concerted effort on the part of American designer-manufacturers to put "pep" in fall fashions and give lagging business a shove. Business in coats reached its peak in the days when women wore colored coats, the division spokesman said. In the past few years smart women by the thousands have chosen black or somber coats which can be worn over dresses of many different shades.

The coats shown in the display included both fitted and straight box models, ranging all the way from luxurious afternoon wraps to sports clothes. They were designed with both large and small collars and furred in a great variety of pelts including kolinsky, beaver, blue fox, gray and black Persian lamb. They reflected both sparing and lavish use of furs. A number of them were worn over frocks of the same hue. Their diversity emphasized the fact that designers are concentrating on color instead of design in this display which preceded regular fashion showings. Stylists watched the show with interest, but none hazarded even a guess as to how strong its influence might be in stimulating a vogue for color which might jar the fashion supremacy of black.

Two colors which are receiving much consideration in the fashion world this fall are win and grape. Purple plum is regarded as a like "high style" hue. Deep laurel green, slate blue and brown are also discussed as colors of some importance.

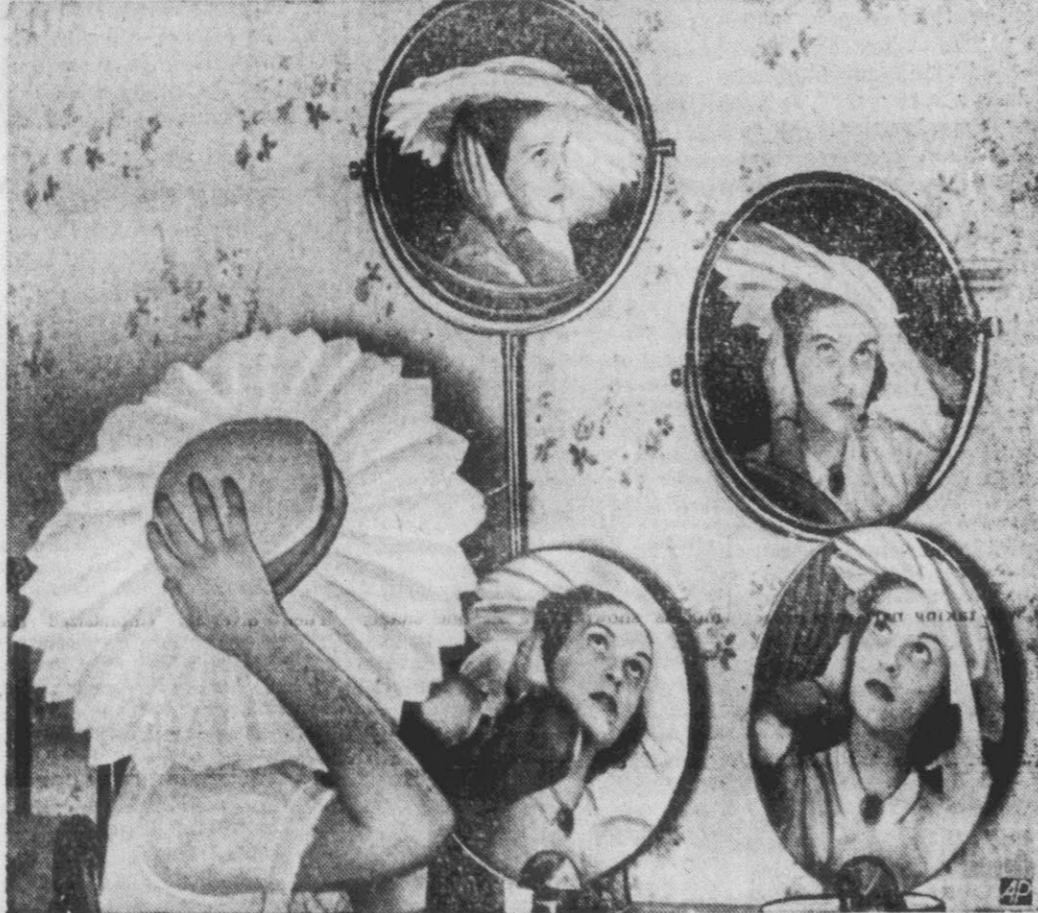

Washington Daybook

By Preston Gruber

Washington—Every time a destroyer slides down the ways it launches 100 or more officers and men on one of the most romantic but hazardous jobs in the navy. Destroyers are those trim little ships about 300 feet long, sleek as a yacht, but in wartime loaded with concentrated hell both for the crew and the enemy. They are the patens in every naval engagement, sacrificed to save the bigger ships or even to force a change in the course of the enemy fleet.

Like Hunting Sharks. Although the public interest neglects them, the Navy doesn't. When destroyers, life on the big boats would be as hazardous in time of war as it is for the destroyers. They are the high assignments of chasing down enemy submarines, which is something like swimming around in the ocean hunting sharks. Somebody has to take the subs out of the line and the job falls to the destroyers. They are fast doing 35 knots compared to 21 to 25 for battleships, and they can spin around almost on the crest of a wave.

Valvry of Sea. The destroyers act as supplemental anti-aircraft defense at all times but particularly for the airplane tenders. Each destroyer has at least eight five-inch guns capable not only of shooting at surface craft but of swinging high into the air to hurl explosives at enemy planes. They must lay smoke screens, and while doing it are as visible to the enemy as a freight train on the horizon.

Their siddest job is in combined fleet actions, where the whole warship family meets the enemy family for better or for worse. Suppose our own naval commander finds it necessary to turn the enemy fleet in a given direction. He sends the destroyer fleet full into the face of the heavily armed battle fleet. The destroyers let go with torpedoes, and the enemy fleet must turn as intended or face destruction. It is tough on the destroyers. They have no armor and their sides are as thin as paper as compared with other war craft. The navy calls them "cans." At their first rush the enemy fleet tries to smash them to prevent launching of the torpedoes. Half of the destroyers may be blown up—and they go down like rocks, for their hulls are loaded with power machinery, torpedoes, and the mechanism for launching them.

LITTLE BROWN JUGS USED TO TEST MOISTURE St. Paul—(AP)—Souvenir counterparts of the "Little Brown Jug" the famed trophy of Minnesota-Michigan grid battles, are aiding foresters in producing vigorous tree seedlings essential to successful reforestation.

The little jugs usually sold at Gopher-Wolverine games, are an essential part of a forest nursery moisture meter developed at the Lake State Forest Experiment station to determine soil water conditions. The unglazed jugs are placed in the ground about five inches deep, or in the zones of maximum root development of seedlings, and filled with water.

Passage of water from or into the somewhat porous jug, caused by an increase or decrease in ground moisture, indicates through variation in the height of a mercury column whether the ground is "dry," "fresh" or "moist."

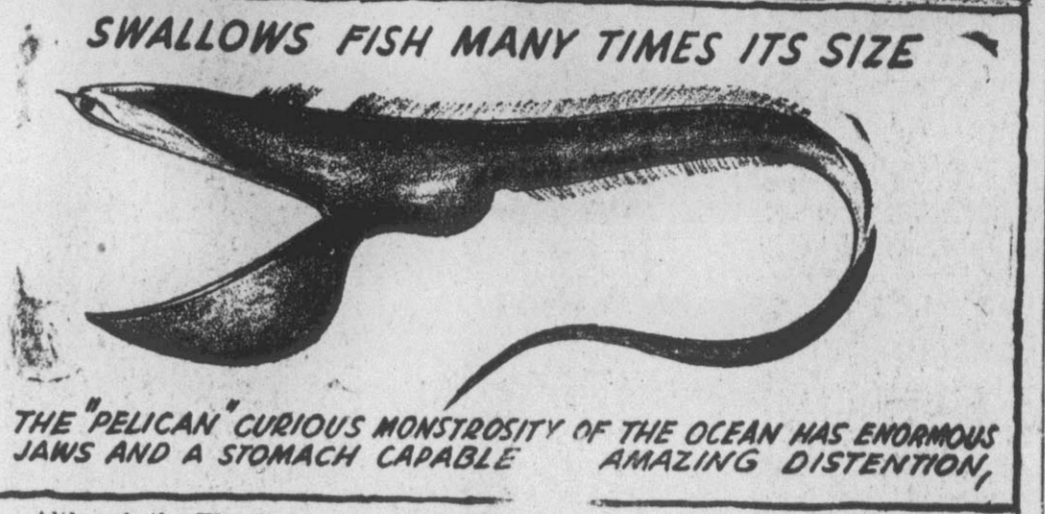
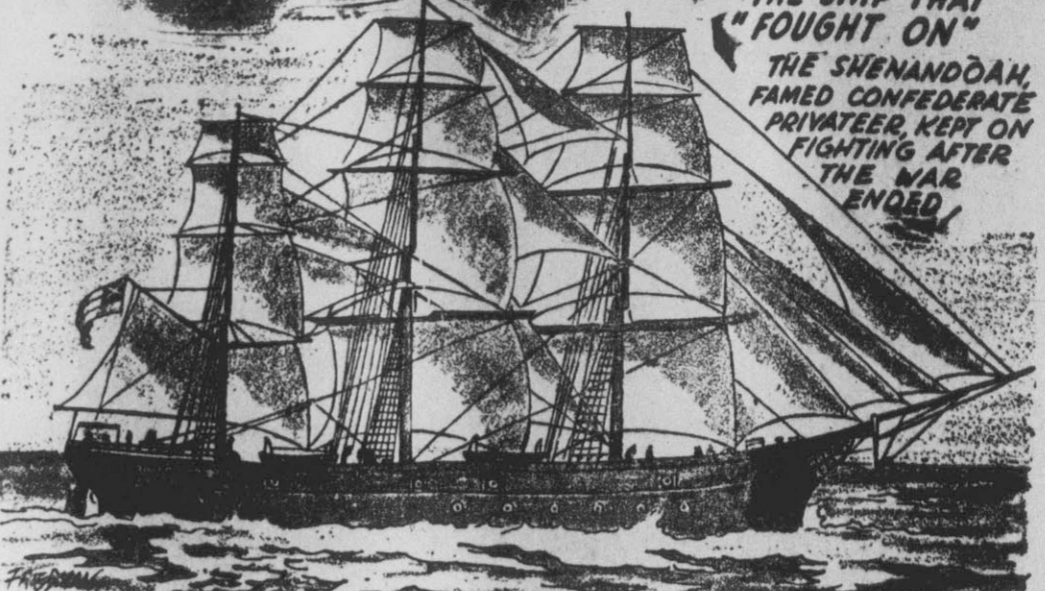

Although the War Between the States virtually ended April 9, 1865 with the surrender of General Lee at Appomattox, it was not until the 29th of June, 1865 that Waddell commander of the SHENANDOAH, learned of the final capitulation of the Confederacy. During all that interval of time, the Shenandoah, famed Confederate privateer, was unknowingly "without a country", and continued to make war upon Federal commerce! Because a great many captures were made after the close of the war, Captain Waddell and his officers were actually accused of piracy on the high seas, but were never molested. With one exception, the Shenandoah inflicted more injury to U. S. commerce than any other ship.

BETTER BUSINESS AHEAD

(Continued from page one) Gains. Moreover, volume of new security financing has been moving higher for several months.

2. STOCK PRICES are up about 30 per cent since their extreme lows several months ago on March 31. The market traditionally turns upward or downward two or three months before the business trend changes. Moreover, history shows that when stock trading dries up to 10 per cent or less of the peak volume of the previous bull market, the turn in business is about to be, or has just been, made. The volume signal was given on June 8 when, with one exception, trading hit the lowest level in 20 years.

3. WHOLESALE PRICES as a whole are not sensitive indicators. Certain raw materials, such as hides, steel scrap, wool, silk, lead, zinc, and export copper, however, are extremely quick to mirror the change in the basic business trend. Recently quotations on nearly all of these commodities have jumped spectacularly. All the other false upturns since the Recession set in over a year ago have taken place while sensitive commodity prices were slipping to lower levels.

4. INTEREST RATES were perhaps the most famous of all revival indicators in the old days. But now rates on bankers' acceptances, commercial paper, and the like, are frozen at ridiculously low levels. Rates charged to customers, however, still have a semblance of a free market and are, therefore, an indicator of business conditions. These rates for different sections of the country all touched their lows in February and March and since then have stiffened.

SEVEN INDICATORS CONFIRM THEM

- 1. Bond yields are falling; security financing is higher. 2. Stock prices and trading volume have leaped upward. 3. Sensitive raw material prices advance sharply. 4. Interest rates charged banks' customers stiffen. 5. Bank deposits have been mounting for months. 6. Steel operations and scrap prices jump impressively. 7. Wholesale cloth buying means merchants are restocking.

These vital trends can give business a great forward push this Fall. The sharpness of the Recession drop may, I believe, be equalled by an almost vertical upswing. There is no financial debris to clean up after this Recession as there was after the 1929-32 debacle. People have lost money, but few have been ruined. slanted downward last year and they have been steadily increasing since last December. Meanwhile, commercial loans have been falling for months. This indicates that inventories have been steadily reduced.

6. STEEL OPERATIONS are a sensitive barometer of industry. They rise and fall with business activity more closely than 90 per cent of the other industrial indexes. Since early June, operations have improved modestly. Meanwhile, steel scrap prices, almost an infallible forecaster of steel operations, have jumped more than 20 per cent.

7. COTTON CLOTH SALES are the favorite "caller of the turn" for many observers. Cotton cloth is representative of the inventory situation. When cloth purchasing starts vigorously, it means that inventories must be replenished. Therefore, it is highly significant that in the last few weeks sales of print cloth have far outstripped production. Moreover, inventory buying has already spread into other textile lines and into the hide, leather, and shoe markets.

There are many other indicators which I could cite to back up my optimism. However, I have listed the major signs of the turn. Just as important, of course, are the factors which will keep the business machinery going now that it has started again. Among them are:

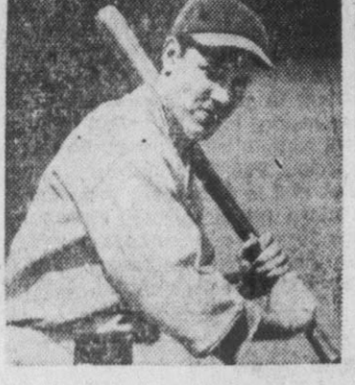

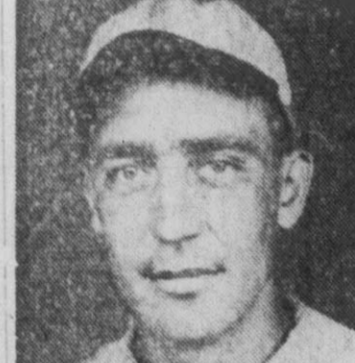

Attorney - General To Rule Whether Badge Is Uniform

Question Coming Up After Motorist Declined to Show License to Officer Without Uniform

Raleigh, July 9—Attorney General Harry McMullan and his competent staff of assistants are gravely, and bravely, preparing to grapple with the serious problem of whether an officer's badge constitutes a "uniform" within the meaning of North Carolina statutes for some cases made and provided.

The question hasn't reached them officially—not yet; but it is reported to be on its way from Durham, via and through the office of Major Arthur Faulk, commanding the state Highway Patrol.

It seems that an A. B. C. officer over in Durham the other day went a-searching for liquor and bootleggers—as ABC officers are want to do.

He stopped a suspect, apparently found no liquor and then demanded to see the driver's license of the chap driving the car suspected to have contained a load of illicit booze.

The driver demanded to know "how come" he must show his license, refused to do so; and finally wound up in the hoosegow charged with obstructing an officer, resisting arrest and maybe three or four other things.

Arraigned at the bar of justice—in this case in the recorder's court of Durham—the defendant came of triumphant, the recorder ruling that North Carolina's uniform driver's license law requires a motorist to show his license only to an "officer in uniform" so reads the statute in words and figures.

ABC people think such a ruling seriously handicaps their men, who do not wear uniforms, but for whom official badges are standard equipment. They want a ruling—have started on the way to get one.

Nobody in the Attorney General's office is talking for publication, in view of the fact the request hasn't been received; but it's a safe bet that the ruling will be Solomonlike in its wisdom, to-wit: It will decide that "in uniform" means just that and without equivocation; but at the same time it will be pointed out that under the general power of peace officers, any officer, in uniform or not, can ask reasonable identification and check on suspected law violations.

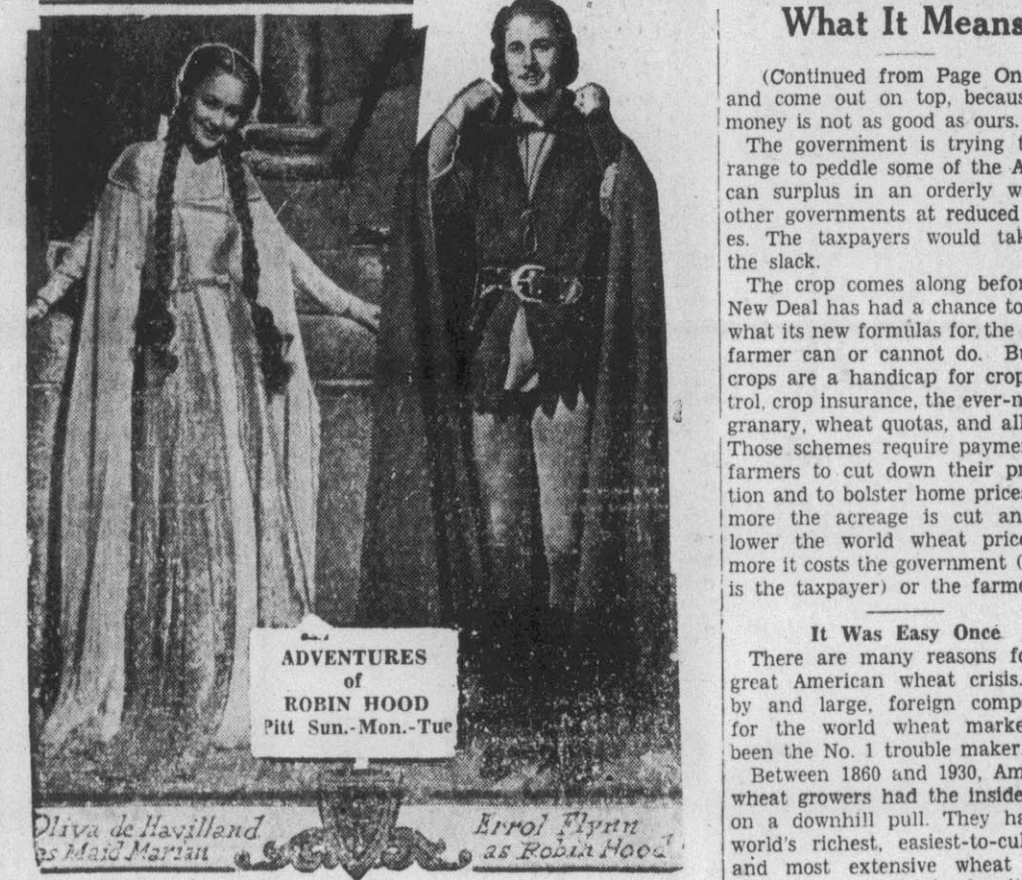

Muncie, Ind.—(AP)—A raccoon in a gunnysack and about 100 keen-nosed dogs give Muncie sportsmen something new on which to bet.

It's a mile race along a "coon-scented" trail. Trails are made by dragging a raccoon in a burlap sack over field terrain. Sharp angles are included for benefit of the "slow but sure" dogs. The faster hounds overrun the trails and lose time getting back on the scent.

About a block from where the 'coon is chained, two judges stand at the sides of the trail and the dogs must pass between them to qualify for prizes.

more and more wheat to make bread for the homefolks. But even so, America still had one-fifth of the world's export wheat market in 1929.

But all along, Canada, Australia, Argentina and Europe's Danubian basin were closing in. For instance, Canada contributed a mere 20,000-000 bushels to the world in 1900. In 1936, she exported 12 times that much.

Tariff Walls Go Up

And as if to complicate an already cockeyed situation, Uncle Sam was constantly raising his tariff walls. Then a few years after the World War he stopped lending money to European nations. These things cut off from foreigners the supply of money they had been using to buy American wheat. Then other nations began raising their own tariff walls in the late 20's.

The drought years — 1933-37 — knocked the American farmer out of the world market. True, he had a piece of good luck in 1937. A wheat shortage in other big exporting nations handed him 18 per cent of the world market, which meant the sale of around 90,000,000 bushels.

But 1938 is a different story. The American farmer planted 80,000,000 acres to wheat, close to a record. This time he guessed wrong. There is no wheat shortage abroad.
