BILLS OFFERED TO AMEND N. C. ELECTION LAW

Four Measures Sponsored by State Elections Board

WOULD LICENSE ALL ROADHOUSES

Flanagan Appears Before Committee Considering Taxation of Slot Machines

Raleigh, Jan. 24.—(AP)—Proposals to revise the state's election law held the center of the legislative stage today.

The House got four bills sponsored by the State Elections Board calling for repeal of the present law on absentee voting and substitution of a new statute, splitting of large precincts, a new registration and tightening of laws on markers.

In name also bills to repeal the absentee ballot law as it applies to Polk, Swain, Catawba, Madison, Simpson and Hoke counties.

The joint committee on election laws called a public hearing for tomorrow morning as some two dozen bills faced it.

Representatives Bryant and Polard of Durham introduced a bill to provide for licensing and regulation of all road houses, tourist camps, amusements, dance halls and tourist homes in the state.

Representative Holloman of Halifax sent in a proposal to amend the laws requiring clerks of court to be at their offices between certain hours and on certain days.

The Senate passed and sent to the House the Larkins-Blythe bill to re-write and extend the provisions of the law setting up an officers' benefit fund for those killed or injured in line of duty.

Provision for a voluntary pension plan. Senators also approved and sent to represent a bill to permit county commissioners to dispose of seized tax-paid whiskey by giving it to hospitals or selling it to ABC stores.

This afternoon University of North Carolina officials appeared before the Appropriations committee to oppose proposed tuition boosts and seek larger appropriations.

Railroad representatives and bankers argued before the Finance committee for franchise tax reductions and changes.

A sub-committee of the joint Finance group heard arguments that prohibition by taxation of "illegal" slot machines would allow the operators to be brought back.

E. G. Flanagan of Greenville, a former State Senator who sponsored the present law under which a hearing on slot machines is outlawed, discussed the matter with the committee.

Revenue Commissioner A. J. Maxwell had proposed the tax as he contended that probably 2,000 of the "illegal" machines are in use in the state because police officers are not enforcing the law in some counties.

The committee was also urged by R. C. Holland of Edenton, president of the Peanac Stabilization Corporation, and J. B. Broughton, Raleigh lawyer representing operators of cigarette vending machines, not to adopt Budget Commission recommendations for a license tax on each vending machine in North Carolina.

European Concern Intensified by Insurgent Advances

BRITAIN PLANS OVERALLS ARMY

Workmen Between 18 and 64 Would be Put in 'Reserved Occupations' in War Time

London, Jan. 24.—(AP)—Great Britain announced plans for an industrial "overalls army" of more than 6,000,000 men today as the Insurgents' advance in Spain intensified European concern over what ultimate consequences may arrive from the Civil war.

The Government through the Ministry of Labor called the scheme one of "selective recruitment" by which workmen between 18 and 64 would in war time be placed in "reserved occupations"—the munition, defense and public service industries.

The list takes in about half the male working population of the country, but roughly 3,000,000 are over 45. Only about one in five of men 18 to 25 is affected.

Over 18 are most grades of clerical workers, workmen in the building trades, workhousemen, porters, packers, store-keepers, entertainment groups, salesmen, hotel and restaurant workers and general laborers.

The Labor office pamphlets said the men would be reserved for "armaments, agriculture, textile, essential public service, food manufacture and distribution."

Not placed in the working population eligible for military service. The announcement followed Prime Minister Chamberlain's appeal last night for volunteers in a civil defense army.

The international picture meanwhile was watched intently here.

Trio Sentenced On Mann Act Charges

Norfolk, Va., Jan. 24.—(AP)—Frank Edward Green, Vernon Shaw, alias Vernon W. Burns, and Betty Louise Lewis, convicted in United States District court here last month on four counts of violation of the Mann White Slavery act, were sentenced today by Judge Luther Way.

Green was given two years in the Federal Reformatory at Chillicothe, Ohio. Shaw (alias Burns), a cripple for hire driver, was sentenced to three years at the same place, and Betty Lewis, mother of two children and former operator of an alleged disorderly house, was given 15 months in the Woman's Reformatory at Alderson, West Virginia.

The Lewis woman is also under sentence in the state courts. Judge Way said he understood the state sentence would be suspended.

The defendants were specifically charged with bringing young girls here from North Carolina for immoral purposes.

FRENCH GUARD SPANISH FRONT

Measures Taken In Anticipation Flood of Refugees

Perpignan, France, Jan. 24.—(AP)—France adopted extraordinary police measures along her tense Spanish frontiers today and anticipated a flood of refugees from the Catalan war front.

Primary emergency precautions were taken in an area extending 125 miles inland from the Mediterranean and some distance north from the border.

On all main and secondary roads in that zone Prefect Dikowski established mobile guard barriers which were in addition to posts on the frontier proper, where the guardsmen regularly watched every mountain pass.

Police of every village, forest guards and other local officers in the zone were notified they formed a part of the refugee-watching service.

Three regiments in Perpignan and other nearby garrisons were designated for a secondary guard.

This secondary line was ordered to watch for refugees who might get through the frontier barrier.

Under the prefect's plans, the whole southeastern section of the eastern Pyrenees has been turned into a zone through which refugees must not pass except under guard.

Many Ministries Deserting Beleaguered Capital City

STREETS FILLED WITH REFUGEES

Insurgent Air Raiders Continue Bombing City as Ground Units Near Objective

Barcelona, Jan. 24.—(AP)—Many Government ministries left Barcelona for the north this morning, while the beleaguered capital, pounded by enemy bombs and with its public services failing, became a military camp.

With an icy wind blowing, refugees crowded streets leading out of the city. Bombs crashed from the skies at brief intervals as the Insurgents' air force heavily attacked the city for the fourth successive day.

Insurgents dispatches said Barcelona was under fire of the Insurgents' big guns.

United States officials prepared to send some of their nationals out of the war-torn Barcelona area.

Government departments began withdrawing from the city despite the cabinet's announcement it would remain in Barcelona.

Meanwhile Hendaye, France, reported Spanish Insurgents announced the encirclement of the town of Gava, only seven miles from Barcelona proper, and the Spanish Government's capital was under the direct fire of their artillery.

While General Franco's column, driving along the coast from the southwest, bore down on its objective and Insurgent inland forces converged on the city from the west, Barcelona was being evacuated by Government ministries and the civilian population.

The Government armies, however, remained before the city, defending it to the last.

To reach Gava the Insurgent forces surged up the Mediterranean coast from Tarragona through numerous towns dotting the shore.

Gava is the site of an American radiator company factory taken over by the Spanish Government early in the war.

Insurgent bombers flying ahead of the forces raided Barcelona repeatedly in a campaign evidently designed to break resistance of the Government troops.

Before noon today the city had been bombed six times.

Air raiders flew above the capital, while anti-aircraft batteries thundered almost without ceasing.

Plan To Beautify New Park In City

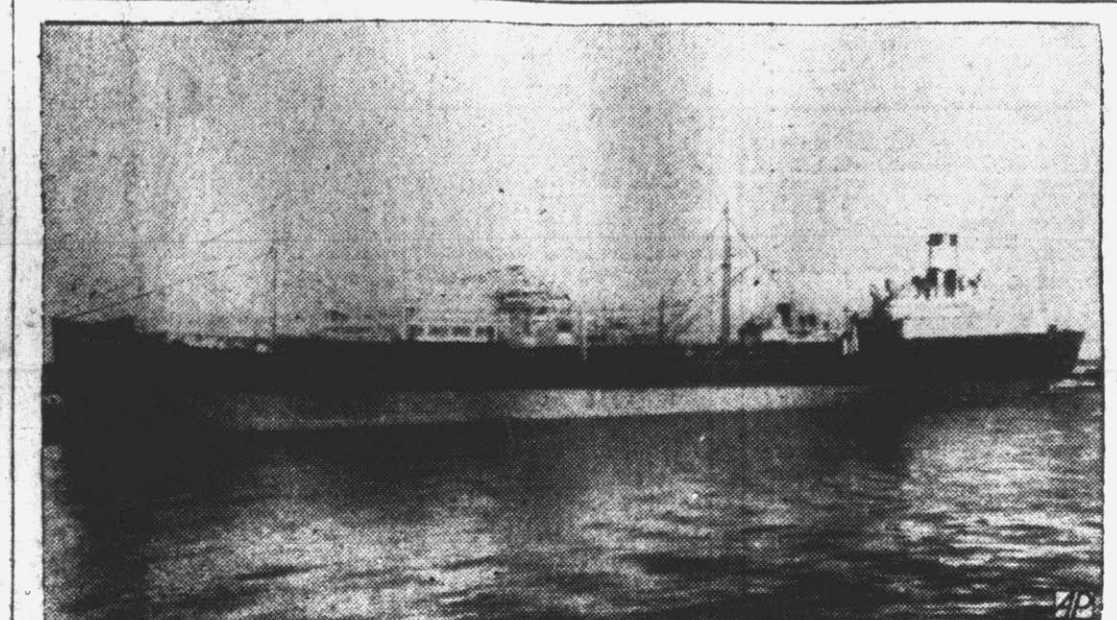
The Project committee of the Greenville Garden club has made several recommendations regarding the planting of trees and shrubbery at the athletic field and recreation park now nearing completion.

BUSY SESSION OF COURT HERE

Large Crowds Hear Robbers Given Road Sentences

The crowds attending Superior court sessions here—every available seat in the main floor and balcony was occupied today—have heard several defendants given long terms on charges of breaking, entering and larceny, and also on other counts.

Joe Mitchell Gurganus, Mark Nelson and Lonnie Hardison, three white men charged with stealing calves and selling them to slaughter pens, were given sentences of 18, six and four months, respectively.

Three cases were brought against the defendants and sentences in two were suspended upon certain provisions.

Walter Smith entered a plea of guilty to breaking and entering and was given from two to three years. Clifton Williams, facing three charges of automobile theft, was given eight to ten years.

Lorenzo Baker pleaded guilty to forgery and was given a six-months sentence, capias not to be issued for 24 hours, thereby giving the defendant time to get out of the county.

Joseph Esson, charged with fraud, was placed on probation for two years. The defendant was found guilty of obtaining his board under false pretense.

J. A. Smith pleaded guilty to a charge of simple trespass and was ordered to pay \$10 on the costs of court and 40 cents to the prosecuting witness. He was originally charged with larceny.

A nol pros with leave was taken in the case charging Jack Atkinson with possession of liquor.

Della Wilson pleaded guilty to possession of whiskey for sale and was given a six months sentence, suspended upon condition the defendant not have any intoxications beverages in her home for five years.

George Buck was found guilty of assault with a deadly weapon, but judgment was suspended.

A nol pros with leave was taken in each of two charges of worthless checks against B. F. McLemore. Randolph Bunnett pleaded guilty to assault with a deadly weapon with intent to kill and with carrying concealed weapons. He was given 15 to 20 years with larceny.

John Wilkins and Herbert Lee Brown pleaded guilty to breaking, entering and larceny. Wilkins was given three to five years, and Brown two to three years, but Judge Clawson Williams later called Brown back and extended the term to from six to eight years when it developed that the defendant had lied on the stand.

Herman Langley pleaded nolo contendere to a charge of non-support and prayer for judgment was continued for 12 months.

James Mellison was convicted of embezzlement and was given from two to three years.

A nol pros with leave was taken in a case charging D. H. Harris with driving under a red light, the defendant to pay for the issuance of a capias.

Airmen Missing

London, Jan. 24.—(AP)—British warships and Royal air force planes searching the English Channel today for a British bombing plane with six airmen aboard since yesterday's storm, which caused at least 14 deaths and extensive damage to shipping in the Atlantic.

Lloyd's, which received SOS signals from 13 ships yesterday, reported that three of them were making for their home ports. There were no further reports from the others, including the 7,200-ton Chilean passenger ship.

Purchasing uniforms were the Farm Bureau Federation, by J. E. Winslow, president; R. V. Keel; Home Building & Loan Association; Dave Mosier, and North Side Lumber company.

Sixty uniforms will be purchased in all and members of the band already have been measured for the new, complete uniforms, and they are expected to be delivered in about four weeks.

A movement also is underway to send the band to the New York World's Fair on North Carolina Day—to be observed in June.

Reflector Bureau Raleigh, Jan. 24.—A lively interest and some concern was manifested today among Department of Education officials at the import of Judge Walter Bone's decision in the Wilson county intangibles tax case.

10 SURVIVORS RELATE STORY

Cause of Crash of Air Liner, However, Still a Mystery

New York, Jan. 24.—(AP)—Why the luxurious British airliner Cavalier smashed at sea with a loss of three lives remained a mystery today as 10 survivors described how they sang and shouted to keep their courage alive until their epic rescue.

They told the story of an 11-hour ordeal spent in clinging to life belts in the Atlantic wastes—a chronicle of gallantry with both comic and tragic overtones—after receiving a hero's welcome on their arrival late yesterday.

The ice-crusted tanker Esso Baytown, which snatched them from a watery grave Saturday night, after the world had all but given them up for dead, was surrounded by whistling tugs as it ploughed its way up the choppy channel.

Airplanes dipped in salute in the frosty sky and a crowd of 2,000 waited at the pier.

Of the five men and five women survivors only the widows of two of the victims, Mrs. Donald Miller of Lincoln, Neb., and Mrs. John G. Noakes of New York, showed evidence of strain. Mrs. Noakes fainted. Weeping, she was taken to a private hospital.

The others refused medical treatment.

Movement Started Plant Trees Here

The city of Greenville, through its street department headed by E. G. Lynch, will work in cooperation with the Garden club on a tree-planting program in the city, it was revealed at City Hall today.

The Garden club as a unit of the Woman's Club of Greenville, for many years has sponsored a movement to beautify the city by planting trees, shrubbery, etc.

It is the plan to work out a program whereby the citizens of the city may obtain the type of trees or plants that they may desire as reasonable cost and be so located as not to interfere with the public utilities, telephone and electric wires. It also is expected that by placing orders early and in large quantities a lower price may be obtained. Any person who desires trees or shrubbery should telephone Mr. Lynch at No. one.

"This movement is to the end that we may make Greenville a more beautiful city and the citizens of the town are urged to cooperate and to make this an important time of the year so that we may give our best thought along this line," a spokesman declared.

WOULD PUT OFF INDEPENDENCE OF PHILIPPINES

President Says He Favors Such a Recommendation

DEBATE OPENED ON RELIEF BILL

Resolution Calling for Investigation of Secretary Perkins Sent to Committee

Washington, Jan. 24.—(AP)—President Roosevelt submitted to Congress for its consideration today the report of the joint preparatory committee on Philippine affairs, recommending postponement from 1946 to 1960 of economic independence for the Philippines.

Mr. Roosevelt said the report, made public last November, had his approval, as well as that of President Quezon of the island.

It proposed gradual elimination of existing trade privileges beginning in 1946 to permit the island republic to adjust its economy to the normal condition of a completely free country having to pay in full tariffs the United States demands of other countries.

Meanwhile Senator Adams (D-Colo.) opened Senate debate on the \$725,000 relief bill with an assertion that misstatements and propaganda had been circulated in an effort to increase the allotment.

Adams, the bill's floor manager, said there "has been much misstatement of the situation, some innocent and some not innocent."

"There has been very extensive propaganda," he added, "and the issue has been misstated to the people of the United States."

Army officers, also, gave Congress some details on the proposed \$110,000,000 program to complete the equipment of the existing regular army and national guard units.

Brigadier General E. M. Beck, assistant chief of staff emphasized before the House Military committee that the sum asked by the President for critical equipment needs were designed solely for the 400,000 officers and men of the regular army and national guard, which constitute what the army calls the "initial protective force."

Other developments of the day in Washington included: A resolution directing the Judiciary committee to investigate the official conduct of Frances Perkins, Secretary of Labor, with a view to impeachment, was submitted to the House by Representative Thomas (R-N. J.).

The President called on Congress for new legislation "to effect a satisfactory reorganization" of the Federal Communications Commission.

San Augustine, Texas, Jan. 24.—(AP)—The State began presentation of its evidence today in the trial of Lester Parker, former police chief of Coats, N. C., on trial here charged with the murder of Laurie Amie in 1932.

Selection of the jury was completed yesterday. After the last juror had taken his seat in the box Judge F. P. Adams recessed court for the day.

Dunn, N. C., Jan. 24.—(AP)—A number of Harnett county officials have signed affidavits attesting the character of Lester Parker, former Coats police chief on trial of a charge of murder in San Augustine, Texas.

More than a half dozen depositions were taken and sent, along with a financial contribution, to Parker's lawyers.

Among those making depositions were Sheriff W. E. Salmon, Judge Floyd H. Taylor and J. B. Williams of Coats, and State Senator Fred Thomas.

## SCHOOL FOLKS CONCERNED ABOUT INTANGIBLES LEVY

the state as the intangible tax on the average balance. Under the act a part of this money came back to the counties and a part to towns and cities, the distribution being governed by factors of population, taxable wealth, etc. All of it, according to the act, had to be used for school debt service.

Trouble is that so many towns and cities do not have any school obligations. A number of cities which actually have school systems, do not legally have them. Raleigh is a case in point. Here the city schools are set up as an administrative unit known as the Raleigh Township School District. Though the city commissioners name the school board members, and though the district and city lines are virtually the same, the city government as such has no hand in school administration.

Each of the one hundred counties does have an administrative school unit, and nearly all of them have some debt service. Money deriving to the county from the intangibles tax must, under the law, be used for retirement of this debt. The law also says that money deriving to cities shall be used in the same way; but if there is no school debt, the law still says the city or town is entitled to its pro rata share of the collections. There's the rub.

In keeping with the requirement for remission to cities, the state Revenue Department sent to the town of Wilson about \$1,700 in 1938 intangibles tax money. The city needed it, could well spend it, and did. There was no school debt to worry about. But the county of Wilson does have a school debt and needs the money to help reduce it. The county school board, supported by the county commissioners, made demand upon the town commissioners for the \$1,700—and got the raspberries. Whereupon court action was begun, resulting last week in Judge Bone's ruling that the town could keep the money and use it for any purpose desired. Although directly in conflict with at least two sections of the 1937 intangibles act, the decision is in line with the opinion twice previously expressed by the attorney general's office upon requests from Charlotte and Oxford.

It is also in line with the practice of most of the smaller towns in the state. It is definitely out of line with opinion of department of education officials.

He realizes that by fulfilling your duties, according to conscience, and the commandments, you shall be free—free, as says St. Paul, with the freedom of the faith—whereas if you live by the theories of the world nothing possibly can result save abuses, excess and license. Your spiritual well-being and oftentimes your corporal welfare, is the reason that God says to you in the precepts 'thou shalt not thou shalt not'.

"When the Almighty says to students not to copy or crib or hand in someone else's homework as their own, it is because it is taking the property of another and because no lasting good can result to one thus filching the property of another. According to the divine plan, money has its rightful place in the world to sustain yourself and those who may be dependent upon you, and to give to the needy and to worthy causes, places of aid and distinction are not to be sought for themselves, but as stepping stones to aid those less fortunate than yourself, you are to love not only your friends and those who are good to you, but even your enemies; you are expected to fulfill your lawful debts and not contract any that you foresee you cannot meet; employers are to give a real, living wage; employees to fulfill their duties to the very best of their ability, even when the employer is absent; following the example of the Master, all are obliged to be pure and chaste in their thoughts, looks, words and actions, with themselves alone and

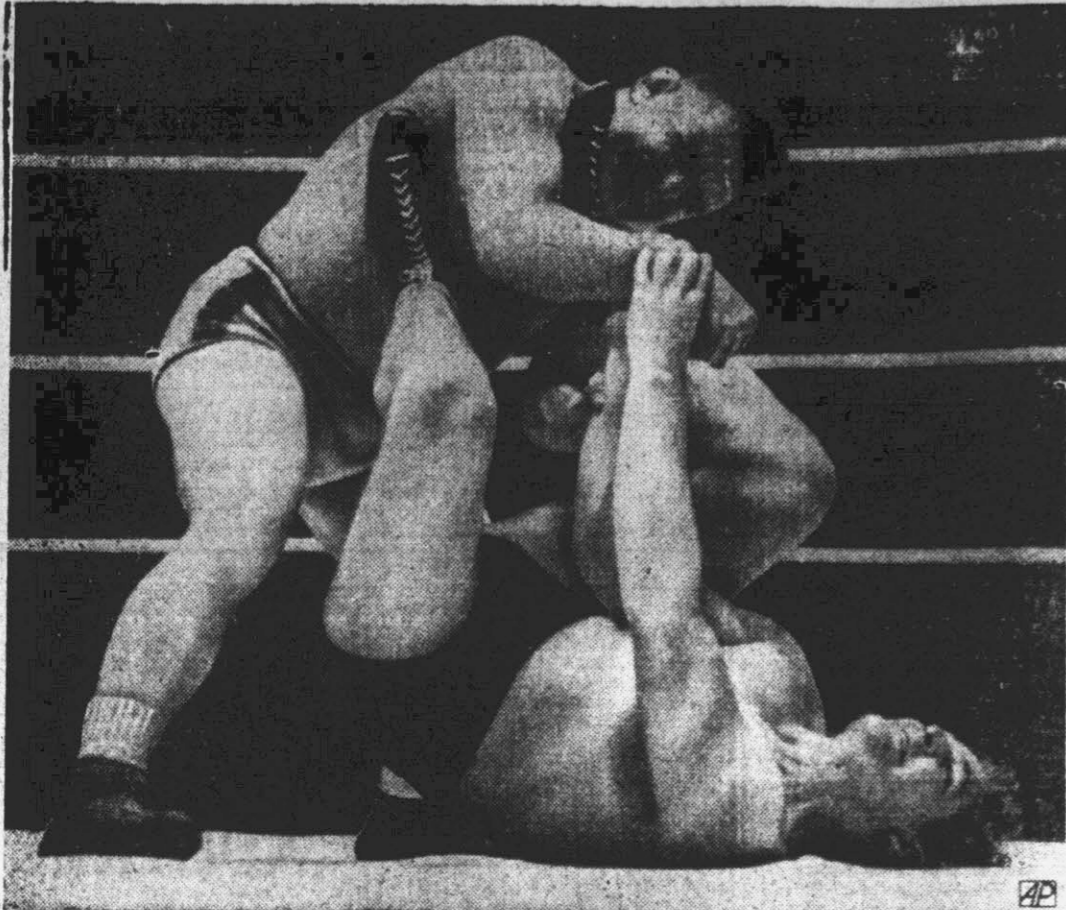

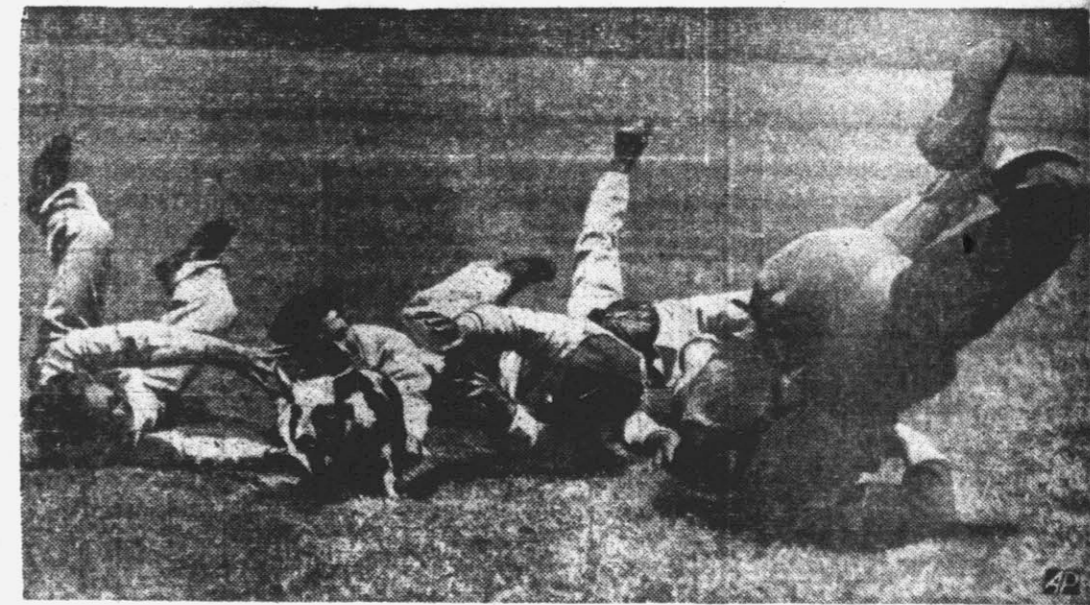

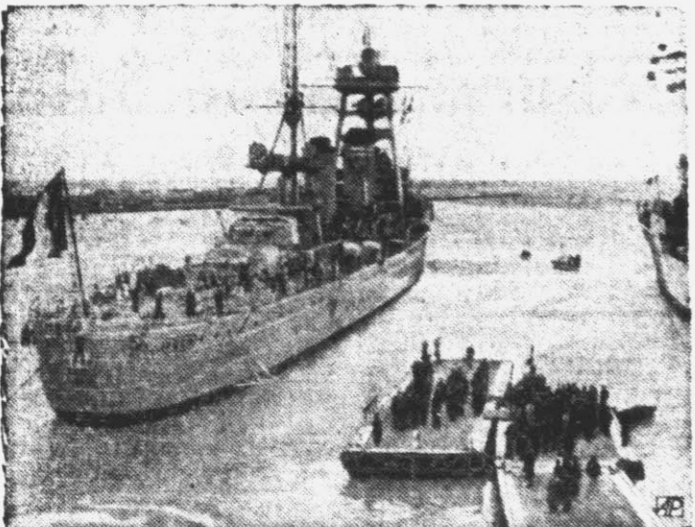

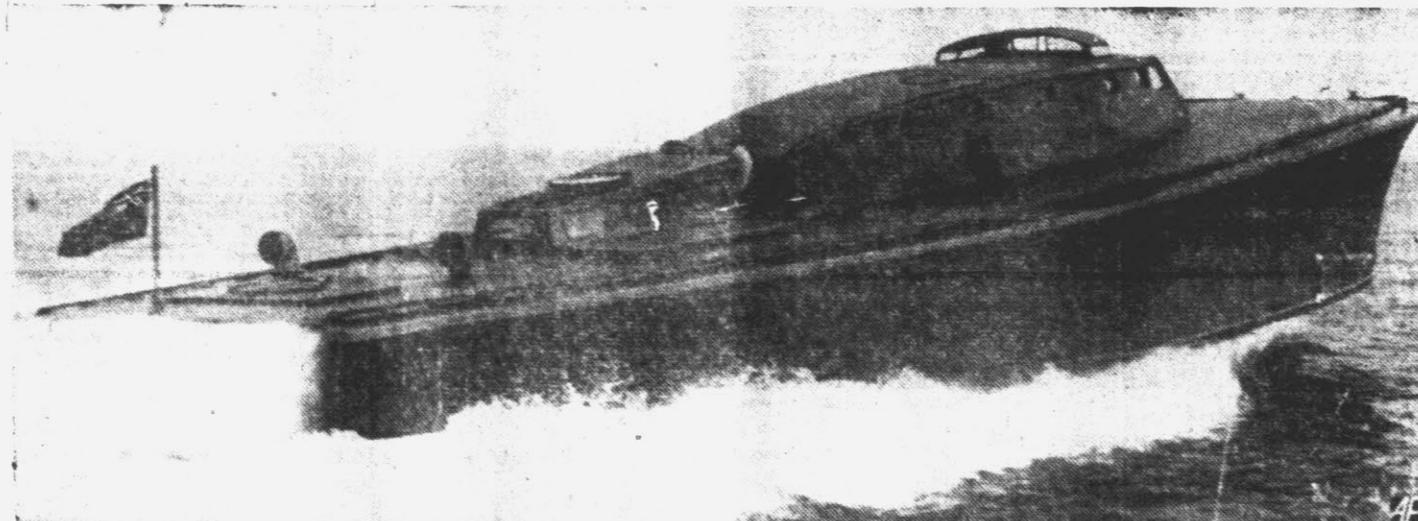

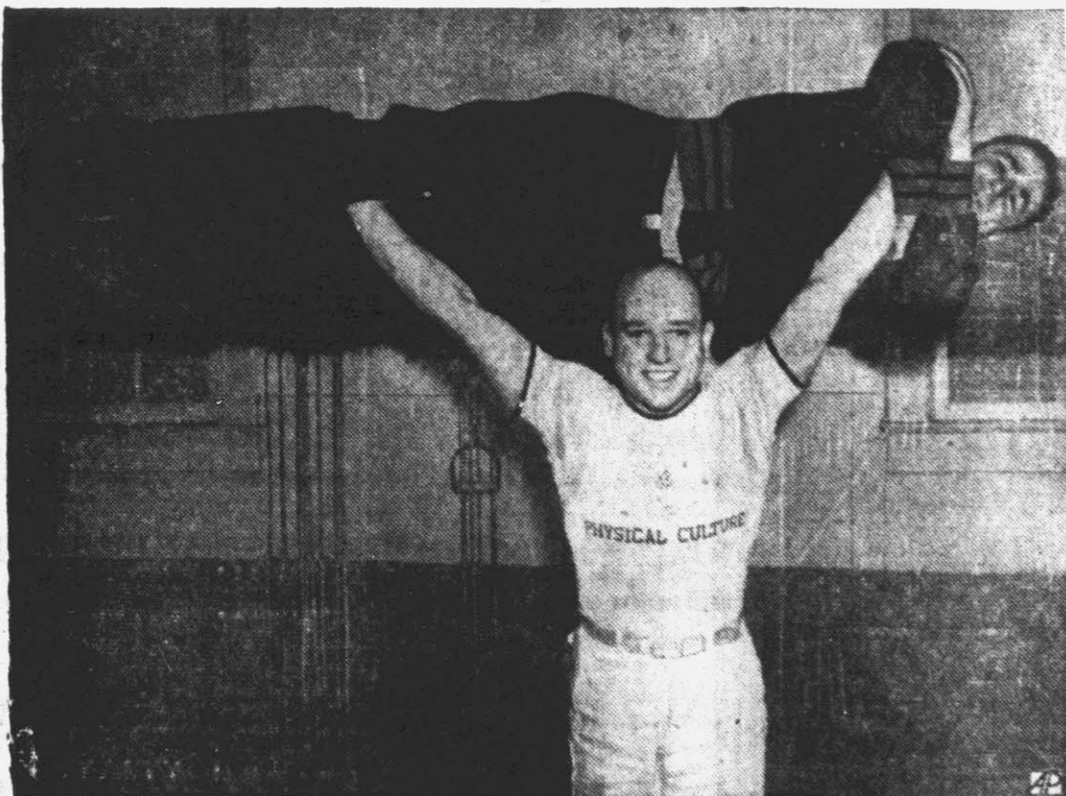

## Lobbyist Statute Catches Regulars

Reflector Bureau  
Raleigh, Jan. 24—North Carolina's lobbyist registration law catches the "regulars" as well as the "duration" pressure boys, according to the interpretation of Secretary of State Eare, with whom they are required to list themselves. This seems to be slightly different from the intention of the Assembly, which framed the statute, which was designed to get put into black and white the amounts being spent by special interests to influence legislation affecting them.

It was not thought, for instance, that former State Senator S. Gilmer Sparger, permanent secretary of the North Carolina Petroleum Industries Committee, would come within the purview of the lobby law even though he is one of the most regular of the "regulars" whose duty is to promote better public relations for big groups. This because of the fact that Mr. Sparger is a full time paid official of his concern and gets not one cent more during the legislature than out of session.

## ADAMS SPEAKS AT CIVIC CLUB

### Asserts People Think Only About One Thing at Hand

People have their minds made up into channels or little strips when they approach a subject requiring thought and that makes life harder declared Dr. Carl Adams, head of East Carolina Teachers College psychology department, last night at the Rotary Club, in the course of a speaking tour on the way men think.

"We think about the thing in hand in the little habitual grooves instead of correlating the matter with the whole of one's living. So often we vote to express ourselves and not know what we are voting about," he went on.

To illustrate the patterns of men's limited thinking, Dr. Adams told

adjectives and then cited incidents of recent occurrence in the local environment. Then Dr. Adams marshaled statistics to prove that it is fallacious to assume that the South is capable of handling its own future, when the future depends on better thinking citizens and better thinking is assisted by education and the South has over 25 per cent of the children of the national income to do it with.

It was brought out that the South has a birth rate in some sections as high as 175 births to 100 deaths and this figure after being further analyzed is not high solely due to the Negro population which has decreased in its proportion to the white, Mr. Adams said.
