SENATE VOTES 72-9 AGAINST F.D.R. NOMINEE

Rejects Nomination Of Roberts As Federal Judge

SUMS ASKED FOR GOV'T. AGENCIES Total of \$1,580,670 Lopped Off Funds Recommended For Independent Offices

Washington, Feb. 6.—(AP)—The Senate rejected today President Roosevelt's nomination of Floyd H. Roberts to be a Virginia federal judge. Senators Glass and Byrd, Virginia Democrats, had objected to the appointment.

The Senate Judiciary committee had disapproved the nomination by a vote of 15 to 3.

Glass and Byrd testified before the committee that the nomination was "personally offensive" to them.

The vote refusing confirmation was 72 to 9.

President Roosevelt told a press conference Friday that if the nomination was rejected he would write a letter to Roberts which would be right interesting.

Meanwhile, the House Appropriations committee recommended \$1,580,670 to operate more than a score of independent government agencies for the year starting July 1, an increase of more than \$288,000,000 over the current year.

Despite the increase, the committee lopped \$1,580,670 from some of the Budget Bureau's estimates.

It withheld the \$2,038,175 appropriation recommended for the Federal Communications Commission, pending action by Congress on the President's request for reorganization of the commission, torn recently by internal dissension.

The commission proposed cutting \$2,000 from the salary of each member of the Maritime Commission and each member and the administrator of the new Civil Aeronautics Authority.

Salaries of these officials were fixed by law at \$12,000 a year, but the committee said the reduction to \$10,000 was in line with the treatment accorded members of both the Interstate Commerce and Tariff Commissions.

The net increase in the bill's total was accounted for by inclusion of a new item of \$100,000,000 for the Maritime Commission construction fund and a grant authorizing the Commission to contract for additional \$230,000,000 of construction.

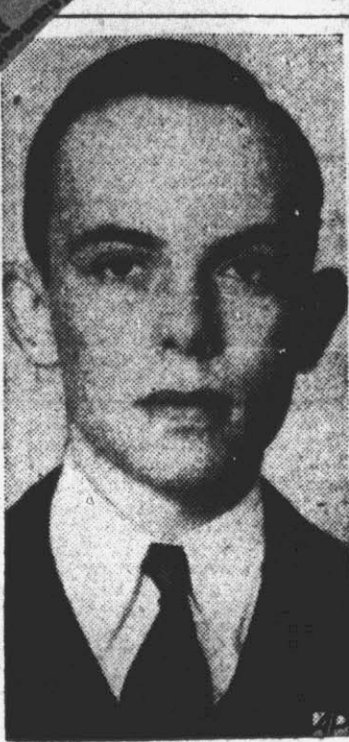

O. W. Harrington, Greenville citizen and former Pitt county sheriff, died last night at Oteen, where he and Mrs. Harrington have been living with their son, Dr. C. L. Harrington, for several years. Dr. Harrington is general physician at Oteen hospital.

Mr. Harrington was 76 years old. The body will arrive at the S. O. Wilkerson and Sons funeral home early tomorrow, with the funeral to be held at the funeral parlor at 3 o'clock tomorrow afternoon. Elder S. B. Denny, Primitive Baptist minister of Wilson, will conduct the services. Burial will follow in Greenwood cemetery.

Active pallbearers will be S. I. Dudley, D. C. Dudley, L. W. Tucker, Ed Ward, W. L. Nobles, J. C. Gaskins, J. F. Harrington and E. R. Dudley.

Two Major Issues Likely Reach Committee Climax

Reflector Bureau Raleigh, Feb. 6.—The major legislative issues are likely to reach committee climaxes this week, while work or preparation of the two big money bills goes forward with prospects good for decision on several important features.

The big committee features have to deal with election law reform and the everlasting wrangle over duplication of effort between Department of Agriculture and State College Extension Service.

Tuition charges at state-supported schools will be the first important Appropriations committee problem, with a hearing for betterers in opposition to a proposed "crown tax" as the major scheduled item on the Finance group's agenda.

Subject to change with little notice, the new seems small likelihood of great progress in consideration of the two Wage-Hour bills already offered.

Three bills dealing with operation of the Unemployment Compensation Commission will come up as a special order of business tonight

and are due for passage in the Senate at that time. Getting back to election law reform, it is expected that the subcommittee named last Friday afternoon by Chairman George W. Phillips will get down to work almost immediately after return of its members from the week-end at home; and it is not at all improbable that it will be ready with its report to the full committee by the end of the week. Speculation is keen over its action with the best guess a recommendation that the reform measures "suggested" by the State Board of Elections, and introduced by Wayne's Frank Taylor be enacted as a substitute for existing absentee, marker and registration statutes.

On the Agriculture front, high spot of the week will come Thursday when a joint committee of technical experts, from State College and the Department are due to report to the committee. Predicting any real agreement between these groups which have been

GREAT BRITAIN AGAIN PLEDGES AID TO FRANCE

Statement Made By Chamberlain Before Commons

SAYS COUNTRIES ARE IN ACCORD

Declaration Follows Statement in Rome That Italian Troops will Remain in Spain

London, Feb. 6.—(AP)—Prime Minister Chamberlain told the House of Commons today "any threat to vital interests of France from whatever quarter it came must evoke the immediate cooperation of this country."

His declaration followed a statement yesterday by Virginia Gayda, Italian Fascism's newspaper spokesman, that Italian troops would stay in Spain until the Generalissimo Franco's political as well as military victory was assured.

The Prime Minister said the British Government was "in complete accord" with the statement January 26 by French Foreign Minister George Bonnet that "all forces of Great Britain would be at the disposal of France, just as all forces of France would be at the disposal of Great Britain" in case of a war in which the two countries were involved.

Chamberlain's statement was considered particularly significant in view of Fascist agitation for concessions in the Mediterranean and Africa.

HARD SURFACE ROADS SOUGHT

Belvoir and Pactolus Citizens Heard By Commissioners

A large delegation appeared before the County Board of Commissioners, in regular session here today, and successfully requested the board to petition the state highway and Public Works commission to pave the roads from highway No. 11 to Belvoir and from the same highway to Pactolus.

Besides residents from these two townships, a number of other Pitt county citizens were present at the meeting in support of the two paved roads. The projects have the support also of the Greenville Chamber of Commerce, The Tobacco Board of Trade, the Merchants association and the civic clubs.

The roads were on the approved list of the county when the State took over all roads. It also was pointed out that neither Belvoir nor Pactolus township has a paved road.

The delegations were headed by Mayor M. K. Blount of Greenville, who served as chief spokesman. Several others also spoke in behalf of the roads, after which the board passed a resolution requesting the highway commission to pave the two roads and appointed Mr. Blount chairman of a county-wide committee to present the matter to the district engineer and also to the State Highway commission.

Mayor Blount has been working in behalf of the two roads for some time and has presented the question to various local organizations for their support.

Ten Face Trial in City Court Today

Of ten defendants who faced Recorder L. C. Skinner in Municipal court this morning, six were given time and suspended sentences, three were acquitted and one was ordered to pay \$5 on the costs.

HOEY PRAISES STATE BUDGET

Declares North Carolina Better Off Than Others

Raleigh, Feb. 6.—(AP)—Gov. Hoey pointed to North Carolina today as being "in a fortunate situation" as compared with several other states, including Georgia and New York, as he discussed the need for a balanced state budget.

There was no legislative activity, except a Finance committee meeting in the afternoon. Representative Mallison of Pamlico, said he planned to introduce a bill tonight to amend the constitution to provide additional pay for legislators who now get \$600.

Speaker Ward of the House, commented that he thought it was "a good thing" for the legislators to go home this week-end after he noted attacks on the assemblymen for practically deserting Raleigh last Friday.

"The legislators have worked hard," Ward said. "The legislature is now just about the mid-way point of the 60-day constitutional period. I think it was a good thing for the legislators to go home this week-end and talk with the people. It is a lot easier to go home and see your constituents than it is for hundreds to have to come to Raleigh to see the members."

Gov. Hoey said he expected the administration bills to be ready this week for creation of a Department of Justice by coordinating existing agencies, na ditto give judges and jury discretion in imposing death sentences of life imprisonment in first degree convictions.

The governor said that a dozen budgets he had studied showed this state in a better condition than others though school appropriations in North Carolina run proportionately higher than in the others.

Franco States Terms As Unconditional Surrender; Spain Hopes To Continue

NEW ATTEMPT AT MEDIATION

Disclosure of Insurgents' Peace Terms Comes on Heels of Report That Britain and France Making New Efforts to Mediate Two and Half Year Old Spanish War

London, Feb. 6.—(AP)—Spanish insurgent authorities were reliably reported today to have informed the British Government their peace terms were "unconditional surrender" of the Spanish Government.

This disclosure came on the heels of a report in authoritative quarters that Britain and France were making a fresh attempt to mediate the two and one-half year old war in Spain.

Informed sources said C. B. Jerram, assistant to the British agent at Burgos, insurgent capital, had called the attention of Generalissimo Franco's regime to a three-point peace offer by Dr. Juan Negrin, Premier of the Spanish Government.

The insurgents were said to have told Jerram flatly that these terms were "utterly unacceptable." One of the three points called for an insurgent guarantee against foreign influence in Spain.

"The Spanish government apparently has left Spain," one informed source said, "and we do not know whether they are actually holding together."

Events in Spain were changing with such rapidity, it was said, "that it is not possible to discuss at this minute any action which the British Government might have taken in the past week-end."

The first indications of merritization came Saturday night when it was reliably reported in the French Spanish border region that the Negrin Government had made a tentative approach for British mediation.

OPEN HEARING ON INSURANCE

Witness Says Policy-Holders Have No Cause for Fear

Washington, Feb. 6.—(AP)—Chairman William O. Douglas of the Securities Commission told the temporary National Economic committee today that "the spectacular" growth of insurance companies since 1906 alone justified an inquiry into their economic influence.

Douglas, who was the first witness called by the Monopoly committee in its investigation into insurance company investments, said insurance firms had cooperated fully with the SEC. He emphasized he was in no way questioning the adequacy of the companies' reserves.

"No policy holders need have any concern," he said, "that any fact brought out in this inquiry will in any way jeopardize the protection which they count upon through their insurance policies."

The witness paid tribute to the work of the so-called Armstrong committee, a joint New York State legislative committee, which investigated life insurance companies there in 1905. The work of the committee, which employed Charles Evans Hughes, now Chief Justice of the Supreme Court of the United States, as counsel, has long been recognized, Douglas said, "as an outstanding contribution to an understanding of the problems of finance."

HOPE TO WAGE MADRID STAND

Spanish Government Premier Negrin Follows Defeated Forces Into France and Announces Aim To Continue Strife with Defiant Stand Before Former Capital

Perpignan, France, Feb. 6.—(AP)—Premier Juan Negrin of Government Spain followed his defeated northern army into France this morning, hoping to continue the war with a defiant stand before Madrid, despite the reported plea of some ministers that he sue for peace.

The broken Government forces started their disorganized flight Sunday afternoon, when French authorities decided to permit them

PEACE ACTION

In the Greenville Peace Council there are representatives of groups of people with widely divergent views about war and peace; but there is one thing that makes them stand together: a common desire for peace, no matter how widely they may differ on the best way to attain it.

All the organizations of Greenville that have representatives on the council have their own programs for outliving world good will, or at least for helping keep the United States at peace, though some may favor complete abolition of armaments as the best path to the goal and some, preparedness for war, as the one peace measure possible now.

This wide range of opinion is found also in the National Peace Conference, with which the local one is linked. The national organization will not admit a local council unless it keeps its membership open to all who really wish for peace.

There is one other point, however, on which all might well agree, and that is the prevalence and danger of propaganda and the need to uncover and bring it out into the open and to educate people in ways of protecting themselves against it in some measure, at least.

So, the next items in the "Peace Action" column will deal with the subject of propaganda, means of protection against it, and fields in which it is most dangerous.

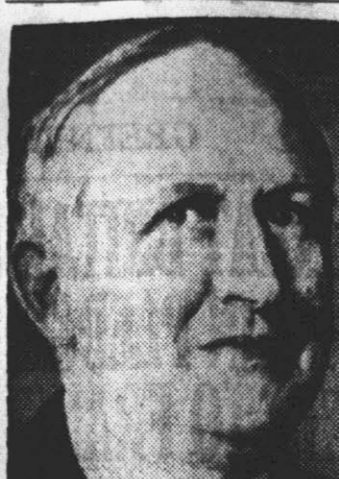

SEEK INCREASE PAY OF SOLONS

To Propose Change By Constitutional Amendment

Reflector Bureau.
By HENRY AVERILL
Raleigh, Feb. 6.—A Constitutional amendment proposing to increase the salary of General Assembly members from \$600 to \$900 per term is scheduled to be introduced in the House tonight by Representative Dallas Mallison of Pamlico, according to apparently authentic reports.

Mr. Mallison was out of Raleigh over the week-end and he could not be reached for confirmation of the report, which appears on its face to be completely reliable, however.

Legislators' salaries are now fixed by the Constitution at \$600 per term, contrary to the belief in many quarters that the assemblymen draw \$10 per day for a maximum of 60 days. If such a thing ever happened—it hasn't for 10, these many years—and the regular session of any Assembly adjourned short of the 60 days, then the members would get their \$600 just the same.

The only official \$10 a day recognition is the fact that state nursing officials will not issue checks to members for part payment for the session except on the basis of \$10 per day for the already expired portion of the session.

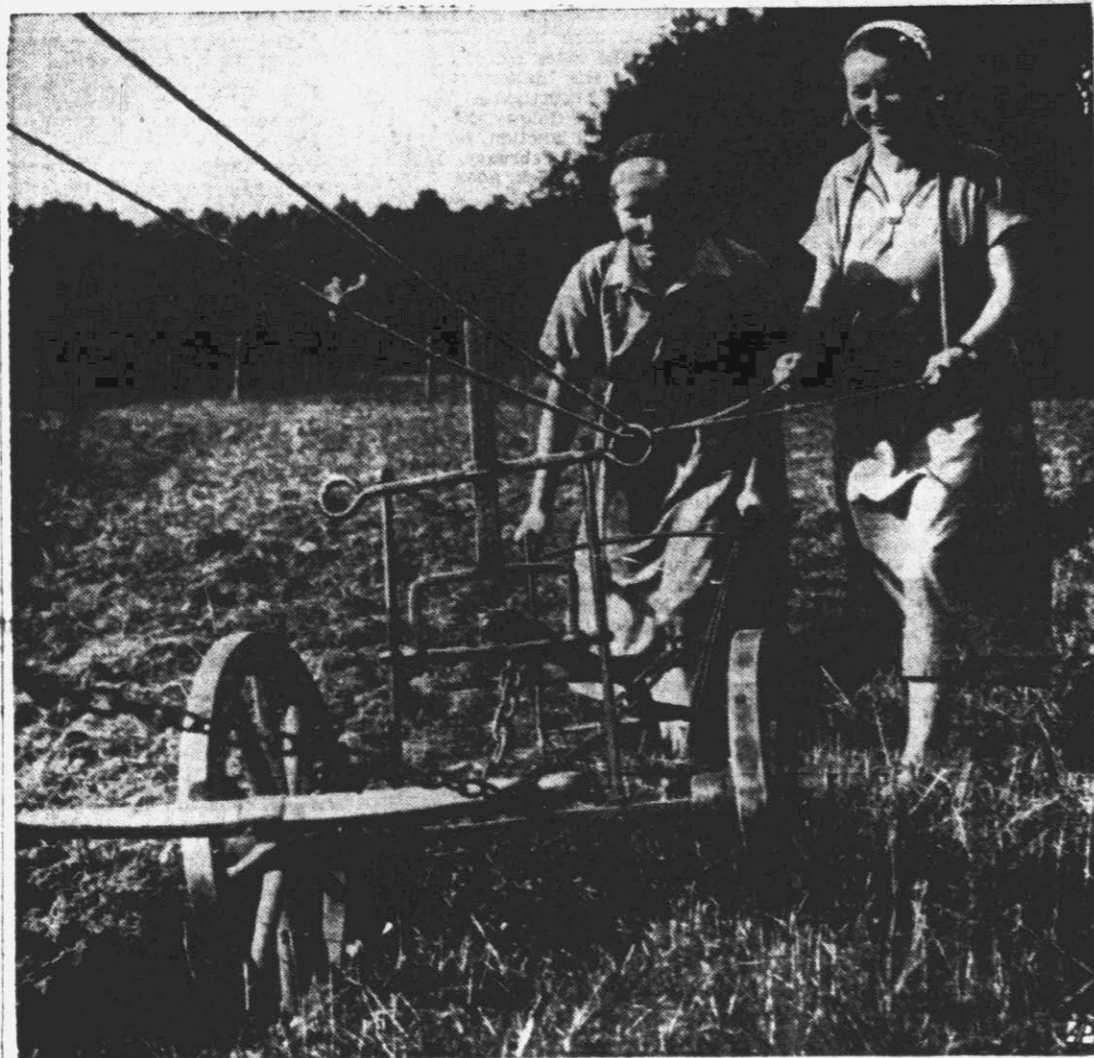
Mr. Mallison, it is reported, will argue that the \$900 salary was fixed at a time when most regular sessions finished their business within a 60-day span. Those days are gone forever, he believes, basing his belief on the record of the last four or five Assemblies. None has finished its work in less than 60 days, the 1937 body getting over quicker than any other—and it took 66 legislative sessions.

Reich Calls Girls To The Farm —Hopes Some Will Stay There



German girls are going to learn about farm work, although not all of them will have to get behind the plow. These are girls participating in the voluntary program which preceded the compulsory call.

BERLIN—Rich or poor, pretty or no, willing or not, German girls are being mobilized. All sturdy Frauleins between 18 and 25 on March 1 must be ready for farm work.

The call to the colors for a "year of duty to the people" was made by Field Marshal Goering, Dr. Friedrich Syrup, employment chief, will enforce it.

The skirted legions will be flung into the thin ranks of Reich manpower, now straining under requirements of the military power and the Four Year Plan to make

Germany self-sufficient. Authorities hope some will marry farmers. The Nazi policy seeks to build up a settled rural population, especially on frontiers—to develop a love of the land and the will to defend it.

Marriage is one cause for exemption from the ruling, physical disability another. Elder daughters of large families may serve at home. An alternative to labor service is two years as probationary nurse. Girls who served in the voluntary farm labor program in other years can do their stint in six months.

There were 130,000 girls in the voluntary program last year. Under conscription the number may reach 400,000. Pay was not mentioned in the new order; the voluntary workers got about 80 cents daily. No girl may obtain private employment unless she has served her year of duty to the people.

Girls may choose their place of service subject to local labor bureau approval. But they will have to go where needed most to work in field or kitchen.

They were directed—not "requested"—by the Agriculture committee to meet together and report stating what things they can agree upon and which they cannot reconcile.

Committee Chairman W. W. (Cap) Eagles told all hands quite plainly last week that their continual and continuous bickering and brawling is seriously endangering North Carolina's whole program for agriculture, and this warning is expected to have a distinctly sobering effect on the principals if not upon all the "hanger-on" of the rival camps.

On Tuesday the Agriculture committee will get another earful of the perennial controversy when peanut growers are slated to appear

and ask that the Peanut Experiment Station work be put directly and exclusively under the State College service.

Appropriations will on Tuesday definitely determine the matter of tuition fees at State Colleges, and there seems hardly a chance that there will be any increase authorized for North Carolina students, at least.

Later in the week the group may get around to considering the Highway Department budget. If it does, the fur is going to fly with a sur-

prise or two perhaps in store. Except for the fact that the "Crown Tu" bill was sponsored by legislators not in the "sacred circles" of the Administration, the bottlers hearing of Tuesday would be a major event. Even as it is there seems real growth in sentiment for such a tax and it is likely to cost the bottlers even more than they spent last time to defeat the measure.

Man About Manhattan

NEW YORK—Some of the men were tired. You could tell that. They were in various stages of undress because they had been there since one o'clock, and it was now five. Some of the men had their coats off. Others had their neckties loose and their collars open at the throat. Eddy Duchin sat at the piano and ran his hand through his jet curly hair.

He said: "Okay, once again for that ending."

The men picked up their instruments. Morton Downey stopped thinking about whatever he was thinking about and stepped up to the mike. Duchin's hand came down and the band, with Downey singing, played about five bars of "Heart and Soul." When it was over Duchin looked up towards the control booth. Harry von Zell, the production man, nodded to him, and then Duchin dismissed the band.

We were sitting in the control booth, studio 3B, watching the rehearsal with Von Zell and several agency officials, and Durrelle Alexander, the little Dallas, Texas, girl who is Duchin's vocalist. Then Duchin and Morton Downey were coming into the booth and Duchin yelled: "What was it, Harry, what was it?"

"A couple of clinkers sneaked in three," Von Zell told him. A "clinker" is a bad note. Duchin looked surprised. "Can't understand it," he said.

"Oh, it's okay now. You're all right now," Von Zell assured him.

"I hope so," Duchin said. "We've been here all afternoon and I'm tired. It costs a lot of money to keep these men on rehearsals, Harry."

"But it can't go out over the air unless it's right." There was a lot of good-natured heckling, and then Eddy said: "How did it go? For time, I mean?"

One of the men in the control booth put his forefinger on his nose. That meant "Right on the nose" or "right on time." Sometimes during a broadcast you'll see production men signal an orchestra leader in this manner. Then he hasn't anything to worry about. If the show is running a little ahead of schedule he makes a motion with two hands as if he were pulling candy or playing an accordion. That means to stretch it out a little. If the show is behind schedule he makes a motion similar to the way you crank a car or turn an egg-beater. That tells the orchestra leader to step up the tempo, that he's running behind time.

There must be a thousand such signals which radio men know and use every day. You have to hang around and watch a lot of rehearsals to get onto them. Duchin was running his hand through his hair again. It was his show—or would be when it went on the air at 9:30. He guessed it was okay. He said: "Come on, I'm buying a drink." So we all went down stairs to a restaurant and had a glass of something or other—all that is, except Morton Downey, who ordered a big bowl of ice cream. He is very fond of ice cream. He will order it four or five times a day, or every time you pass a restaurant, if you go inside. He just can't say no to ice cream.

Duchin said: "you hear a guy a half hour on the air and you think that's all there is to it—a half hour. But we've been working since one o'clock—and it'll be after midnight before we're through. I'm going to catch a little shut-eye." Downey said: "I better call Barbara." Barbara is his wife. So Duchin to up and went out, and Downey went off to look for a telephone, and the rest of us said "so long" and scattered here and there. It was just that sort of afternoon.

PITT COUNTY ENTITLED TO MORE ROADS

The movement for the paving of roads from highway number 11 on the north side of the river to both Belvoir and Pactolus, as recommended by the Board of County Commissioners this morning, should be pushed to successful completion. Practically all of the present hard surfaced roads in this county were built at the county's expense before the state took over the roads, and while the county was left with the bag to hold so far as payment of the bonds for the roads were concerned, we have been left out in the cold in the way of getting additional paved roads in this county. It is understood that there is already allocated to this county approximately \$500,000 of State Highway funds and there is no reason why some of this money should not be used now for the building of these two and other much needed paved roads. The matter has the hearty endorsement of the local Chamber of Commerce and others, and it is to be hoped that the committee appointed to push the projects will leave nothing undone to get the Highway Commission to give us these roads at once. We not only need them but we are likewise entitled to them.

LET THE PEOPLE DECIDE

Before seeking legislative changes in our town charter we believe that our legislators would do well to hold a mass meeting here at which time all our people may have the matters explained to them and decide whether or not they favor the proposed changes. If the city manager form of government would prove economical for our city we are sure that the great majority of our citizens would favor it, but until they have had the opportunity to say whether or not they favor it, we believe it would be a mistake to legislate it upon them.

As to the proposed establishment of park, planning and zoning commissions by legislation, we are opposed to them. It is our belief that our present charter permits the Board of Aldermen to act in these matters and being directly responsible to the people, we believe that through the board, these matters can be handled better than through appointed commissions whose members will serve for five-year periods if the proposed charter changes are made.

There is far more opportunity for private individuals to gain control of appointed commissions for their own purposes and benefits than to get control of a Board of Aldermen elected by the

people, and certainly Greenville wants no commissions whose recommendations could work to the advantage of certain property holders instead of for the common good.

Our observations have been that most commissions, in the long run, are expensive to a taxpayer's standpoint and accomplish little public good.

We repeat, there should be no action before the legislature regarding changing our town charter until our people have had an opportunity to understand just what is going on and make known their wishes in the matter. The only way to reach this conclusion is for a mass meeting to be called here and have the matter thoroughly threshed out. Then, if it is shown that our people want the changes the legislators will have no trouble in getting the necessary laws passed, but if our people signify that they do not want the changes, then the legislators can go about their other duties and not even present this matter to the legislature.

He based his conclusions on the "duality" of control over general

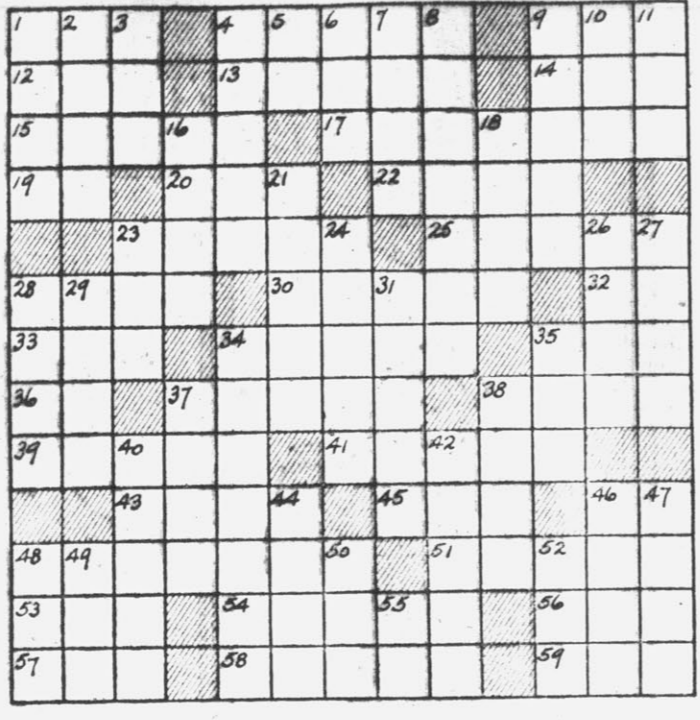

elections and the lack of such control in primaries.

"Dual supervision is the mudsill on which our whole election system is based," he said. "We have it in the general election, but we cannot possibly have it in the primaries."

Wherefore, he argues, we ought to keep the absentee ballot for general elections and abolish it in primaries.

The Mull argument sounded fine, but Wilson's Larry Moore went a long way toward demolishing it with the brief comment: "We may kid ourselves here, but we can't kid the people of North Carolina. If

we abolish the absentee in the primary and not in the general election, they are going to steal from the Republicans but not from each other."

And Rupert Pickens of Guilford pointed out that "dual control" is more a theory than a fact. Since the Democratic registrar controls every step of absentee voting, except actual counting of the ballots.

LEGAL NOTICE
The following regulations were adopted by the North Carolina Board of Conservation and Development at its regular meeting in Raleigh on January 17, 1939, and is now in full force and effect:

Rule 3. (Amended) CLOSED SEASONS: It shall be unlawful to fish or take fish by any means whatsoever in "Inland Fishing Waters" of North Carolina from April 1 to May 9 of each year, both dates inclusive; Provided, that the closed season in and west of Alleghany, Wilkes and Rutherford Counties and west of Highway No. 18 in Burke and Caldwell Counties shall be from March 1st to June 9th of each year, both dates inclusive, except that the closed season on Trout (all Species) shall be from Sept. 1st to April 14th following, both dates inclusive.

It shall be unlawful to fish or take fish from Lake Santee in Graham County from Oct. 1st to June 9th following of each year, both dates inclusive, except that the closed season for Trout shall be from Sept. 1st to June 9th following, both dates inclusive.

12. Minimum Size Limit For Small Mouth Black Bass
The minimum size limit for small mouth black bass in North Carolina is hereby set at 12" and Inland Fishing Rule 5 is hereby amended to conform with the above action.

Rule 11. (Amended) UNLAWFUL TO BUY, SELL, OR SHIP GAME FISH: It shall be unlawful in the State of North Carolina for any person, firm or corporation to buy, sell, ship, offer for sale, or possess for the purpose of sale game fish which were taken within or without this State. The possession of any game fish in any hotel, restaurant, cafe, market or store, or by any producer or dealer in this State shall be prima facie evidence of the possession thereof for the purpose of sale. The following are classified as game fish for the purpose of this rule: Large and small-mouth Bass; Fresh water Trout, more commonly known as Brook or Speckled, Rainbow or California, and Brown: Bream, Crappie or Chinquapin Perch, Pike, Slobin, Blue Gill, Robin Perch, Goggie-eye, Pler Perch and Grass Perch. Paved further that White Perch (Morone americana) taken from inland waters shall be classified as game fish.

Rule 11-a. It shall be unlawful for any common carrier, or any employee of such carrier, or any person, firm or corporation engaged in transportation for hire, to transport game fish as defined in Rule 11, for delivery within the State or from a point within the State to a point without.

Rule 18. (Amended) No person shall at any time willfully molest or disturb take, catch, or destroy any game fish while such fish are on their natural spawning beds.

Certain Waters Classified As Trout Streams
The Division of Game and Inland Fisheries is hereby authorized to classify such streams or portions of streams in Western North Carolina as it may deem advisable as trout streams; and no fishing of any kind shall be permitted in these designated areas except during the open trout fishing season. Adequate signs designating such areas shall be posted along the banks of such streams.

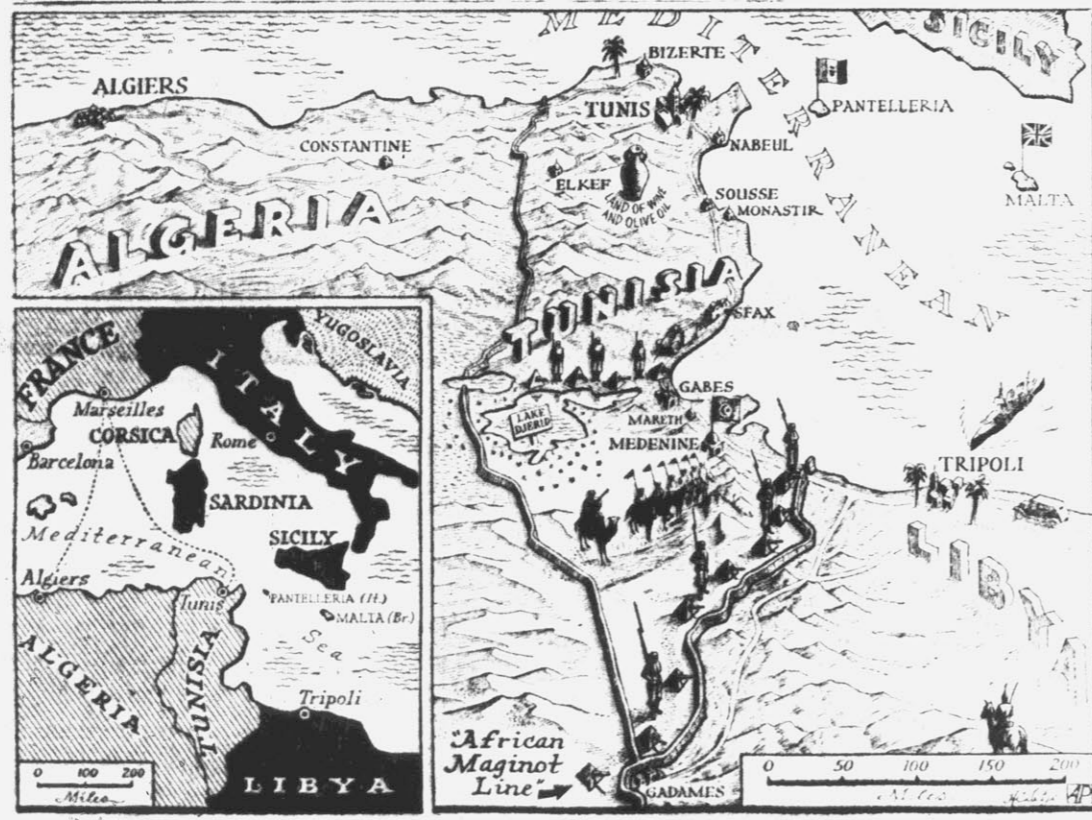

If Next War Does Start In Africa, French Count On Triple Defense



Where France maintains a triple guard, Italy, to osi alert, Libya is strongly garrisoned, and godo roads have been built to the Tunisian frontier. Note Barcelona in inset map. It is close to French 'life lines' (sea lanes to Africa), and it is now held by Franco, Mussolini's friend.

TUNIS AP—Three hundred miles of tortuous mountains and shifting sandunes crown France's African Maginot Line along the frontiers of Italian Libya.

Many military experts believe it is along those frontiers that decisive battles of the next world war may be fought.

These experts point out that Germany and France virtually are stalemated by their lines of fortifications from Switzerland to the North Sea and that the Alps form a formidable barrier between France and Italy.

So with the quarrel between the democracies and the dictatorships now turning on colonies, the experts believe any eventual armed conflict, may be settled in th colonies themselves.

The Tunisia fortifications built in the past two years are more secret than those of the great line along the Orman frontier. Some reports have placed the number of troops in the line at 100,000, but the French command acknowledged only some 35,000 in all Tunisia, with about 25,000 manning the forts.

The scant information brought out of the area is of pyramid-like

fort that seem to melt into the parched countryside.

Other Strong Barriers.
This line is but one of France's triple Tunisia defenses. Behind the Lots—known officially as the Maginot line from the name of a city—runs the hardy, veteran and famed French Foreign Legion, and the possibly even more deadly native North African cavalry recruited from desert tribesmen.

Behind these two is a still more secret and "bush" that extensive fortifications are being built there.

BACKGROUND
Joseph P. Kennedy, ambassador to Great Britain, has been quoted as saying that an Italian invasion of French Tunisia might set off the next big war this spring. Those who agree point out that Italians have demanded Tunisia and that France has replied she'll never give up an inch of territory. This story tells how the French are preparing for the trouble.

125 miles in the interior to guard the narrow corridor between northern and southern Tunisia.

The protectorate is cut almost in half by three great lakes—Chott El Rharas, Chott Djerid and Chott El Fedjadj—which run from the Algerian frontier on the west to within 20 miles of the Mediterranean on the east. Miles of marshland hinder an approach from the south to the first two and a chain of mountains curves protectively in front of Chott El Fedjadj.

So the French would need only to close a 20-mile bottleneck to check invasion from the deserts of the south to the more fertile and administrative heart of the protectorate.

Desert-Trained Defenders.
Most of the French manpower in Tunisia is made up of colonial troops thoroughly trained in the strike and run desert warfare which defies even modern equipment.

Every few months the South Tunisia headquarters at Medenine orders new regiments into the "African Maginot Line" to become familiarized with the fortifications which form the fixed base for their operators.

Bill Shelton, who bagged 18 points in the classic, made the locals' first point a minute later when he guided a gift shot through the net.

Saturday night's offering was slated to be sandwiches around Cipolat for the Virginians and the Brock-Shelton combination for the Pirates. This prediction was only half right. The Hornet topnotcher did not get busy in scoring ways until the last eight minutes. His best performance came three minutes before the end when he got a basket and sank another beautiful shot ten seconds later.

After chalking up 14 points in the first half, Don Brock, overbalancing the scales of exhaustion, came out of the game three minutes and twenty seconds before intermission. He was relieved by Milton Glass. Coach Gordon Gilbert's Pirates were in front 26-13 at the half. Brock got a half-dozen points in the last half, built his total to 20, and led the locals' scoring.

Bill Shelton, another E.C.T.C. scoring ace, featured the Pirates' offensive onslaught in the final phase with five field goals. Shelton, with 18 points, was the locals' next best man in scoring ways. Earl Smith, valuable Pirate forward, showed marked improvement over recent engagements. Tom (Parson) Parrish, former Greenville high school athlete, did well as he aided considerably in advancing the ball to the scoring zone.

Plymouth high school was an excitement creator in a preliminary affair, which saw the local Outlaws subdued 31-29 in overtime play. At intermission, the Outlaws held a 19-7 advantage. When the game ended, the score was deadlocked at 27-all. Carson, with 9, led the losers. Liviman bagged 17 to feature for his mates.

He is a catcher and was secured in a trade in which Tarboro gave up Fat Malone, pitcher, and Solly Myers, shortstop.

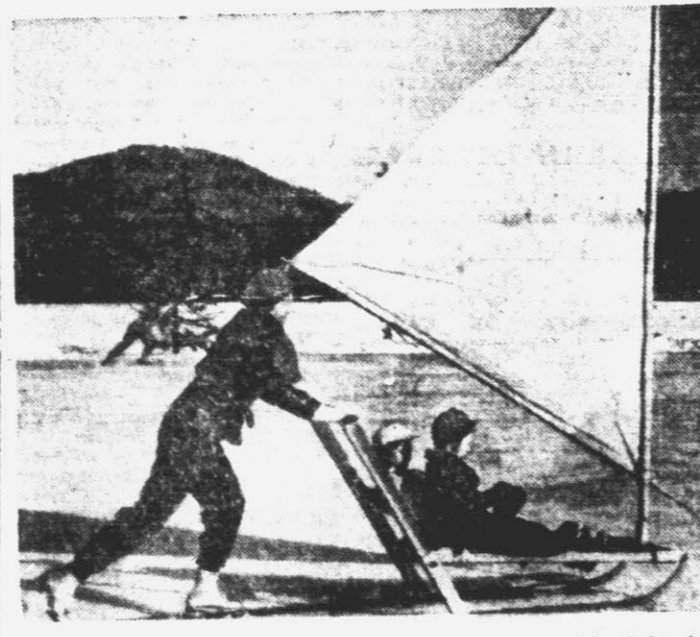

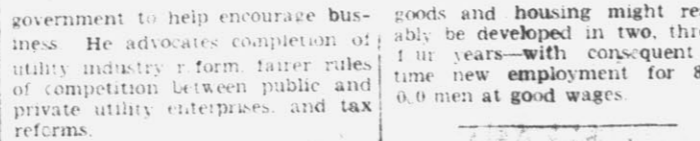

Washington Daybook

By Preston Grover

Washington—Back of the flurry about helping business is one solid problem—how to transfer from the shoulders of the Government to the shoulders of business the task of supporting the national economy.

Priming the pump is successful when it generates private buying of a truly sustaining nature. In 1936-37 it brought up the spending level but competent trade analysts since have discovered:

1. The buying increase was mainly in the field of consumer goods (groceries, clothes).
2. Purchase of capital goods (those intended for plant expansion) was one-fourth below the level which sustained the prosperity of the happy twenties.
3. Much of the buying of capital goods actually reported in 1936 and 1937 was merely for replacements long deferred, and did not represent new capital invested in the hope of profit.

Study 'Indigestion' Causes
Prof. Sumner H. Slichter of the Harvard business school and other economists, have been digging into treasury figures, bank reports, industrial tables and other places where symptoms of business indigestion show up.

They found that it wasn't government alone, nor labor nor steady dollars nor was consumer spending, that caused the 1937-38 slump. Instead it was a combination of all these.

While many big corporations reported profits, the 400,000 smaller corporations, important to industrial America, were making thin profits, or none at all.

So the transfer from government spending to private spending fell short of success. Last year it was started all over again.

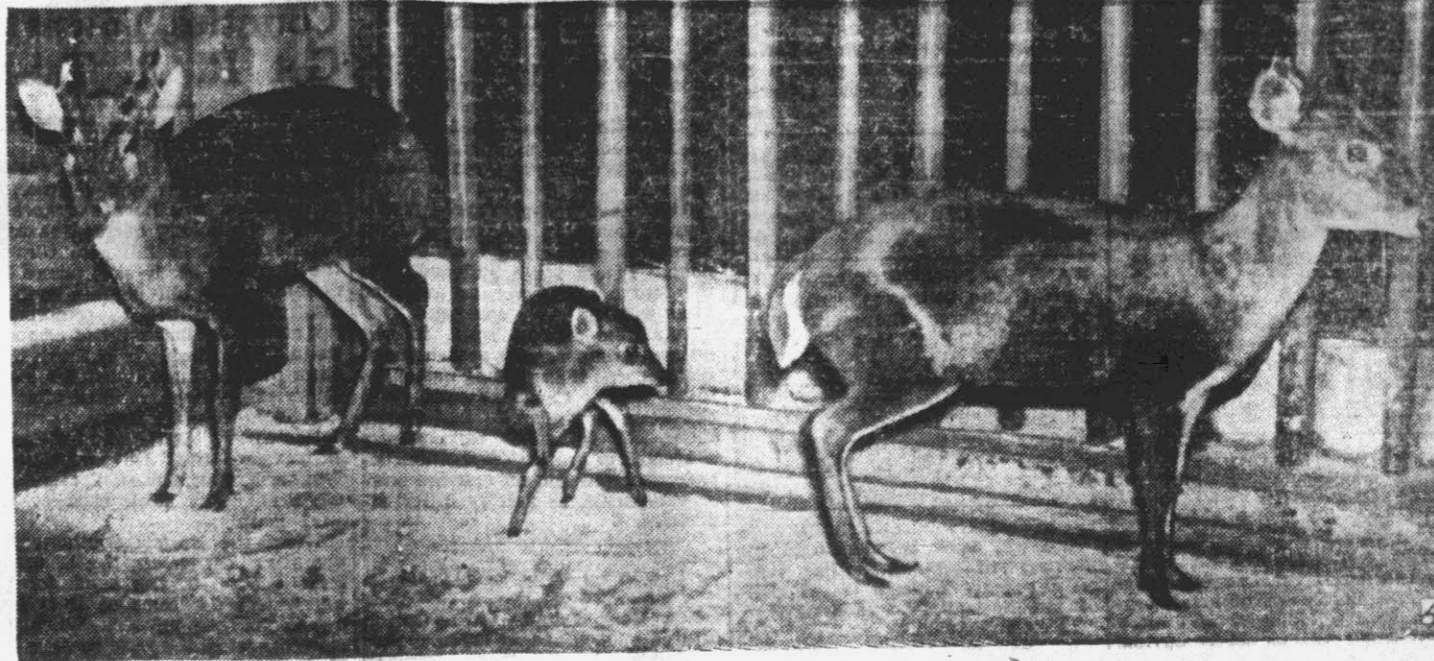
Has Ideas For Improvement.
Slichter, although often critical of the policies of the present administration, says the task of transferring the prosperity to a private basis is primarily one for private business managers. They must test new methods. He says lowering prices offers limited relief because the price level of finished goods already is below the 1929 level.

Boosting prices won't work, he adds, pointing out that while labor income increased during 1936-37, purchased of consumer goods did not increase correspondingly.

Slichter advises that wage scales be revised to allow the business manager to lower costs and thus to after new business. Hosiery workers have cooperated notably, he said. He cites rail wage scales as obstacles, asserting that they discourage railroad management from running faster lighter trains.

Railroads further are troubled, he said, by small blocs of security holders who hinder needed capital reorganizations. (There are moves afoot in Congress aimed at remedying that).

His analysis also puts the bee on

Exhibition Tilt

Temperature of some of the "witnesses" rose high at times, and there were thinly veiled charges of bad faith and inefficiency. The committee closed its weeks work by asking that three technical specialists from each department present in writing to the committee next Thursday a full analysis of points of agreement and difference. This may result in a permanent super-joint committee to supervise agricultural work in the state.

An earnest appeal to both departments and to committee members was made by House Chairman Eagles, who begged all interested parties not to jeopardize agricultural progress by petty spite and jealousy. Mr. Eagles pointed to a real danger there. Committee members individually voiced the opinion that differences and overlapping between the departments and the college were greatly exaggerated to begin with, but the attendant publicity has raised them to a place of much greater importance than the actual situation warrants. The point is that if most people believe the situation is so bad, then it is bad, because neither the college nor the department can function without popular support.

The appropriations committee during the week long study of the budget has spent more than half a million dollars off the budget commission proposals. Only one item was restored, that was \$9,000 for the biennium to match a like sum from the agricultural fund for credit union work. This item was not included by the budget commission. The hardest fight was made on the State ABC board which last year spent \$38,000 and asked for \$64,000 for each of the next two years. Compromise figures was \$43,210 a year. Back of this is considerable personal feeling that board members are not earning their money.

Hard put as the state is for money, few competent observers have an idea that all of the committee cuts will stand. They point out that every legislature has such an "economy" flurry about this stage of the session, and that later most of the budget recommendation dates are restored.

The money-raisers did not have as interesting week as the money spenders. Some wag might remark that they seldom do. The finance committee passed over, for the most part, controversial matters and spent the time approving sections over which there was little disagreement. The week ended with a rather general feeling that little chance would be made in the total revenue by actions of the finance committee to date; and with the hope, rather than the definite belief, that some increases might be found next week.

Taken together, action of the finance and appropriations committees indicate a reasonably close balance of the budget—if intangibles and antidiversion don't break up the plan.

The administration wage-hour bill and the so-called "Estate Bill" have been reviewed in this correspondence. Another bill hitting the hopper last week which might be far reaching in effect was Senator Sparks' repealer of common law rights to royalties on phonograph records and other "canned music." It is designed to stop collection of fees for the public use of such records but may result in taking the records off the market in this state.

Appealing to sentiment were the proposals by Murphy of Rowan for

Presence Of Rabbits Worry Peach Growers Carthage, Feb. 6.—Rabbits are becoming one of the chief worries of peach growers who own young orchards in Moore County, reports W. G. Caldwell, assistant farm agent of the State College Extension Service.

Of 4,000 two-year-old trees in the orchard of Hawley Poole, all but 500 have been severely damaged by rabbits, these animals eating the bark from around the trees. Not over 200 were left which were not damaged to some extent.

While not all orchards are damaged to this extent, all young orchards show the result of visits from the animals.

New York, Feb. 6.—(AP)—The stock market took a rallying cue from the utilities today as a number of the latter issues pushed into new high ground for more than a year with gains of one to seven points at the best.

Financial quarters consequently saw signs of greater cooperation between the government and the power companies, as well as other industries.

Counties, Towns to Get R. R. Taxes

Reflector's Bureau. By LYNN NISBET Raleigh, Feb. 6.—Five eastern Carolina counties and a dozen or more towns will have a chance to collect some long overdue taxes if Senator Larkins' bill goes through the House as easily as it passed the Senate.

The bill permits counties and municipalities to compromise tax claims against railroad companies in which the State of North Carolina owns a majority of the stock.

There is only one railroad affected, the Atlantic and North Carolina, better known as the "Mulleet Line." It traverses the five counties of Wayne, Lenoir, Jones, Craven and Cartaret. The stock back of the story is this:

When the Norfolk Southern was operating the A. & N. C. under lease the N. S. was liable for all taxes, just the same as if it had owned the road outright. When the state cancelled the lease because the N. S. was so badly behind in rental payments as well as taxes, there was something like \$200,000 due the counties and cities exclusive of interest and penalties.

The road has practically enough money to pay that tax bill, but the Reconstruction Finance Corporation has had first claim to it. Agreement has now been reached, according to sponsors of the legislation, whereby R.F.C. will release enough money to pay the principal tax claims, without interest, cost or penalties, and it was deemed advisable by legal authorities to have a special act authorizing the counties and municipalities to accept such payment and remit the charges.

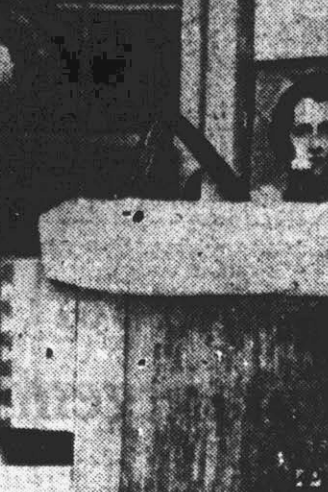
