SENATE VOTES TO DRAFT NEW N. C. UCC LAWS

No Debate Nor a Single Dissenting Vote On Measure

HOUSE DEBATES TOURIST CAMPS

Peanut and Peach Producers Appear Before Joint Subcommittee

Raleigh, Feb. 7.—(AP)—Senators approved today without a word of debate, and no dissenting votes, bills to re-write the law on unemployment compensation and give tax reductions to employers who stabilize employment.

The measures went to the House. They passed second roll call reading last night and final reading at noon.

Representatives debated briefly the Bryant-Pollard bill to license and regulate all tourist camps, cabin camps, dance halls and the like, then passed the measure on second reading.

An effort by Taylor of Caswell to send the bill back to committee brought from Fenner of Nash the statement "This bill is to clean up and to clean out the worst cess pool in North Carolina."

Caswell, Moore, Bladen, Hyde and Cabarrus counties were exempted. A House sub-committee on elections laws agreed to recommend passage of bills for a new state-wide registration and splitting of precincts where more than 1,000 persons voted in the last general election.

Peanut and peach producers urged a joint sub-committee on agriculture to provide funds for peach research and a new test farm to handle peach research. Alleged duplication of agricultural services was attacked by the peanut growers, who also urged ample provision for work in quick analysis of soil.

The joint appropriations committee this afternoon acted on allotments for educational institutions for 1939-41, while the joint Finance group heard arguments on a proposal to impose a crown tax on bottled soft drinks.

Representative Clegg of Moore introduced a bill to make it unlawful for any person carrying liability insurance on motor vehicles to accept any fee or payment from a garage mechanic involved in making repairs to such vehicles after accidents.

Three Defendants In Tuesday Court

The weekly session of Pitt county court was completed before the luncheon recess today, and although only three cases were tried, the docket is considered in good condition, with only a few cases remaining for trial at the close of the day's hearings.

Of the three cases tried one involved a highway accident one domestic difficulties and the third a whiskey charge.

Kirk Bennet was convicted of driving careless and reckless and ordered to pay the costs of court and his license was suspended for 90 days or until he pays M. L. Eason for property damage sustained in a collision.

Joe Briley, Negro, was convicted of non-support. His wife waived a demand for support and the court ordered him to pay \$5 now and \$1 each Saturday for the support of his child.

John Bradley, Negro, was convicted of having liquor for sale and was given a six-month sentence, suspended upon payment of \$40, costs to be deducted and the balance to go as a fine and upon further condition that the defendant not have any intoxicating liquors in his possession and show good behavior for the next two years.

Italy Pledges Support To Spanish Insurgents

New Spain

Paris, Feb. 7.—(AP)—Insurgent General Franco has given a promise of friendly relations between the "New Spain" and France, diplomatic informants said today.

Senator Berard, semi-official French envoy to Burgos, received this assurance from the insurgent administration and was returning to Paris "highly satisfied" with his exploratory talks, it was ascertained here.

His trip to Burgos during the military decline of the Spanish Government served as a prelude to possible recognition of General Franco as ruler of Spain by both Britain and France.

FLUE ATTACKS POPE PIUS, XI

All Scheduled Audiences Cancelled by Holy Father

Vatican City, Feb. 7.—(AP)—Pope Pius, XI, was said by a Vatican news service today to have been stricken with a mild attack of influenza which aggravated his chronic asthma and compelled him to "take all precautions."

Vatican circles said the pontiff was running a temperature of 99.5 degrees.

This was the second time in three months that he was forced to suspend his activities because of illness, but his staff did not summon cardinals who usually call when the pope's illness is serious.

Vatican circles said the Holy Father keenly missed the presence of his regular physician who has attended him almost daily since he was stricken ill in 1936. The physician himself is ill with influenza.

The Pope cancelled all scheduled audiences, but summoned Cardinal Pacelli, Papal Secretary of State. (Continued on page six)

Reflector Bureau By LYNN NISBET Raleigh, Feb. 7.—Sideline gossip over the week-end indicates that members and hangers-on of the legislature are thinking more and more about the 1940 campaign. There is less certainty at this stage about who will be the "administration candidate" for Governor next time than there has been at a next time legislature since 1925.

Will Demand Political As Well As Military Victory

Rome, Feb. 7.—(AP)—Virginio Gayda insisted today that the Spanish Insurgents would continue to get Italian and German support until they had won a "political" as well as a military victory, despite reports of an official recognition of his earlier statement that Italian troops would remain in Spain even after the end of the war.

The usually authoritative Fascist editor, who often reflects Premier Mussolini's views, did not, however, repeat specifically his assertion that troops would remain in Spain. Reliable sources said the British government had been assured by Foreign Minister Count Ciano that the Sunday statement on troops did not represent Fascist policy.

In his editorial in his paper today Gayda set forth four prerequisites for a complete insurgent victory:

1. Demobilization of Spanish Republican Government forces which had found refuge in France.

2. Resignation and dispersal of the Republican army with no armistice negotiations.

3. Return of the Bank of Spain's gold stock which the Government had deposited abroad. Gayda said British Prime Minister Chamberlain's announcement yesterday of an "immediately functioning military alliance between Great Britain and France" caused no surprise in Italy.

The question in Fascist minds, Gayda said, was whether Britain "unconditionally swallows the intransigent and one-sided policy of France against Italy and Germany and their claims."

Dies At Wheel Of Auto. Ernest Nobles, Greenville Negro, mechanic, died suddenly while seated in his automobile this morning and just as he started to drive onto the highway from a filling station on West Fifth street. Death was attributed to heart trouble.

Two Democracies Plan Recognition Of Franco Regime

With End of 30-Months Strife Imminent, Britain, France Authoritatively Reported, Considering Recognition of Rebels

London, Feb. 7.—(AP)—British Foreign Office officials said today Great Britain and France were considering recognition of the insurgent regime of General Franco as the sole official government of Spain.

Spanish Insurgent authorities in London said Franco has not yet asked for de jure recognition of his government.

British officials said, however, that unless Franco is recognized soon the insurgents would look entirely to Germany and Italy for aid in rehabilitating Spain.

In diplomatic quarters it was said Britain might even offer immediate recognition of Franco provided he agrees to end hostilities at once. This suggestion, however, had not been raised officially.

Perpignan, France, Feb. 7.—(AP)—An end to the civil war which has paralyzed Spain and endangered the peace of Europe for 30 months, appeared imminent today.

Dr. Negrin, Premier of Government Spain, and his last die-hard supporters were reported in diplomatic circles to be swinging around to the view that they must yield.

President Azana abandoned all appearance of clinging to his post as chief executive of the republic. After coming to France Sunday and staying a day near the frontier he went to a French retreat near Geneva.

Fighting in northern Spain appeared to be over. Insurgent General Franco checked. (Continued on page six)

DEATH CLAIMS C. F. CARROLL

Veteran Newspaper Man Dies Following Stroke

Charles F. Carroll, Sr., 49, veteran newspaper man of Greenville, died at Pitt General Hospital at 3:55 o'clock this afternoon, following a stroke of paralysis suffered Saturday morning.

Funeral services had not been arranged, but members of the family said they probably would be held some time tomorrow.

Mr. Carroll apparently was in his usual health last Thursday, but became ill Friday morning and went to bed about noon. The stroke followed Saturday morning and he was taken to the hospital Saturday afternoon.

Mr. Carroll had worked for several papers in Eastern North Carolina and also had published two, one at Kinston and one at New Bern. At the time of his death he was employed by The Daily Reflector.

A native of South Carolina, Mr. Carroll came to Greenville about 1912, and later was married to Miss Elizabeth Ploff, native of New York State, who was staying here at the time.

He is survived by his wife; two daughters, Mrs. Clarence B. Whigham, Jr. and Miss Gloria Carroll; five sons, Charles, Jr., also an employee of The Reflector; Eugene Spencer, Walter Bickett, and Larry Carroll; one brother, Walter J. Carroll of Gastonia; and one sister, Mrs. H. V. Hoover of Durham. He also is survived by two grandchildren.

Farmers To Make Shipment Of Hogs

Pitt county farmers are cooperating in marketing hogs through the livestock marketing unit of the Pitt County Mutual Exchange.

As an improvement over the old method of shipping hogs on a consignment basis, a group of farmers in Pitt county met in 1937 and organized a livestock marketing board. Through their association the farmers have marketed in 1937 and 1938, 3,454 head of hogs weighing 68,443 pounds and brought \$61,900.80 to the farmers.

The principle on which the producers market their hogs through their own association is that the hogs are assembled by the farmers and are weighed and graded by a person who is disinterested financially.

Competitive bids are received by wire from the packers on the interested markets.

The highest bidder is notified that he gets the hogs and the hogs are loaded into the cars and shipped to the buyer. A draft is then drawn on the buyer and the association writes the farmer a check, withholding the discount for soft and oily hogs.

Under this system each lot of hogs and each hog is marketed on the basis of quality. A number is tattooed on each hog, identifying that hog as belonging to a certain farmer. If the hog kills hard, the farmer receives the premium for hard hogs in a second check. If the hog kills soft or oily then the farmer who has hard hogs is not penalized as he would be if the hogs were sold on a flat basis.

COUNTY BOARD EXTENDS MEET

Several Matters Discussed by Commissioners Today

The Board of County Commissioners, unable to complete its monthly session yesterday, continued its session today and took up several important proposals.

The board officially terminated the services of E. W. Braxton as deputy tax collector, who has been employed on a temporary basis since December 1, and employed J. L. Foster of Grimsland to fill the position, effective March 1. Mr. Outlaw will draw a salary of \$175 monthly, out of which he will have to pay his own traveling expenses.

After taking action yesterday to secure roads for Belvoir and Paction townships, the board today passed on three petitions for improvements to secondary roads in the county and ordered the petitions sent to the district highway engineer to be called to the attention of the State Highway and Public Works Commission. The petitions requested: that a road be opened and improved in Bethel township from Highway No. 64 to Whitfield and Hammond road; that the dirt road in Aiden township from a point near Harvey Dail's farm to the intersection of the Ayden-Snow Hill highway be widened; that a road in the Black Jack area near Cox's mill be improved. It was pointed out in the petitions that improvement of these roads is necessary for the convenience and protection of school children being transported to and from schools in the respective communities.

F. M. Wooten appeared before the board in regard to the Swift Creek drainage canal. He stated that the canal in this county drained into Craven county and covered a large tract of land there since the canal was not extended thru Craven to the natural channel of the Swift Creek. The board adopted a resolution requesting Craven officials to petition its Congressman, Representative Barden to attempt to get a WPA project to complete the Craven end of the project and carry the canal to the natural channel of the Swift Creek. The Pitt board also adopted a resolution urging Congressman Warren of this district to support Rep. Barden in procuring the WPA project for Craven county and setting forth that the proposal would be a health measure in that it would aid in the control of malaria.

Raleigh, Feb. 1.—(AP) Hallet S. Ward, Washington lawyer, argued to the Supreme Court today that "South Carolina Negroes like South Carolina buzzards, each has a distinct individuality in North Carolina" as he pleaded for reversal of a death sentence imposed on James Page.

Page described as a South Carolina born Negro was convicted of raping Mary McBurn, a 22-year-old show girl, last fall in Beaufort county, the argument opened the court's spring term.

Ward, a picturesque former legislator, told the court that Page was "lonesome as a jackass in a hail storm" and contended that an examination of the woman by a physician showed "no signs of violence after the alleged attack." The court has 20 cases for argument for the week, two specially set and the others from the first, twentieth and twenty-first district.

Floods And Snow Storm Visit Parts Of Nation

Ten Thousand Families Affected In Ohio Valley

(By The Associated Press) Rising flood waters harassed areas of the Ohio valley today, while a Pacific storm brought heavy snow to the northwest and possibly death to nine seine fishermen.

The Red Cross estimated 10,000 families in five states were affected by the Ohio flood, described by the Kentucky State Health commissioner as the worst in the history of the mountains.

A heavy list in east Kentucky, where Ohio river tributaries climbed to higher river levels, was feared.

Newport, Ky., authorities estimated 600 families had been removed from homes when the water flooded 35 city blocks, preparations were made for further evacuation.

The 68-foot Sunnysbo, a purse seiner enroute from San Francisco to Seattle, disappeared early Monday in a rain squall and the master of a companion boat feared the boat and its nine hands had been lost.

The storm covered northern Idaho and eastern Washington with snow and drifts marooned 20 patrons of a Mount Hood resort.

Fishing Craft Not Heard from Since Early Monday

Port Angeles, Wash., Feb. 7.—(AP)—Lieut.-Commander Norman Nelson, coast guard air station commander, said the purse-seiner Sunnysbo, reported missing off the Oregon coast last night, had reached the strait of Juan de Fuca at 8:15 a. m. (PST) today, apparently in good condition.

Portland, Ore.—Feb. 7.—(AP)—A purse-seine fishing boat with nine men aboard was believed today a victim of the storm that smashed against the northwest corner of the United States and Canada yesterday and last night.

The 68-foot Sunnysbo, en route from San Francisco to Seattle with two other purse seiners disappeared early Monday in a rain squall off a rugged section of Oregon coast. Captain Sam Mirkovich of the Wanderer, one of the other two seiners, a brother-in-law of Sunnysbo's captain M. Mirkovich said he felt certain the boat had gone down with all hands.

SUM CUT FROM RELIEF FUNDS ASKED BY FDR

Seeks Exact Amount Lopped Off From Previous Bill

DESIRES PROMPT CONSIDERATION

House Military Committee, Meanwhile, Approves Special Defense Program

Washington, Feb. 7.—(AP)—President Roosevelt today provided Congress with new cause for debate on relief, in sending a special message asking "immediate consideration" of an additional appropriation of \$150,000,000 to operate WPA until June 30.

This was the exact amount Congress cut off his request last month for a \$870,000,000 WPA appropriation. He signed the bill for the reduced sum, \$725,000,000, on Saturday and with his message today insisted that the original amount was needed.

In asking immediate consideration on what he termed the "simple and alarming facts" in the relief outlook, Mr. Roosevelt said that with only \$725,000,000 available, WPA either must reduce its rolls abruptly on April 1 by 1,000,000 persons or begin on that date a week-by-week reduction which by June 30 would drop employment from a present 3,000,000 to "a figure well below 1,500,000 persons."

"In other words," the President said, "the program of present employment would be slashed considerably more than one-half within a period of three months."

"If, however, proper reserves were maintained at the end of the fiscal year, employment at the end of June would drop still further—to a figure of only slightly more than one million persons."

Chairman May (D.-Ky.) said today the House Military committee had unanimously approved legislation to authorize the major parts of President Roosevelt's \$882,000,000 special defense program, including expansion of the army air corps to 5,500 planes.

Action on the bill came, he said, after Republican members of the committee sought unsuccessfully to limit the War Department's production to no more than 1,000 planes in any fiscal year.

Representative Andrews (R.-N.Y.) senior minority member of the group, said the limitation proposal was defeated, 15-10, on a "straight party vote."

May declined to say how the committee divided on his original proposal to give the air corps a total of 6,000 planes.

Meanwhile, in another committee the touchy issue of foreign policy, particularly toward Japan, bobbed up again.

"I am broadly supported by public opinion," Walter W. Van Kirk told the House Naval committee in stating that "nobody in this country does know what the foreign policy is—where the Congress is drifting."

Van Kirk said he spoke for 42 peace organizations.

Mayor LaGuardia of New York, strongly endorsed the President's nomination of Thomas Amle to be a member of the Interstate Commerce Commission.

**Speaks To Woman's Club.**  
On Friday afternoon at 2:30 the regular meeting of the Woman's Club was held at the club house. In the absence of the president and vice-president, Mrs. Vance Perkins presided. The meeting was opened with the collect and club hymn, after which Mrs. Perkins presented Mr. John A. Lang, state director of N. Y. A.

Mr. Lang said "The problem of youth adjustment concerns us all. For the last eight years we have been passing through a great economical and political and social adjustment. Youth has been caught in the treadmill of the times. We should be more concerned about our youth when these facts are true. There are more arrests between ages 1 to 25 than any other span of years.

"In days gone by, there was the frontier, cities and mills in towns where youth could seek employment. Today business is not taking in as many youths. The things we can do as a club or as a Pitt county citizen is to study natural problems—then do something about it.

"Out of 25,000 high school students statistics showed only 18.4 per cent graduated. Are those who did not graduate prepared to enter some field of business?  
"Youth should be fitted to the type of life he needs and trained in school to meet this need. Whether he be prospective farmer, mechanic, engineer, dairyman, etc. He needs this training early if he cannot go to college.

"Our educational system in North Carolina needs to be raised. We are one of a few states that does not have the twelfth grade throughout the state. Then, too, we need more pay for teachers. They get less than bricklayers, yet the teachers have our most precious possession in their care, moulding our youth.

"We need more vocational training."

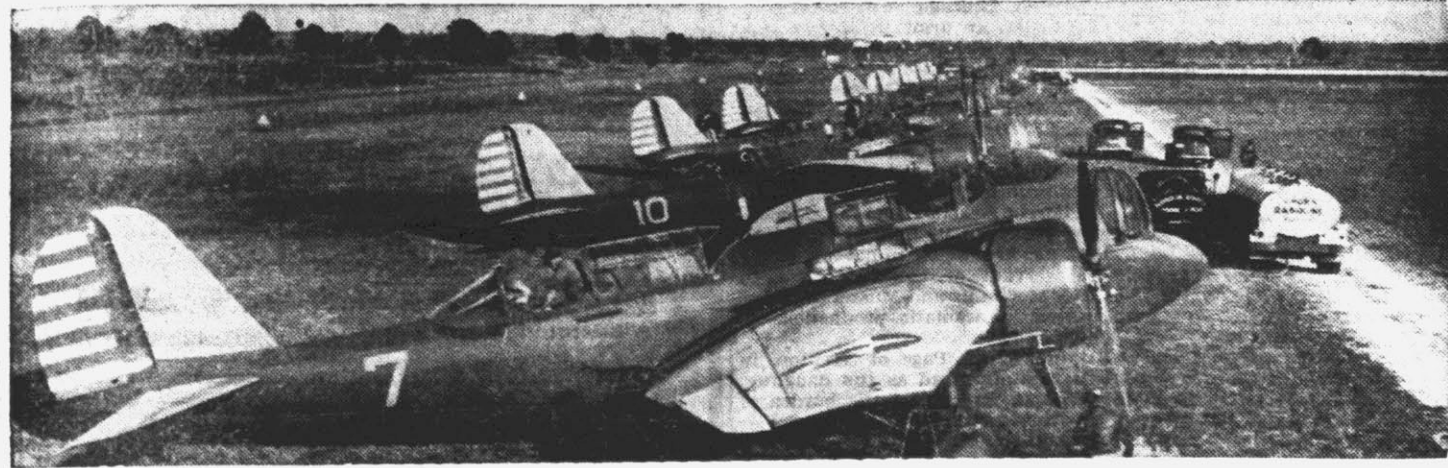

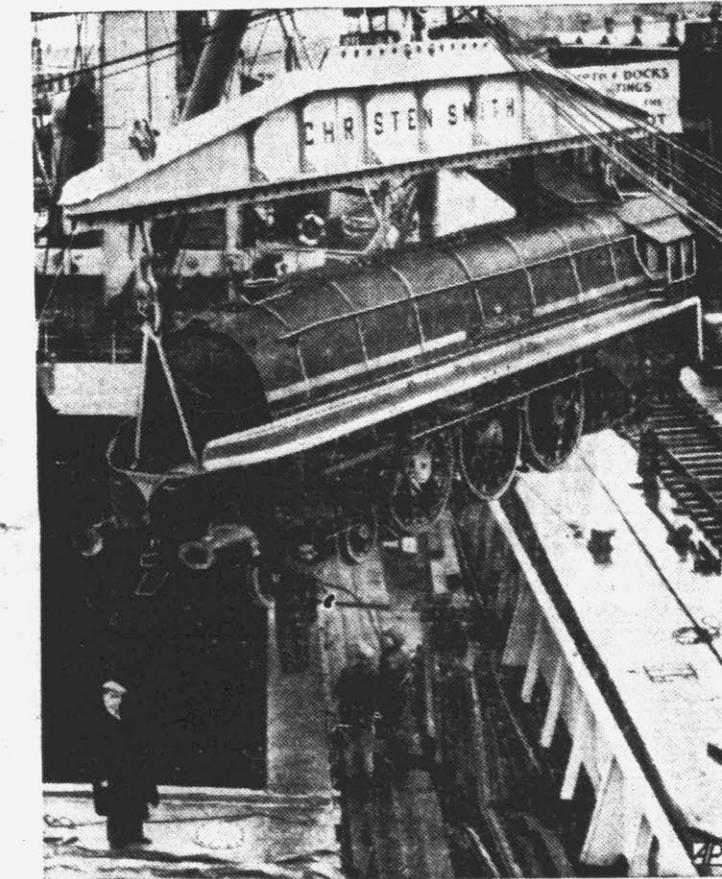

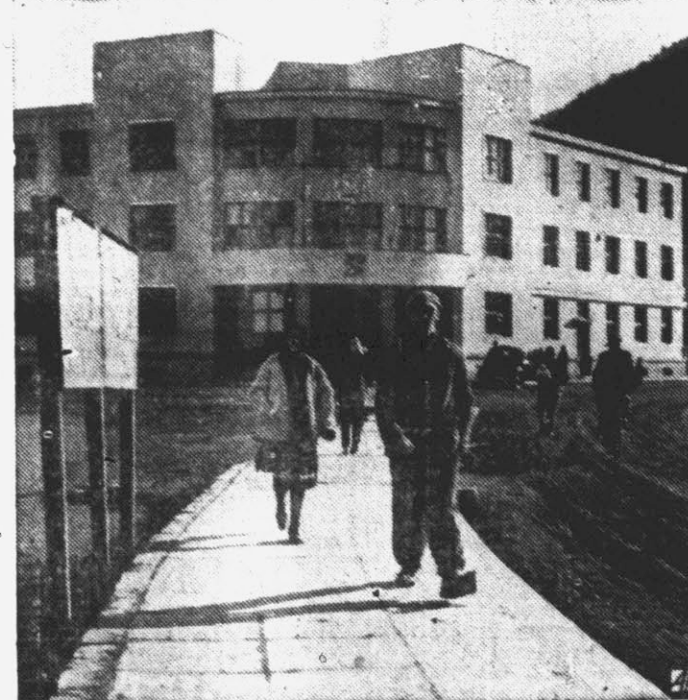

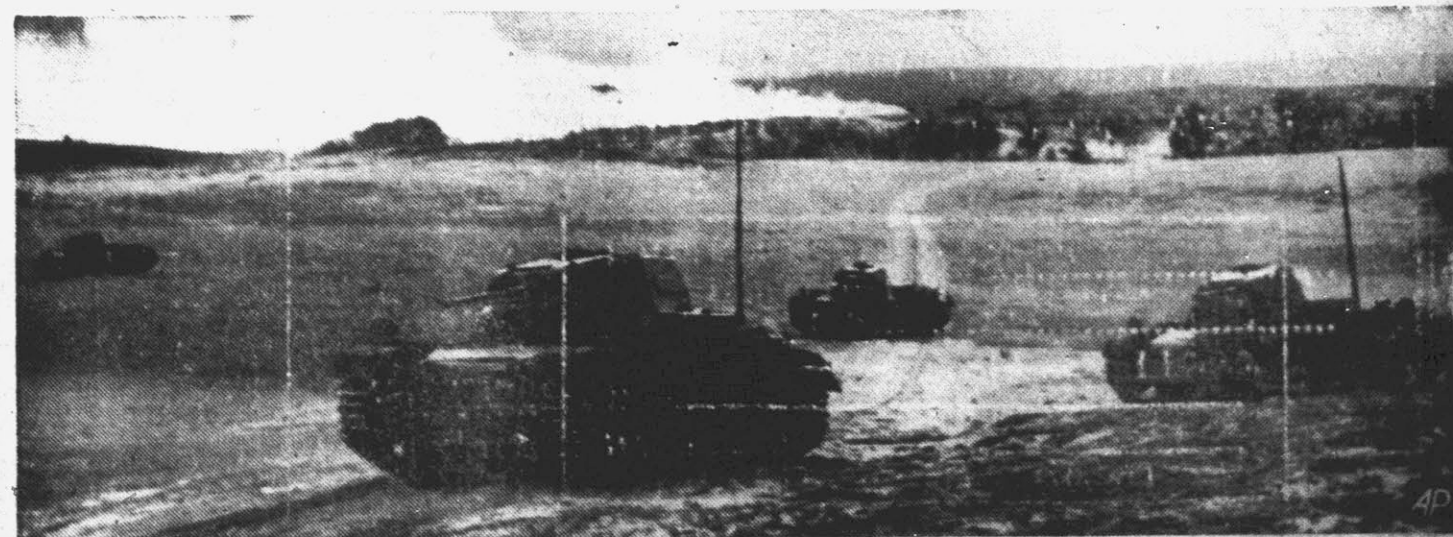

IT SMELLS BAD

(Industrial News Review)

The unpleasant odor that has surrounded relief activities in many states has at last reached the sensitive nose of Congress.

First step in this overhauling was to cut the proposed appropriation of \$875,000, 000 to be spent up to June 30 by the WPA, to \$725,000, 000. Then the House tacked on a number of salutary amendments to the bill, including strictures denying WPA relief payment to aliens, denying WPA money to any person attempting to influence the political opinion of another, and making illegal for a WPA supervisor to bring political pressure on those beneath him.

There is ample evidence to support the statement that the public has become sickened of too much politics in relief administration. It feels that maximum economy is essential if the business of providing for the jobless isn't to bankrupt those who still have jobs.

It is believed by persons in close touch with conditions, that untold millions of dollars could be saved annually simply by divorcing relief from politics, waste, excessive bureaucracy and red tape—without reducing the scale of living of the relief beneficiary.

GOOD TURN TO BOY NETS LIFE JOB OFFER

Jenkins, Ky. AP. C. E. Gifford, veteran Eastern Kentucky coal miner, rescued 20 cents in a meal for a hungry Indiana farm boy last summer, and persuaded the youth to return home.

Recently, Gifford received a letter from the youth's father, T. H. Alexander, of near Martinsville, Ind., offering him a home on the farm for life.

Gifford, who has spent 54 of his 65 years in the mines, had been without steady employment two years.

ILLINOIS SATISFIED MOST SUGAR-TEETH

Chicago (AP). Illinois led all other states in candy making during 1937.

Federal figures show that 108 Illinois candy plants, employing 13,657 employees on a payroll totaling \$13,625,578, produced \$90,371,121 worth of confectionery products during the year, or nearly one-third of the nation's \$305,839,262 supply.

New York state rated second with a \$29,460,555 output; Pennsylvania \$22,512,294; Massachusetts \$30,626,298.

SHORT SHOTS

Raleigh, Feb. 7.—Slot machines took up more than an hour of the Finance committee's time yesterday afternoon, with final outcome the adoption of a section which Revenue Department officials estimate will raise from \$200,000 to \$300,000 annually instead of the \$23,000 actually produced by the corresponding section last year.

This "estimating" or "guessing" led vigilant Gregg Cherry to announce "You can't jump revenue that way without taxing gambling machines." He offered an amendment providing that the new section be non-retroactive.

At one stage Gregg sought to question Senator Thomas J. Gold of Guilford who had just announced "I'm willing to take a chance there will be some gambling on some of them somewhere if it will produce that much revenue. Senator Gold finally yielded after expressing fear that the gentleman from Gaston is so sarcastic I'm afraid to get into a debate with him."

Nash's Bill Fenner, House Finance chairman, was with Cherry. He said: "Anytime I think I've killed a snake and think he's dead and then he turns round and bites me, I'm afraid of him."

None of the committee members suggested any way to tax or get rid of the two One-Armed bandits which on Sunday were operating full blast in Steve's Place, fine Fayetteville restaurant.

"The best way to solve the problem of dissenation in your own group is to start a big fight against some outsider," remarked a legislative attaché this morning. "I understand that there has been some friction among faculty members at State College lately, and that may be one of the reasons for the assault of the college is making on the state agricultural fund." The same man continued by saying that he did not like the idea of giving over control of too many state functions to the federal government.

Some western legislators, returning from week-ends at home express genuine surprise at the vote in Hertford county on ABC stores. Hertford is right among a lot of central counties, and these westerners had expected that it would vote for the stores by a big majority. The strong anti-control sentiment manifested there Saturday has encouraged some of those who seek to make the whole state legally "dry."

A well known capital city politician was walking down Fayetteville street last night, when he was accosted by a stranger bearing all the earmarks of a country-town ward heeler who asked, "Can you tell me where I will find that lawyer that wants to run for governor?" asked the stranger. Without hesitation the Raleigh man answered, "Just stop the first man you meet walking up Fayetteville street. That will be him."

With only one social function last week to which all members had exclusive invitations—the Wake County Young Democrats reception—and with none on tap this week, legislators are looking to the Charlotte trip next Wednesday.

(Continued from page one) eight years is not so long and administration folks haven't forgotten 1932. Mr. Maxwell may run, but he will not have full blessing of the "ins."

Congressman Warren has everythink the administrationists want. Ability, popularity, experience, record, etc., of the first district man are perfect. But he is believed to prefer his chances for speakership of the national House of Representatives.

Some advances have been made to Congressman Cooley of the fourth district. He would be acceptable to the administration largely because of his recognized popularity and ability as a campaigner. But Mr. Cooley is known to be looking at Senator Bailey's seat rather than at Governor Hoey's.

Of the dozen or more other suggested candidates—Mayor Tom Cooper of Wilmington, Tobaccoist Lee Gravelly of Rocky Mount; Banker-Auto Dealer Flanagan of Greenville, State Treasurer Charlie Johnson—only the last named would be acceptable to the present regime, and there is the fear that he might be "too close."

That leaves one man, sometimes mentioned but to date not very seriously considered, who has everythink needed—Willis Smith of Raleigh. As speaker of the 1931 House he made a statewide reputation. Native of Elizabeth City, in the far east; son-in-law of Judge Tom Lee, political power of the far west; widely acceptable to, but not closely identified with, the Gardner-Hoey group; well-liked by Piedmont industrialists and no on Labor's black list; Willis Smith is coming to be mentioned more often as the current legislator near mid-term.

If that intangible, invisible, elusive, but powerful group, known as "the administration forces," can get Lindsay Warren they want him. If they can't get him, today's indications are that they would rather have Willis Smith than any of the other extensible candidates. The 1939 legislature has from six weeks to three months to run. It is a full year before the 1940 campaign really gets under way. Many, many things can happen and fall to happen. Any prophecy now would be foolish. As of today, the trend is as herein outlined.

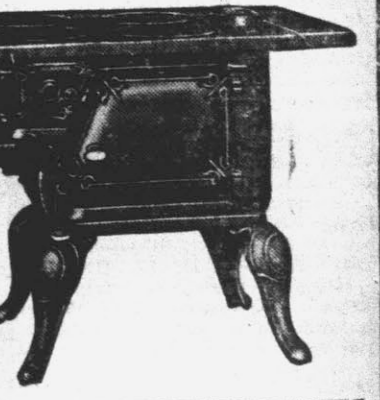

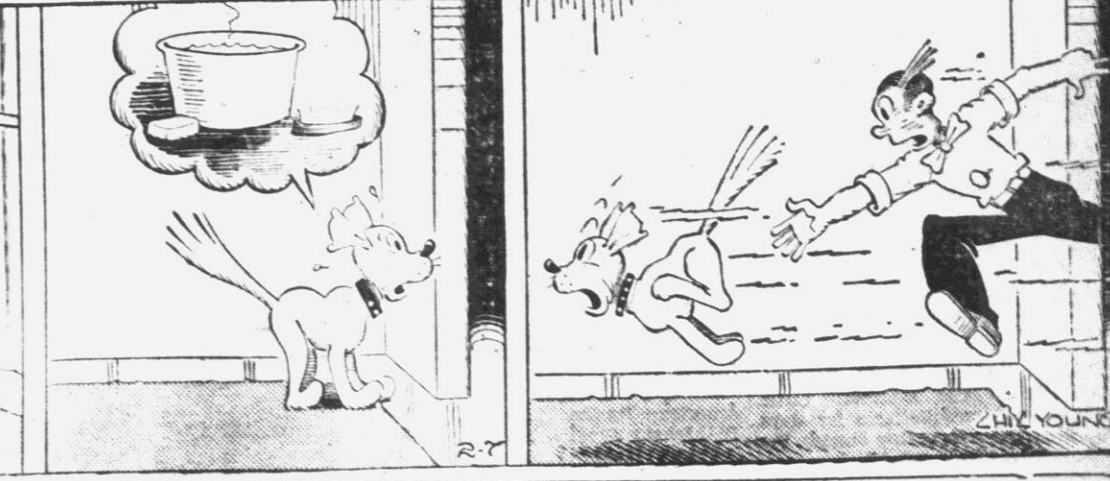

be weighed and graded in the county and inspected in the coolers after the heat has been driven out of the meat, by men who are not interested financially in the transaction.

This cooperative movement by farmers has not only increased their income, but there is a marked improvement in the quality of hogs marketed and a comparison shows that the farmers' f.o.b. shipment prices are averaging 85c per 100 pounds nearer the market's quotations in 1938 than they were able to get in 1928.

Interest in hogs is increasing in Pitt county as an additional source of farm income. This is a healthy condition for a progressive agriculture and farmers should plan to have some hogs to sell throughout the year. It was declared at the county agent's office.

The farmers will make a shipment of hogs Wednesday morning. All farmers who have hogs for shipment should notify the county agent's office.

## EXEMPTION OF PRESS SOUGHT

### News Photographers Ask Protection From Position

Reflector Bureau.  
Raleigh, Feb. 7.—North Carolina's press photographers are petitioning the General Assembly to define their status under the law and to protect them from embarrassment because of what they call their "peculiar" position.

The photographers' association, meeting at Pinehurst this week, unanimously resolved against their inclusion in any law affecting commercial photography. The legislators were asked to insert an amendment in the present law or any proposed act affecting photography, in which press photographers would be specifically exempted from its provisions. President Frank Jones, Winston-Salem outlined the position.

The newspapermen say that commercial photographers warring on itinerant picture takers and bad practices in the profession have unwittingly put a legal disability upon the press boys.

The law prohibiting sale of photo prints except by licensed commercial photographers fails to take into account, press photo men say, the fact that they are frequently called upon to furnish prints of their news shots.

Such news pictures, the association of news men contends, are peculiar to their calling, are almost always spontaneous and unarranged and are not in any sense encroachments on the commercial field.

News pictures are made for republication in newspapers and not for sale, and any demand for them on the part of persons pictures is purely incidental, unsolicited and uncalculated, said Jones. Just the same, newspaper men usually attempt to fill any request for such pictures, though many of them say sale of such prints is more of a nuisance than a real revenue-producer.

The association is asking that the peculiar nature of news photos and the sale of prints as a by-product be recognized under law.

## PEANUT GROUP GETS HEARING

### Appears before House Committee On Agriculture

Reflector Bureau.  
Raleigh, Feb. 7.—More peanuts, better pickers, and more money for the goobers produced was the desire loudly voiced by a large group of Eastern Carolina farmers here today. More dignified statement of the fact would be to say that a stable delegation of peanut growers from the Albemarle section appeared before the house committee on agriculture and asked for establishment of another peanut test farm in their area. The news value of the incident is greatly enhanced by the additional request that the test farm be administered by State College.

This runs squarely into the current argument over duplication of activities between the College and the state department and calls to mind a little recent history about the establishment of the peanut test farm in Edgecombe county last year.

The group here today is made up largely of growers of peanuts for commercial sale; that is, for re-selling as peanuts or for processing into peanut butter. There is another group of farmers, as numerous or more so, who feed their peanuts to pigs and sell them through cooperative hog shipments who are much better satisfied with the present set-up on peanut research than are the commercial growers.

And back of both groups stands the Farm Bureau, which has assumed in the present legislature an importance reminiscent of the old Farmers Alliance of the nineties, and has become the vociferous champion of State College in the argument with the State Department of Agriculture for more control. In fact, the whole of the current scrap over control of agricultural funds was precipitated by high officials of the Farm Bureau.

But getting back to peanuts. The delegation here today asked for a public hearing before the committee on agriculture to see if they could get another peanut test farm established on the existing one near Tarboro moved further east. That raises the question of why the farm was located in Edgecombe county.

When the demand for a special peanut testing and research such proportions as to demand action, the state board of agriculture authorized one to be established. Department executives called in soil and crop specialists from State College, and weeks were spent in looking over suggested locations. Finally the soil specialists reported that the best location found was adjoining the state test farm near Tarboro.

On this location were found all types of peanut soil, whereas other
