FRANCE NAMES MINISTERS TO REBEL REGIME

Brother - In - Law of General Is Chosen Premier

SNAG IS STRUCK IN NEGOTIATIONS

Conversations Suspended Abruptly When Franco Demands Unconstitutional Surrender.

Perpignan, France, Feb. 20. (AP) - Nationalist Generalissimo Francisco Franco was said today to be planning to name a new government of eight cabinet ministers under the nominal direction of his brother-in-law, Serrano Sumner, as Premier.

The generalissimo, these sources said, will retain his title as chief of state and supreme commander of the army.

France has filled most of the spots on paper, these reports declared, but the actual change may not take place before the central zone of Spain is occupied.

There is presently Minister of Interior and one of the outstanding leaders of the Salangists (Fascists). He has been working publicly in the Nationalist government a little more than a year.

French negotiations with Franco for peace in Spain and for recognition of his Nationalist regime have been suspended abruptly.

The observations struck a snag at the Nationalist Burgos headquarters last night when Franco's delegates ruled that only unconditional surrender of Republican Spain or final victory for Nationalist arms could end the civil war.

The French mission had been instructed to seek a promise of leniency toward the Republican side, as well as assurances that Spain would be rid of Italian and German forces as a basis of the recognition of France, which it hoped would bring peace.

Dislikes Being An 'Obstructionist'

Raleigh, Feb. 20.—Newspaper pictures of John Kerr, Jr. as an obstructionist and one of a die-hard group who opposes all reform of the State's election laws, are vastly overdrawn, the Warren county representative and son of the Second District Congressman, declares without heat or rancor.

"As a matter of fact, I am really more for reform than are some of the loudest vocal champions of reform, but I do not believe in rushing headlong through the legislature some bill or bills which might well prove as obnoxious as the present absentee law," he explained.

Outlining his position, he described the absentee ballot as "right in principle" and expressed a determination to fight for its retention in both primaries and general elections.

"If it is right in principle, it ought not to be abolished at all, but to get rid of it is primaries and keep it for use against the Republicans in general elections is certainly not my idea of real reform," he said.

BARKLEY AIDE IS GIVEN POST

Campaign Manager Approved as Federal Judge

Washington, Feb. 20.—(AP)—A union labor contention that Senator Barkley, the Democratic leader, had made a "promise" to his 1938 campaign manager was filed with the Senate Judiciary committee today.

Despite the protest, the committee approved President Roosevelt's nomination of Shackelford Miller, Jr. to be a federal district judge in Kentucky. Miller was Barkley's campaign manager in the state's hot Democratic primary last year.

"Knowing of some of the trades that were made at the beginning of Senator Barkley's re-election campaign," Edward Weyler, secretary of the state A. F. L. organization, wrote the committee "We do not think this promise of the federal judgeship to Miller was very ethical."

Weyler said he had a letter from Barkley stating: "I could not and in good conscience would not ask Mr. Miller to sacrifice nearly a year of his time in managing my campaign for re-election and then deny him any endorsement when he wanted to be appointed a federal judge."

M'CALL GIVEN FOUR-DAY STAY OF EXECUTION

Head Had Been Shaved for Execution Set for Today

TO FILE APPEAL SUPREME COURT

Relatives Had Said Good-Bye Yesterday To Abductor of 5-Year-Old Cash Boy

Raiford, Fla., Feb. 20. (AP)—Franklin Pierce McCall, his head shaved for the electric chair, was granted a stay of execution today until next Friday to permit an appeal to the United States Supreme Court of his conviction in the death of five-year-old James Bailey Cash, Jr., who was kidnapped and killed last May.

McCall was to have died at the State prison farm here today. Superintendent L. F. Chapman of the prison said he ordered postponement under authority given by the death warrant to hold executions any day of the week set by the Governor. He said he acted after a telephone conversation with Gov. Fred Cone.

The stay was obtained after relatives bade cheerful good-byes yesterday to the youth who confessed kidnapping the Cash child and collecting \$10,000 ransom after his victim was dead.

C. A. Avriett, McCall's attorney, said he would go to Washington immediately to present the case to the United States Supreme court.

WILL ENLARGE FESTIVAL HERE

Greenville Headquarters for Big Musical Contest

Beginning next year the districts for the State Music Contest will be reduced from 15 to eight and the local district will be more than doubled in size as the area taking in all of Eastern Carolina with exception of the area around Elizabeth City and Currituck and southeastern area around Wilmington.

This action was taken at a meeting of the state committee in Greensboro on Saturday, presided over by Dean Hugh Altavater of Woman's College and which was attended by Supt. J. H. Rose of Greenville, a member of the committee.

It also was decided at the meeting that no junior high pupils will be allowed to enter state contests at Greensboro.

The endangering of the Greenville district will bring to this city additional hundreds of school music contestants and also will make it necessary for the district contests to run two days instead of one.

Mr. Rose has been advocating the changes several years for two reasons, he said. First because it is becoming an impossibility for Greensboro properly to take care of the thousands who now go to the state contest, and second, because the enlarged district contest will bring to the district contests large numbers of the smaller high schools who are now taking no part in the program, thus stimulating the study of music in the smaller schools.

ITALIAN NEWSPAPER ASSAILS ROOSEVELT

Rome, Feb. 20.—(AP)—Foreign Minister Count Galeazzo Ciano's newspaper charged today that an "imperialistic puritan minority" of American leaders, headed by President Roosevelt, was starting the United States toward a "democratic war."

In the paper's leading editorial it was said that the "army of American minds, even more dangerous than enormous material armaments, failed to impress Italians.

Italians do not believe, the paper asserted that providence has given Americans a "black check" on which they can write any victory they want.

The editorial appeared as Marshal Pietro Badoglio, chief of the Italian general staff, arrived in Libya on a mysterious mission which foreign observers believed had some connection with recent troop reinforcements in that Italian territory adjoining Tunisia. French North African protectorate, Tunisia figures largely in an Italian campaign for French territory.

KING CONFERS WITH BRITISH DEFENSE HEADS

Conversation Precedes House Rearmament Debate

KING RECEIVES CHIEF OF STAFF

Government to Ask Parliament to Approve Costliest Peace-time Program

London, Feb. 20.—(AP)—King George, VI, and Prime Minister Chamberlain conferred today with key defense chiefs prior to a full dress rearmament debate in the House of Commons set against a background of increasing European tension over Spain and Italian-French differences.

The monarch received Viscount Gort, chief of the Imperial General staff who recently returned from a tour of Britain's Near Eastern defenses, and Chamberlain conferred with Admiral Baron Chatfield and Admiral Rofer Backhouse, Lord Commissioner of the Admiralty and chief of the naval staff.

Lord Chatfield was named Minister for Co-ordination of defense in a cabinet shake-up January 28.

The British government asked Parliament to approve what probably is the costliest peacetime rearmament program in history, its purpose strengthened by uneasy developments in the European struggle for mastery of Spain and the Mediterranean.

Hoey Says Special Court Judges Serve Purpose

Raleigh, Feb. 20.—(AP)—Governor Hoey said today he did not feel there is any necessity for this legislature to create additional Superior court districts as it has enacted a law to permit continuance of special judges.

The governor said he would present to the legislature "as information" the report of a special commission on judicial districts, which recommended increasing the number of districts from 21 to some-where between 24 to 27.

The judicial district commission was authorized by the 1937 legislature and its report will be given to legislators tonight.

In its report the commission said special judges had rendered a great service, but that it was "of the opinion that the policy of having special judges is a makeshift for the (Continued on page six)

DELIVERY BOY WRECK VICTIM

Struck by Auto; Girl Hurt in Another Crash

A 17-year-old grocery delivery boy was killed almost instantly and a five-year-old girl was seriously injured in accidents near Greenville Saturday night.

Johnnie Harrison, son of Mr. and Mrs. Ed Harrison of near Greenville, died at 12:15 o'clock Saturday night after the motor-bike he was riding was struck by an automobile driven by Arthur Harrington, 19, of Bethel. The accident occurred on the Tar river bridge here. The youth was dashed against the hood of the automobile and then was thrown over the embankment into the water from the overflowing river. He died five minutes after the accident.

Although it developed that the motor-bike had no lights, it was brought out at a coroner's inquest this morning that Harrington did not have any driving license and consequently was ordered held on a technical charge of manslaughter. Bond of \$500 was provided.

Funeral services for the victim were conducted at the home near Fleming's crossroads this afternoon at 3 o'clock. Rev. Worth Wicker of the local Episcopal church conducted the services. Burial followed in the House cemetery on the Pactolus road.

Besides his parents, young Harrison is survived by five brothers, Sammie, Norland, Bernie, Huey and Thurman Harrison, all of the home; three sisters, Beckey and Mildred Harrison of Pitt county, and Monteen Harrison of Beaufort county.

The five-year-old girl injured was Louise Jane Wainwright, daughter of Mr. and Mrs. Dennis Wainwright of near Tarboro. She is in Pitt General hospital, where her condition today was declared to be "satisfactory." She was injured when the car driven by her father and one operated by H. E. AIR BASE BILL BEING PUSHED TO ENACTMENT

New Determination to Bolster National Defense

HOUSE TO LIMIT DEBATE ON BILL

Opponents to Establishing Base at Guam to be Given Ample Time for Arguments

Washington, Feb. 20.—(AP)—The \$53,800,000 naval air base bill went forward in Congress today, new evidence of determination to bolster national defense.

Speaker Bankhead said Rep. Rayburn of Texas, the House majority leader, announced that the House would devote tomorrow and Wednesday to consideration of the legislation. They acted after the rules committee voted unanimously to ask the House to start voting after six hours of general debate.

Senator Nye (R-N.D.) proposed meanwhile, to write into law army and navy regulations against the release of military aircraft to foreign governments.

Nye introduced in the Senate a bill designed to safeguard the United States any airplane or airplane appliance now under government contract according to government specifications or with the aid of government funds for research.

Chairman Vinson (D-Ga.) of the naval committee, and Rep. Maas (R-Minn.) ranking minority member, said they would grant "ample time" for arguments of opponents of the \$5,000,000 item for developing a seaplane harbor at Guam.

Presidential hint of threatening developments abroad acted as a damper on congressional controversy over American foreign policy, but there was no doubt that the Guam project would be criticized.

Vinson told the Rules committee the Guam item was the only controversial section of the 11 air base program. Even that, he said, constituted "no entering wedge" which might lead to actual fortification of the island.

"I would not be here advocating development of Guam," he declared, "if I thought it would involve us in the Orient."

The Japanese press looked with disfavor on any proposal to strengthen this Pacific outpost of the United States and critics in this country have declared it would be provocative to do so.

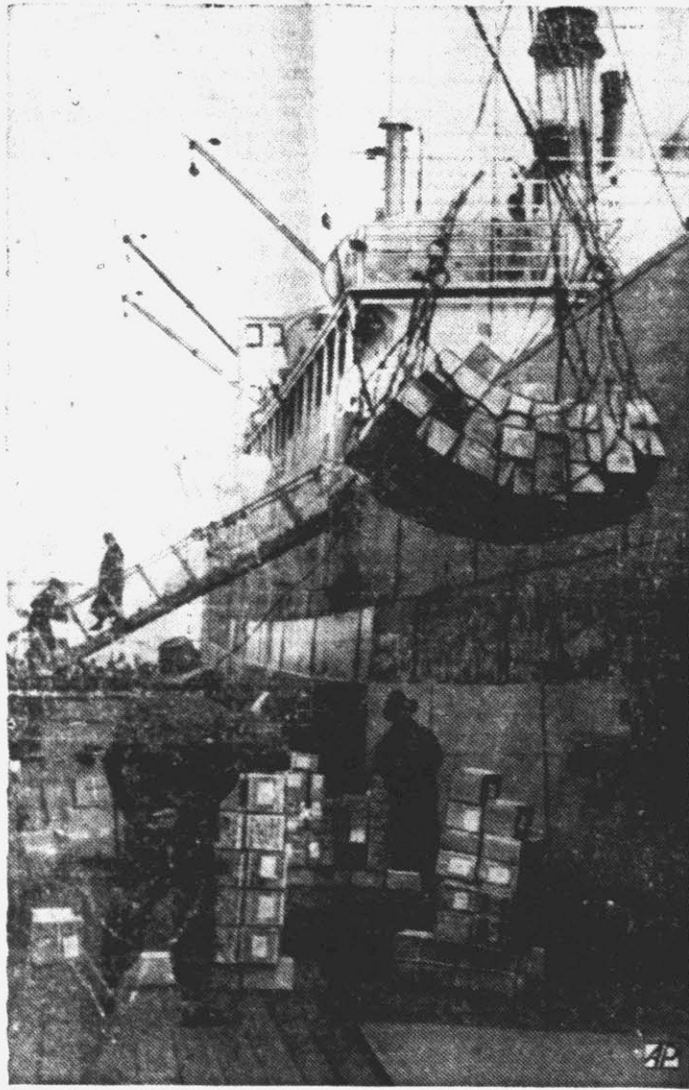

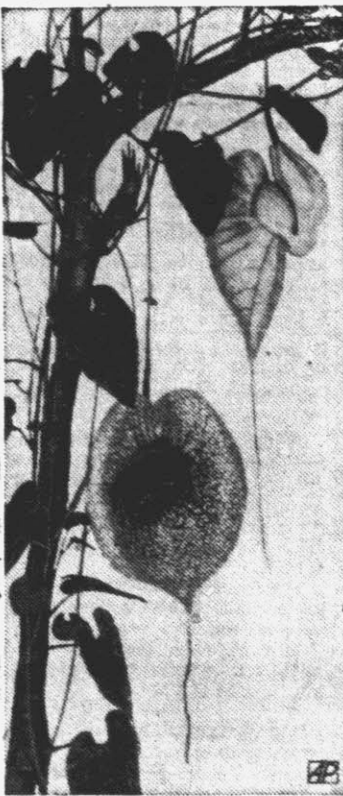

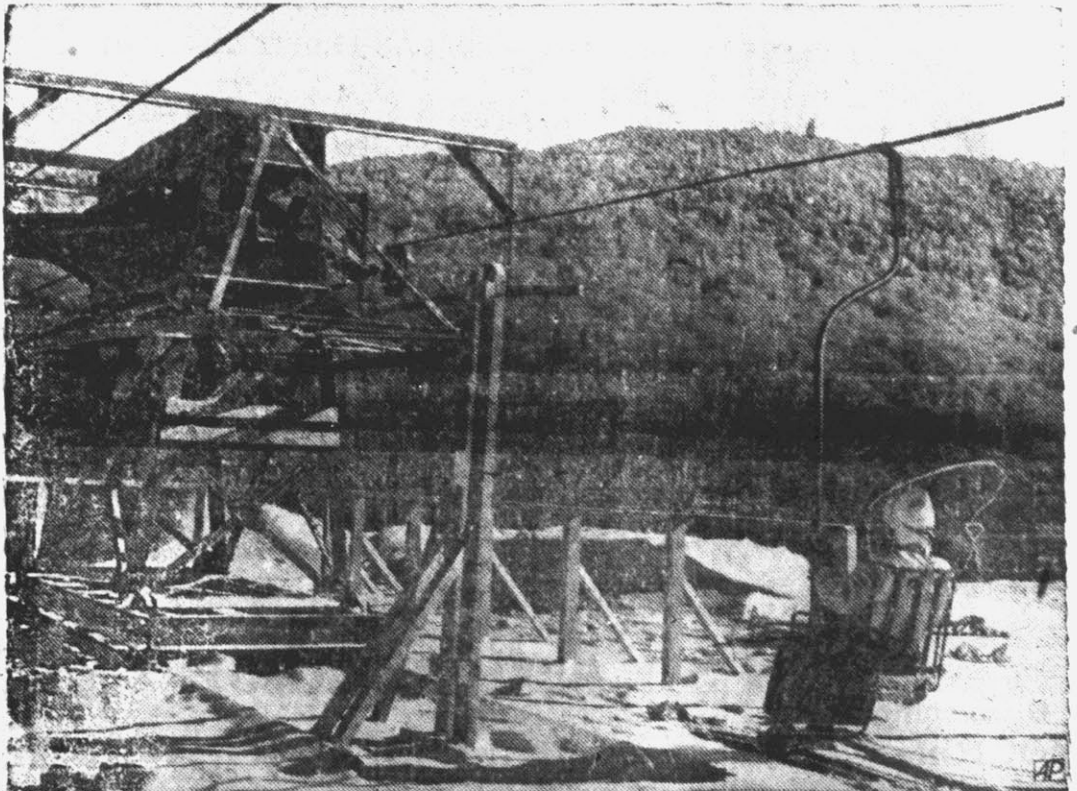

The bill admittedly has some merit; it certainly did have some difficulty in finding a papa. It was shown to a number of other senators and representatives, and Mr. Moore talked to lots of them about it, before Umstead and Thomas signed it and sent it to the factory.

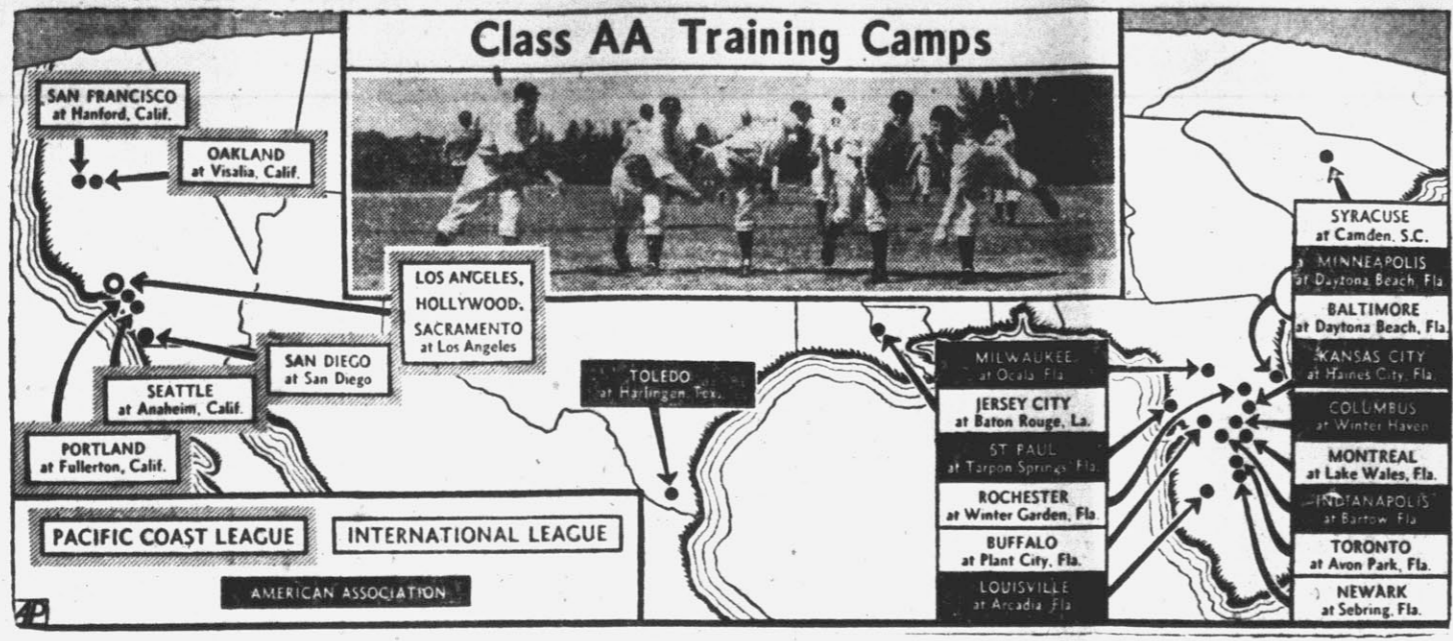

Grimesland girls have made 197 points in eight games this season.

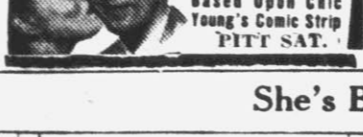

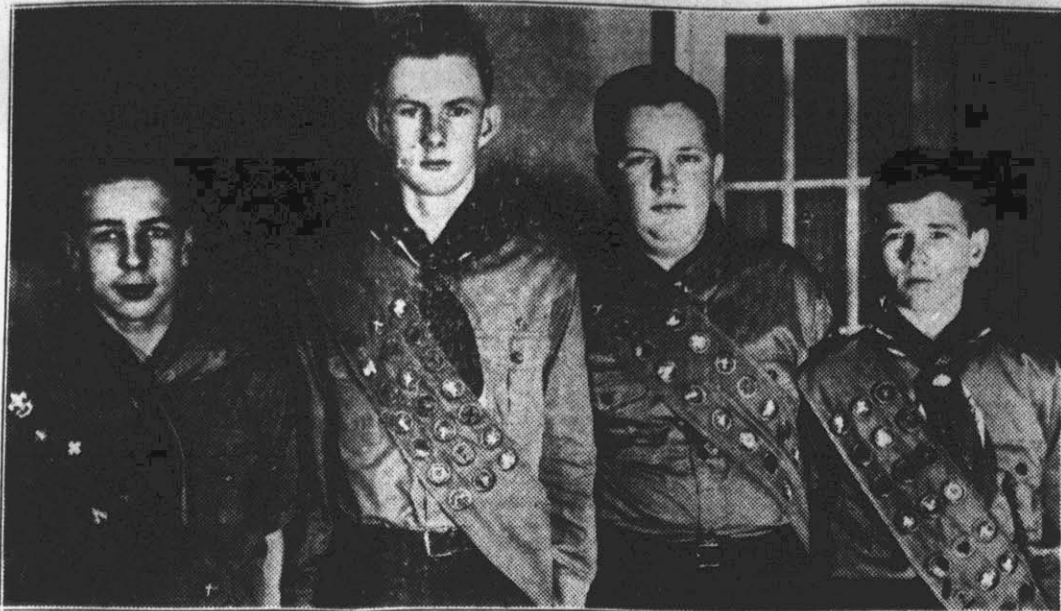
