JAPS TO SEEK MORE RULE IN NEUTRAL ZONE

Desire Stronger Hand In Settlement At Shanghai

ARRANGE TO SEE U. S. OFFICIALS

Necessity of Suppressing Wave of Crime In Area Given As Reason for Move

Shanghai, Feb. 23.—(AP)—Japanese authorities, seeking a stronger hand in administration of the International Settlement of Shanghai, turned today to the commanders of United States armed forces for presentation of their requests.

The Japanese arranged to see admiral Harry Yarnell, commander in chief of the United States Asiatic fleet, and Col. Joseph Fegan, commanding the fourth regiment of marines stationed here.

The Japanese already had conferred with civil authorities of the settlement and with the commanders of British and Italian defense forces. Japanese marines, yesterday with Italian consent, took over part of the Italian defense sector in the northwest corner of the city.

Because the Italian defense zone lies outside the permanent boundaries of the settlement, this occupation was not regarded as an invasion of the settlement itself.

The Japanese ascribed their pressure for a greater hand in the hand in the internationally administered settlement to the necessity of suppressing a wave of crime, including assassinations of 300 Japanese Chinese.

Former Greenville Officer Succumbs

Wilson, Feb. 23.—(AP)—Funeral services were held this afternoon for Police Chief John Rufus Gurley, 54, who died yesterday at 3 p. m., following an illness of several days.

Chief Gurley came here in 1925 from Greenville, where he was a member of the police force. He was born in Wayne county and spent most of his boyhood in that section.

He later joined the army and saw service in the Philippines, China and various American posts during the 12 years he served. He went to Mexico as an orderly to General Pershing and later went to France as a sergeant in the medical corps.

He went to Greenville police department after his discharge from the army and came here in 1925 being named chief two years later.

Surviving are his wife, three children, Wallace, Velda and Annie Gurley; two brothers, Waldor, Aldon and Andrew Gurley and one sister, Mrs. Viola Pipkin.

Temperature Drop Believed A Record

The temperature dropped to 22 degrees last night, one of the lowest marks reached so far this year and 56 degrees below the high mark of 78 set Sunday afternoon.

Although a drop in the mercury was recorded throughout much of the United States, the rapid descent here is believed to have equaled that in any part of the country.

Although the unseasonal warm weather last week and the high mark of Sunday probably made local residents feel the cold weather more than they otherwise would, the 22 mark reached last night is believed to have been about as low as the mercury has reached this winter.

A Mistake

Tokyo, Feb. 23.—(AP)—Japanese Foreign Office announced today that the bombing of a railroad station within British Hongkong Tuesday had been explained as a "mistake" to British Ambassador Sir Robert L. Craigie.

It was said that Foreign Minister Arita invited Craigie to call today and had offered an explanation of the attack.

MERS MARCHES IN THE SAND!



Persistent reports from the sandy wastes of northern Africa described a clash between French and Italian troops on the Tunisian boundary in which 84 men were said to have been killed. This map shows the territory in which the fighting was said to have occurred.

The reports put an added strain on French-Italian relations which already were tense because of Italy's demand for a slice of French African territory, preferably Tunisia, since possession of that colony would give an overland route to Italy's Libya.

Appeal Made For Fund Aid Tornado Sufferers

Acting upon instructions from national headquarters of the American Red Cross, J. Nat Harrison, chairman of the local chapter, today issued a call for donations to aid in the rehabilitation of homes in the Bertie county area struck by a tornado Tuesday night.

A latest estimates place the loss at approximately \$75,000, with the homes and other belongings of many small farmers a complete loss. Money also needed to provide hospitalization for the injured.

"It is the first time in many years that we have had an opportunity to contribute to a cause right at home," declared Mr. Harrison, "but now we have an opportunity to help disaster sufferers right at home and we should do everything within our means to relieve their sufferings."

Recognizing the need, the local Red Cross chapter has contributed \$50 from its fund and is calling upon the citizens of Pitt county to add to this fund.

Contributions may be made at the office of the Chamber of Commerce, The News Leader or The Daily Reflector. Contributions will be acknowledged through the columns of the press.

Although the call for aid has just been issued, the Red Cross had workers on the scene shortly after the disaster struck.

Money is needed now to give those people who lost their homes and all their furnishings a new start. Many are old and had their life's savings swept away in a few seconds. Most of them are farmers and without some help will not be able to start a crop this spring. Too many are in the hospital, and some have to be cared for, given some place to stay, something to eat, etc. until they can get a new start.

VOTE ABOLISH ABSENTEES IN PRIMARY ONLY

House Elections Committee Reports Bill Favorably

ACT IS DESCRIBED AS COMPROMISE

Group to Act Tonight On New State-Wide Registration And Splitting Precincts

Raleigh, Feb. 23.—(AP)—The House Elections Committee voted to report favorably to the floor the bill to abolish absentee voting in primaries and tighten absentee voting regulations in general elections.

The favorable report was given overwhelmingly on an oral vote. Representatives Pickens of Guilford and Kerr of Warren, led the opposition.

A motion by Pickens to abolish absentee voting entirely was rejected, as was a move by Kerr to retain the privileges in both primaries and elections.

There was extended discussion before the vote was taken. The bill approved was drafted by a sub-committee and was referred to as "a compromise" during the debate.

The committee will meet tonight to act on the measures drafted by the sub-committee which provide a new state-wide registration, requires splitting of precincts in which more than 1,000 persons voted in the last gubernatorial election, and abolish use of markers.

Meanwhile the senate passed on second reading the Long bill to require immunization of children against diphtheria.

Before approving the proposal, senators adopted an amendment offered by Gold of Guilford and Price of Rockingham, which specifically exempts children of persons believing in faith healing. The measure reported by the Health committee had given county health boards authority to exempt children of religious objectors.

The third reading was postponed until tomorrow, upon request of Senator Sparks of Gaston.

The House did not formally get the favorable report voted Tuesday by the joint appropriations committee to a \$154,371,322 record-setting biennial spending bill for (Continued on page six)

SIGNED INJUNCTION ENFORCES LABOR ACT

Washington, Feb. 23.—(AP)—The Wage-Hour Administration announced today that its first injunction suit to enforce provisions of the fair labor standards act had been settled in North Carolina by the signing of a consent decree.

Federal Judge I. M. Meekins signed the consent decree at Elizabeth City, N. C., permanently enjoining the Central Weaving and Spinning Company of Fayetteville from paying less than the 25 cents an hour minimum required by the wage-hour law.

Consent decrees enjoining violation of the fair labor standards act also have been obtained in two other cases, while subsequent to the complaint against the Fayetteville company.

Soviet Russia Joins Race To Build Up Naval Forces

Moscow, Feb. 23.—(AP)—An invincible Soviet Russian fleet was forecast today by Navy Commissioner M. P. Frinovsky in a statement published on the occasion of the 21st anniversary of the Red army and navy.

"We are constructing a large, powerful fleet to defend the country's wealth and the peaceful labor of citizens of the Soviet union," Frinovsky wrote.

"While pursuing a constant policy of peace, demonstrating repeatedly to all countries an aim to safe guard peace, the Soviet union can not remain indifferent in the face of the furious armaments race carried on by capitalist countries.

"Our own industry during recent years has built and armed many new ships for the navy which, in military quality, are not only equal to the ships of imperialist navies, but even superior to them.

"During the third five-year plan (started last year) our sea forces will be augmented with powerful big ships armed with long-range artillery.

Just a week ago it was revealed that Russia was sending a naval mission to the United States for an undisclosed purpose.

HOUSE FORCES ROLL CALL ON GUAM PROJECT

Administration Leaders Seeking Full Strength

COTTON SURPLUS PLANS OFFERED

Sec. Morgenthau Says Business Men Have No Need to Fear Additional Losses

Washington, Feb. 23.—(AP)—Leaders forced a roll call when the House convened today to bring out maximum voting strength for the administration's proposed \$5,000,000 naval development on the Pacific island of Guam.

Chairman Vinson (D-Ga.) of the House Naval committee demanded the roll call when only a handful of members appeared just before the scheduled vote on the controversial Guam project—a part of a general measure authorizing the building and development of naval bases.

Other developments: Secretary Wallace outlined to the Senate Agriculture committee three possible plans for dealing with the large surplus of American cotton.

The three ways of dealing with the surplus problem, Wallace said, were: 1. To continue the present loan program and find some way to replace American cotton in world markets, "on a competitive basis"; 2. A program of increasing cotton growers' incomes so they would give up government loans and permit a large amount of cotton to flow into domestic and foreign channels.

3. A plan for fixing a high price on domestic cotton that would let the surplus flow into world markets for what it would bring.

The Senate passed a House-approved bill to continue from next June 30 to June 30, 1941, the operations of the Export-Import Bank and the Commodity Credit Corporation.

Secretary Morgenthau said at his press conference that business men not only need not worry about new taxes, but might have hope for easing present taxes.

Speaker Bankhead told his press conference that President Roosevelt had "rather definitely stated" he did not intend to propose any additional new legislation to Congress at this session.

Hollywood—Hollywood has a way. There was Henry Fonda, some years back. If every young fellow wanted neither part nor parcel of the movies, it was Hank.

Why should he have? His days of starvation were over. He'd gone through that phase of his acting career on Broadway. He had lived through lean periods by eating rice—a nickel's worth swells up so fillingly when boiled. At last he had a contract, an informal agreement with a New York producer giving him \$100 a week—and he was acting in plays here and there, in stock, and in general on top of the world.

FACE PROBLEM WITH RECORDS

State May Confront Question of Which To Destroy

Reflector Bureau
Raleigh, Feb. 22—The disposition of old books, papers and reports of various sorts has long been a problem, not only with many private enterprises. So many are not worth keeping, but which to destroy is the question.

The 1937 legislature authorized the building of a warehouse on State Fair ground property to house some of these old records. That helped a lot, but didn't completely solve the problem. The statutes require keeping of some records for five years, some indefinitely, and for some there is no provision at all.

Comes now a bill offered in the senate by Ballentine and in the house by Garrett, chairman of the committees on banks, permitting destruction of the records of defunct banks after they have been completely liquidated. On its face, the bill would seem to be innocent enough. But no one knows better than legislative observers that things are not always what they seem. There is grave danger that in destroying records of some of these banks, there may be forever destroyed information concerning exorbitant commissions, fees and allowances to receivers and attorneys during their liquidation.

The records of the banking department have a great deal of this information, but far from all of it. Those records show attorney fees allowed and paid by state voucher, but they do not show, as do the papers of individual banks, the commissions for collecting accounts.

In view of the long-drawn out litigation, and the near approach to criminal indictment of a Kingston bank receiver, and the frequent charges that a fellow-townsman of the bank commissioner received in three years over a quarter million dollars, there is the suspicion in some quarters that the proposed destruction of records is actually an effort to destroy evidence.

streets of New York. There was a Society for the Prevention of Pauperism, and one of its earliest edicts was to advocate jail for all who asked for relief. New York had 90,000 people then, of which 15,000, or one in six, were on relief.

But conditions were even worse just after the surrender at Yorktown. One out of every seven inhabitants was in debtors' prison, and one out of every 14 persons was a slave.

Mr. Smith Hart, who has chronicled much of the early madness of our metropolis in his book "The New Yorkers," informs us that in 1809 "a committee reported that at the Bridewell in City Hall Park 72 women were imprisoned in one small room—little girls, prostitutes, and thieves and drunks. One man had been in a dungeon more than 10 years. The jailer did not know why he had been put there. He was now both blind and insane and his clothes were in rags. The committee protested that he should be given a shirt, but were assured that as often as a shirt was given him that it was eaten by the rats."

A man couldn't call his soul his own in 1788 because "Civil liberties were a joke. Newspapermen and even a Congressman were jailed for criticizing the administration. A typesetter was jailed for expressing the wish that the wedding fired off on public holidays might lodge itself in the seat of President Washington's pants."

During the great wave of Asiatic cholera in 1832 nearly 4,000 men, women and children died. At Bellevue hospital "the rooms had not been cleaned in two years. Convalescent patients wore the unwashed garments of the recently dead and the nurses were convicts."

Poe's island is not a beautiful body of land surrounded by water. It is a nub of mud, about 20 feet square, in the center of East river, but even the gulls shun it. It was named for the poet because Poe used to step at the foot of 42nd street and swim out there every day. GARDNER WINS FIRST BATTLE

Action Reminiscent of His Father, O. Max Gardner

Raleigh, Feb. 22 — Old-timers among the senate members and hangers-on grinned yesterday as Senator Ralph Gardner got in a jam with one of his pet bills, and for the first time during the session took the floor to defend it in a manner reminiscent of his daddy, a quarter of a century ago.

The bill was one prohibiting sheriffs, deputies and jailers or their wives from going bail for prisoners in their custody and getting paid for the service, either personally or as agents for bonding companies. The bill had passed the senate some days ago and had been amended in the house so as to exempt about one fourth of the counties. Young Gardner moved to concur in these amendments, and that motion was adopted without dissenting vote.

Then two or three senators had changed their minds and wanted to take their counties out of the

bill, but President Horton ruled out of order as the bill itself was not under consideration. Then a motion to reconsider the vote by which the senate concurred in the amendments was made and passed without dissenting vote.

Senator Gardner leaped to his feet and ripped into about three minutes of as vigorous oratory as the chamber has heard. He said the bill was a good one and ought to pass, and that if every county in the state got out from under except Cleveland he wanted it for his county. Then he renewed his motion to concur and the senate again, without dissenting vote agreed to do so.

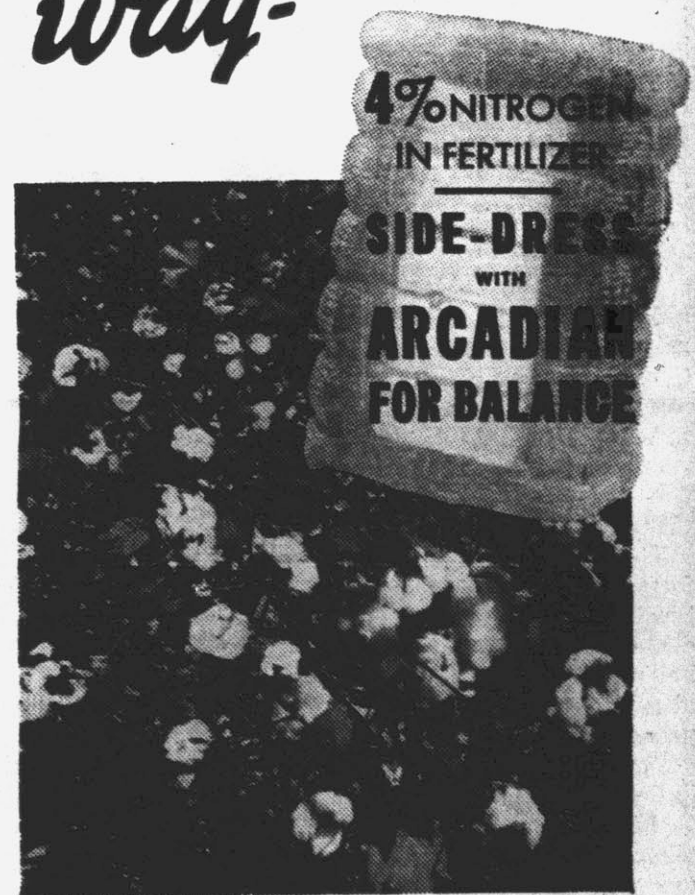

Washington Daybook

WASHINGTON—Possibly the unluckiest (or the luckiest) man in the country today is Joseph George Strecker of Hot Springs, Ark., who is being used as a legal guinea pig to decide whether Harry Bridges, West Coast CIO longshoremen's leader, shall be deported.

The U. S. Supreme Court has Strecker's case in hand and a decision will be down soon. But the big game in the woods is not inconsequential Strecker, but consequential Bridges.

The law says any alien advocating overthrow of the U. S. Government by force must be deported. The Justice Department in prosecuting Strecker argued that communism advocates overthrow of the Government, and therefore an alien Communist can't stay here.

District Judge Wayne G. Borah nephew of the senator) decided that was so and Strecker must go. The Fifth Circuit Court disagreed and reversed the decision. From there the case went to the Supreme Court.

How Bridges Fits In Bridges comes into the picture this way. It can be coaxed or coerced into adopting this extension of the sales tax principle into still a new field. Its foes believe sincerely that it might be the last straw and the one thing needed to set off a violent explosion of public wrath against the entire sales tax and all its works. The proposals of Senator John Umstead for liquor warehouses and for an increase in income tax rates likewise give opponents of the organization's financial policies real rallying points around which to set up the sturdiest and stubbornest sort of resistance.

Over on the Appropriations side, cuts by the committee out of the budgets of half a dozen different state agencies broadens the base of resistance also. If the committee had taken just one big bite out of one department, agency or project it would have found the going easier. There is now a fine chance for a coalition of proponents of all affected agencies with resultant formation of a bloc fighting to restore all the cuts.

In short, the present outlook is exceedingly bilious in so far as any rapid progress is concerned. Nothing much has been done in 43 days and it wouldn't be at all surprising to see as many as 20 or 30 more go by with still much undone.

This is all the truer because in addition to the financial issues there are still plenty of vital problems for the perplexed legislators. Listing just a few—Reform of election laws, revision and extension of Social Security program, the Wage-Hour bill, a unified program for Agriculture which will settle the perennial Department-State College feud, expansion of the public school system so as to provide much vocational and adult education.

These are some of the things about which nothing has been done so far, and the list is by no means all-inclusive.

the power to destroy."

Minus the successor to Brandeis, the court is even-stephen on a close decision in the fundamental law.

Regularly in the experimenter's corner are three Roosevelt appointees, Black, Reed and Frankfurter. Usually with them is Stone, a one-time Wall Street affiliate gone liberal.

On the other side are two dyed-in-the-wool precedent followers, Butler and McReynolds, and two middle-of-the-road men, Chief Justice Hughes and Roberts. Their older records put these two pretty close to the conservative camp, but their more recent opinions indicate that they, too, are taking an experimental turn of mind occasionally.

About Even Politically
Similarly, the court is split about even in party politics. Hughes, Stone and Roberts bear the Republican stamp, having drawn their appointments from two Republican Presidents, Coolidge and Hoover.

Reed, Black, McReynolds and Butler are Democrats. As a New Deal adviser of first rank, Frankfurter falls vaguely into that slot, too, although the record implies that he is agnostic in politics. Or at least he was before Roosevelt came to Washington.

Curiously, one Republican, Stone, and two Democrats, McReynolds (a Wilson appointee) and Butler (a Harding appointee) jumped the traces somewhere along the road. They found themselves consistently side with strange bedfellows, so far as politics are concerned.

Sectionally, the division of the court is not quite so happy.

The East is well taken care of with New York's Hughes and Stone, Pennsylvania's Roberts, and New England's Frankfurter; Middle Americans kick exactly, having on the court Kentucky's Reed and McReynolds; while the South has Alabama's Black and the North-west Minnesota's Butler. TAX PROPOSAL FACES DEFEAT

Bill to Hike Income Levy Rates Likely To Lose

Raleigh, Feb. 23—Senator John Umstead has a way of suggesting sources of revenue which are admittedly practical and which will conceivably produce large sums for the state treasury, but he likewise has chosen to suggest methods which arouse intense opposition.

First was his liquor warehouse bill. Nobody denies it would just about solve the financial dilemma of the Assembly, but the drys are holding up their hands in holy horror and making the walls ring to their denunciations of the proposal.

Now comes the Orange county law maker with his proposed hike on income tax rates. Here again nobody can or will deny it would bring in the checks; but here again there is sure to be the hottest of hot opposition, and if the action of the 1937 Assembly is any criterion, he is doomed to defeat.

Two years ago Willie Lee Lumpkin, one-time comrade-in-arms of Dr. Raiph McDonald, tried to up the income tax by amendment to the Revenue bill; but was beaten 60 to 30, or almost two to one.

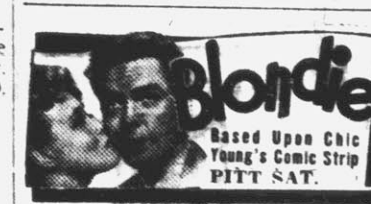

The Senate received from Larkins of Jones a bill which was introduced in the house last week to give the highway commission and boards of county commissioners authority to zone highway road-sides. Receipts from the outdoor advertising tax could be used to beautify roadsides. The joint finance committee met this afternoon to continue trying to restore something like \$1,500,000 which was eliminated from the advisory budget commission's recommendation. Senator Umstead of Orange, who Tuesday proposed a boost of one per cent in all income tax rates, sent in a bill today to tax all illegal liquor seized by enforcement officers at one dollar a gallon. Property of persons possessing the liquor could be held under lien for the tax. He said the measure should produce \$200,000 to \$500,000 a year. Senator Taylor of Anson introduced a new bill to set up a \$325,000 loan fund for the rural electrification authority, from which counties and school districts could borrow to erect vocational buildings.

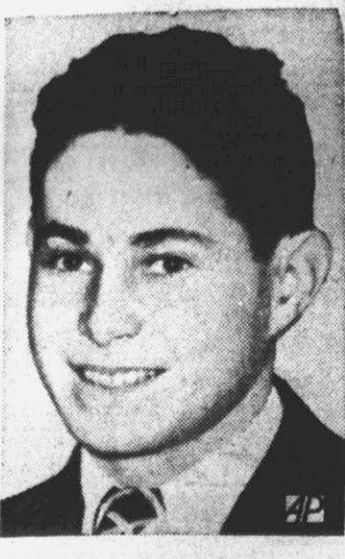

RELIGION SEEN AS SALVATION

Urged As Greatest Aid To A Disturbed World

Challenging his listeners to make religion such a habit that it becomes a security and aid in helping to meet the present demands of a disturbed world, Reverend Fred W. Helfer opened a series of spiritual discussions at the Eighth Street Christian Church last night. Emphasizing the necessity for making worship habitual, Mr. Helfer declared that only by doing so could one expect his religion to be an armor sufficiently effective to permit him to face the realities of life unafraid. Declaring that man has merely paved the way for spiritual growth and a rekindling of one's ideals when prayer, worship and religion become a habit, Mr. Helfer urged his audience to the finest type of life—life replete with love, courage and service. Mr. Helfer will speak again this evening on some topic relative to "God's Peace and the World's Unrest." "The membership of the Eighth Street Christian Church is eager that fellow-citizens enjoy the appropriate message which Reverend Helfer has prepared for the Greenville series," declared W. A. Ryan, minister.

4-H Club Youth Gets 167 Bu. Corn to Acre

Raleigh, Feb. 23—The average farmer in North Carolina produced about 20 bushels of corn an acre in 1938. Glenn Best, a 20-year-old 4-H Club boy of the Four Oaks community in Wayne County, harvested 432 bushels from 2 1/2 acres or an average of almost 167 bushels per acre.

This outstanding achievement wins for Glenn a one year scholarship to State College according to an announcement here today by L. R. Harrill, state 4-H Club leader. It also marks the boy as the 4-H corn growing champion for 1938.
