NO NEW BILLS TO BE SOUGHT BY ROOSEVELT

Willing For Congress to Adjourn When Slate Cleared

PARLEY IS HELD AT WHITE HOUSE

FDR Takes Personal Charge of Administration's Campaign to Stimulate Business.

Washington, March 6. — (AP)—President Roosevelt, who has taken personal charge of the administration's campaign to stimulate business, gave White House callers the impression today that he is willing for Congress to adjourn as soon as it cleans up its current slate.

Rep. Rayburn of Texas, House majority leader and one of the Congress chieftains at the White House conference, said Mr. Roosevelt reiterated that he had nothing new to submit to Congress.

On that basis Rayburn predicted a "reasonably early" adjournment.

Speaker Bankhead, who attended the conference, said afterwards that with all the recent "reassurances" from the administration, business should be justified in "going ahead."

He told newsmen that the Iowa address of Secretary Hopkins, recent statements by Secretary Morgenthau and repeated assertions that no new taxes within prospect should assure business of "new cooperation on the part of government."

What went on in the conference, no one would say. Those attending did have an opportunity to discuss an economy bloc contention that only by reducing expenditures can the government create industrial confidence.

A second development was the President's fixing of the opening meeting of the A. F. of L. and C. I. O. peace committees at 2:30 p. m. tomorrow. The conference, in Roosevelt's office, will be attended by representatives of the two labor organizations and by Secretary of Labor Perkins.

The White House announced that Colonel Edwin M. Watson, President Roosevelt's military aide, would be appointed a presidential secretary to succeed James Roosevelt about April 1.

Only Three Fires Here Last Month

A loss of \$3,370.72 has been experienced by fires in Greenville so far this month. The loss in January was only \$225.

The people are exerting much more caution with fires, thereby cutting down the number of fires and the total damage.

With the highly controversial Revenue bill to be thrashed out in committee of the whole House anything can happen between now and Saturday. The legislators can decide to enact a money bill about as it came from the Finance committee and thereby put adjournment sine die on the calendar for a comparatively near date, or they can kick over the traces, upset the precarious budget balance and turn the session into a go-as-you-please and stay-as-long-as-you-like affair.

There were faint, but distinct rumbles of impending showers of wrath and indignation over the Revenue bill as last week ended, and the House refused to trail docilely along behind its leaders in racing

GROUP AGREES ON FARM BILL

Test Farms Apparently Anchored for A While Yet

Reflecter Bureau. By LYNN NISBET. Raleigh, March 6.—Although shrouded in what the members hope is secrecy, terms of the agriculture sub-committee recommendations on duplication of activities in experimental and market work have become pretty well known.

The main point at issue was the test farms now operated by the department of agriculture and which State college wants. The sub-committee will recommend that the test farms continue as at present. They further will recommend that duplicate and triplicate office-holding be eliminated in both the college and the department. This is directed at several situations, one of them being the three jobs held by Dean Schaib as dean of the school of agriculture, director of extension and acting director of the central experiment station. On the question of marketing, and of some minor points the matter is left to the two departments to work out mutual agreements.

In these recommendations the sub-committee overruled the recommendation of its "super-suds" committee as the group of five men named as a sub-committee to give further study to the matter, have been dubbed finding that preliminary procedure did not admit a sub-party the boys popularly called at the "super-suds." This group of five was known to have received strong views on the test farm (Continued on Page Six)

Neuse At Highest Mark During 1939

Raleigh, March 6.—(AP)—Recent rains sent the lower Neuse river today to a 21.8 foot level, the highest of 1939 and more than seven feet above its banks, Weather Man Lee Denson said.

Denson added the Neuse was falling at Smithfield and that the Goldsboro height was 3 of a foot more than the previous flood peak. At Goldsboro a 22-foot crest is expected within 24 hours.

At Kinston the river rose more than three feet out of its banks, at 17.5 feet today, and was expected to reach a 19-foot peak Friday.

The Tar was at a stand at 16.5 feet in Greenville, three and a half feet over its banks, and at Tarboro it was two out, at 18, and falling.

The Roanoke was within its 31-foot bank at Weldon and at Williamston a foot out, at 11.1 feet, and rising.

WAY IS PAVED FOR PEACE IN SPAIN BY COUP

Spanish Leader Says Seizure Must Lead to Peace

NEGRIN ACCEPTS HIS OVERTHROW

Some Quarters Express Belief That Peace Talks Might Already Have Been Started.

Paris, March 6.—(AP)—Diego M. Barrio, president of the Spanish Parliament, declared today that the seizure of power in Republican Spain by a National Defense council "must lead to peace."

Informed quarters expressed belief also the way for Republican Spain's surrender to the Nationalist had been paved by the formal resignation of the government of Premier Negrin.

A radio broadcast said Negrin had accepted his cabinet's overthrow by a six-man "defense council," thus legalizing the coup by which power was seized in Madrid.

Despite the pledge of the "defense council" to continue resistance, informed quarters declared it would sue for peace.

Some quarters expressed belief that peace talks might already have been started. They based this on a radio speech by General Casado, leader of the uprising against Negrin, in which he declared to the Nationalists that his followers "wish for peace" if a "real peace" were offered.

Negrin and his ministers were reported under arrest by Republican troops. They have consistently demanded a fight to the finish unless Nationalist General Franco agreed to full amnesty for Republican leaders.

Part of Carado's broadcast was addressed to "Spaniards on the other side." It appealed to them to join the new Republican rulers to help eject "invaders"—foreign fighters.

"Spain wants peace," Casado proclaimed. "It is up to you to help her secure it. If you offer us real peace and independent peace, we will be glad to meet you. Otherwise we shall fight on. The question is either peace or fight until death."

The reported nomination of Julian Besteiro to head the "big six" council was seen in some quarters as a sign of the new Madrid regime's intent on peace.

Armed Negro Goes On Rampage Here

Local police officers today were on the look-out for James Clark, Negro, who last night is alleged to have beaten his wife, took a night watchman's pistol from him, assaulted him, caused disturbances at two filling stations, assaulted a taxi driver and then to have fled.

According to police headquarters reports the Negro went to Perkins mill, drew his pistol on the watchman, Carl Bass, white man, knocked him down when the man started to reach for his own gun and took the pistol from him. The Negro allegedly then hit his wife after having beaten her earlier in the night. Going to Ed Fleming's filling station the man is said to have started a fuss there, then to have gone to a taxi stand where he drew his pistol on Arthur Layton, driver, cursed him and beat him, and then to have gone to Heber Green's filling station on West Fifth street, where he drew his pistol on Matthew Gibbs.

When officers started looking for him, they found the Negro had left with his wife, Thelma Whitehurst and Sam White, who other Negroes said to have been with Clark when he started on his "rampage" are being held in the city jail while officers are conducting an investigation. Clark lives on Fourteenth street.

Former P. O. Clerk Held on \$500 Bond

James E. Forrest, former clerk in the Greenville post office, was placed under bond of \$500 following a preliminary hearing in Washington before U. S. Commissioner Anna M. Paul this morning on charges of embezzling United States funds.

Forrest was arrested in Fountain this morning by U. S. Deputy Marshal Ben Buck and the preliminary hearing was arranged immediately. Details of the charges were not made known.

May Intervene To Halt Gandhi's Hunger Strike

British Viceroy of India May Take Official Steps

Rajkot, India, March 6.—(AP)—The possibility of intervention by the British viceroy of India in Mohandas K. Gandhi's dispute with the native ruler of Rajkot was strengthened today as Gandhi grew weaker on the fourth day of his "fast unto death."

A morning medical bulletin said that the frail little leader was so exhausted that any attempts to sit up brought attacks of giddiness.

The viceroy, the Marquis of Linlithgow, broke a tour of the Rajputana states and hurried back to New Delhi after appeals from Gandhi's nationalist followers and nationalist-controlled provincial government for pressure on behalf of administrative reform in Rajkot.

Scores of protests against the adamant attitude of the native ruler were telegraphed to Lord Linlithgow, while a thousand peasants prayed outside the quarters where Gandhi was fasting.

It was Gandhi's sixth hunger strike and his physicians said "this time the fast will not last many days."

The 69-year-old Gandhi, a wisp of a man in lincolith and shell-rimmed spectacles lay on a rustic cot on the veranda of a native dwelling, screened from the broiling sun and the eyes of those who gathered nearby to pray.

Already he had lost two pounds, his legs were swollen, his pulse had quickened and his blood pressure had risen from 168 to 185, having gained five points this morning.

One Minor Accident Reported in County

State Highway patrolmen reported only one highway accident over the week-end, this being about five miles from Greenville on the Farmville highway Saturday night.

Cars involved in the wreck were damaged, but Patrolman C. R. Williams, investigating officer, reported no one was injured. Johnnie White, Negro, of near Farmville, is charged with reckless driving and driving without a license as a result of the collision with a car driven by him and one operated by W. H. Lilly of Fountain.

Fire at Negro House Causes \$50 Damages

Greenville firemen extinguished a fire at the home of Charlie Best, Negro, at Broad and Center streets, shortly after 11 o'clock last night.

Fire Chief George Gardner declared the blaze evidently started from an oil stove in the house, and estimated damages at \$50.

Nothing Doing So Far On Money Bills Before House

Raleigh, March 6.—Although the house of representatives had the biennial appropriations bill in hand at the first of the week, and received the formal report of the finance committee on Friday morning, the week passed with only 30 minutes actual consideration of the only two laws which the general assembly must enact.

House leaders adopted the strategy of considering the revenue bill ahead of appropriations, with the alleged purpose of preventing any boosting amendments to the spending bill. The idea was that any such amendments could be headed off by the assertion that the revenue bill had already been passed and that it did not carry enough money for any new purpose. For the same reason effort was made to ram the revenue bill through without debate or amendment.

Pursuant to this plan, the house went into committee of the whole Friday morning to consider the finance bill. Matters ran more or less smoothly for a few minutes, although Committee Chairman Fenner experienced some difficulty in making members understand just what some of the items meant. It was when a motion was made to adopt Schedule B (the franchise and license tax section) in its entirety that the lid blew off. Francis efforts of Speaker Ward, who had yielded the chair to George Uzzell for the committee session, of Chairman Fenner and Budget Commission Member Bryant to hold the boys in line failed. Such veterans as John White, Pete Murphy and Gregg Cherry had caustic comment about Hitlerish tactics, and the committee of the whole arose and the house re-convened in formal session. ORDER OF NLRB IS UPHELD BY HIGH TRIBUNAL

Supreme Court Declines to Review Ruling

NO COMMENT ON COURT DECISION

Board's Ruling Had Required Washington Company to Re-instate Discharged Workers.

Washington, March 6.—The Supreme Court refused today to review an attack by the Carlisle Company of Onalaska, Wash., on a labor relations order requiring reinstatement of 147 discharged employees with \$185,000 back pay.

Without explanation, the tribunal refused to pass on a decision by the Ninth Federal Circuit Court upholding the order.

No opinions were delivered by the court. This postponed at least until next Monday a final decision on the right of the government to deport an alien Communist. Joseph G. Strecker of Hot Springs, Ark., is involved.

Action on the Carlisle case had been held up for several weeks to await rulings on three labor laws cases, which were decided last Monday.

In those cases the court set aside the labor board's orders directing the reinstatement of striking employees. In addition the tribunal condemned the sit-down strike.

The board found that the Carlisle Company had discharged employees who were members of the Lumber and Sawmill Workers Union and had organized a "pretended labor organization" known as the Associated Employees of Onalaska, Inc.

The union local filed a complaint with the board in 1936 after a strike and subsequent disputes between striking pickets and new employees.

The company contended the strike started May 3, 1935, two months before the labor act became effective, that the plant was closed indefinitely and that there were no employer-employee when the act became effective.

What would in different case be the toughest battle of them all—the matter of levying a sales tax on basic building materials.

The committee leadership and the administration started out with firm steadfast purpose to enact this section, which is estimated to be worth \$400,000 a year in revenue.

but despite pressure of the reverent sort the chairmen were never able to get the joint Finance group to acquiesce.

As a result the administration leaders are not only estopped from themselves proposing to put back this provision in the bill, but they can't even be openly "nice" to those who might propose it. It is now their bounden duty to support the bill they piloted out to the floor.

It is, of course, conceivable that under outwardly tremendous pressure from local units, the House might be prevailed upon to upset now proposed by the committee, in which case the leaders might feel themselves free to urge again the building material levy on the plea of "necessity" brought about through upset of the balance resulting from intangible changes.

This appears to be little more than a possibility, certainly not a probability.

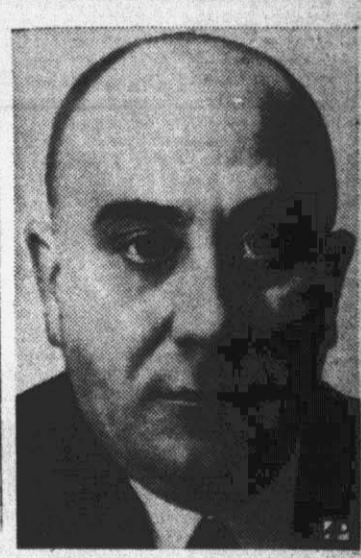
Elsewhere along the line the prospects for a pulse-tingling battle are somewhat remote; though there still isn't any getting around the fact that under the surface there is abundant opposition to the proposed taking of \$7,000,000 gasoline tax proceeds to balance the General Fund budget.

If by any chance this sentiment should ever crystallize under really competent leadership (so far totally lacking) then storm warnings could be hoisted and all hands piped on deck to man the pumps.

Strongest efforts to insert new and better money raising sections in the Revenue bill are likely to be made by those who would like to see bigger appropriations for departments, agencies or activities in which they are interested.

For instance those who want bigger salaries for school teachers will be practically forced to fight for bigger revenues than the current bill provides—and the same thing goes for those who oppose any cut in the State advertising fund (reduced from \$125,000 to \$90,000 for each year of the coming biennium), and for those who would like to see the \$70,000 clash in Health Board appropriations restored to figures recommended by the advisory Budget Commission.

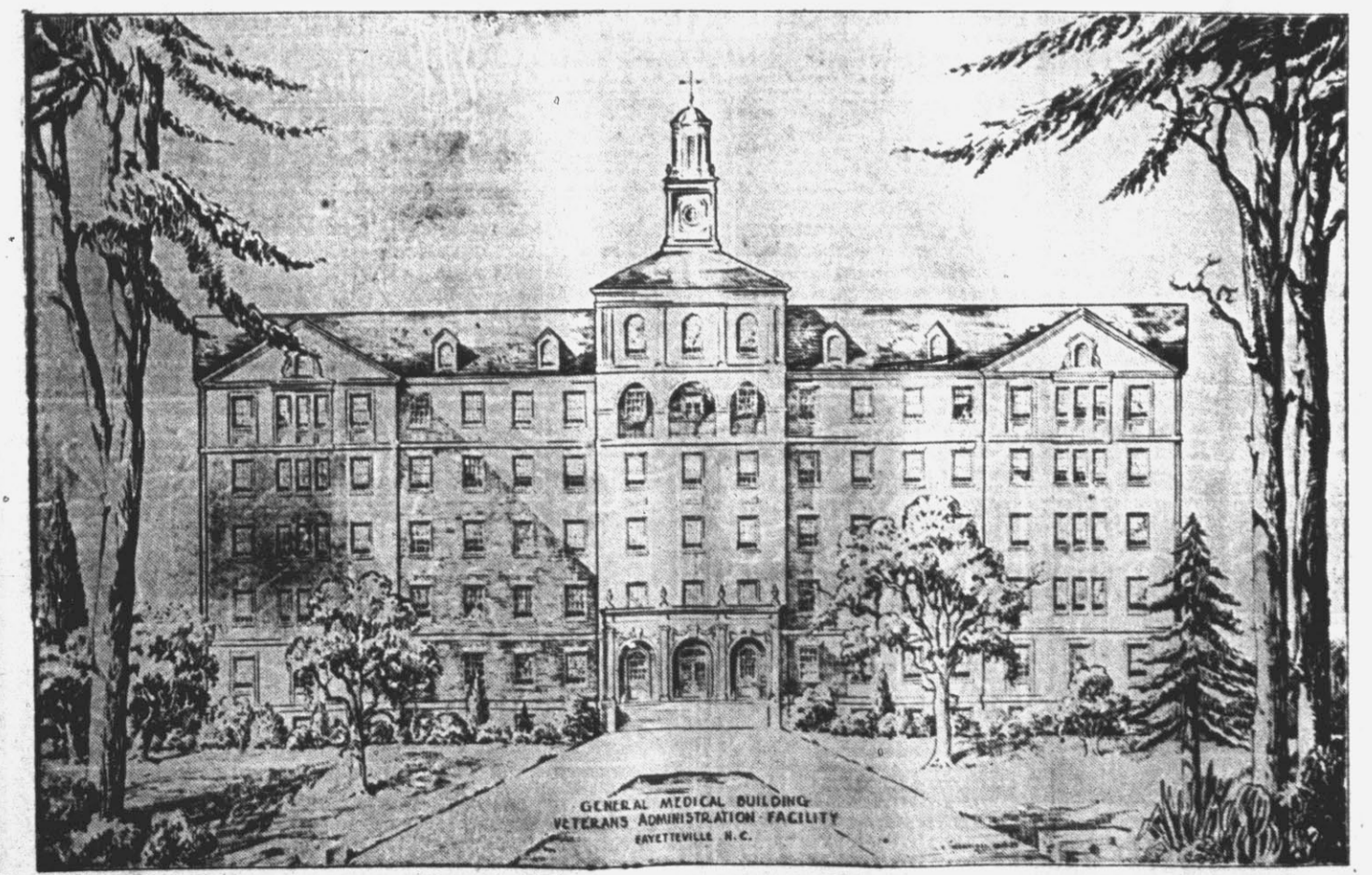
On every hand opponents of the bill are going to be met by the argument that there's no point in increasing revenues because the measure provides enough to meet proposed appropriations. Then when the appropriations bill is reached it will work the other way—you can't increase these appropriations

Washington Daybook

Washington—it is slowly dawning on this defense-drunk capital that the fastest naval maneuver performed in recent history took place before ever the fleet sailed into the Caribbean.

Out of the excitement over whether Guam, far eastern island, should undergo preliminary development as a naval base, the Navy emerged with House approval for starting 11 new naval bases, a whopping building program such as has not been authorized in a generation.

And even before the Senate acted, fervid expressions of approval for the program as adopted by the House were coming from the sides of the political aisle in the Senate.

For years the Caribbean has been something of a U.S. sea. With the new bases of Congress follows up and appropriates the money; it will become virtually an American lake. The Navy never has felt satisfied with Caribbean operations bases. Purchase of the Virgin Islands from Denmark during the World War gave the country a possible base for fleet operations lying almost a third of the way across the Atlantic. The Virgin Islands are the farthest out of the island chain headed by Cuba.

With liquidation of the German fleet after the war, no immediate call was seen for developing the place, so the entire Caribbean area had been passed over for 20 years. The fleet took up its station in the Pacific.

New Tactics Necessary

Changed conditions brought changed tactics. The Navy must plan "hemispherical defense" once more against potential aggressors from Europe. So it jumbled Caribbean defenses together with certain other required bases in the Pacific and submitted the whole program to Congress in the Hepburn report. Sticking out like a sore thumb from all the rest was Guam. It was 2,000 miles out beyond the Alaska-Kawaii defense line. Instantly it became the focus of a congressional dispute over foreign policy. It drew fire from all the rest of the effort. That is good tactics for the navy in war or in Congress. Besides Guam the rest of the program seemed trivial.

Whether the administration added Guam to the list for the specific purpose of taking attention off the rest probably will remain in doubt. Regardless of whether it was done by design, it had that effect and the Navy was well pleased at the outcome.

Republican Angle

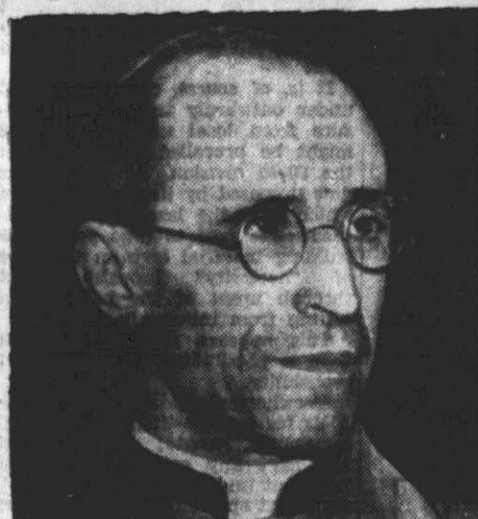
Out of this action came another development. For the first time in six years Republicans were able to shape the national policy. By saying they had a hand in bringing about the defeat of the Guam proposal, House Republicans hedged in the administration on one more front. The balance of the defense program can be defended as part of a defense of the United States and the western hemisphere. But Guam looked like hemispherical defense PLUS. House Republicans so interpreted it. They said it looked like assistance to the totalitarian states, of which Japan is a member.

They announced that they would support measures only strictly useful for hemispherical defense. Republican ranks held tightly together, won support of 60-odd Democrats, and defeated Guam.

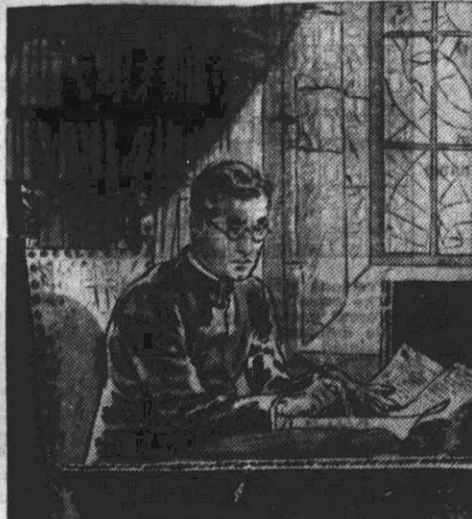
The Republican victory in the House, an adroit turn, was part and parcel of the Republican strategy of limiting defense efforts to this hemisphere, as distinguished from many sort of "united front" with the democracies. A similar GOP-Democrat alliance made the administration demonstrate that there was no international connivance with the French in the plane deal. When it was so demonstrated, they withdrew opposition and patted the deal on the back.

Pius XII: Pictures Tells Story of How 'The Flying Cardinal' Became Pope



1. PIUS XII, 262nd Pope of the Catholic church has, like his predecessor, a rare talent for diplomacy. Born in Rome of a family that had long been on intimate terms with the Vatican, his history suggests that of a career man. He is unselfish, of unflinching courage and rigid piety. And though he has an unusual gift for preaching, circumstances never gave him the opportunity to fulfill one of his greatest ambitions—to have a diocese of his own where he could preach before a congregation to his heart's content.



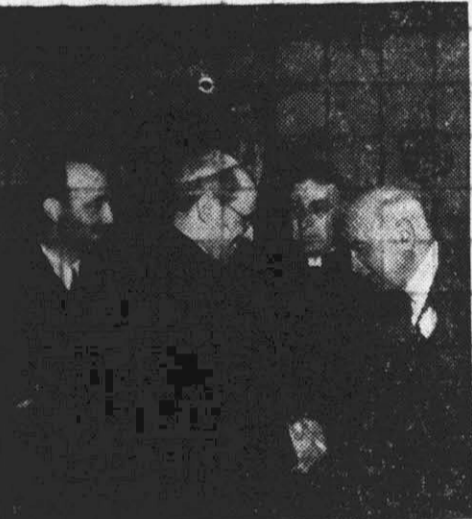
2. HIS EARLY LIFE developed along very simple lines. Educated in Rome, he was about to enter a university when he resolved on an ecclesiastical career. Of delicate health, he pursued his studies at home, where the surroundings were adapted to priestly training. He was ordained in 1899, and Pope Leo XIII assigned him to work in the offices of the papal secretariat of state. In 1912 he was named undersecretary of state by Pope Pius X, when Merry del Val was secretary. He served there until 1917.



3. THE WORLD WAR was the papacy's biggest problem when Pacelli was made nuncio at Munich. He thus became the channel for communication between the warring powers. Once, as shown in the sketch, he delivered a letter from Benedict XV to the Kaiser, at the front. His reports on this and other wartime meetings are believed to have prompted Benedict's attempt to mediate for peace in August, 1917. With the founding of the German republic, Pacelli became dean of Berlin's diplomatic corps.



4. IN POST-WAR GERMANY, Pacelli made his mark. He worked in behalf of the people of the Ruhr, and effected a concordat between Bavaria and the Holy See. Then he did what had been considered impossible—won a concordat with Prussia. For that diplomatic triumph, Pope Pius XI called him back to Rome. He left Berlin late in 1929 on his way to elevation to College of Cardinals. This picture shows him leaving presidential palace after saying goodbye to the aged former general, Hindenburg.

SHORT SHOTS

By HENRY AVERILL and LYNN NISBET

Raleigh, March 6—There hasn't been time since its introduction to make any positive predictions of its fate, but there are indications that the teacher's retirement measure dropped into the House law-making machinery Friday will start a real battle in the General Assembly.

There are several facts, too, which make its enactment not at all beyond the bounds of possibility. To begin with it has the right sponsors to give it a chance. Such legislators as Victor Bryant, Gregg Cherry and Hugh Horton do not just casually up and introduce bills they know are doomed to defeat. Any bill that bears their stamp of approval with something in its favor.

Then it is recalled that some weeks before the Assembly convened Jure Warren, big shot of the North Carolina Education Association, said that of all the things for which the teachers are contending, retirement is the most important.

The Cape Fear Valley Authority, proposed by Representative Lucy McBryde for his projected hydro-electric giant in eastern North Carolina would be rather unusual in its members' terms. There would be 11 of them appointed to serve for one, two, three, and so forth up to eleven years. Thus the term of only one member would expire each year.

Every Congressional district of the state would be represented on the Authority, under the bill.

Speaker Libby Ward didn't go home on Friday this week. He is obviously concerned over slow progress of the Assembly. Opinions differ as to when the general assembly will adjourn, but Representative Forrest Pollard of Durham knows very well what the deadline is for him. Other folks guess at adjournment dates all the way from March 25th to May 1st. Forrest is quitting on April 14. He isn't contrary about it, and he doesn't mean to run out on his job. But he has a date with a girl and a preacher on April 15th and he is going to keep that date, even if the budget remains forever unbalanced. Some of his colleagues are framing up to have him named on conference committees, or some thing, if the Assembly is still in session. But the only reason Forrest won't keep that date on April 15th will be for the girl to change her mind. There isn't much likelihood of that.

What can be done about the revenue

bill. These were the bills for pension and retirement for school teachers, and the one providing for a gigantic hydro-electric development in the Cape Fear Valley.

The teacher retirement plan has been worked out by a committee of the North Carolina Education Association over a period of two or three years. Its sponsors declare it to be actuarially sound. An appropriation of about \$2,000,000 will be required to put it into effect, and a bill has been introduced authorizing the Governor to name a commission to figure out what to do about it.

nothing out of the session was reported on in thirty minutes.

The finance bill as reported out of committee will yield for the two years about \$80,000,000. The appropriations bill calls for expenditure of \$154,360,000. This doesn't mean, however, that the budget is \$74,000,000 out of balance, because the appropriations bill includes highway and agricultural fund allocations, while the revenue bill levies only taxes for the general fund. As has been many times pointed out by this correspondent, the budget for the biennium will actually be nearly eight millions out of balance as to the general fund, because the bill under consideration contemplates using up substantial balances and dipping into highway money to the amount of seven millions.

The house of representatives made much more progress on election reform than it did on money during the week. Bills have passed the house embodying the essential features of board of elections recommendations. Under them absentee voting will be eliminated entirely from party primaries and will be harder to get and much harder to have counted unless they conform strictly to the law. Also the "markers" evil will be tremendously relieved. It will still be possible for voters to get some assistance in marking ballots, but only in extreme cases of need for help.

Only one major election reform remains to be acted upon by the House. That is the requirement for a complete new registration throughout the state. Many counties have not had new registration in forty years or more; in some instances where new registrations were ordered it has been admitted that it was consummated largely by copying names from the old book.

One step toward abolition of capital punishment in several cases was taken when the senate passed the bill making sentence of death or life imprisonment optional upon conviction of a charge of arson or burglary. Two bills of far-reaching importance were introduced in the house Friday and would have received more attention, but for the simultaneous appearance of the revenue

hills half a million dollars a year, according to some supporters of the plan. Reason for the large immediate need would be the retirement of so many teachers above 60 years of age at one time.

The retirement plan provides cooperative payment by the teachers and the state to build up a fund on an actually insurance basis.

The power measure was offered by McBryde of Cumberland and calls for a preliminary appropriation of \$10,000 for a commission to be composed of one member from each of the 11 congressional districts in the state, to formulate a

corporation to be known as the Cape Fear Valley Authority, and to head up in Fayetteville, which would be empowered to borrow money from the federal government to aid in water, commerce, flood control and the manufacture and distribution of electric power in the valley of the Cape Fear river and its tributaries. General capitol opinion is that the measure hasn't much chance of passage at this session, but it is accepted as indication of a trend toward socialization of water power.

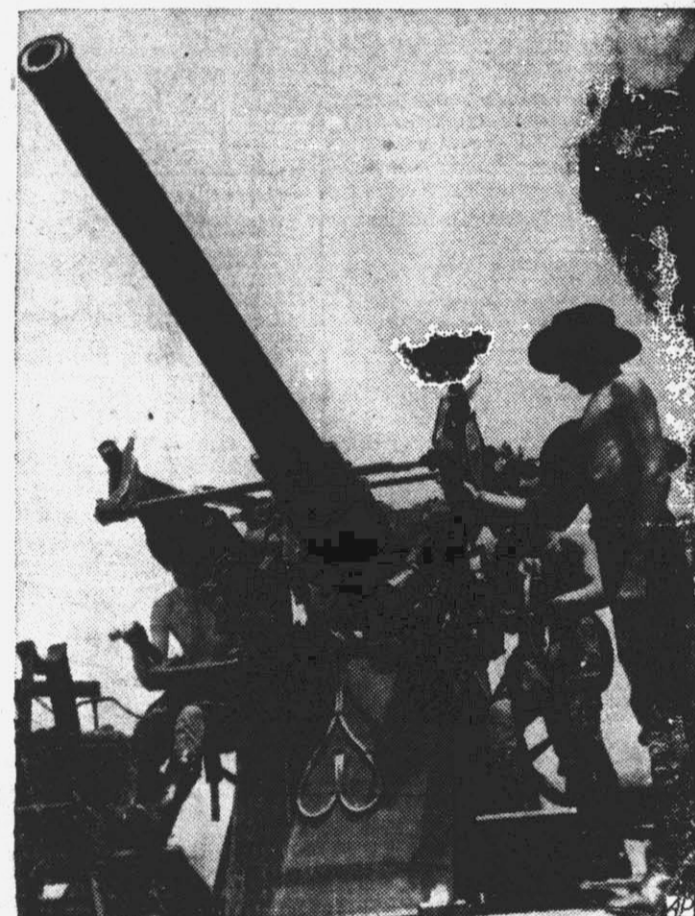

matter, and a majority of them was known to be in favor of changing their administration. The campaign for removal of the test farms was fostered by the Farm Bureau which has all its strength in the east and in a few counties these. Three of the five men on the "super-subs" were from these counties. The other two were from the Piedmont section. There wasn't a western man named on the group. The full subcommittee was more representative of the state as a whole and looked at the matter from a broader point of view.  
The full joint-committee on agriculture will receive the report early next week, and while there will undoubtedly be some opposition to it, changes are much better than even this it will be adopted. Feeling is so strong among one group, however, that a minority report is quite possible.

Veteran legislators have expressed amusement at the lengths to which the group studying duplication have gone to preserve accuracy. Executive sessions were the rule; and in this case the term meant just that. Finance and appropriations committees held many executive sessions, but always outsiders were admitted upon pledge of divulging only results and not the procedure by which results were obtained. The agricultural subcommittee and the "super-subs" committee not only didn't admit outsiders, they didn't admit members of the full committee, and they have tried desperately to keep any news from finding its way out what they did while in session.

area by the federal Farm Security Administration.  
The Department of Conservation and Development plans to use this Bladen county area of some 30,000 acres as a demonstration project in reforestation. In order to show farmers and land owners what can be accomplished through systematic reforestation.  
The area includes three state-owned lakes—Jones, Salters and Singletary—which are being developed into recreational areas for use of the people in that section. Considerable development has already been done by the FSA so that bathing beaches and bath houses will be provided. A bathing beach and all facilities are being planned at Jones Lake for the exclusive use of Negroes.  
In addition to using this Bladen project as a forest demonstration and public recreation area, it is expected to prove valuable as a game refuge in which regulated hunting will be permitted later.  
Enrollees of the Civilian Conservation Corps camp at White Lake, are doing the actual planting of the 100,000 seedlings. Donald S. Stubbs is project supervisor for the CCC.
