PLAN TO HALVE WPA FUNDS FOR ENSUING YEAR

Administrator Doubts Permanency of Agency

3,000,000 SHARE RELIEF BENEFITS

Wallace Says Continuance of President's Monetary Power Preparedness For Money War

Washington, March 16.—(AP)—Col. F. C. Harrington, administrator, told a House Appropriations subcommittee today that WPA rolls probably would be cut in half by July 1, 1940.

Harrington appeared at secret hearings on legislation to give PWA an additional \$150,000,000 requested by President Roosevelt for its operation through June 30, this year.

The administrator also declared that he did not consider the huge relief agency permanent and thought it could be liquidated eventually.

Halving of the relief rolls by the middle of 1940, committee members indicated would be predicated upon an increase in private employment hearings on legislation to give WPA rolls now.

The subcommittee decided to recall Harrington for further testimony today and some members said it might be possible to wind up hearings Monday. That would mean that no attempts would be made to go onto the controversial question of investigating and revamping the whole relief set-up, as some legislators have proposed.

Other developments: Secretary of Agriculture Wallace told a Senate Banking subcommittee today that continuance of President Roosevelt's monetary powers were preparedness for "armed conflict among currencies of the world."

Secretary of the Treasury Morgenthau indicated that the administration tax revision plan would not be made public until after the first week in April.

Chairman Walsh (D-Mass.) of the Senate Naval committee said after a White House conference that President Roosevelt had no objection to elimination from the naval air base bill of a \$5,000,000 item for harbor development at the island of Guam.

Negroes Escape In Storm Last Night

Raleigh, March 16.—(AP)—Penal division authorities said today that four Negro prisoners worked quickly during a heavy thunderstorm at 3 o'clock this morning to saw out of the Bladen county prison camp.

The escapees were listed as: J. D. Wiggins, given three to five years in Martin county, in September, 1937, for breaking, entering, larceny and receiving; John Bragg, sentenced to five years for assault with a deadly weapon in Vance county in July, 1937; James Peoples, sent up in May, 1937, from Forsyth for 12 years for forgery and other charges; and William P. Probst, given two one-year terms in Caldwell last August for breaking, entering and larceny.

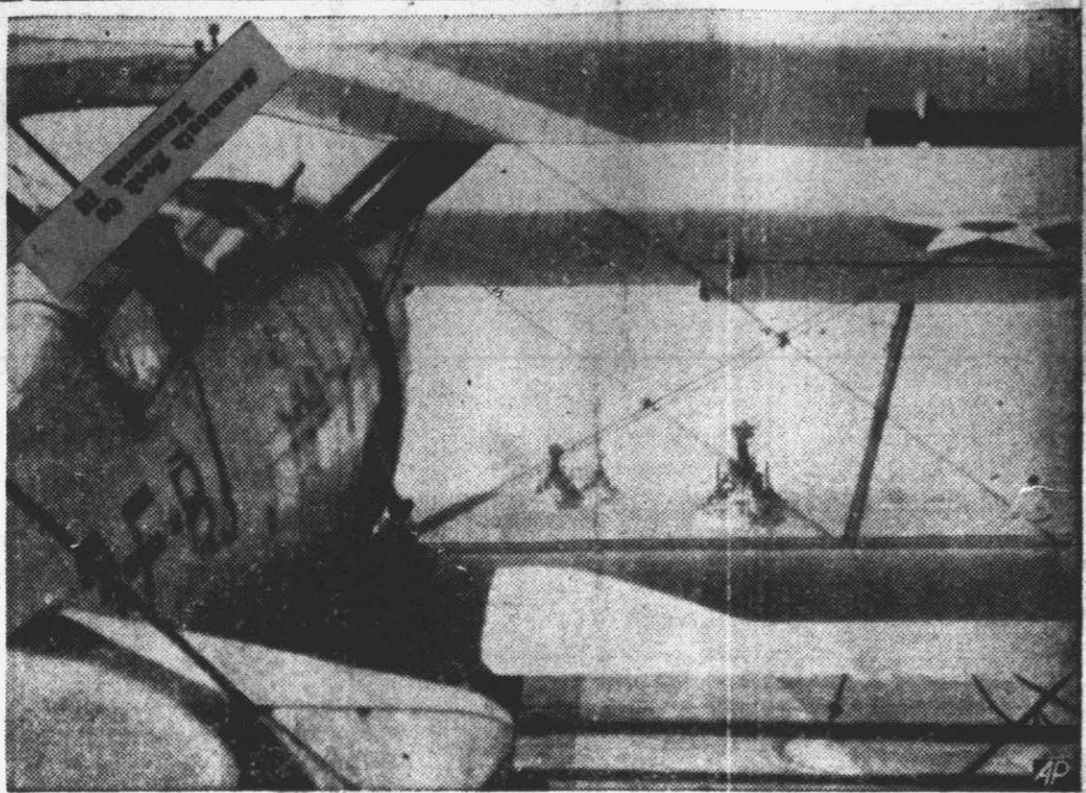
Statement Issued About Pool Room

PLANNING FOR EASTERN MEET

School Safety Patrol Convention Here April 7-8

A complete program for the Eastern Carolina School Safety Patrol convention to be held in Greenville April 7-8, was announced today, featuring a parade on the latter afternoon.

Several hundred school safety patrol members are expected to participate in the parade. Approximately 40 teams will be represented.

The address of welcome will be delivered by Mayor M. K. Blount, after which the school patrolmen will participate in athletic contests and competitive drills. Prizes will be given in the following events: Best drill team, best appearing patrol in parade, largest uniformed (belt and badge) visiting patrol in parade, best safety slogan in parade, best juvenile float in parade, best decorated bicycle in parade.

Governor Clyde R. Hoey has been invited to address the Friday evening banquet, at which a number of prominent persons will appear on the program. Presentation of the silver loving cup to the winning drill team by Coleman W. Roberts, president of the Carolina Motor Club, which organization sponsors the school safety patrol.

Free sleeping quarters for patrol members from too great a distance to go home Friday night and return for the parade Saturday morning will be provided in Greenville homes and in the army patrol members who stay overnight will be furnished breakfast by the Greenville Chamber of Commerce.

The first five cases on the calendar are divorces. Many others involve claim and delivery proceedings and judgments.

Boards and Commissions Plague General Assembly

Raleigh, March 16.—The Senate simply can't get away from the plague of legislation regarding the almost countless boards and commissions authorized to control everything from the practice of law and other professions down to the laying of dog house roofs.

No less than five measures dealing with these multiple commissions were on Wednesday's Senate calendar, and, as usual, there was plenty of jawing about them, with Haywood's Anti-Commissioner in Chief contributing his usual share of oratory to the proceedings. It was said one of the bills before the Senate is so for reaching that it would be necessary to employ a licensed man "to put the roof on a chicken house or a dog house."

Bills dealing with commissions before the Senate were: 1. To "clarify and amend" the 1937 law relating to licensing plumbing and heating contractors. Senator L. S. Prince of Henderson wanted to amend it so that it would not apply to "a man who contracts only for his own services." His proposed change was beaten and the bill passed second roll call reading: 2. A companion bill "to create a state board of warm air, sheet metal and roofing contractors." This is the one which drew the heaviest Cogburn fire. When a dozen Senators proposed to exempt counties of their districts, the bill went over.

HITLER AGREES TO PROTECT AREA

Hungarians, Meanwhile, Fighting With Czechs

Berlin, March 16.—(AP)—Reichsfuehrer Hitler today agreed to Slovakia, "independent" central portion of broken Slovakia, under his protection.

Dr. Joseph Tiso, who declared independence of Slovakia Tuesday under Hitler's guidance and promise of support, appealed to Hitler to take the little country of 14,600 square miles and about 2,500,000 population under his rule.

Tiso telegraphed Hitler, now at Prague: "In supreme confidence in you, Fuehrer and of Greater Germany, the Slovak state places itself under your protection."

The Slovak state begs to take over this protection. Hitler replied "I acknowledge receipt of your telegram of yesterday and herewith take over protection of the Slovak state."

With the Hungarian army in Carpatho-Ukraine—Hitler trench fighting raged seven miles west of Chust this afternoon as the Hungarian army of occupation approached the little capital of Carpatho-Ukraine.

A Hungarian officer said that before noon 100 Hungarians had been killed or wounded in the battle. He declared seven losses had been inflicted on Czech forces resisting Hungary's invasion of the easternmost section of broken Czechoslovakia.

Buncharest Rumania, March 16.—(AP)—Premier Volosin of Carpatho-Ukraine today fled into Rumania ahead of Hungary's advancing armies taking over the easternmost section of former Czechoslovakia. He crossed the frontier at 1 p. m.

Officials Discuss Traffic Problems

Charlotte, March 16.—(AP)—Experts in every division of traffic operation, representing both passenger lines and the shippers, led discussions today before a joint meeting of the Southern Traffic League and the Southeastern Shippers Advisory Board.

F. E. Norris, president of the Southern Railway, L. R. Powell Jr. of Norfolk, receiver for the Seaboard Air Line Railway; G. B. Elliot, president of the Atlantic Coast Line Railway; W. S. Franklin, vice-president of the Pennsylvania Railroad and other carrier officials attended the general meeting of the advisory board before the combined session started.

Archbishop of Prague Visits Pope Pius, XII

Vatican City, March 16.—(AP)—Pope Pius XII received Karl Cardinal Kasper, archbishop of Prague, in private audience this morning.

He was believed to have discussed German occupation of Bohemia with the pontiff, although the Czech cardinal's call presumably was also to say farewell before returning to his See, now that the coronation ceremonies are over.

More Emergency Fields

Johannesburg.—(AP)—To make air travel safer emergency landing grounds at intervals of 50 and 100 miles are being established along routes operated by South African Airways.

Hitler Decree Establishes 'Autonomous Protectorate' Over Bohemia and Moravia

German Fuehrer Lays Down Law for 7,000,000 Czechs

STATE ADDED TO GREATER GERMANY

Annexation of Territory by Hungary Is Certain to Have been Made with Consent of Hitler

Prague, March 16.—(AP)—Adolf Hitler, in a decree issued from an ancient castle of Prague, today charted the future of the ancient land of Bohemia and Moravia as that of "an autonomous protectorate" forming part of the territory of Greater Germany.

A day after he had sped into the capital of the broken Czechoslovak republic behind the wheels of his motorized army, the master of central Europe laid down the new fundamental law for the country of 7,000,000 Czechs.

His decree, read over the radio by his foreign minister, Von Ribbentrop, made all the quarter million Germans within the protectorate German citizens.

This, however, is subject to provisions of the Nuremberg racial (anti-Jewish) laws and other German laws. In other words, German Jews can not be citizens.

All other inhabitants of the protectorate are subjects of the protectorate. "The protectorates of Bohemia and Moravia is autonomous and administers its own affairs," the decree continued.

It established sovereign rights pertaining to a protectorate in harmony with the political, military and economic interests of the Reich.

The German fuehrer decreed that the head of the autonomous administration should enjoy all protection and honors accorded the head of a state.

He said there would be a Supreme head of the autonomous protectorate and a Reichs-protector as guardian of Germany's interests. He did not name them.

At almost the same moment that Ribbentrop read the decree, Count Teleky, Premier of Hungary, proclaimed in Budapest that Carpatho-Ukraine, easternmost part of the crumbled Czechoslovak republic had become "part of the kingdom of Hungary." He said it would be autonomous.

It was considered certain that Hungary had acted with Hitler's consent in formally annexing the province, though which Hungarian armies already had been driving for two days. Hungarian troops had reached the Polish border, establishing a common Polish-Hungarian frontier.

Hitler's troops had completed occupation of Bohemia and Moravia and the fuehrer laid down the new law of the land.

Funeral services were conducted this afternoon at the home of Mrs. Bailey by Rev. M. A. Woodard, Free Will Baptist minister of Winterville. Burial followed in the Nobles cemetery near Greenville on the Farmville highway.

Mr. Anderson was well known in this section, having spent his entire life in and around Greenville.

He is survived by five sons, Theodore of Greenville, Lester and Chas. of near Stokes, Wiley of near Farmville and Jim Anderson of Washington three daughters, Mrs. Agnes Dail of Fountain, Mrs. Jack Buck of near Greenville and Mrs. Bailey one brother, Alf Anderson of near Bethel; and one sister Mrs. Amos Joyner of Tarboro.

Freak Tornado Strikes Area In Gates County

Three Persons Injured, Heavy Property Damage

Norfolk, Va., March 16.—(AP)—A freak tornado which hit Sunbury, N. C., this morning at 3:30 caused considerable property damage and slight injuries to three people.

A cotton gin and sawmill were demolished and the Episcopal church was damaged and roofs were blown off a number of garages and sheds, it was reported.

An automobile trailer was blown 75 yards and destroyed, the two occupants receiving only slight injuries.

A Negro fireman on duty at the sawmill was the only one to receive extensive hurts.

The blow came suddenly and lasted only two minutes, but left demolished buildings and debris in its wake.

Persons injured were identified as Mr. and Mrs. G. D. Dickerson, occupants of the trailer, and John Lassiter, the fireman.

Damage was estimated by Graham Byrum, Sunbury business man, at from \$50,000 to \$75,000.

Locate Two Stills Near Craven Line

Pitt county ABC law enforcement officers yesterday located and destroyed two whiskey stills in Swift Creek township. The plants were within 50 yards of each other and were close to the Craven county line.

One of the stills was a 50-gallon capacity copper outfit and the other was a 50-gallon steam plant. Neither was in operation and no one was found at either place. One hundred gallons of beer were found at one of the stills.

KEEP GUARD AT NEGRO'S TRIAL

Negro Accused Of Burglary and Attempted Assault

Nashville, March 16.—(AP)—In a court room guarded by over a half-dozen State Highway patrolmen, under the personal direction of Captain Charles Farmer of Raleigh, and the night shift of the Rocky Mount police department, coupled with officers from Wilson, Nash and Edgecombe counties, 19-year-old Willie Richardson, Rocky Mount Negro, went on trial for his life in Superior court here this morning on a charge of first degree burglary.

Though officers would not comment on the presence of the State patrolmen, who have been here since Richardson was brought from State's prison yesterday, it was apparent possible disturbance was feared from the crowd. The Negro is also alleged to have attempted criminal assault upon Mrs. Frank Butler, 40-year-old wife of a Rocky Mount accountant, on the night of February 10 when he broke into her home and stole her pocketbook.

The Negro is charged with attacking Mrs. Butler and dragging her into the yard of her home, where he allegedly attempted the criminal assault.

By 11 o'clock the 12-man grand jury was selected from a special venire of 50 and Judge C. E. Thompson of Elizabeth City, allowed a recess of an hour before the 13th juror was chosen.

SENATE DEFERS SPENDING BILL UNTIL TUESDAY

Body Told Income Tax Receipts To Exceed Estimates

BILLS ON HEALTH OCCUPY SENATE'S

All Chances for Enacting Minimum Wage Legislation This Session Apparently Lost

Raleigh, March 16.—(AP)—The Senate today deferred until Tuesday any action on the 1939-41 appropriations bill after being notified that income tax receipts apparently would exceed estimates and make more money available.

Revenue Commissioner A. J. Maxwell, carefully qualifying the report by saying this year's figures probably ran a day ahead of last year's due to speedier processing, said collections through yesterday were \$7,033,985, as compared with \$6,285,000 March 15, 1938.

The Senate devoted itself to major health bills, passing a pure food measure to make state laws conform to federal statutes and approving on second reading a proposal to require persons to have physical examinations before they may secure marriage licenses. The third reading on objection of Senator Prince of Henderson. The pure food act went to the House.

Senators also passed and sent to the House bills to require blood tests of prospective mothers and sanitary toilet facilities at all public schools.

The House completed floor action on the biennial revenue bill, estimated to raise a record amount of general fund money to finance a record \$154,000,000 budget for 1939-41. The final vote on concurrence in Senate amendments was 94 to 9. It likely will be ratified late next week.

All chances for minimum wage legislation apparently faded when a joint subcommittee voted six to two to draft a substitute bill dealing only with maximum hours and providing a labor advisory board to study the wage question and report to the 1941 legislature.

The Senate passed and sent to the House a bill to create a statewide pension system for county and municipal employees.

Maxwell's report on income taxes was read to the Senate by Chairman Rodman of the upper division's Appropriations committee.

The House approved and sent to the Senate the Quinn bill to prohibit wholesale shipments of liquor into dry counties.

Pedestrian Killed At State's Capital

Raleigh, March 16.—(AP)—William B. Snow, 66-year-old former city attorney, died early today at a hospital shortly after being struck by an automobile at a street intersection.

Coroner Roy Banks was investigating and said police informed him Snow was run over by a car driven by M. D. Holt of Raleigh, route three. Holt carried Snow to the hospital and is under \$500 bond pending further investigation.

Formerly Snow practiced law in Lumberton as partner to former Governor McLean and once lived in Hendersonville. He once worked in the Department of Justice in Washington, also, and was a Raleigh native.

Funeral plans were incomplete. Surviving are his wife, two sons and two sisters.

RESERVE ARMY 'MINUTE MEN'

Corps Composed Of Former Members Regular Forces

"Remain with the color" has become the enlistment in the War Department's campaign to build the newly created Regular Army Reserve to a strength of 75,000 men.

Posters recently distributed by the Recruiting Publicity Bureau to U. S. Army posts, stations and recruiting agencies throughout the country tell graphically the story of the Regular Army Reserve.

The regular army reservists are 1939 plan of national defense. They are the "Modern Minute Men" in our army, a voluntary body of outstanding, selected men who have served in and have been honorably discharged from the U. S. Army. Eligible are all honorably discharged regular army, less than 36 years of age, physically fit, and whose active service totals at least one year. Married men are now accepted for enrollment.

The advantages of membership in this organization are considerable. In addition to the financial reimbursement, the ex-regular will have the realization that though his active service over he is still, in a sense, wedded to the Association and ideals which were his when he wore the uniform of the regular army.

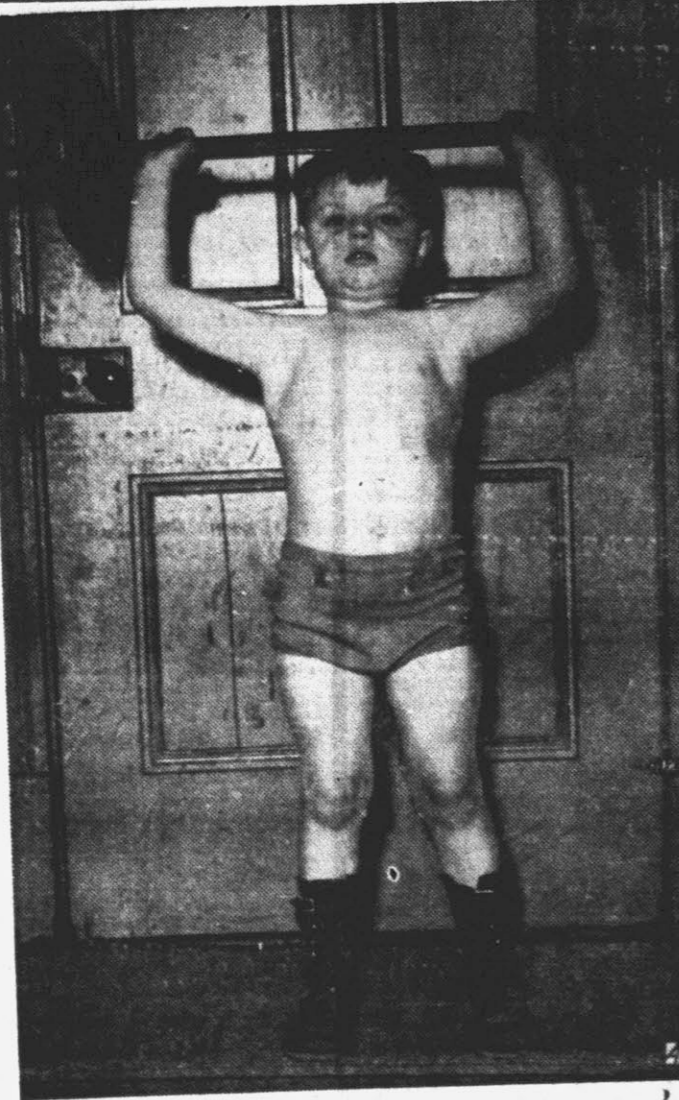
That ex-service men are more and more appreciating the advantages of enrolling in the reserve unit is evidenced by a recent occurrence at Fort Moultrie, S. C.

The U. S. Army transport "Chateau Thierry" arrived in Charleston a short time ago, enroute from Panama to New York and from the troops who disembarked at that port, and who were due for discharge upon expiration of their terms of enlistment, two hundred and forty-nine eligible men enrolled in the regular army reserve.

It seems to me that Hollywood missed a bet in not having a representative on hand at that sale. Pearl White was as important to the formation and the growth of the motion picture industry as Washington's army was to the colonies when we became revolutionists and broke away from the mother empire.

Why wouldn't it be a good thing to have a museum in Hollywood dedicated to those who helped make it great? A museum of rooms and galleries dedicated to the Rudolf Valentinos and the Pearl Whites and the John Gilberts who took much from Hollywood and gave much, who touched it with their hands and made of it a thing of their own personalities and left their impress on it, so that even now we speak of "a second Valentino," or we say, "He looks like John Gilbert."

It could be handled in such a way that the curse of the tomb would be taken off. There could be laughter and music, and surely the flowers would have an extra incentive to blossom in all that California sunshine.

Charge a dime. Charge a quarter. Charge anything. It would pay for itself in time, and if there were anything left over there are charity organizations who would welcome the money. Pearl White's name isn't going to die because she epitomized in silent serials, the dauntless, blonde heroine who leaped off cliffs or wrecked railroads to preserve her virtue and thwart the evil influences of the world.

Valentino's name isn't going to die because he epitomized Latin Love in slick-haired capital letters. He wore slave bracelets and he was something of a perfumed dandy, but nobody ever called him a sissy. When he died women all over the world fainted and said they were engaged to him. The center of the world became Campbell's funeral chapel at 66th and Broadway and for days the streets were a seething vortex of prostrate humanity. Nothing like it has ever been seen before or since.

Nor will John Gilbert's name die, because he was the Great Lover, too—a different type of lover—dashing, impetuous, reckless, mastering. His and the Garbo legend are entwined forever. His whole life was a tragedy, despite sensational monetary success. At least two of his wives have said he was a victim of his own driving ambition.

Washington Daybook
 By Preston Crover

Washington.—As Congress approaches debate of our neutrality policy it becomes plain as day that the administration wants all legislative shackles removed wherever they interfere with the free exercise of diplomatic action.

Just now it wants to be able to:

1. Refuse supplies to aggressor nations. The only active aggressor now is Japan, but likely Italy and Germany will be included if they disturb the present quiet.
2. Keep foreign diplomats from snickering up their sleeves over extraordinary legislative restraints imposed upon the chief executive and his foreign ambassadors when they deal in foreign affairs.

The administration considers the second as most important just now as a peace preservative. The President as much as said so in his carefully guarded statement about the Neutrality Act. That act requires the President to shut off all military supplies to nations at war. American nations excepted. He considered it certain that existence of the Neutrality Act had contributed more toward war than toward peace.

Shuts Off All Help
 Why? He did not say, but his line of reasoning is plain. England and France, rightly or wrongly, count this country probably sympathetic possibly an ally, in any affray breaking out in Europe.

The Neutrality Act makes that "alliance" less certain and less valuable to them. It would lock up all American arms and ammunition the very day war broke out. President Roosevelt has known that the two nations considered the act a handicap to their diplomatic position. They considered it—and so did their foes—as a factor contributing to their weakness at Munich.

It may be that this country should not give a rap whether the position of the English and French is weakened by the isolationist nature of our Neutrality Act. Opponents of the President's policy have said as much. But the present administration thinks differently. It has not said so openly but it has indicated so in more ways than one.

It wants its diplomats to be able to hint, without necessarily speaking out, that if trouble comes this country is more likely to be friendly to England and France than to Germany and Italy.

With the Neutrality Act on the books, such diplomatic "under-tones" sound cracked. The Neutrality Act says in effect, that Congress is not going to let this country be friendly to any one when the war comes. That includes England and France.

Cuts Persuasive Power
 And because the administration and its diplomatic agents abroad cannot display the administration's friendliness unfettered their persuasive weight abroad is lessened. Their warnings—temperate though they may be—carry less weight against nations looking for a chance to leap.

It is this administration attitude that forms the basis of the upcoming debate. At times the Neutrality Act itself becomes little more than a side issue. Some members of Congress who criticize the administration policy nevertheless agree with the administration that the Neutrality Act is bad legislation.

They don't like the Neutrality Act. But even more they don't like the administration's implied reasons for not liking it. They look upon England, France and the whole European scene as a sour job out of which this country should keep its hands.

Thus the fight in that respect comes again the old battle over the League of Nations. That affair lasted many, many months, and the isolationists won hands down.

Caffey, who last year drew more than four thousand dollars in fees and expenses as attorney for the group, again moved that consideration be deferred. Wilson protested, but the Caffey motion prevailed. Later Mr. Wilson remarked that much action only prolonged the agony.

During one debate Page of Bladen wanted to know of Uzzell of Rowan if he thought the bill under discussion was constitutional. Speaker Wood answered that "that's a question for the Supreme court." NEW YORK—If there were such a thing as a caste system among cities in this country New York would have to dine at the second table. We stand for some things that are pretty crude times. The newest off-shoot of the death pool is an example, a widespread sweepstakes that was set into motion by the death of Pope Pius XI.

There were hundreds of them in the city and each was a lottery predicated on the ultimate choice of the College of Cardinals. You found them in office buildings, department stores, and pool halls.

This is the way they worked: there are 62 members of the College of Cardinals. Each Cardinal was given a number, and those numbers were sold. If you had a dollar sweepstakes you paid a \$1, drew a name, and then sat back to wait the election of a new Pope. The lucky man took the jackpot.

Some of these sweepstakes ran into real money. I knew of two that were \$20 a name and one that was \$35. The winners of these were rewarded with sizeable sums. But most of the pools were of the dollar variety, and it is a conservative estimate to say that in New York a thousand of them were in operation.

The original death pool, which still flourishes day and night, works like this: You select a list of famous men who are all well along in years. These names are tossed into a hat and sold. You pay your money and you take your pick. Then everybody sits around and waits for someone on the select list to die. If your "man" goes first, you win.

The late Colonel Jacob Ruppert adorned many such lists. Pope Pius himself was another. A taxi-driver told me his son-in-law twice held the name of the late John D. Rockefeller and gave it up in disgust "when a dark horse beat him out." That's the way the cabby phrased it.

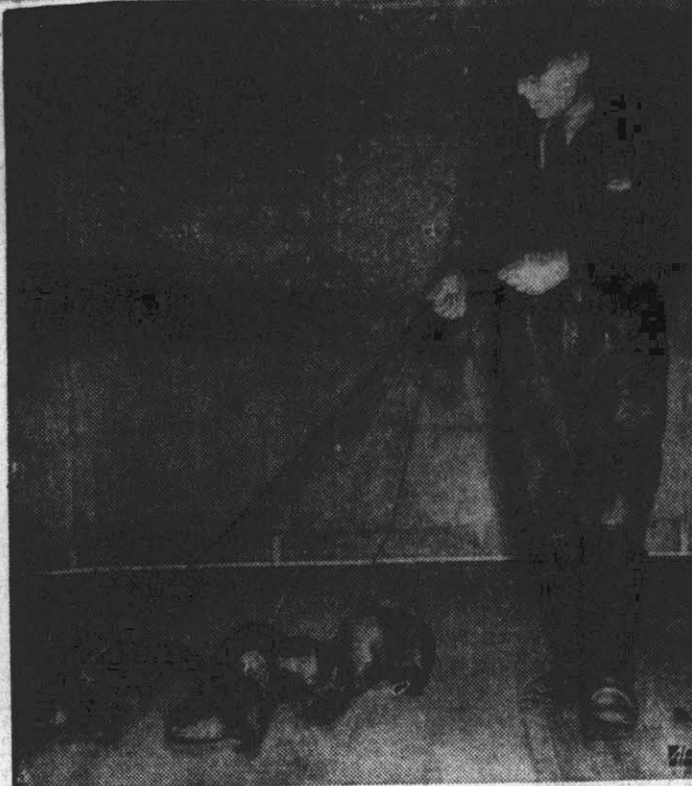

Cabarrus Resident Is Granted Pardon

Raleigh, March 16—(AP)—Governor Hoye gave a complete pardon today to Willis Clark, Cabarrus county man, who escaped from prison in 1932, and lived "the upright life of a law-abiding citizen in his home town of Kannapolis until March 8.

Clark was sentenced in March, 1931, to two to three years for larceny of an automobile. Prayer for judgment was first continued for two years upon payment of costs, but Clark was sent to prison when he could not pay the costs.

The man served 16 months, escaped July 11, 1932, and went home. The pardon statement pointed out, "I wish to make this observation, when he walked away from the Caldonia prison farm about seven years ago he did not go to some distant state and take upon himself an assumed name. On the contrary, he went back to his home in this state without any effort whatsoever to conceal his identity or his whereabouts. I have before me indisputable evidence of rehabilitation and a life well-lived openly and honestly in his home community.

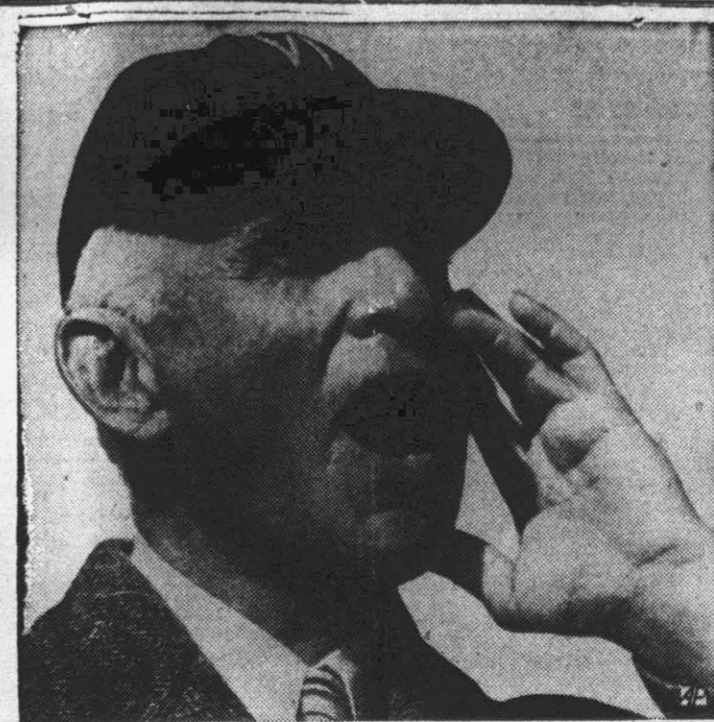

"On March 15th, 1939, the city attorney appeared before the City Council and advised the City Council that it had no legal authority to deny the license applied for by Mr. Gaston due to the fact that license had already been issued to others to operate pool rooms in the City of Greenville. And that the charter of the City of Greenville is without authority to withhold license from Mr. Gaston, and the city attorney advised the City Council that to deny the license to Mr. Gaston would be illegal and that the court, if the question was tested, in the opinion of the city attorney, would hold that Mr. Gaston was entitled to have the license issued to him. Upon this statement by the city attorney to the City Council the resolution of March 8, 1939, denying the issuing of the license was rescinded and a resolution adopted by the City Council authorizing the license to be issued to Mr. Gaston. The City Council was in no way acting arbitrarily in the matter, but was taking into consideration the objection set out in the petition signed by a large number of citizens and business men of the City of Greenville, and acting upon precedent heretofore established, but upon advice of the city attorney, the City Council desiring to stay within the law and do only those things which have legal and provided for by statute and its charter, rescinded its former resolution and passed an order granting the license."

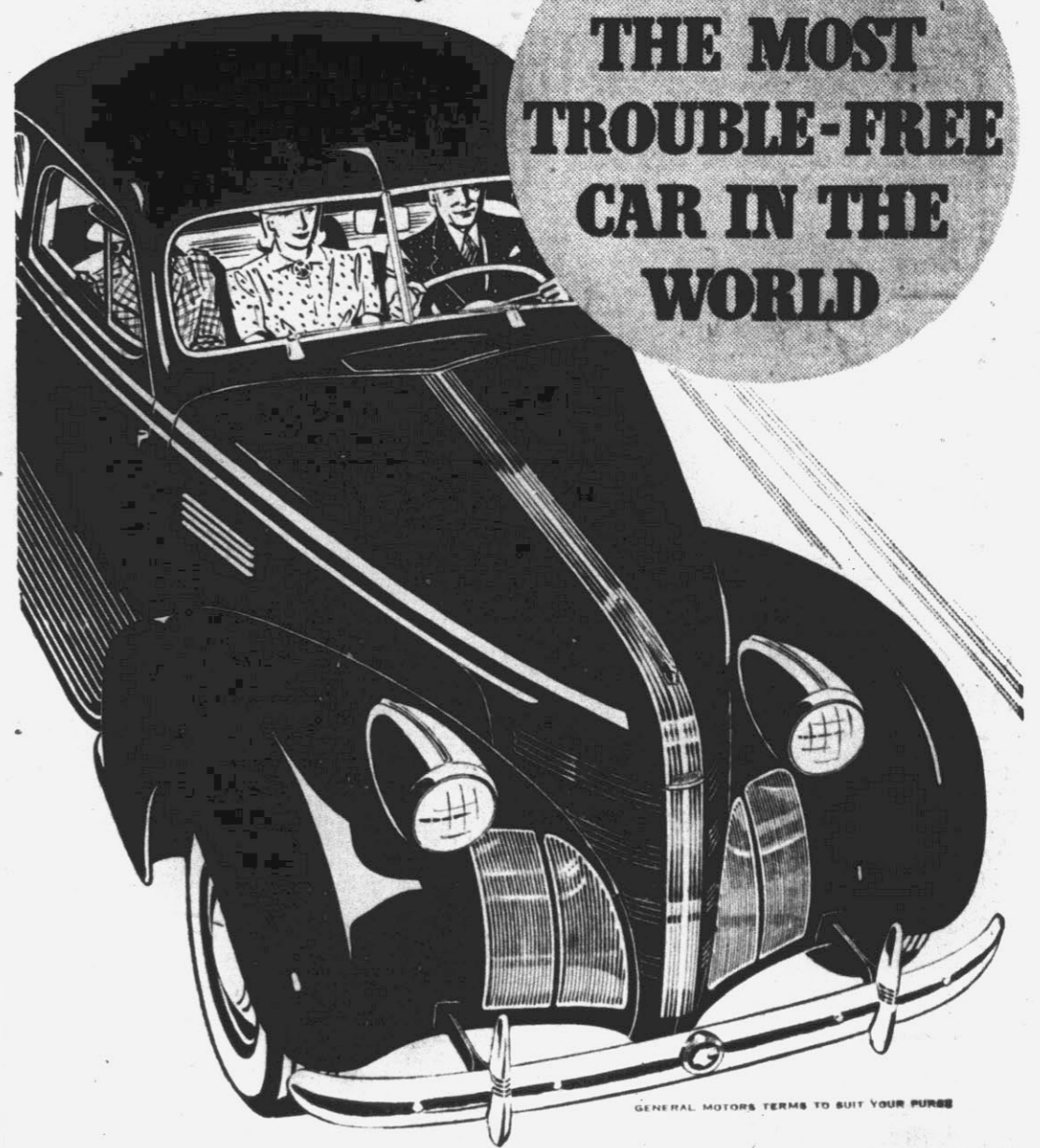
