EUROPE LOOKS TO MUSSOLINI FOR NEXT STEP

Sunday Speech by Il Duce May Make Demands on France

POLAND AFRAID AFFRONT HITLER

Britain Now Said To Be Considering Triple Entente With France and Soviet Russia

London, March 25.—(AP)—The governments of Europe looked today to Rome, whence may come from Premier Mussolini an indication of what the Nazi-Fascist powers hope to do next.

Mussolini makes an important address tomorrow and there was some belief here today that he might enunciate demands upon France for colonies in Africa.

If he does, there likely will result another period of high tension like that of the past 10 days during which Adolf Hitler of Germany, the Italian anti-Communist partner, obliterated Czechoslovakia, regained Memelland from Lithuania and thrust the Nazi economic machine to the Black Sea by an accord with Rumania.

In the meantime, the British government slowed efforts to form a four-power league against Germany with France, Soviet Russia and Poland. Poland has been cool to the idea because, Polish political informants said, she does not wish to affront so powerful a nation as her border.

There was a possibility that Britain would conclude a triple entente with France and Russia, then make a separate agreement with Poland, which might include a definition of military aid each would give the other.

Memorial Baptist Will Hold Revival

Dr. Forrest C. Fozz, pastor of the Tabernacle Baptist church, Raleigh, will conduct a one-week revival at the Memorial Baptist church here, beginning Monday and continuing through next Sunday.

The local church has been making plans for the evangelistic services, for the past several weeks. These plans include a religious survey conducted in the city, a week of cottage prayer meetings and extensive publicity.

Dr. Fozz, a native North Carolinian, is a graduate both of Wake Forest college and the Southern Baptist Theological seminary. Following his graduation from the seminary, he became professor of Bible at William Jewell college, Liberty, Mo., where he also served as pastor of the church.

He went to Raleigh in 1932 and has attained much success there, attracting large congregations, in addition to the thousands who hear him over the radio.

Rev. Lucian Pinnix, pastor of the First Baptist of Jacksonville, N. C., will direct the music for the services. Rev. Mr. Pinnix formerly was director of music at the First Baptist church of Burlington. He is an accomplished soloist and a capable director of congregational singing.

The schedule for each day of the services includes two services daily, at 8 a. m. and 7:30 p. m., with a prayer retreat each evening at 7:10 o'clock.

Sets Marker Bill As Special Order

Raleigh, March 25.—(AP)—The Senate today set for special order Monday a bill to abolish use of professional markers in elections and primaries.

Senator Lumpkin of Franklin, an exponent of the measure, moved to have it considered immediately under suspension of the rules, but his motion failed to carry the necessary two-thirds majority.

The motion to postpone consideration was made by Senator Prince of Henderson, an opponent of the proposal.

Dr. Meadows Goes To School Conference

Dr. L. R. Meadows is leaving today for Memphis, Tenn., to attend a meeting of the Southern Association of Colleges and Secondary Schools.

E. C. T. C. has for many years been a member of the association, which is an agency that sets up standards for educational institutions in the South and puts on its accredited list only those that reach its standards.

The conference will be in session the early part of next week.

END IN SIGHT FOR CIVIL WAR

Final Negotiations for Madrid Surrender Near

Hendaye, France, March 25.—(AP)—Final negotiations for surrender of Madrid to the Spanish Nationalists and for peace in the 32-months-old Spanish civil war were said today to be nearly completed.

Some dispatches from both Burgos and Madrid, the Nationalist and Republican capitals, indicated that a plan for the almost unconditional surrender of Madrid was so far advanced that General Franco's troops might march into that besieged city today or tomorrow.

The correspondent of a Rome newspaper on the Madrid front forecast that Franco's troops would attack Madrid in full force "within the next few hours" unless attack orders already issued were countermanded.

The Nationalist defense council, which rules Republican Spain, one-fourth of Continental Spain, met last night in General Miaja's office.

Meningitis Is Fatal To Army Private

Port Bragg, March 25.—(AP)—Private Ernest H. Plemmons of Battery F, 83d Field Artillery, died yesterday at the post hospital of meningitis, post authorities announced today.

They said there were two other cases in the hospital. One patient was described as critically ill. The other's chances of recovery were considered good.

The announcement said officials did not regard the outbreak as sufficient to curtail post activities, although a close watch was being kept.

Doctors expressed confidence the danger would be over if no more cases developed during the nine-day incubation period, which they said would end next Thursday.

Machinery Act Embodies Several Radical Changes

Reflector Bureau. Raleigh, March 25.—The Revenue Machinery Act of 1939, which like the revenue act itself purports to be a "permanent" one, makes radical departure in several particulars from previous operating statutes.

Most important changes noted are: Change of tax listing date from April 1st to January 1st, effective for the year 1940 and thereafter. This change made at the instance of county and city officials who protested that they could not get the tax books ready by July 1st when listing was not made until April. The January 1st date was used some years ago and was changed when farmer organizations objected.

Towns and Villages Declared Bombed By Both Sides

Iglo, Slovakia, March 25.—(AP)—Air and land fighting between Hungarian and Slovak troops was reported today over the Ung river valley, claimed by Hungary as her new frontier line.

Bombing of towns and villages behind the fighting zone was attributed to both sides. Losses of life as well as property damage were reported.

A Slovak aviation squadron based here took off to bomb Kosice in retaliation for a Hungarian air attack on this town in which authorities said 10 civilians were killed and 27 wounded.

Bratislava, Slovakia, March 25.—(AP)—Semi-official sources said today that an armistice had been ordered in eastern Slovakia where Hungarian and Slovakian troops have been engaged in border fighting.

"An armistice was ordered Friday night," it was stated. "Both sides are holding their positions awaiting diplomatic negotiations."

The Slovak government appealed to Berlin, now protector of Czechoslovakia, calling attention to the protectorate treaty signed March 23. Germany was understood to be trying to smooth out the dispute through diplomatic representations in Budapest.

R. E. Sellers Out From Third Ward

R. E. Sellers, Greenville brick manufacturer, today announced his candidacy for the post of alderman from the Third ward in the city primary election to be held on Monday, May 1st.

Mr. Sellers has had previous experience on the Board of Aldermen, having served from 1929 to 1929. J. D. Simpson, present member of the board, has previously announced for re-election. The ward has two members on the board, but J. M. Taft's term does not expire this year.

Mr. Sellers, head of the brick manufacturing company bearing his name, has been a resident of this city for the past 26 years.

FOUR HELD BY NARCOTIC ACT

Prominent Elizabeth City Physician One Defendant

Elizabeth City, March 25.—(AP)—Dr. Howard J. Combs, prominent 44-year-old Elizabeth City physician with home and offices in his own building on East Main street, was arraigned this morning before U. S. Commissioner J. C. Menden of the U. S. District Court under an indictment charging him on 142 counts of violations of the Harrison narcotic act.

The indictment charges that Dr. Combs has dispensed 361,000 half-grain doses of morphine within the last three years.

Indicted along with Dr. Combs were Harrison Perry, Negro chauffeur of the doctor, charged with being an accessory, and Mrs. Helen Taft Goodman and William Modrell.

A native of Tyrrell county, Dr. Combs has been practicing in Elizabeth City for nearly 20 years.

The indictments were made by the Fayetteville grand jury at Fayetteville, March 21, before Judge I. M. Meekins.

Dr. Combs and Perry were released under \$1,000 bond and the 23-year-old Goodman girl and Modrell were remanded to jail when they were unable to raise the \$1,000 bond set for each by Commissioner Menden.

PROFIT MARGINS GOOD Babson Says Industry More Efficient Than Ever Before

Palm Beach, Fla. March 24.—Profit margins of many companies are very good. In view of the sharp increase in wages and taxes in recent years, many people will be astonished to discover how good profit margins are when first quarter reports are printed. This, of course, is not true of all companies. In some concerns, margins are about as low as they have ever been, but these are special situations. In this connection, readers may recall that one-third of all companies lost money even in 1929.

The reason for improved profit margins are two fold. First is the gain in industrial efficiency thru the wider use of labor-saving machinery and processes. It is estimated that the output of goods for one man in one hour has jumped 12 per cent since the end of 1935. It has gone up more than 50 per cent in fifteen years. Higher wages and union activities have spurred into combining every possibility where they could install a new machine or a new process to save on labor costs. Insofar as union activities and higher wages have caused this the unions have only hurt their less efficient workers.

Raw Material Cheap. Second major reason for better profit margins is a lower cost for raw materials. The following figures show this clearly:

Finished Prices Have Held. Finished prices of steel, motor cars, bread, shirts, etc. have been marked down 11 per cent according to the Department of Labor's Index. Why, with the cost of making products less, have these finished prices not tilted downward more sharply? Well one reason is that wage rates have absorbed some of the savings. Another reason is that taxes have galloped up to new all-time high. Higher wage rates may represent an increase in national purchasing power; but higher taxes represent a dangerous trend. Taxes do not add to the nation's purchasing power or standard of living in the same proportion as do wages because most

TELLS OFFICERS WHERE TO FIND BODY OF WIFE

Husband Breaks After Stubborn 19-Day Silence

BODY IS LOCATED IN SEWER GRAVE

Federal Housing Authority Inspector Of Oklahoma City Admits Strangling Wife To Death

Oklahoma City, March 25.—(AP)—The body of socially prominent Mrs. Eudora Cunningham was dug by flarelight from a deep sewer grave early today after her husband broke a stubborn 19-day silence with a dramatic last-minute confession.

Just a few hours before a scheduled habeas corpus hearing, officers said would have ended in freedom for 33-year-old Roger Cunningham, he broke, admitted he strangled his wife March 6 and directed searches to her body with a crude map.

With a firm, neat hand, the bearded and haggard Cunningham sketched the diagram to show officers where the body was buried, then returned to his cell for the first sound sleep jailers said he had this week.

Headed by Sheriff George Goff and Assistant County Attorney E. W. Brown, weary searchers who had toiled many hours in a hunt for the 30-year-old Mrs. Cunningham, sped to the spot indicated by her Federal Housing Authority inspector husband.

There, toiling in the red earth by the light of flickering signal flares, the searchers dug almost eight feet into the ground.

Then, quietly, Brown signalled to officers to herd back a group of 100 curious and announced "I struck her. There she is."

His shovel had bared the head of the missing woman.

Carefully the searchers removed the earth, moistened by recent rainfall, from around the body of Mrs. Cunningham, employed as librarian at Foster high school.

Father Local Woman Is Claimed By Death

Word was received here this afternoon of the death of J. S. Benson of Smithfield. Mr. Benson was the father of Mrs. E. F. Duke of Greenville.

Mr. Benson died this morning. Funeral services will be conducted in Smithfield tomorrow, but details were not known here this afternoon.

Assembly Pushes For Adjournment April Fool's Day

Senate Passes Substitute Bill Creating State Department of Justice; House Adopts School Machinery Act; Week Brought Enactment of Biennial Spending Measure

Raleigh, March 25.—(AP)—The Senate, without dissent, today passed and sent to the House a committee substitute for a bill to create a State Department of Justice.

However, Senator Folger of Surrey, who had led a fight against the proposal, said he would move for reconsideration of the vote Monday.

Yesterday he had charged that "Hitler wouldn't want more and Mussolini wouldn't ask as much" as the measure provided in the original form before re-drafting by a sub-committee.

The measure would bring the Bureau of Investigation and Identification under the Attorney General, provide for codification of statutes and permit investigations by the Department of Justice at the request of district solicitors.

Meanwhile a fast-moving General Assembly ended its most memorable week.

With sine die adjournment for April 1, the assemblymen worked overtime throughout the week, and in the maze of bills passed, bills killed, new bills introduced, these developments were among the outstanding ones:

1. The appropriation bill, carrying the largest spending program in the state's history, became law.

2. The House after all minimum wage proposals had been abandoned, killed a measure to extend provision of the 1937 law setting maximum hours for interstate businesses.

The House met this morning and passed on third reading and sent to the Senate the school machinery bill under which the state's eight months school term will operate next biennium. The measure had to be amended to allow a unit with a school population of 1,000 or more to vote supplements for nine months of the twelfth grade, vocational education and other purposes. Governor Hoey was represented as "very anxious" that this change be made.

Without explanation, Representative Woodhouse of Yadkin introduced a bill to abolish the paroles commission and a resolution to provide appointment of a legislative committee to investigate alleged holding of "certain funds" of the highway commission in the state treasury without "logical reason." The speaker would name five house members to study the "apparent withholding" of the fund and report within three days.

Corey Bill Provides Election On Limits

Raleigh, March 25.—Senator Corey of Pitt introduced a measure to provide elections on extension of city limits. Cities would be required to draw maps showing surrounding territory which would be divided into sections of 2,000 square feet each. By a petition of 10 per cent of the residents of one of the sections proposed extensions could be taken before the Local Government Commission, which could authorize elections to be participated by both the city and the area to be incorporated.

Reflector Bureau. By HENRY AVERILL. Raleigh, March 25.—Dr. Ralph W. McDonald, whom State Administration leaders still see as the central figures of their nightmares, today definitely and positively removed himself from the field of North Carolina politics either as a possible Hoey appointee or a potential candidate for any office.

In a statement whose sincerity was so obvious as to admit no doubt—the man whom came so close to overthrowing the established order in 1936, flatly and without equivocation told your correspondent that he is not seeking any appointment is not being considered by the Governor for one and "could not and would not" take one if offered.

He left only one possible avenue to public employment. He said he is hopeful to get back into college teaching.

This indicates that his election or appointment (or whatever is the proper term for getting a teaching

job) to some instructional position at the University of North Carolina is not at all impossible.

There are, in fact, reports now current around Raleigh that he will be named head of a Department at the Chapel Hill institution. These, however, are so far unverified and unconfirmed in any official quarter.

Going a bit beyond a prepared statement which he gave your correspondent, Dr. McDonald said these isn't the faintest chance that he will ever reenter politics as an active participant. He by no means cut off the possibility that he will retain a keen and active interest as an observer, however.

BILL RELIEVES PITT OFFICERS OF FUNDS DUE

Measure Offered By Worthington Passed By House

ALSO RELIEVES SURETY FIRMS

Officers Would Be Relieved of Liability for Any Money They Should Have Collected

A bill that would relieve all Pitt county officers of any responsibility for failure to collect commissions, fees, fines, etc., belonging to Pitt county prior to January 1, 1939, has been introduced in the House of Representatives by Representative S. O. Worthington, and according to information, has already been passed by the House and is now awaiting action in the Senate.

The bill if enacted into law would give all present and past Pitt county officers and their bondsmen a clean bill up to January 1 of this year relieving them of any liability to the county for money that should have been collected in behalf of the county regardless of whether the fees were not collected as a result of neglect on the part of the officer or otherwise.

The bill is as follows: A Bill To Be Entitled An Act For The Relief of Certain Public Officers in Pitt County.

Whereas, the General Assembly by Chapter five hundred one of the Public-Local Laws of one thousand nine hundred twenty-one, as amended by Chapter five hundred ninety-seven of the Public-Local Laws of one thousand nine hundred twenty-seven, provided that certain public officers of Pitt County should receive fixed salaries in lieu of any fees, commissions, emoluments, or other compensation for their services; and

Whereas, certain public officers of Pitt County have inadvertently failed to collect the full fees, commissions or emoluments belonging to their respective offices; Now, therefore,

The General Assembly of North Carolina do enact:

Section 1. That any public officer of Pitt County now in office, or who has previously held public office who shall have failed or neglected to collect all of the fees, commissions, costs, fines, or emoluments of any kind, which it was his duty to collect, shall as of the first day of January, one thousand nine hundred thirty-nine, be, together with his bondsmen or bondsmen, relieved of any and all liability of any kind for such failure to collect the said fees, commissions, costs, fines, or emoluments of any kind, which should have been collected prior to the first day of January, 1939, and all of their acts in failing to collect such fees, commissions, costs, fines, or emoluments of any kind, are hereby validated.

Section 2. That all laws and clauses of laws in conflict with the provisions of this Act are hereby repealed.

Section 3. That this Act shall be in full force and effect from and after its ratification.

Diphtheria Requires 21 Days Quarantine

The Pitt County Health department has called attention to an error appearing in The Reflector earlier this week in regard to the quarantine period for diphtheria.

The quarantine period for the disease is 21 days, and not 12 days as printed. Dr. N. Thomas Ennett, health officer, declared that several persons had been confused by the mistake and hastened to correct the misunderstanding.

LARGE NUMBER ATTEND FORUM

Hundred School Patrons and Educators Analyze School

The power of the open forum for community needs was evident last night at the open meeting of the A. A. U. W. in the high school library, where almost a hundred school patrons and educators met for a discussion of the topic "Interpreting Our High School."

After introducing the purpose of the meeting by the thought that "Education is an organic, living thing," that "Greenville high school is thoroughly alive and hence changing," and that study of its changes is therefore essential, Dr. Lucille Turner introduced the persons participating in the panel discussion, who ranged from a pupil in high school to a college president.

On the topic of revising the curriculum, Vester Mulholland, principal of the high school, stressed that without minimizing book learning, the school is putting emphasis on development of character traits for getting along with people, thinking clearly and tolerantly, and of having right habits of work and attitudes. Bert Darden, president of the Student Council, speaking from the point of view of the student, expressed appreciation of the enlarged curriculum, with its new courses in dramatics, world problems, journalism, and advanced biology, and its enlargement of the old courses in home economics, languages, and industrial arts; and suggested the need of more vocational courses, for, he said, "White collar jobs are not for the majority of people" and "The aim of all these changes is to educate individuals individually for their needs and their powers."

Concerning "How Our Graduates Are Meeting College," superintendent J. H. Rose read records of the Southern Association of Colleges and Secondary Schools of which organization the local high school has maintained its membership since 1917. These records on Greenville graduates show that, though the school system has been continuously a teacher-training system and has striven to guard the welfare of the 85 per cent of boys and girls who do not attend college as well as of the 15 per cent who do go to college, the standing of Greenville graduates in various colleges and universities has been average or a little better than average; and he reported the changes which the Association as recently made in its plan of ranking to meet justly the changes in high schools. On the same topic President Leon R. Meadows, basing his conclusions on personal observations and registrations records over a period of twenty-nine years, reported that Greenville graduates in East Carolina Teachers College have shown ability to adjust themselves to college, unusual interest in extra-curricular activities, good academic records, and common sense in attending the home college, the common sense of saving money and yet having advantage of study under a faculty which by the American Association of Teachers Colleges, is ranked in training as third among 250 State-supported teacher-training college faculties.

Mrs. Will Hooker, speaking for the School Board on the subject "Financing Our School," said that the Board is willing and has always been willing to give all possible assistance.

Miss Mary Shaw Robeson, alumna of Greenville High School and now a teacher in the school, pointed out many advances made by the new school and expressed the belief that the loyal spirit which has long prevailed has been strengthened by the enriched curriculum and new objectives.

Mrs. Vincent of the Sheppard Memorial Library reported concerning the series of exhibits which the school has arranged over a period of eight weeks, that pupils have enjoyed seeing all parts of the school work and that through teachers from all over the county "the eyes of Pitt county were on the exhibits."

In her comments on "The Teacher in the Modern High School," Miss Naomi Newell, formerly a practice teacher in the high school and now a member of the Goldsboro faculty, said the teacher is the heart of the work, the new objectives are a great challenge, and the opportunities of service are

greater than in the old system. Adopt Provisions For Legislatures

Reflector Bureau.
Raleigh, March 25.—The General Assembly of North Carolina has been meeting with due regularity and decorum ever since the present constitution was adopted some 70 years ago, and it wasn't until this session that there really has been no provision for convening the House of Representatives in session. The law says that in absence of the president of the Senate, the secretary of state shall convene that body.

By long established custom the principal clerk of the last session has convened the House. By custom of later development, the clerk usually calls the House to order as the speaker approaches the stand. Nobody has objected but there really hasn't been an authority for that procedure.

In House bill 1004, introduced by the veteran Murphy Friday, becomes law, there will be no further question about it. The secretary of state will convene the House of Representatives and preside until the body elects a presiding officer.

Also, custom has been for the manager of the capitol building and grounds to allocate seats to members of the General Assembly. There hasn't been any law for this, but somebody had to do it. Mr. Murphy's bill puts that little job on the secretary of state, too, but relieves him of lots of worry by providing that any returning member shall have the same seat he occupied the previous session if notice is filed within five days after the general election. Otherwise, he will have to take what the secretary allots to him.

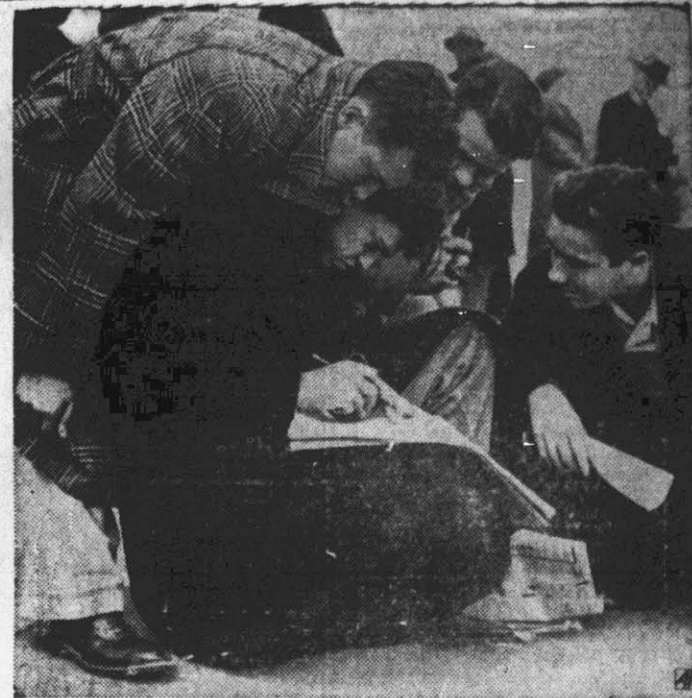

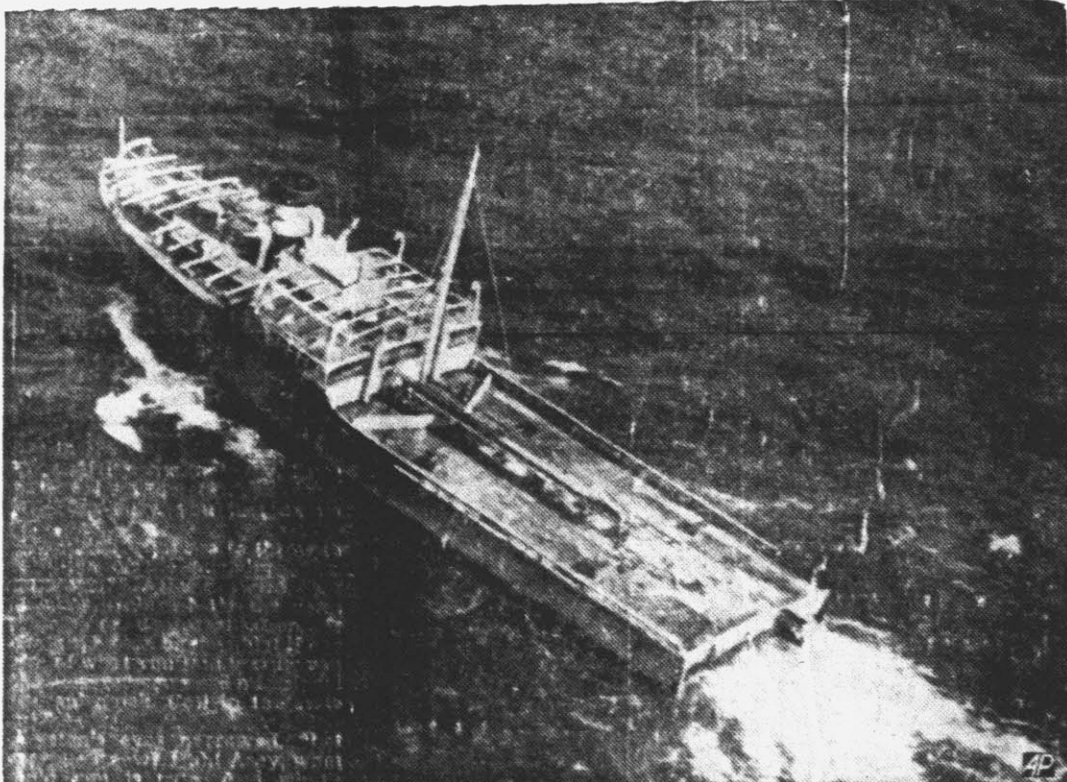

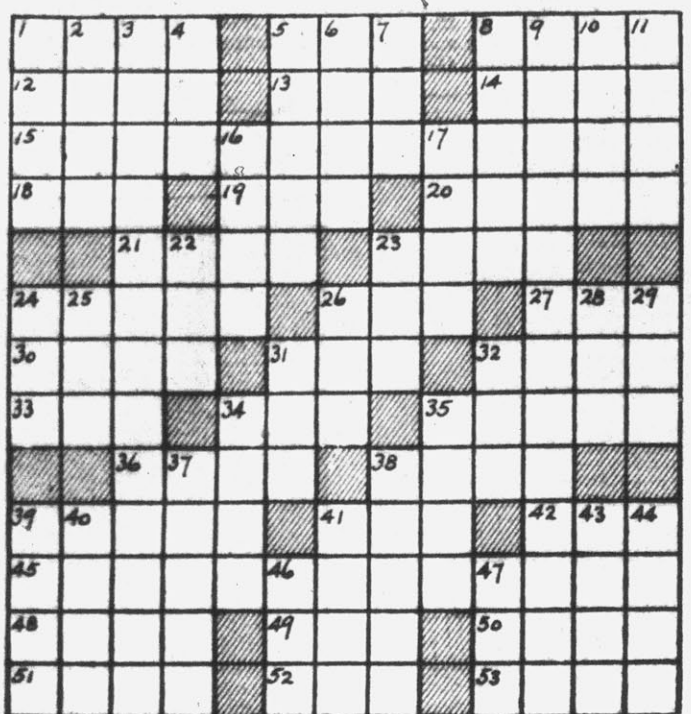

Try Herbs In Your Window Box For Miniature Gardening Fun

By The AP Feature Service.

Take hope, you city dwellers. You can still satisfy that spring urge to plant a garden. Inside the four walls of your apartment you can have most of the fun and enough of the troubles of a big-space gardener. You can grow a surprising variety of flowers, but if you're cramped for space, or want to be different—

Plant herbs. A table fork will do nicely in place of a hoe. Try a water-glass instead of a hose. Or if you must have atmosphere you can buy a miniature watering can, and a little wire scratcher with prongs three inches long to do your cultivating. Get a box to fit your window. A south window is preferred, but an east or west exposure will do. The box should have a double bottom, with holes in the uppermost bottom layer to let the water drain through. The lower bottom catches the water.

Most any size will work so long

herb plants than growing them from seed. Best sizes come two to two and one-half inches tall. They're frequently sold in pots or paper containers about two inches across. When you put them in your window box give them room to grow. Four or five plants six inches apart is usually enough for one box. Many herbs grow eight to ten inches high and six to eight inches across.

Last Long White. And they bloom. The thyme produces clusters of a lush bluish pink flower, small and sweet-scented. The chive has a purple blossom, the basil a light green flower. Sweet marjoram, summer savory and parsley also grow in indoor boxes.

They'll last a long time if you can pull them through late summer. When the plants begin to look ragged trim them back and let new growth start. Dry the tops you cut off, for seasoning—that's what herbs were intended for anyway. As the different varieties bloom trim them back about the time the



as it fits your window sill, but six by twelve inches would be the smallest useful box. Eight by twenty-eight inches is a good size. Six inches is deep enough in any case.

Soil is Important. Then choose your soil carefully. Department of Agriculture herb men say it's most important.

What florists call "potting soil" is the easiest answer because it comes ready-made with the right ingredi-
ents to mix with your own soil, use two parts of garden loam, one part well-rotted stable manure, one part sand. If you buy dried manure at a seed store use just half as much of it. Peat moss rubbed fine through a screen is a good sand substitute. The moss helps hold moisture. You'll have better luck buying it

blossoms begin to fade. Ordinarily it's best to cut them half to three-quarters of an inch from the tips of the branches that bloom. Some herbs require deeper cutting, however. Two and one-half inches is not too much on the summer savory.

In bright sunny weather herbs need a glass of water per plant every day, less than half that in cloudy weather. You'll learn by feeling the soil to tell whether it is moist enough. If you have a porch on your apartment it will help to take your herb boxes outdoors occasionally. But don't just leave them sitting on the outside window ledge over a side walk. taxes are used for non-productive purposes.

Before business was regulated—when there was free competition among industries the saving in production costs was passed along to the consumer. A prime example of this principle is Henry Ford and the motor industry. Year after year Ford turned out better and better cars at a lower and lower price—due to his increased efficiency in production. Other motor makers had to follow suit. Wages were increased, investors received bigger dividends and consumers had better cars and more money to spend on other goods and services.

Taxes Sopping Up Economies

This is a crude pattern of the progress in all industries that has given the United States the greatest material wealth of any civilization in any age. Now, what is happening? The savings in the cost of production are no longer being passed along to the consumer. Instead, they are being sopped up by taxes. Some of the President's "Princes of Privilege" would add that they are being sopped up by taxes especially where efficiency

is being hampered by labor rules. Hence, retail prices now tend to go up even with producing costs going down. The politicians are spending so much money that they are sponging up the benefits of increased productive efficiency which formerly went to the consumer. What does this mean? Unless

this trend is stopped, it means that the American standard of living of September, 1929 or even of March, 1937 may represent the all-time high for the nation. Of course, certain individuals, certain companies and certain investors will forge ahead as they always have. But the nation as a whole has already seen the peak of America's living standards—unless the political spenders and wasters are driven to cover. I may sound like an old-line Republican when I say this—but it is just as dry as day follows night.

Capitalism Sound System
Capitalism is the soundest economic system the world has thus far had; but many of the things that have been done by some capitalists have been very bad. The capitalist system is still sound and is still producing good profits. Moreover, profit margins should continue good this year. Consequently, after this latest European trouble clears away, stock prices and dividends should be considerably better. We all are learning as we are getting older. This even applies to Congressmen!

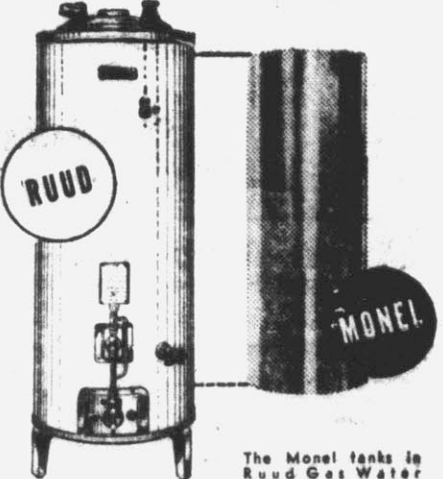

cannot engage mildly—it must be to the limit of my capacity or not at all," he said, "and the condition of my health will keep me out."

He commented on recent published reports that he would get an appointment from Governor Hoey, and said they were "perfectly natural."

In making clear his withdrawal from the political field Dr. McDonald said he is doing so in order that this endorsement of Governor Hoey can not be considered as influenced by any mercenary motives.

The Governor, he said, is not the type man to use his power to "bribe and corrupt" those who disagree with him. And he added "I do not think that anyone as ever nourished for long any impression that I am the type of man who would place his political influence on the auction block."

In a pen and ink statement prepared especially for your correspondent, Dr. McDonald said:

"I am not seeking an appointment at the hands of Governor Hoey, nor has he said anything to me about such a thing."

"Furthermore, I could not and would not accept one if it were offered."

"Frankly, I hope to get back into college teaching, which is a non-political as any activity can be."

Here Dr. McDonald paused long enough to say that he will not leave North Carolina under any circumstances, and to add that he has received "one or two" tentative offers to reenter the teaching field.

"I do not want my commendation of Mr. Hoey to be weakened by any presumption that I am un-

dertaking to curry political advantage. I can easily understand, however, how such an impression would naturally arise from my unstinted praise of Mr. Hoey's administration and our exceedingly cordial relations with each other."

"I still stand exactly where I have always stood on public issues, but I am not going to let difference in our views blind me to the simple fact that Mr. Hoey is one of the finest executives this State has ever had and that he is any deserves to be probably the most beloved governor in the State's history. I am deeply appreciative of the fact that others who have been associated with me politically agree with me on this point."

Pitt High School Attains Standard

The Pactolus High School, of which R. H. Forrest is principal, has met the necessary requirements and will be placed on the list of standard schools for the state. It was announced at the offices of the County Board of Education.

This leaves only one high school in the county, Arthur, which is not on the list. The Arthur school, however, is rapidly working toward the requirements and is expected to be placed on the list next year.

The Arthur school has been handicapped by the lack of room, but the building program there will eliminate this problem.

The Pactolus school has made required improvements to the laboratory library, teacher certificates and has increased its enrollment to such a point it will be given another teacher if the present scale is retained. The school also has met requirements for placing its elementary school on the standard list.

Marker Measure Is Put On Calendar

Raleigh, March 25.—The Senate will likely pass today a measure which has already passed when this (published) a bill designed to ban the "professional marker of ballots in primary elections of North Carolina."

Yesterday the Senate overrode a majority of the election law committee and put the bill on its calendar by way of the minority report. In an unfavorable report was given the bill by the group which is headed by Graham's Jack Morphaw.

The minority report was signed and handed up by Senators Willie Lee Lumpkins, John Umstead and Pat Taylor. It was adopted, 26 to 13 after brief and sparkling debates. The most notable feature of the vote was the fact that almost half a dozen Senators sat in their seats and answered "Present" when their names were called. In addition, there were several hurried departures from the chamber when it became clear a vote was to be taken.

Another outstanding feature of the markers fight was that it alienated Senator Lumpkins squarely with Governor Clyde R. Hoey, whose action in giving unqualified approval to a measure to end "professional" markers undoubtedly had much to do with turning the tide of battle at the last moment.

Page Given Sentence Of Ten-Fifteen Years

Washington, N. C., March 25.—(AP)—James (Grease) Page, Negro, was removed from the death row cell at Central prison in Raleigh yesterday afternoon, driven 105 miles to this city to face a charge of assault with intent to commit rape and recommitment to the prison to begin the serving of a 10 to 15 year term imposed by Special Superior Judge W. H. S. Burgwyn, after the Negro pleaded guilty to the count—all within less than 24 hours.
