LEADERS SEEK END CONGRESS AT EARLY DATE

Apparently Desire To Side-Step Controversies

SESSION NOW IN FOURTH MONTH

Chieftains Express Determination To Drop Secondary Proposals And Stick To Program

Washington, April 3.—(AP)—Congressional leaders began to speed up legislative machinery today in an apparent desire to sidestep controversies and hasten adjournment.

As the session began its fourth month, they noted that the Senate and House have disposed of only five bills, those authorizing government reorganization and army expansion, and approving funds for the WPA, independent federal agencies, and for deficiency needs of various departments.

Altogether, Congress has finished action on 45 measures out of 7,857, most of them minor ones introduced in both chambers.

As a result leaders expressed determination to drop secondary proposals and stick largely to the program outlined last week by Sen. Barkley (D-Ky). He estimated that at least two and a half more months would be required.

This would mean side-tracking some pet measures of anti-New Dealists including revision of the Wagner Labor relations act and business taxes.

The rush for adjournment was said to result from several causes, among them the fact that the New Deal legislative program was virtually completed last season, the increasing pressure of political considerations as 1940 approaches and the factional differences among Democrats.

Some legislators speculated, too, that the president might desire to end the session early in order to have a free hand in foreign affairs.

Collins And Corey Out From Second

At least a three-way race for membership on the Greenville Board of Aldermen for the second ward post which will be vacated by Jack Spain, candidate for Mayor, was assured today with the announcement of J. Hicks Corey and J. A. Collins.

A four-way race was avoided when A. O. Clark who at the request of friends in the ward had filed this morning, definitely announced this afternoon that since learning two other candidates would announce today, he had decided to withdraw his candidacy.

Mr. Collins, head of the Home Furniture Store, is a former member of the board, having served from the third ward when he lived in that district. Mr. Collins is active in various organizations of the city and is one of Greenville's leading furniture men.

Mr. Corey, real estate and insurance agency head, has long been active in various civic and fraternal organizations, being a member of the American Legion, Wivian club, Chamber of Commerce and Merchants Association. He is a native of Pitt county and has been in business here since 1920.

Before today's announcements for the position, C. A. Robertson was the only one who had stated his intention to run for the office.

Resume County Court On Tuesday Morning

County court will be resumed tomorrow after having been in recess two weeks, during which time a civil term of Superior court was being conducted by Judge Clawson L. Williams.

Despite the fact the court has been inactive for the two weeks, Clerk E. F. Tucker said the docket was not over-crowded. He estimated that there were about a dozen cases scheduled to be tried, but added others probably would come in during the day.

RECORD SET BY NEW BUILDING

Nineteen Permits Issued for Work To Cost \$200,889

Permits issued the latter part of the month for the construction of the municipal building, fire station and street department yard and for the erection of numerous dwelling houses brought to 19 the number of buildings permits issued during March, the work to cost an estimated \$200,889.

These figures compare with ten permits issued during the previous month to cost an estimate \$15,350. The total cost of construction for which permits were issued during March is believed to be a new high in the history of the city for any similar period.

Election Law Measure Really Means Something

Reflector Bureau. Raleigh, April 3.—In past General Assemblies election law reform, like the weather, was a subject for conversation rather than action; but the about-to-die gathering of law makers this time translated a large part of the talk into accomplishment.

In short, this time something really was done about it. First and foremost, the absentee ballot law, cause of more than 90 per cent of the complaints of fraud if not in fact the cause for that much actual fraud, was completely and entirely wiped off the slate so far as primary elections are concerned. No more Democrats or Republicans vote in their party contests except by going to the polls in person on election day.

If the Assembly had stopped right then and there it would have done more than any other since 1929 when the Australian ballot was adopted.

But in addition to that radical revision, the 1939 law makers threw all sorts of safeguards around the use of the absentee ballot in general elections. What the results will be in practice cannot be foreseen until after the 1940 pollings, but there is one thing certain—if there are any absentee frauds then the responsibility for them will rest squarely upon the shoulders of the county election board chairmen and nobody else. They are the key figures and there will not be any way for them to duck or dodge the onus of whatever real abuses may in future arise.

Then there has been made provision for a revision of the registration books throughout the state. Dead and removed voters are to be stricken from the lists, Democrats and Republicans are to be re-recorded, for primary voting, in separate books—a provision aimed at keeping the G.O.P. boys and girls out (Continued on page four)

Doubtful Small Countries Will Accept Offer Of Aid

BRITAIN USES LOAN AS BAIT

Statement by Foreign Secretary That Britain Has No Desire to Encircle Germany Made Shortly After Government Indication That It Was Prepared To Make Loan To Rumania

London, April 3.—(AP)—Foreign Secretary Viscount Halifax told the House of Lords today that nothing could be further from the truth than German charges that Britain and France were trying to encircle her.

His statement was made shortly after the British Government indicated to the House of Commons that it was prepared to make a loan to Rumania for rearmament. R. A. Butler, under secretary for Foreign Affairs to the House of Commons "The British Government are at all times preparing to give sympathetic consideration to the Rumanian government as well as in naval and other spheres."

In response to questions, Butler added "the question of Danzig will no doubt be discussed with Colonel Beck (the Polish foreign minister who arrived this afternoon) during his stay in London."

Informed circles said earlier that Britain had offered Rumania a pledge to help defend her independence similar to the one Prime Minister Chamberlain announced Friday that Britain and France had given Poland because virtually all her armaments in the past had been purchased from Czechoslovakia munitions works, now in Germany's possession. Rumania is almost wholly dependent on Germany for her arms.

Clipper Prepares Complete Flight

Marseille, France, April 3.—(AP)—The Yankee Clipper arrived at the Margiane seaplane base here at 9:47 a. m. (4:47 a. m. EST) today after a brief flight from Viscrose base, Bordeaux.

The 42-ton Pan-American air-ways trans-Atlantic craft is due to fly tomorrow to Southampton, England, and then to the United States, compelling a survey flight.

300,000 Miners Away From Work

New York, April 3.—(AP)—Seventy per cent of the nation's soft coal industry shut down today as more than 300,000 miners in the Appalachian area remained away from work spending completion of negotiations for a new contract.

Week-end attempts by a sub-committee of miners and operators to reach a new agreement to replace the old two-year contract that expired midnight Friday were futile despite an urgent appeal by secretary of labor Perkins.

The work stoppage followed automatically under the traditional rule of the United Mine Workers "no contract, no work."

The 3,000-odd locals of the union were instructed to pull out all of the 338,000 miners affected except for skeleton crews totaling 20,000 men. The daily payroll lost was estimated by Secretary Perkins at \$1,500,000.

The shut-down affected the bituminous industry in Pennsylvania, West Virginia, Ohio, Eastern Kentucky, Western Virginia, central Tennessee and some mines in Maryland and Michigan.

Work continued under temporary agreements in other soft coal fields except in Alabama, where an additional 20,000 miners faced idleness because of a deadlock over the new contract.

BRITAIN WOULD AID OTHER DEMOCRACIES

London, April 3.—(AP)—Prime Minister Chamberlain told the House of Commons today that the Anglo-French pledge of aid for Poland would be followed by similar commitments to other countries which stand in the way of any attempts by Germany to dominate Europe.

"I am no more a man of war today than I was in September," Chamberlain said, "I have no intention and no desire to treat the German people otherwise

GERMAN ENVOY KEEPS ADVISED

Foreign Minister In Frequent Contact With Embassy In London to Get Complete Picture of Developments Concerning British - Polish Negotiations; Germany Appears Confident

Berlin, April 3.—(AP)—Foreign Minister Joachim von Ribbentrop and his associates maintained frequent contact with the German embassy in London today to get a complete picture of developments there in British-Polish negotiations.

German government sources, however, expressed doubt that either Poland or Rumania would join Britain in a "Halt Hitler" bloc. "We have reason to believe Poland will not accept Britain's offer," an informed source said, "and much less so Rumania. Nor will Yugoslavia join in."

Whether this meant that Poland and Rumania had given Germany positive information to that effect could not be learned. But this statement reflected an apparent feeling of reassurance in government quarters.

Hitler's implied warning Saturday to Poland or any country that joined in a British attempt to encircle Germany was considered to have had the desired effect.

Without naming any nation, Hitler said that he who is willing to pull the chestnuts out of the fire for others must expect to get burned.

Newspaper headlines said that a sizeable British loan was being held before Poland as "bait."

Woe to the "protected" was one paper's theme. The fates of Ethiopia, Czechoslovakia, China and Republican Spain were cited to prove how badly "protected" nations fare.

The fact that Bohemia, Moravia, and Slovakia are now protected by Germany was not mentioned.

One Day Sentence In Contempt Case

Gertrude Reese, Negro woman, was cited for contempt by Judge L. C. Skinner in Municipal court this morning and sentenced to one day in the city jail.

A case charging Thomas E. Thorpe with failure to secure a city automobile license tag, was dismissed.

Edmond Carr, charged jointly with Lyman Price and E. D. Carr, all Negroes, with disorderly conduct and assault, was found not guilty, but Price was convicted and given a 30-day road sentence, suspended upon payment of court costs. E. D. Carr has not been apprehended yet.

Isaac Sprull, Negro, was acquitted on a charge of disorderly conduct and assault with a deadly weapon.

No further details as to the British-French intention or the possibility of developments to lessen international tension were available immediately.

FAIL TO BOOST FUND FOR WPA

Senate Group Balks At Request for \$150,000,000

Washington, April 3.—(AP)—A senate appropriations sub-committee refused today to increase the \$100,000,000 relief appropriation to \$150,000,000, the figure recommended by President Roosevelt.

The vote in the closed session reportedly was eight to two, with Senators McKellar (D-Tenn.) and Overton (D-La.) supporting the higher figure after voting down the increase the sub-committee deferred further action on the appropriation until tomorrow. Then, member said, proposals to reduce the House-approved \$100,000,000 appropriation will be considered. One member said that every sum from nothing to \$100,000,000 was being discussed.

Leaders conceded it was unlikely the Senate Appropriations committee would increase the allotment, but they said a vigorous fight for the original sum would be made on the Senate floor.

The President asked for the money to supplement WPA funds already provided for the fiscal year ending June 30.

The House Coinage committee approved a bill to continue for two years the treasury's \$2,000,000,000 stabilization fund and the president's power to devalue the dollar further.

The measure also would renew for two years the presidential authority to provide for unlimited coinage of silver and the purchase of newly mined domestic silver at a price above the world level.

Under present law the free monetary powers would expire next June 30 the committee wrote in an amendment to require the treasury to report to congress once a year on operations of the stabilization fund.

Committeemen said they expected a fight when the bill reaches the floor against the silver purchase and dollar devaluation provisions. Opponents of the latter, chiefly Republicans, have contended the existence of authority to alter the gold content of the dollar had an unsettling effect on business.

Permanent Committee On Education Is Objective

Reflector Bureau. By HENRY AVERILL. Raleigh, April 3.—North Carolina's future General Assemblies, Governors and educational departments will never be without benefits of the advice of a permanent commission which had made a thorough and complete study of the state's educational system and needs, under terms of a joint resolution introduced by Senator Bob McIntyre of Robeson county and approved by the current legislature.

Under it there will be appointed by the Governor a commission of nine members, to be known as the Commission on Education which will be a permanent body which can be terminated only by direct and specific action of some future General Assembly.

In addition there will be an Advisory Council of Education "to consist of 25 members, selected by the Governor as fairly representative of all groups in the State directly or indirectly concerned in public education."

The duty of the Commission on Education as set forth in the resolution is: "To study the problems of public education in North Carolina and to develop a long time program for improvement of public education in this State; to make recommendations to the Governor, the Advisory Budget Commission and to the General Assembly as to such improvements therein as may be recommended for each succeeding biennium."

"The scope of such work shall include the University of North Carolina and all colleges and institutions of higher education supported, in whole or in part, by the State of North Carolina."

The Advisory Council would be expected "to give special thought and study to the relations between (Continued on page four)"

MAKING PLANS FOR ASSEMBLY QUIT TONIGHT

Final Meeting To Be Held After Midnight Hour

TAX SOUGHT FOR LEAF PEDDLERS

J. C. Lanier of Greenville and Others Ask Levy in Behalf of Independent Dealers

Raleigh, April 3.—(AP)—Legislative leaders laid plans today for the 1939 session of the General Assembly to adjourn sine die at about 1 o'clock tomorrow morning.

Lieut. Governor W. P. Horton and Speaker Ward said all legislative business should be out of the way a few minutes after midnight.

Ward said he expected a new resolution to be offered this afternoon changing the hour for adjournment from noon tomorrow until some time around 1 A. M.

The House Calendar committee held a hearing this morning on a Senate bill to tax tobacco peddlers and itinerant tobacco dealers \$250 if they buy scrap tobacco from farmers and truck it to market. The bill passed second reading in the House Saturday and will be up for third reading this afternoon.

J. C. Lanier of Greenville, appearing for independent tobacco dealers, asked that the \$1,000 license tax now imposed on scrap tobacco dealers be reduced to \$250 to place them on the same basis with the peddlers and itinerant dealers. He said peddlers could truck any scrap tobacco they bought to out-of-state markets and escape any tax.

Philip Whitley, Wendell Ware, houseman, contended that the bill was an effort to do away with scrap tobacco by taxation and warned that elimination of scrap tobacco from the market might destroy the export tobacco business.

Rep. Eagles of Edgecombe county, Roy Cox of Pitt County, W. F. Woodruff of Nash, A. D. Williams, of Wilson, Rep. Rasberry of Green and Rep. Crawford of Wayne argued for the bill. Most of them said farmers in their communities would like to see all scrap tobacco eliminated from markets. Rep. Everett of Halifax said that most scrap tobacco was worth more as fertilizer than the farmer got paid for it.

Some of the committee members indicated they would favor an amendment to reduce the license tax on scrap tobacco leaders to \$500.

At College Wednesday Night. The ten notable artists from Shanghai touring the United States under the name of the Chinese Cultural Theatre to raise money for China's war refugees, who will be at East Carolina Teachers College, Wednesday night April 5, are outstanding representatives of both the old and the new China.

Not until 1915 was the centuries-old ban against men and women appearing together on the stage lifted, but these young people are so much of the new China that they act together as naturally and easily as American men and women would, and embark without a question on a world tour to aid their stricken country.

Yet they are presenting the ancient arts of China, her traditional high stylized acting, her own type of classic dancing, which seems so odd to audiences in the Western World, and her peculiarly oriental music, made on instruments that go back two thousand years. They have put much research on their program to have everything on it absolutely accurate according to tradition.

To hear Chinese music, which is strange and unearthly, to watch the flowing motions of their dancing and acting," says Brooks Atkinson, dramatic critic of the New York Times, "is to glance for a moment into the rich treasury of Chinese culture and to learn something vital about the Chinese people."

An American audience will find no real way to compare the acting on this program with that of its own stage. It does not present the conflict found in American drama, but "is the poetry of phrase and pantomime." Every gesture conveys a special idea to a Chinese audience.

Chinese music is written for a different scale and to express a different idea from those of occidental music, but as many critics of the United States are saying, even an untrained ear would distinguish the magnificent art of Professor Chung-loh Wei, who is

a master of his ancient instrument, the p'ipa, as well as many of the 150 other musical instruments that are known to the Tung Musical Research Institute where he is teacher.

Such a program would need an interpreter which it has in James Zeemin, the manager, who introduces the various numbers.

The members of the troupe will speak to people in the audience who wish to greet them, only after they have had twenty minutes or so to remove their complicated make-up after the program.

Raleigh, April 3—Some capitol wag took advantage of the April First date Saturday to start in motion a rumor that Dr. Frank Porter Graham had given notice of his resignation as president of the Consolidated University of North Carolina, and that he would accept the presidency of the University of Porto Rico. Pressed for the reason behind his unexpected resignation, it was given as the failure of the legislature Friday to elect David Clark of Charlotte a member of the board of trustees. Mr. Clark failed of election by only two votes. He is probably the most vigorous opponent of Dr. Graham's liberal policies in the state.

Senator Chester Cooburn of Haywood is the champion taker-up in the senate. He takes the counties in his district out from under every statewide bill designed to regulate the everyday habit of the people who patronize dry cleaners, plumbers, steam fitters, tin roofers, barbers, and other artisans and craftsmen which have boards and commissions. The senator does not always get away with his exemptions, but he keeps on trying. Friday night the tables were turned on him. President Horton called Cooburn to the chair during debate on amendments to the unemployment compensation act. Almost immediately Senators Clyde Council Doggie Hatcher, Joe Eagles and others joined in sending up an amendment providing that the bill should apply "only to Haywood, Jackson, Transylvania and Stanly." The acting president got by the difficulty by ruling the amendment not pertinent and everybody who attempted to speak about it out of order.

Thomas Jefferson was very highly spoken of at the Young Democrats' rally staged by fourth district juveniles Friday night. Congressman Harold D. Cooley was the eulogist for the founder of the party in whose honor the rallies are being held. And the congressman a well known N. W. Dealer, couldn't resist the temptation to have done during the past four or five years if he had been living then. Naturally, the answer was that he would have done just about what the Democratic party leadership has done. Any other conclusion considering the speaker and the occasion would have been unusual.

Mr. Cooley however, did come out strongly for America staying out of Europe. "Just as the spirit of Jefferson lives on," he said, "the evil genius of Bismark still dwells in its native haunts and cruel visions of Napoleon tempt the liberty-loving people of the earth." Again he said that the inventive genius of man has got brought to the world close enough to the old world squabbles. "The great need of the day is moral and military armament."

NEW YORK—Unity Freeman-Mitford of England, has been hailed by Hitler as the perfect Nordic type—and has been honored with an autographed swastika badge. Diana Freeman-Mitford is married to Sir Oswald Mosley, British fascist leader, and has brought up her children to greet visitors with a "Heil Hitler!"

But young sister Jessica married a volunteer for loyalist Spain, and now is selling dresses in a Fifth avenue shop—the "black sheep" of the Freeman-Mitfords.

She and her husband, Esmond Romilly, a nephew of Winston Churchill, arrived in mid-March to continue the adventures that started two years ago when both were 19. After having known each other only three days, they eloped to France. Wealthy Lord Redesdale—he's Jessica's father—sent a destroyer to bring her back. But she was too much in love with anti-fascist Esmond. So she hasn't seen her father since.

The two have been on their own since then. First off they settled down in southern France, and proceeded to earn a living translating

in the Union with a provision for markers at election.

No change whatever was made in the provision for official party markers in general elections and until the very last minute it looked like there would be no effective change in the marker's provisions as regards primaries—and there's some doubt about it now. As a last-minute so-called "compromise" however, both houses agreed to a provision that only physically disabled or illiterate voters shall be allowed to have assistance in marking their ballots in primaries. Then, it is provided, the assistance must be rendered by a member of the voter's immediate family or if none be present by some qualified voter who has not previously assisted some one else. Finally, if there is no member of the immediate family present and also no other qualified voter who has not previously marked a ballot, election officials the two judges and the registrar may be asked by the voter to render the required assistance.

It's all quite complicated and, in practice, may lead to abuses, but nobody can tell about that until it has been tried out. But whatever the ultimate result of the changes made, the 1939 Assembly at least honestly made an effort to do something about the many charges and countercharges which have featured past elections general and primary. For that it deserved credits, not scoldings.

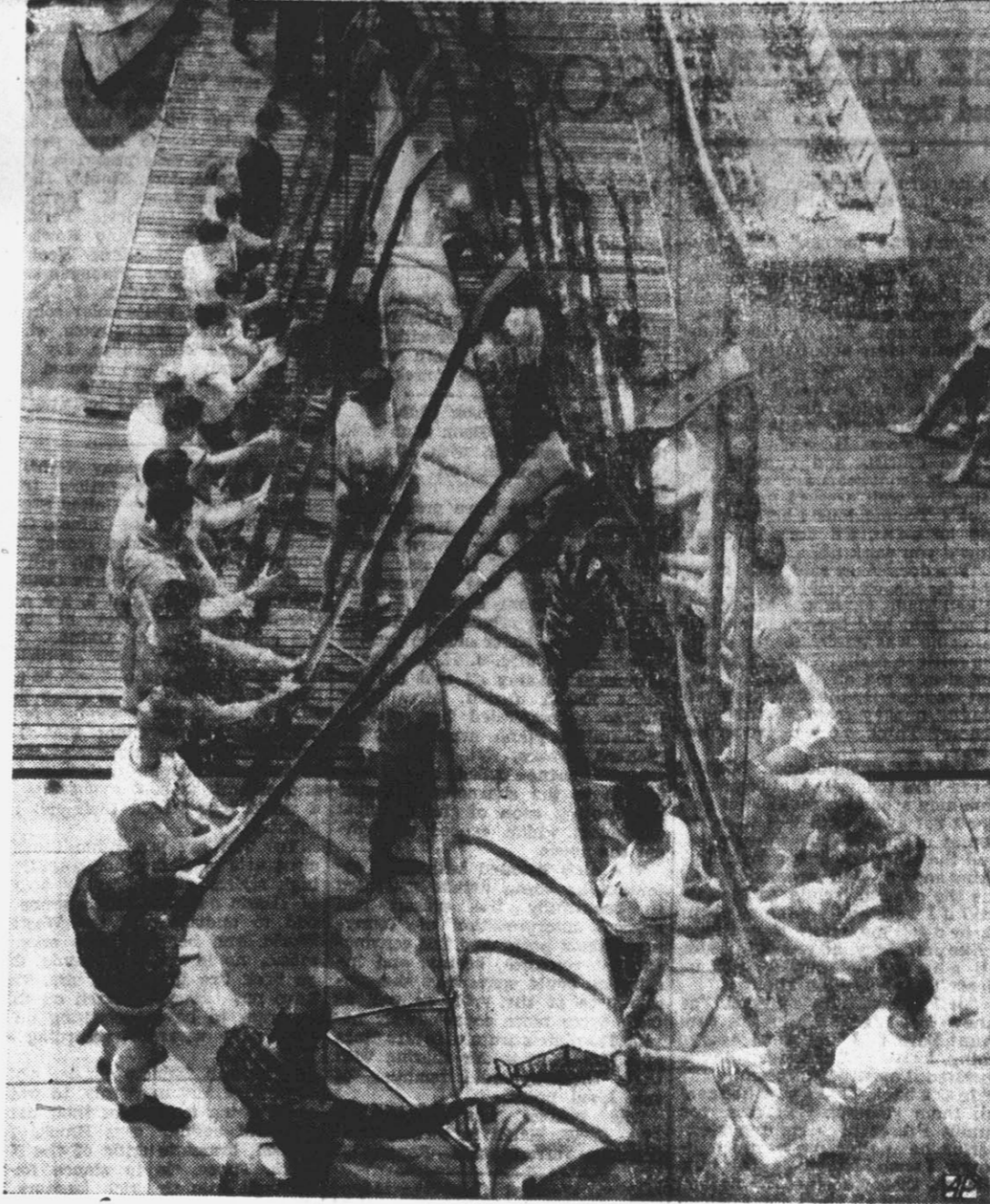

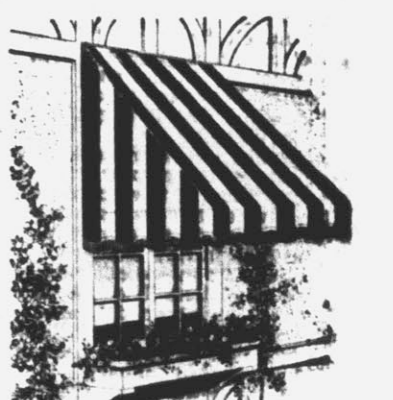

The Greenies concluded their first week of spring training yesterday at the Third street stadium, under direction of Manager Rube Wilson, with a large number of spectators on hand to watch the workout.

Drills, consisting of bunting, joints around the diamond, limbering-up exercises, batting practice and infield practice got under way here Wednesday and have been held daily since that time. They will continue until the season opens. Skipper Rube Wilson has been putting his boys through some stiff workouts and more than likely the going will be much tougher this week, as the Greenies prepare for their opening tilt, which will be staged here next Sunday afternoon at the Guy Smith ball park, when they meet the Lucky Strike team of Durham.

So far 16 men have reported, including six men who composed last year's roster, and 10 new men who are trying out for various positions. As yet to report are Freddie Calliguri, who is ill at home; Whitey Heavener, left fielder for the Greenies last year; "Lightning" Spence, pitcher here last year; and June Badger of Gastonia, a new man, also a hurler. So far no news has been heard from the latter three as to why they have not arrived. However Manager Wilson stated definitely that Jerry Underwood, outfielder, and John Ramp, infielder, both of Piedmont, S. C., would not come here this season. Calliguri is expected to report during this week.

The latest rookies to join the local camp are "Red" Rufus Webb of Delray Beach, Fla., and Teddie Maloney of Norfolk, who joined the Greenies today. "Red" who made his appearance with the club Friday, is an outfielder and last year saw action with the Delray Beach club of Florida East Coast League, a semi-pro outfit, where he hit over the 300 mark. He throws 'em right handed and hits from the left side. Maloney is a second baseman and played with the city of Norfolk team last season.

With those now reporting, the infield of last season will remain intact, with the exception of first base which this year will be played by Skipper Rube Wilson. Only one fight for an infield position is not secured, that being between "Red" Christopher, second sacker last season, and Teddie Maloney, the new man. "Gracie" Allen has no competition for short, and he certainly would give any opposition a "fit," and Harry Jenkins is back at the hot corner.

Ralph Simpson, who held down the centerfield position last season, is back at his old post. The other outfield jobs are being fought out among Bill Wiggins, Jack Cochran and Rufus Webb.

Three men are out for the backstop position, including Vincent Smith, regular catcher of last year. Others are Edward Steck, St. Louis, Mo. youth, who starred in the Southside Catholic high school in his home town last year; Edward Sulhazewicz (Shalley to you) of Stockton, Mass., former University of Alabama player.

Funds Provided For Both Agriculture Divisions

Raleigh, April 3—Officials of the state department of agriculture and of State College were happily congratulating each other Saturday, and renewing pledges of further co-operative effort in working out a progressive program of agriculture in North Carolina.

It appeared reasonably certain that the long months of disagreement and squabbling over duplicating of effort, control of test farms, and supervision of marketing had come to an end.

The legislature had just passed the bill carrying \$165,000 for research work under direction of the department, and levying an additional fertilizer tax to yield \$70,000 for the department's program of marketing, how, control and soil testing. It has been evident all along that money was the root of the difficulty between the two state institutions. In the background, too, was some personal jealousy and political ambitions, the desire to control personnel and to claim credit for agricultural accomplishments.

The trouble started about the time the legislature convened with demands from the farm Bureau on the east that the test farms now controlled by the department be turned over to the college for administration, together with the money which the department collected for fertilizer inspection taxes for their operation.

The department resisted the plan to make it just a tax collector, and let the college expend the money. It was suggested that research money ought to come from the general fund of the state, but no

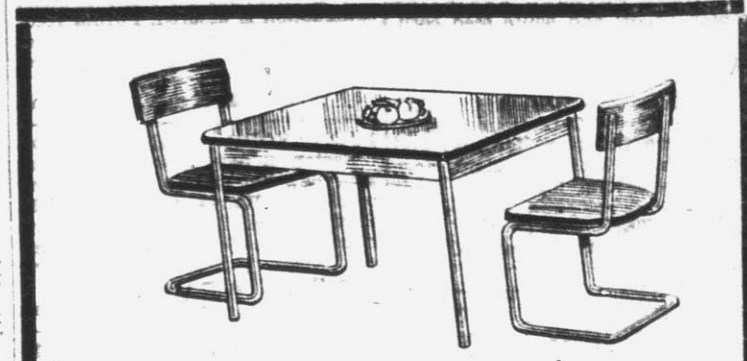
